FIG. 3 is a top view of the watch of FIG. 1.

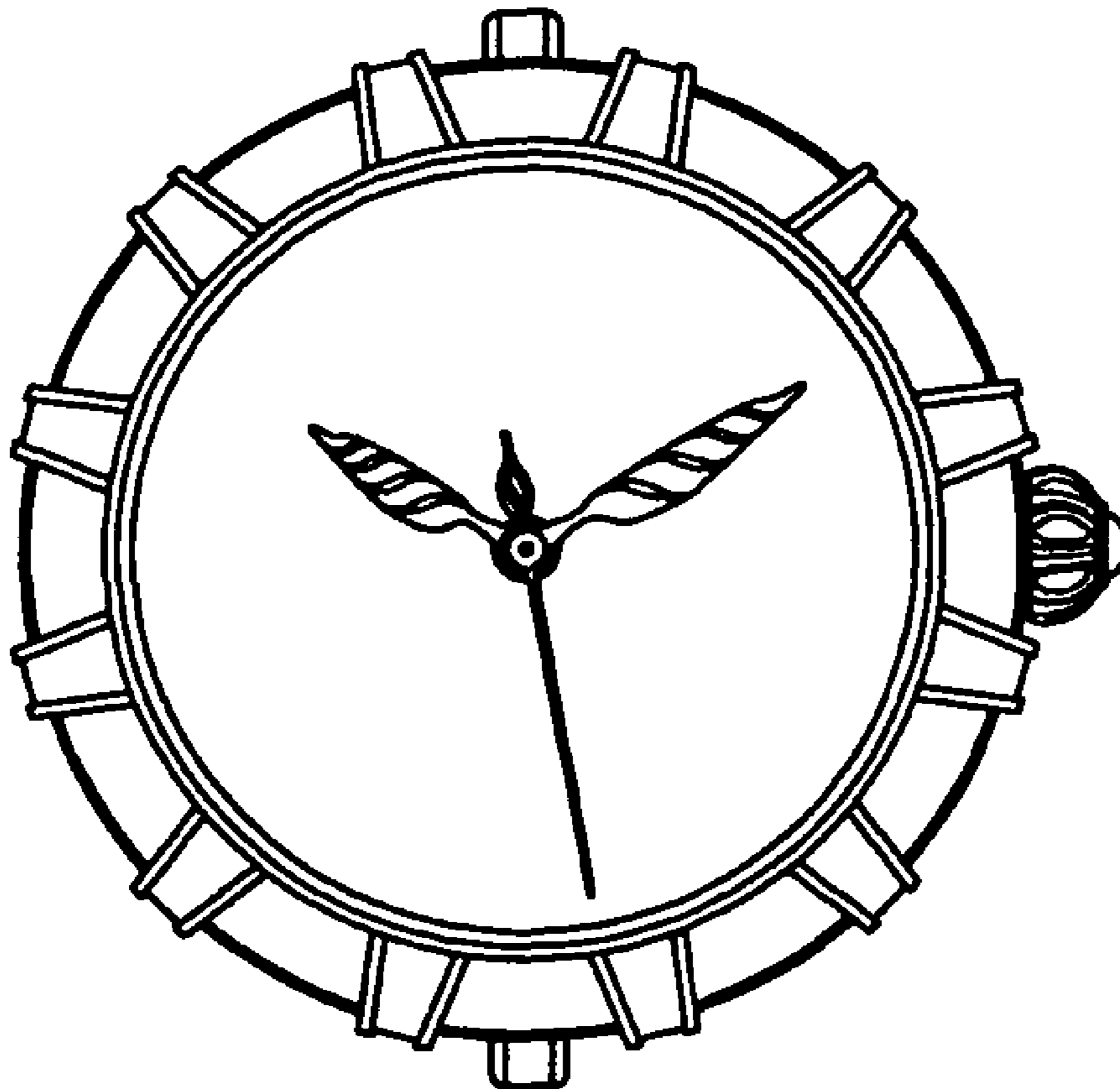
FIG. 4 is a right side view of the watch of FIG. 1.

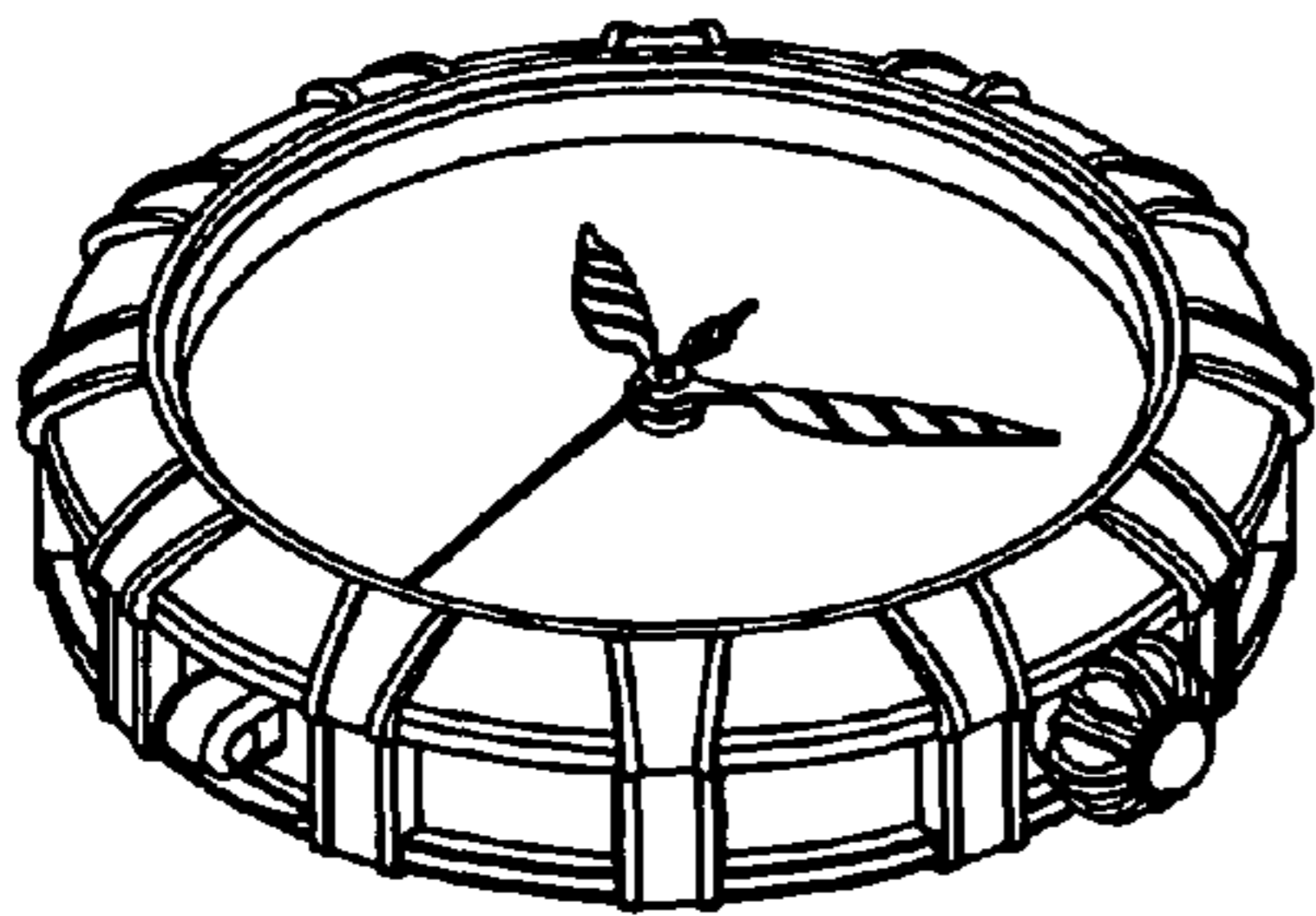

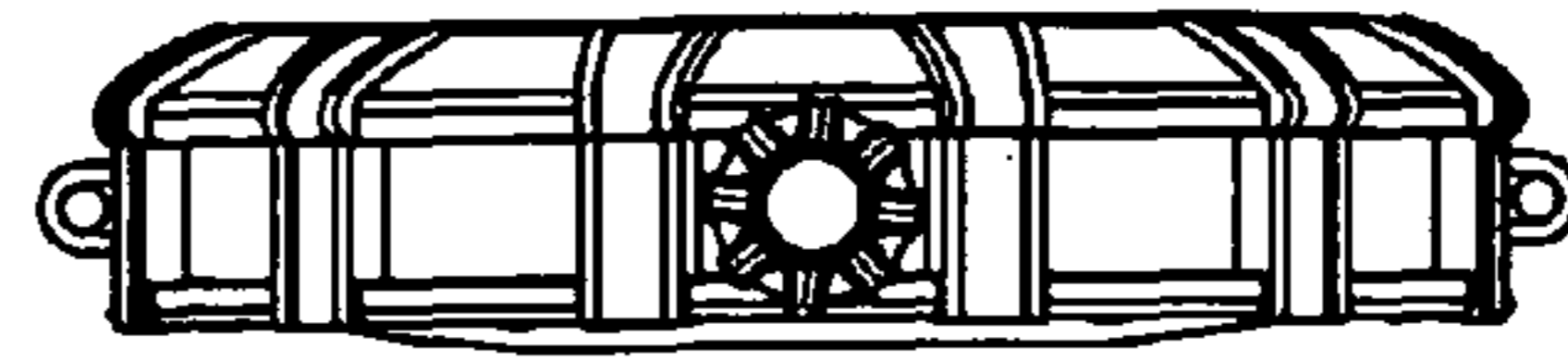

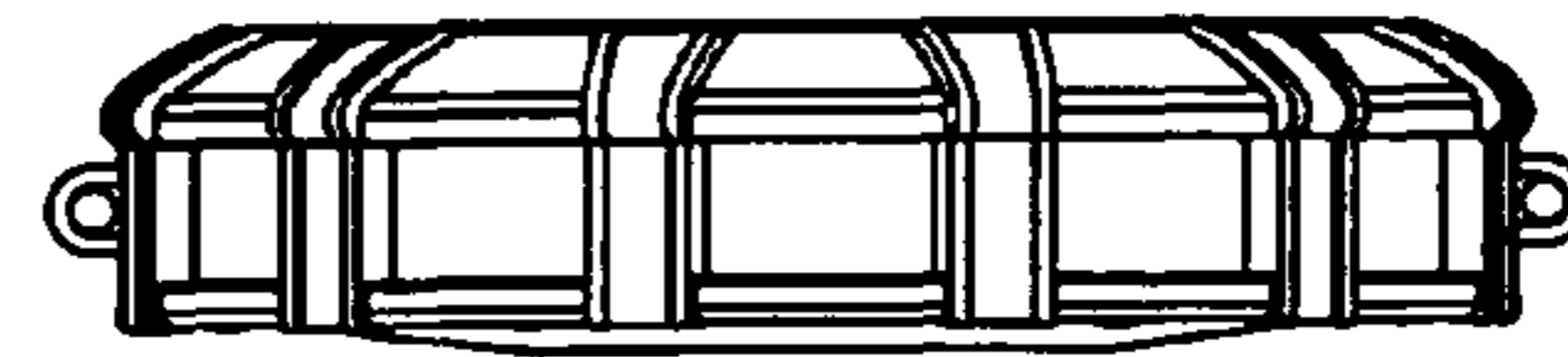

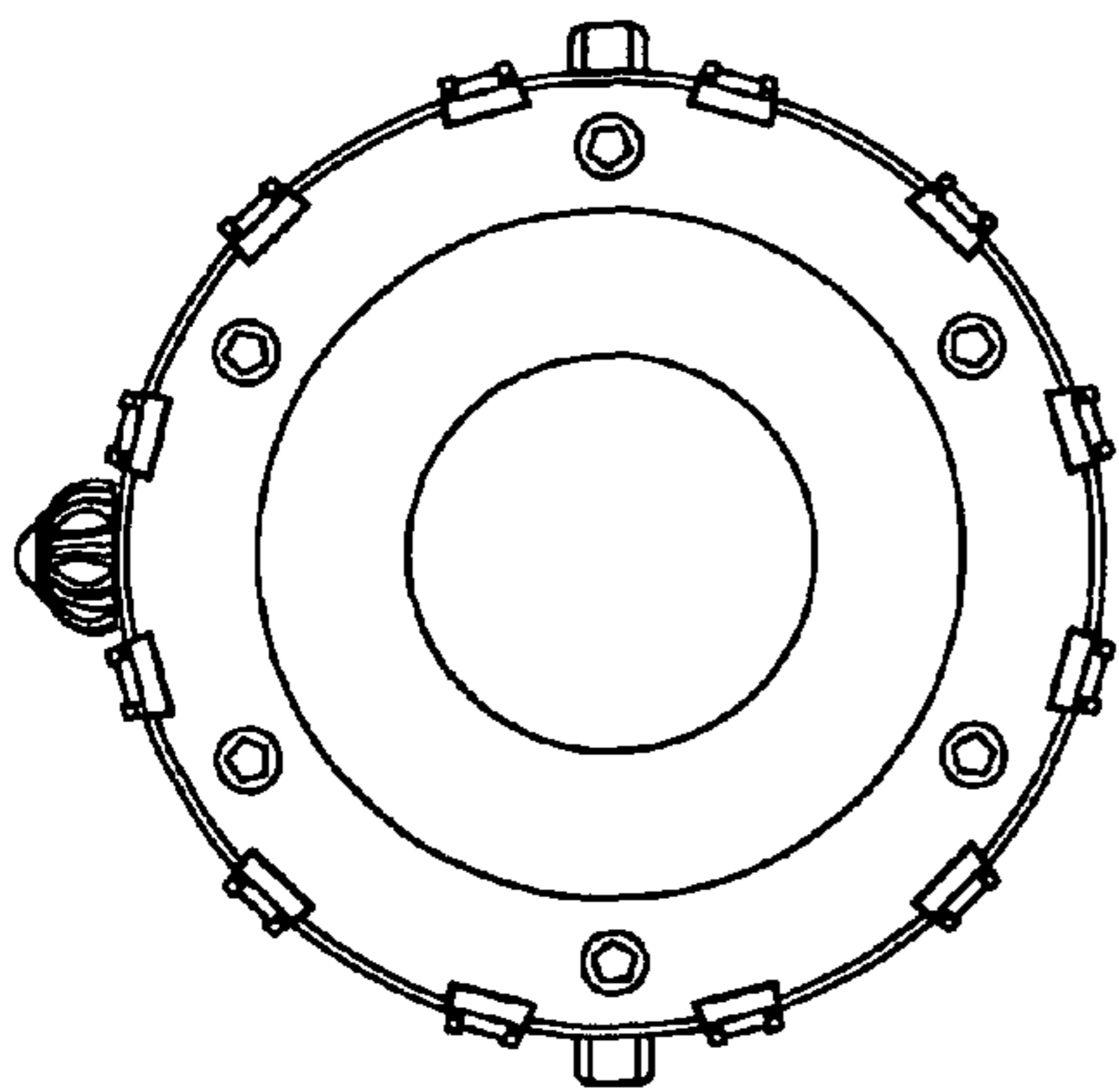

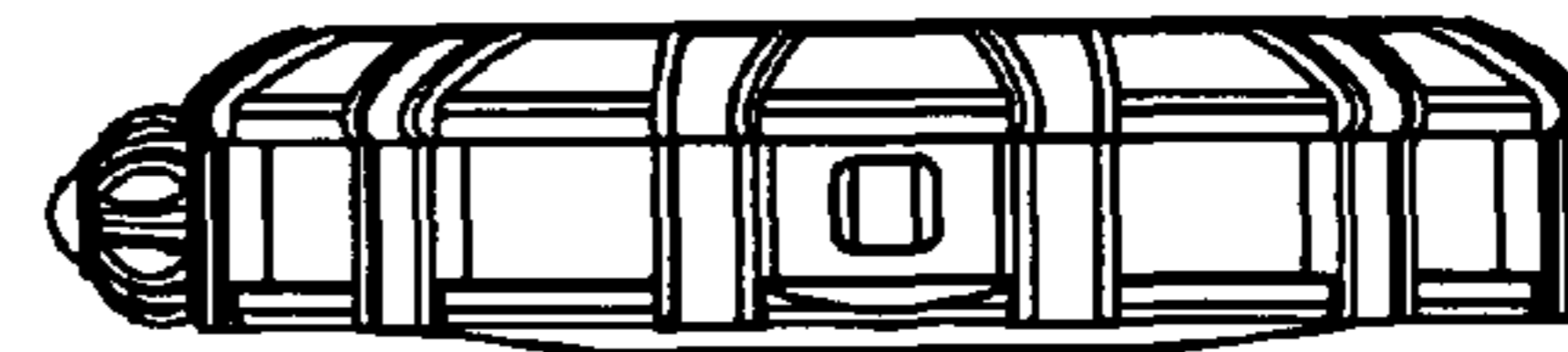

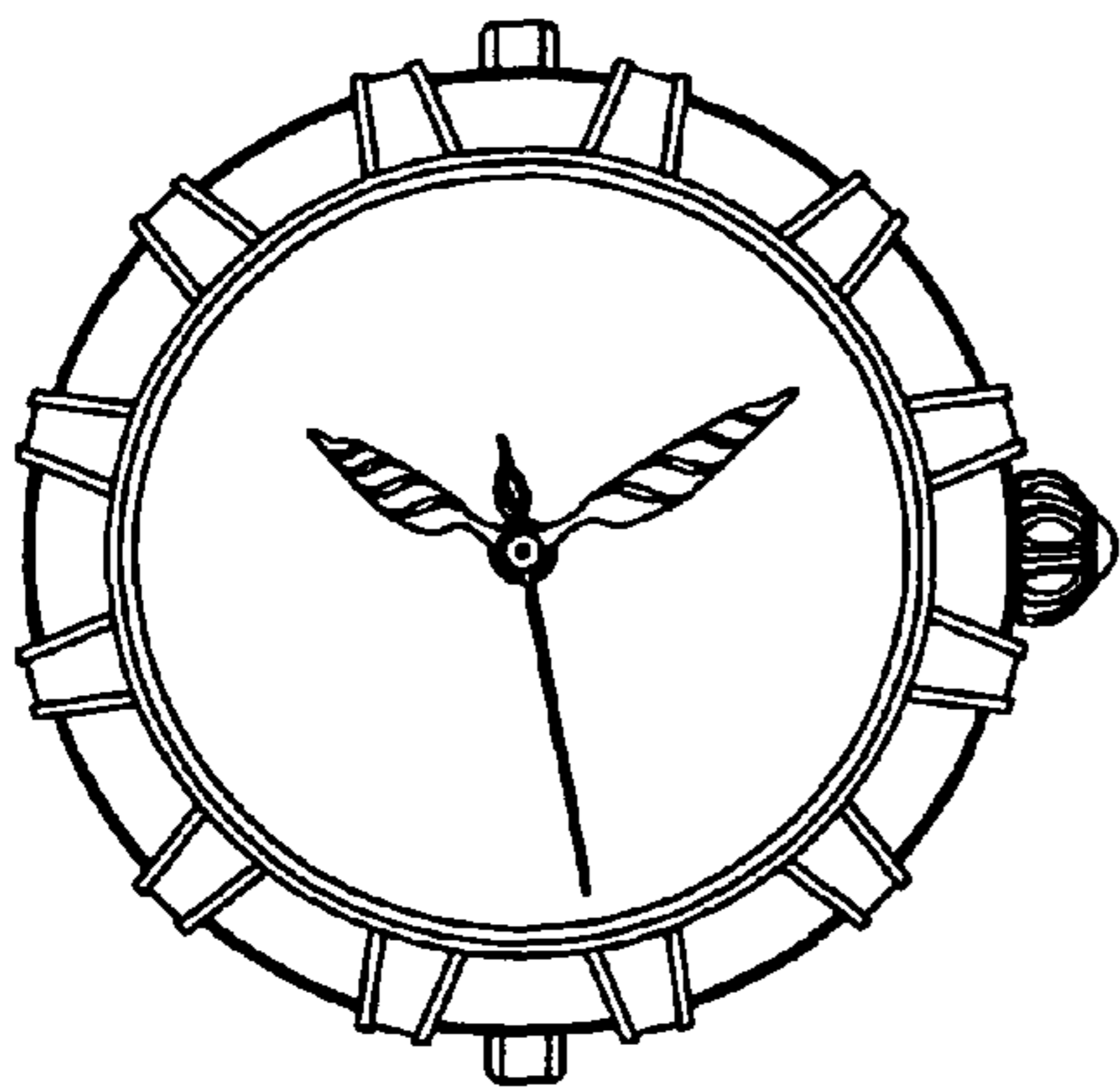

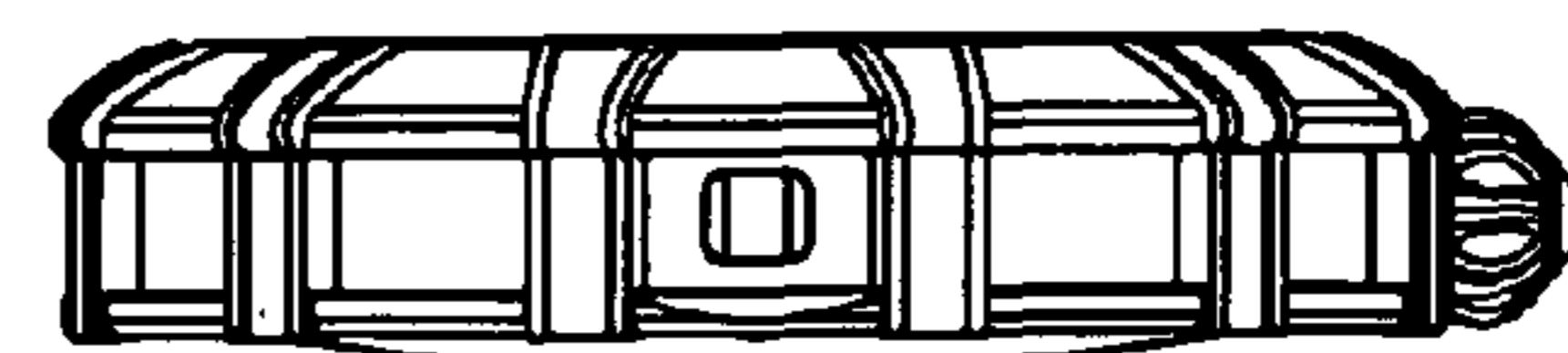
