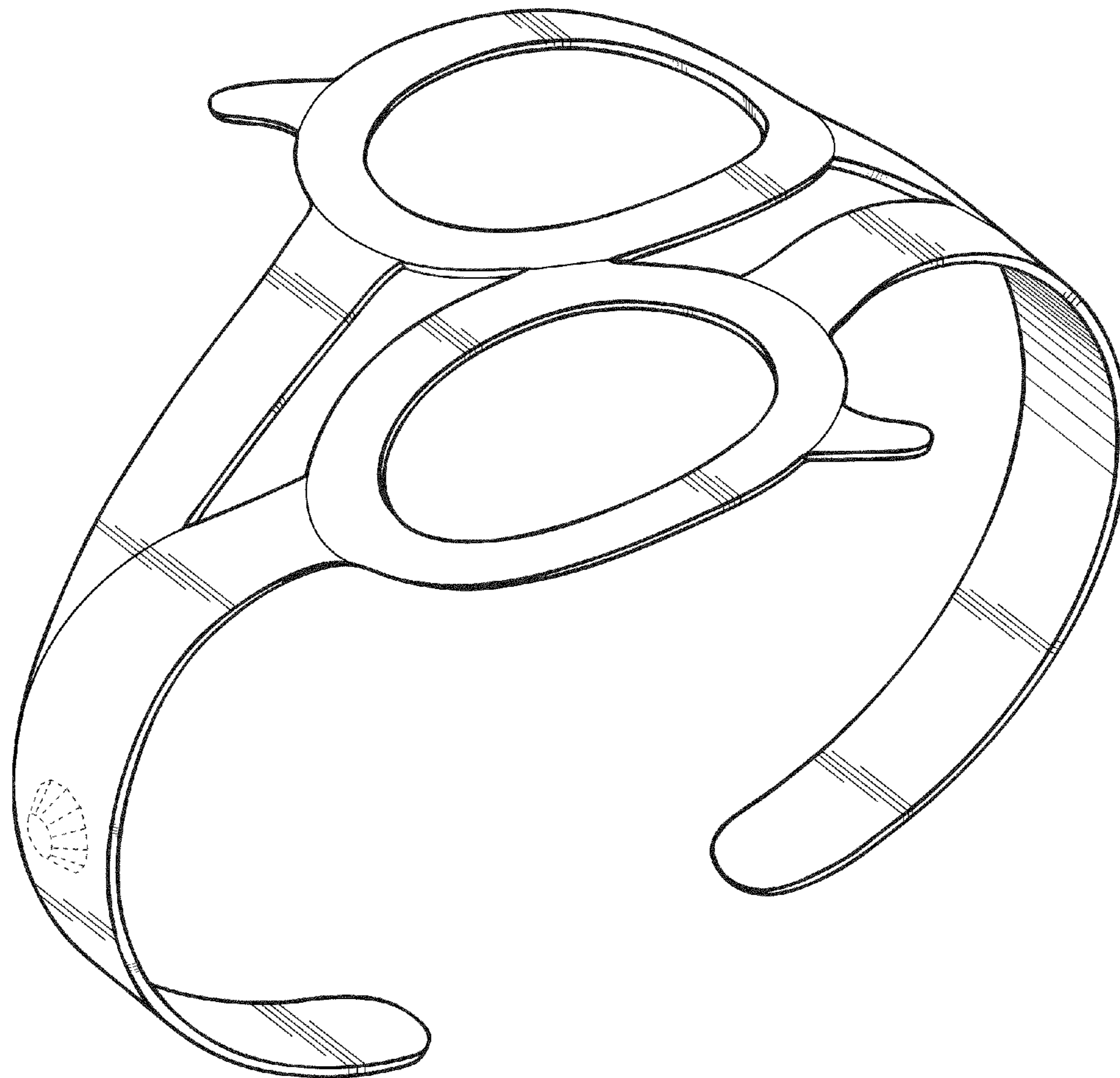

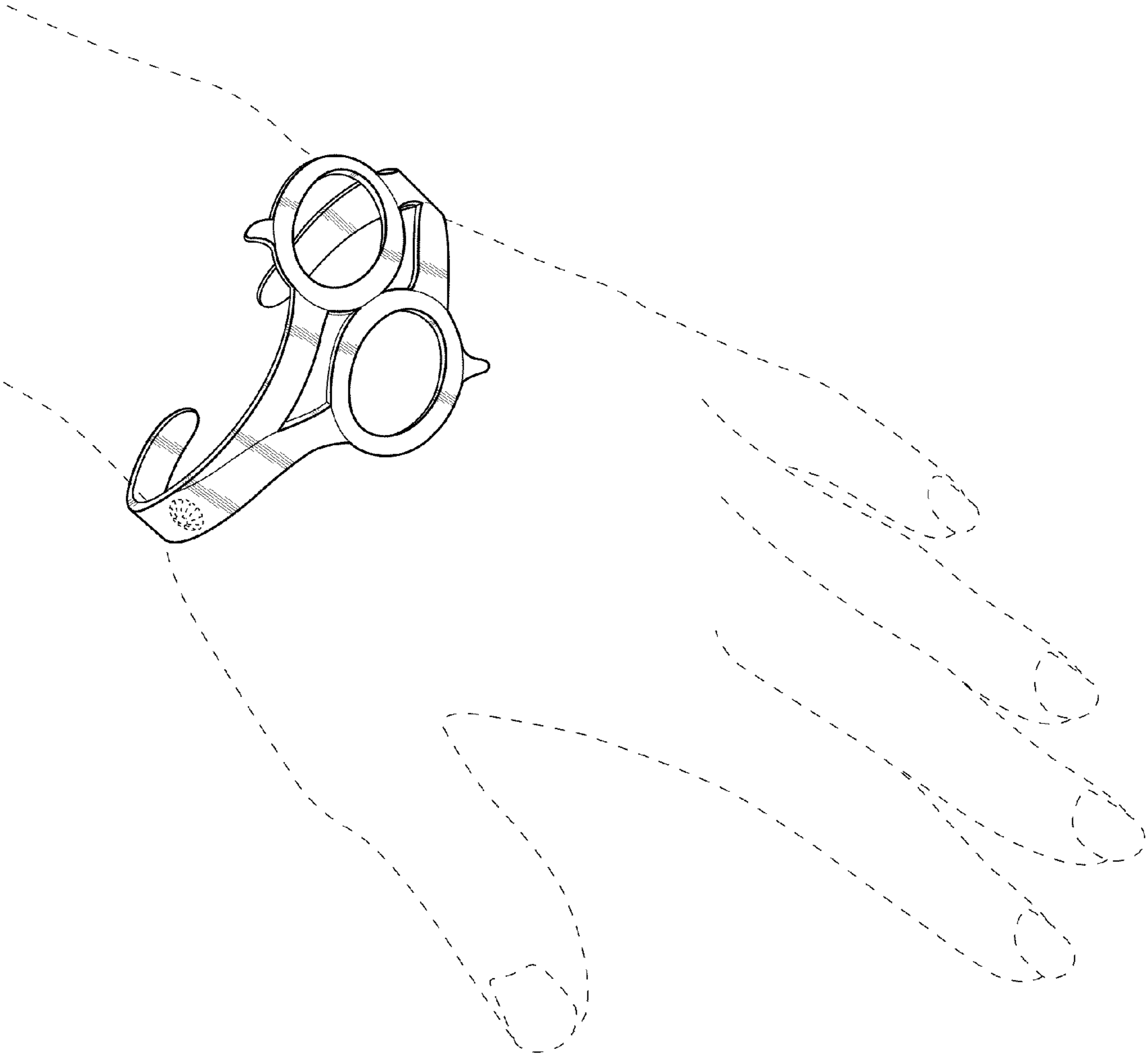
The ornamental design for a bracelet, as shown and described.

**DESCRIPTION**

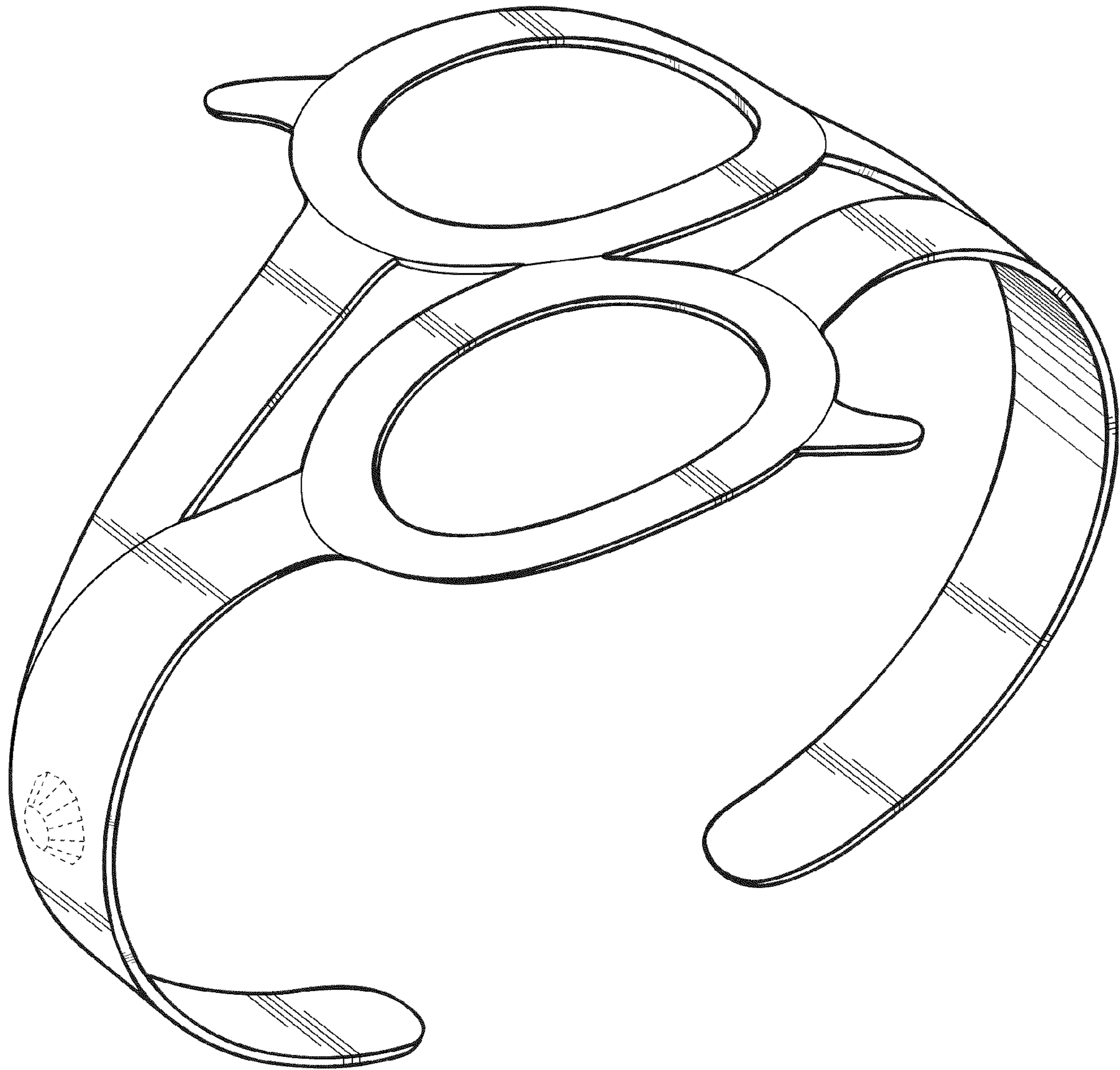
FIG. 1 is a perspective view of a bracelet of the present invention;

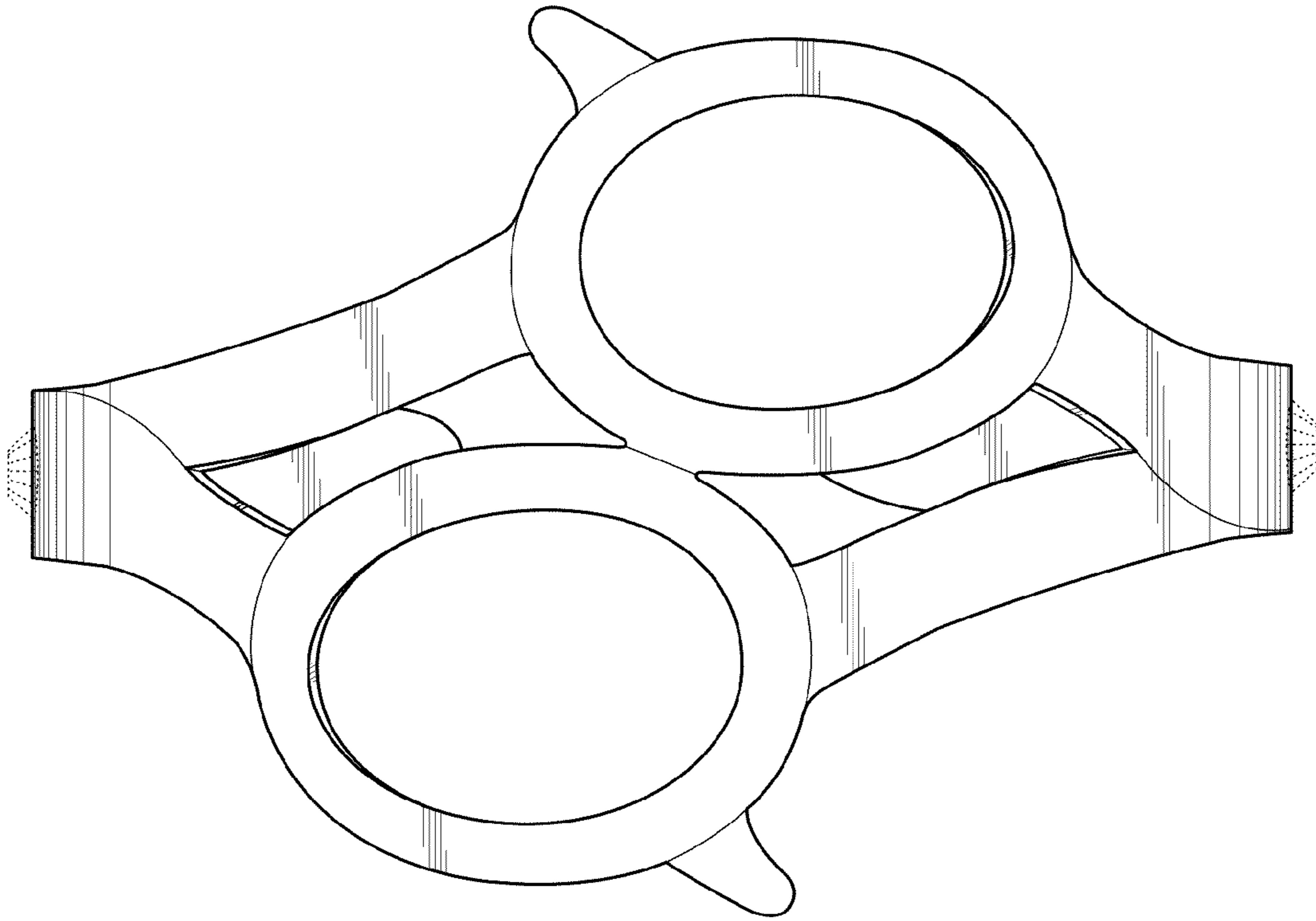




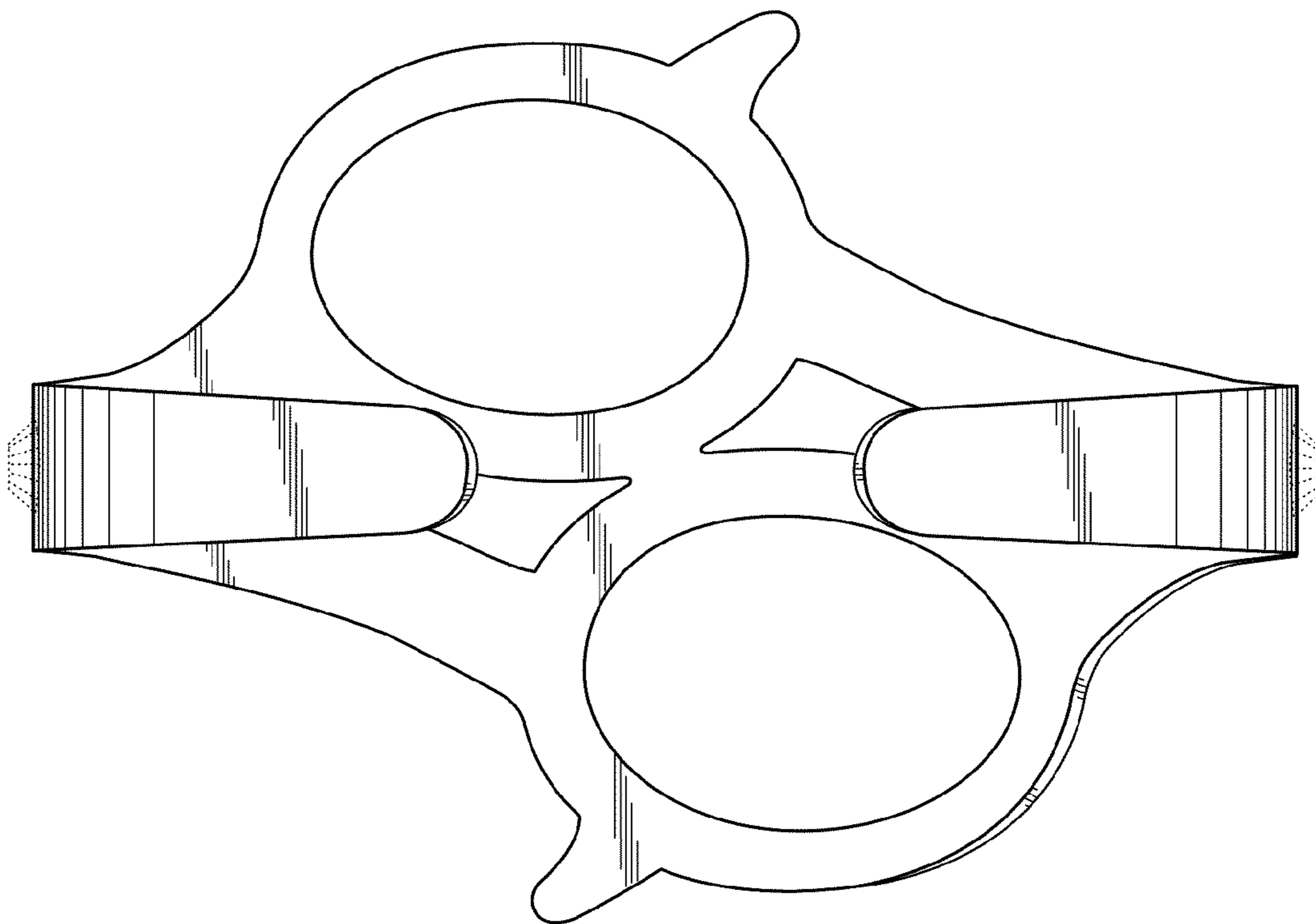

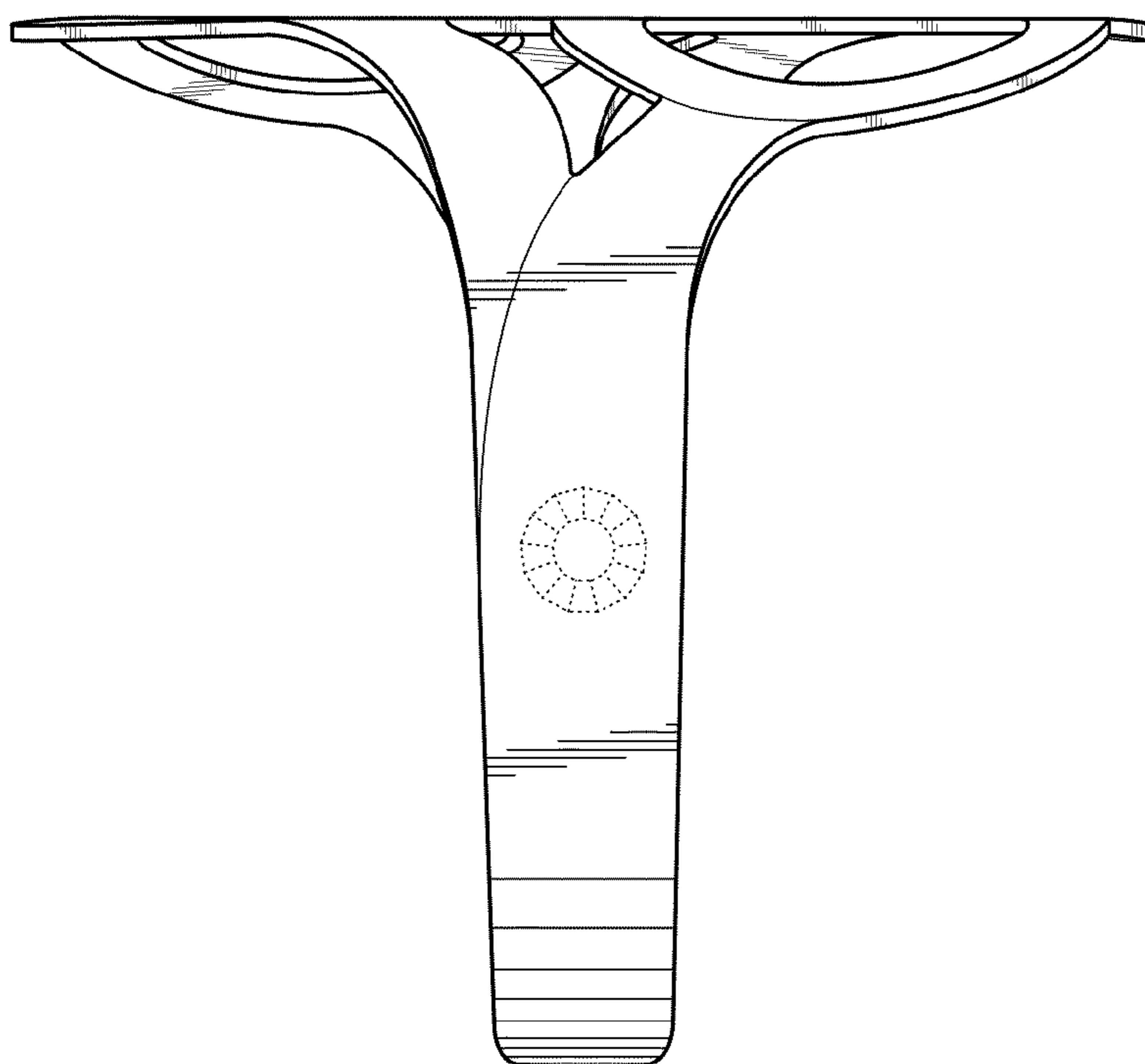

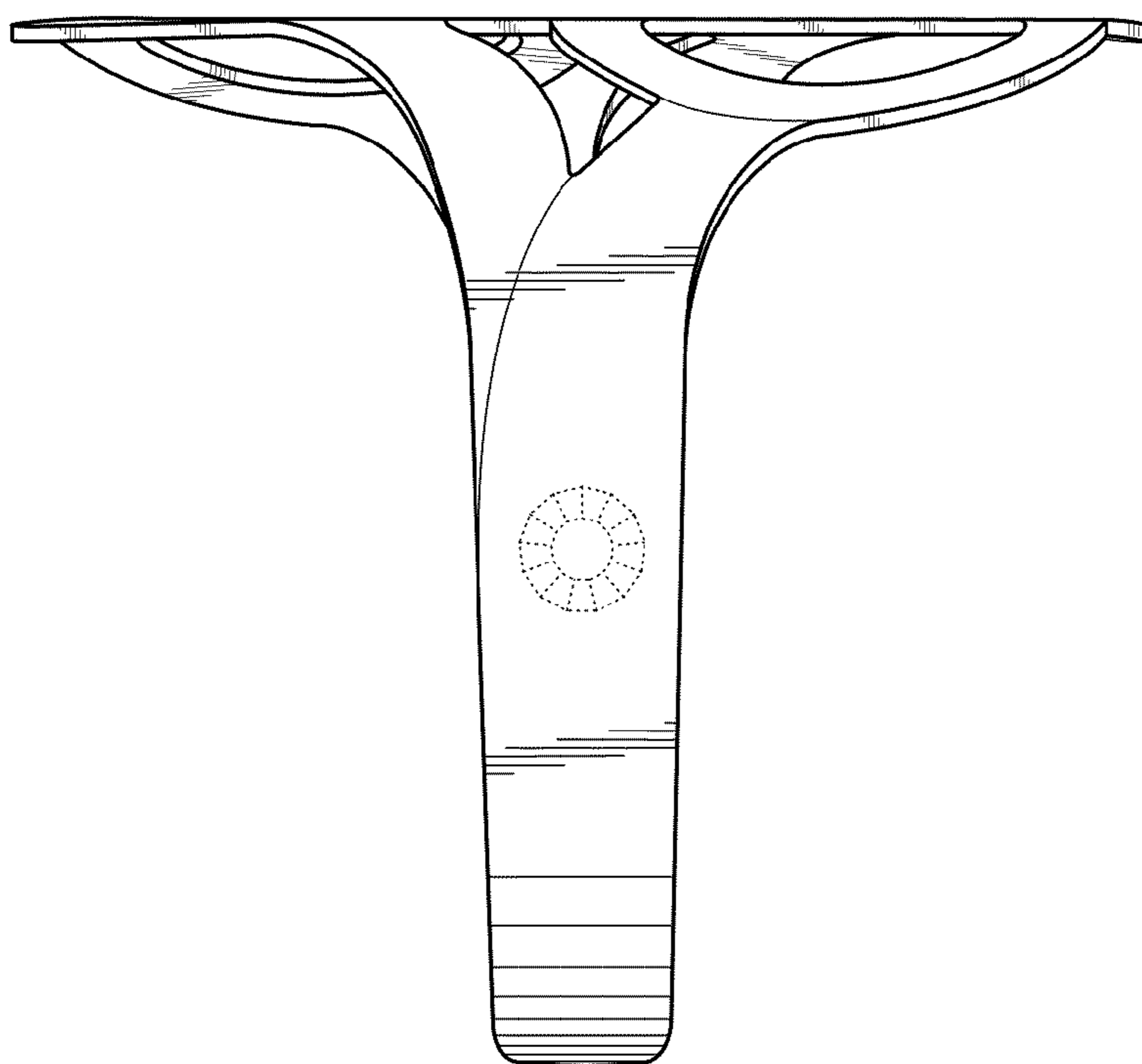

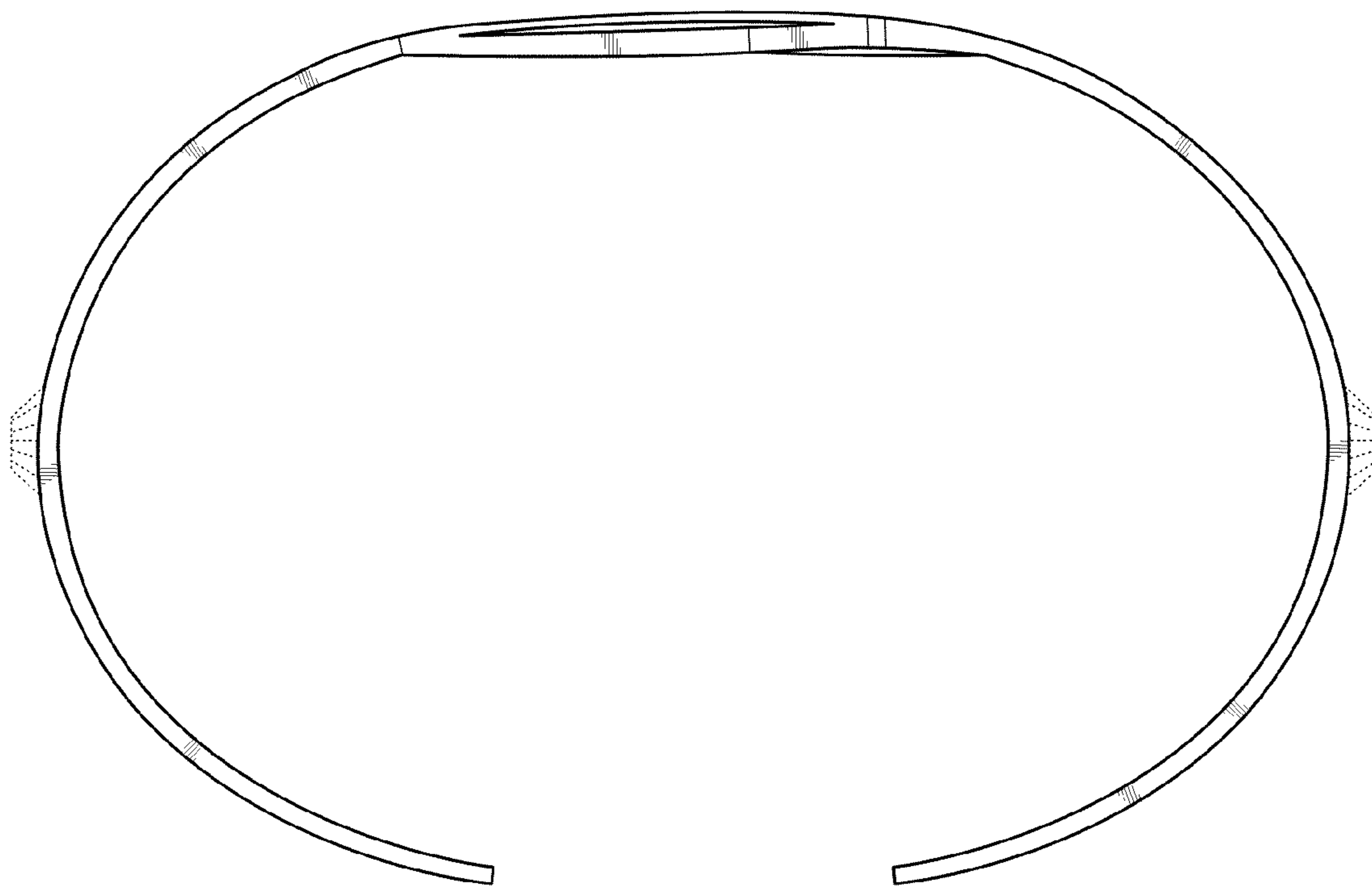




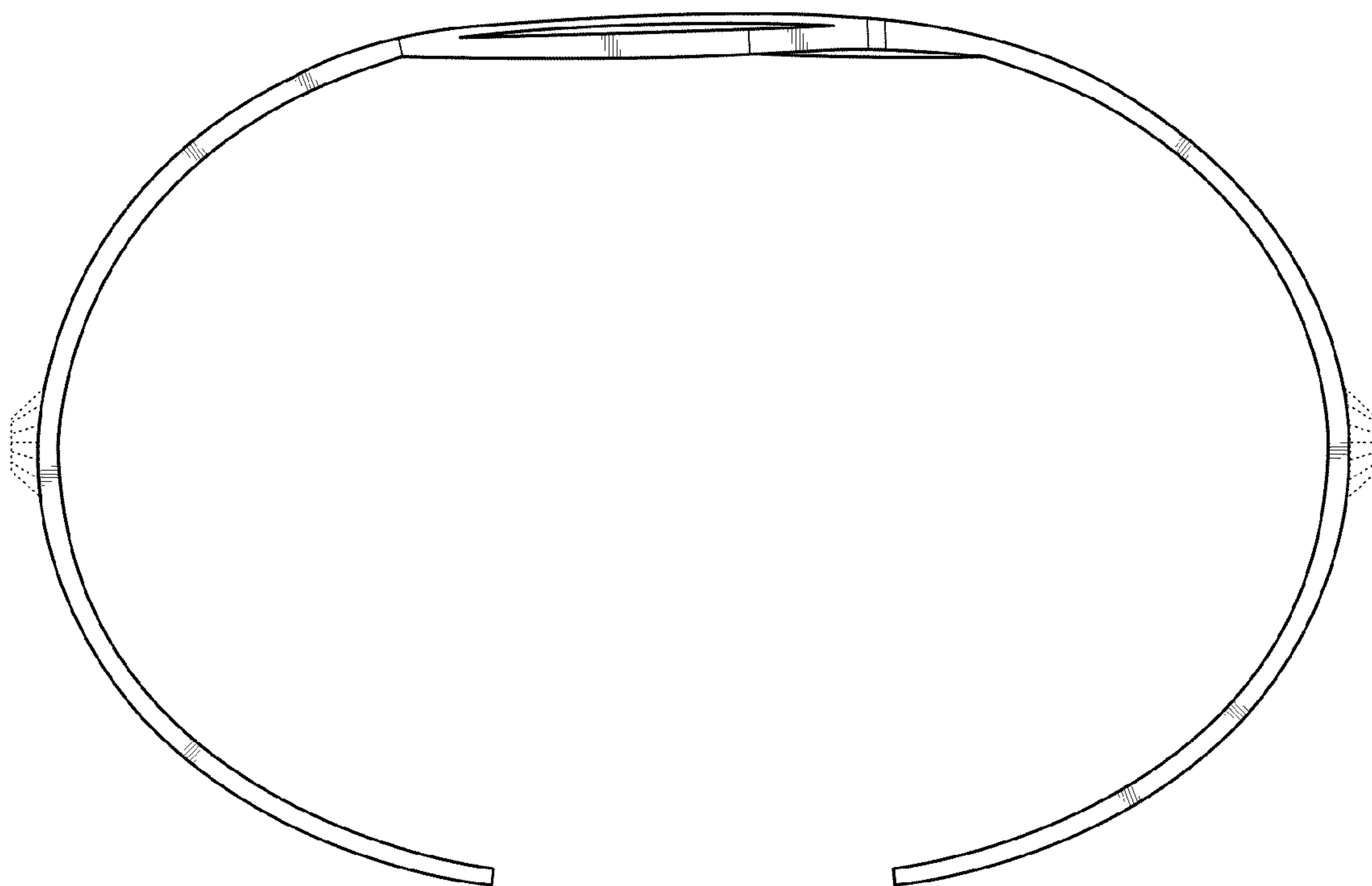
