**DESCRIPTION**

FIG. 2 is a rear view of the jewel ornament.

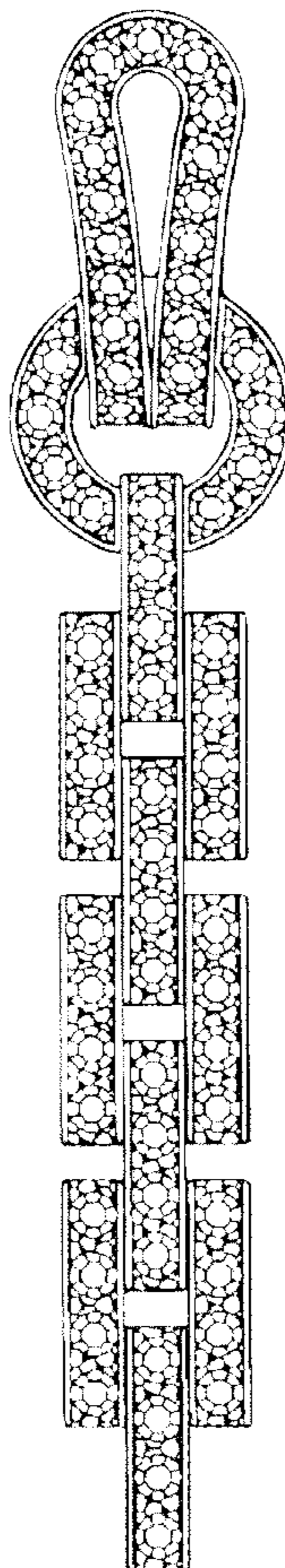
FIG. 3 is a left side view of the jewel ornament; a right side view is a mirror image.

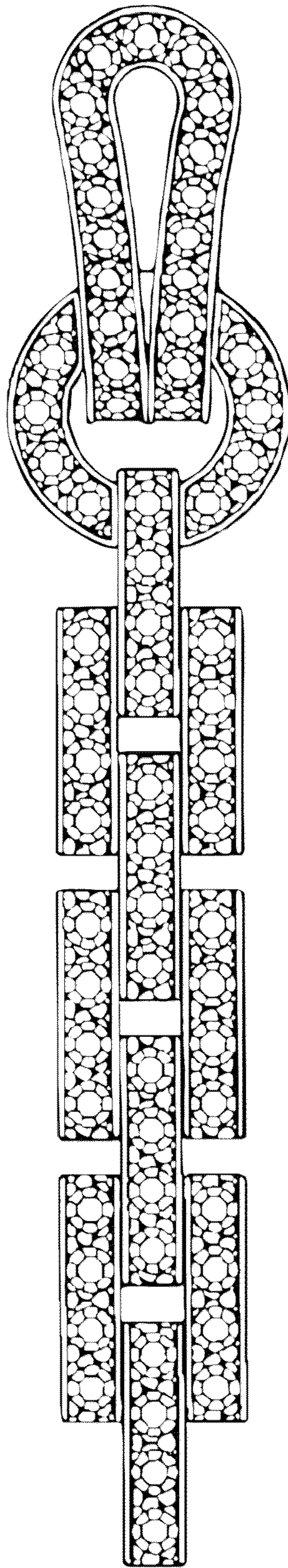

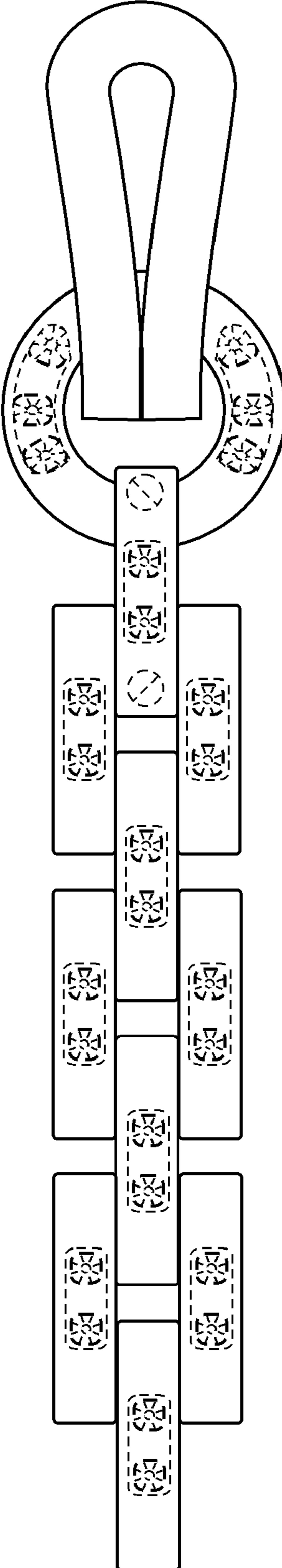

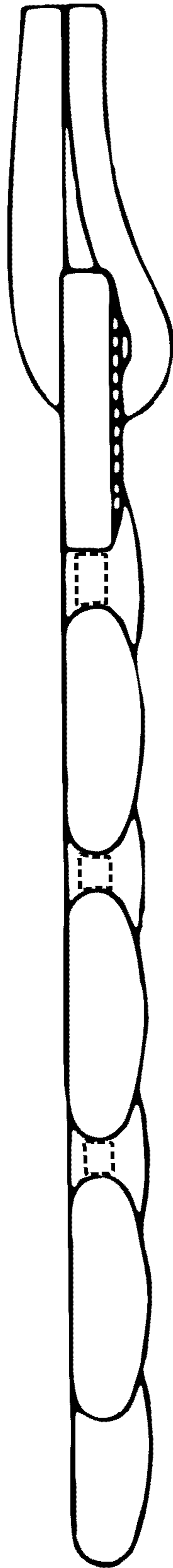
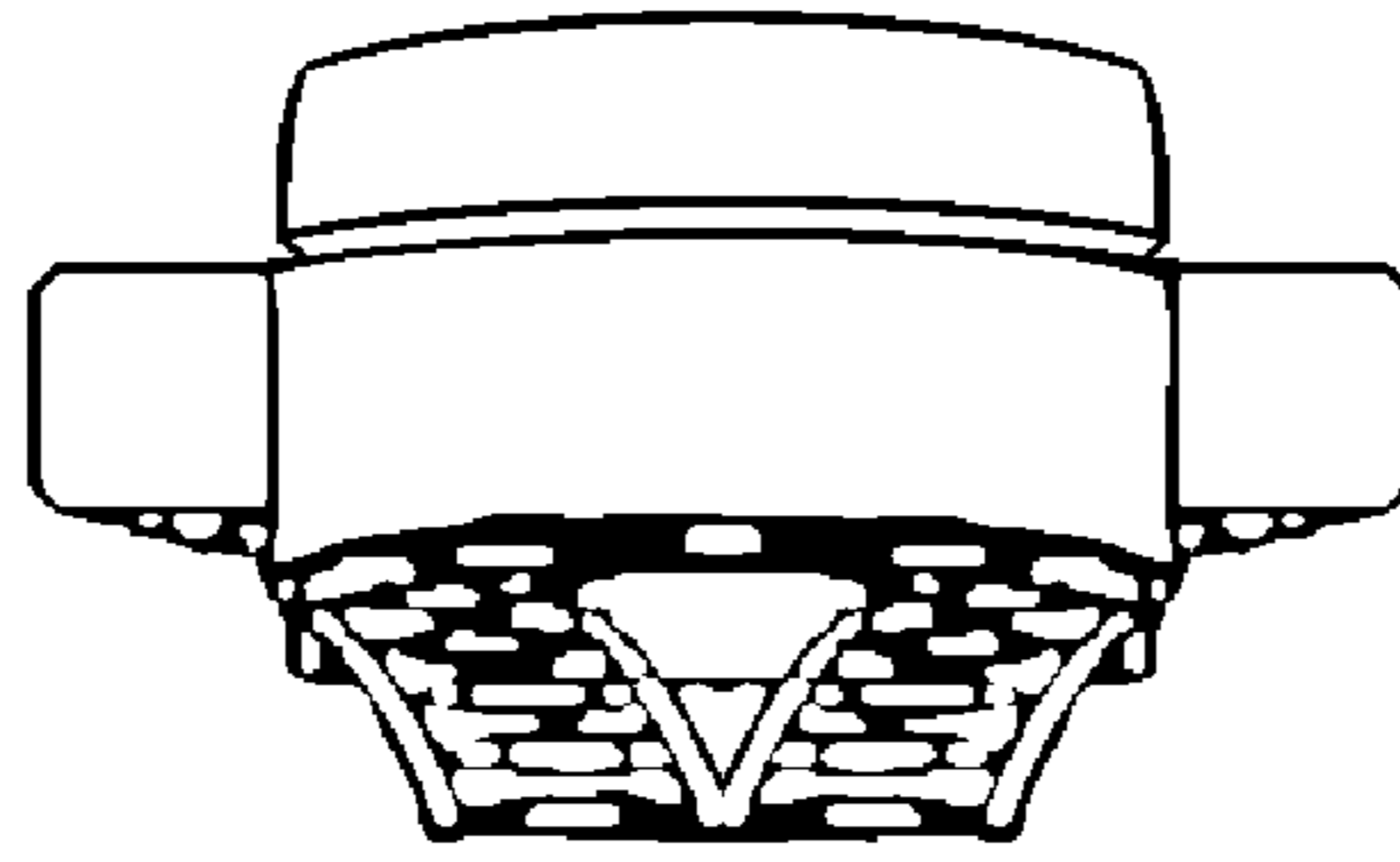
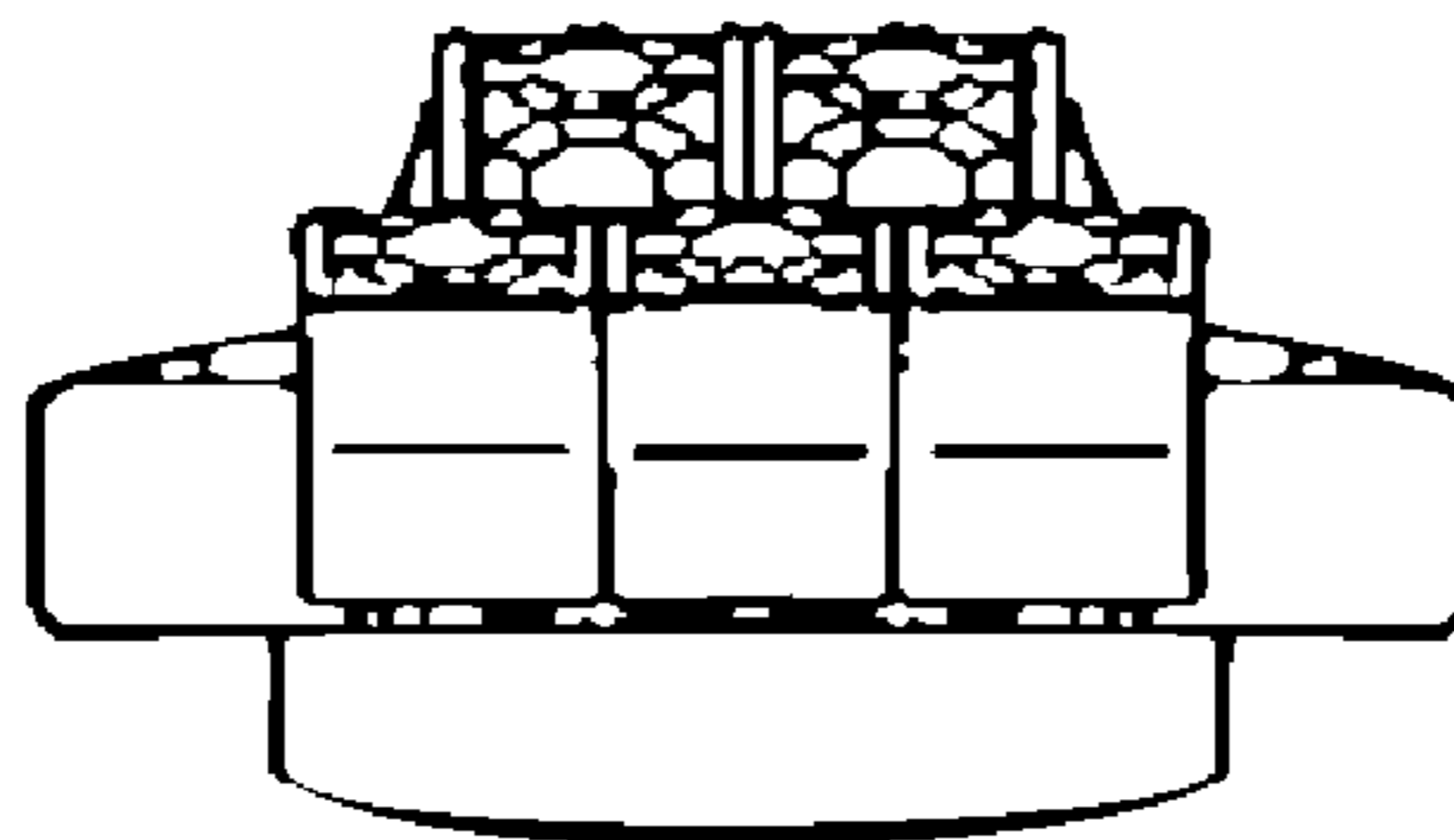
