The ornamental design for a vehicle front bumper unit, as shown and described.

FIG. 4 is a side elevational view of one side thereof, the opposite side elevational view being a mirror image.

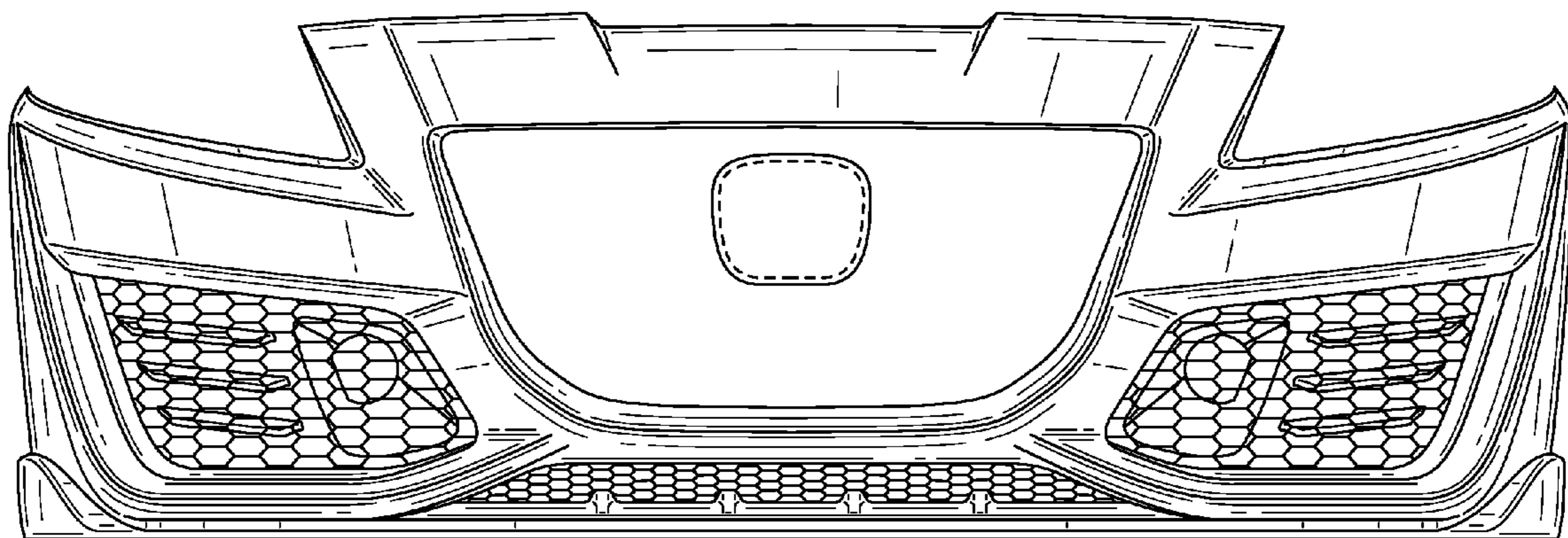

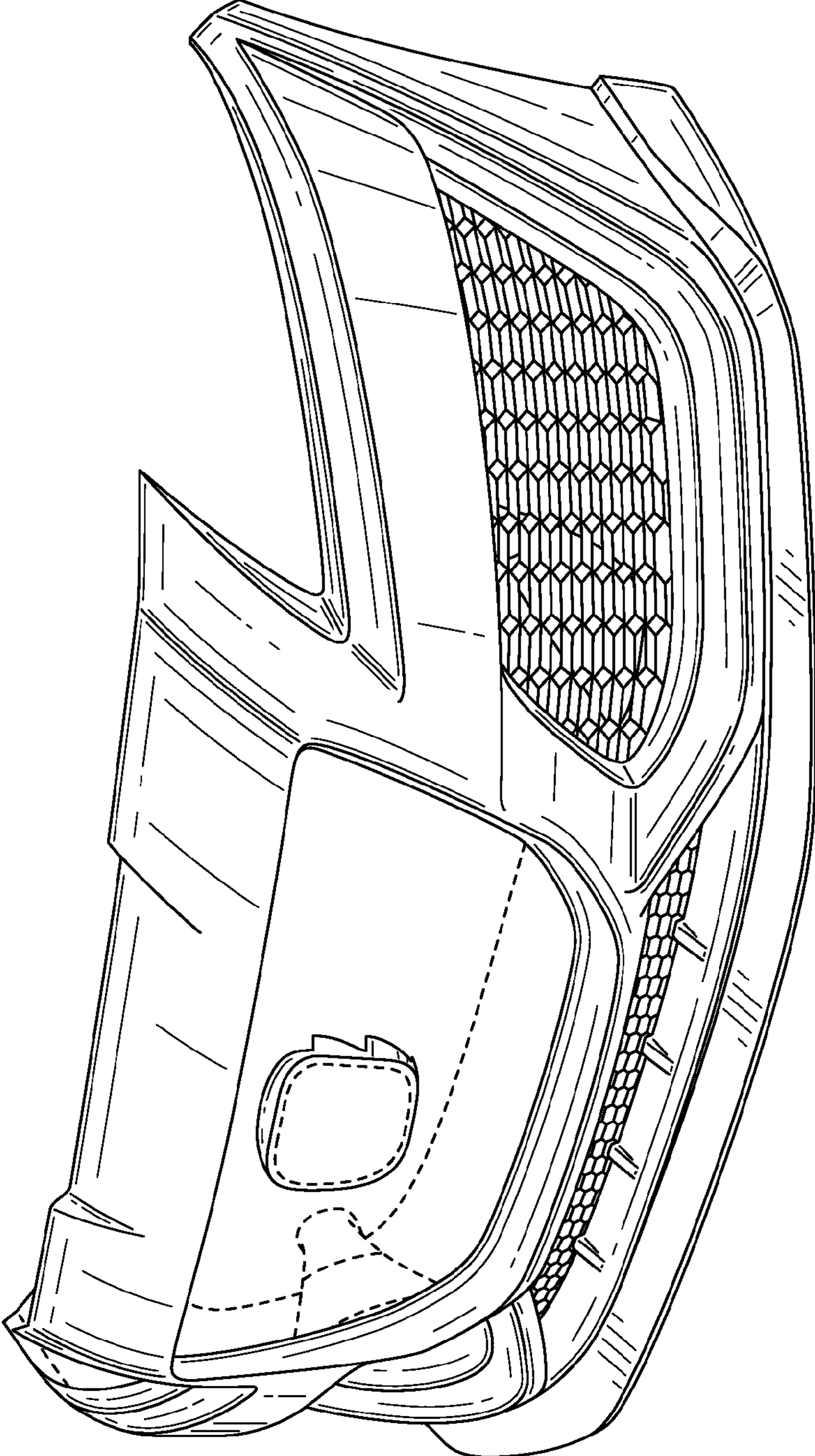

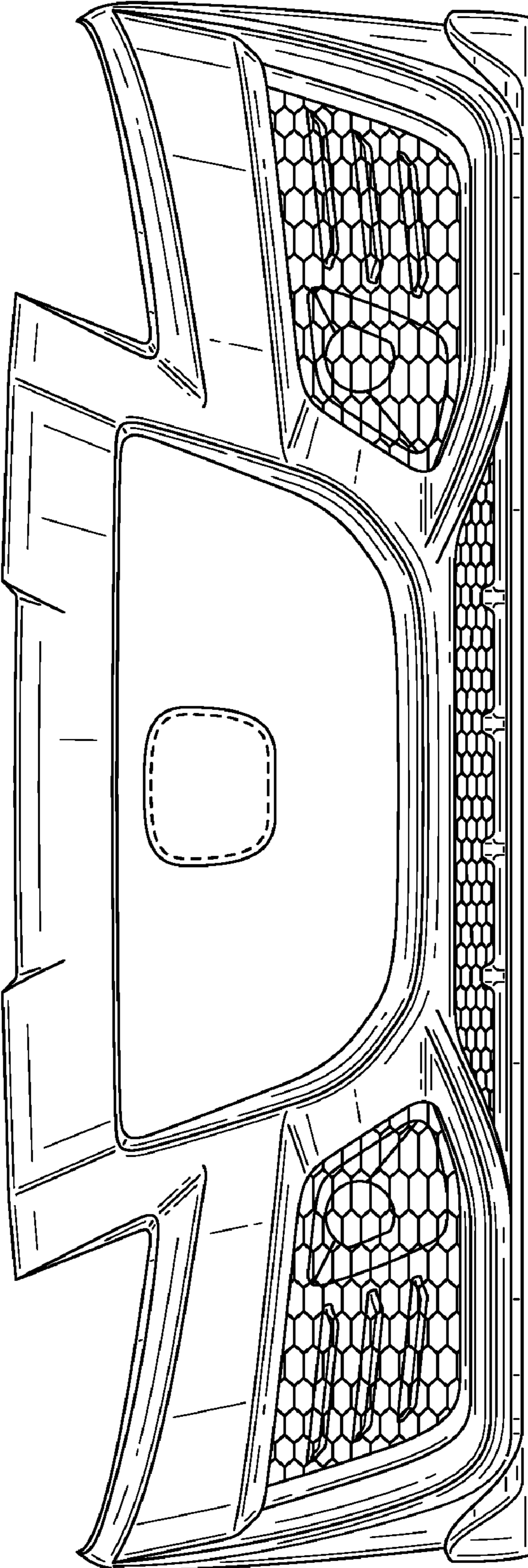

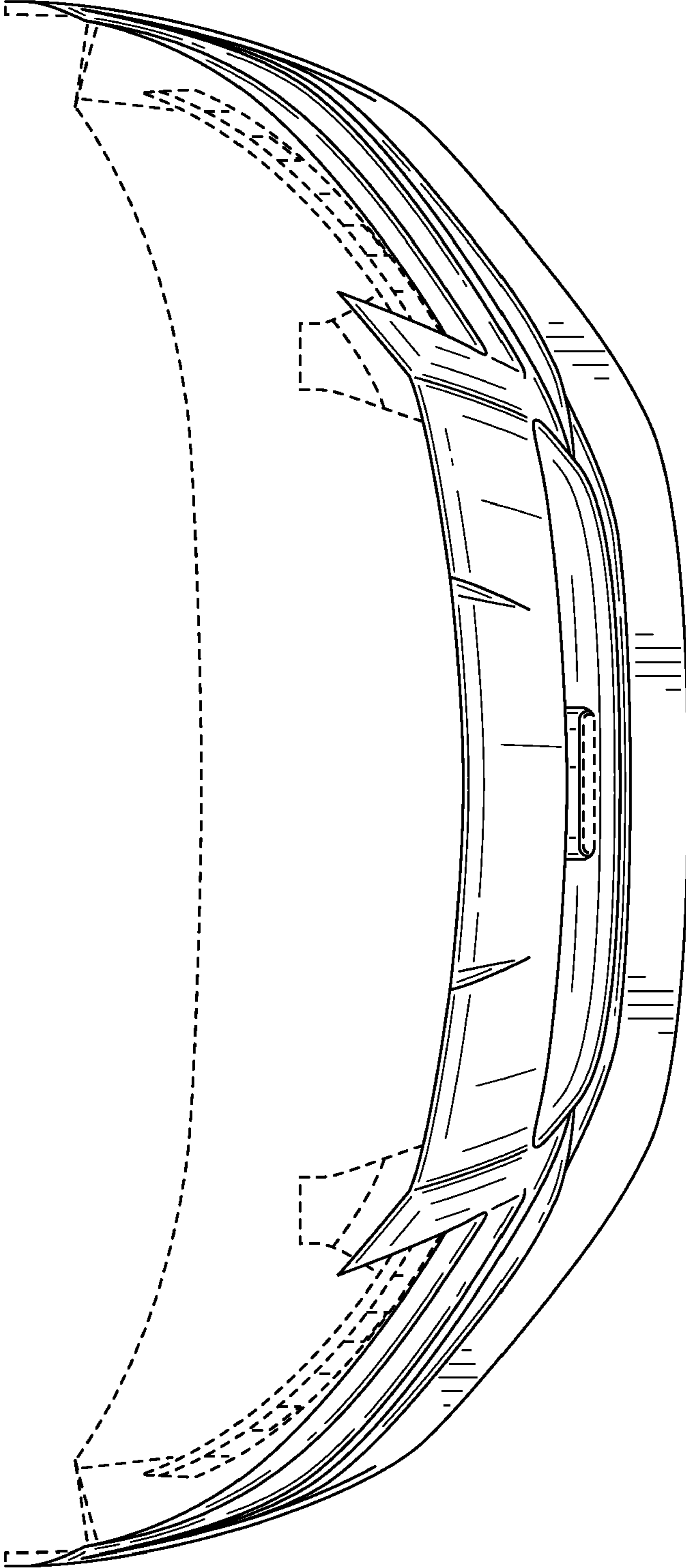

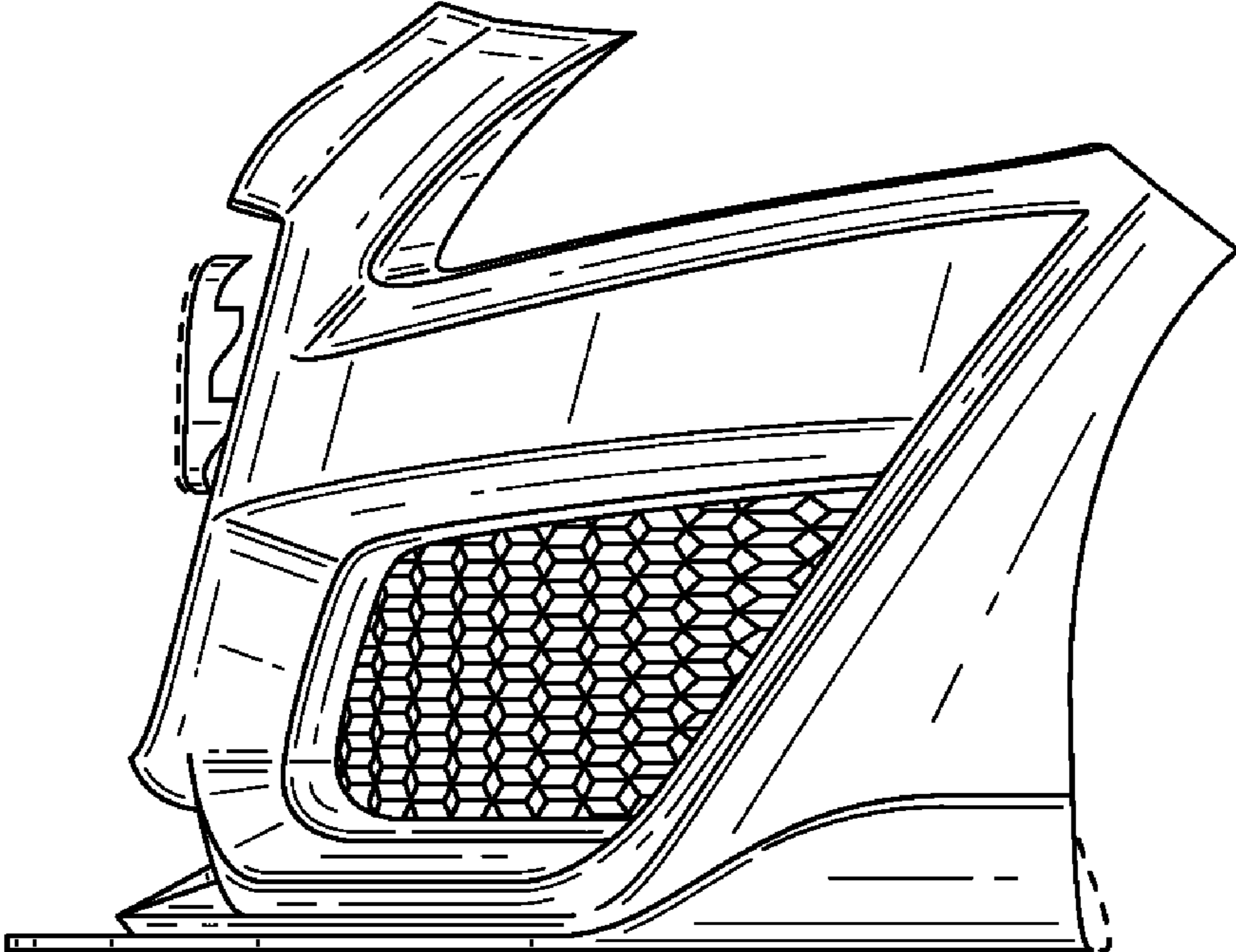
