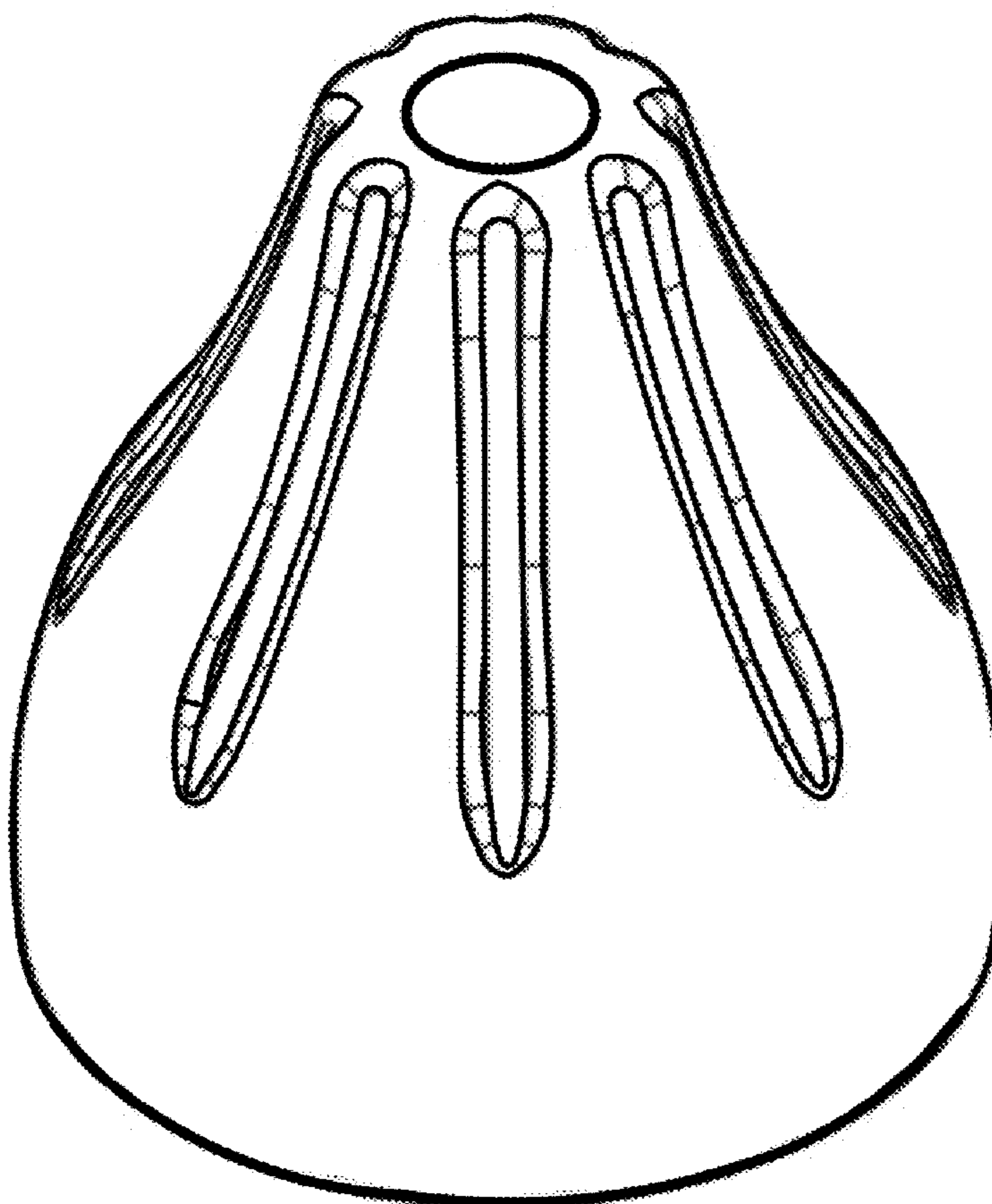
(57) **CLAIM**

The ornamental design for a partially occluding ergonomic earbud adapter, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the partially occluding ergonomic earbud adapter showing my new design.
FIG. 2 is a bottom perspective view thereof, the broken lines form no part of the claimed design;

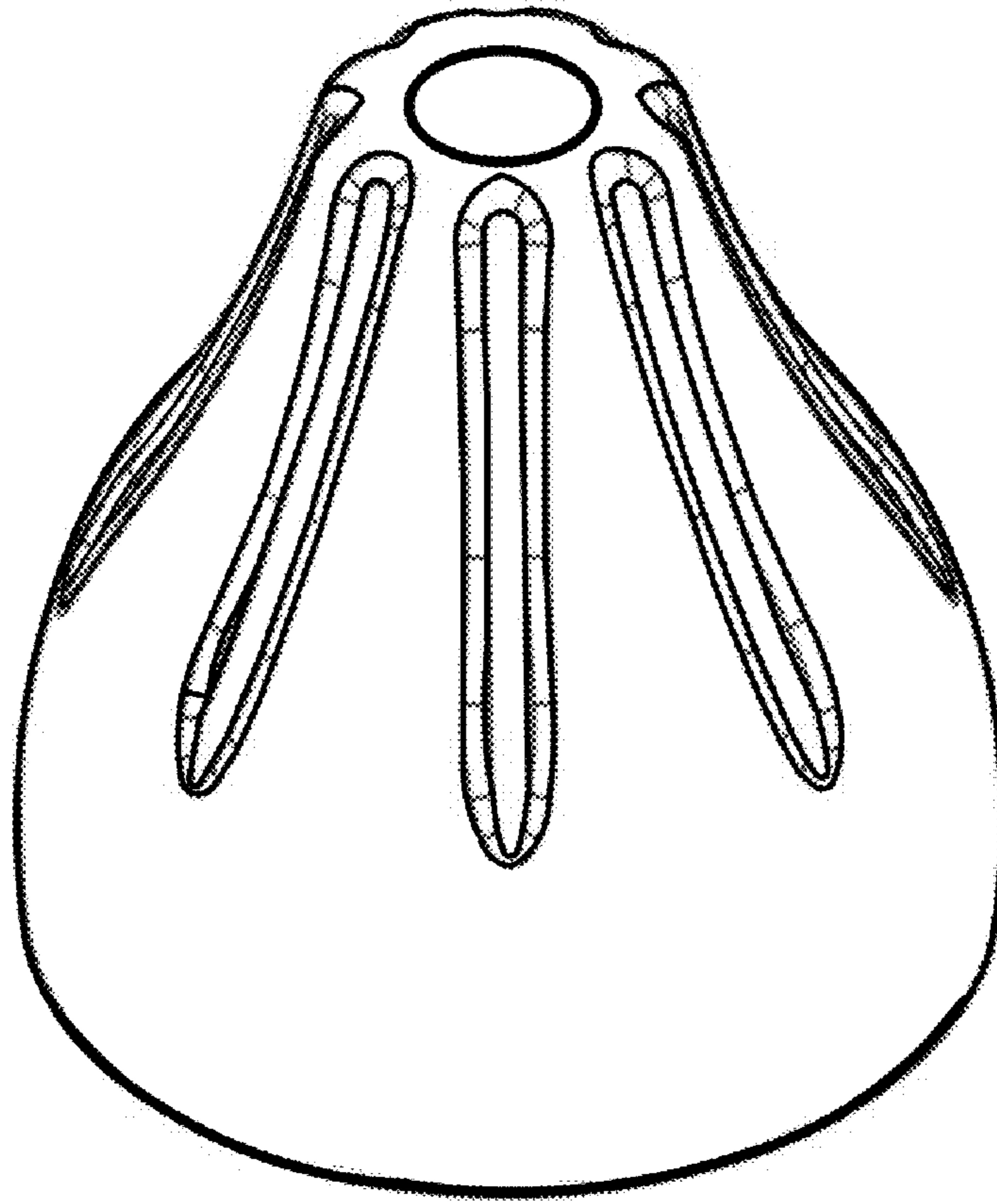

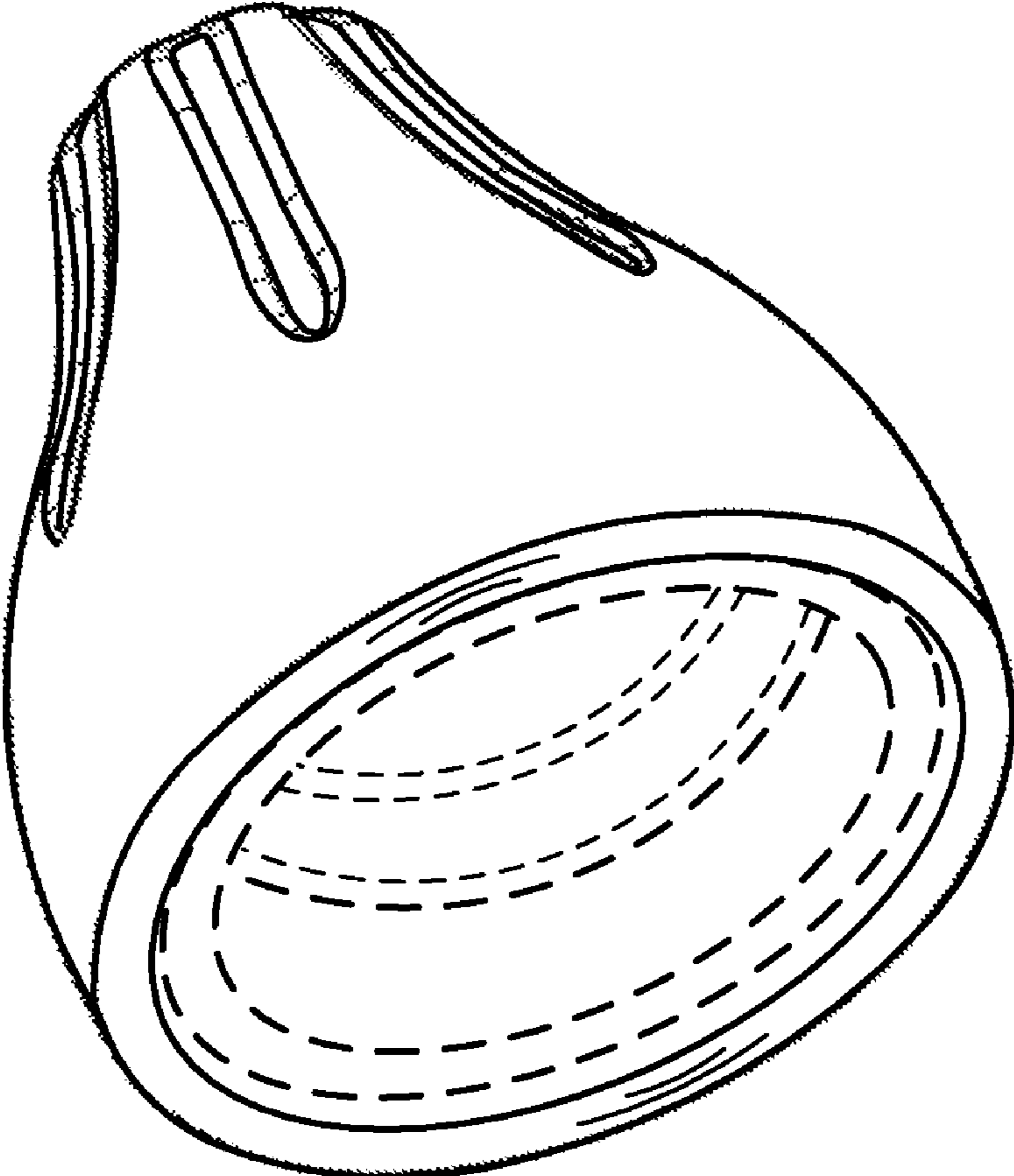

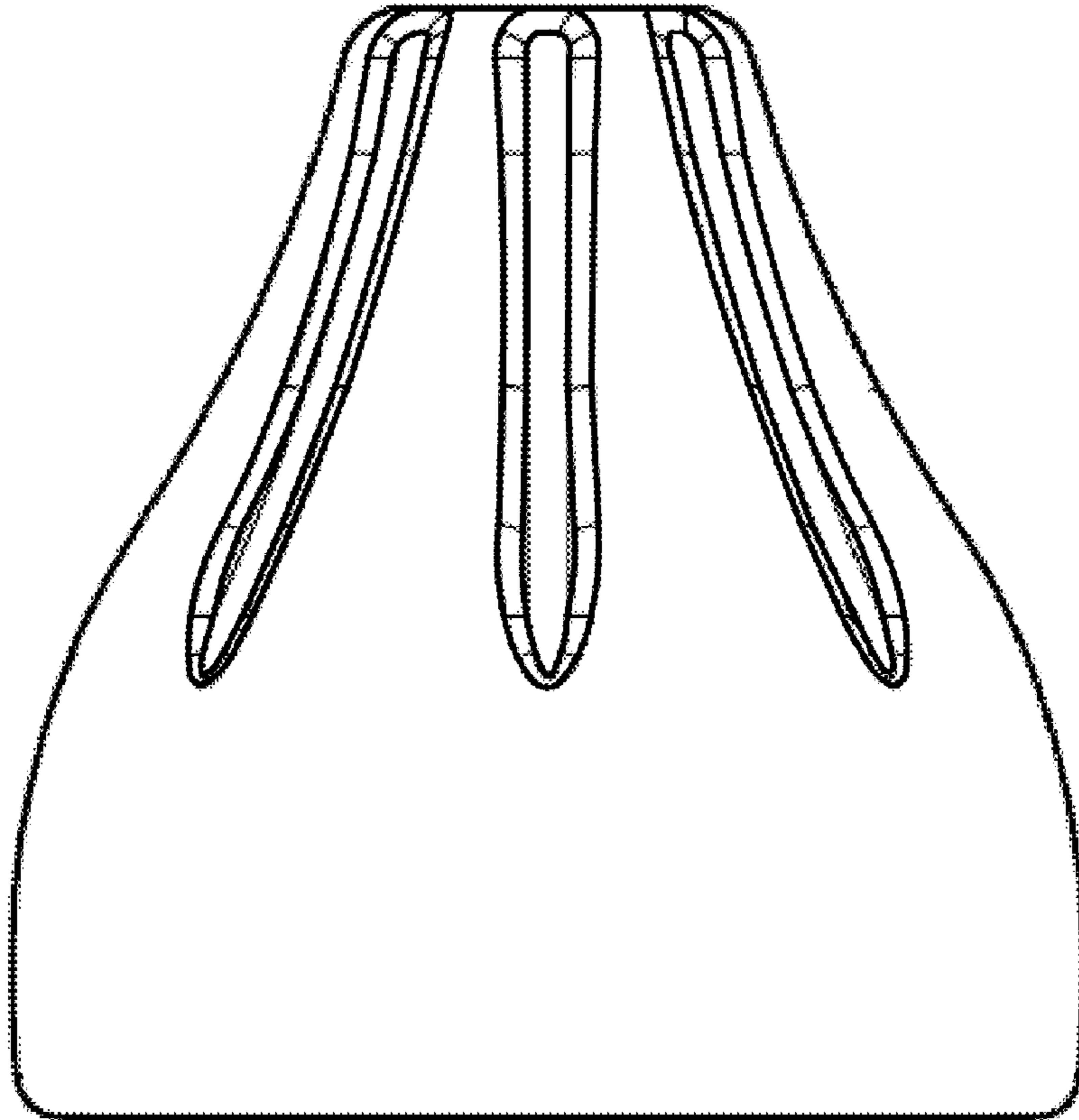

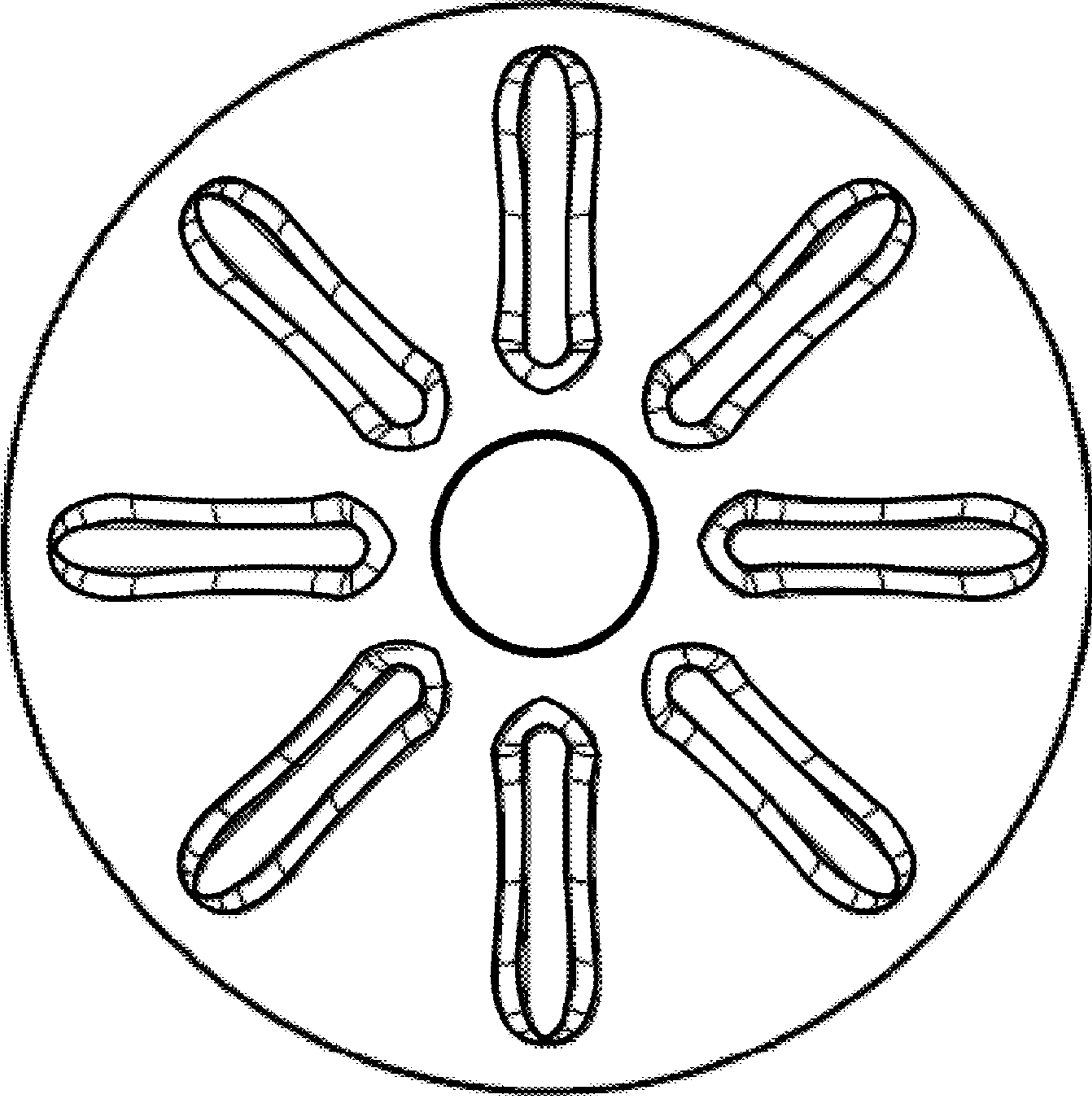

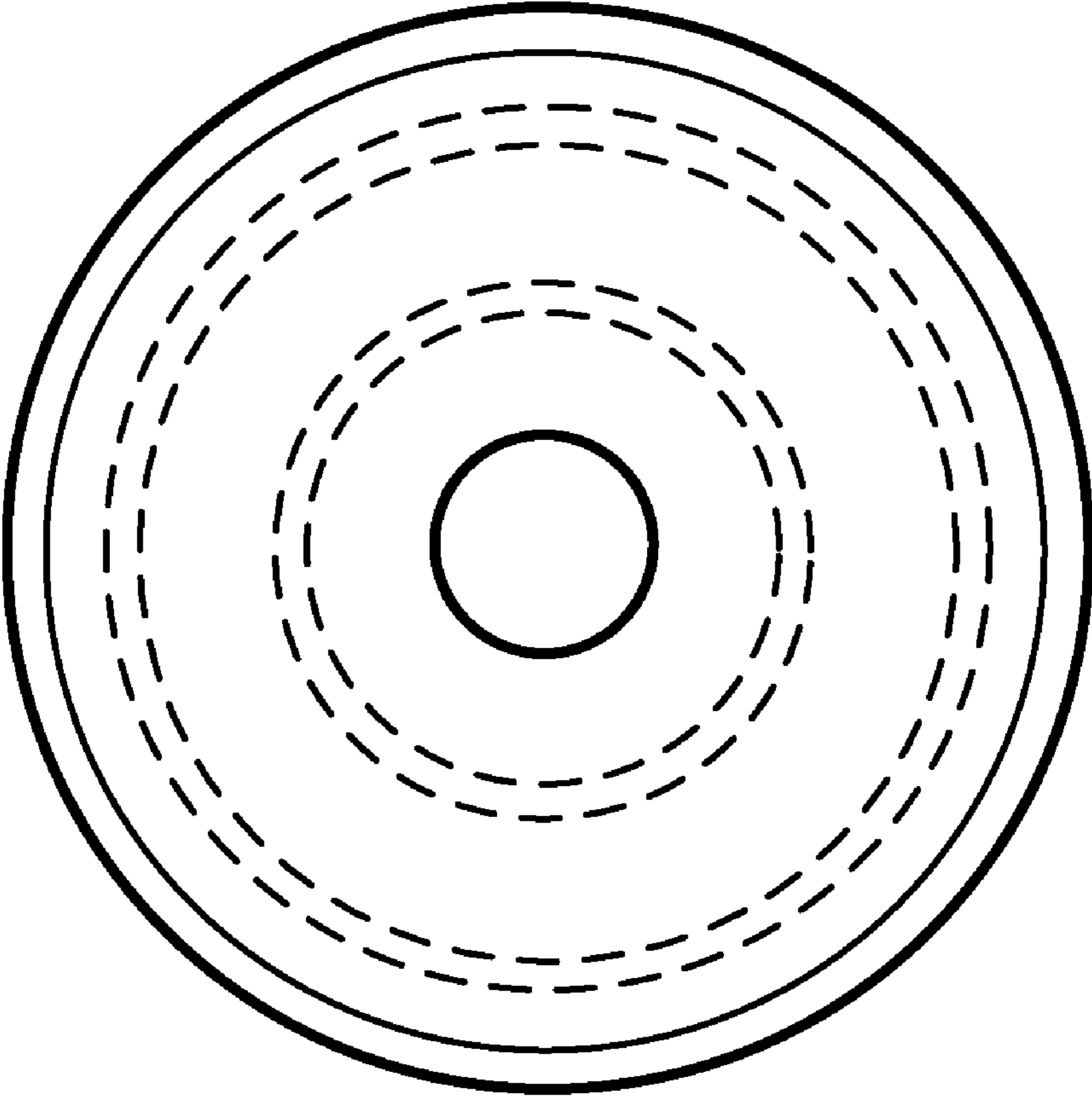
