DESCRIPTION

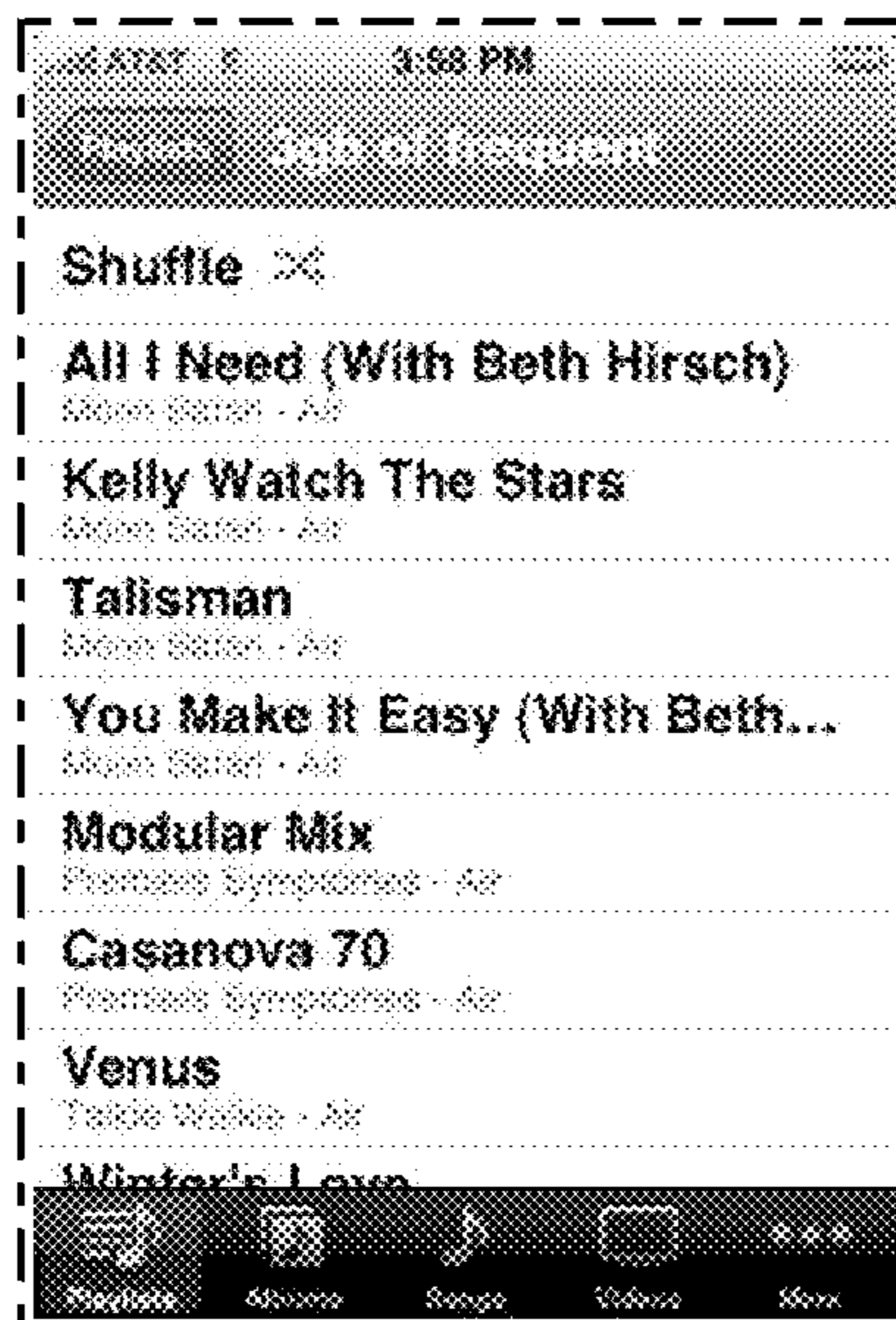
FIG. 1 is a front view of a graphical user interface for a display screen or portion thereof; and,

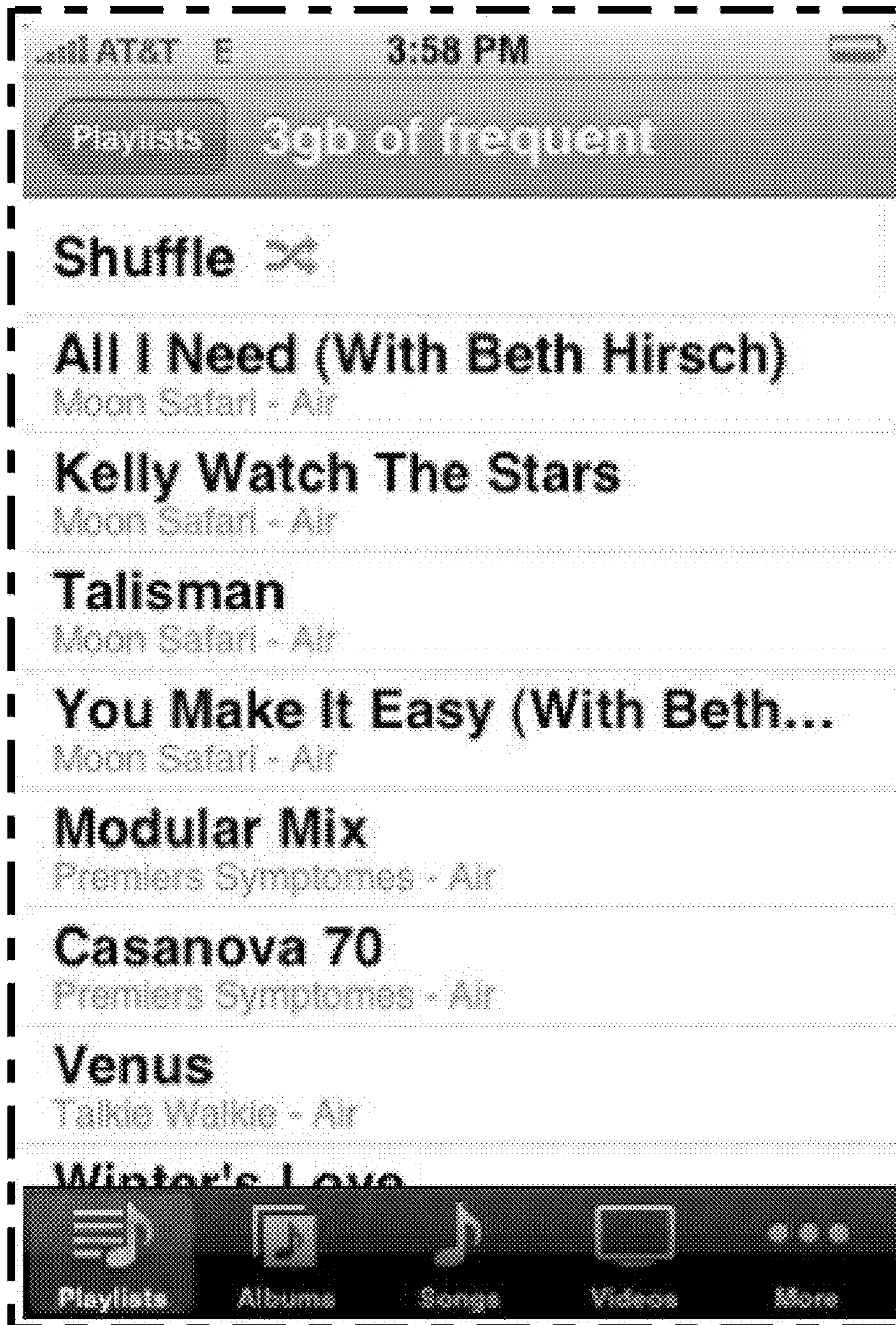

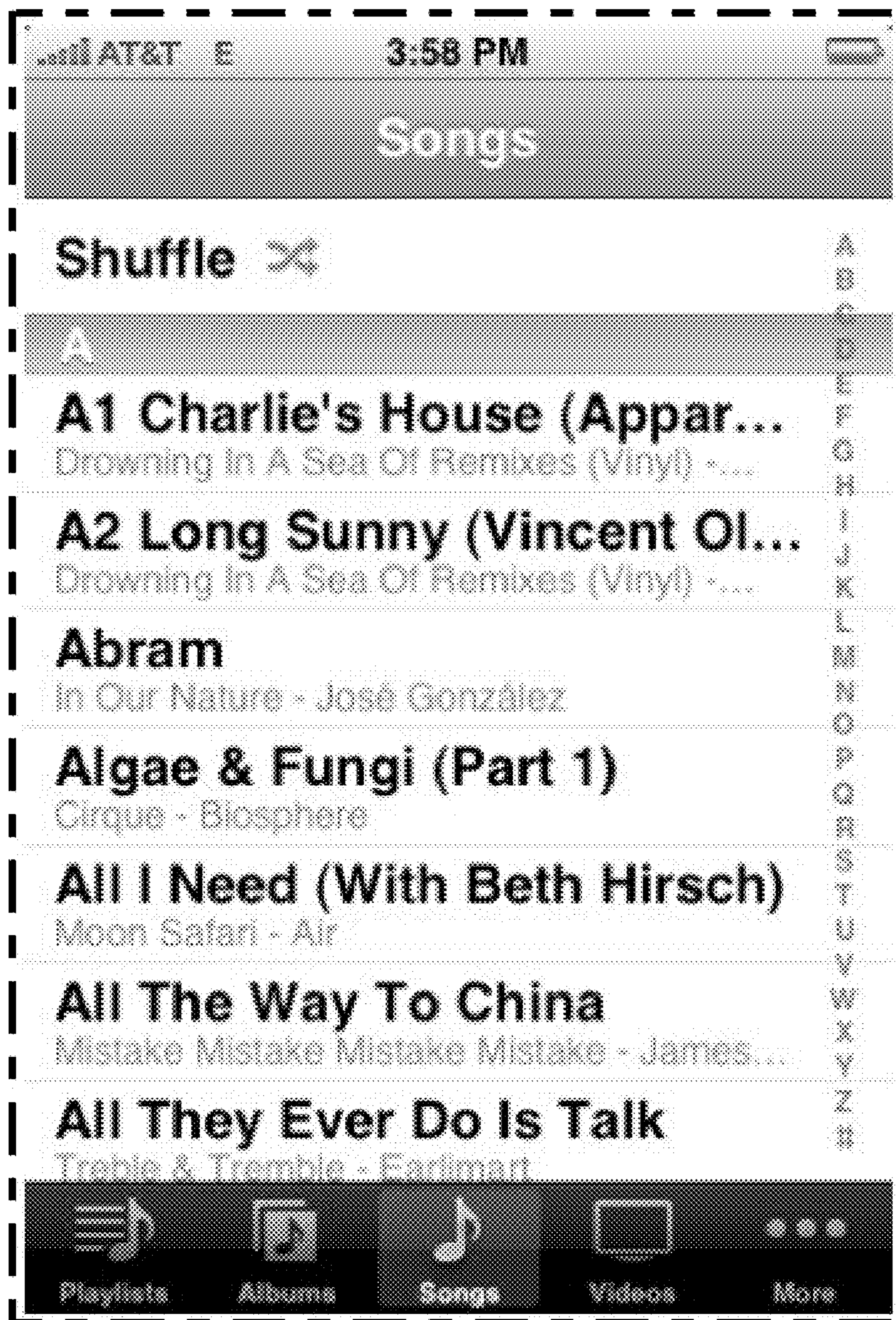
