(57) **CLAIM**

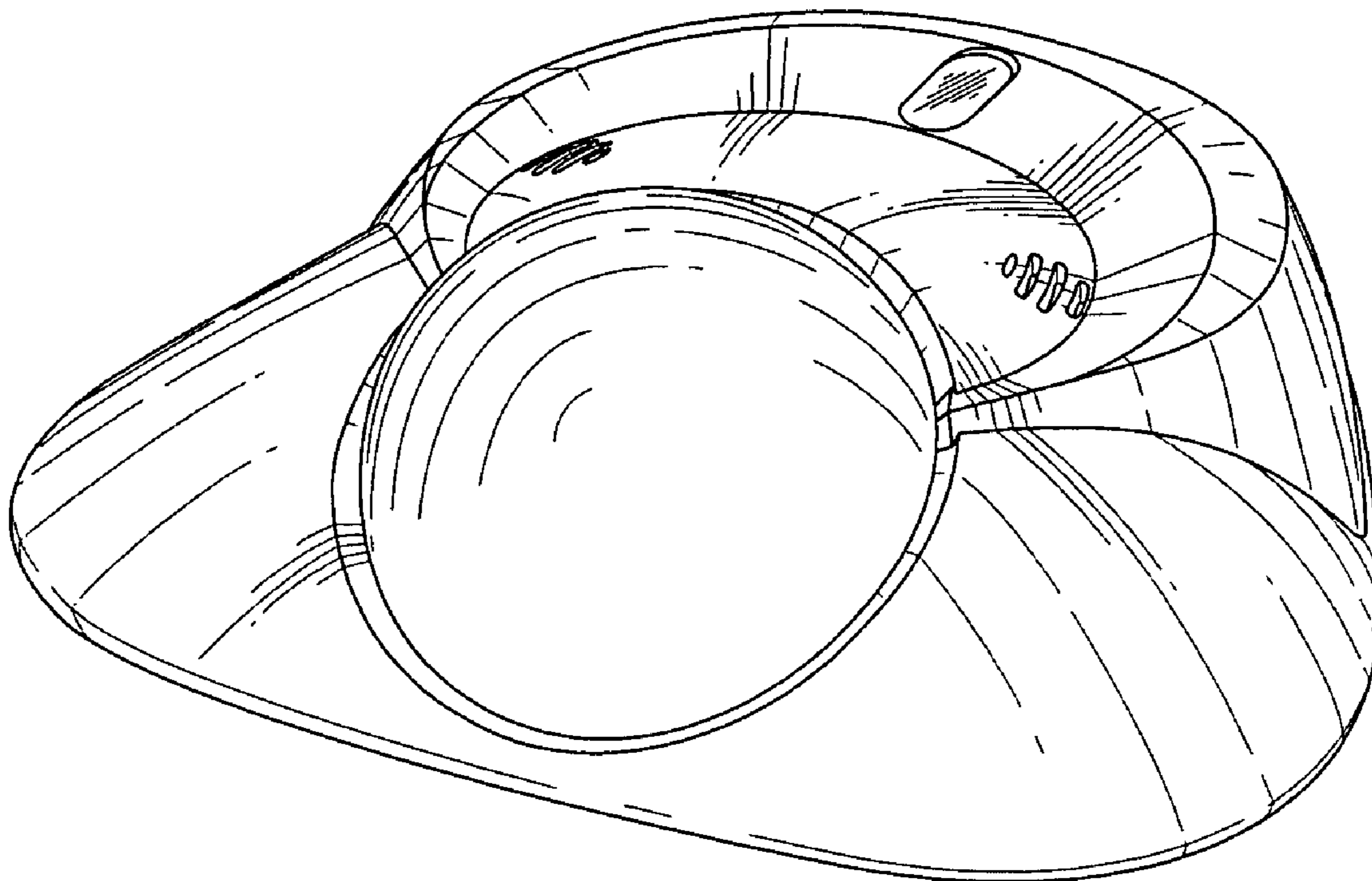
The ornamental design for a surveillance camera, as shown and described.

DESCRIPTION

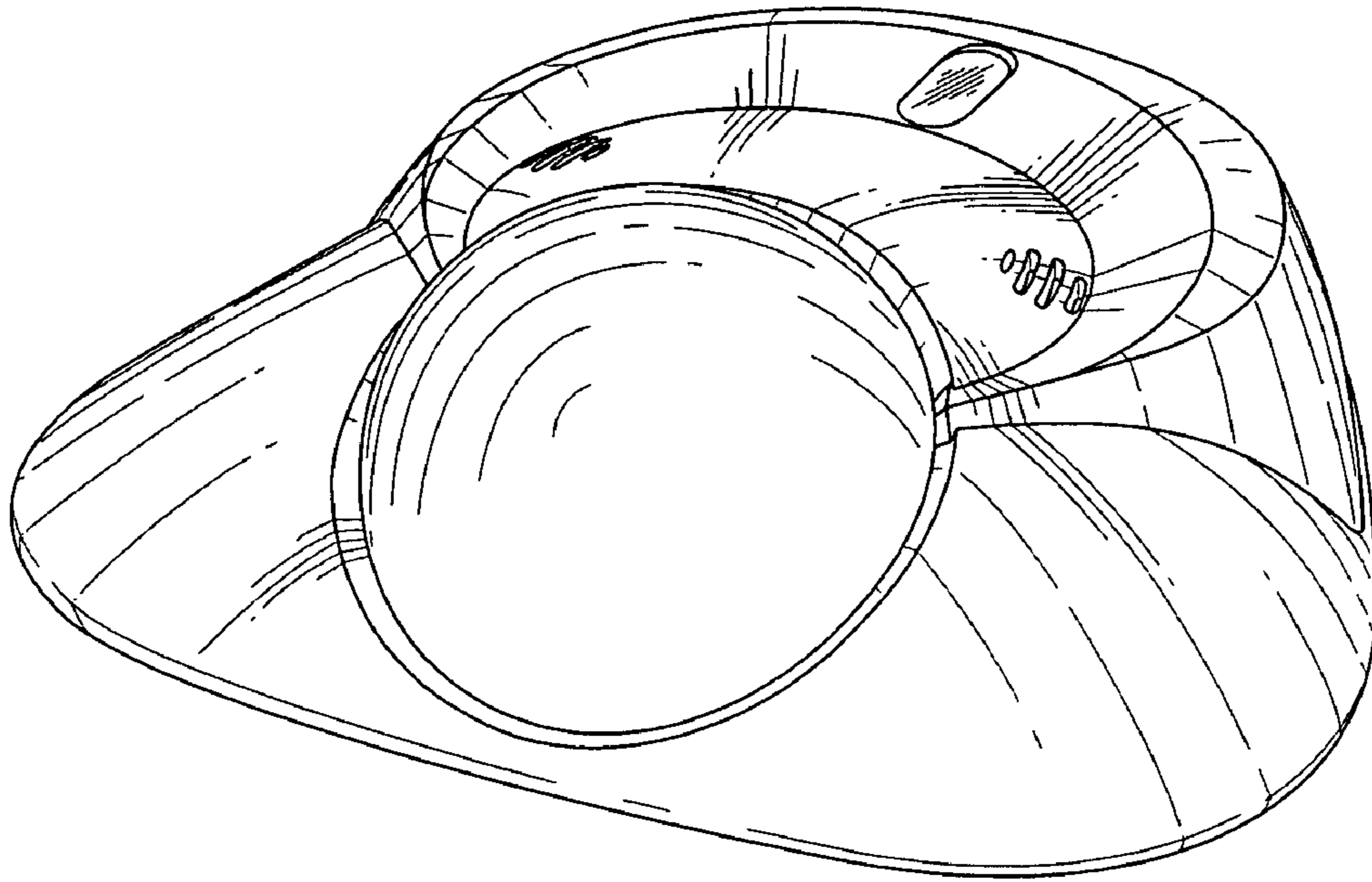

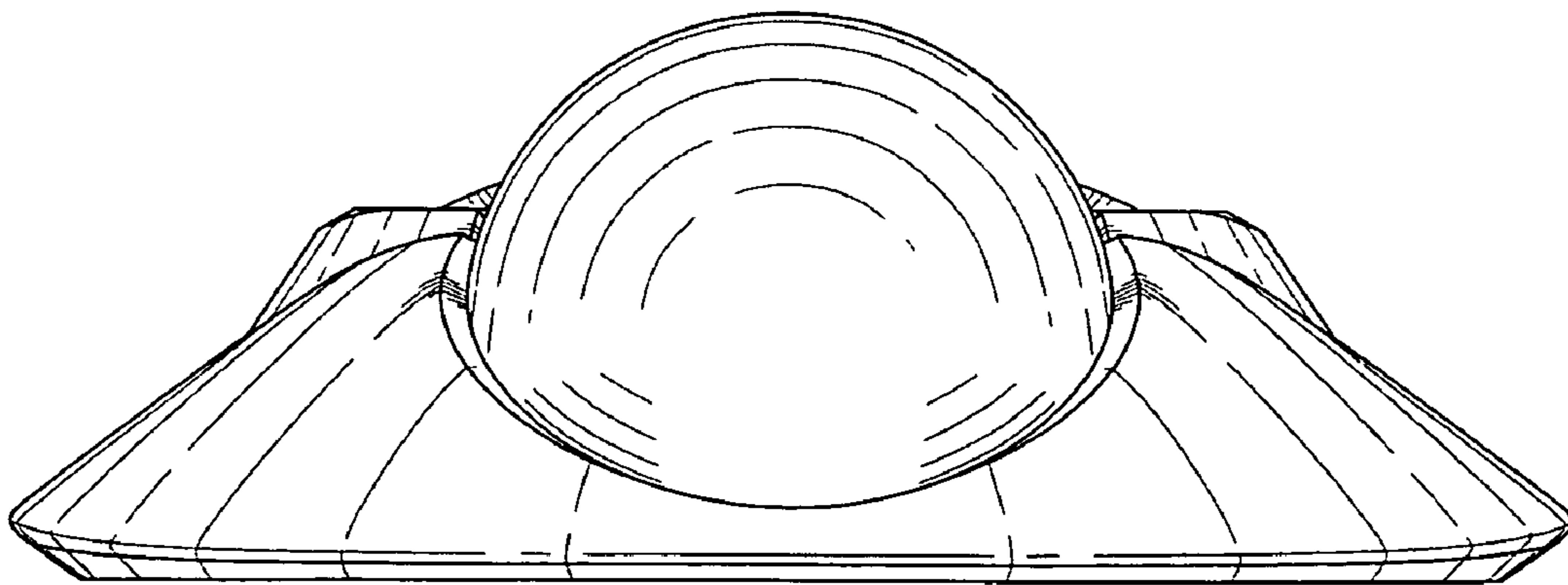

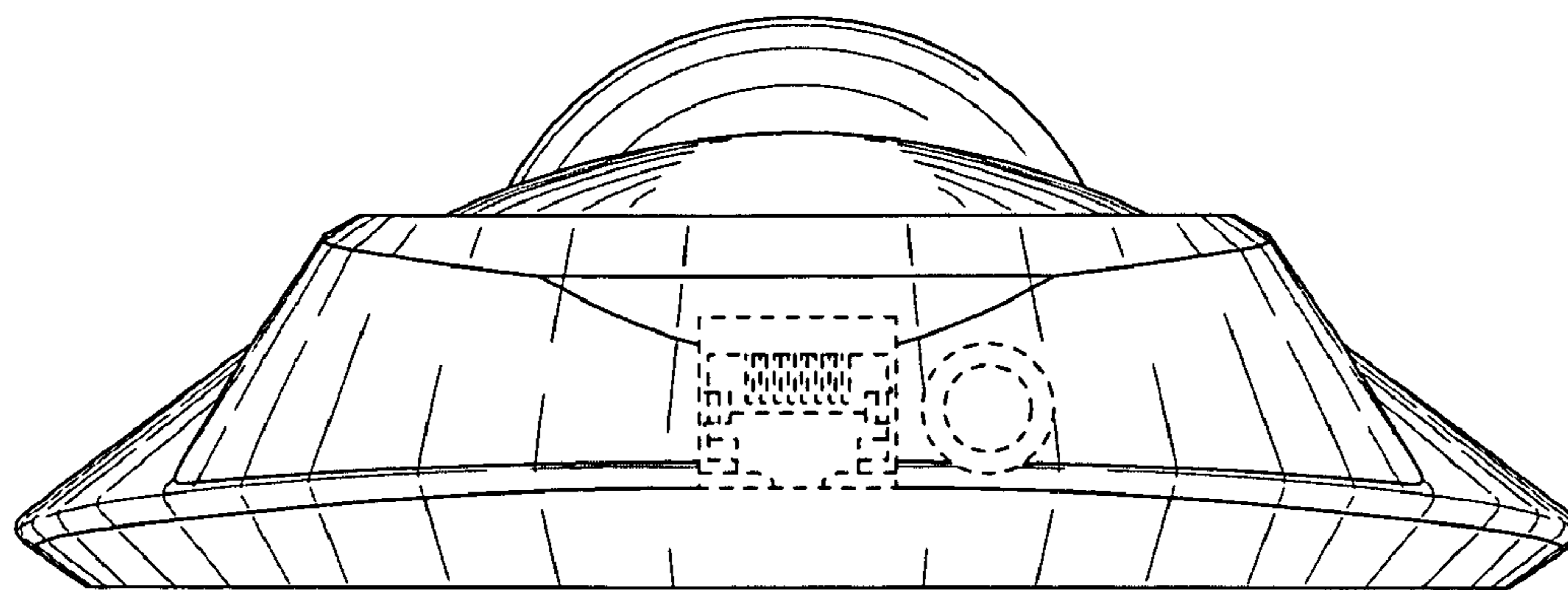

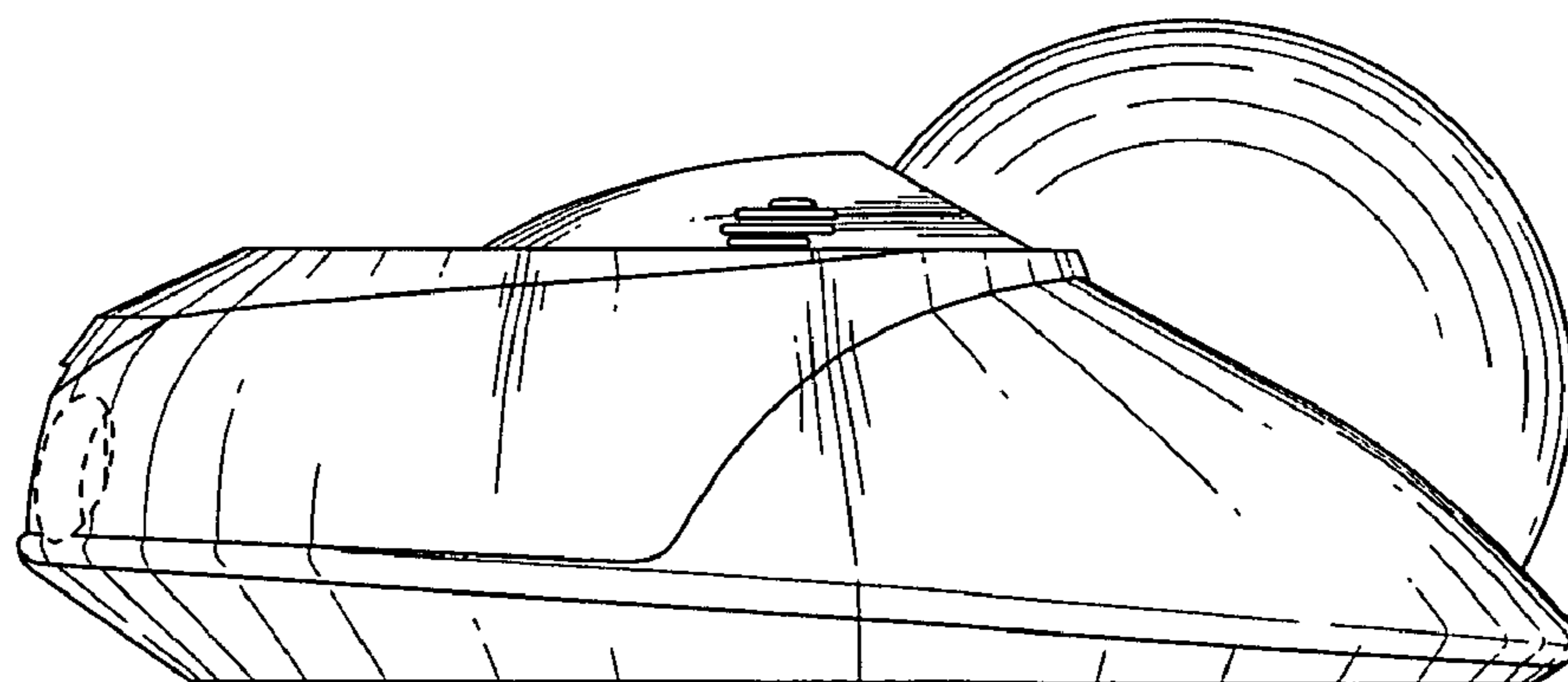

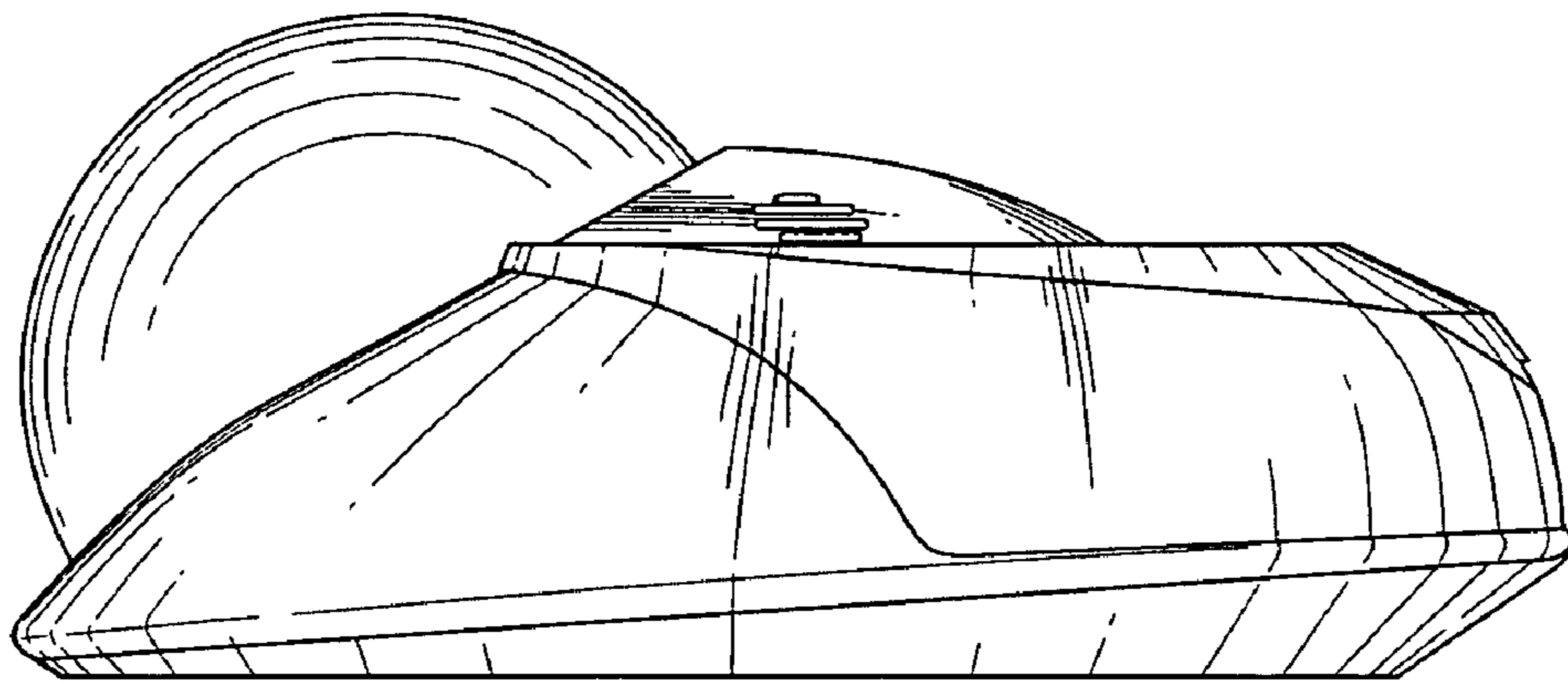

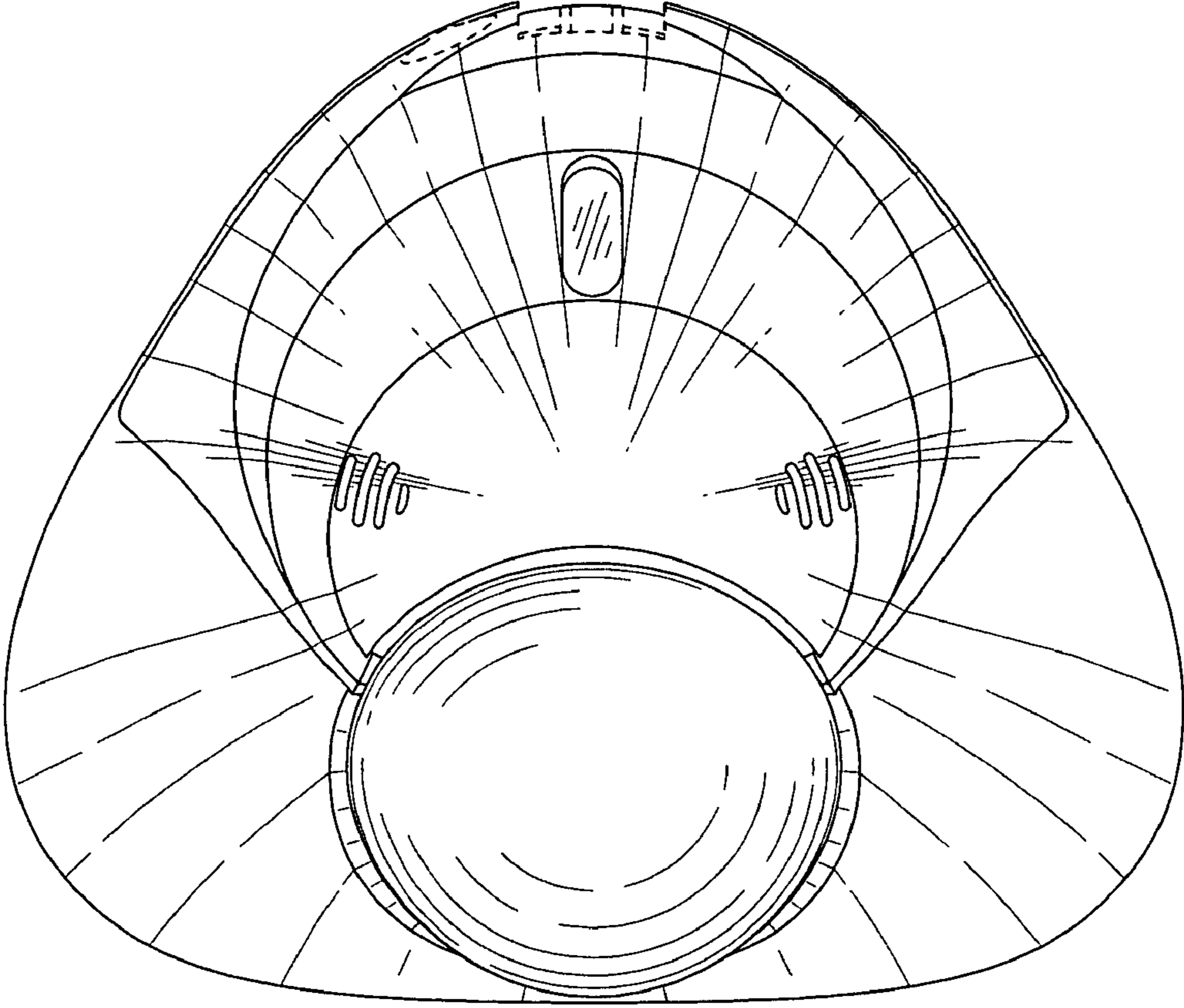

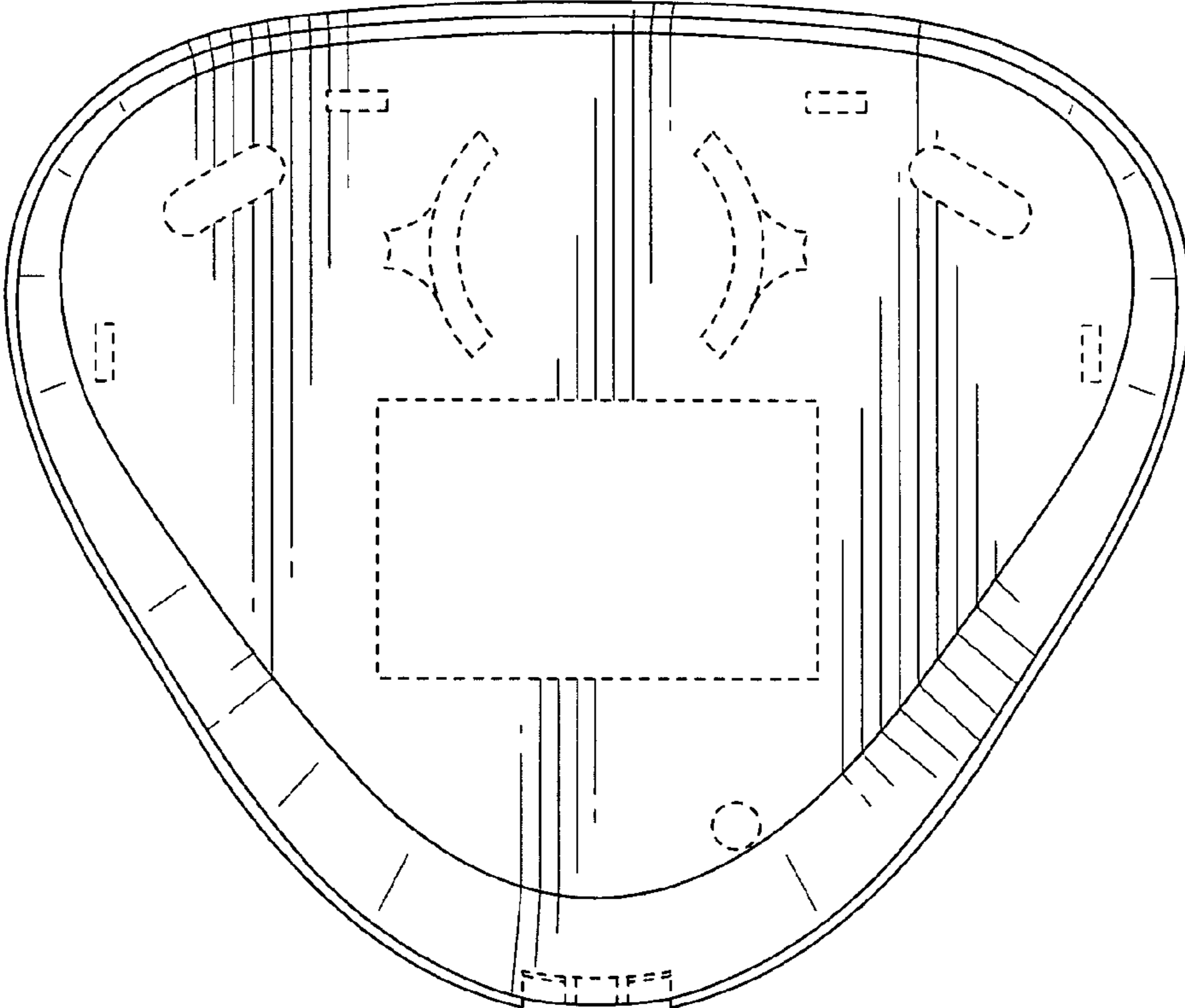
