The ornamental design for a multi-layer grip for a handle
having a customizable inner layer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective exploded view of a multi-layer grip for
a handle having a customizable inner layer that illustrates the
novel design;

FIG. 2 is a perspective assembled view of the multilayer grip
for a handle of FIG. 1;

FIG. 5 is a right side view of the multilayer grip of FIG. 2;

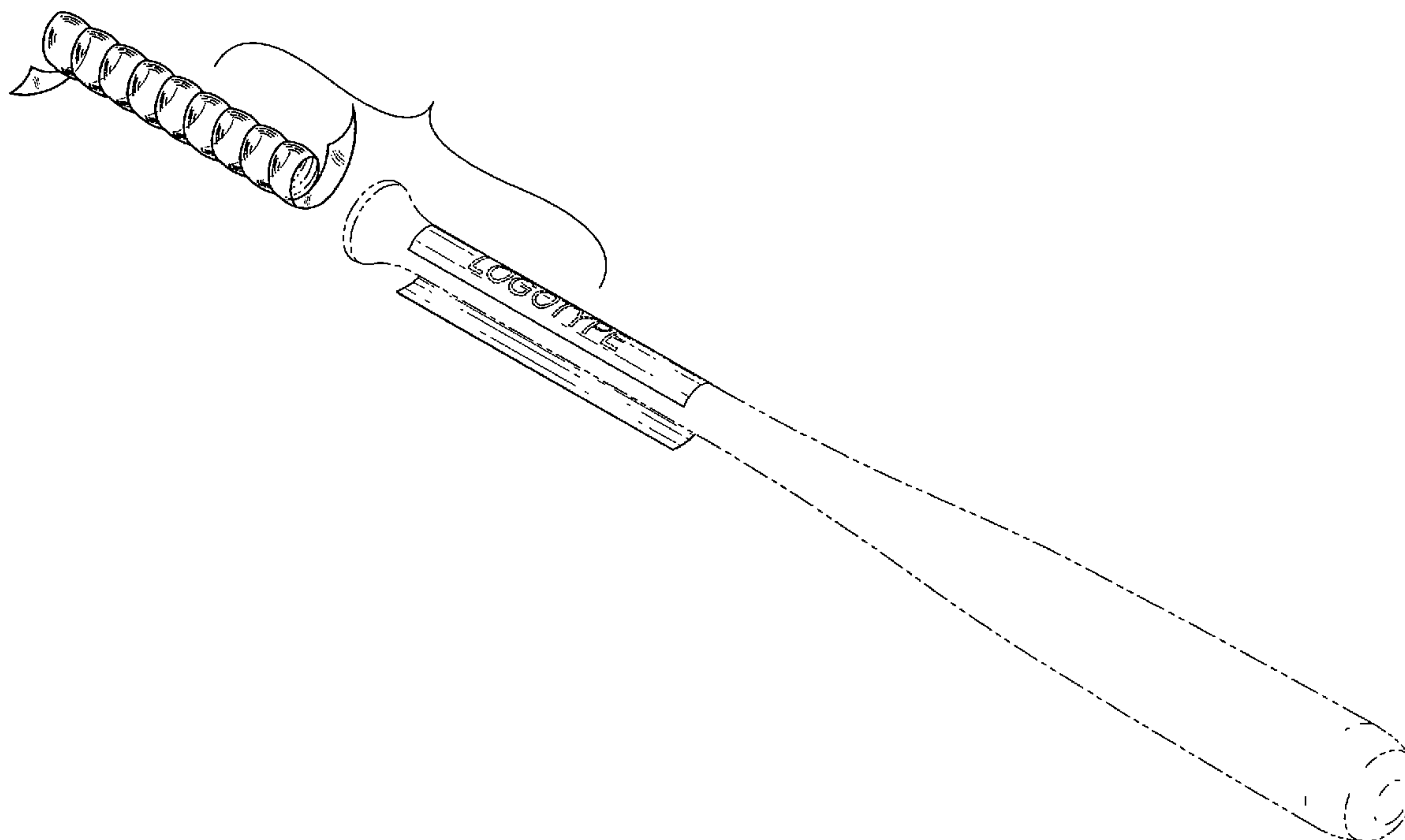
FIG. 6 is a left side view of the multilayer grip of FIG. 2;

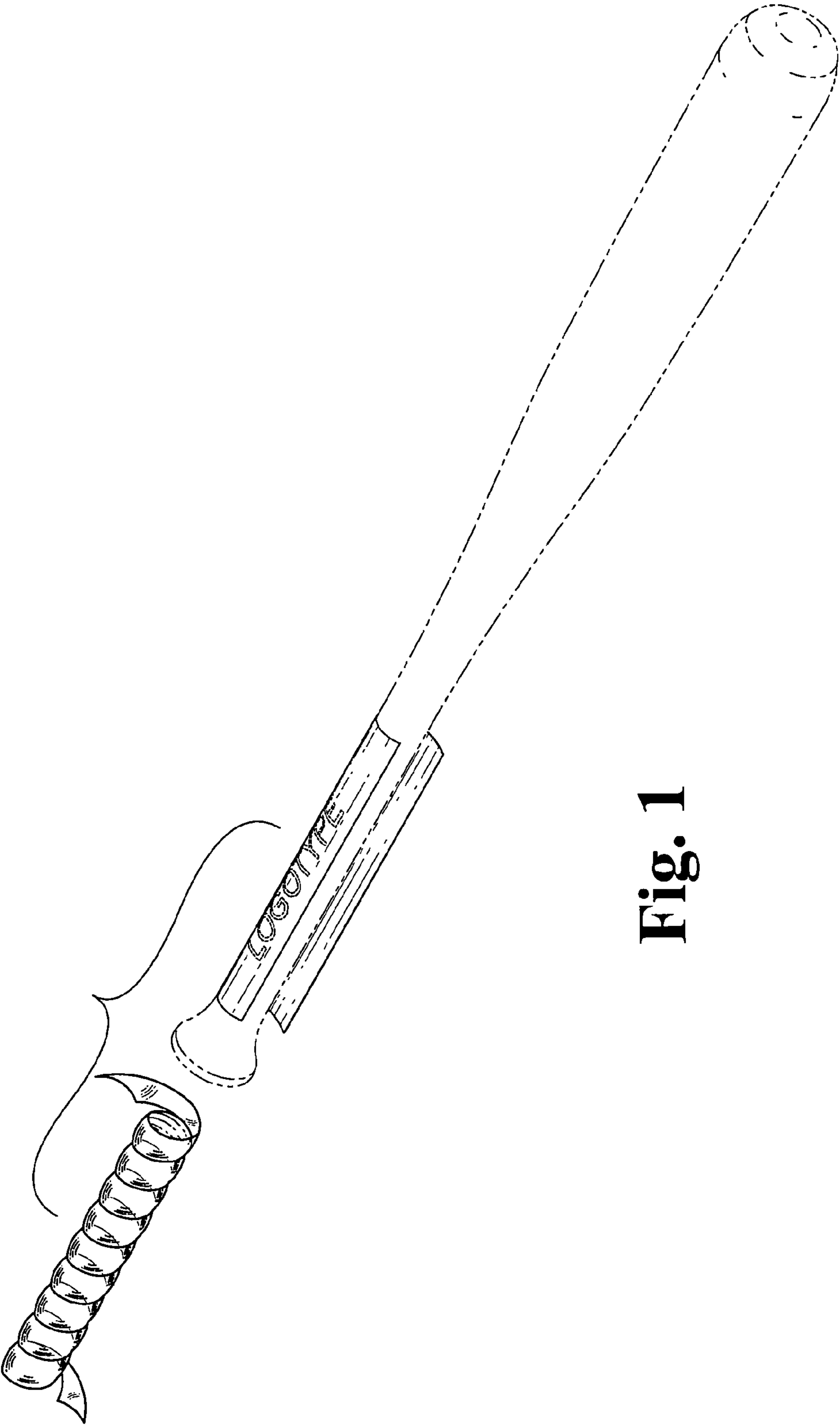

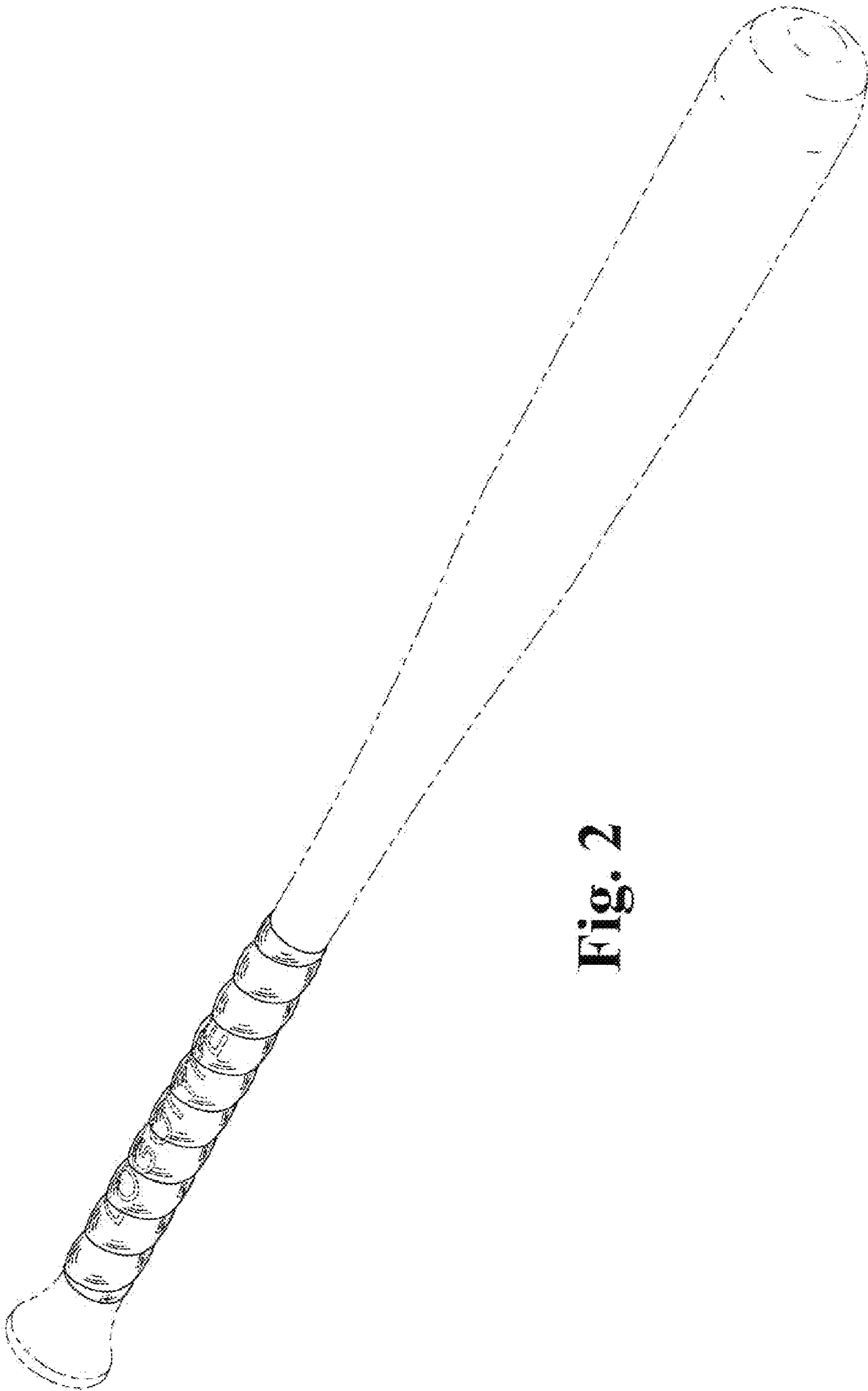

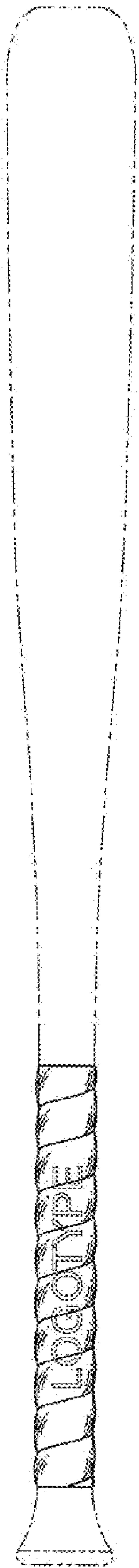

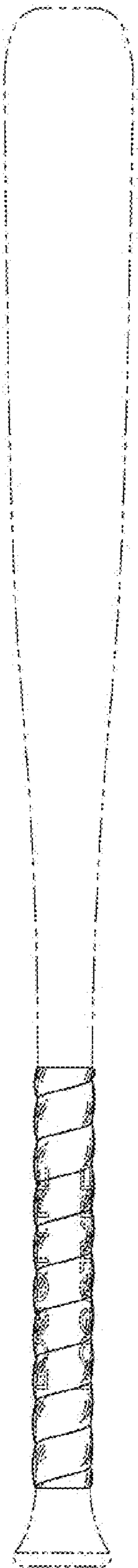

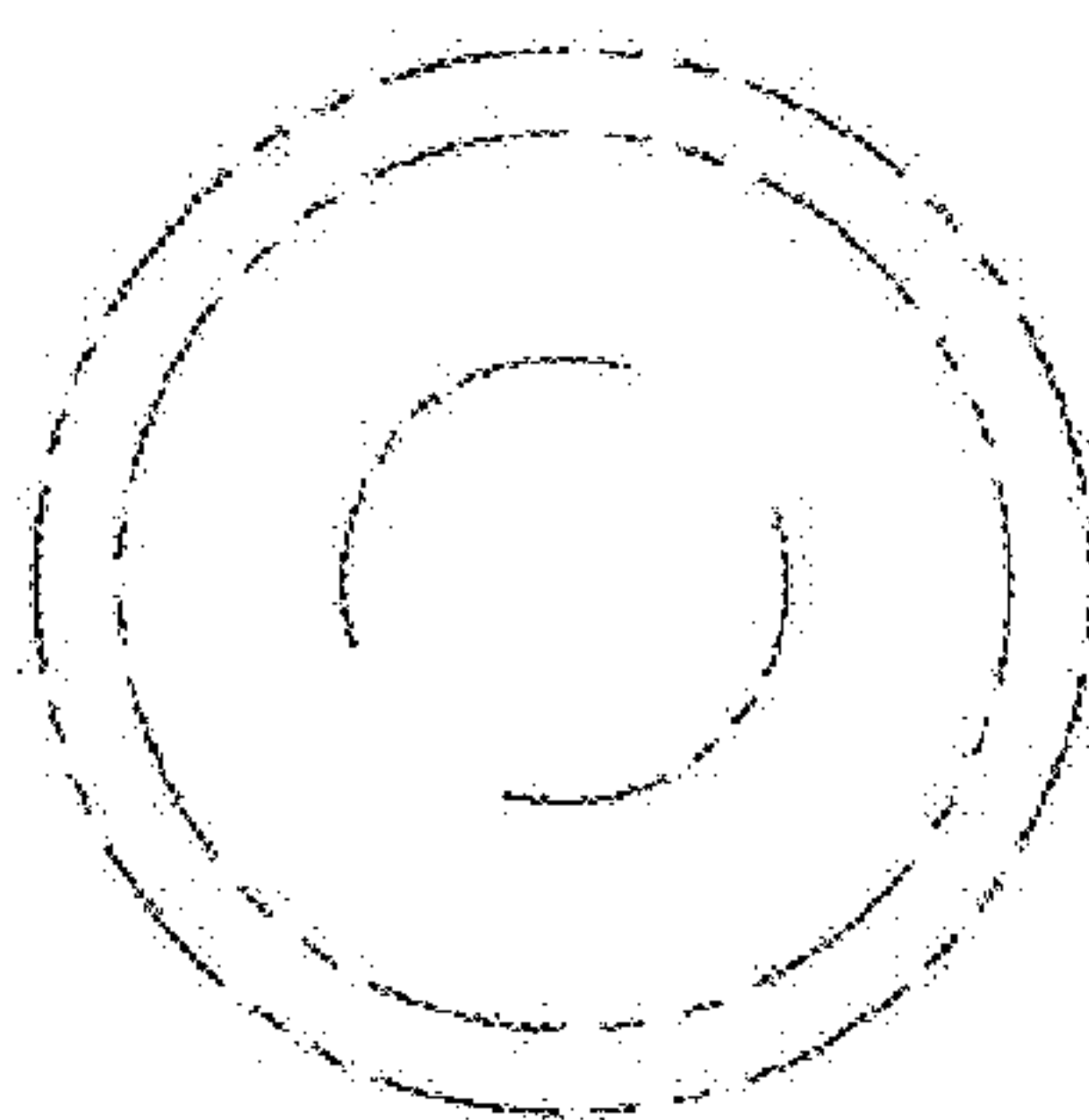

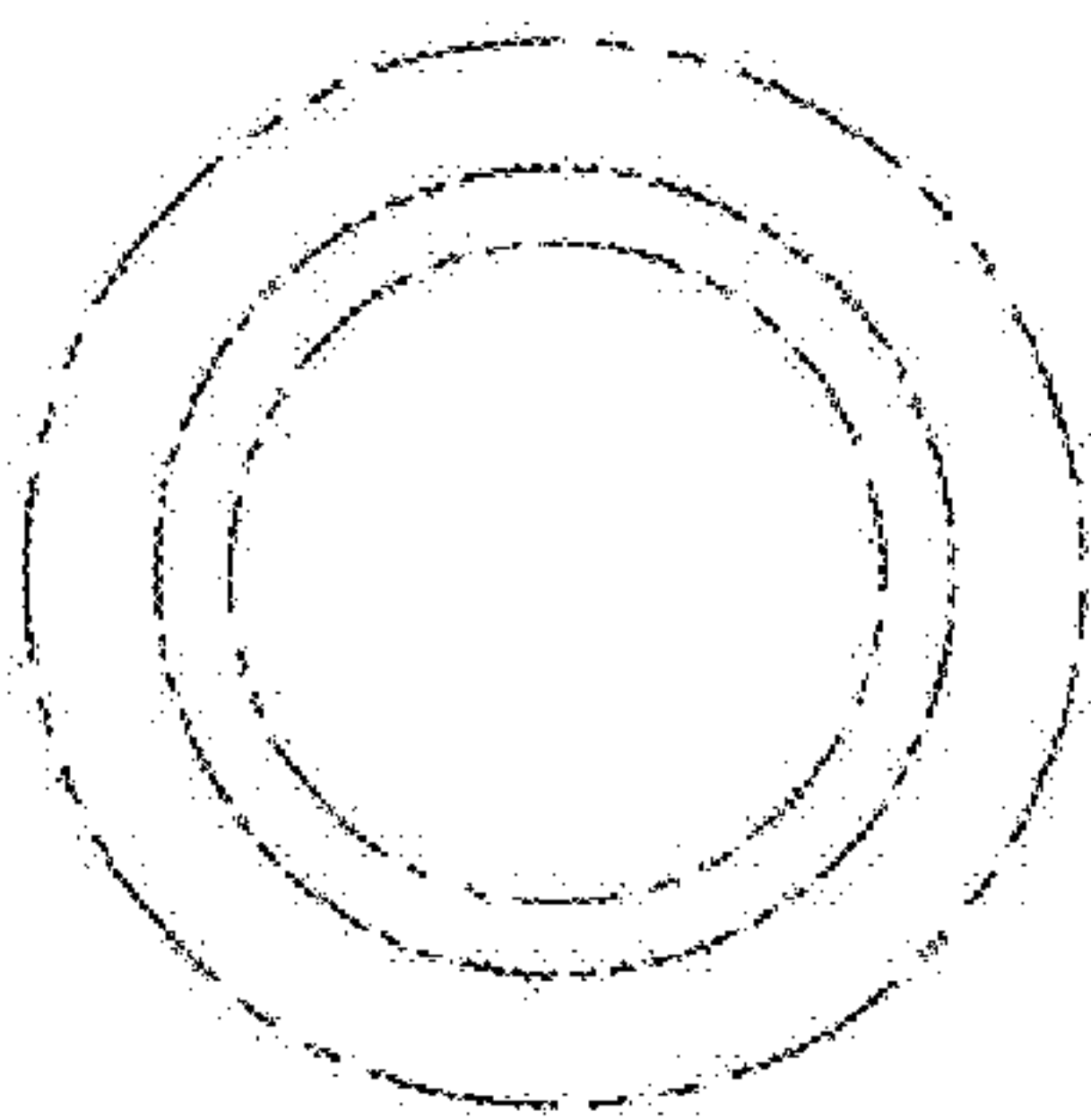

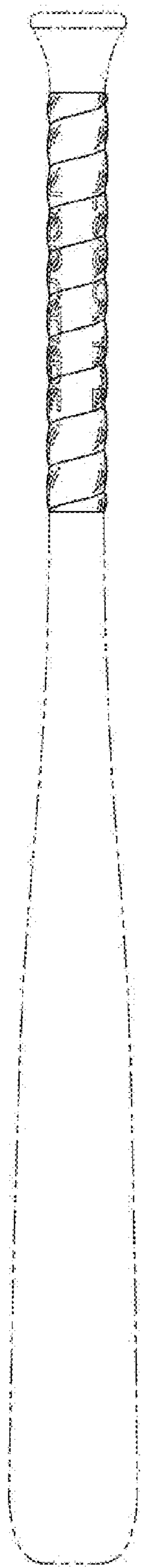

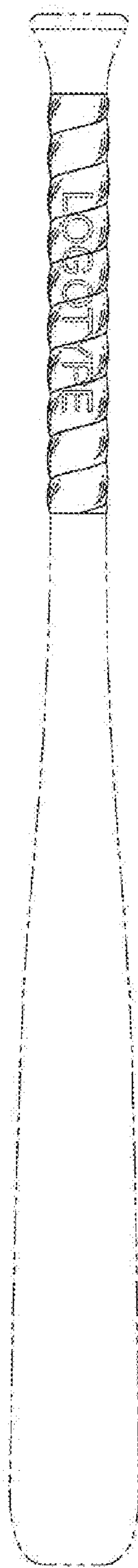
