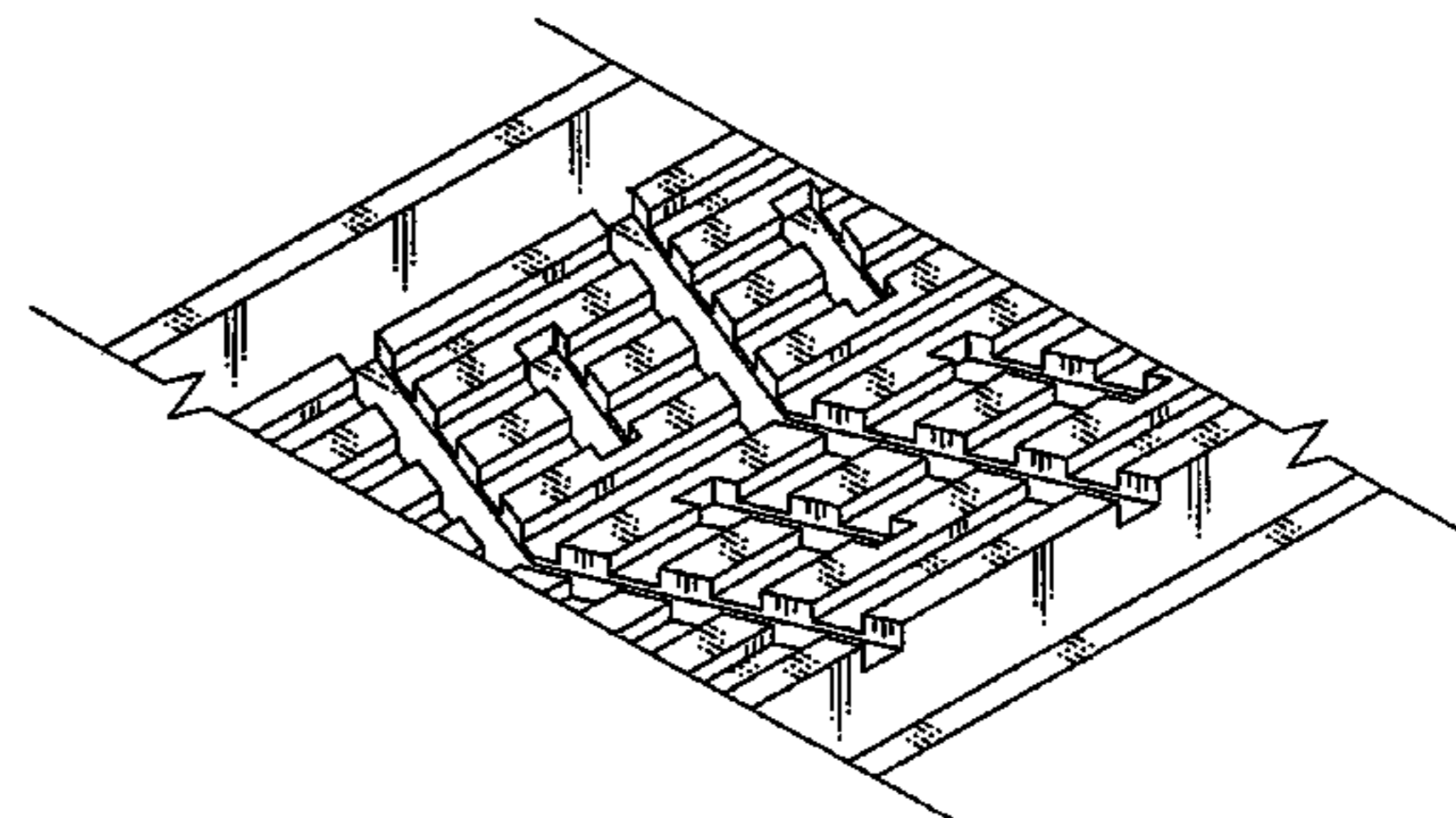
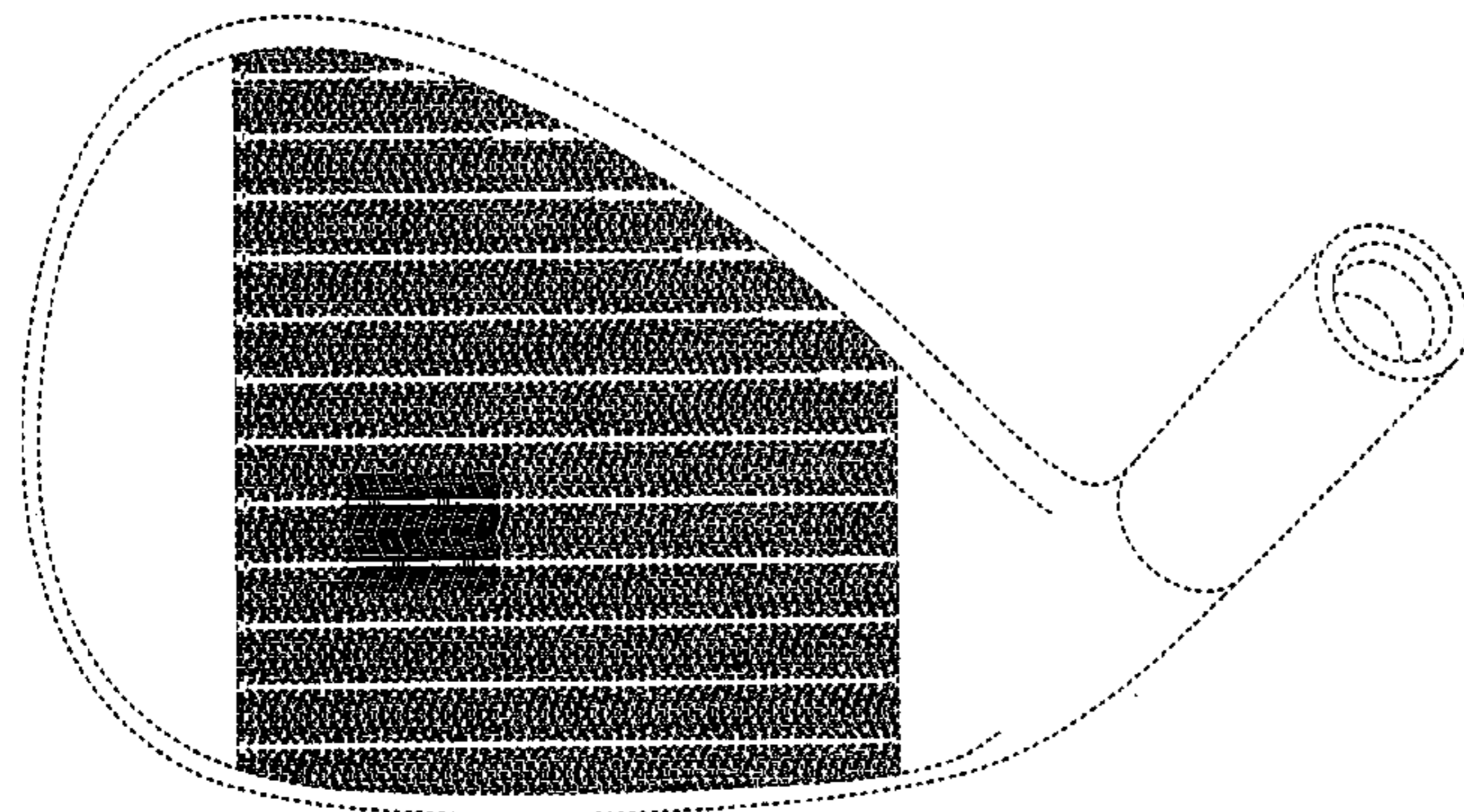
The ornamental design for an iron golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the iron golf club head of our design; FIG. 2 is an enlarged front view of the highlighted portion of the iron golf club head shown in FIG. 1; FIG. 3 is a perspective view of a portion of the iron golf club head shown in FIG. 2; FIG. 4 is a rear view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a left side view thereof; FIG. 7 is a right side view thereof; FIG. 8 is a front view of a second embodiment of the iron golf club head disclosed in FIG. 1; FIG. 9 is an enlarged front view of the highlighted portion of the iron golf club head shown in FIG. 8; FIG. 10 is a perspective view of a portion of the iron golf club head shown in FIG. 9; FIG. 11 is a rear view thereof; FIG. 12 is a bottom plan view thereof; FIG. 13 is a left side view thereof; and, FIG. 14 is a right side view thereof.

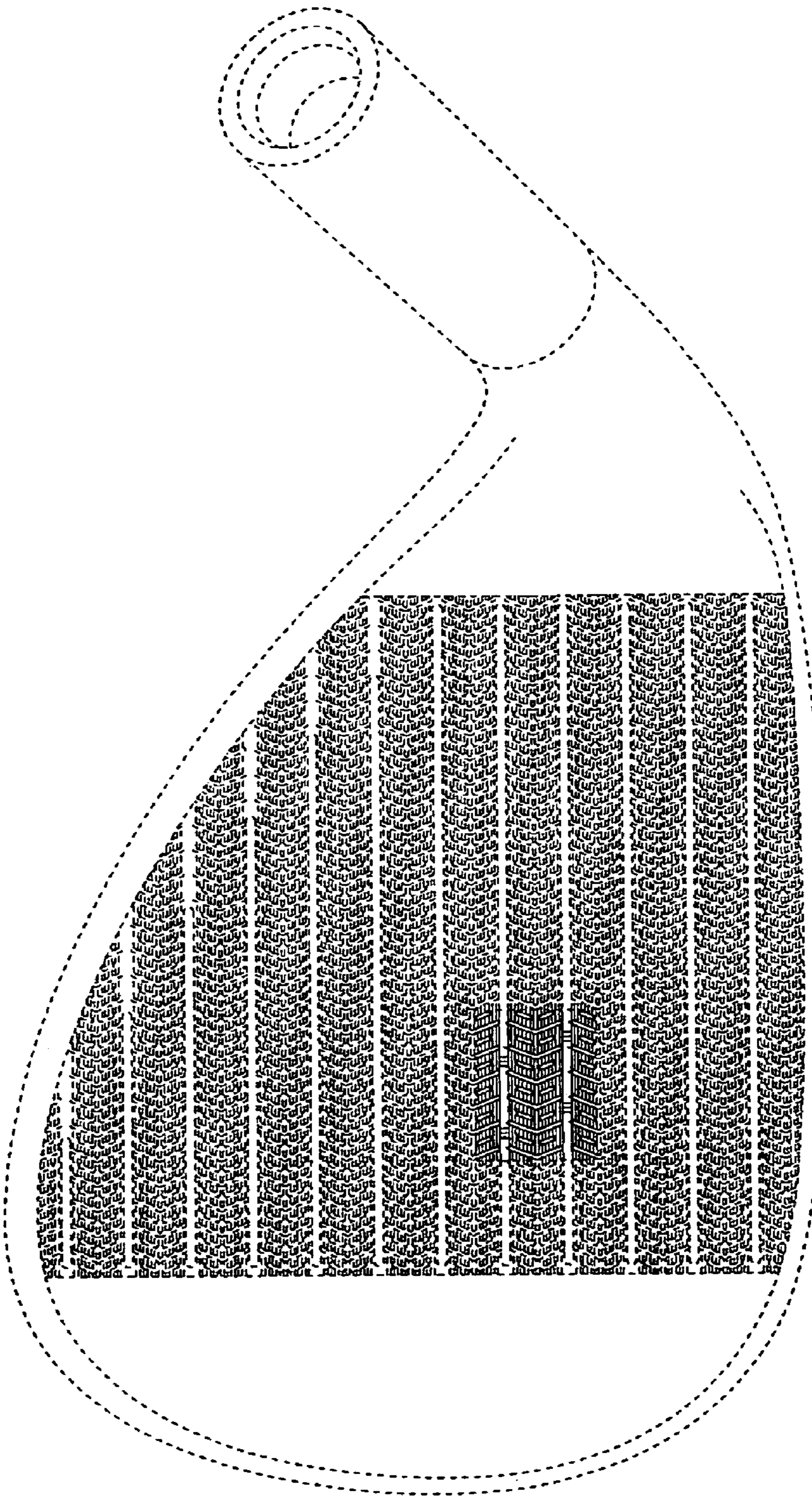

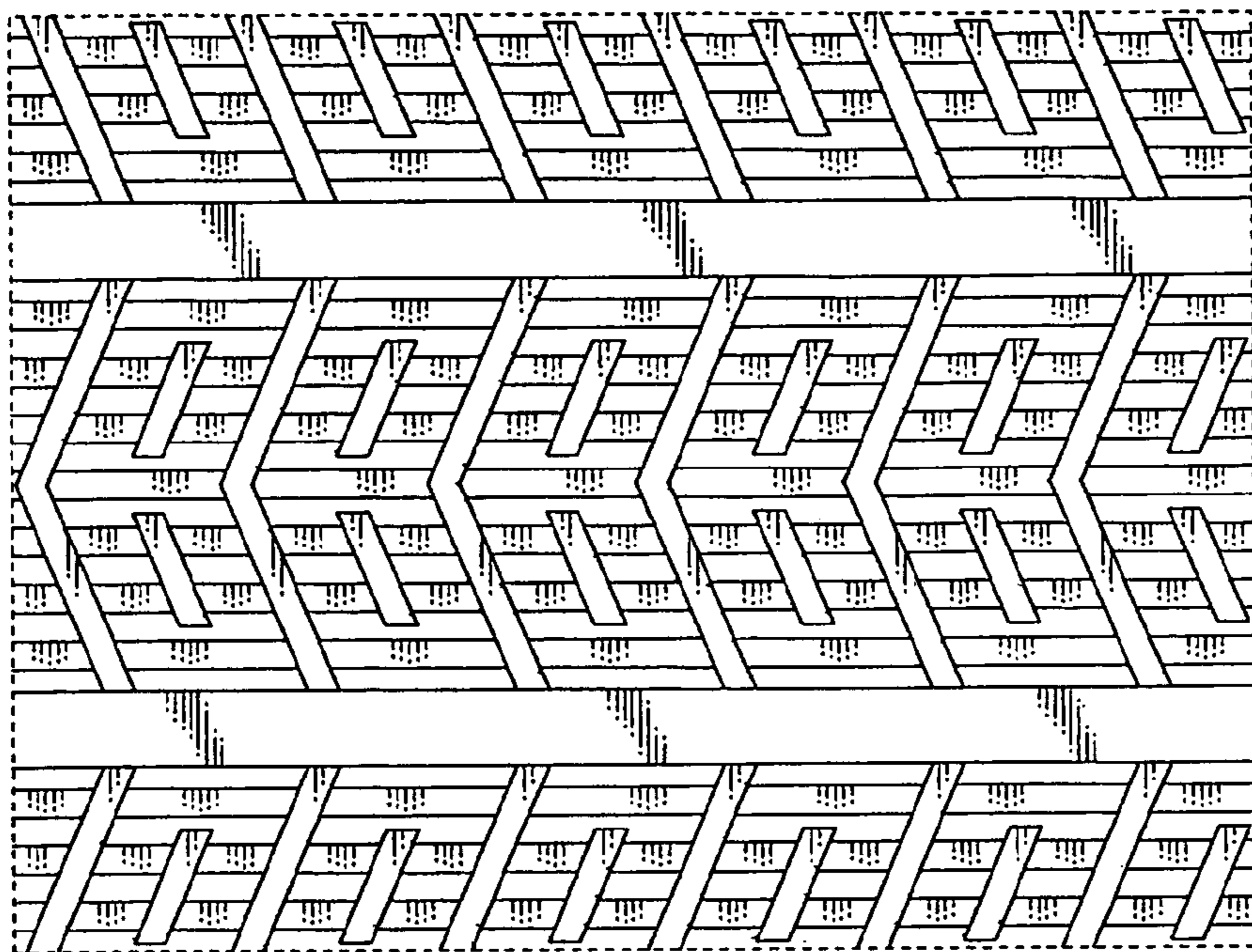

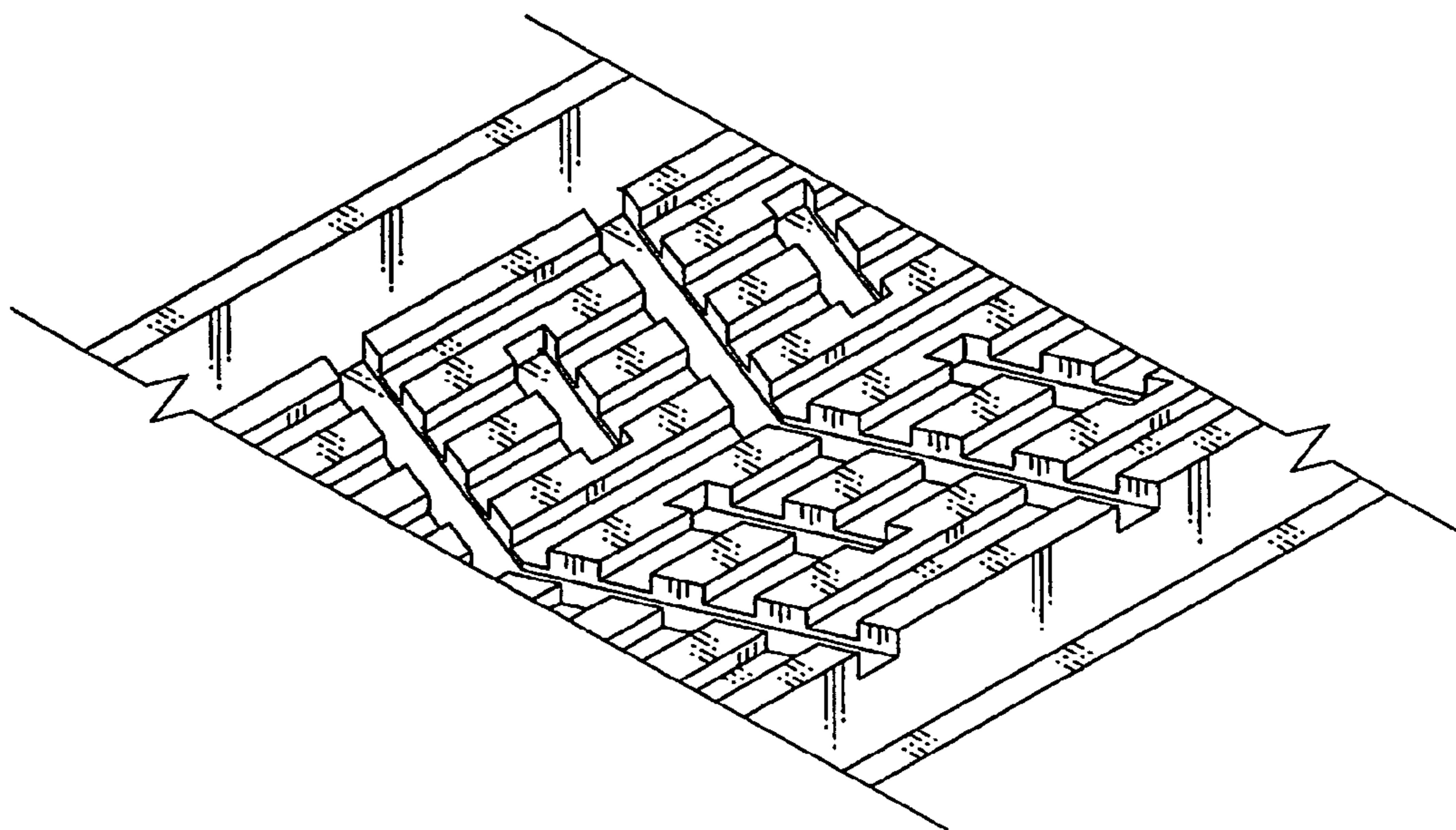

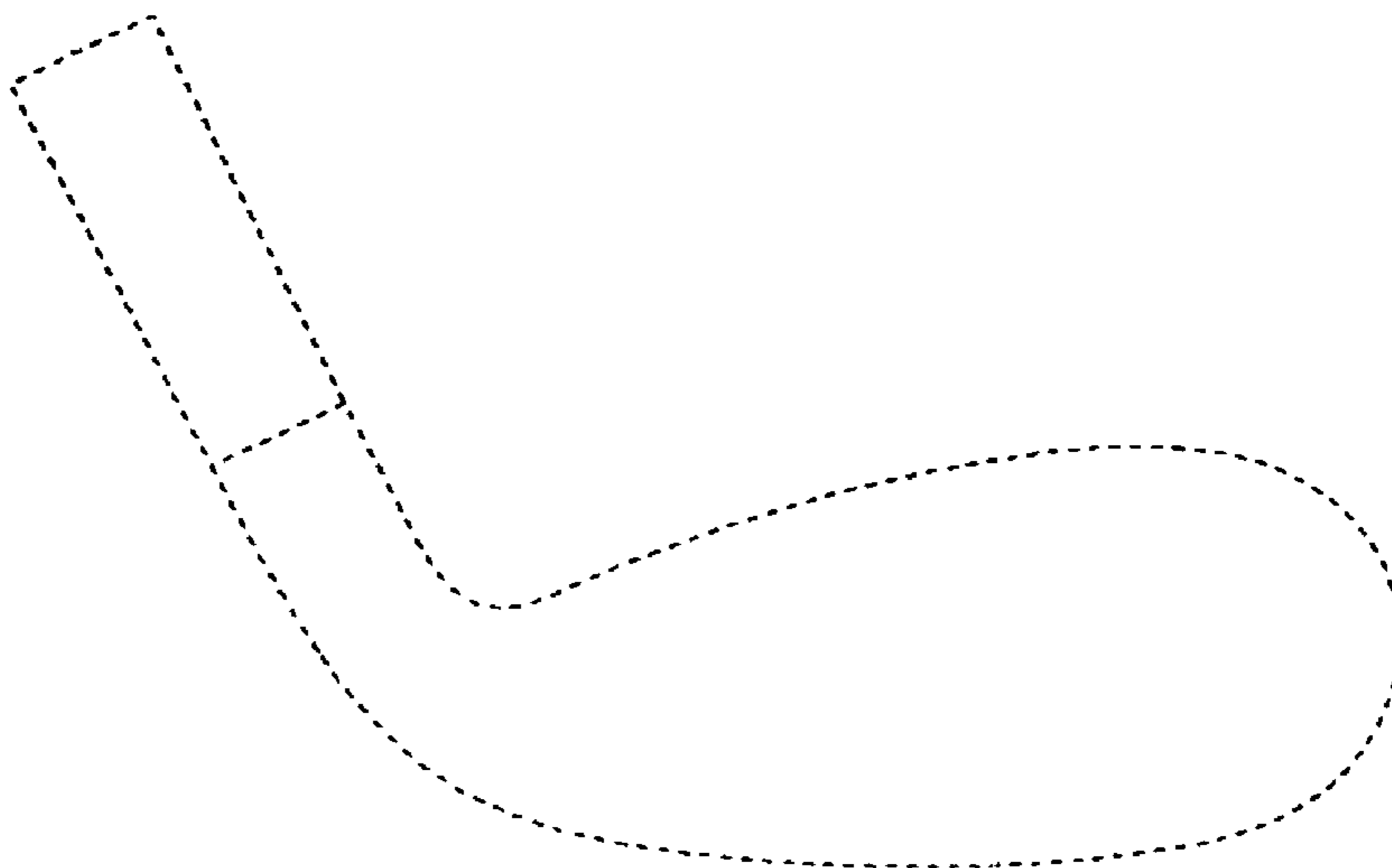

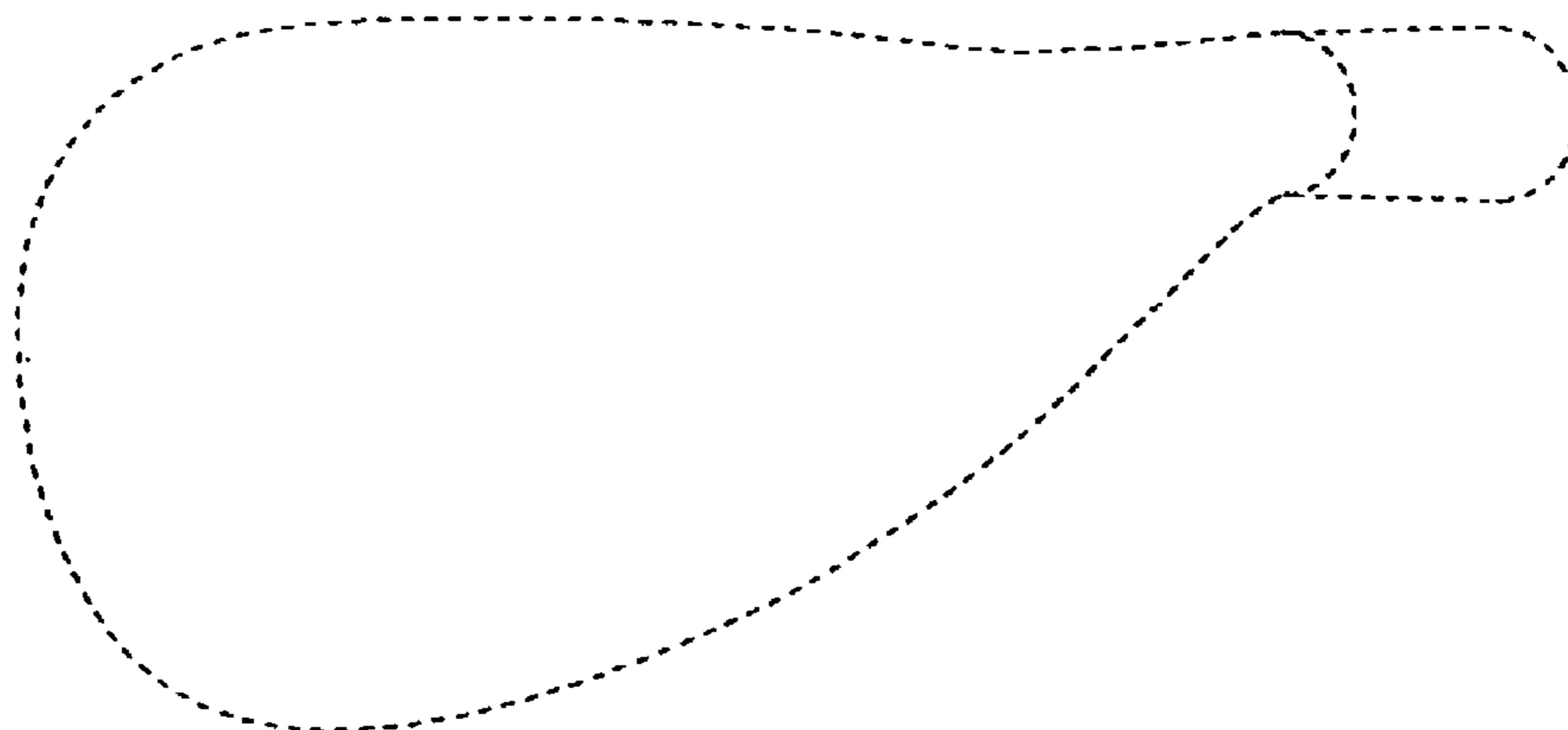

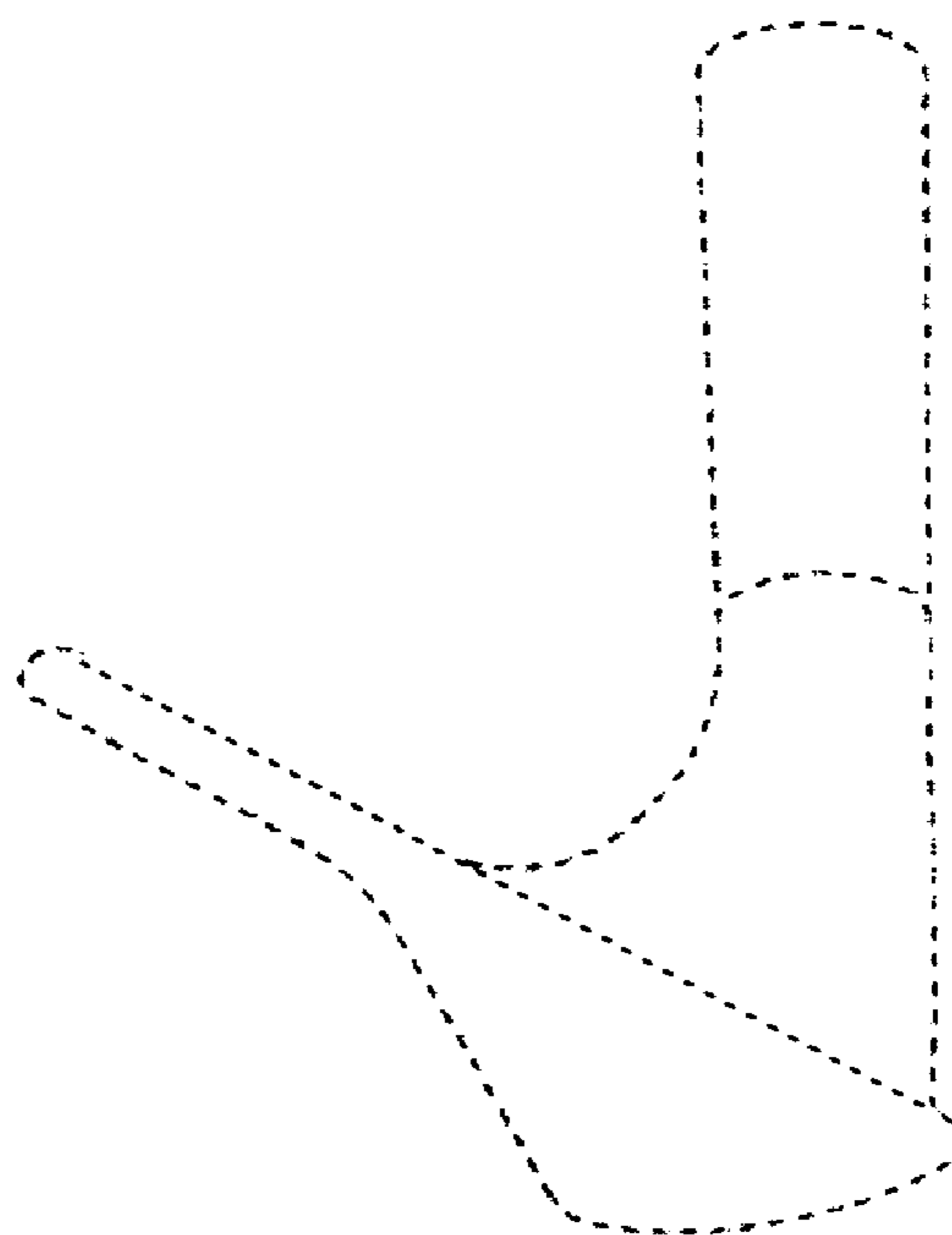
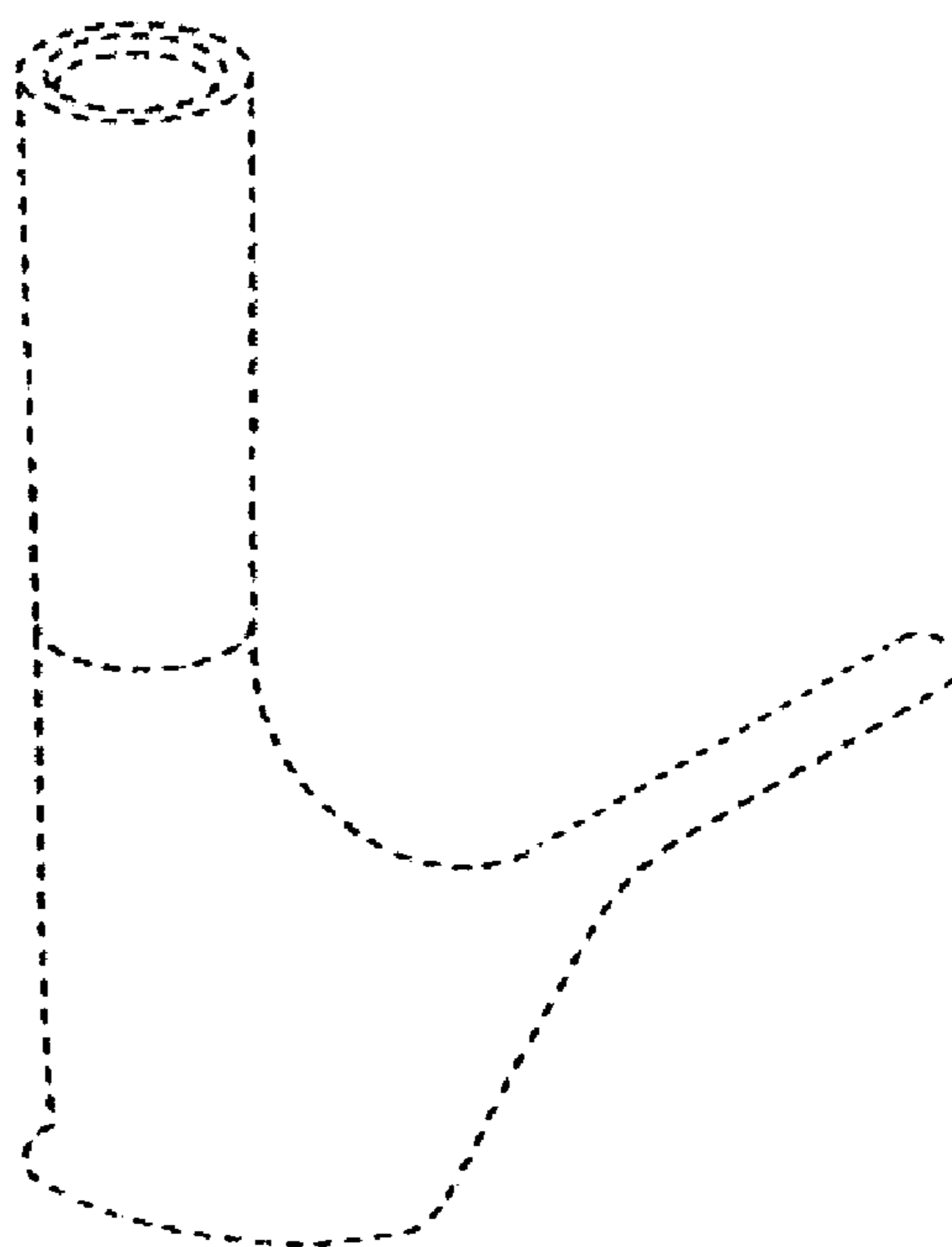

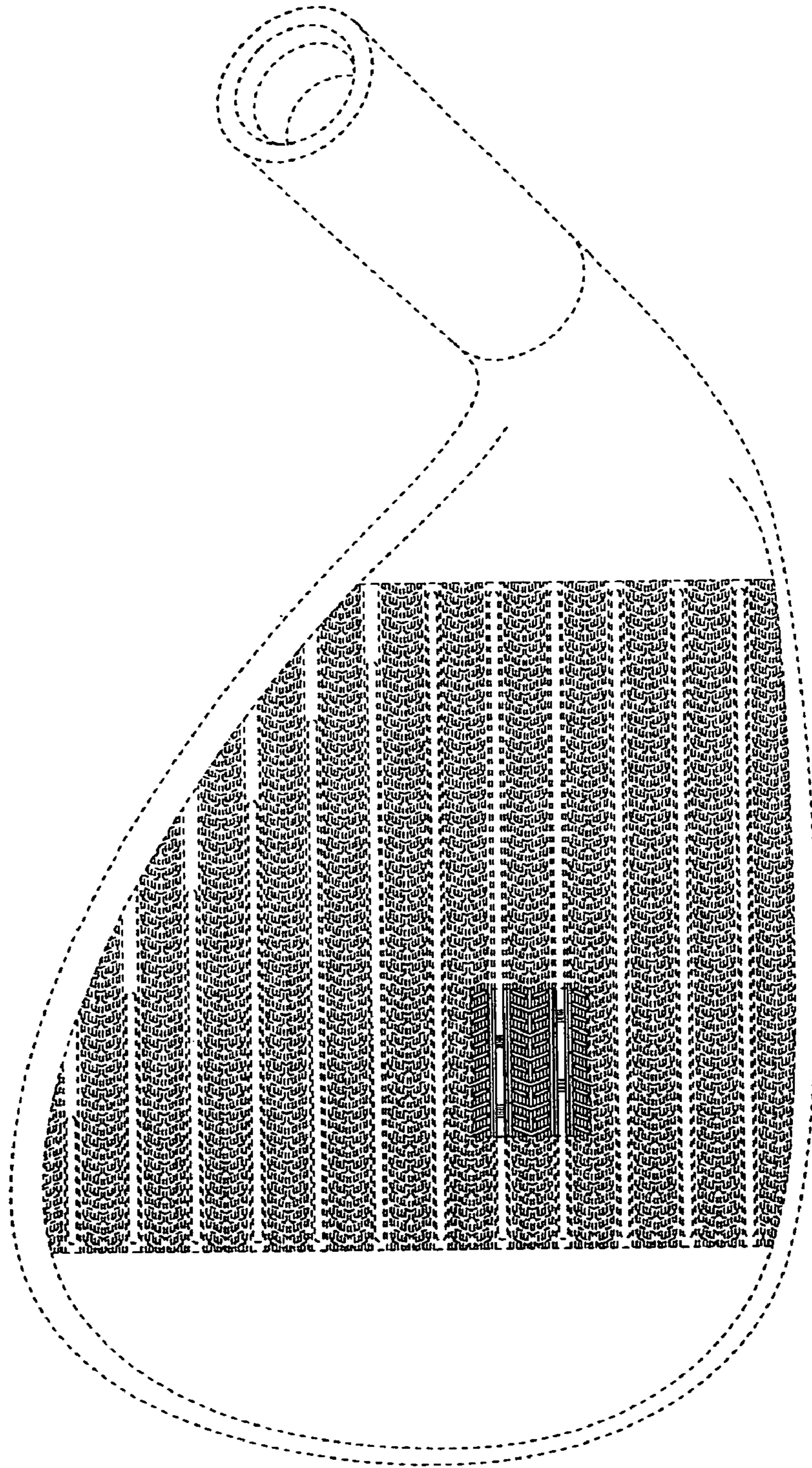

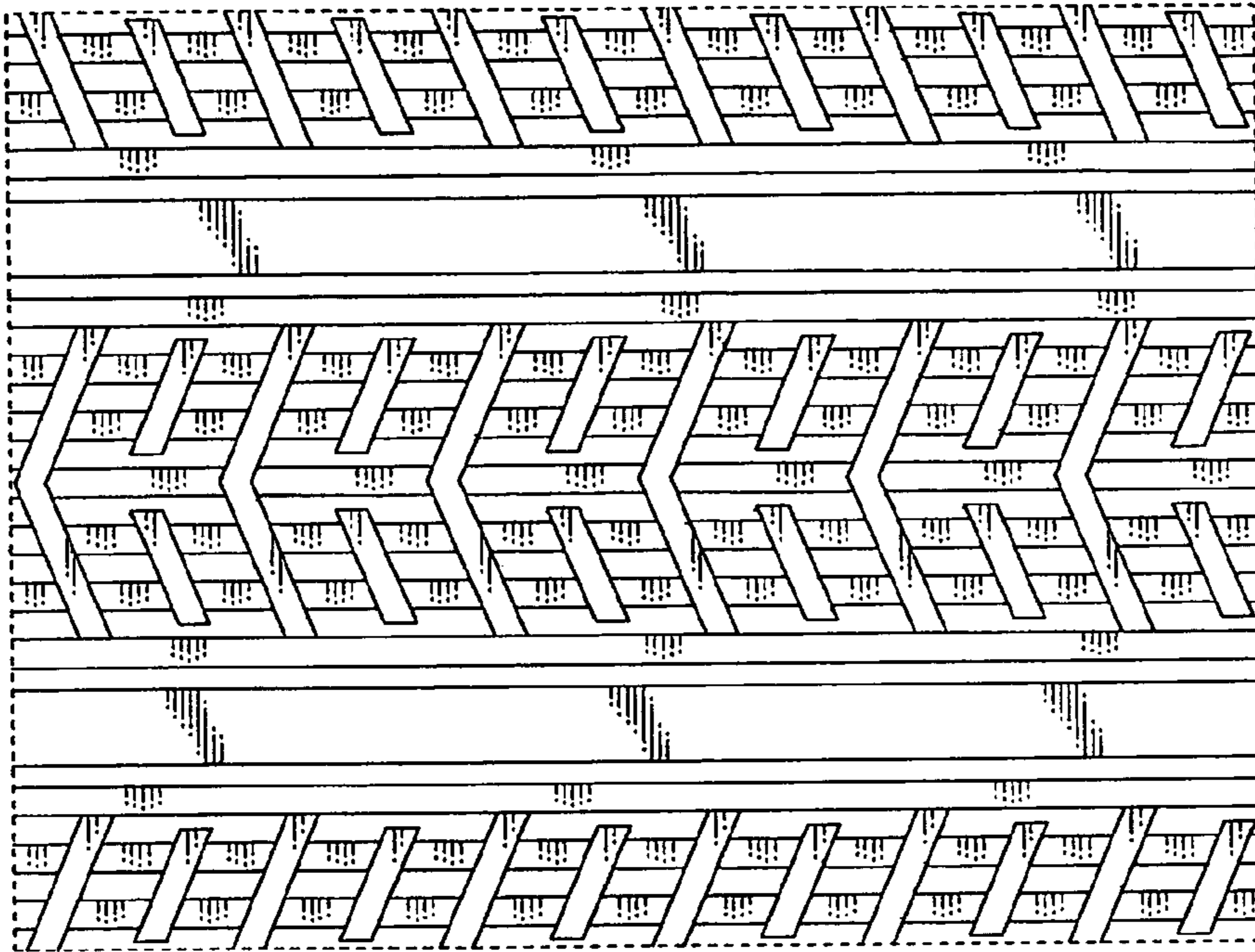

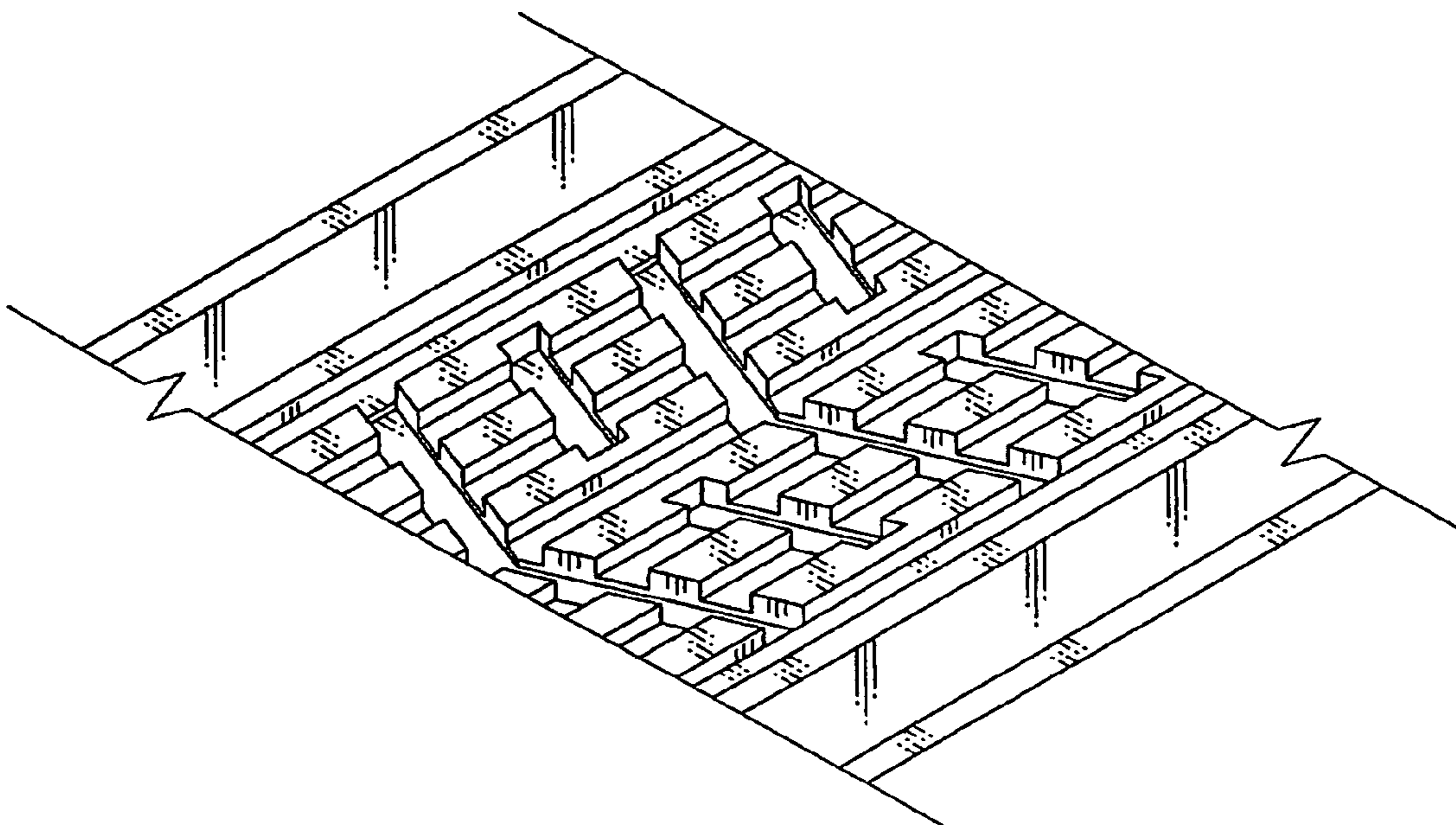

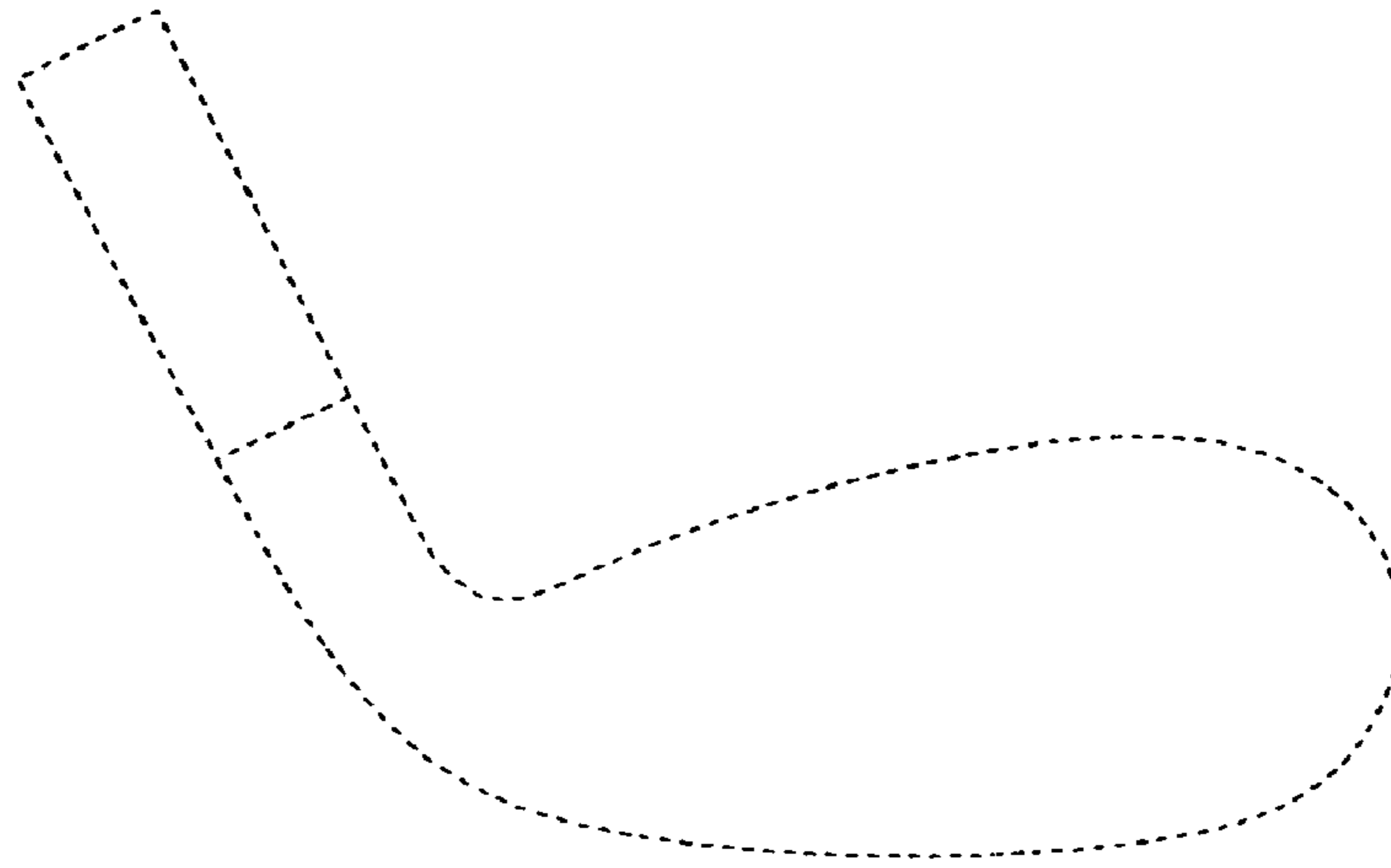

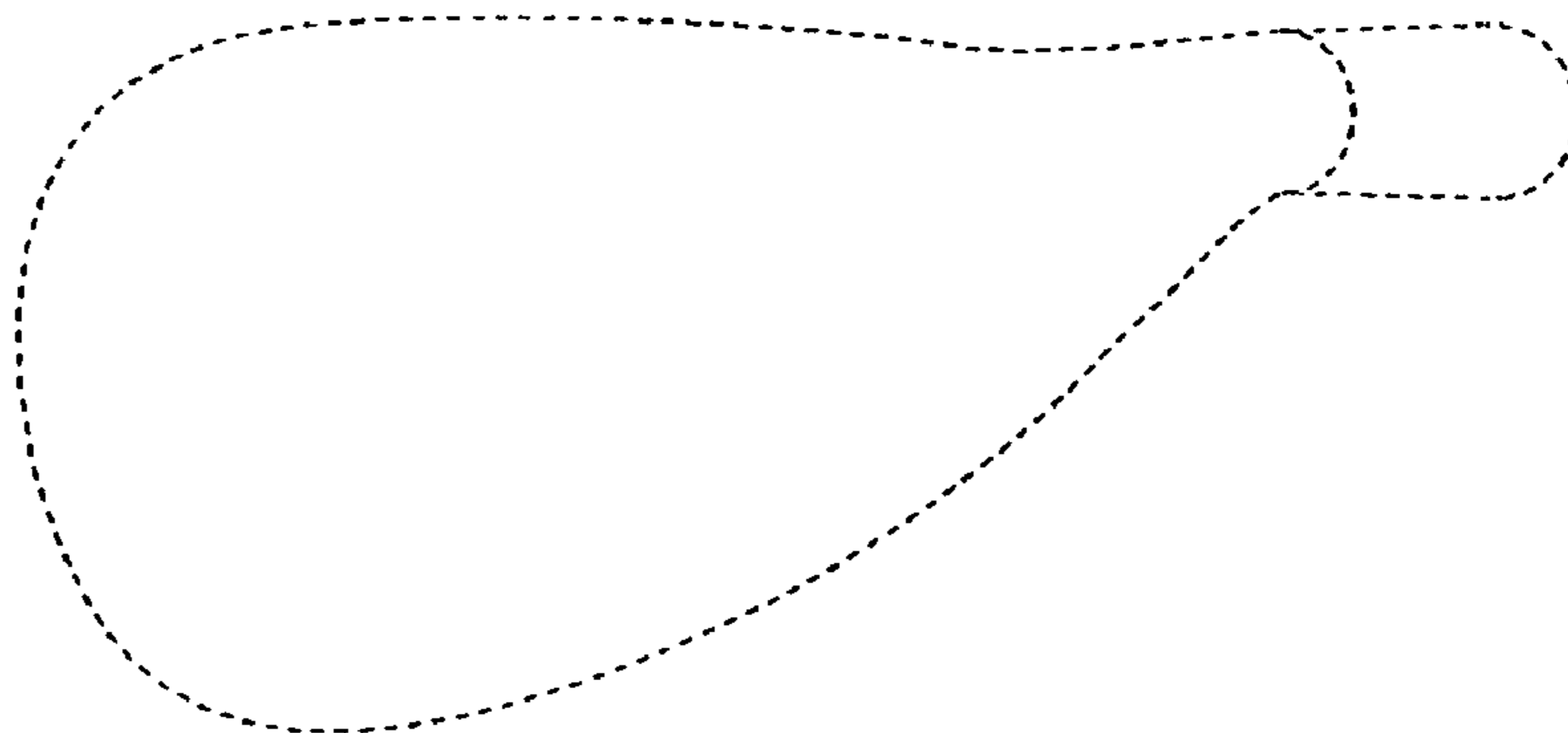

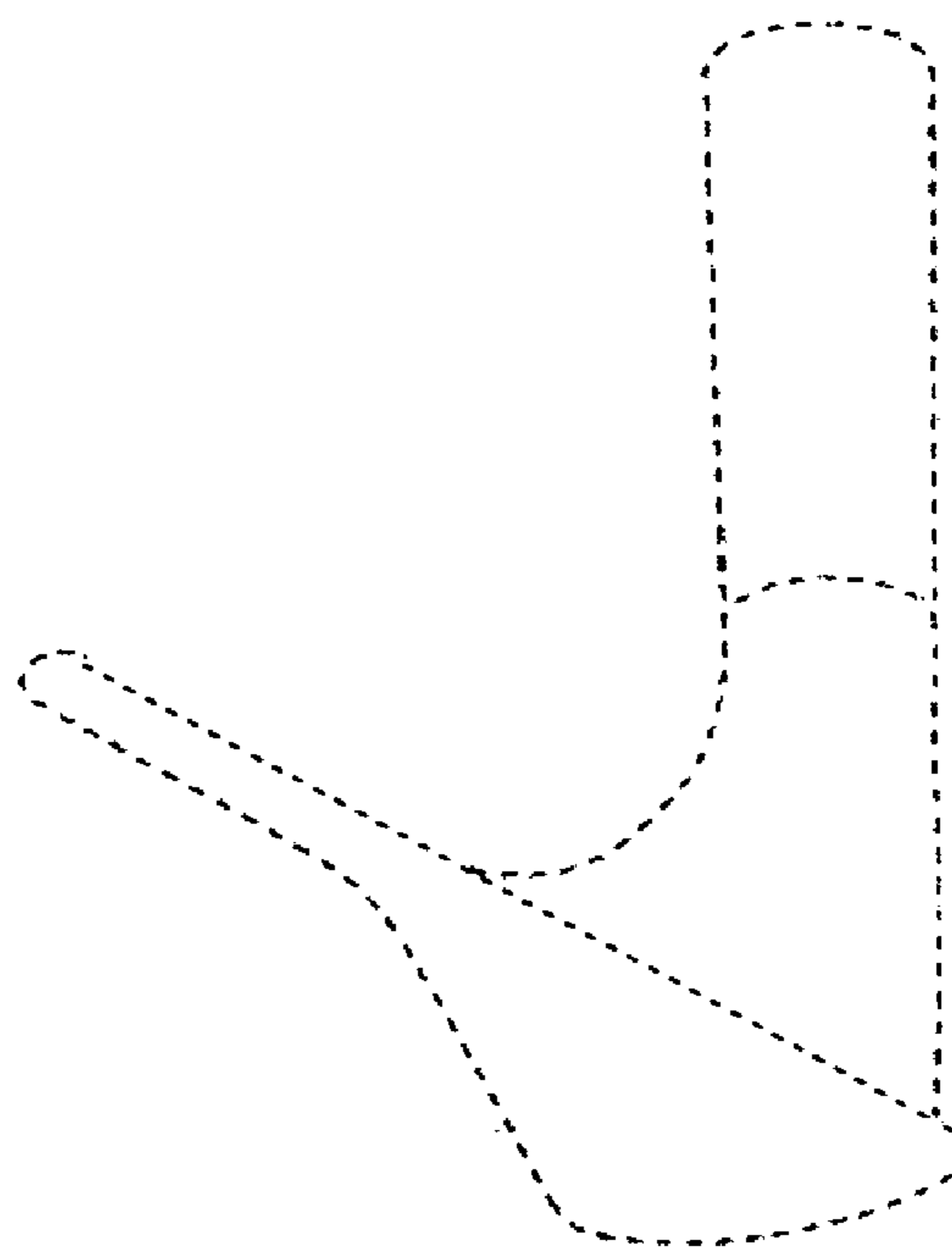
