The ornamental design for a fireplace giarre, as shown and described.

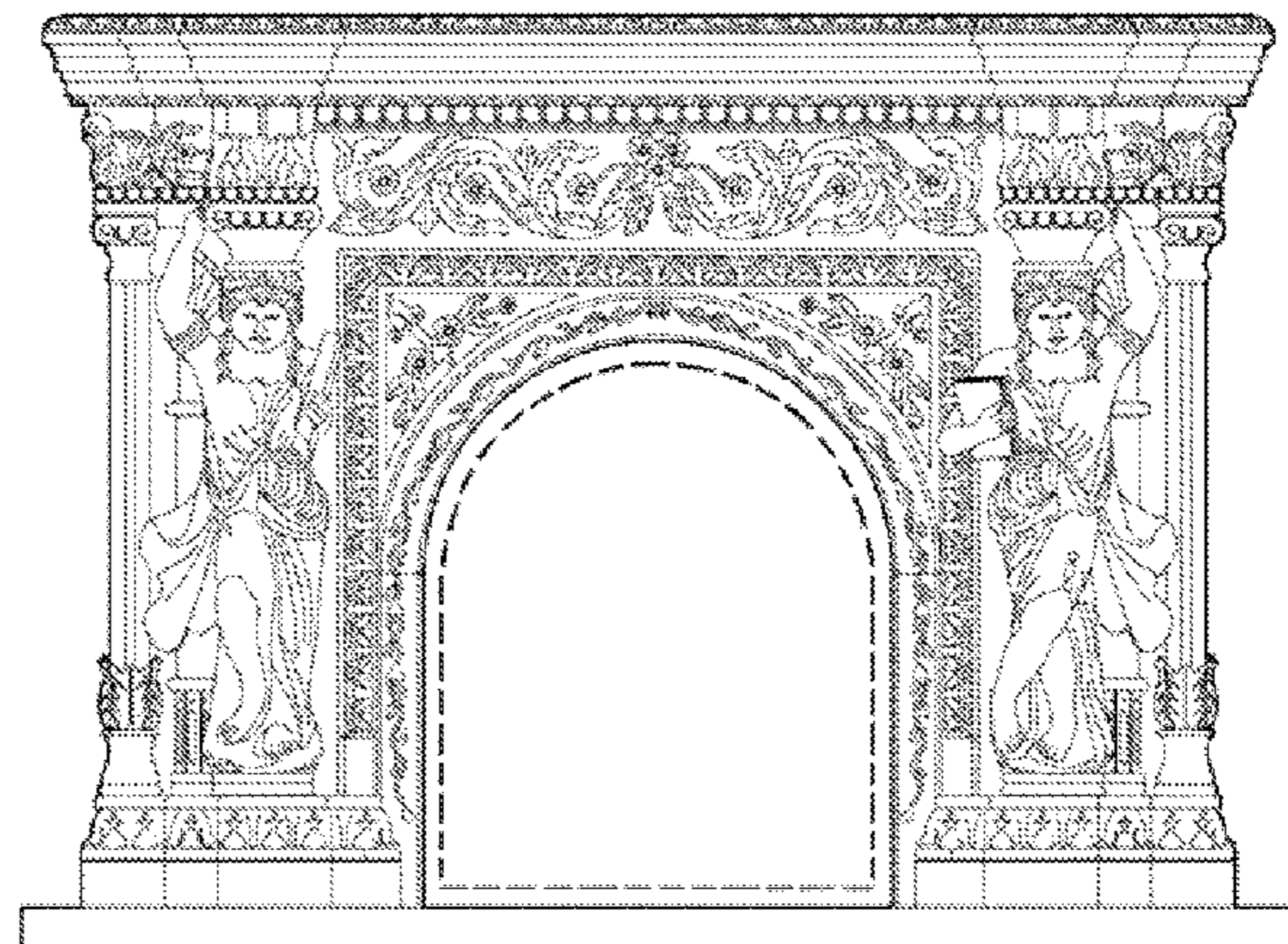
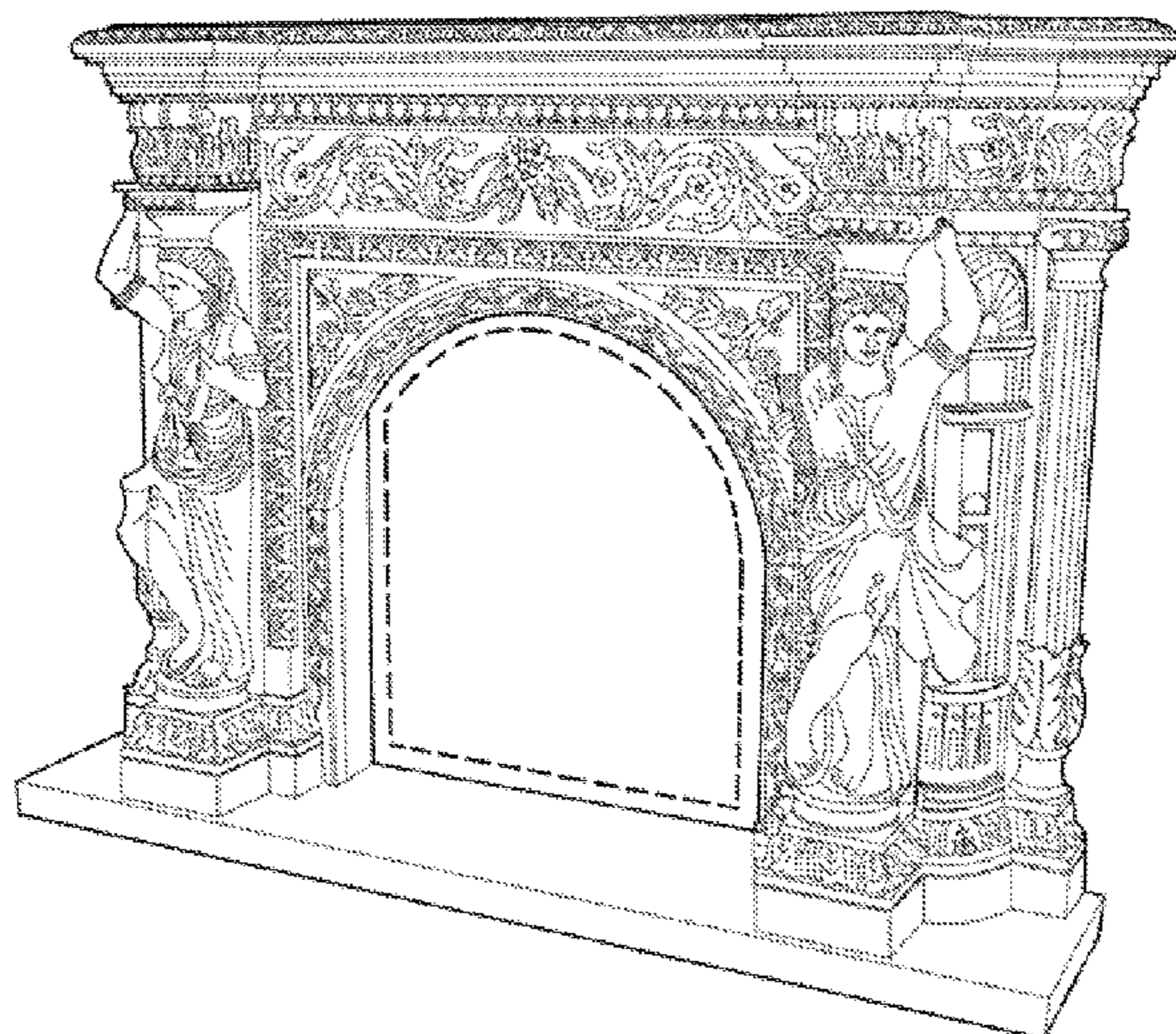
DESCRIPTION

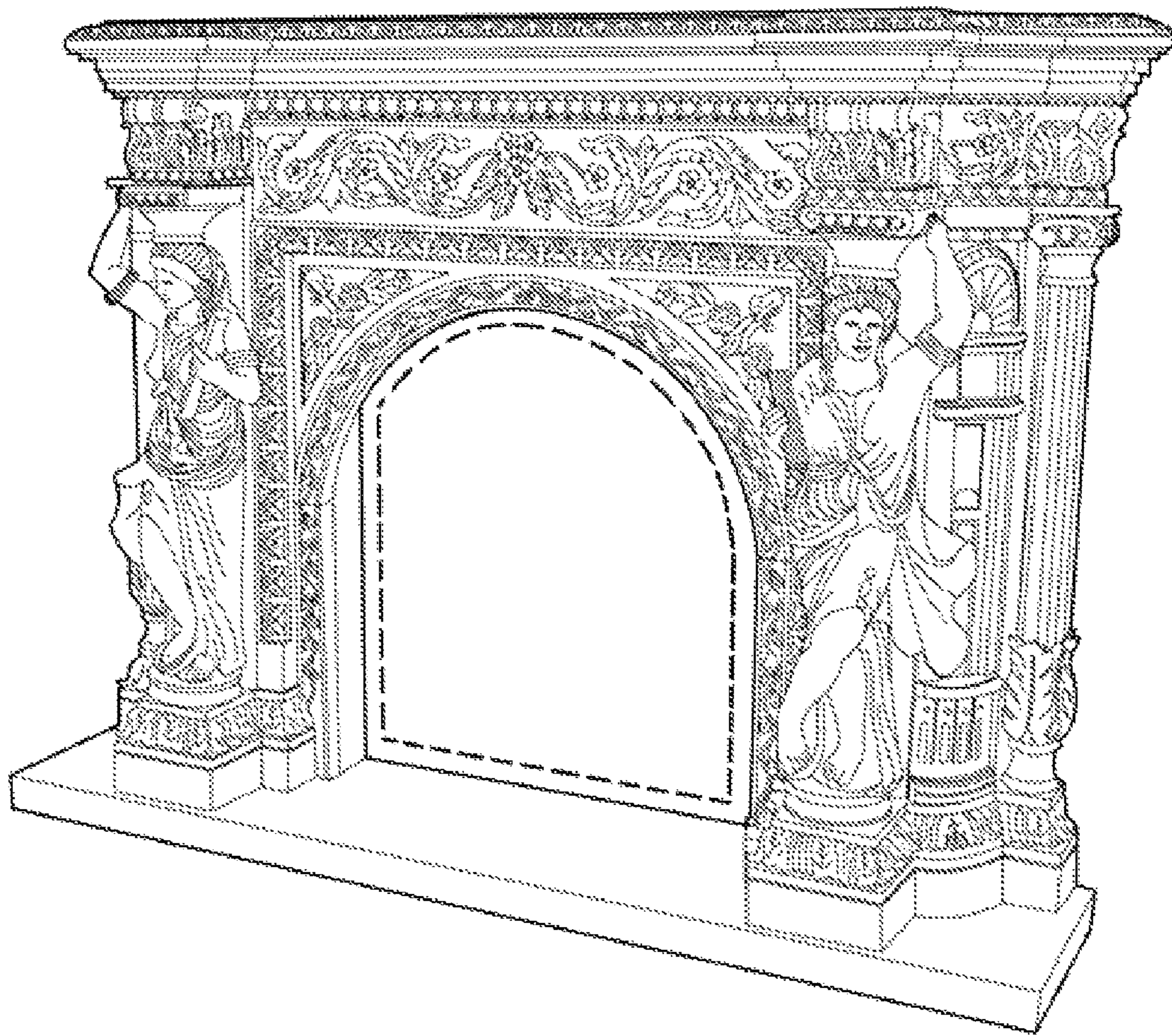

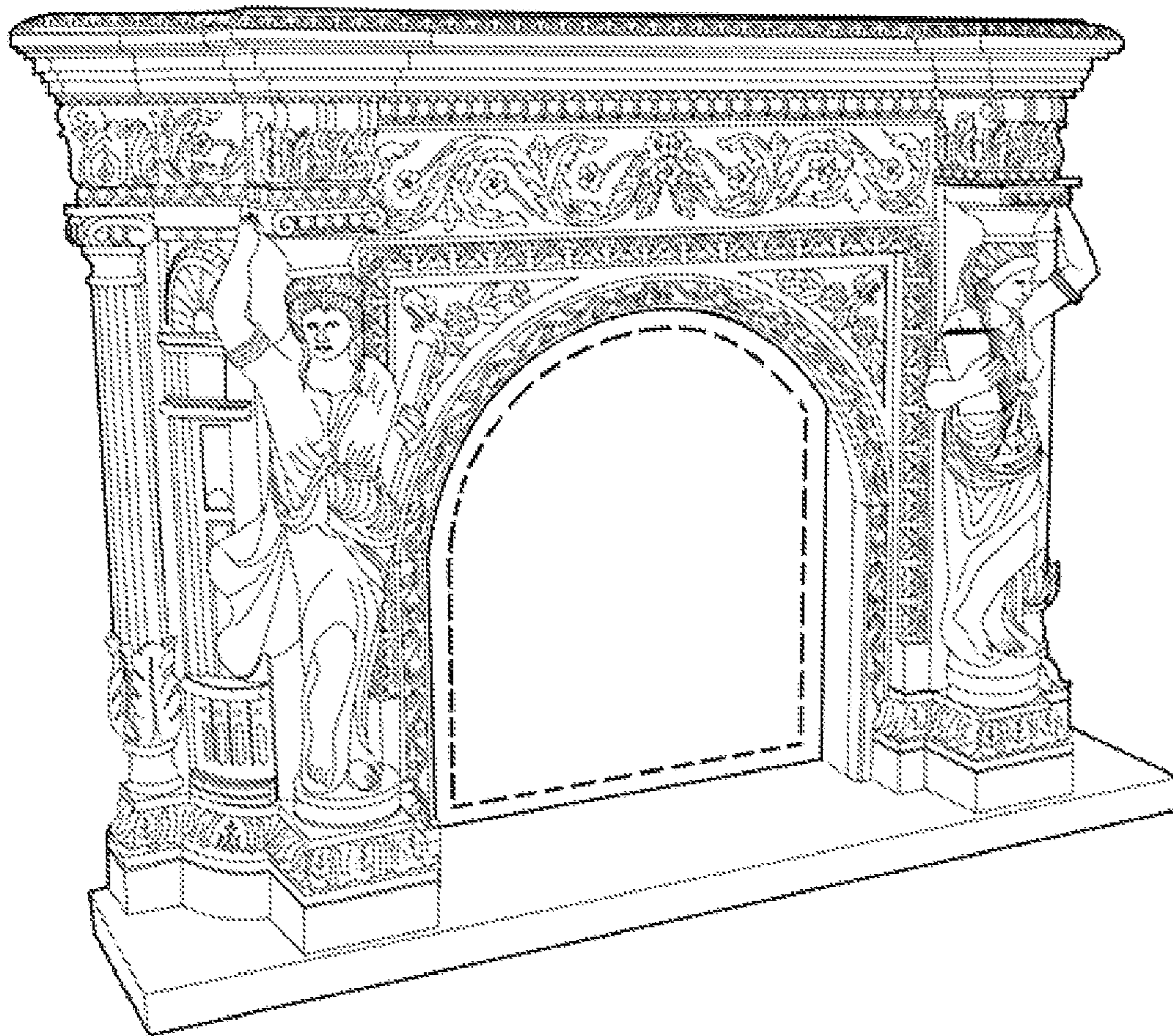

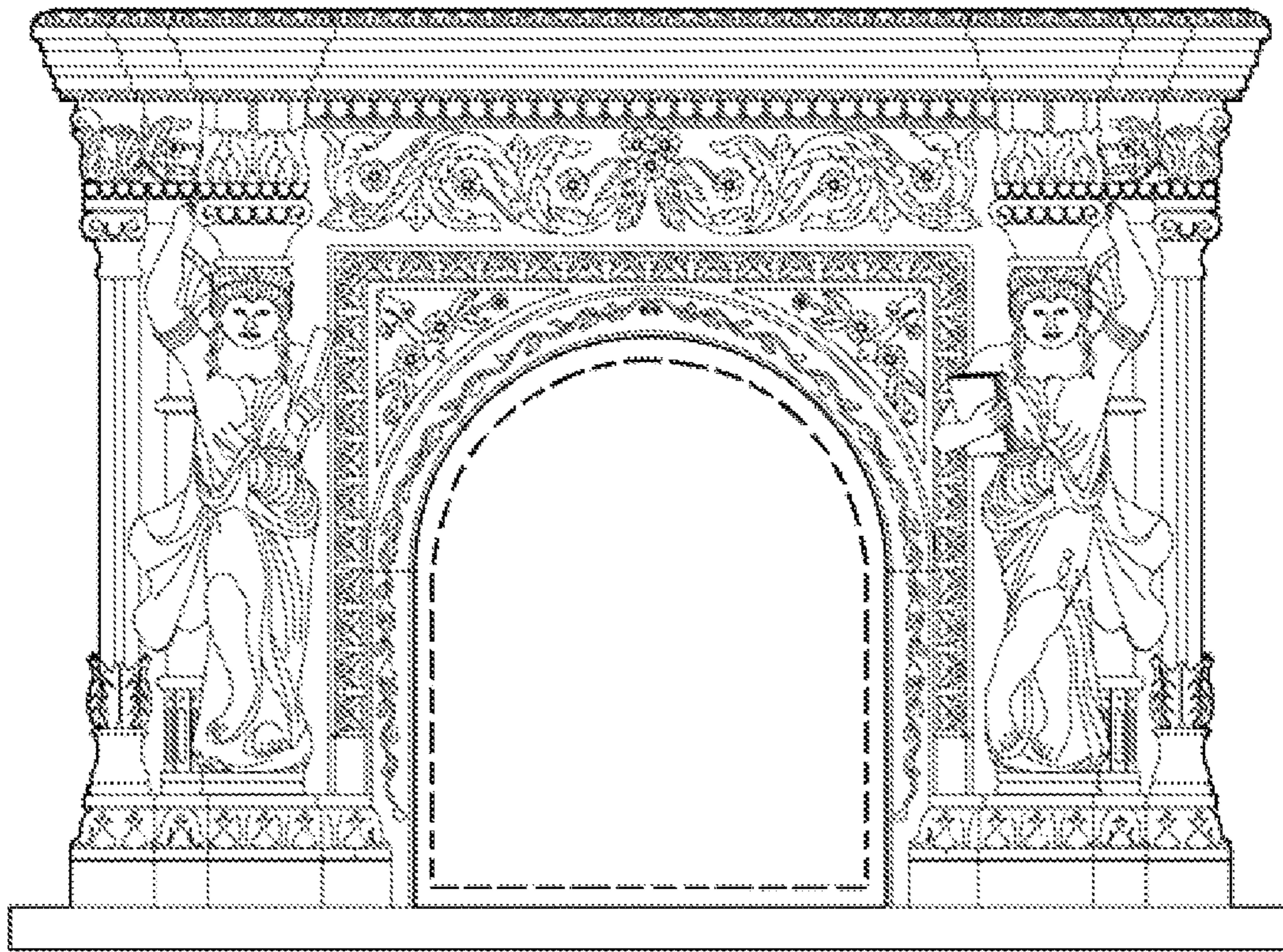

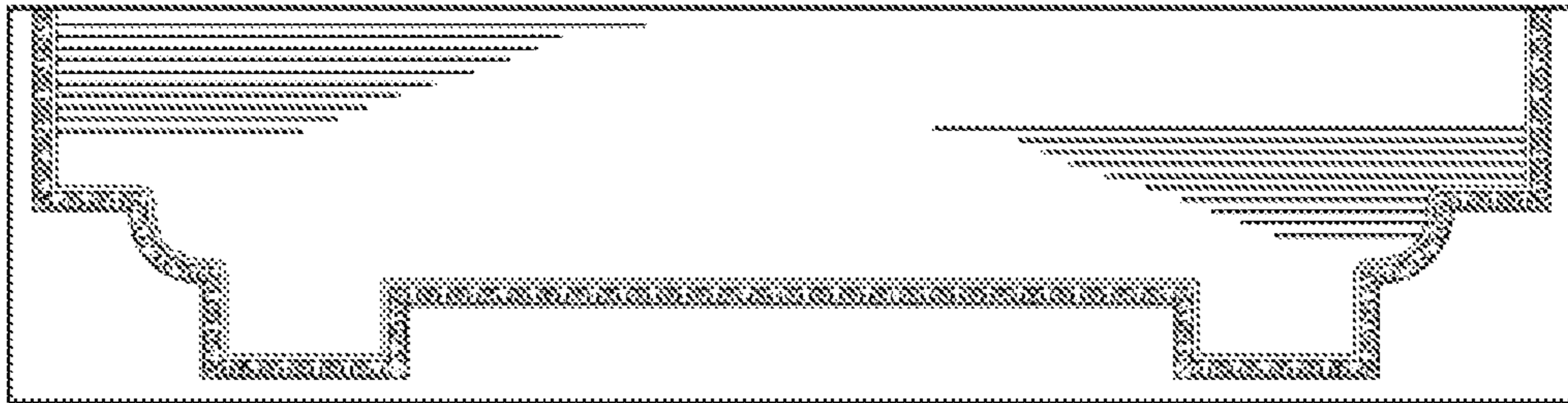

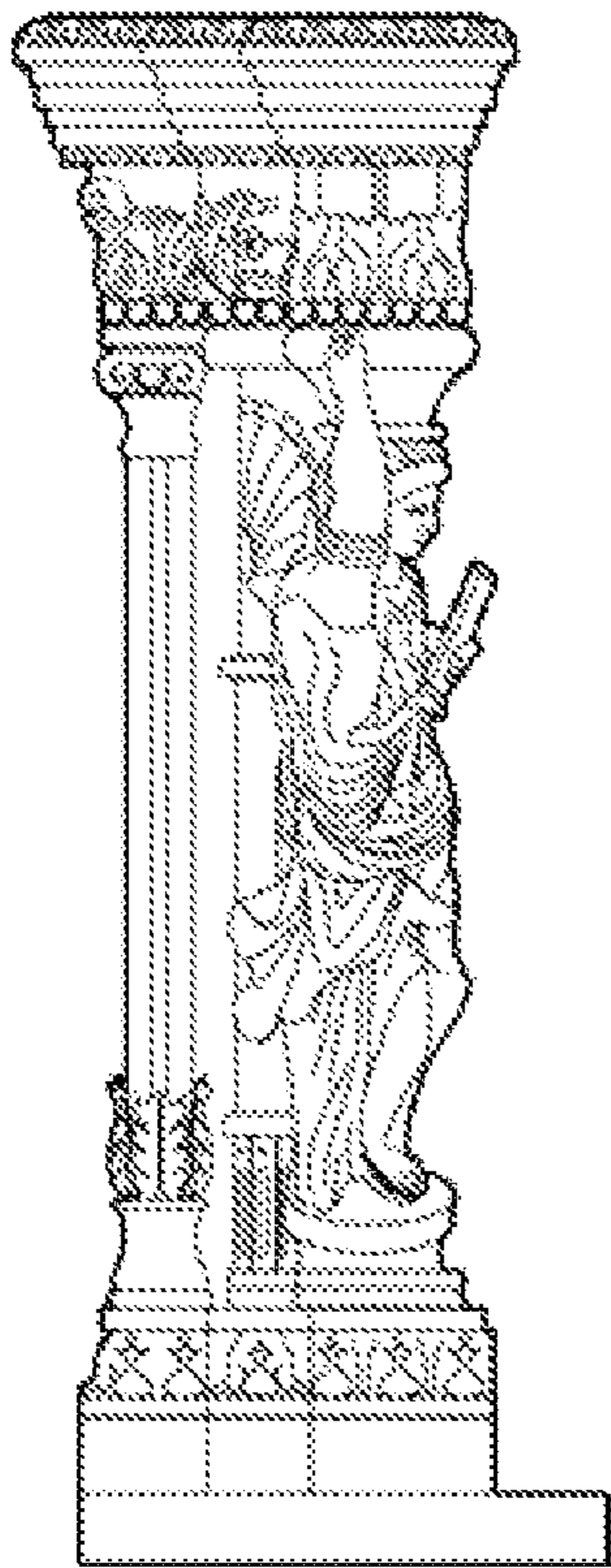

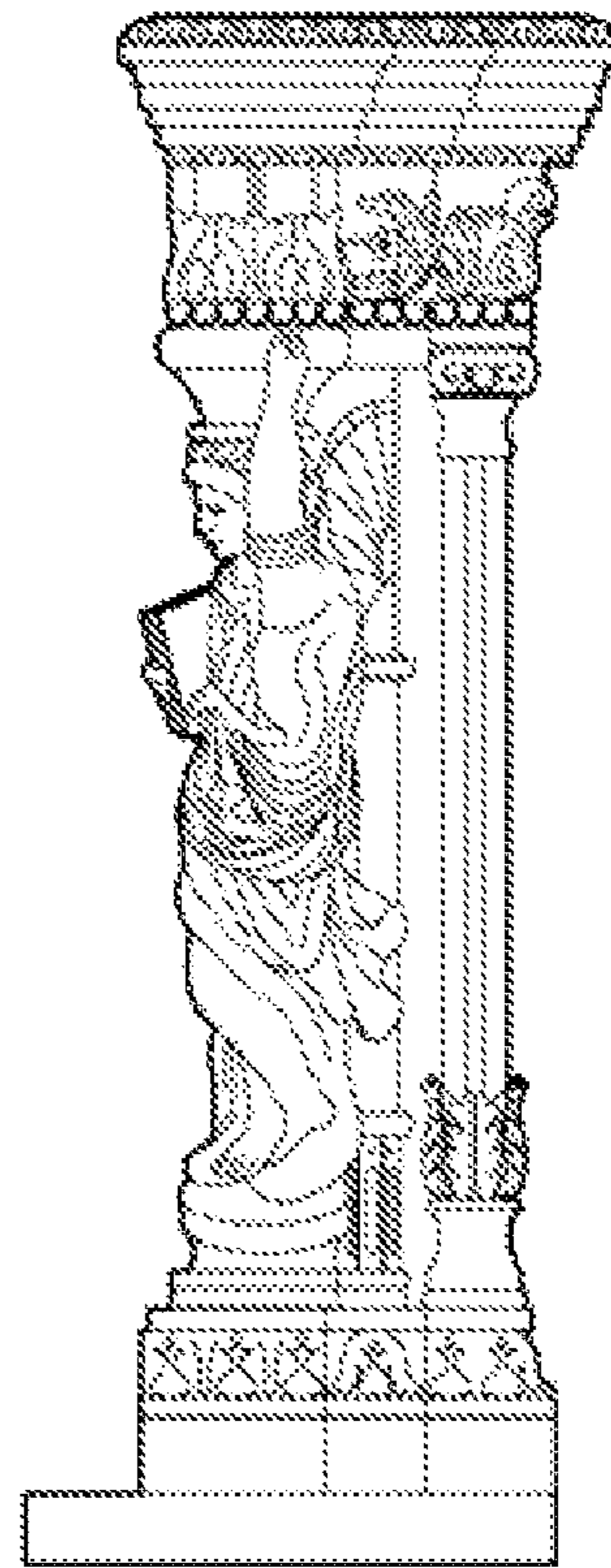
