(57) **CLAIM**

The ornamental design for a solar powered phone kiosk, as shown and described.

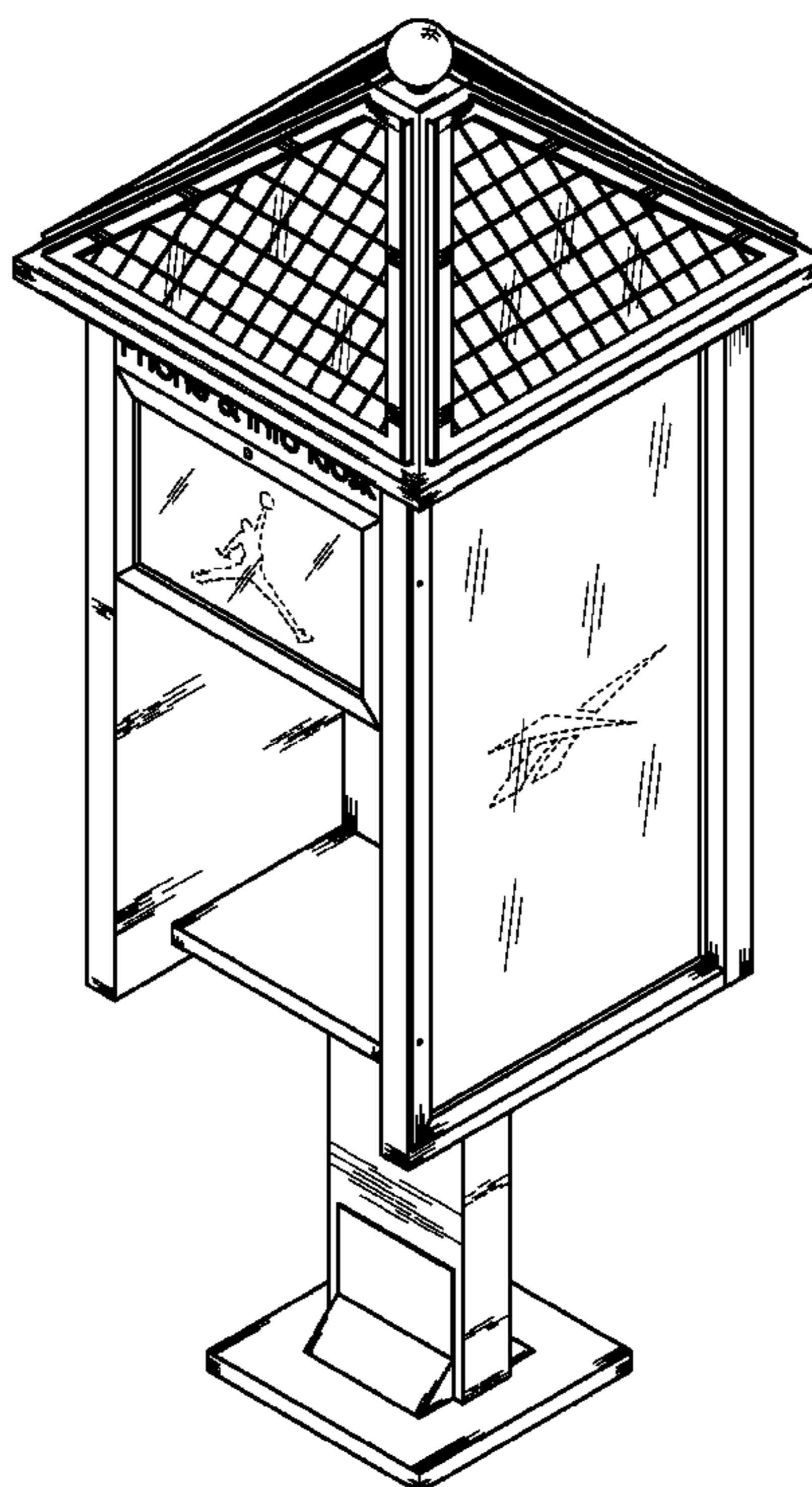
DESCRIPTION

FIG. 1 is a perspective view of a solar powered phone kiosk; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right-side elevational view thereof; FIG. 5 is a left-side elevational view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a top plan view thereof.

The broken line showing of a solar powered phone kiosk is for the purpose of illustrating environmental structure and forms no part of the claimed design.

The broken line showing of interior details in FIGS. 2 and 6 and the shapes on the advertising frames in FIGS. 1-5 is included for the purpose of showing environmental portions of the solar powered phone kiosk and forms no part of the claimed design.

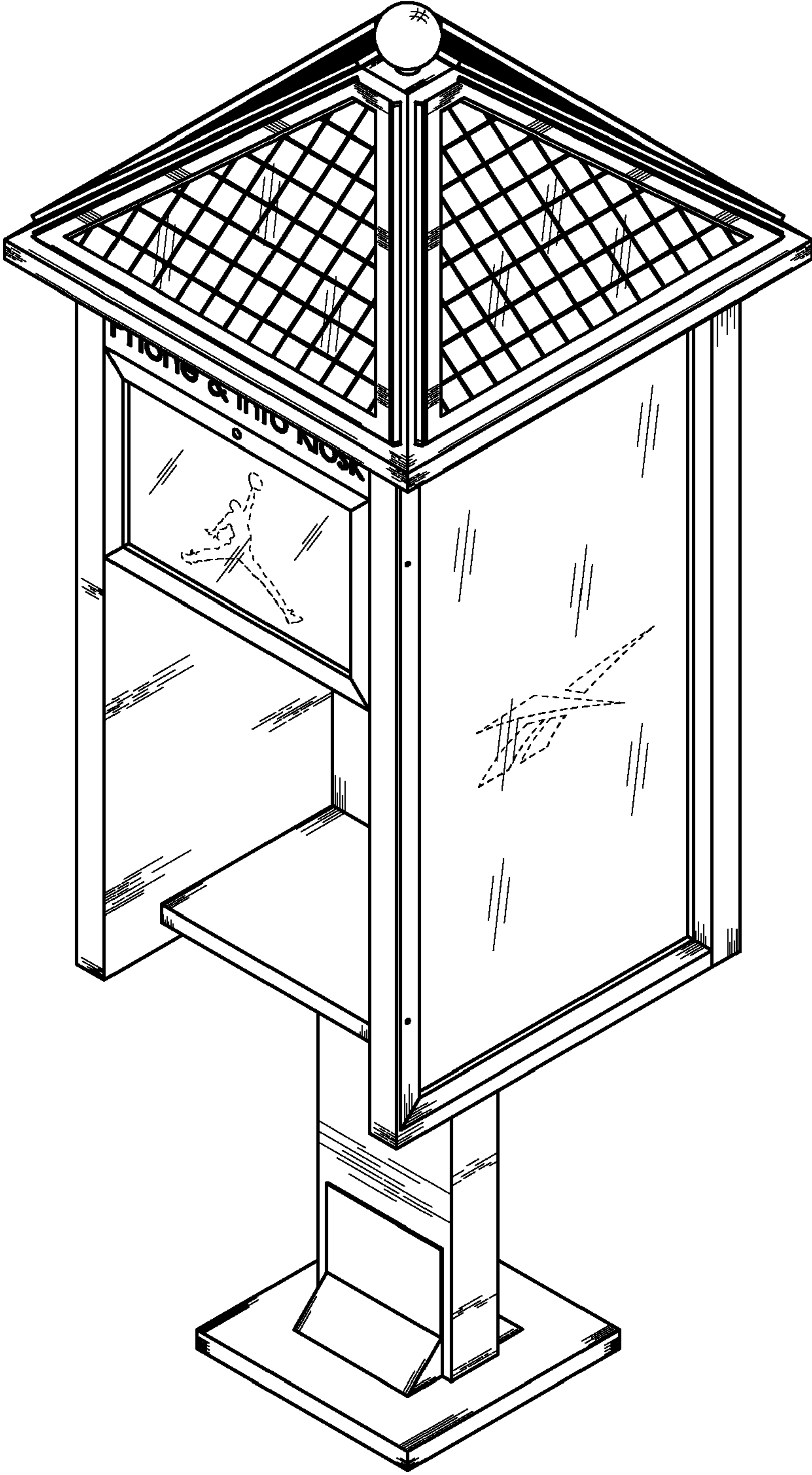

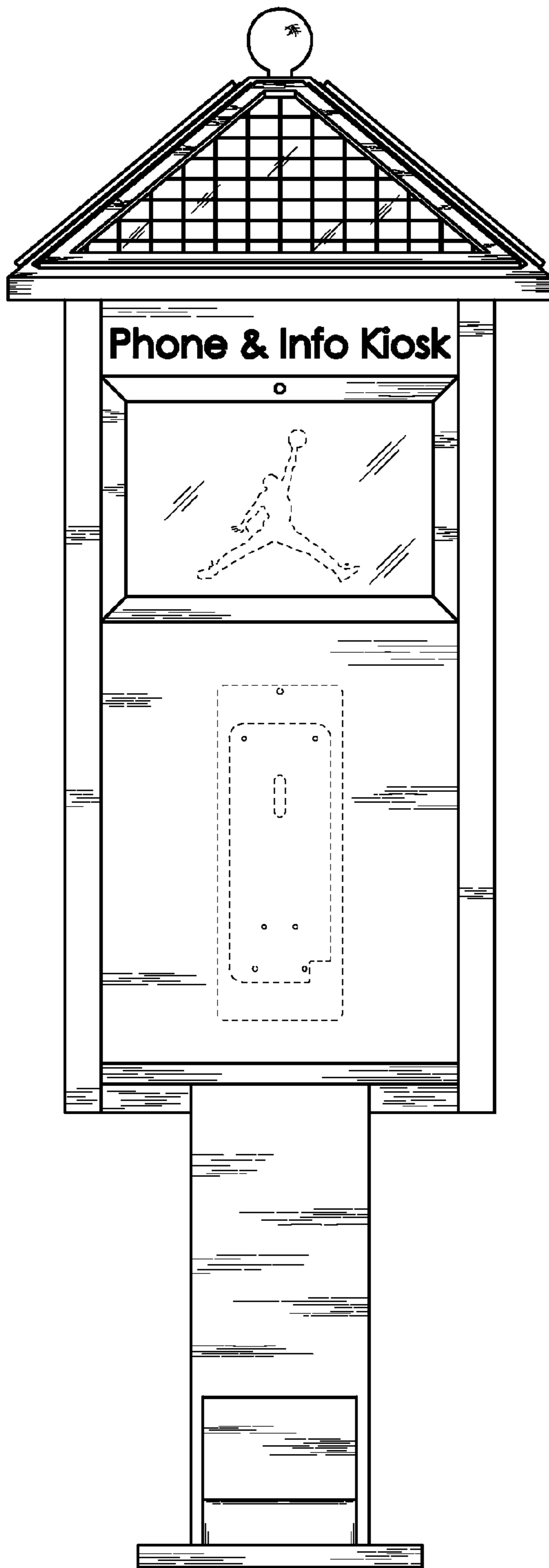

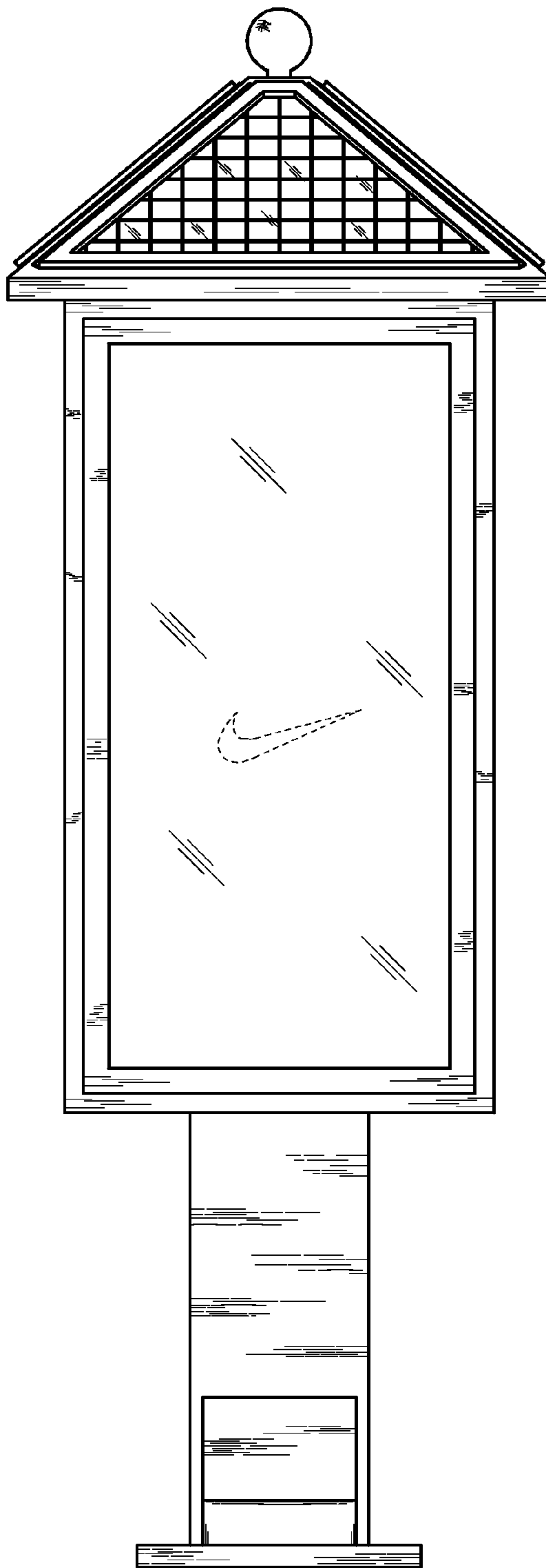

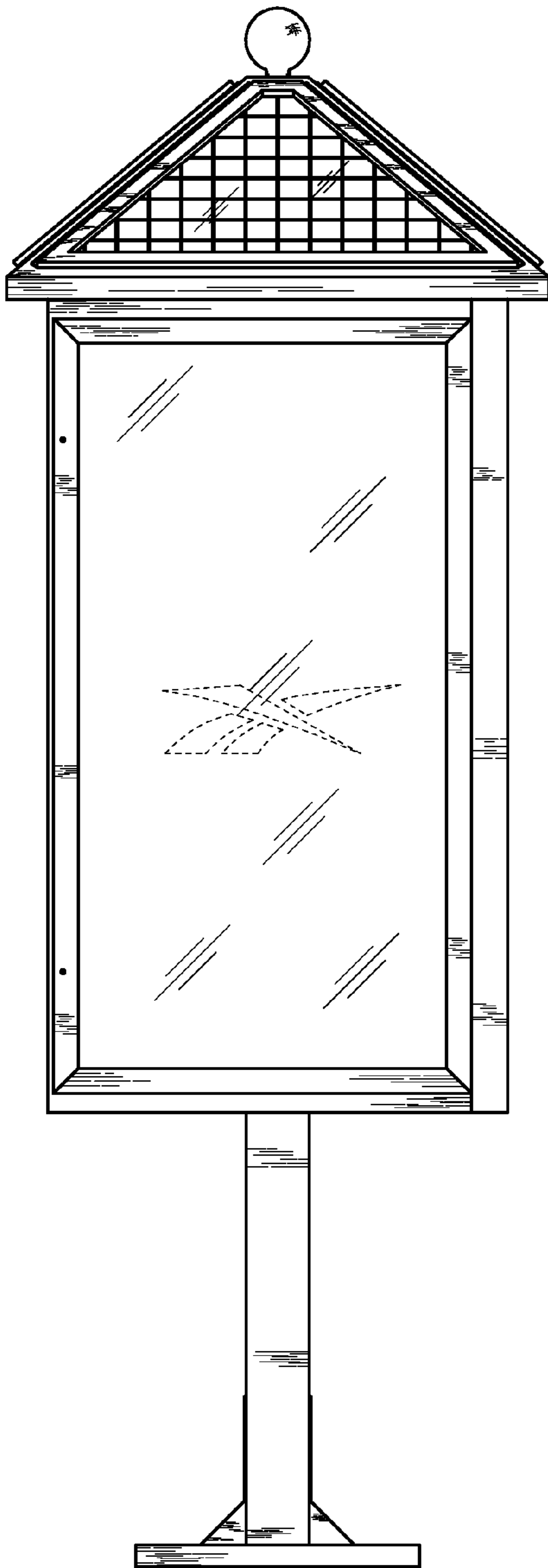

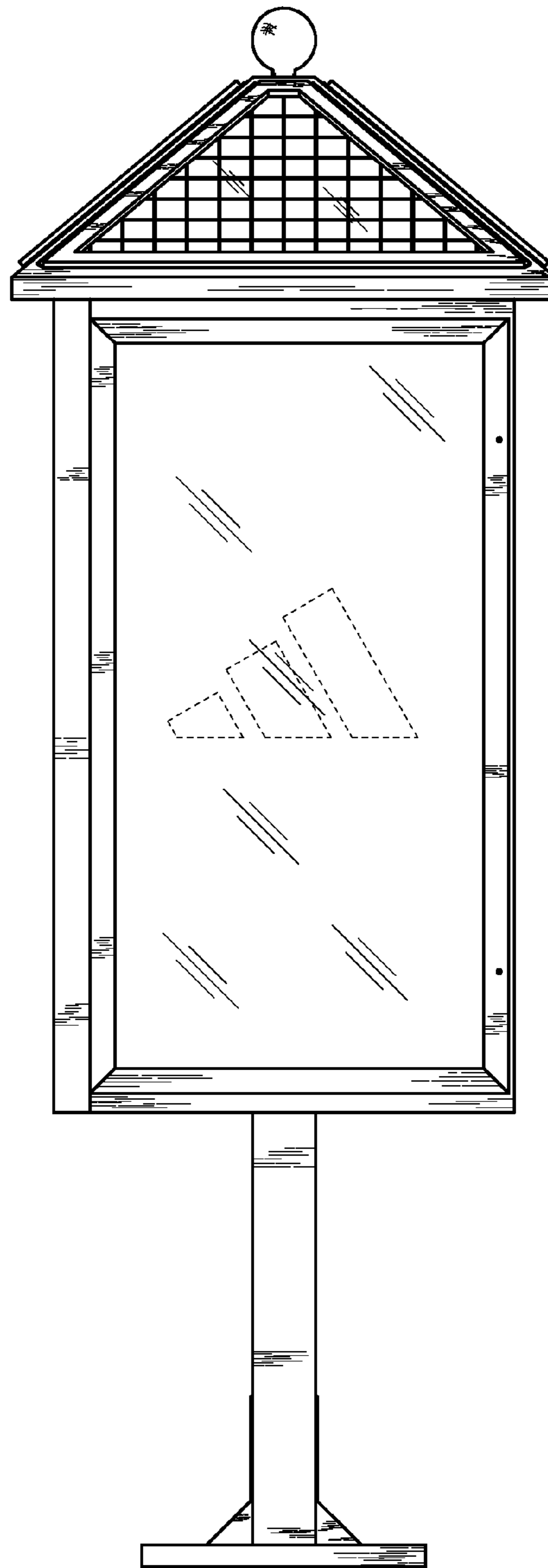

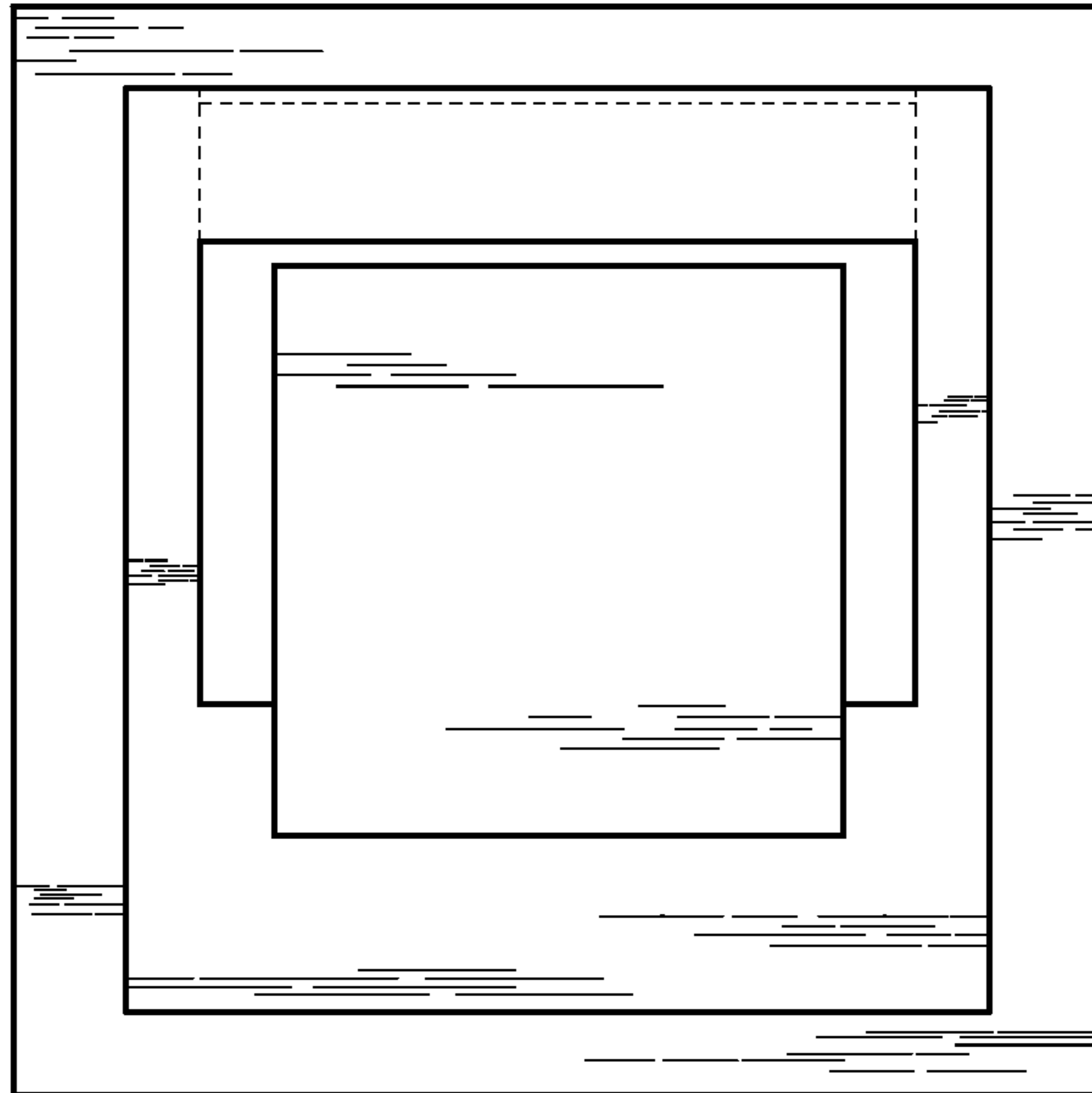

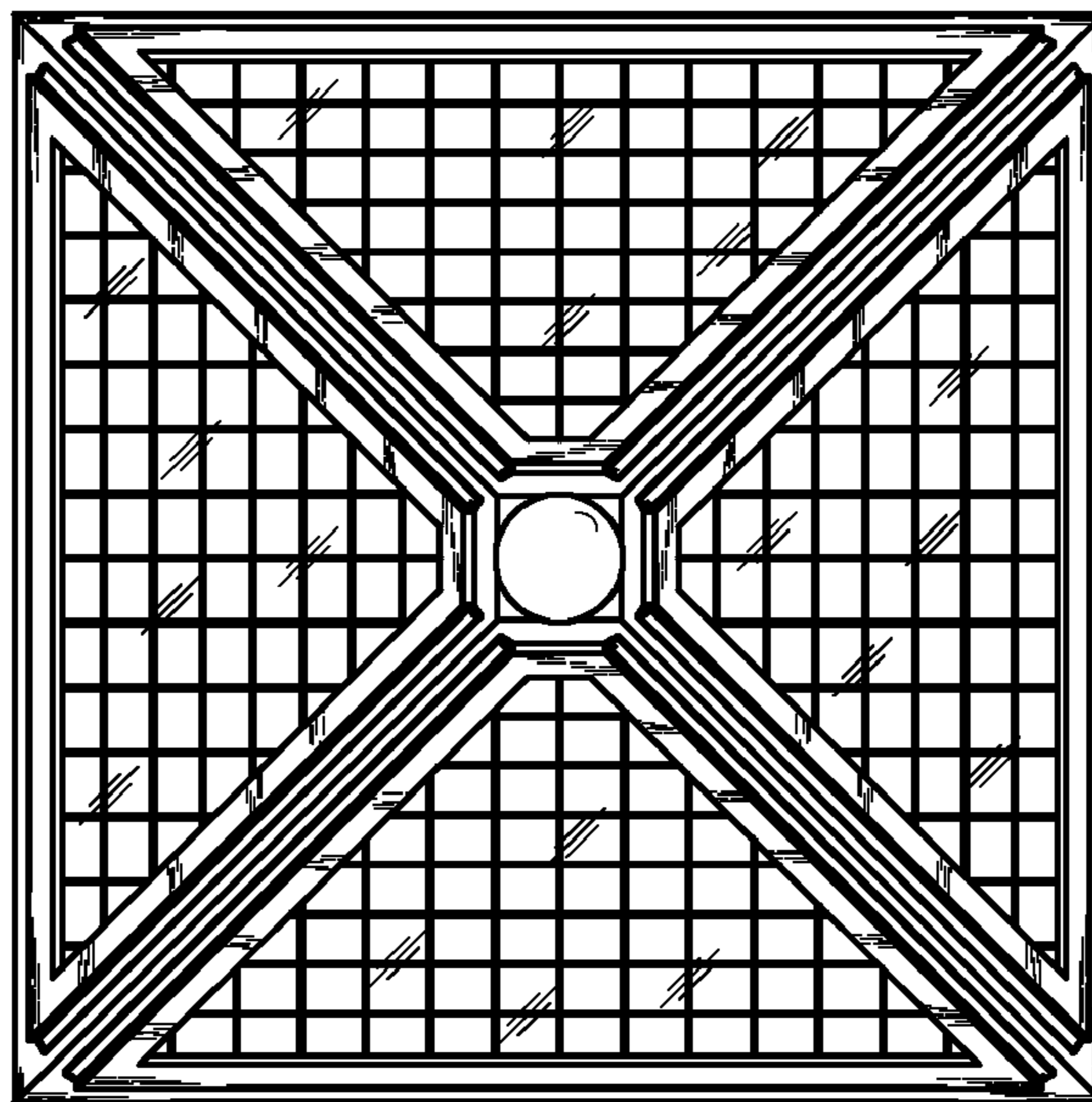
