The ornamental design for a wearable arm pillow, as shown and described.

DESCRIPTION

FIG. 1 is an illustrative front view of the wearable arm pillow; FIG. 2 is a back view of the wearable arm pillow; FIG. 3 is a right side view of the wearable arm pillow; FIG. 4 is a top side view of the wearable arm pillow; FIG. 5 is a bottom side view of the wearable arm pillow; and, FIG. 6 is a front view of the wearable arm pillow.

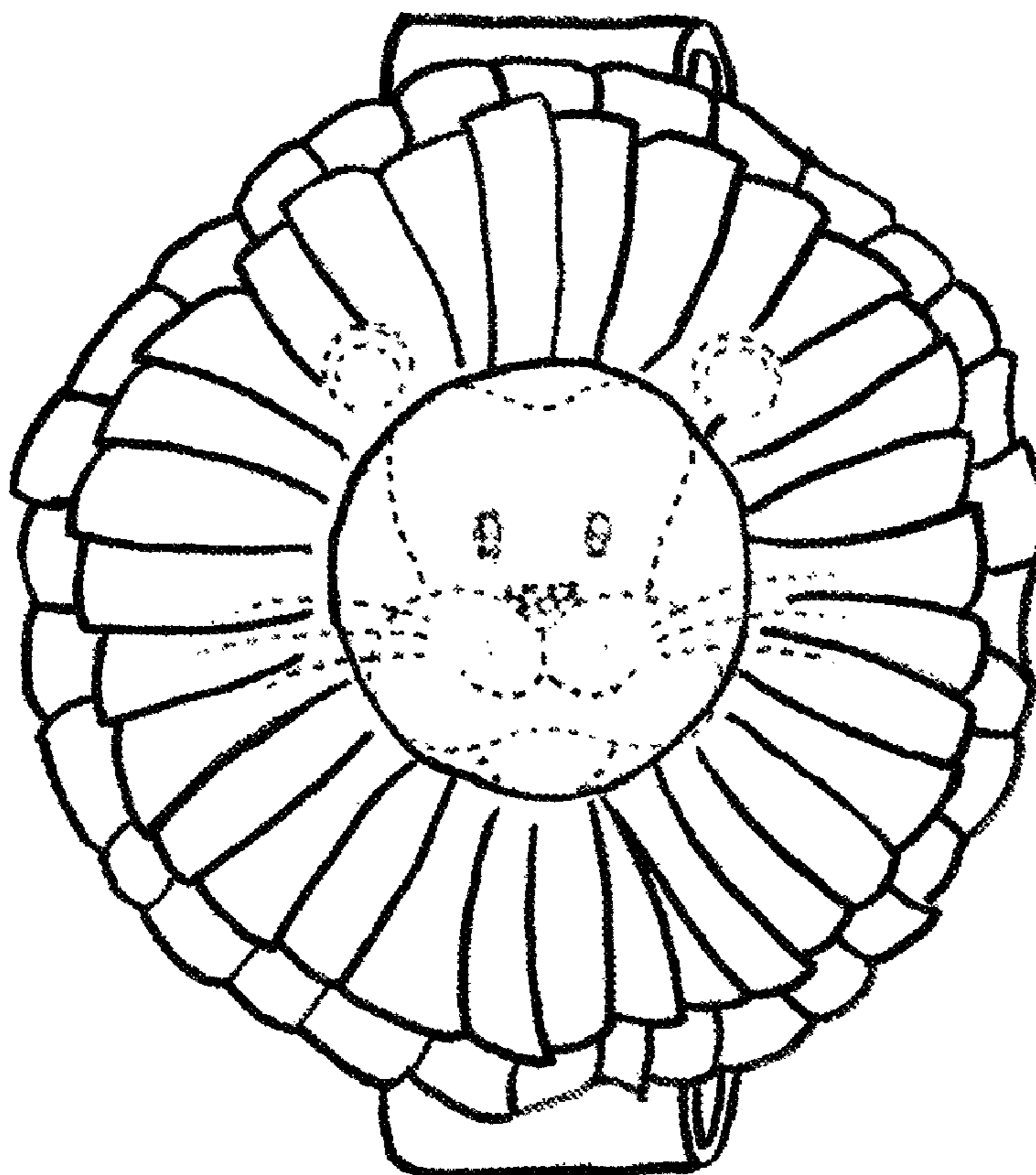

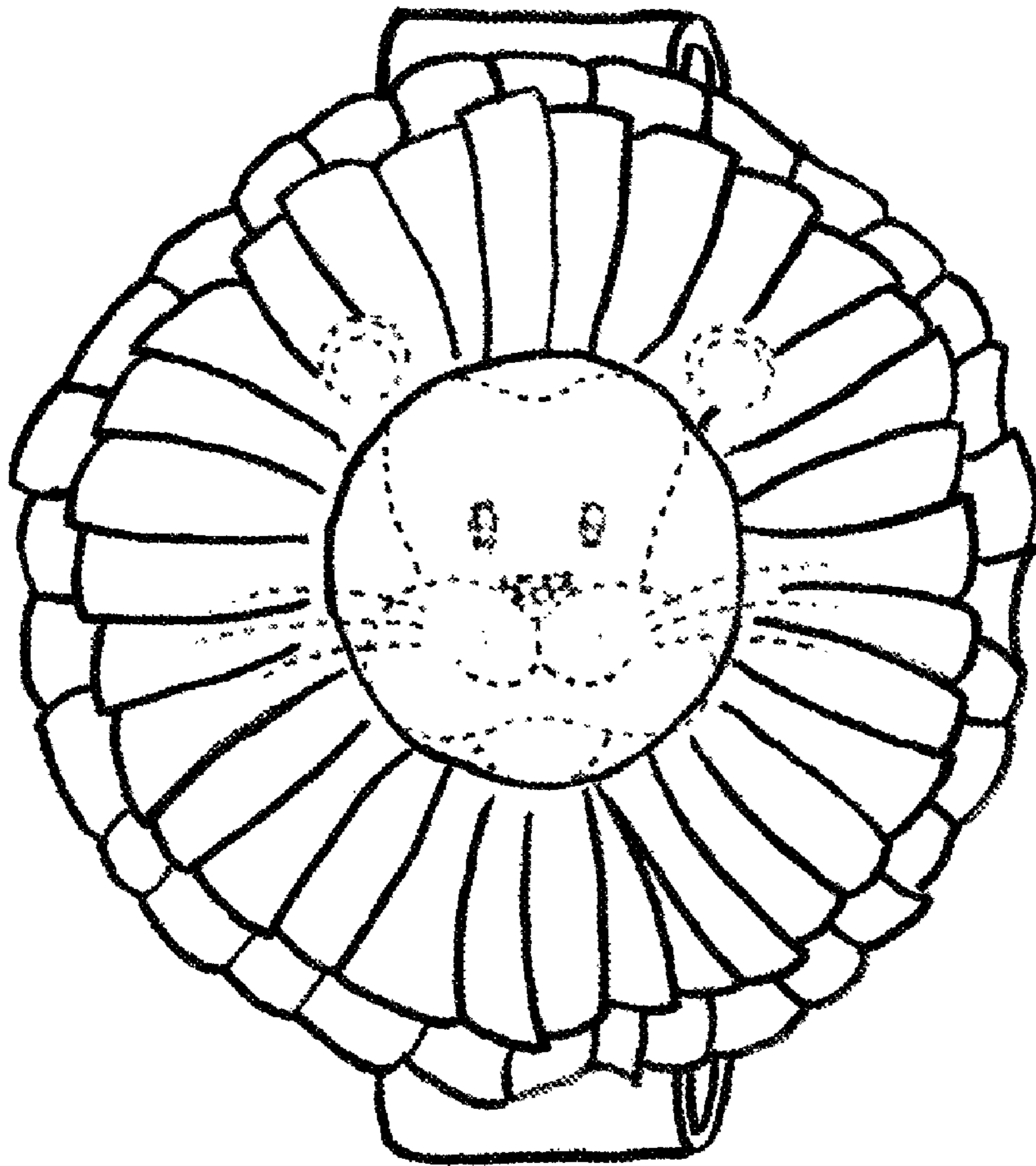

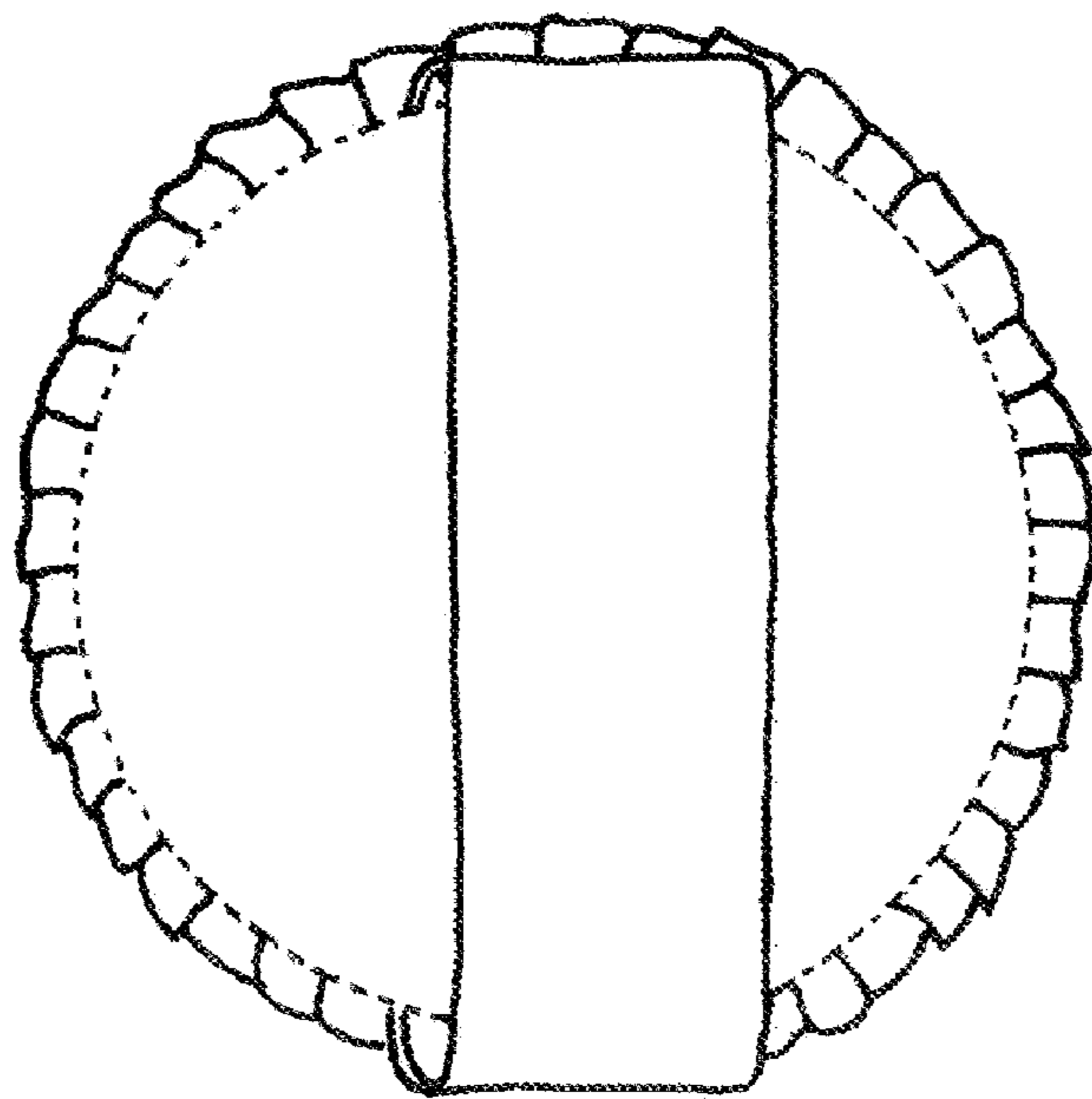

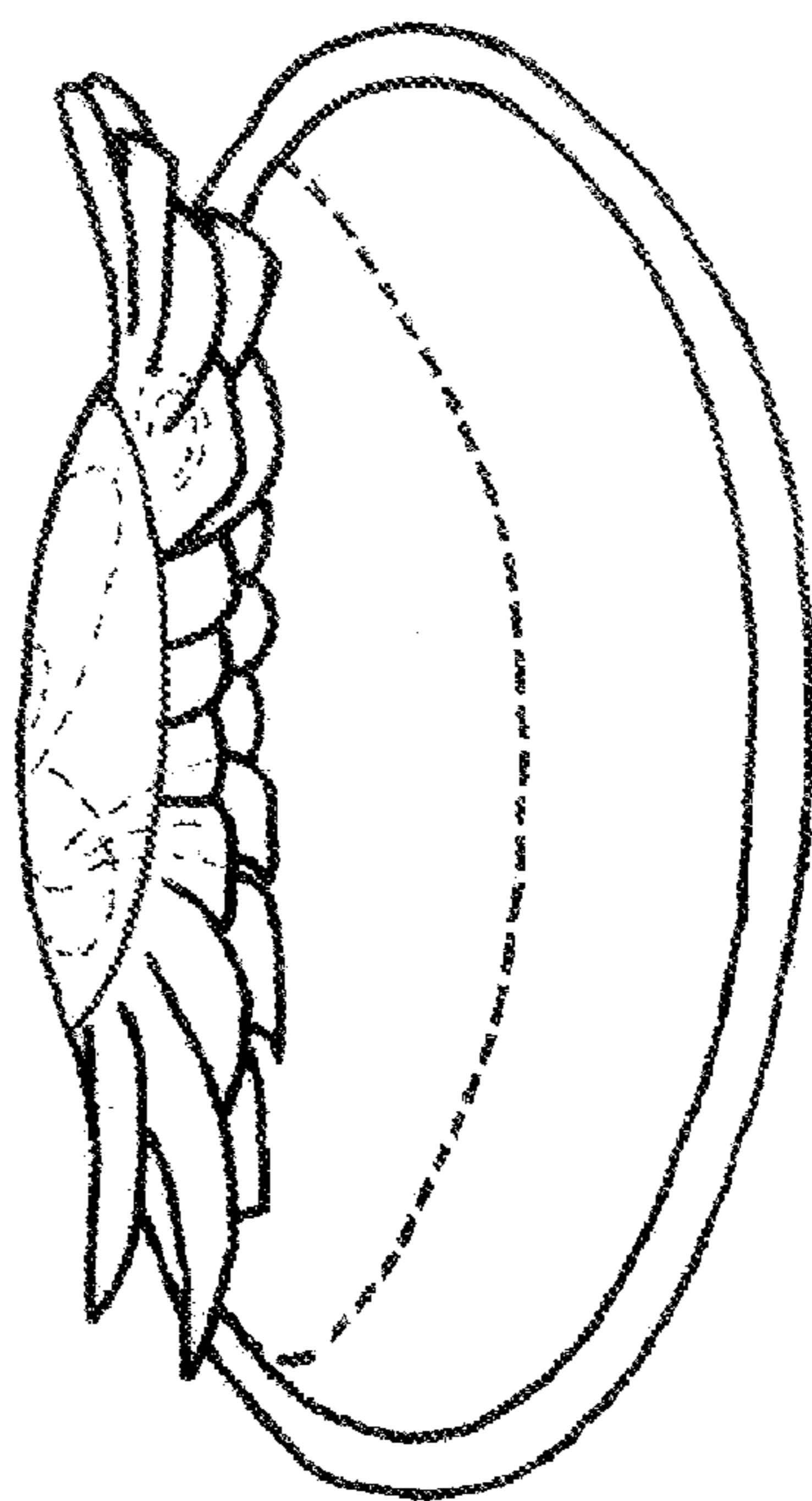

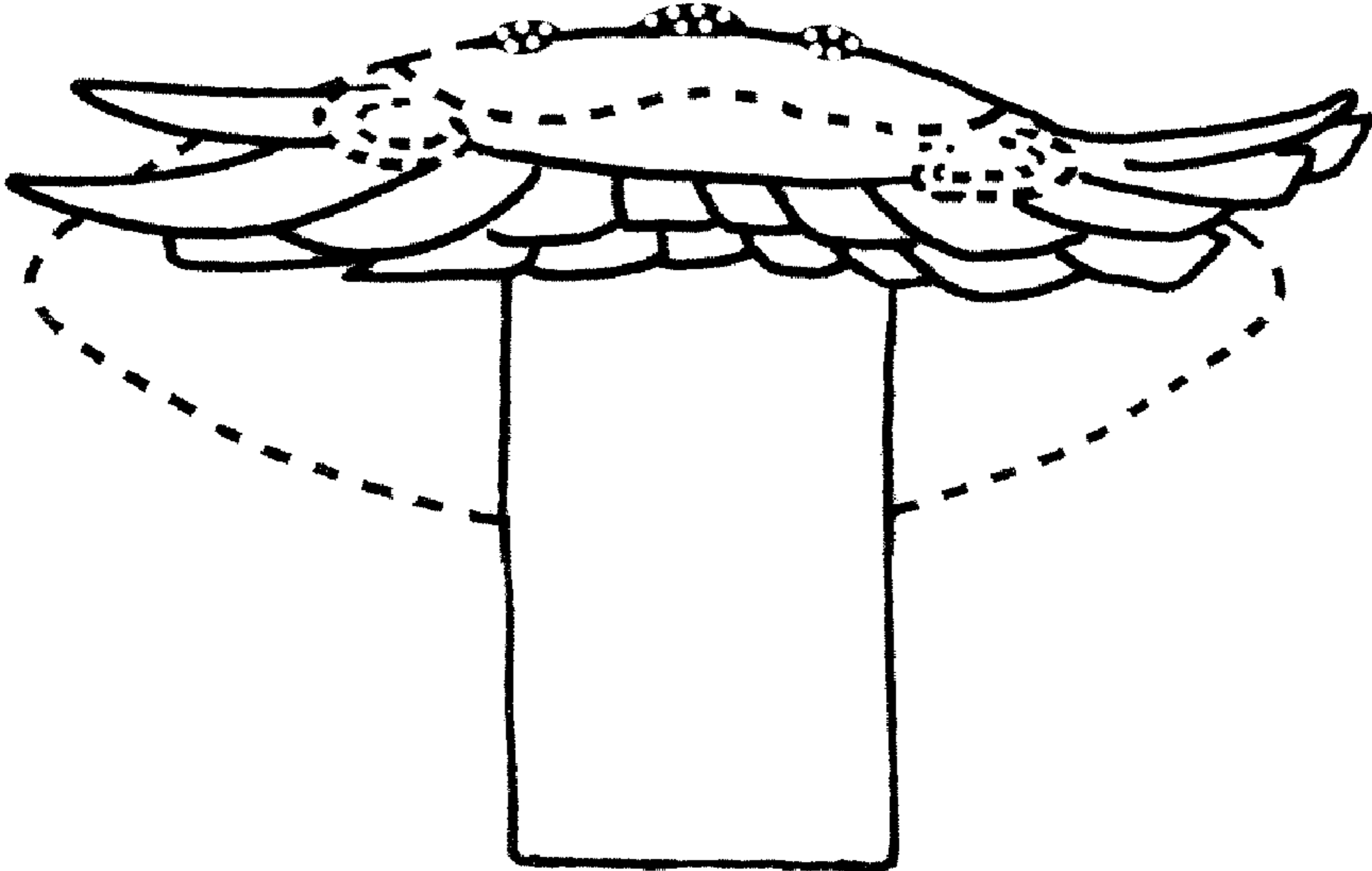

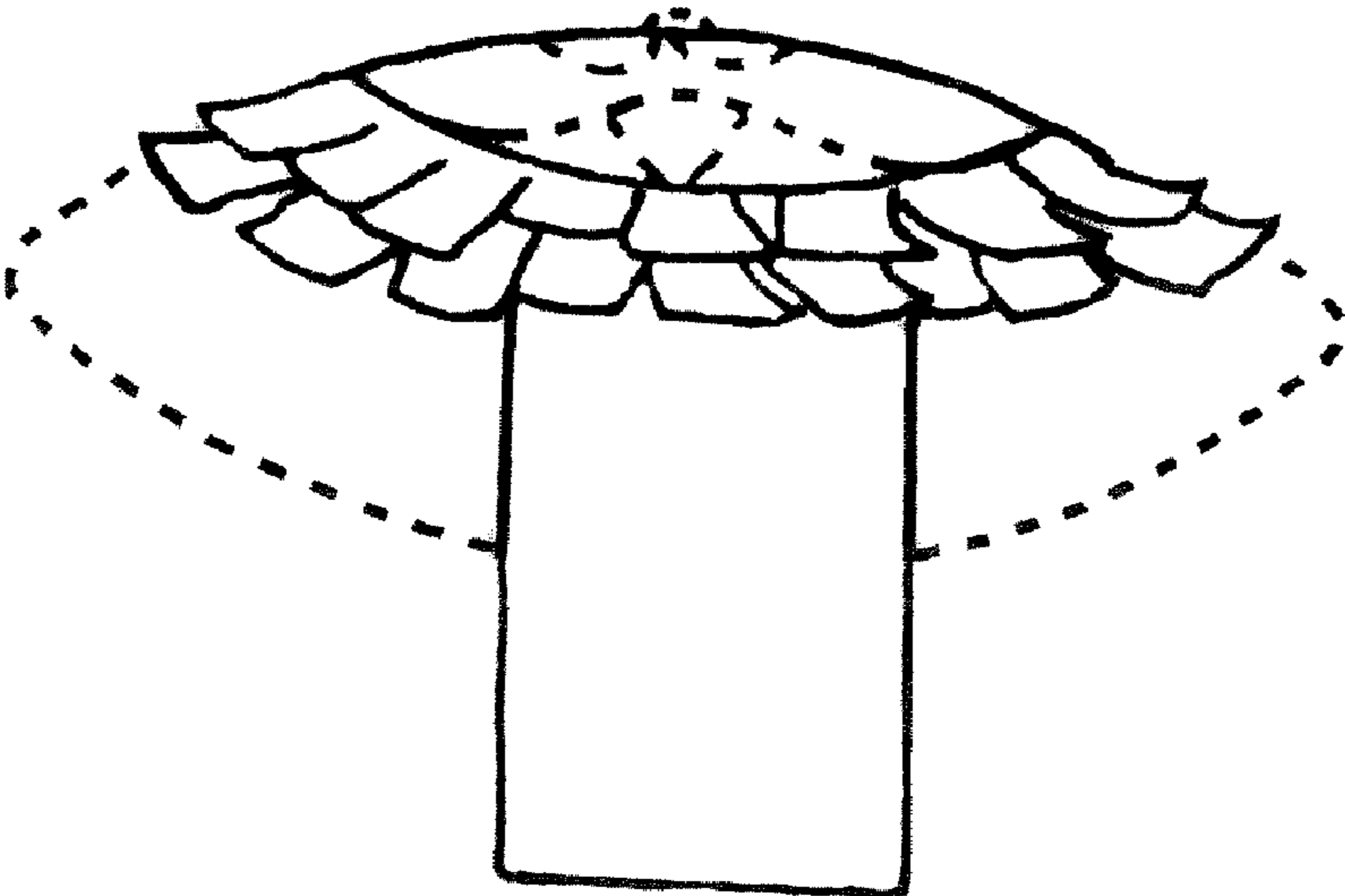
