The ornamental design for a sleep sack, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the sleep sack of the present invention;

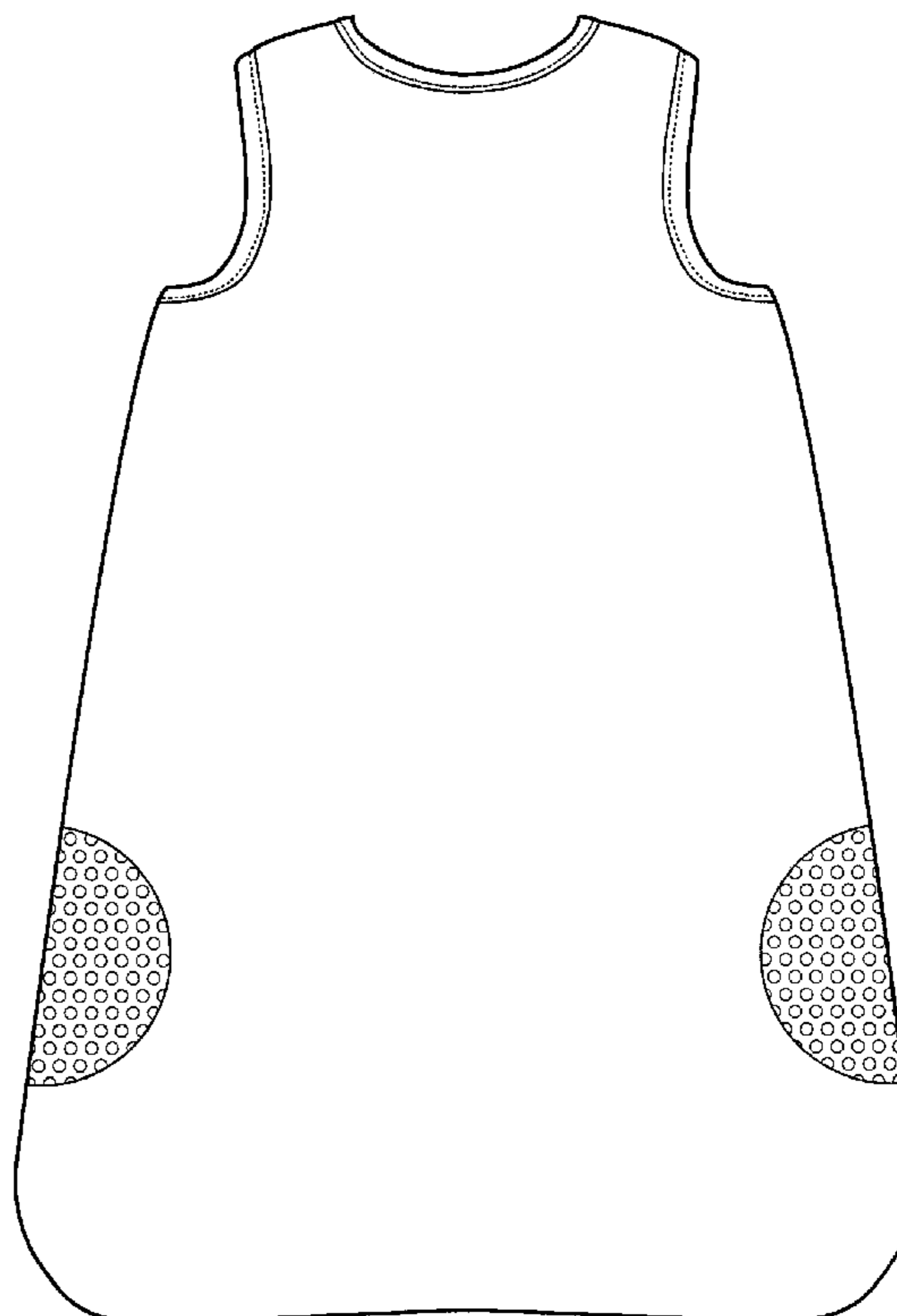
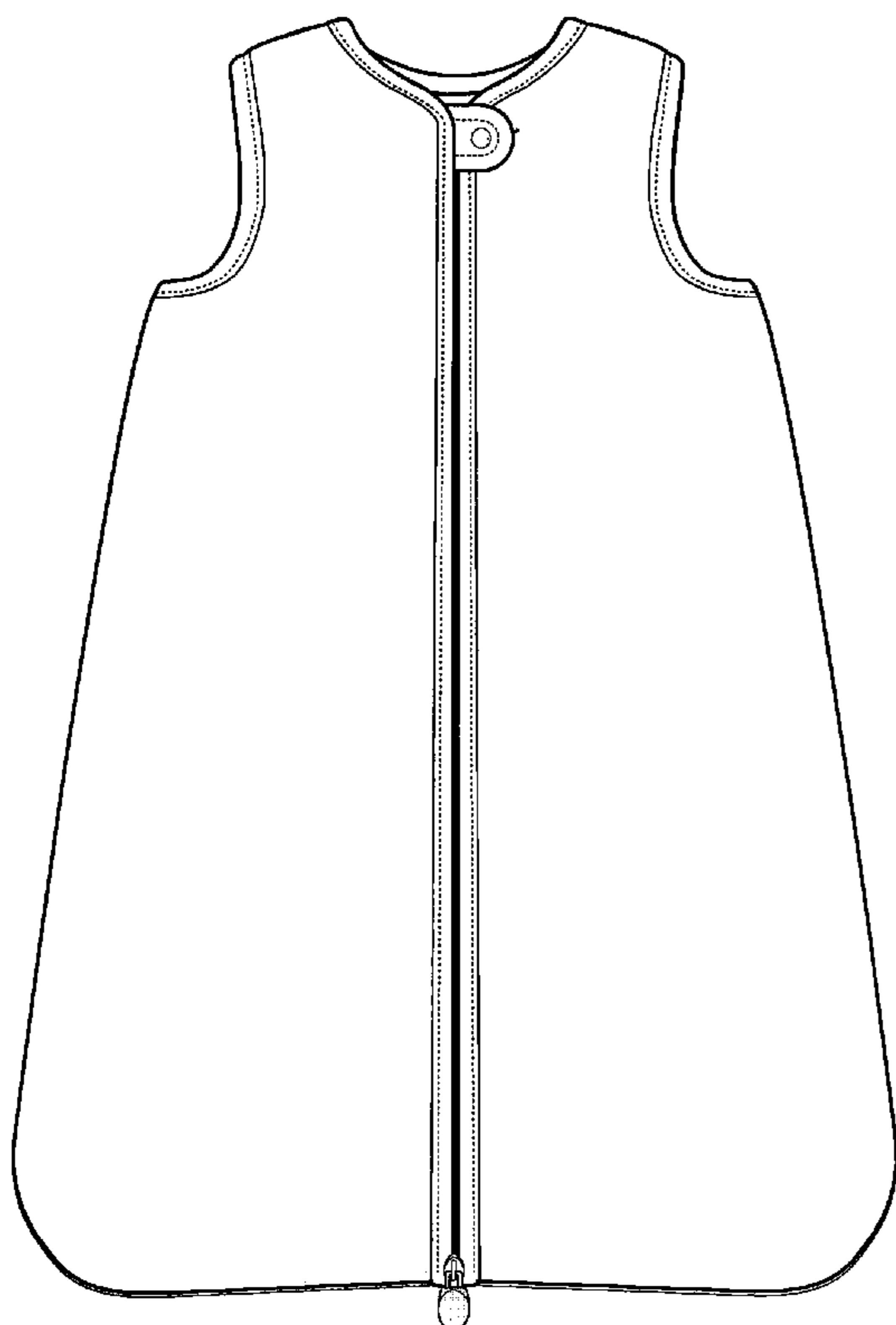

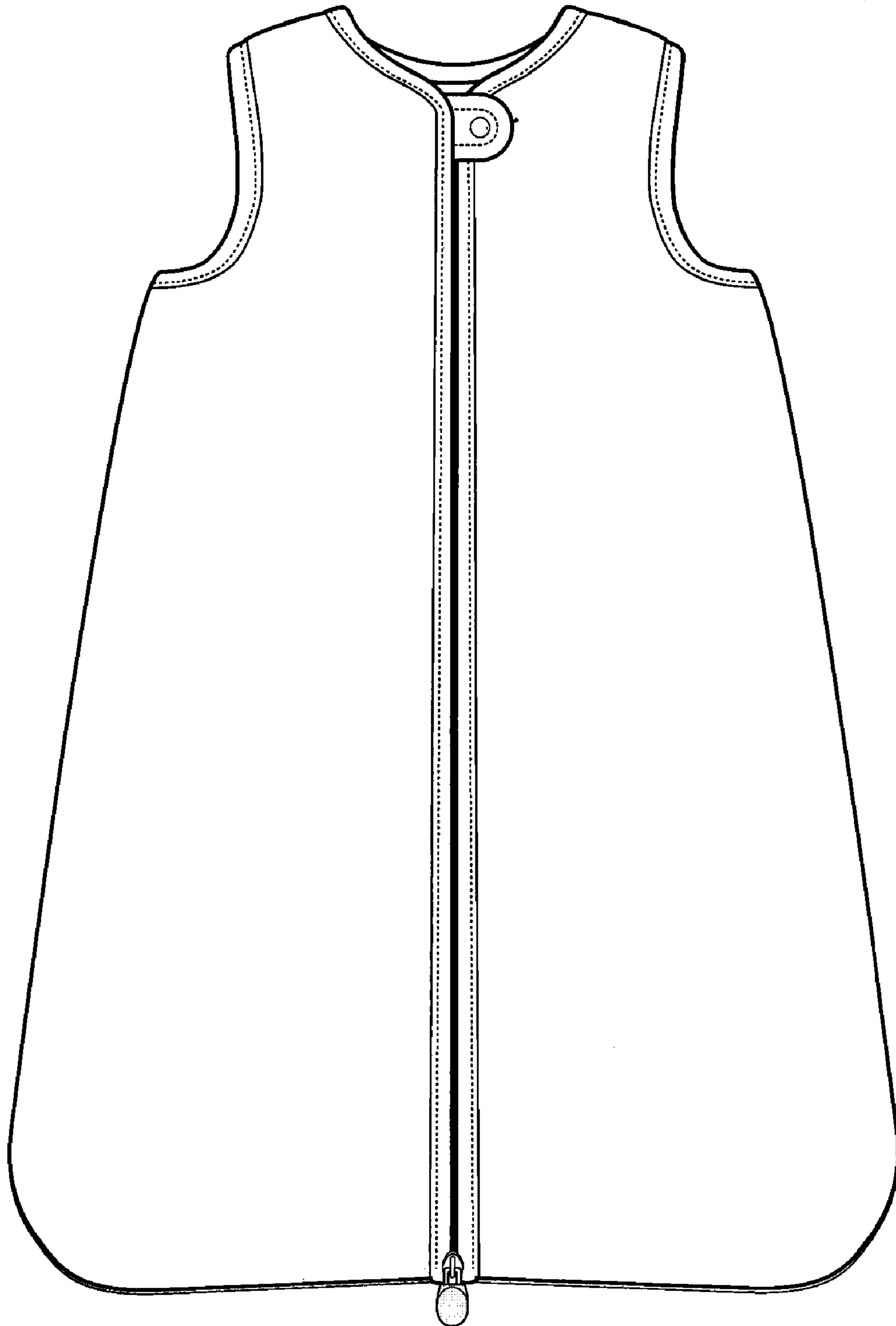

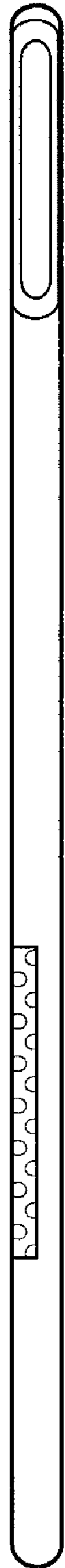

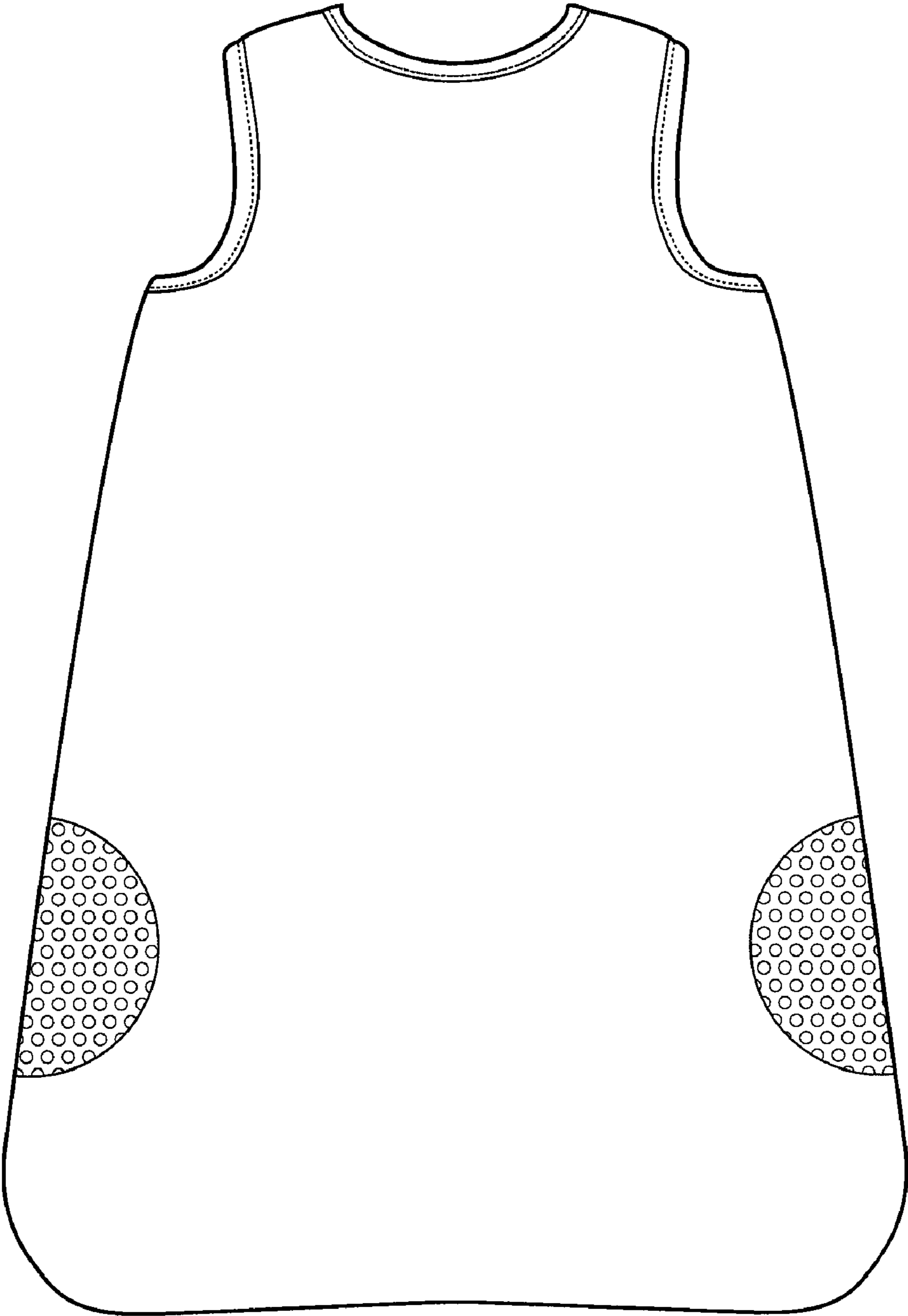
