The ornamental design for a legging, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a legging shown in an environment;

FIG. 2 is a first side elevational view thereof;

FIG. 3 is an opposite side elevational view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof.

FIG. 6 is a top plan view thereof; and,

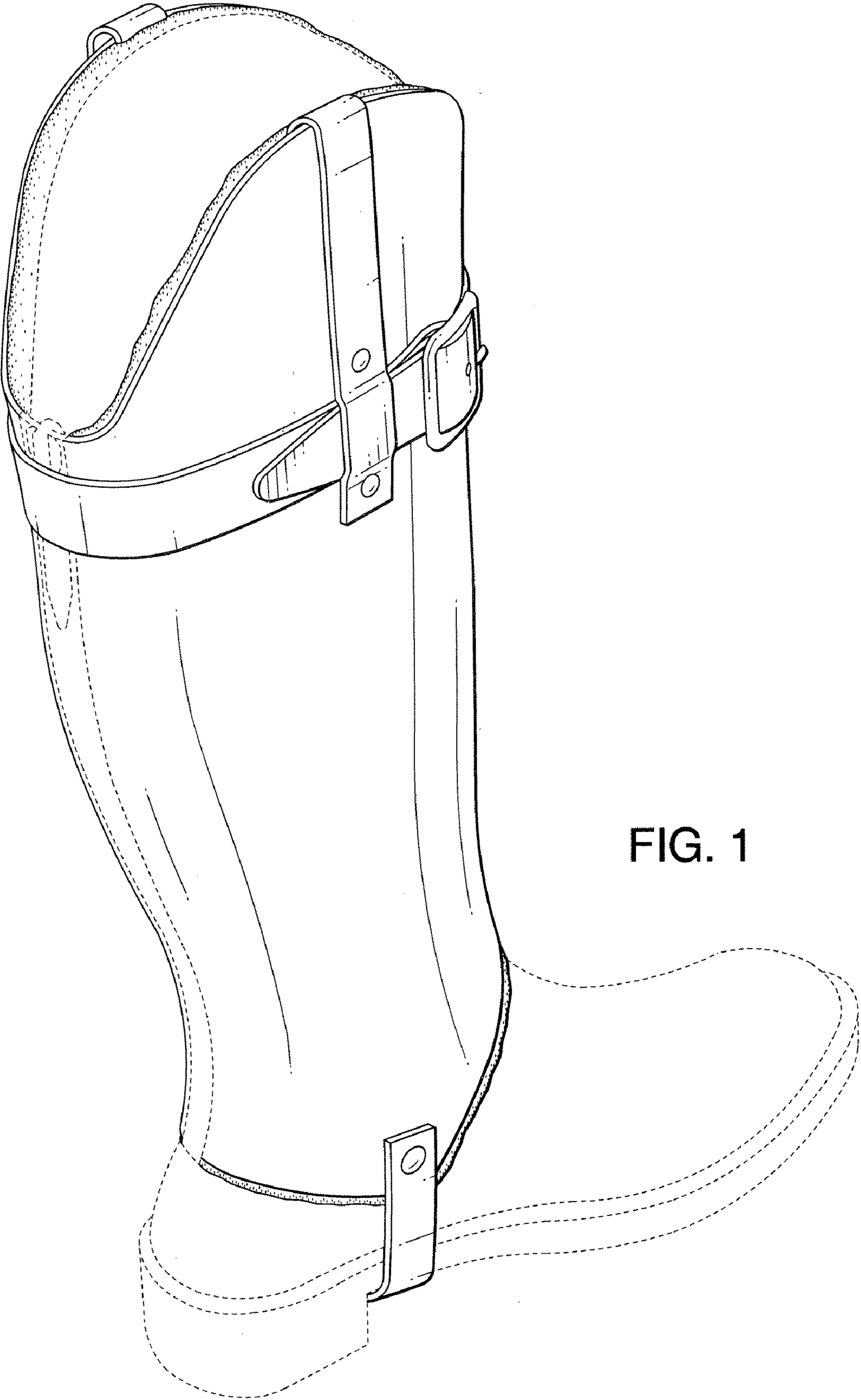

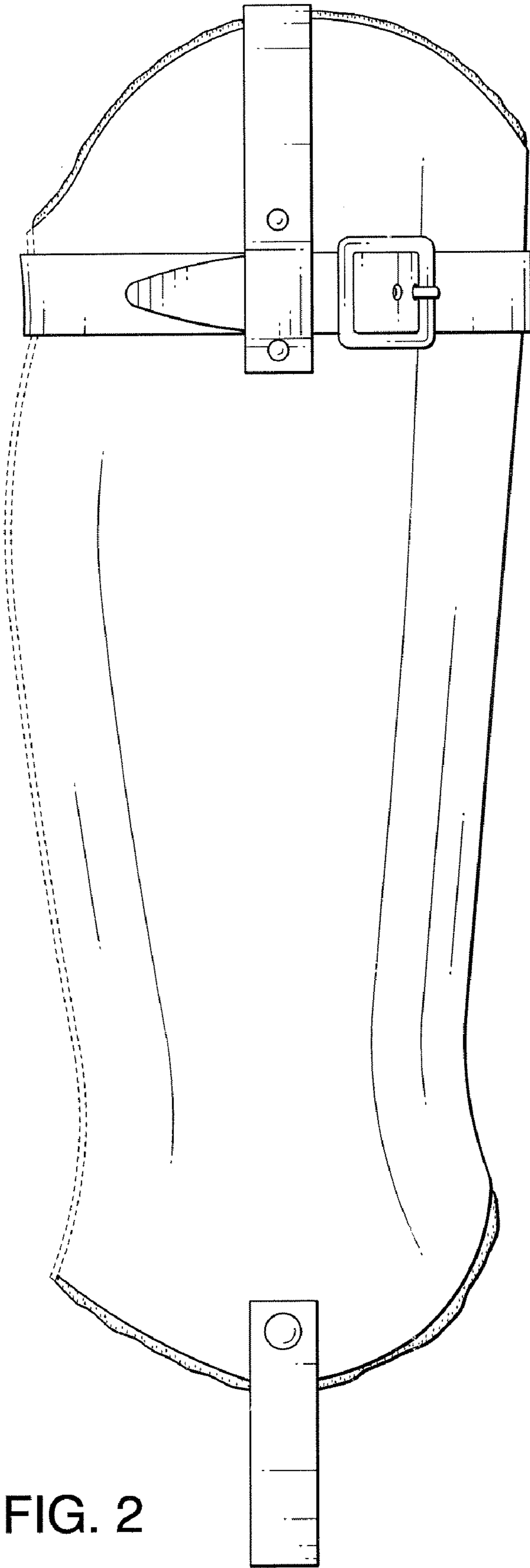

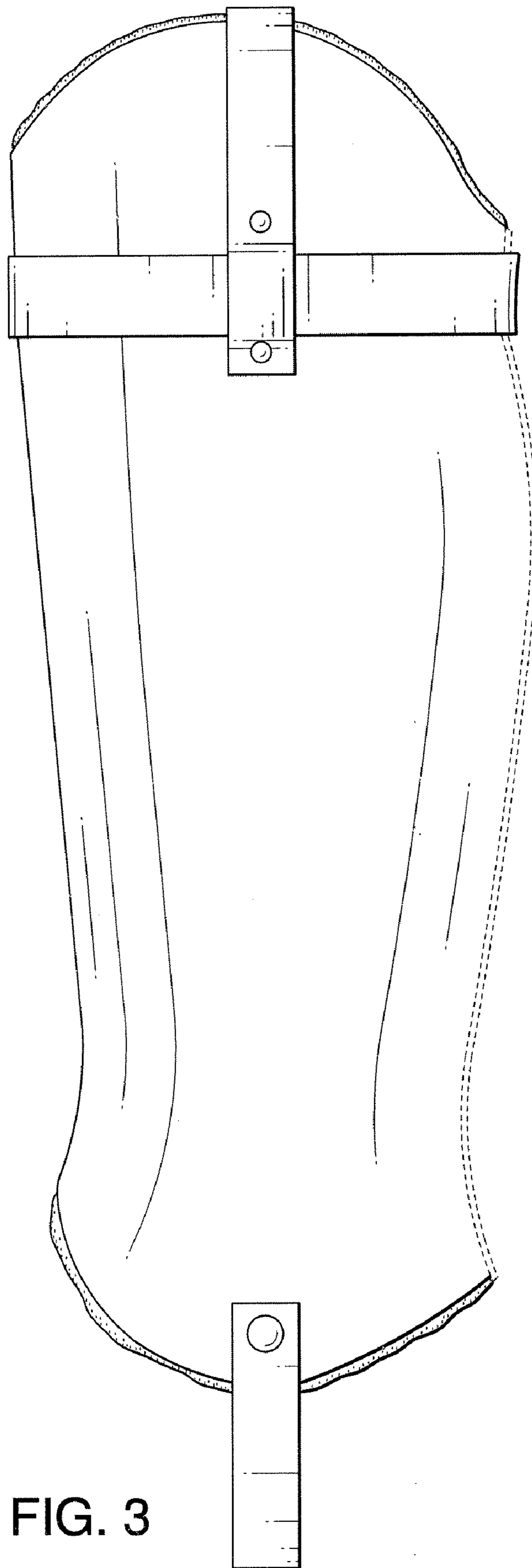

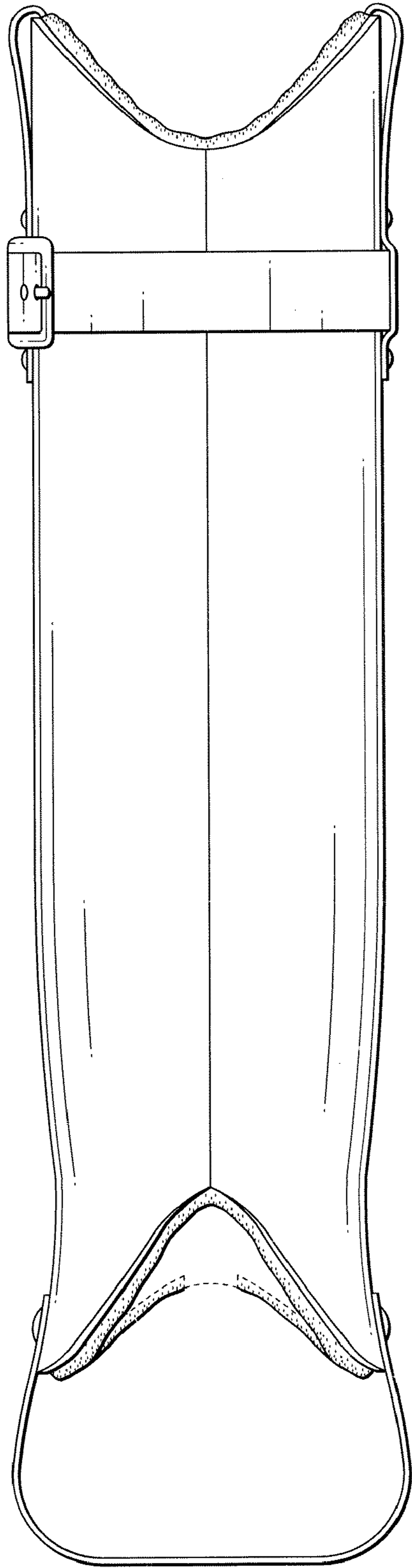

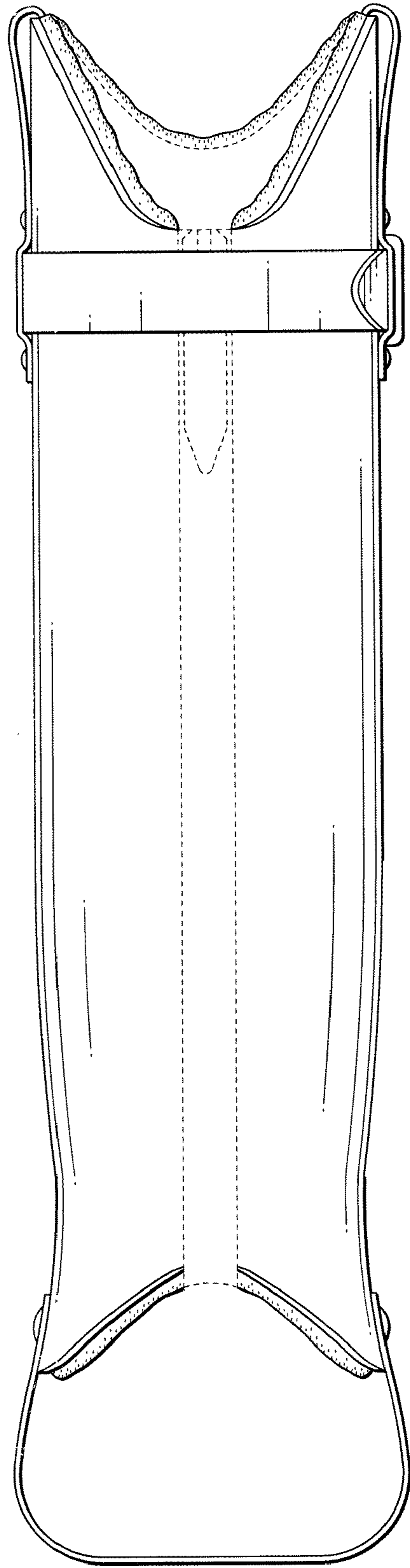

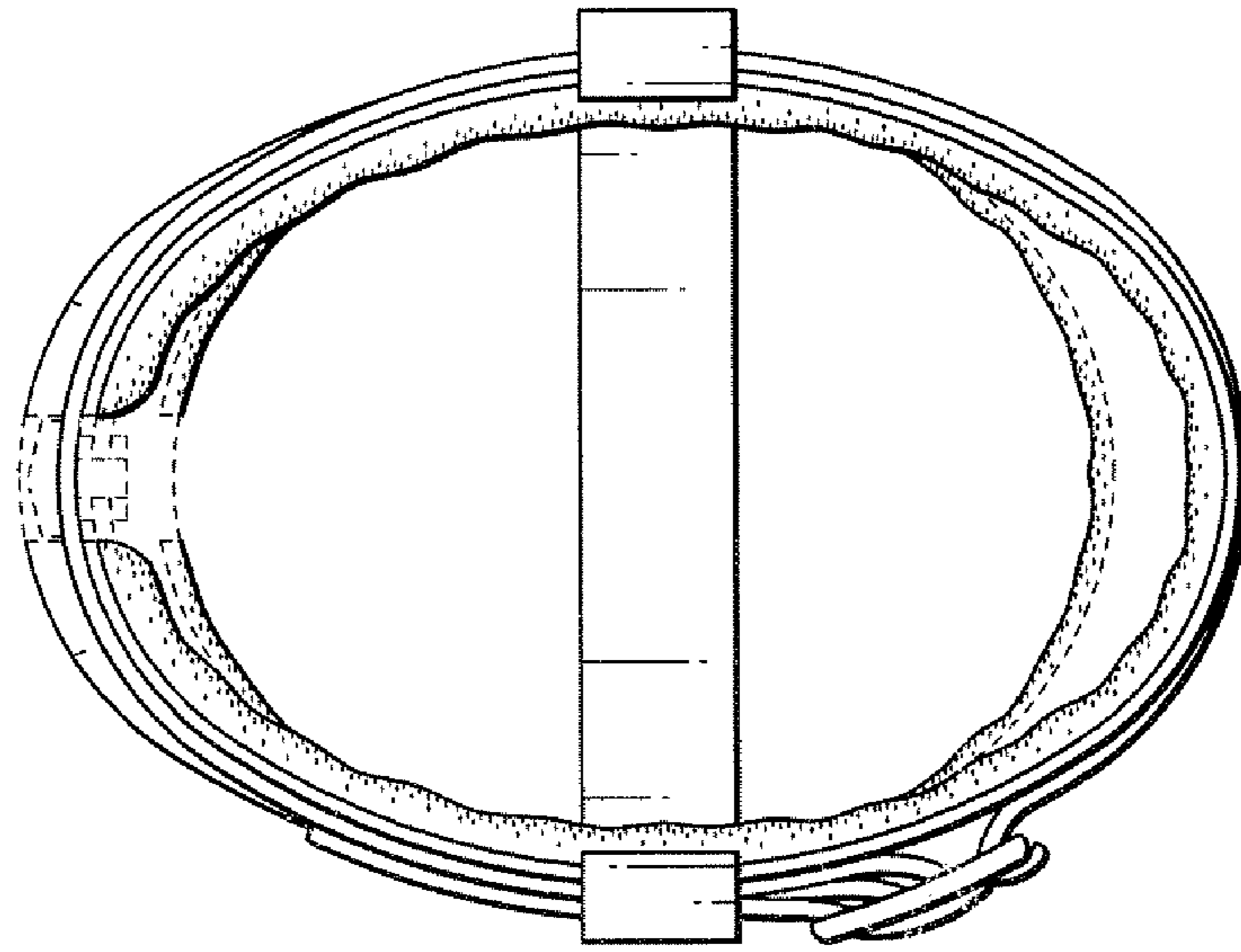

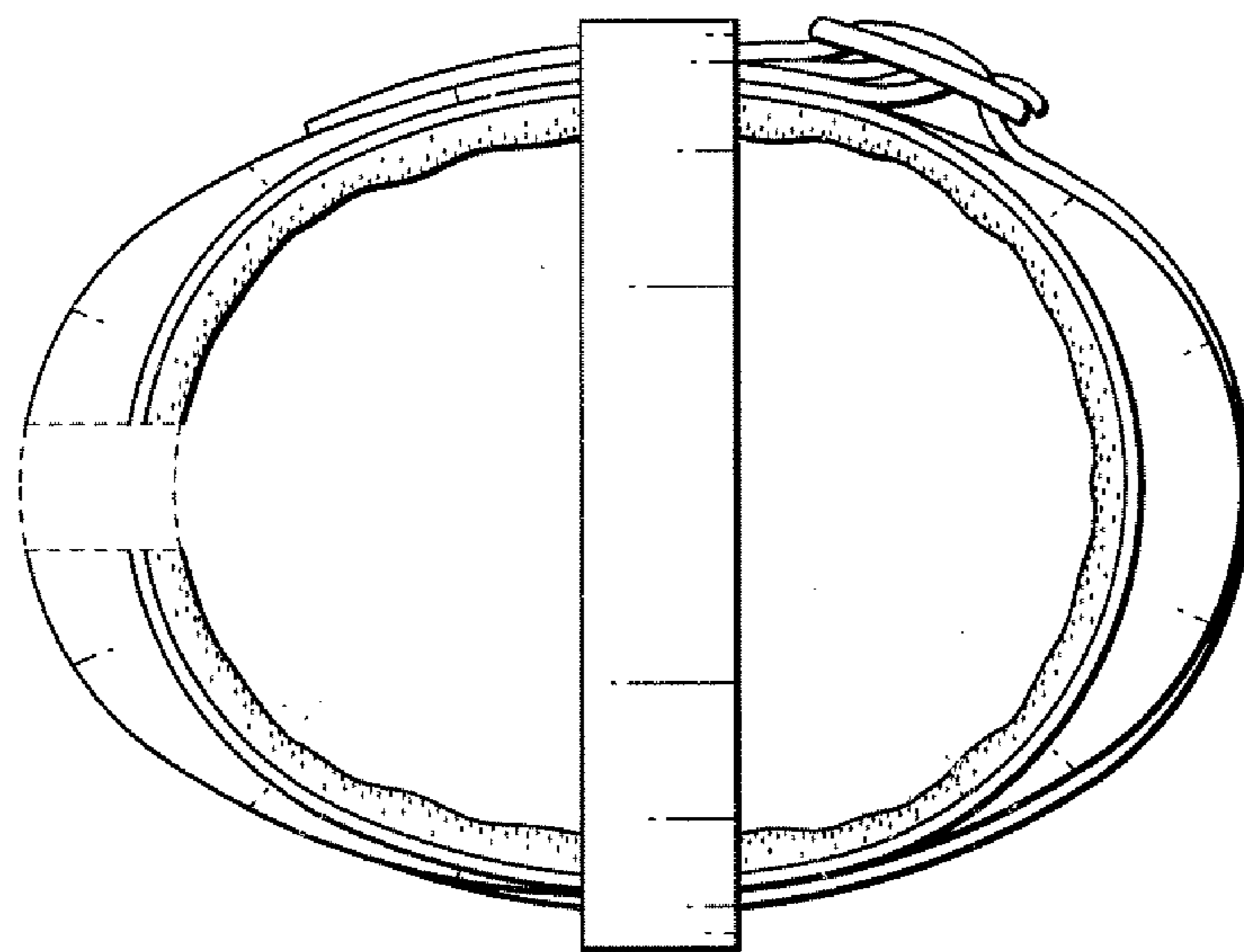
