(57) **CLAIM**

I claim an ornamental design for a sandal with separable parts, as shown and described.

DESCRIPTION

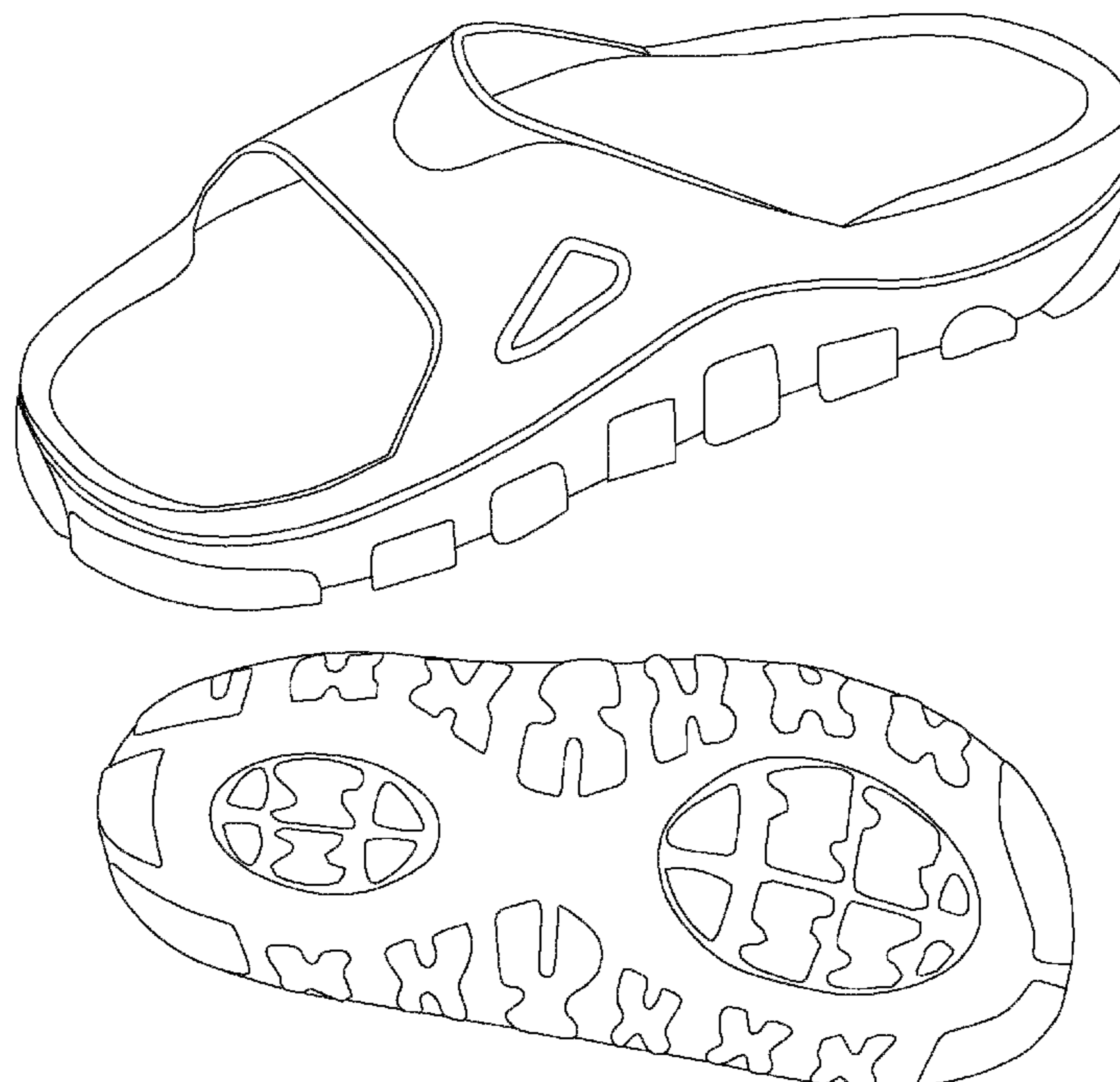

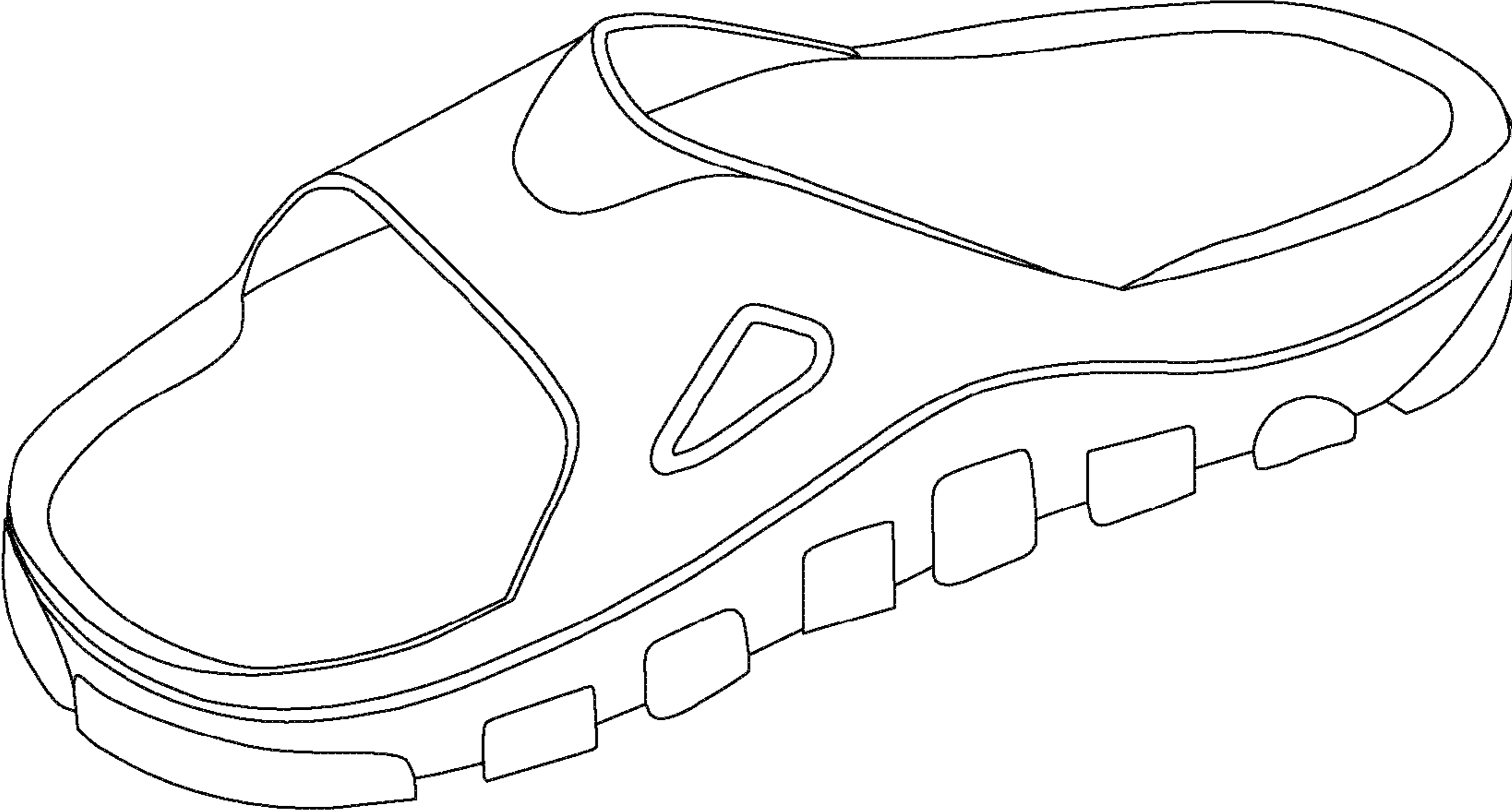

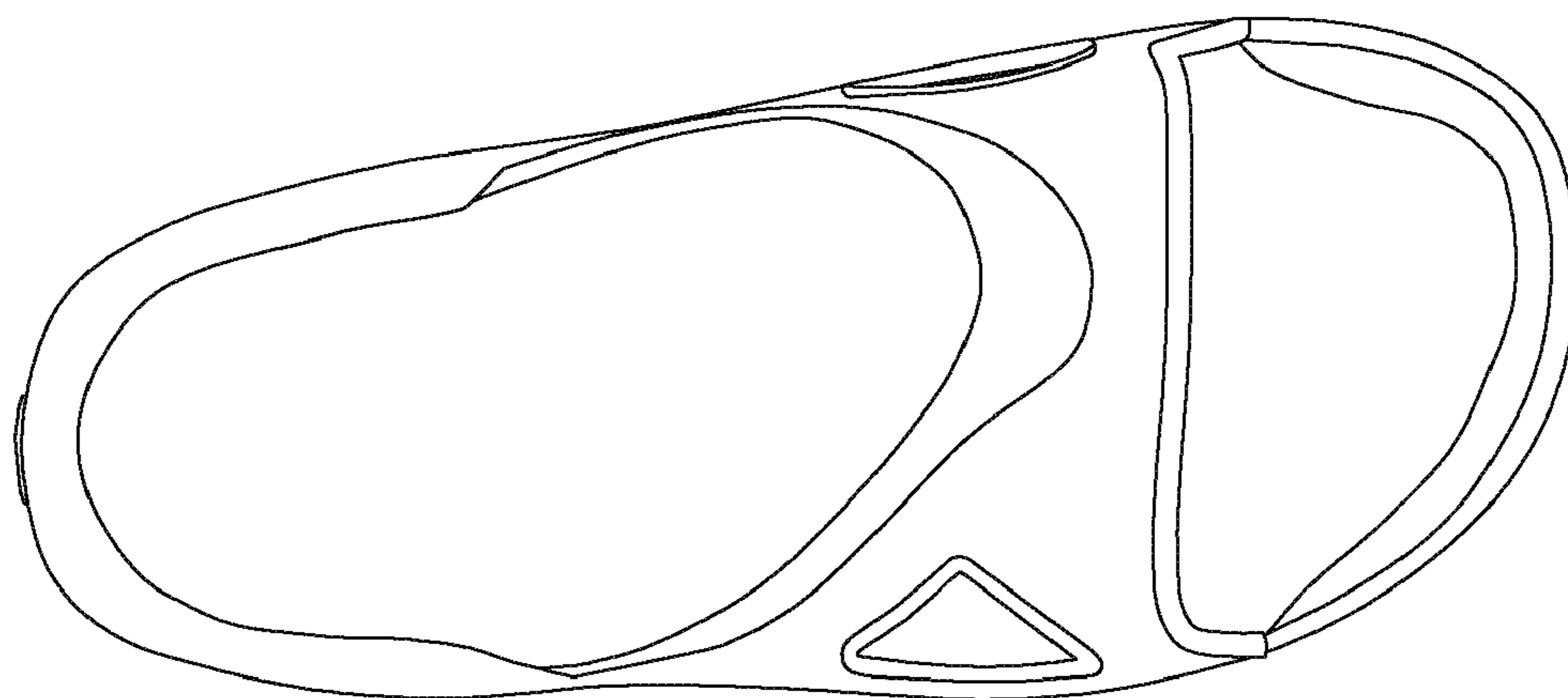
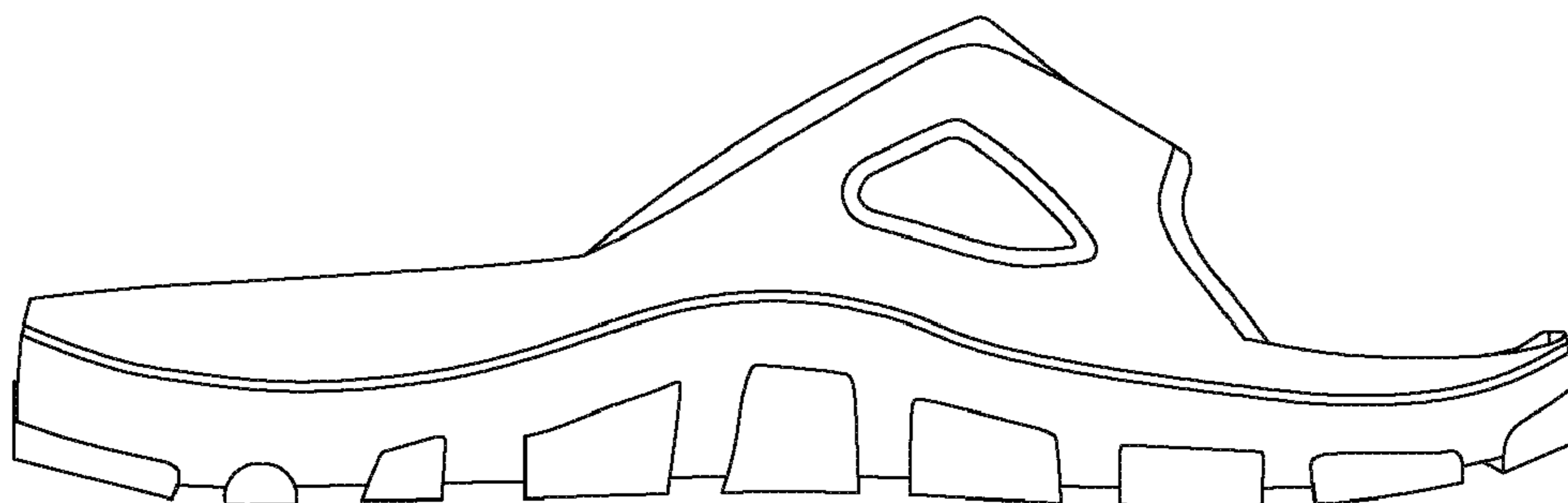

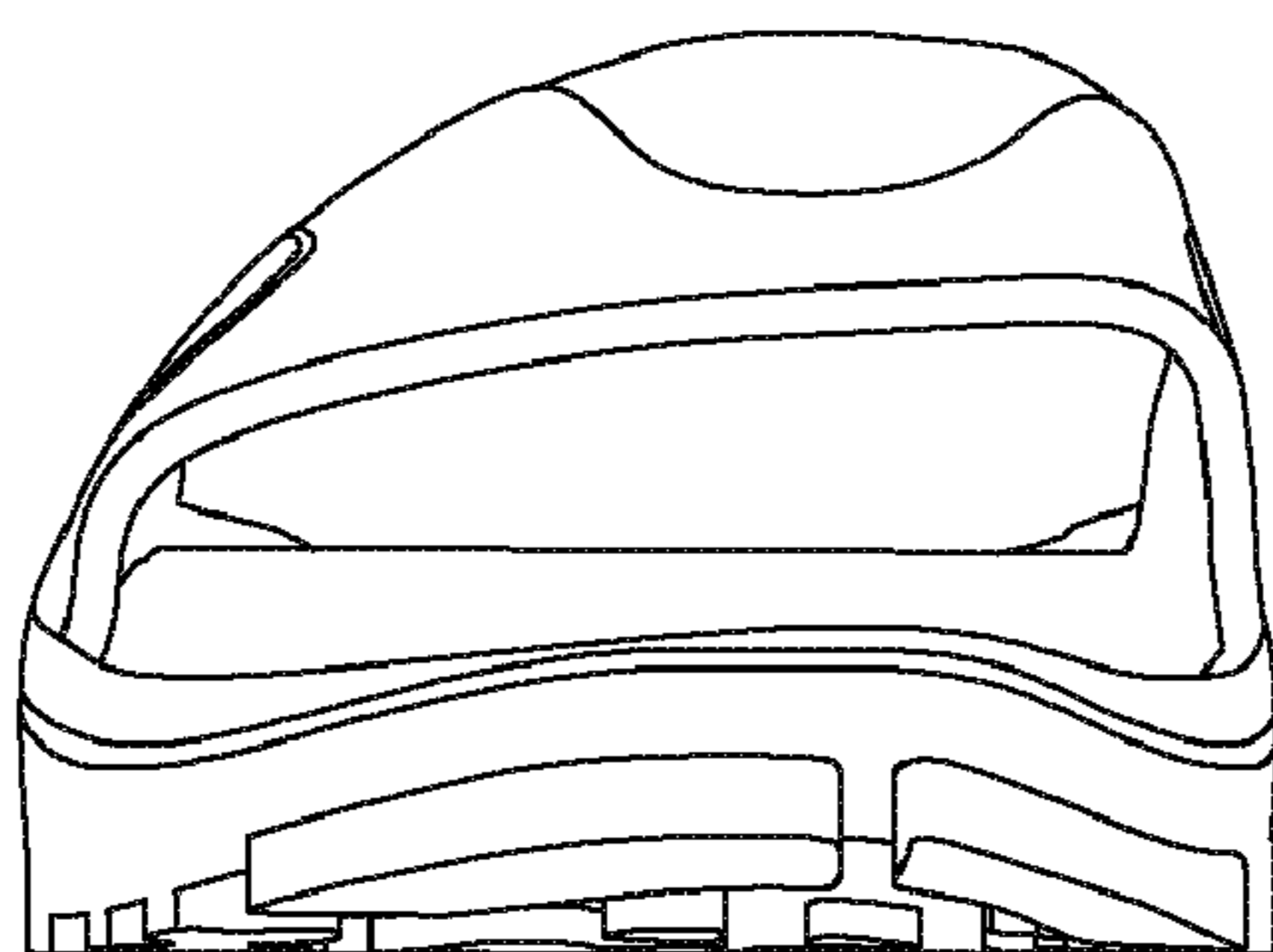

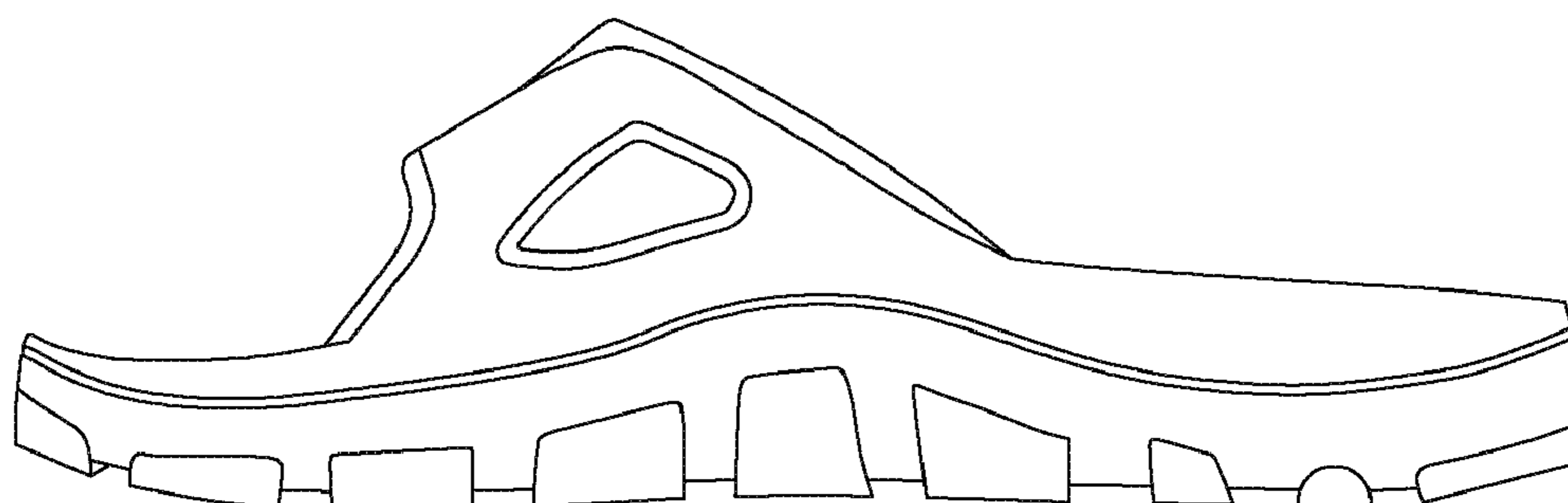

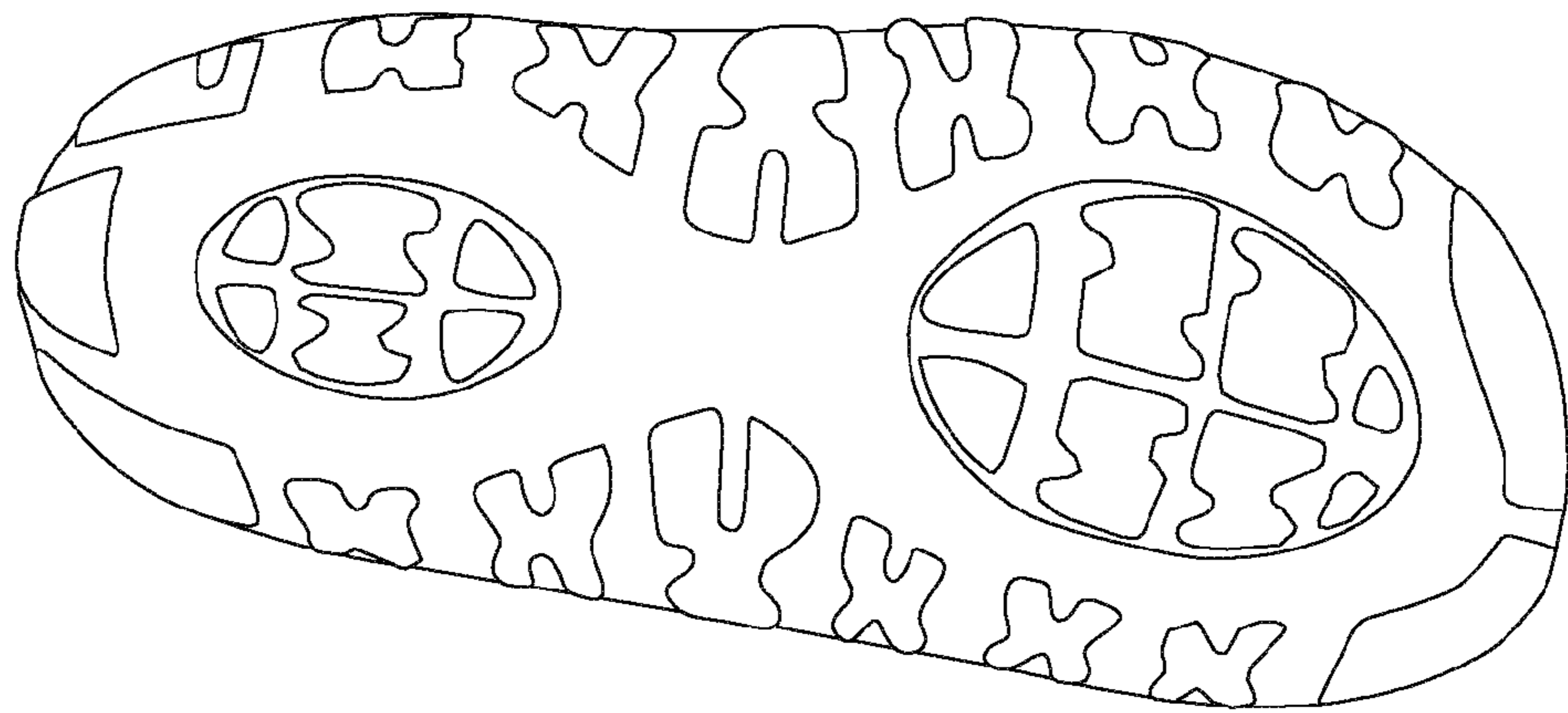

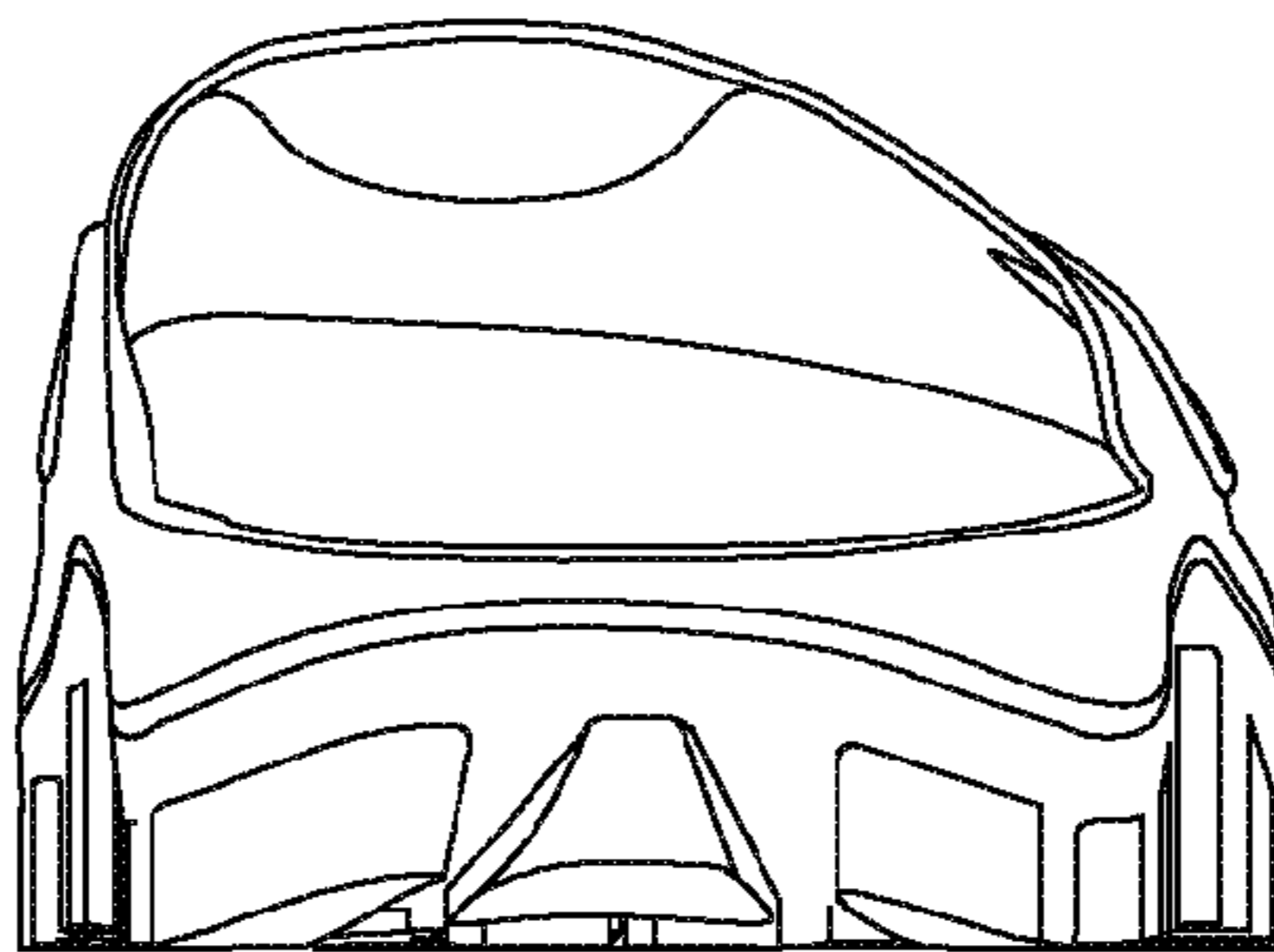

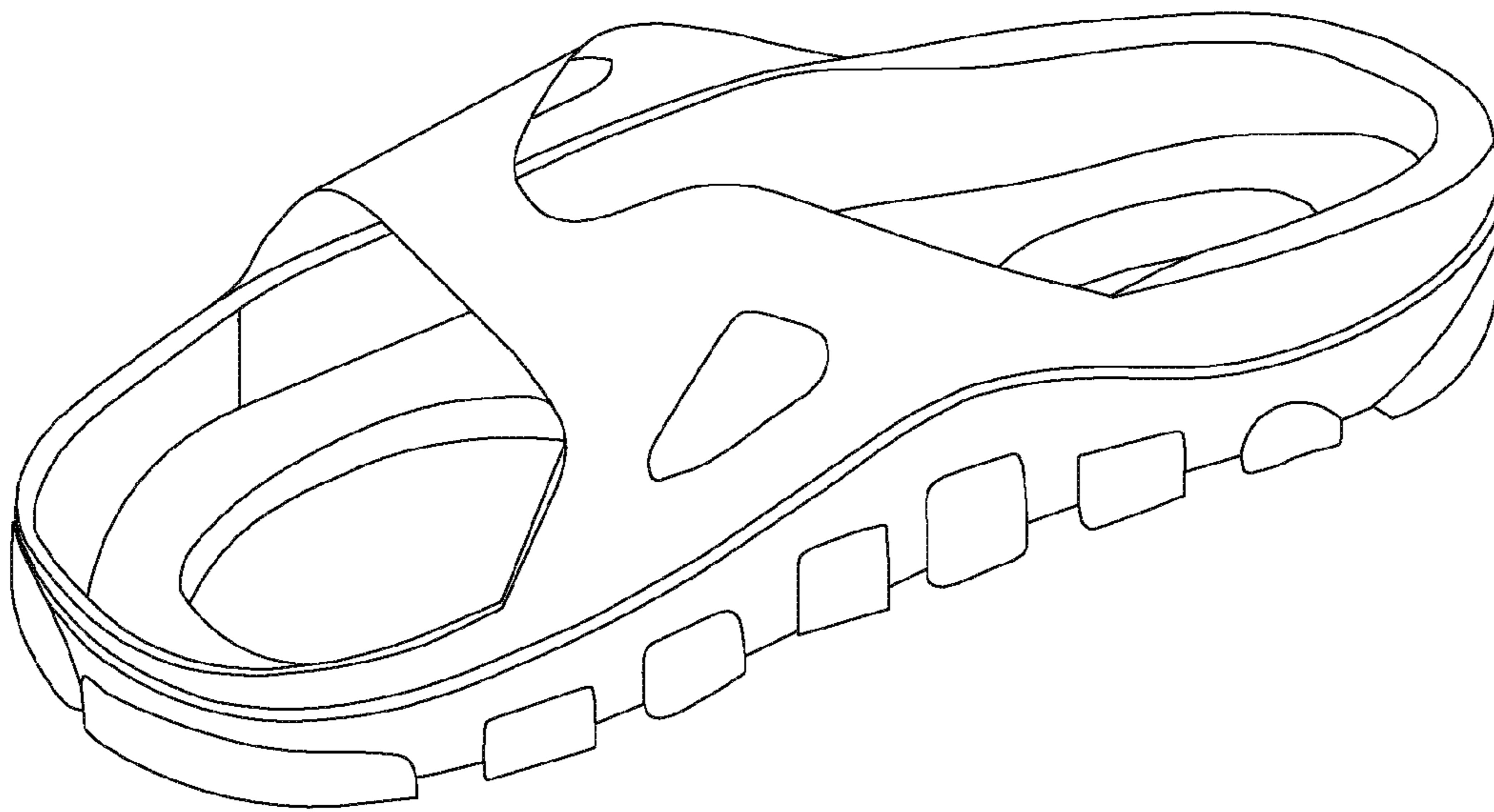

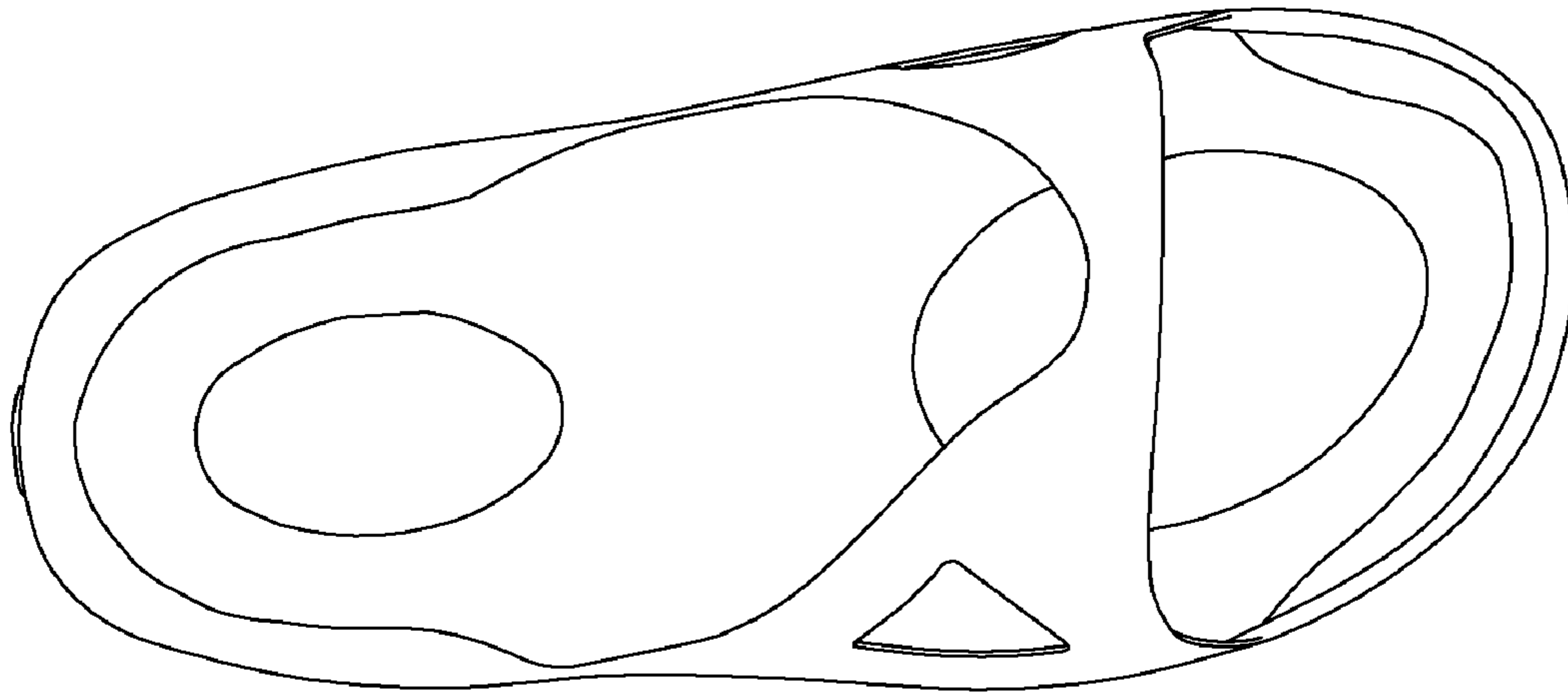
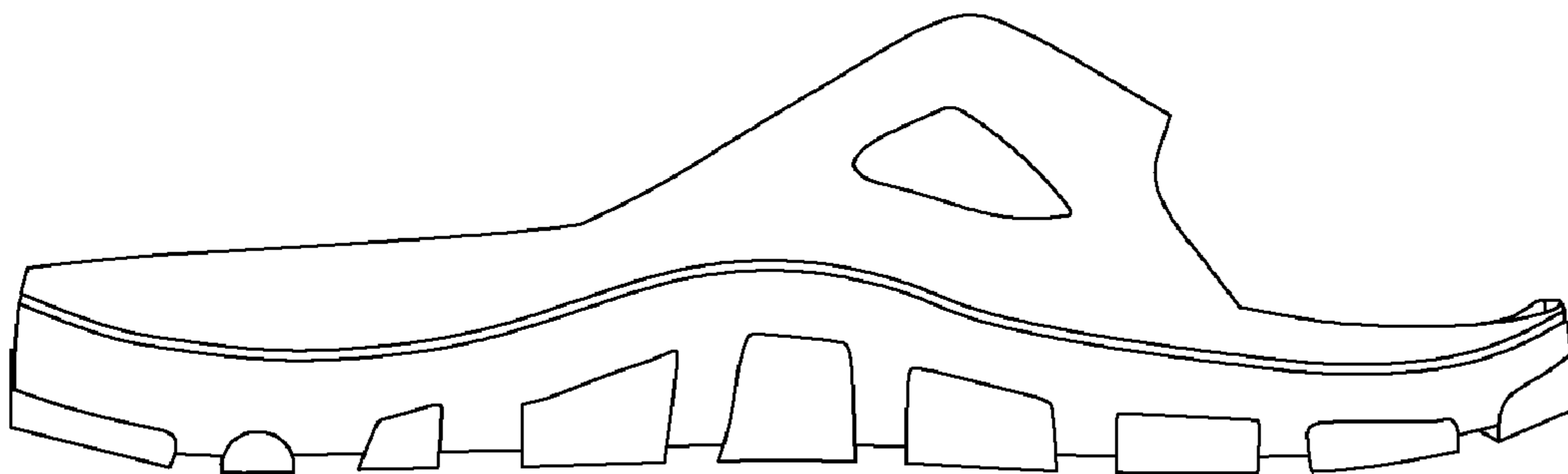

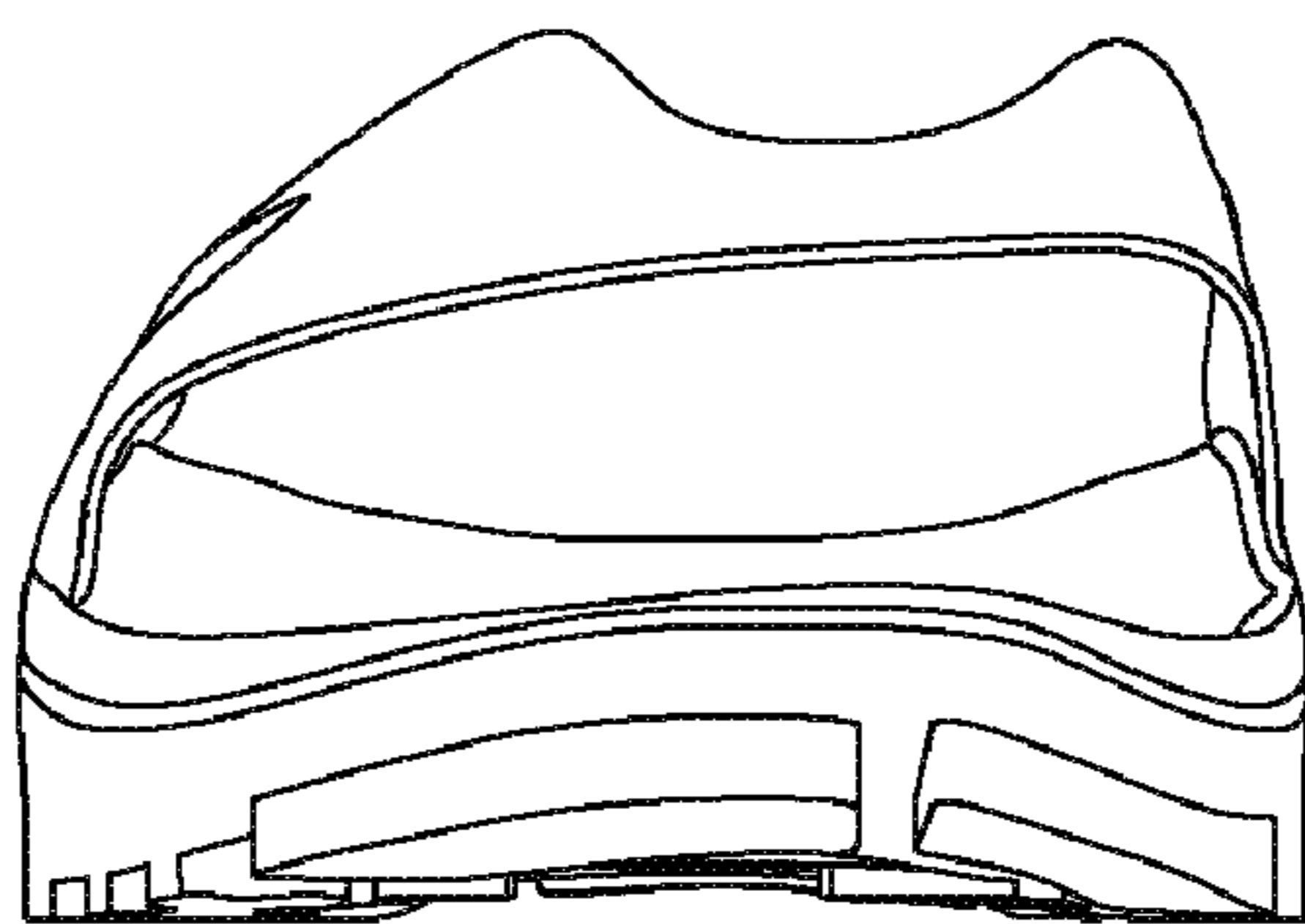

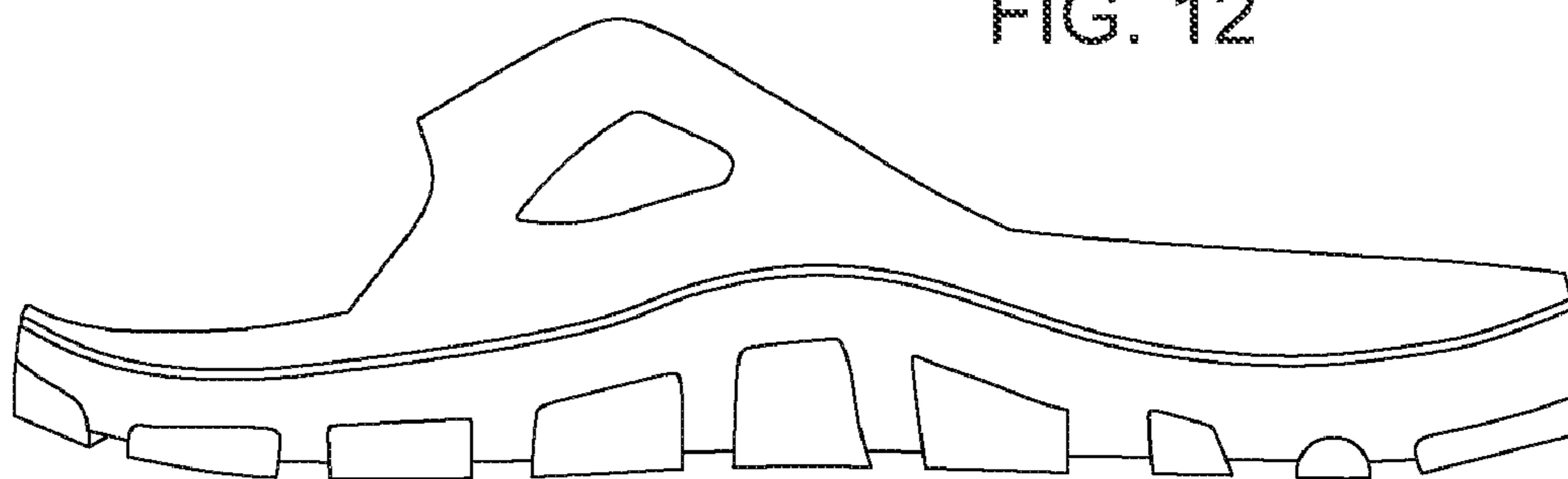

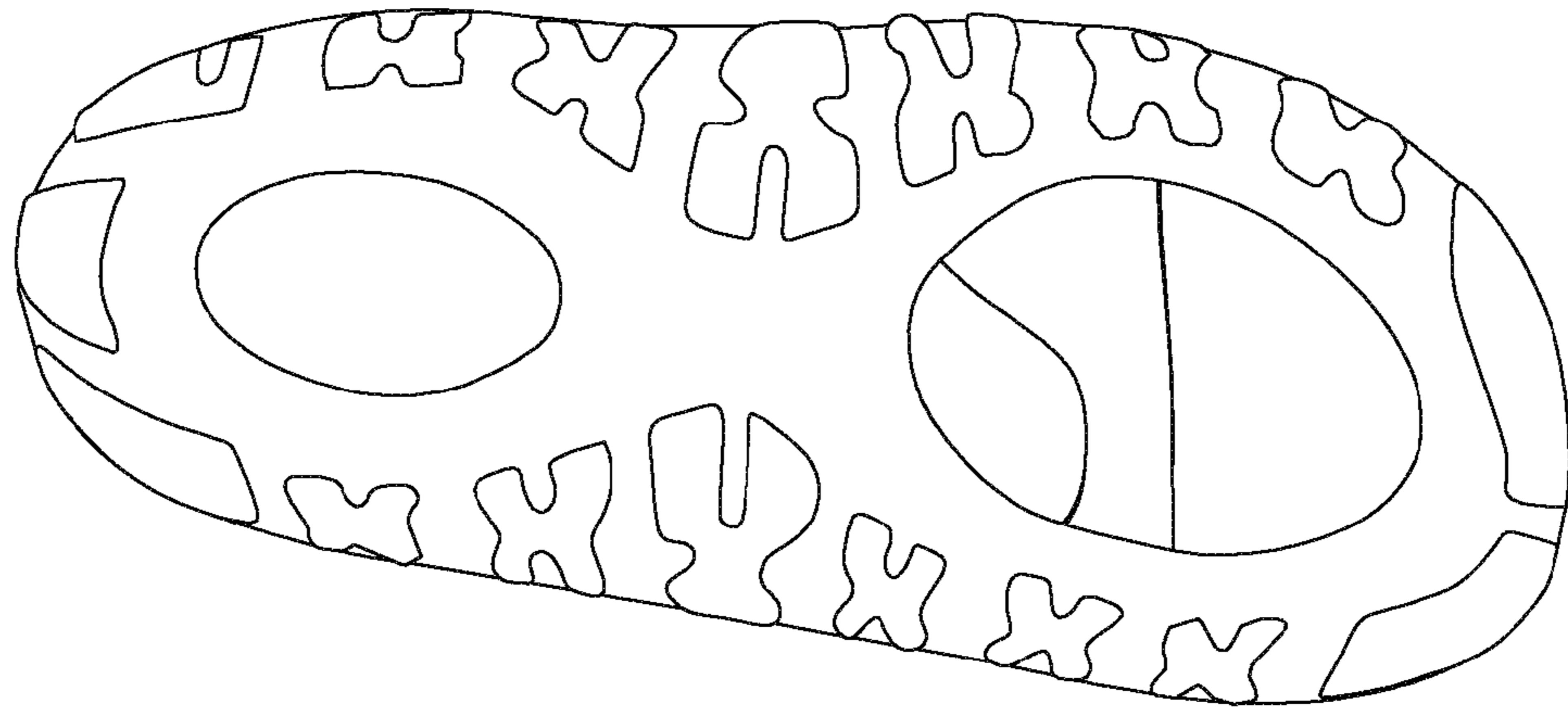

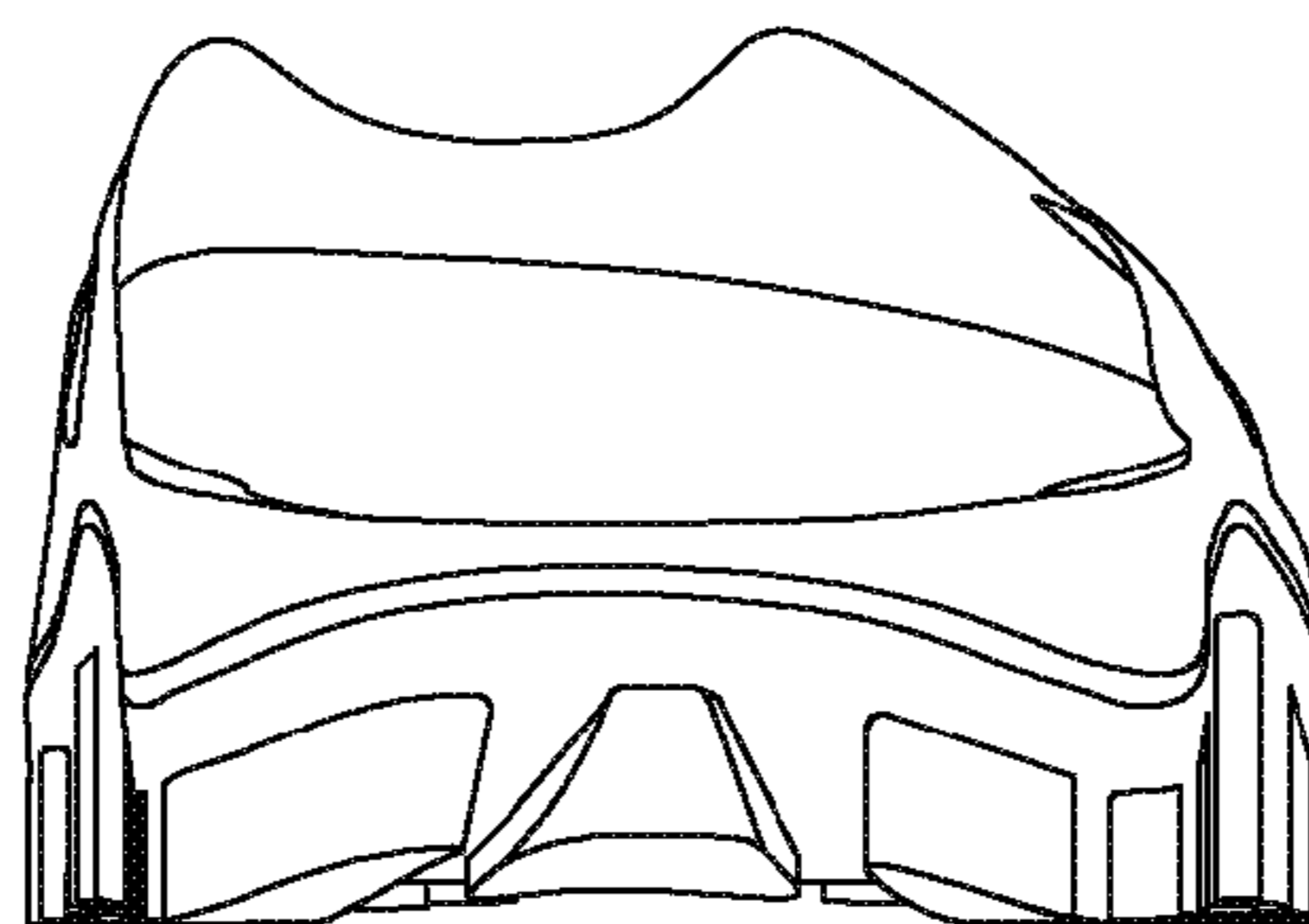

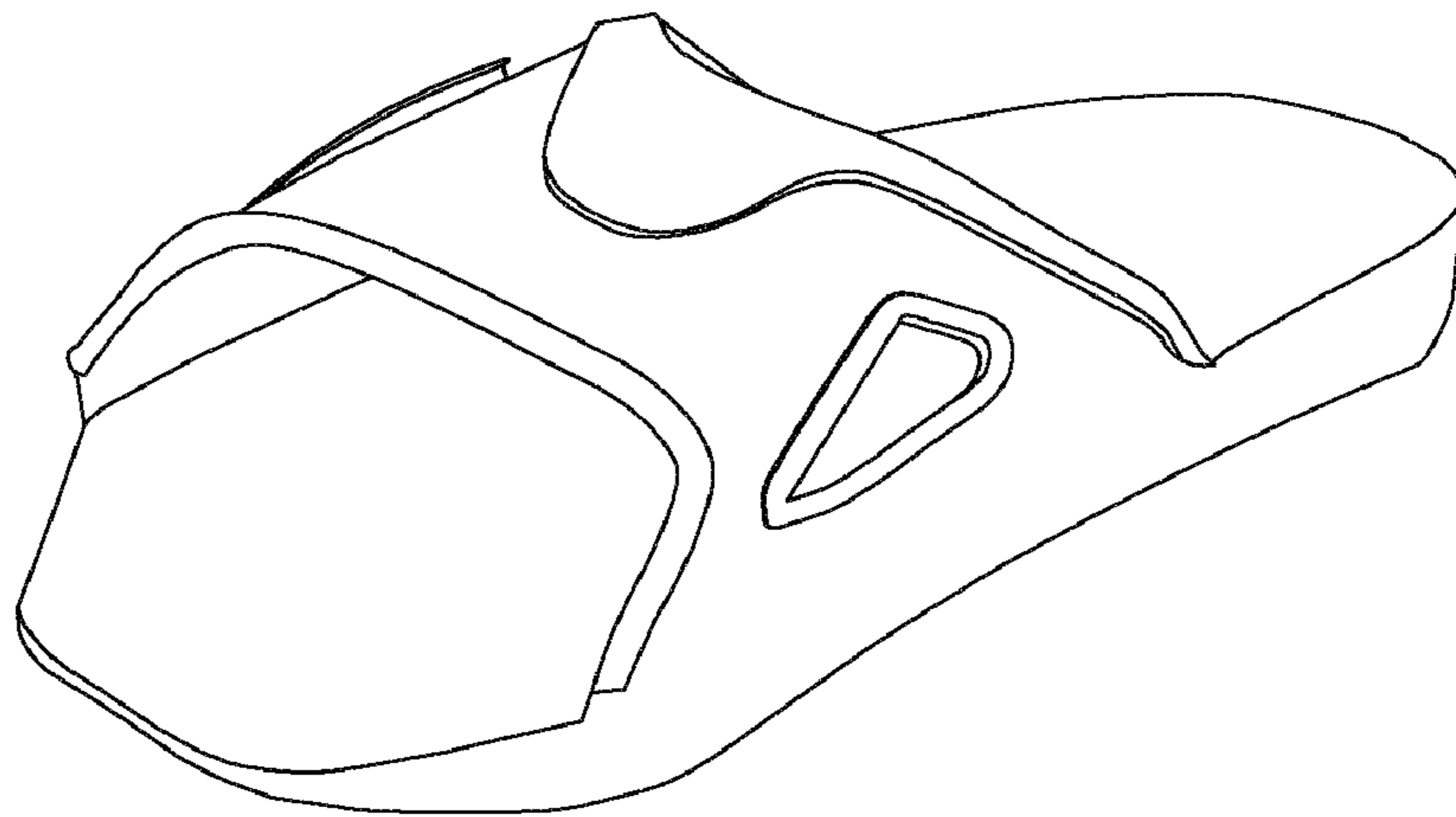

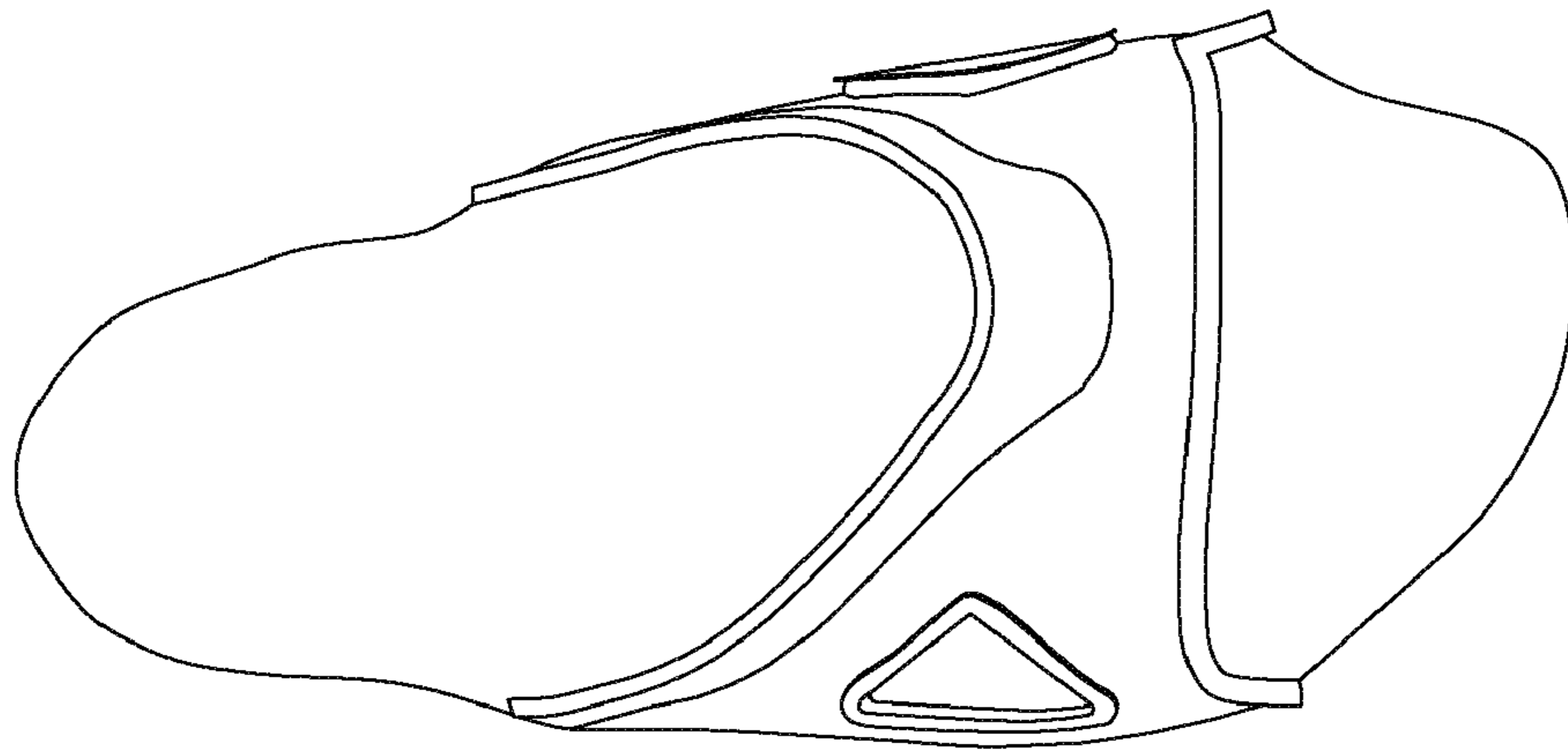
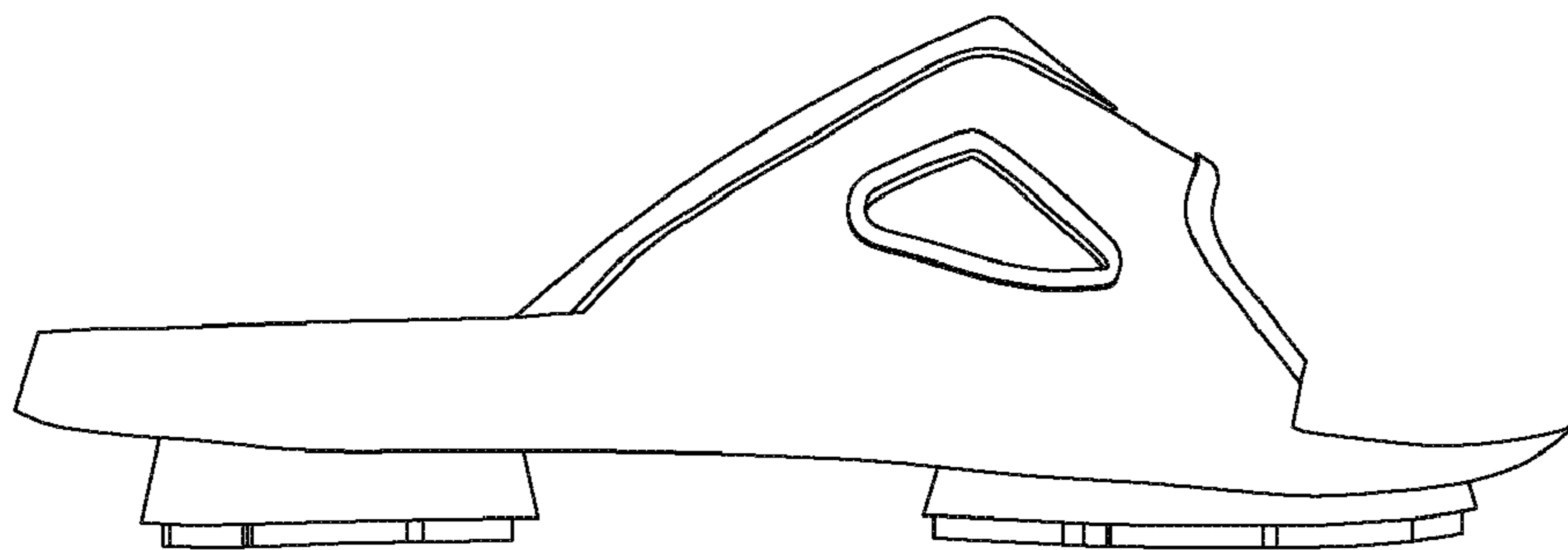

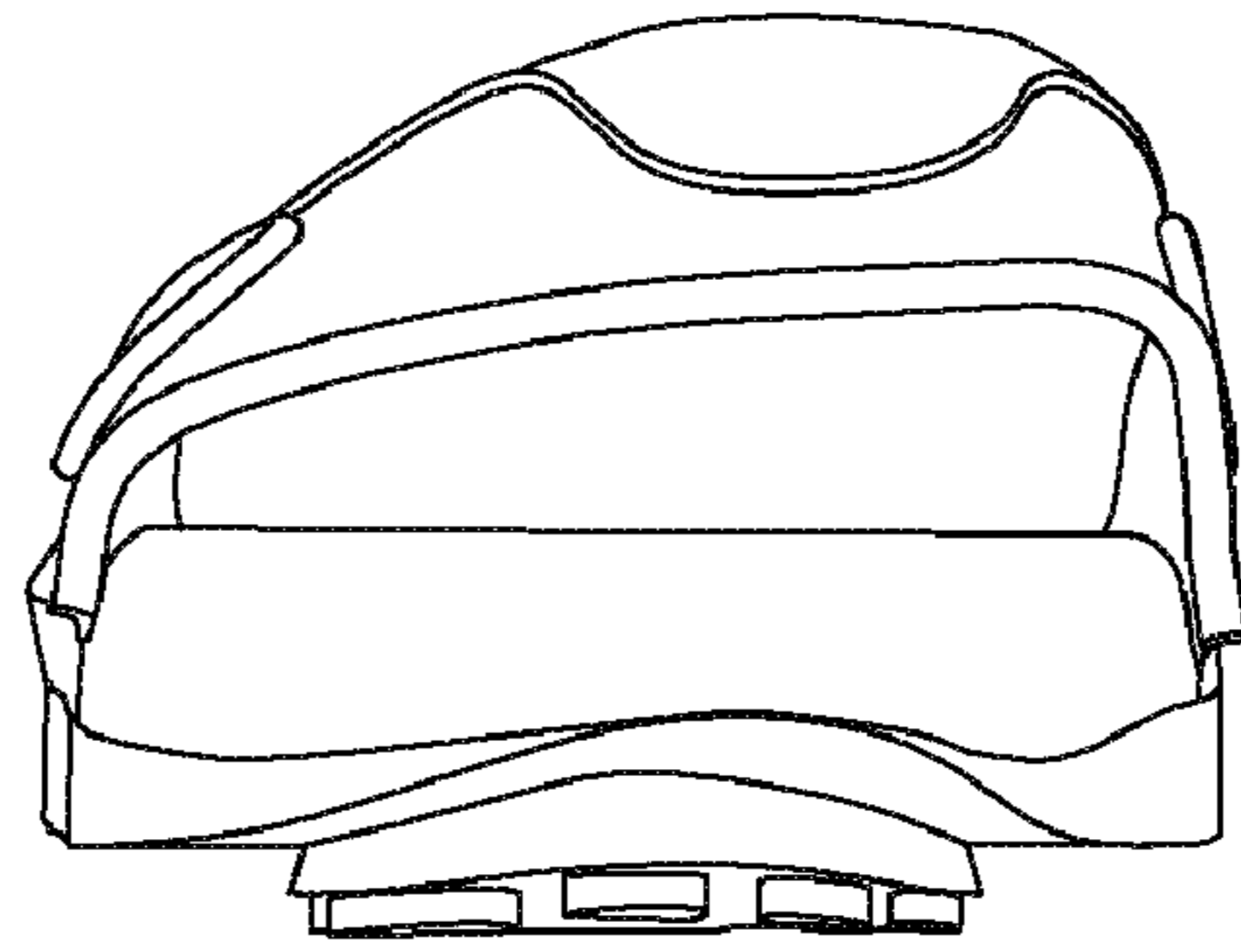

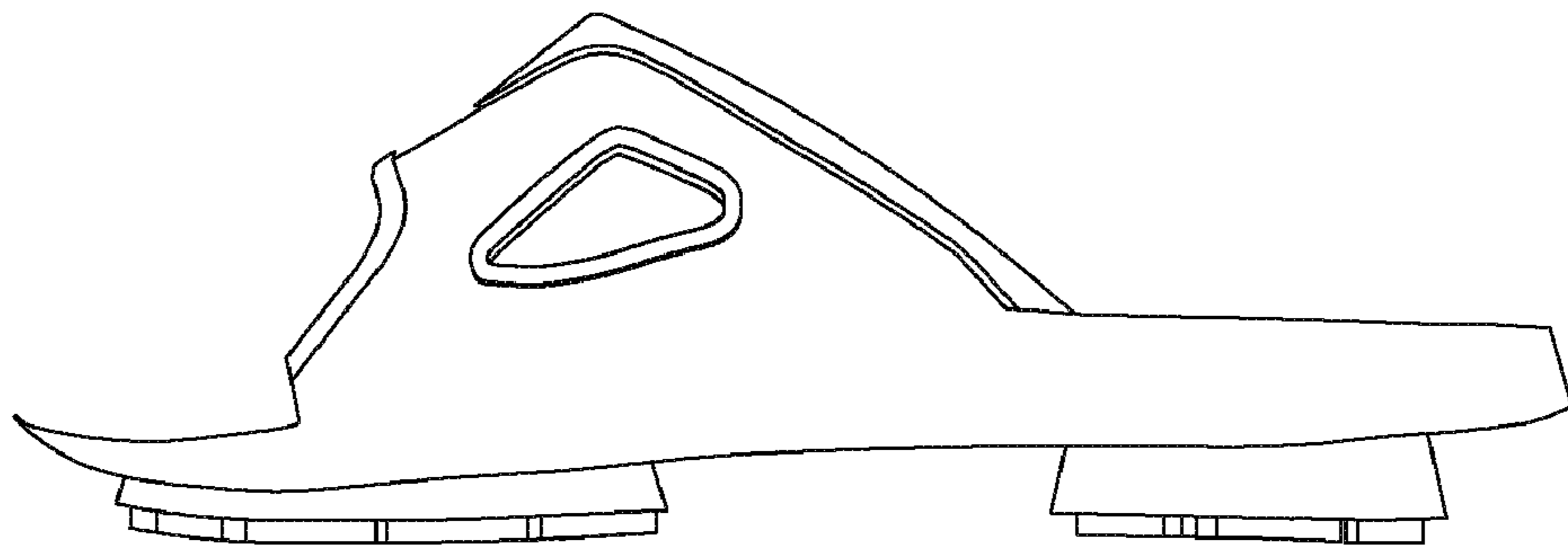

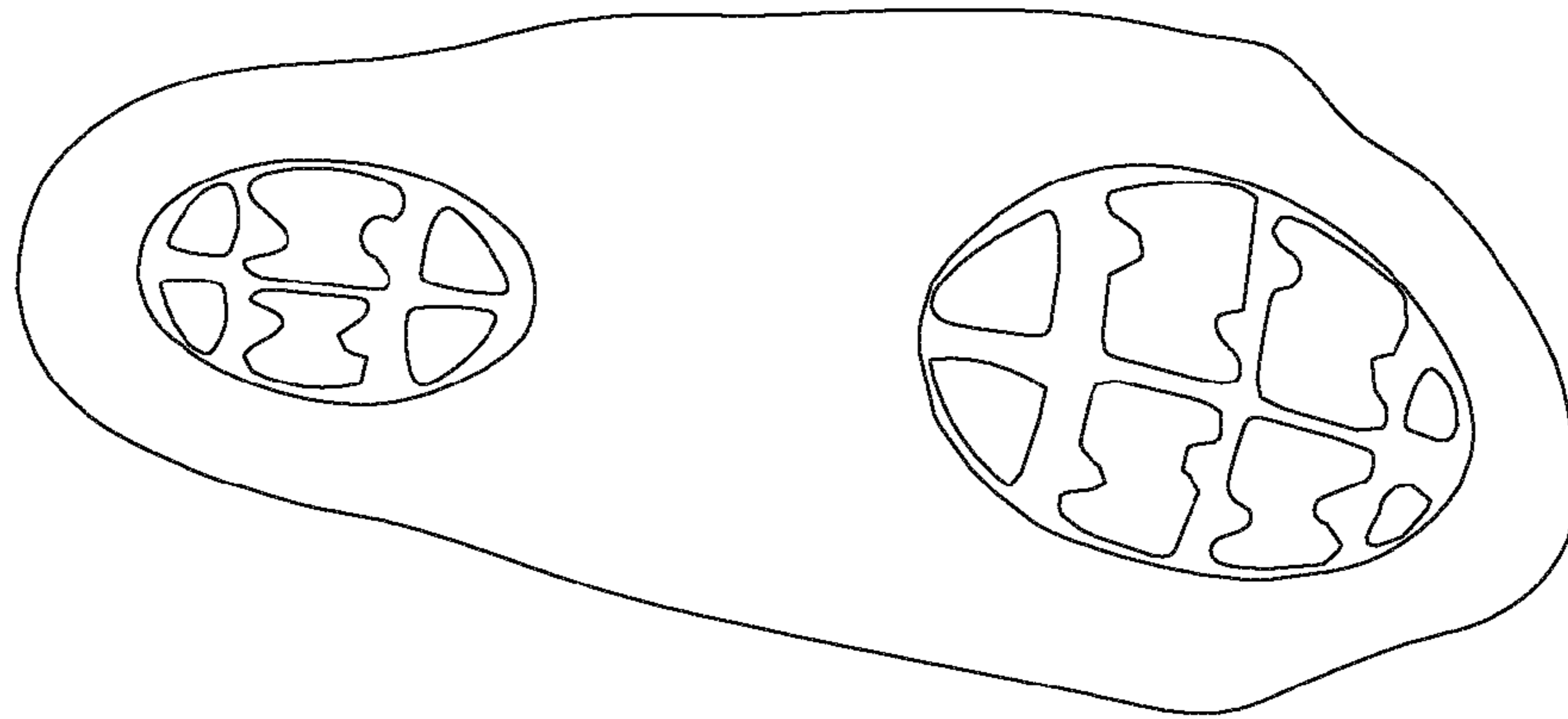
