**DESCRIPTION**

FIG. 1 is a perspective view of a periphery of an outsole embodying my new design.

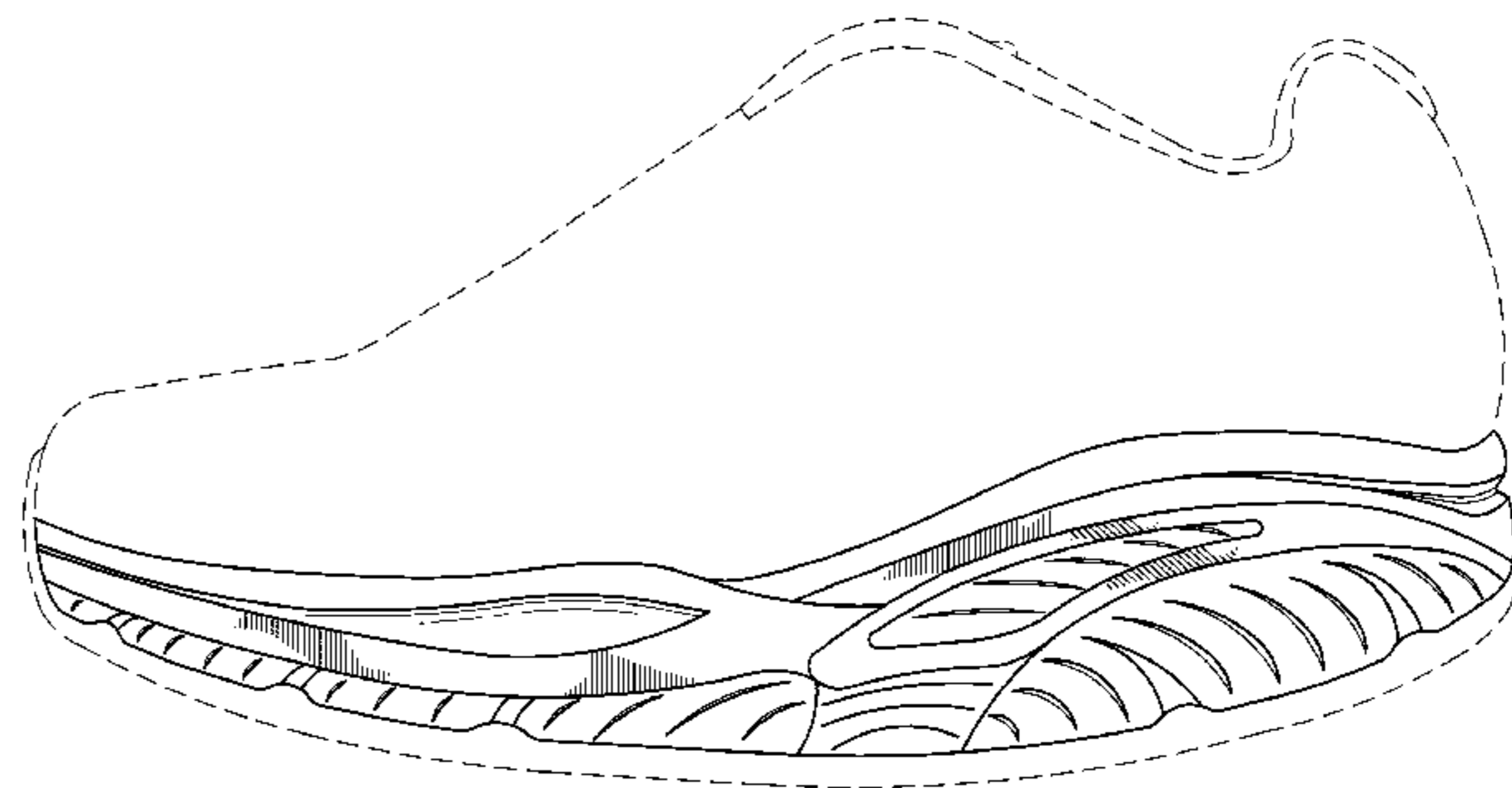
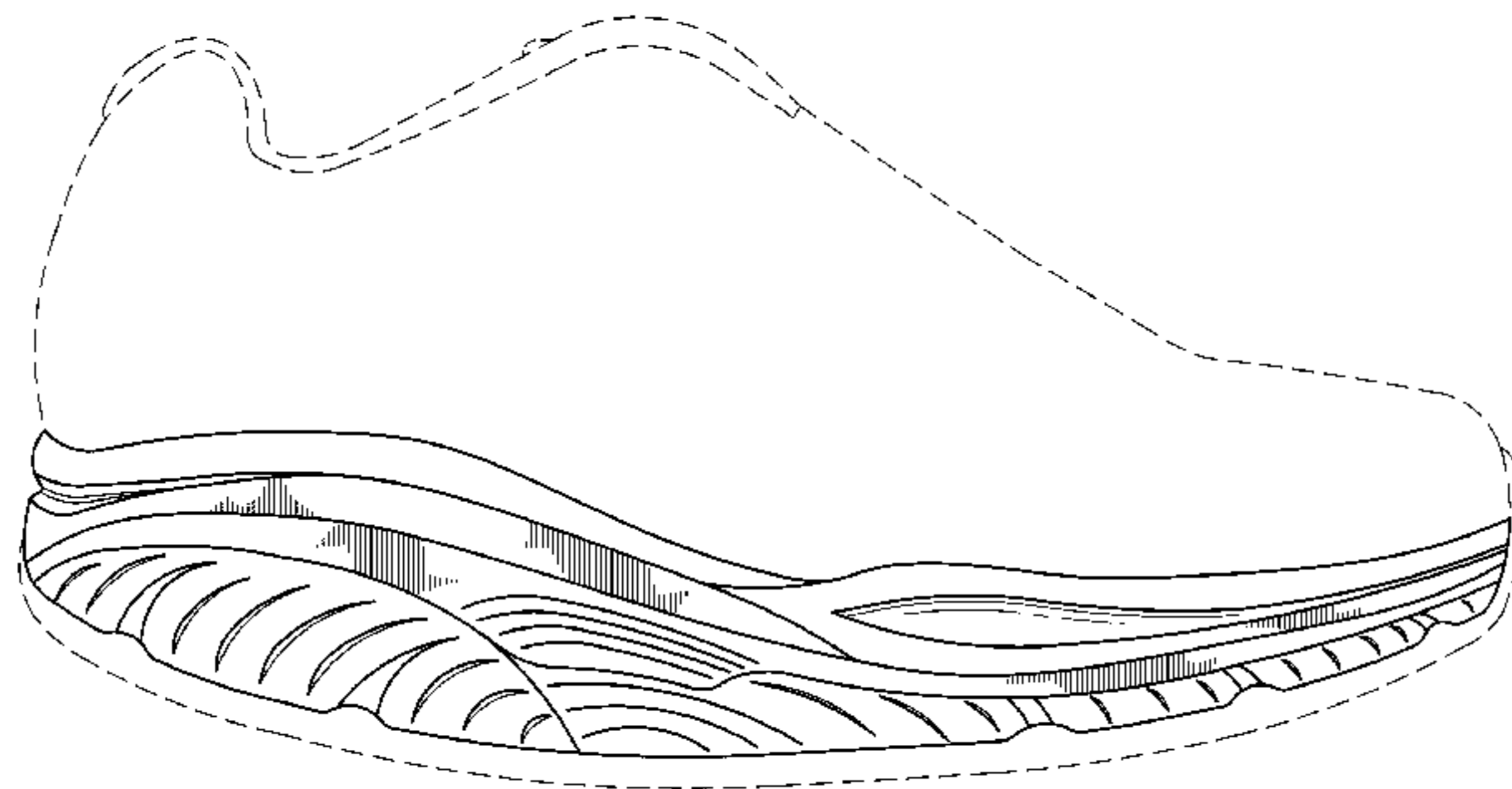

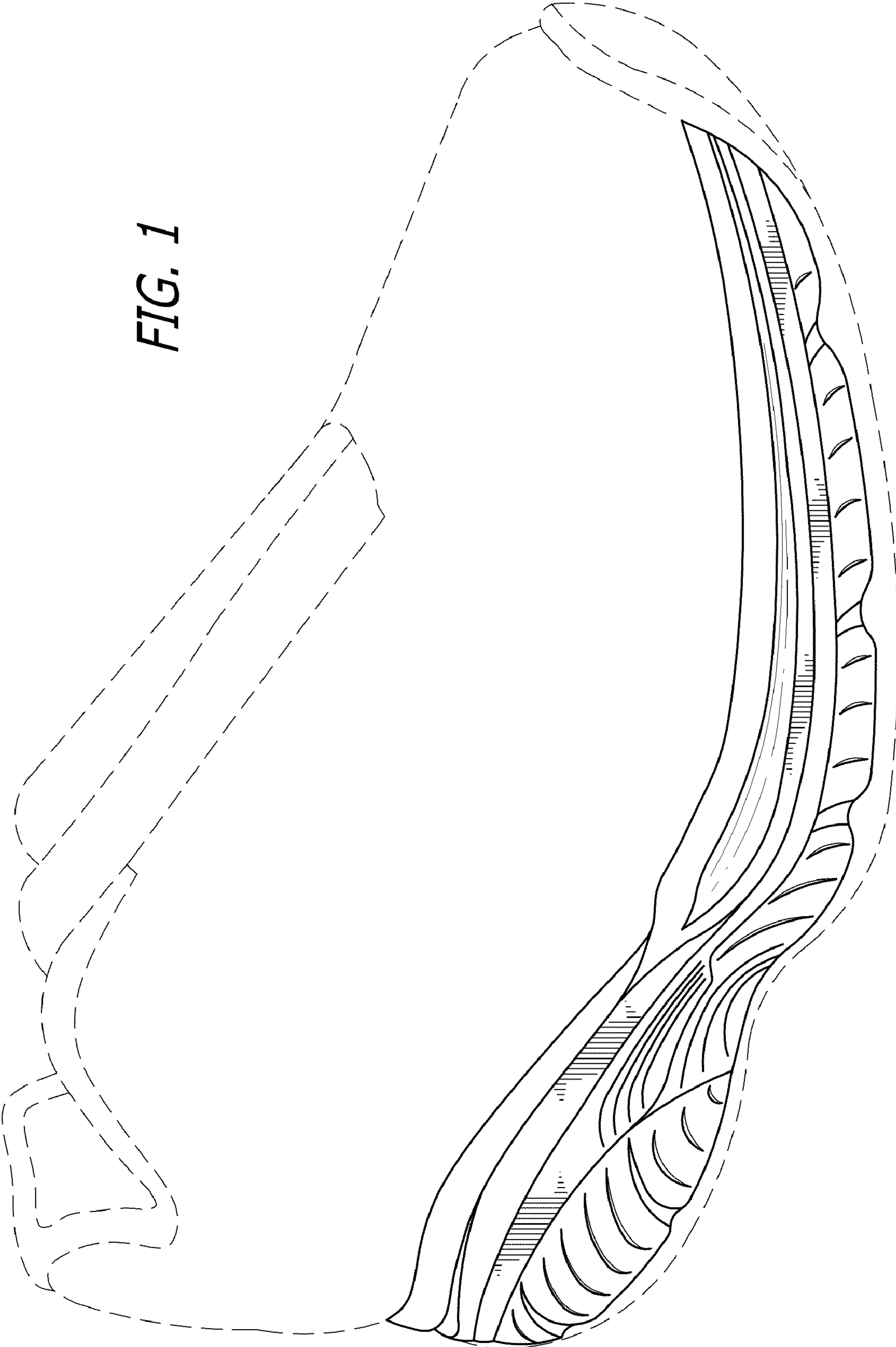
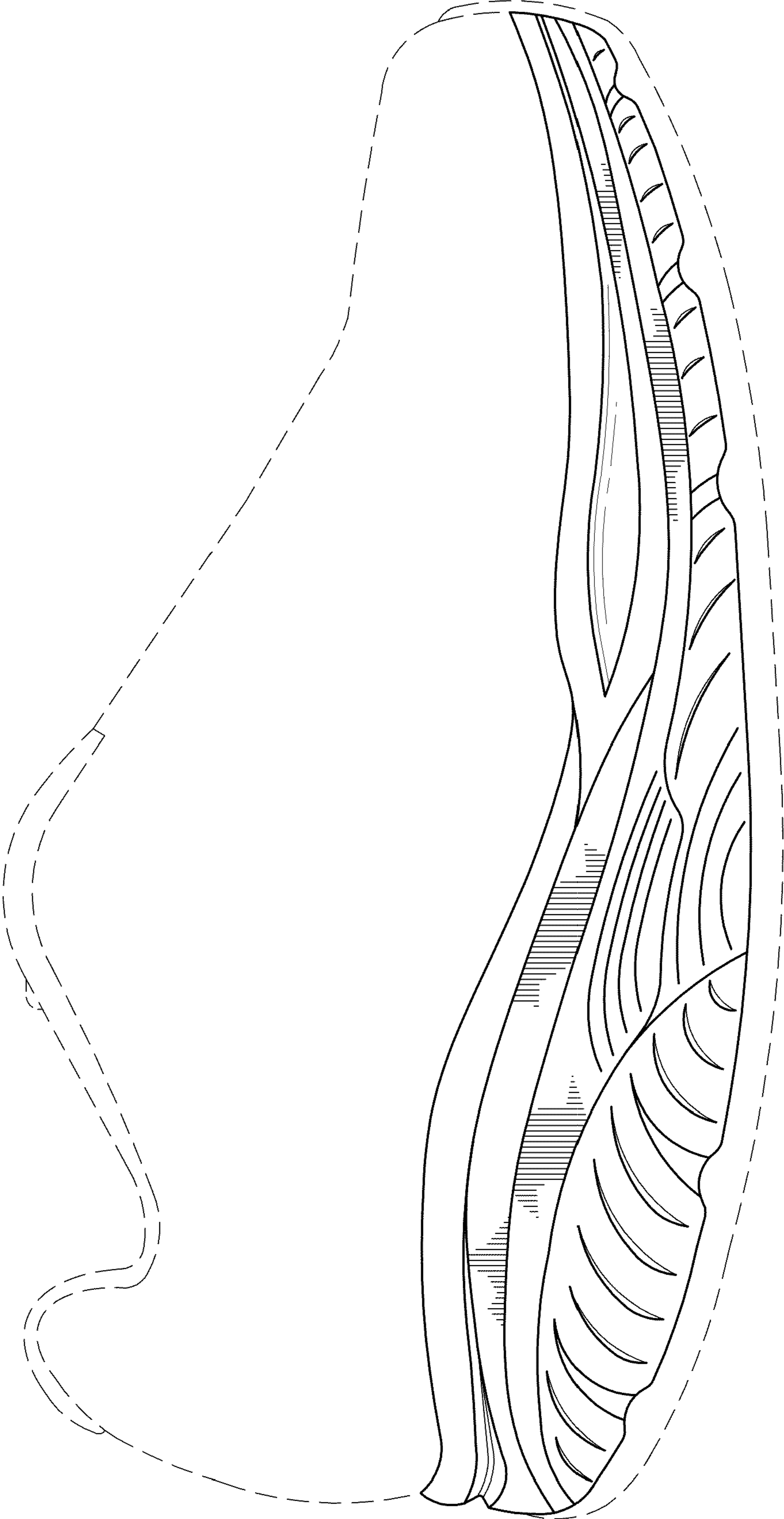

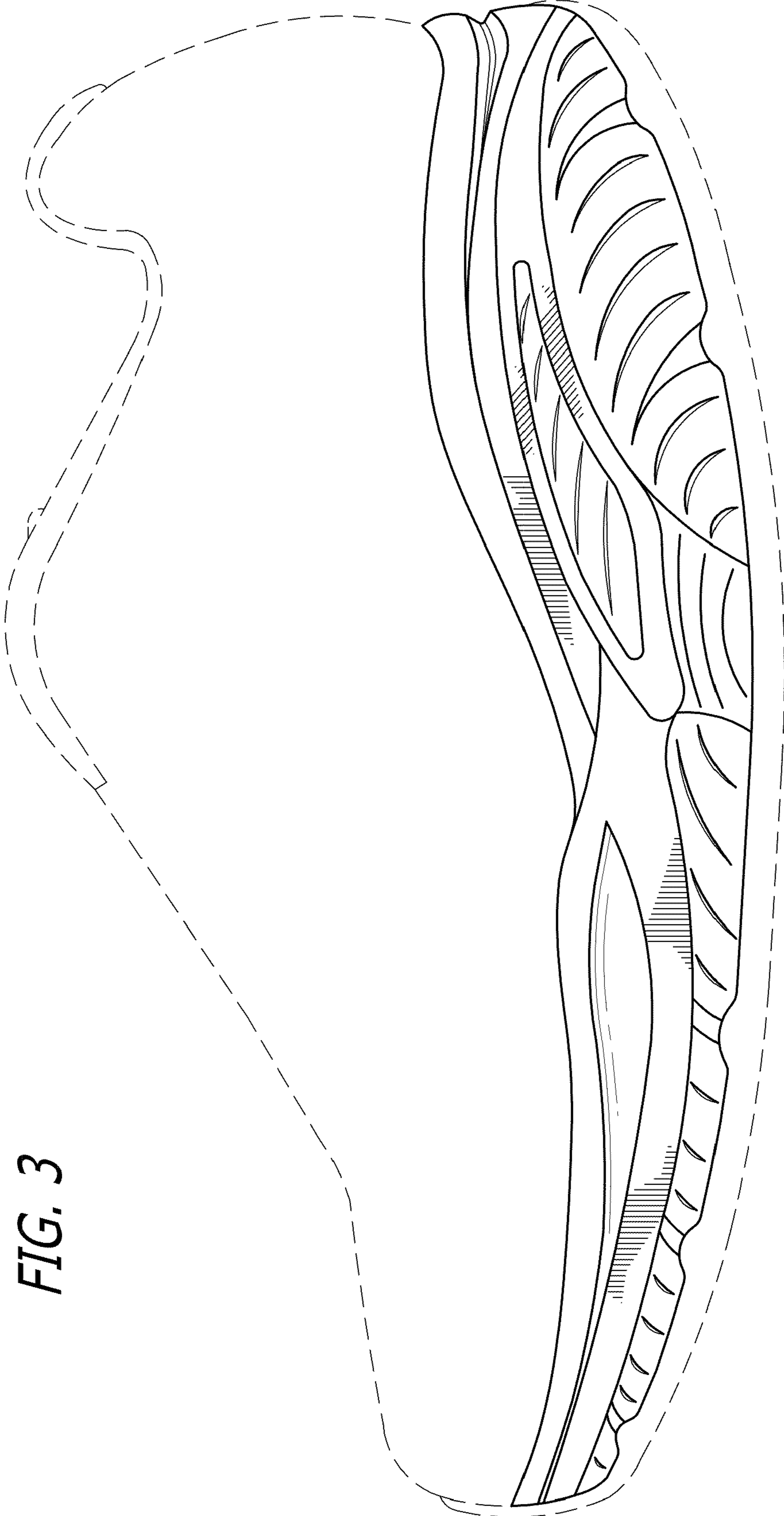
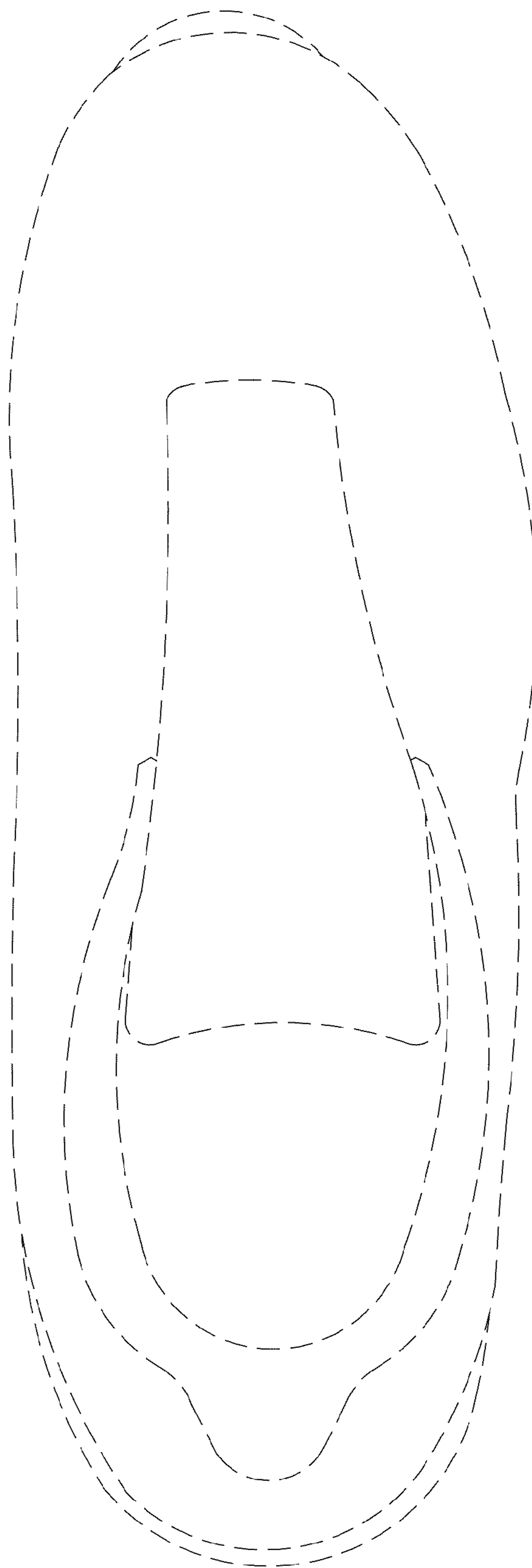
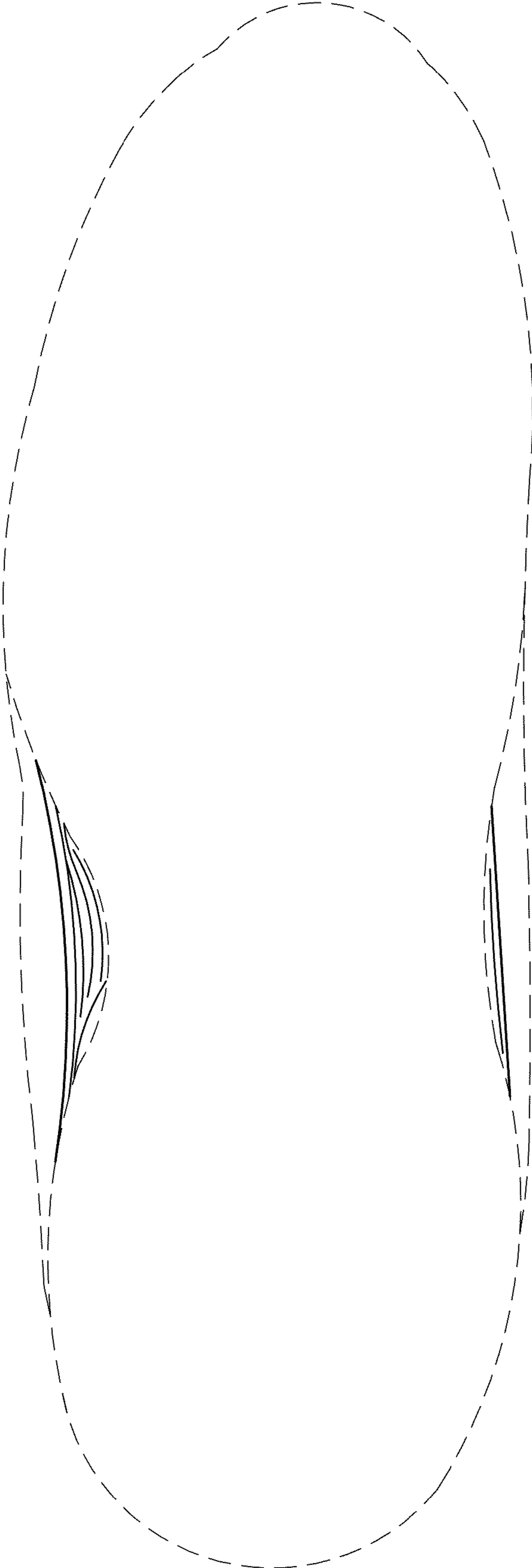

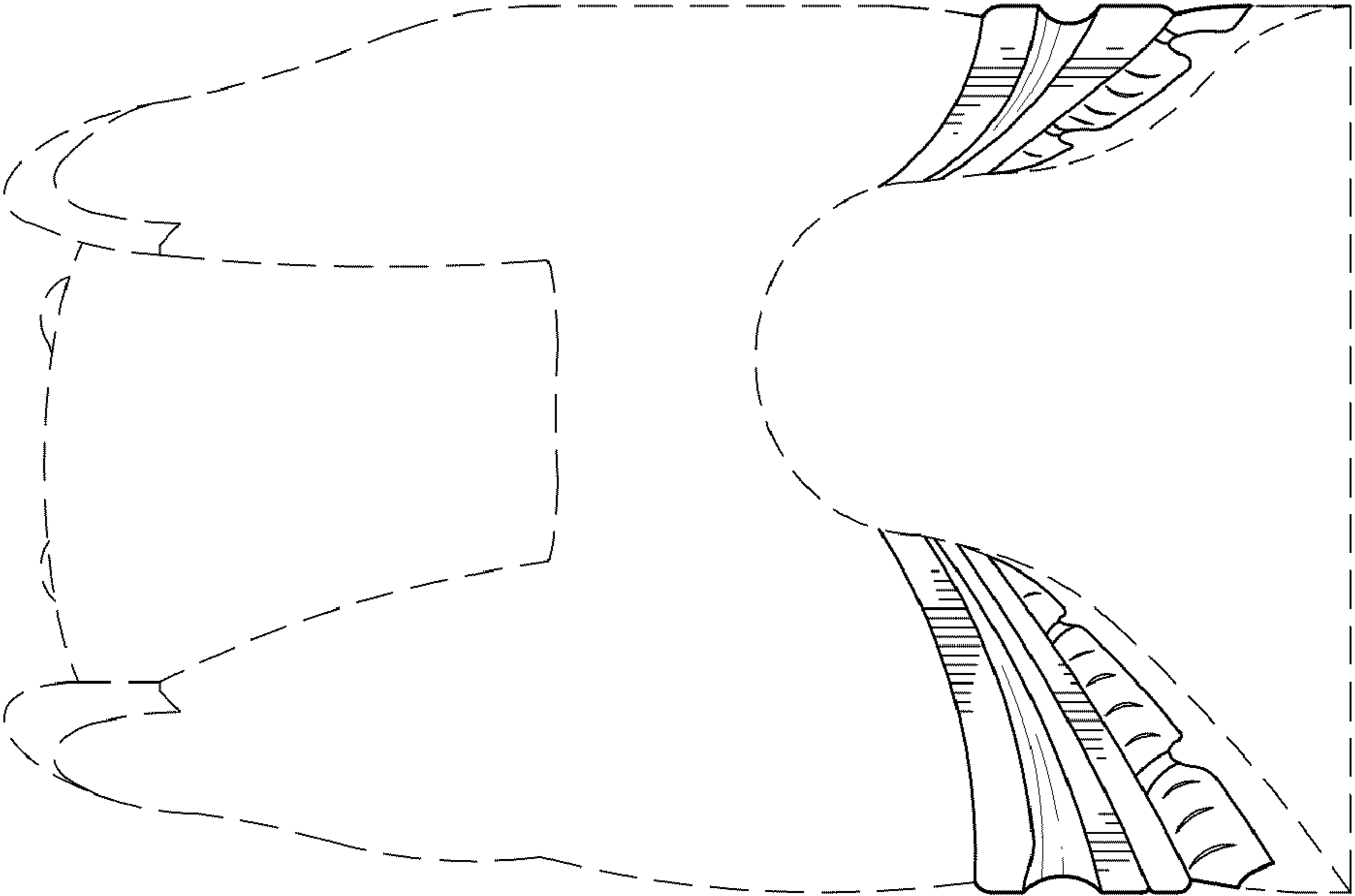
