The ornamental design for a footwear upper, as shown and described.

DESCRIPTION

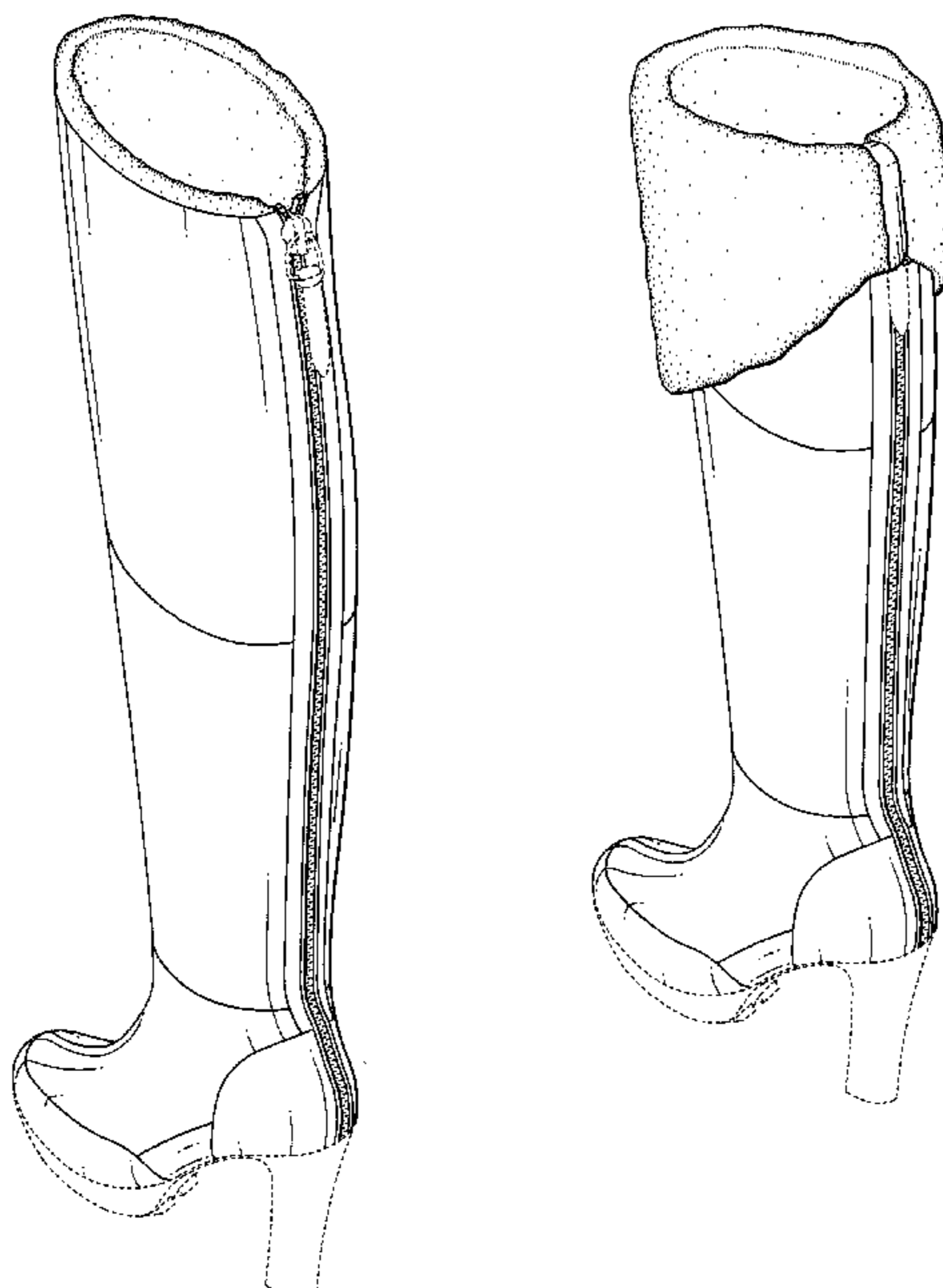
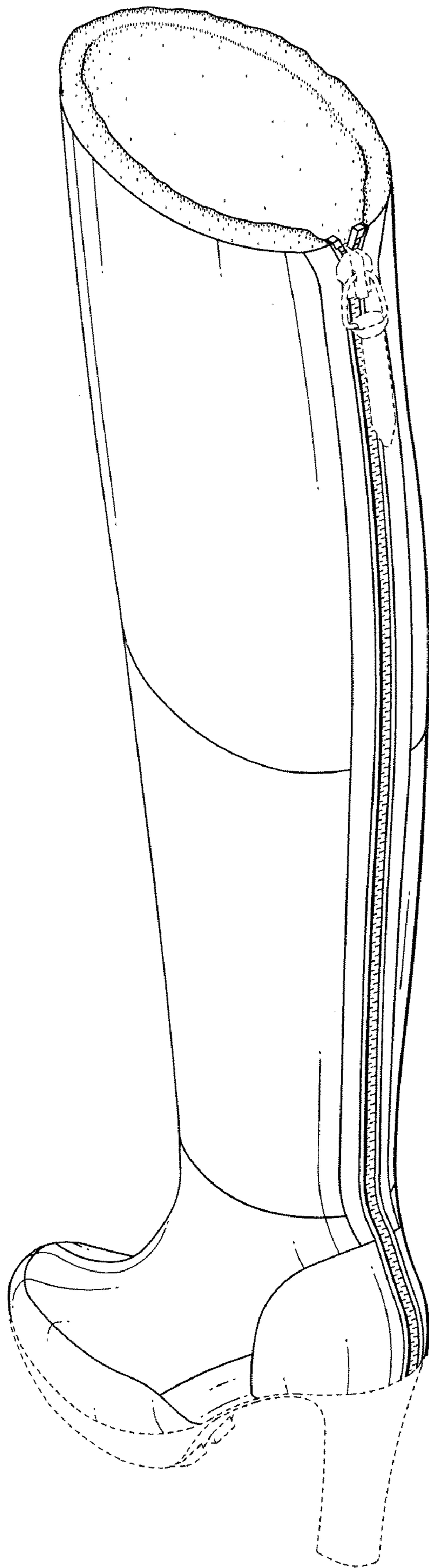

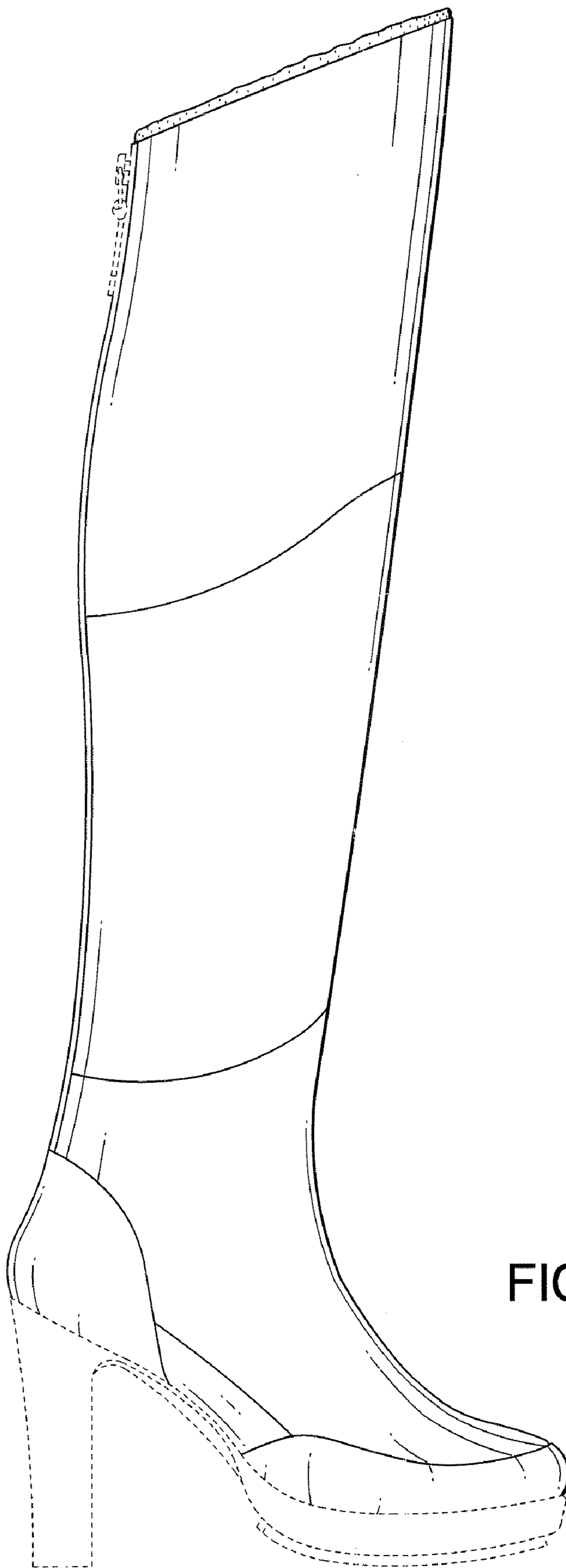
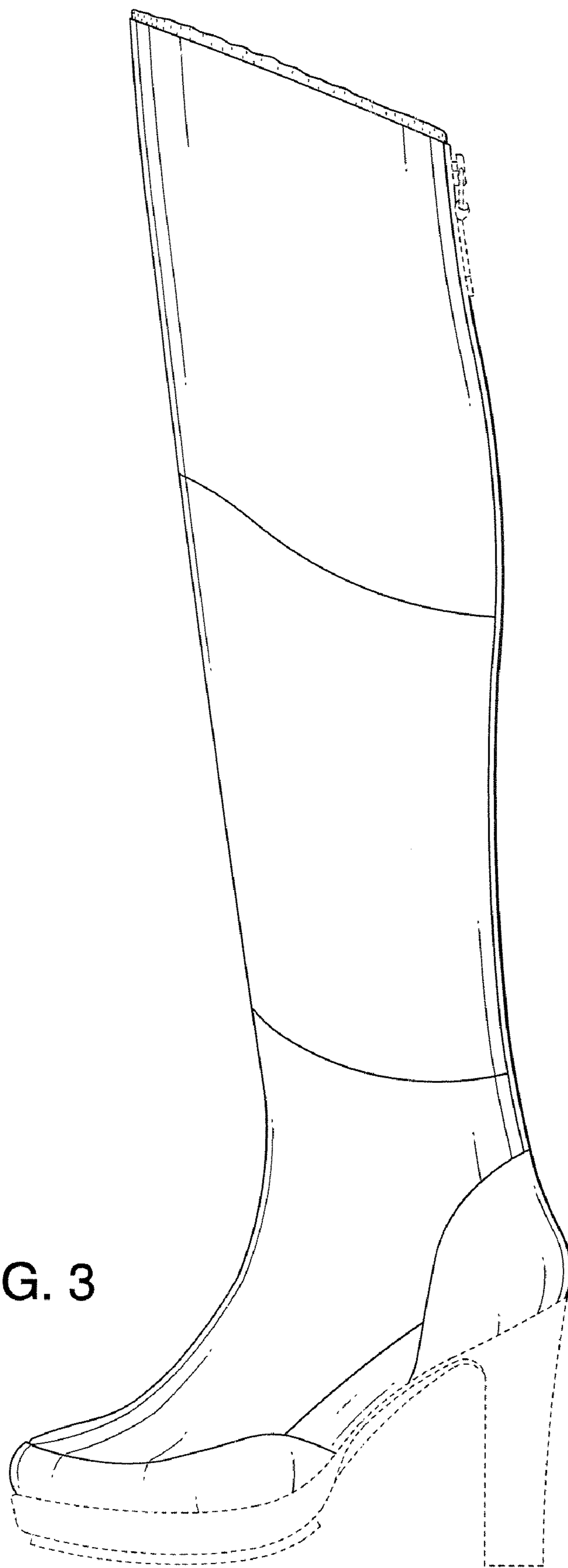

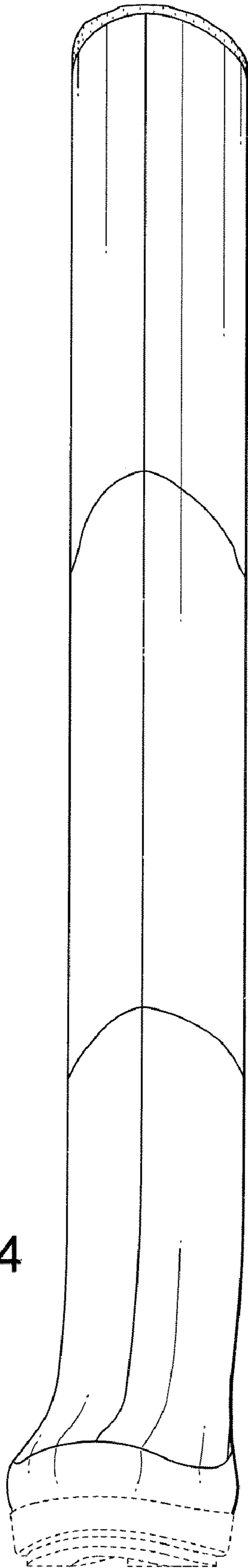

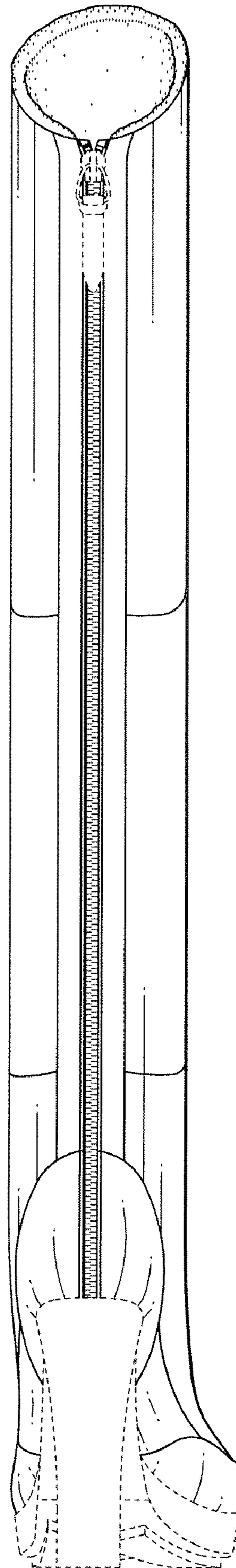

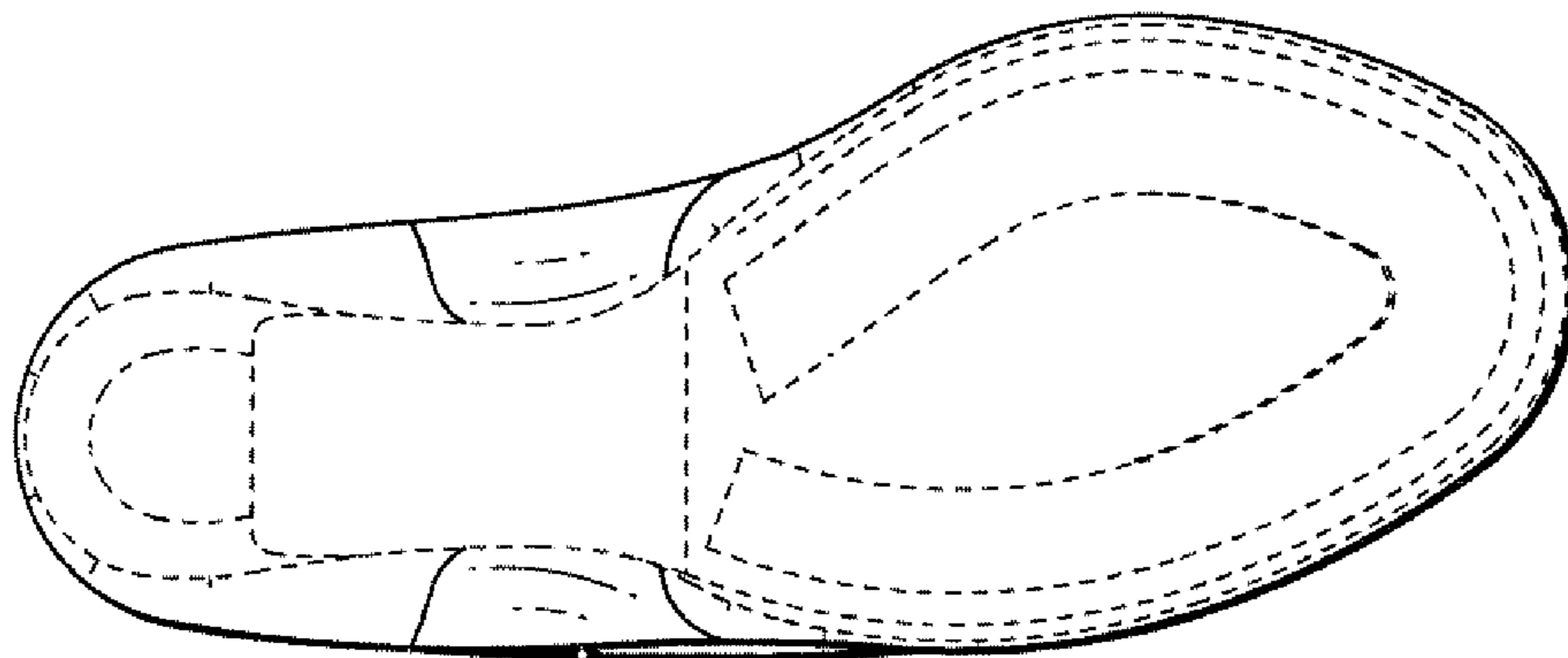
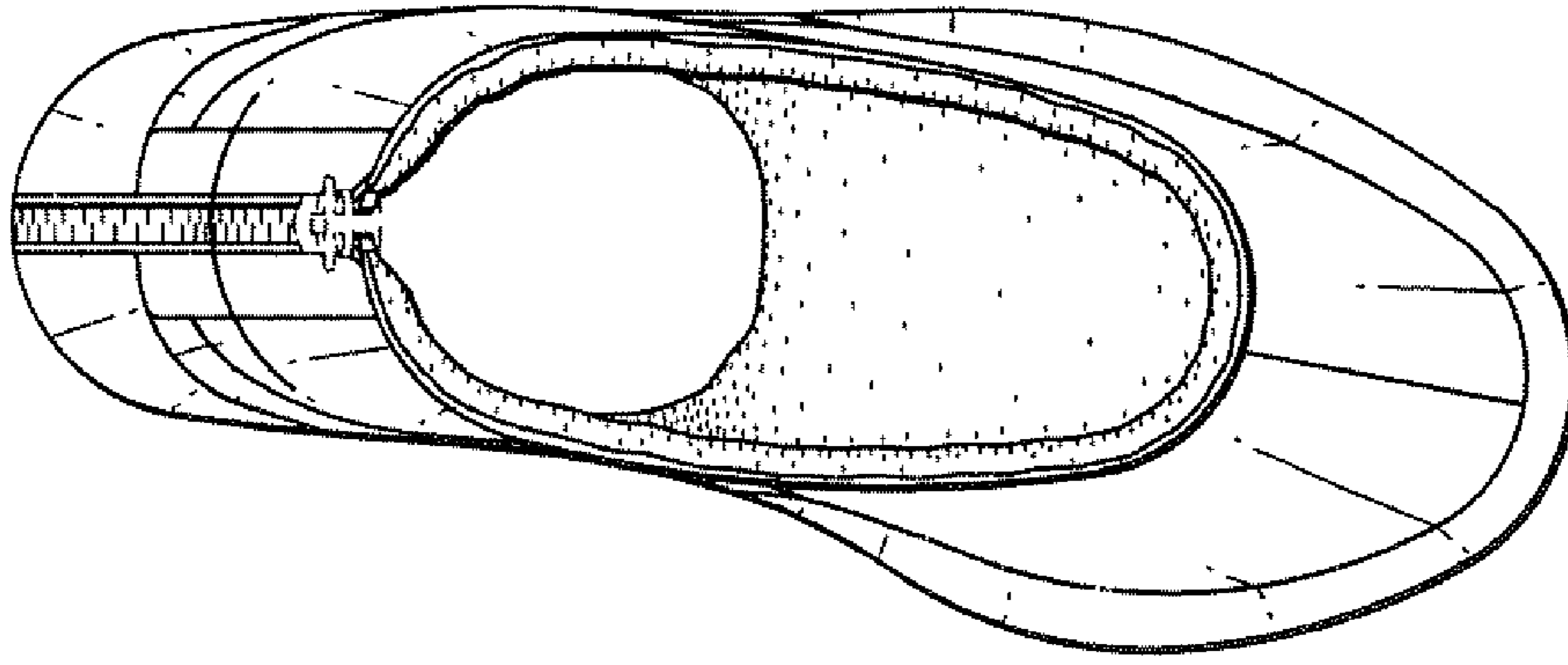
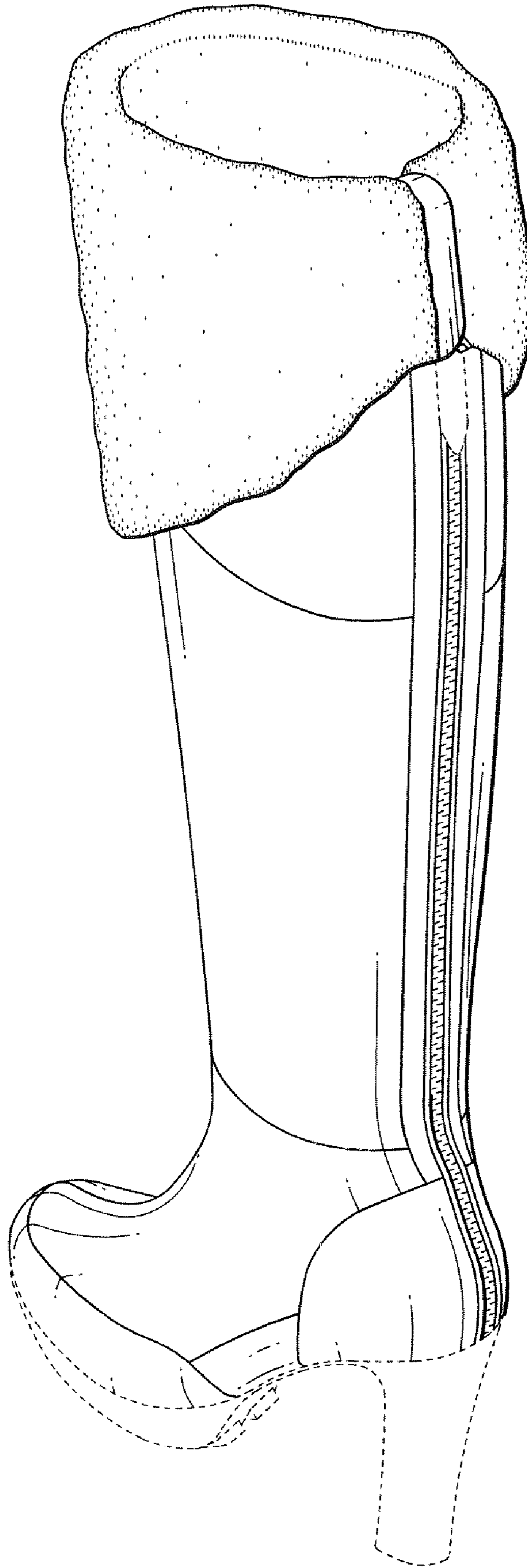

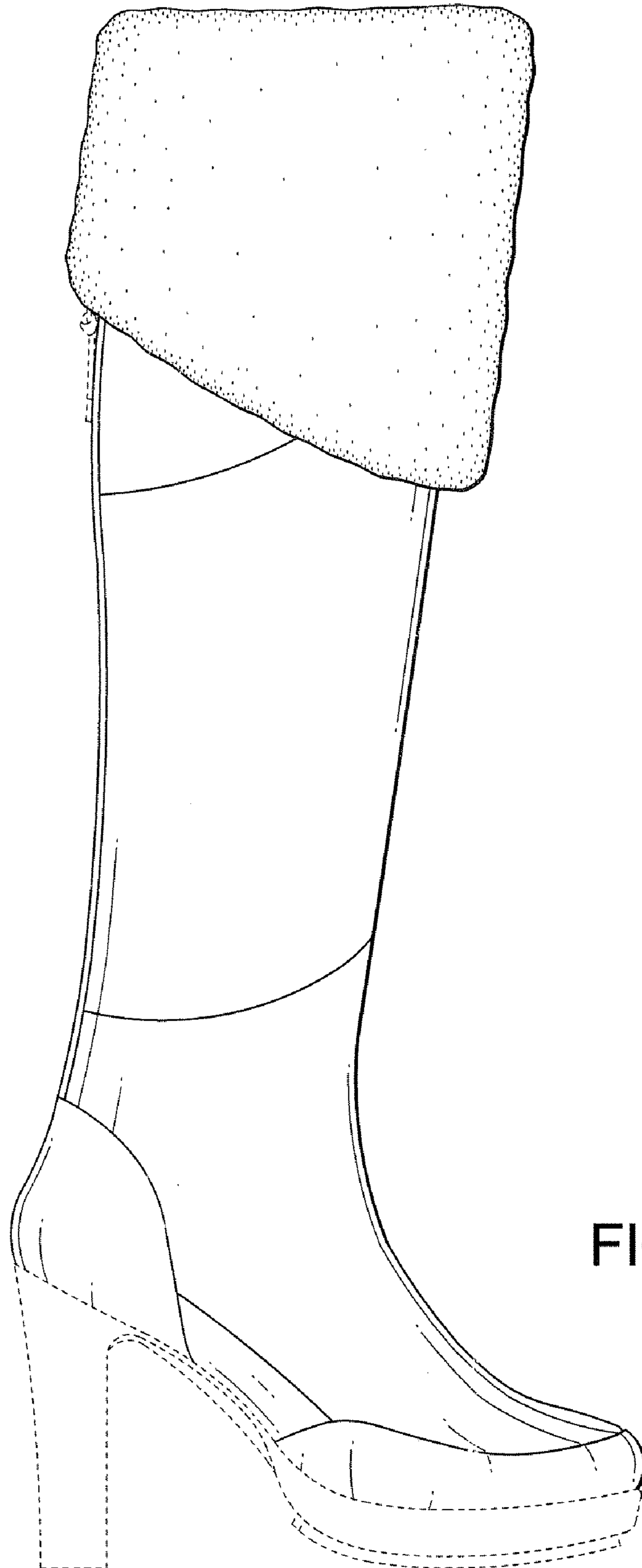

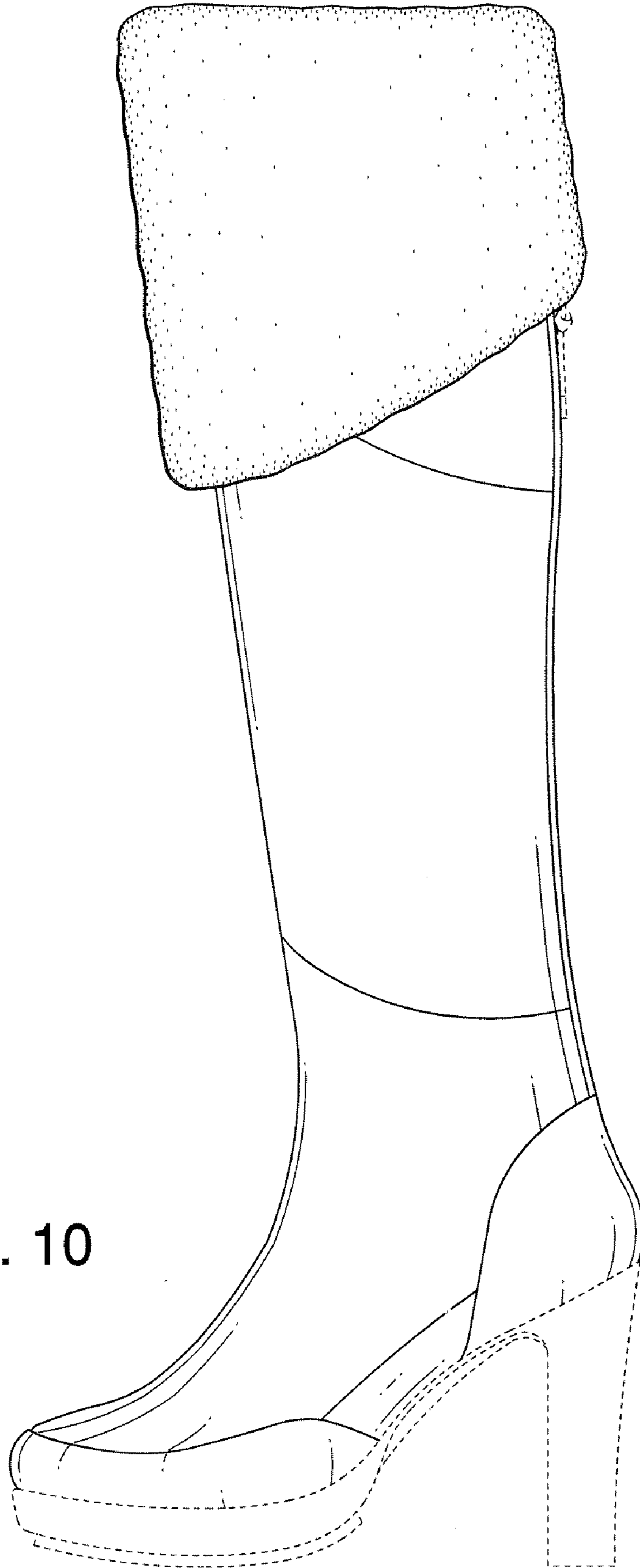

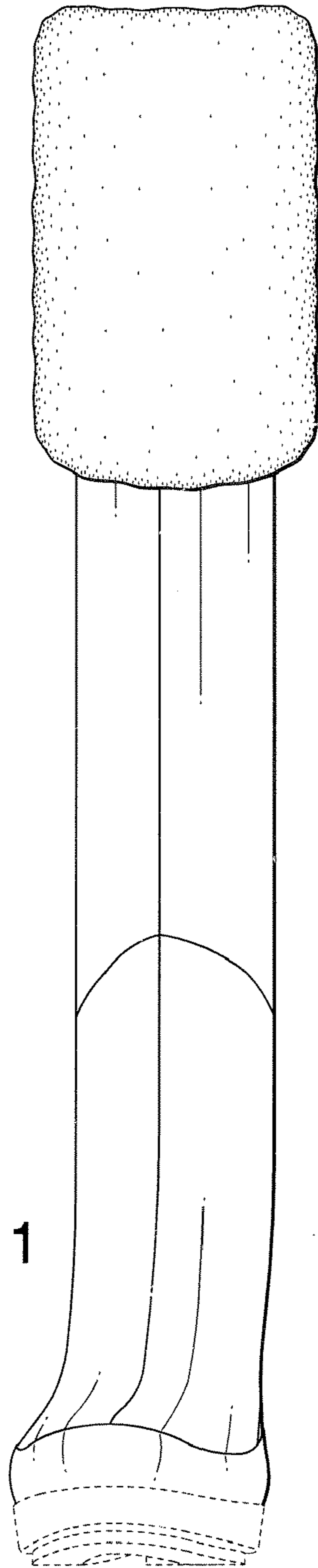

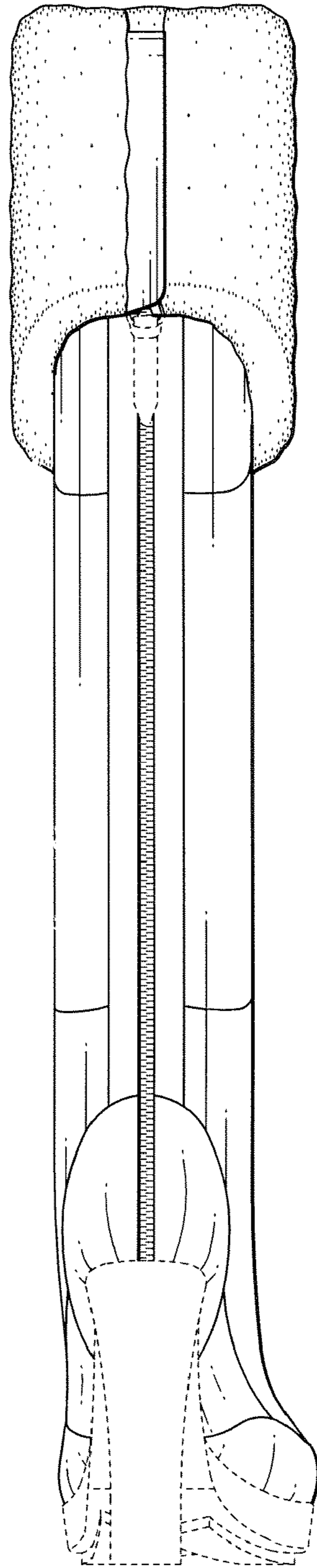

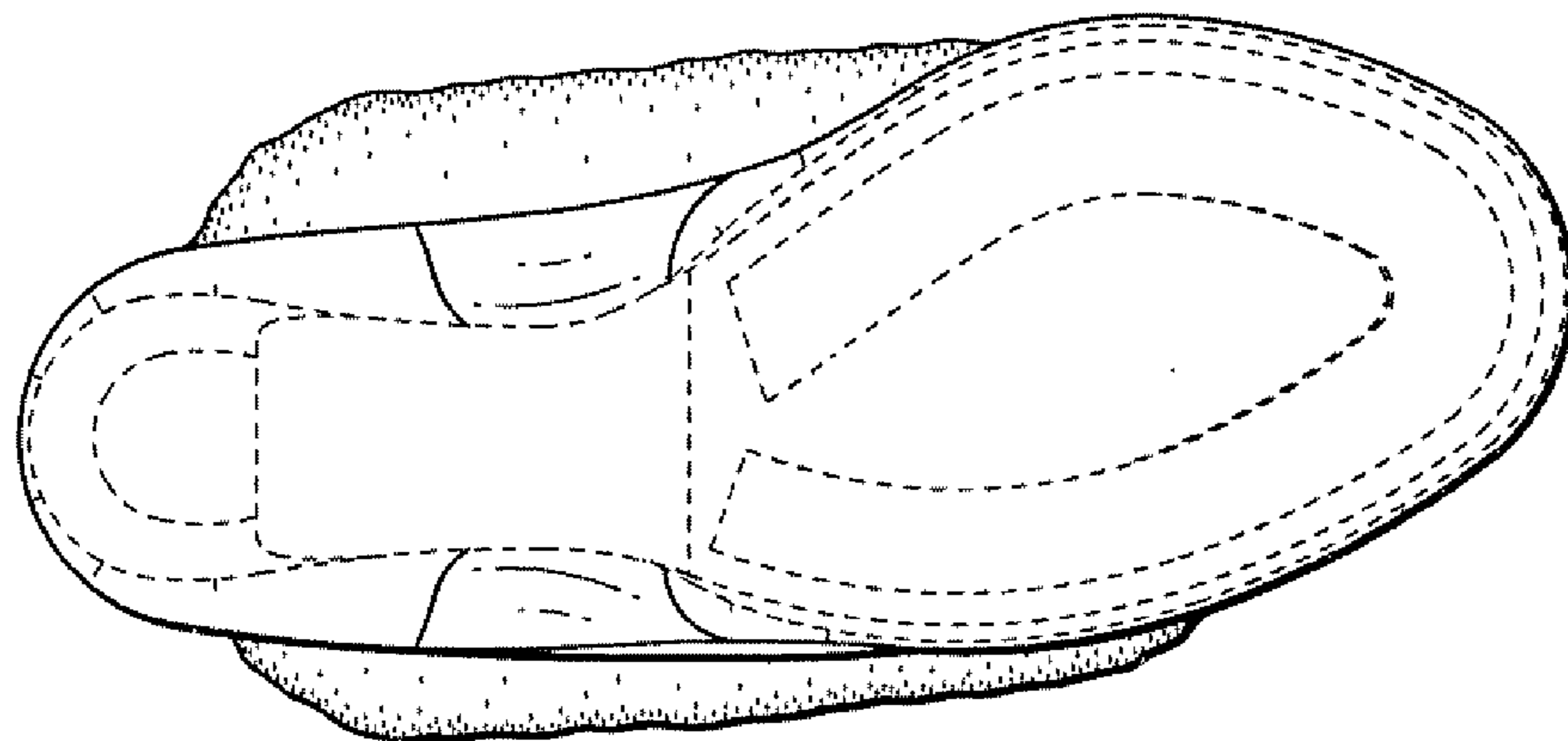
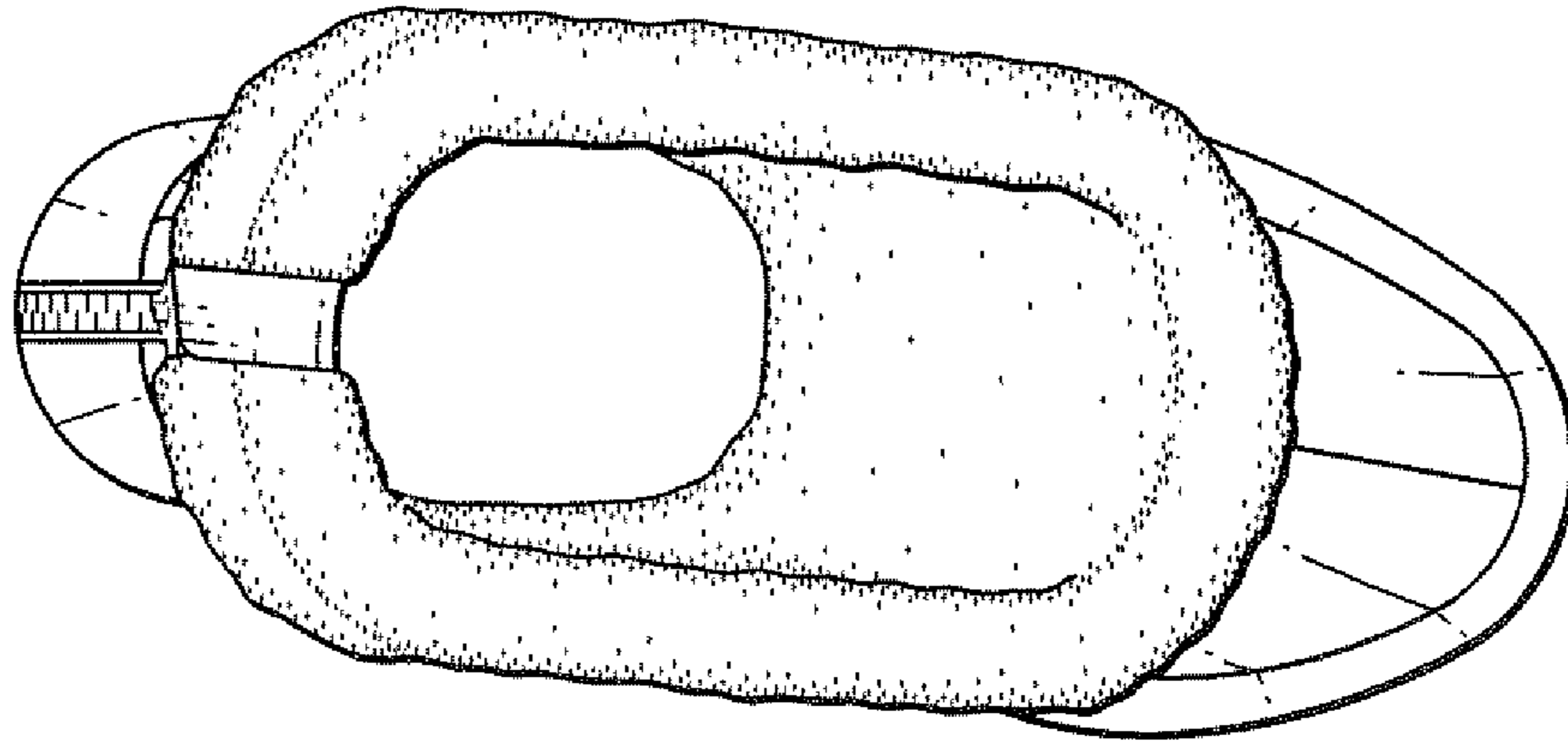

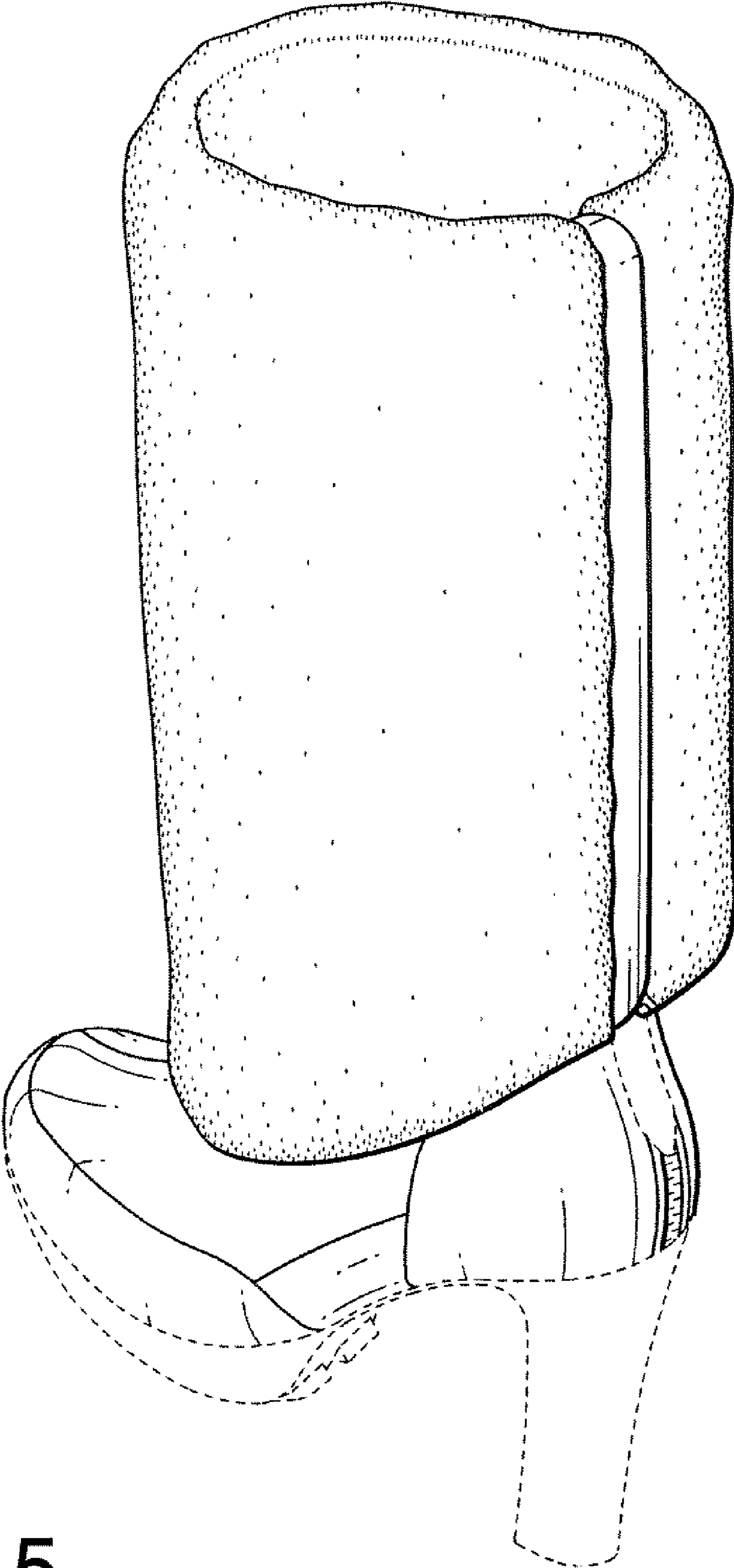

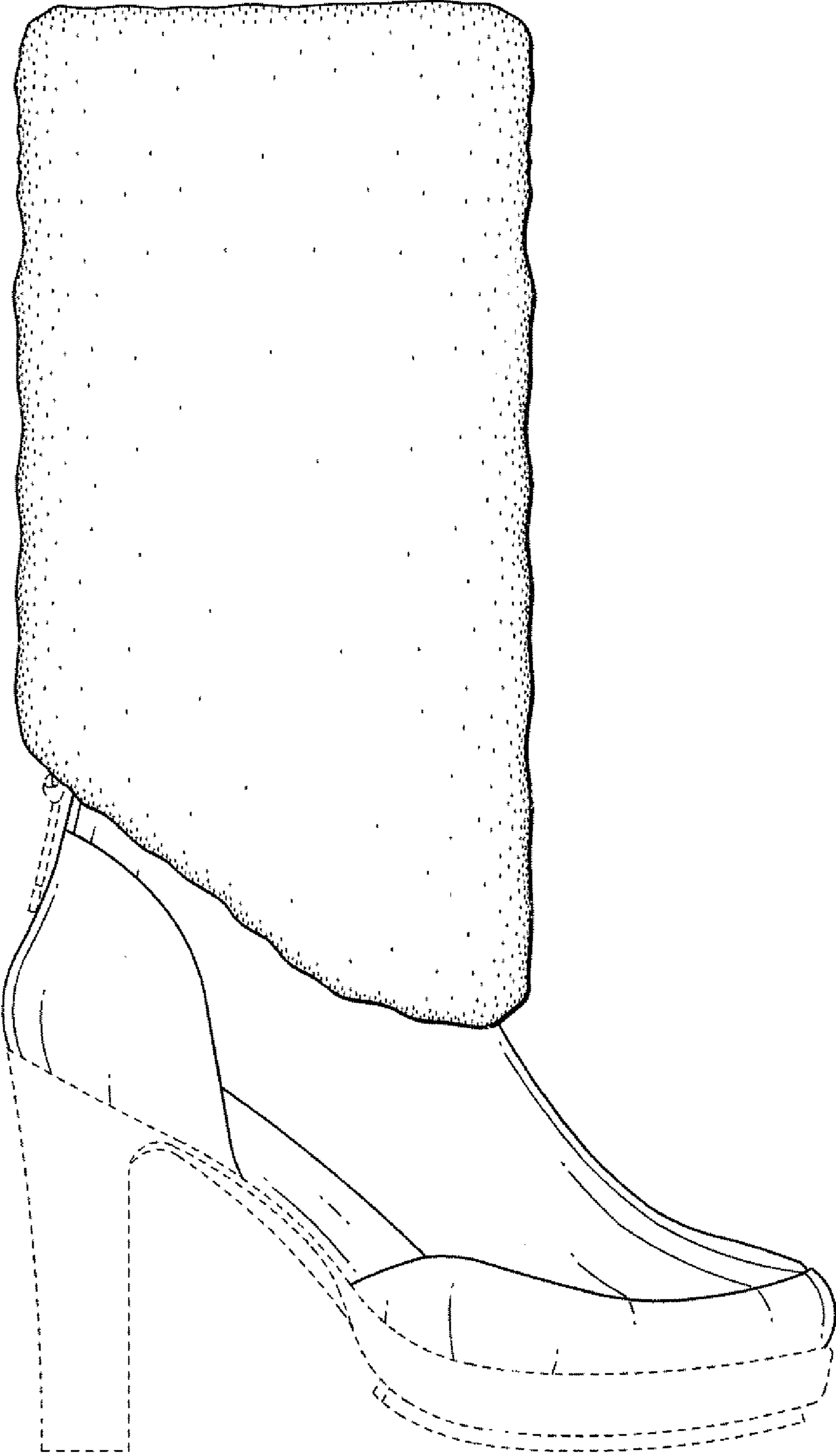

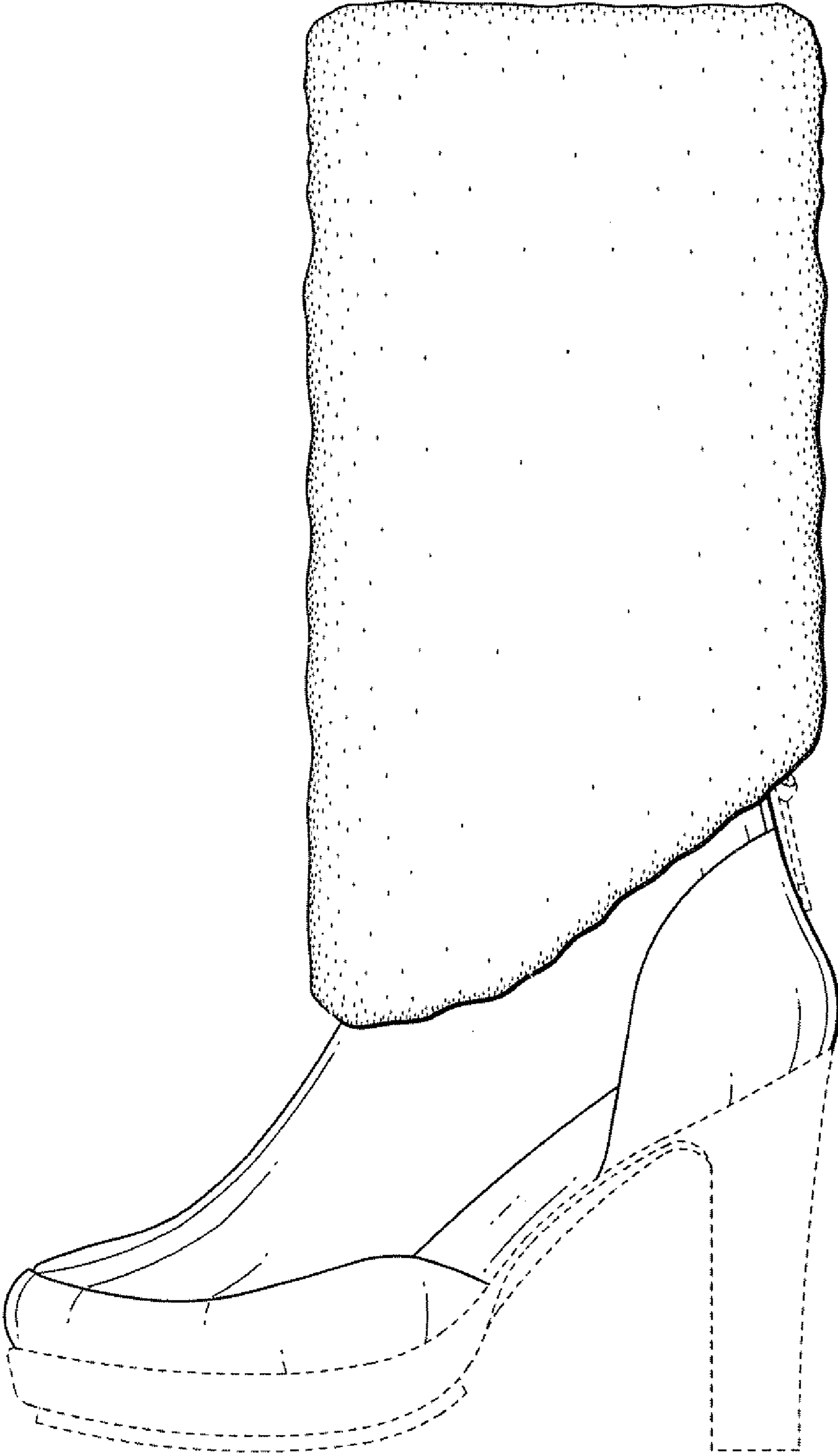

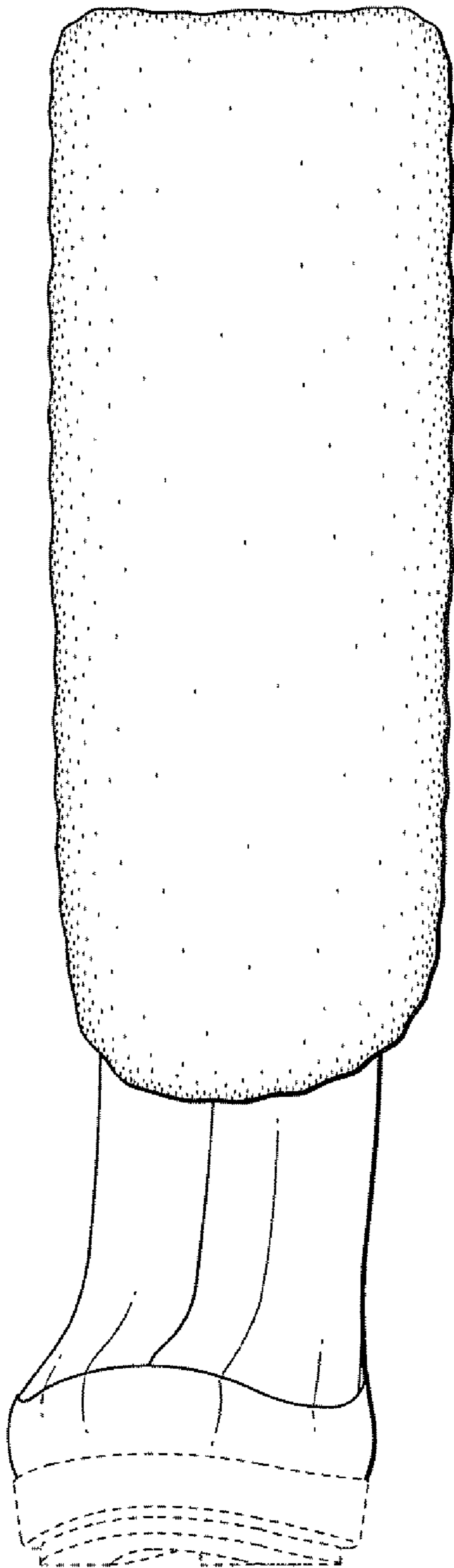

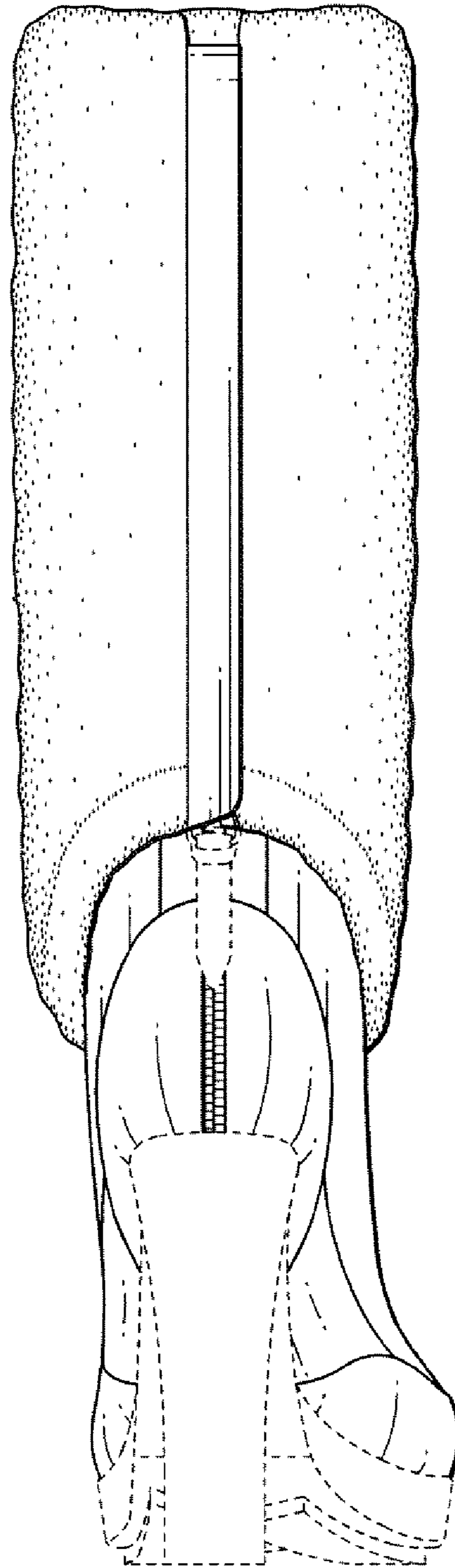

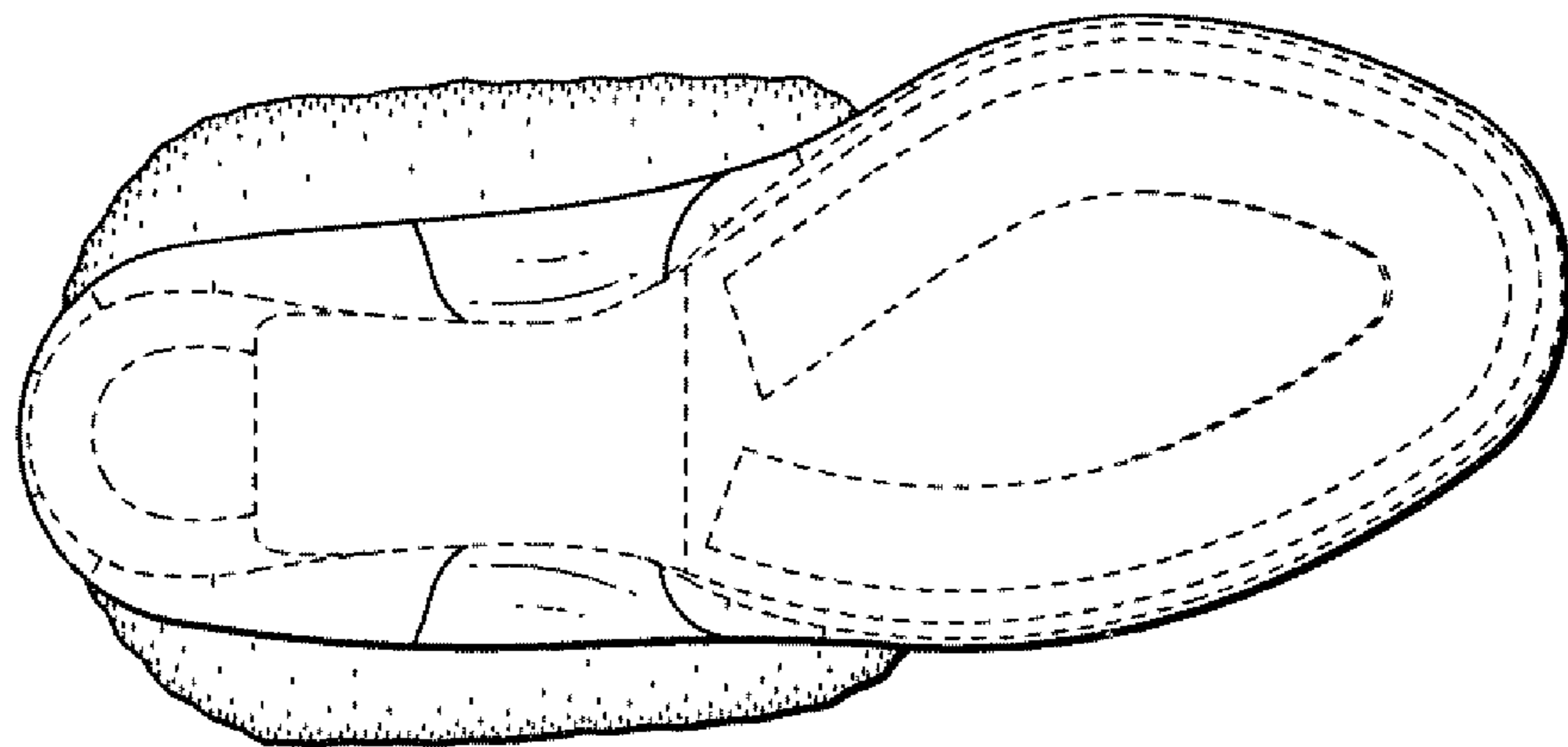
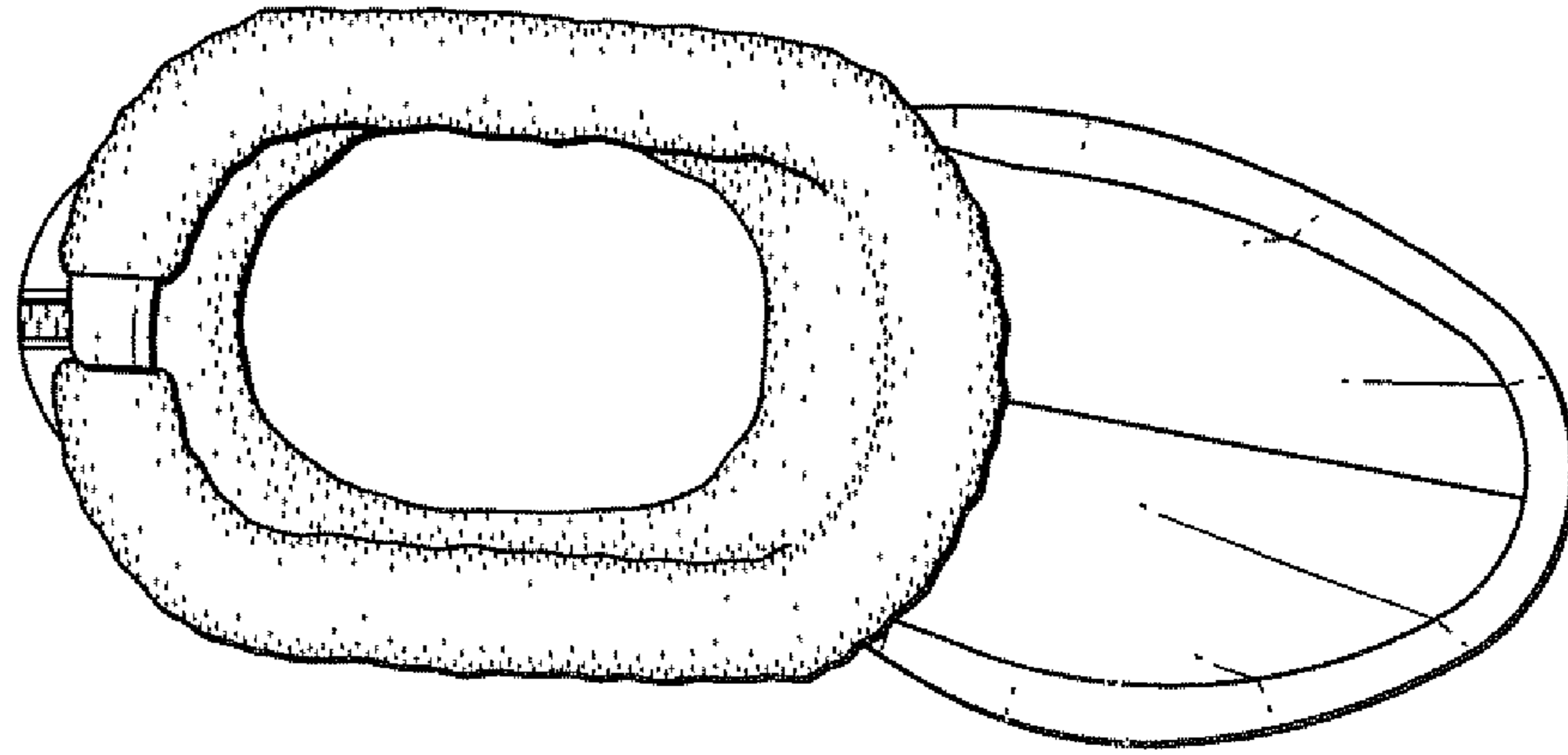
