applicant's invention.

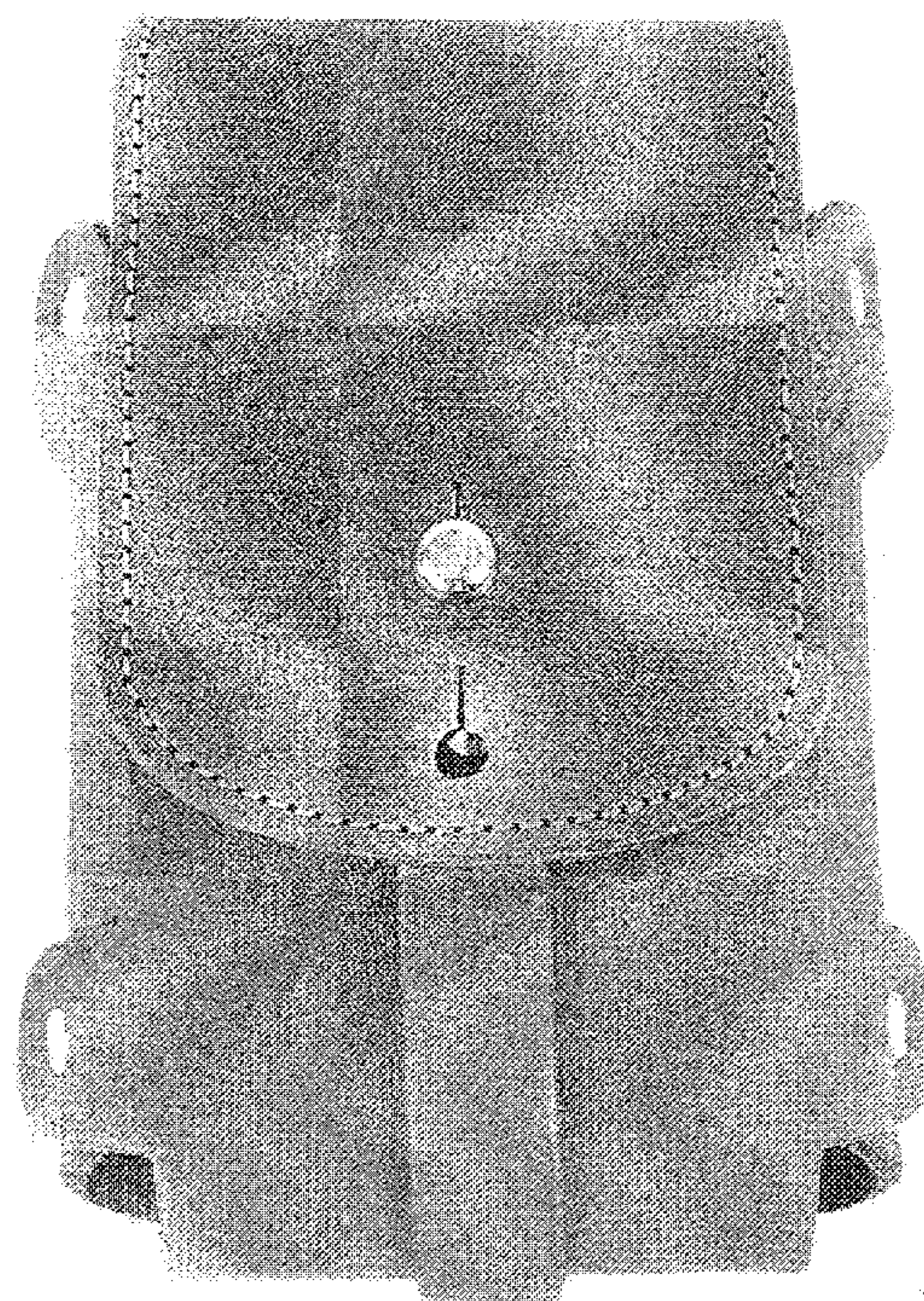
FIG. 7 is a left side view (flap open) of the vertical holster of

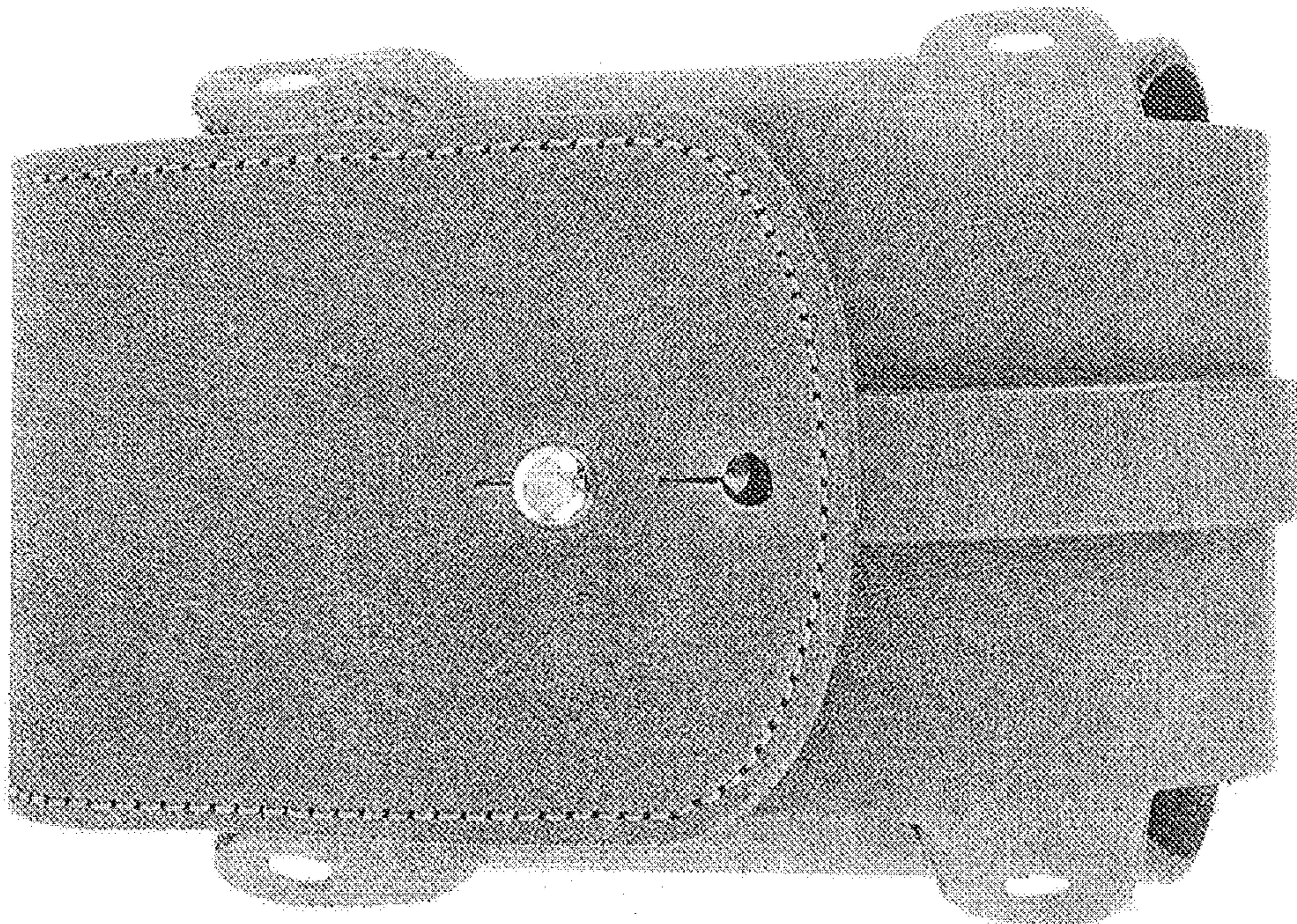


Fig. 1 - Front View/Flap
Closed

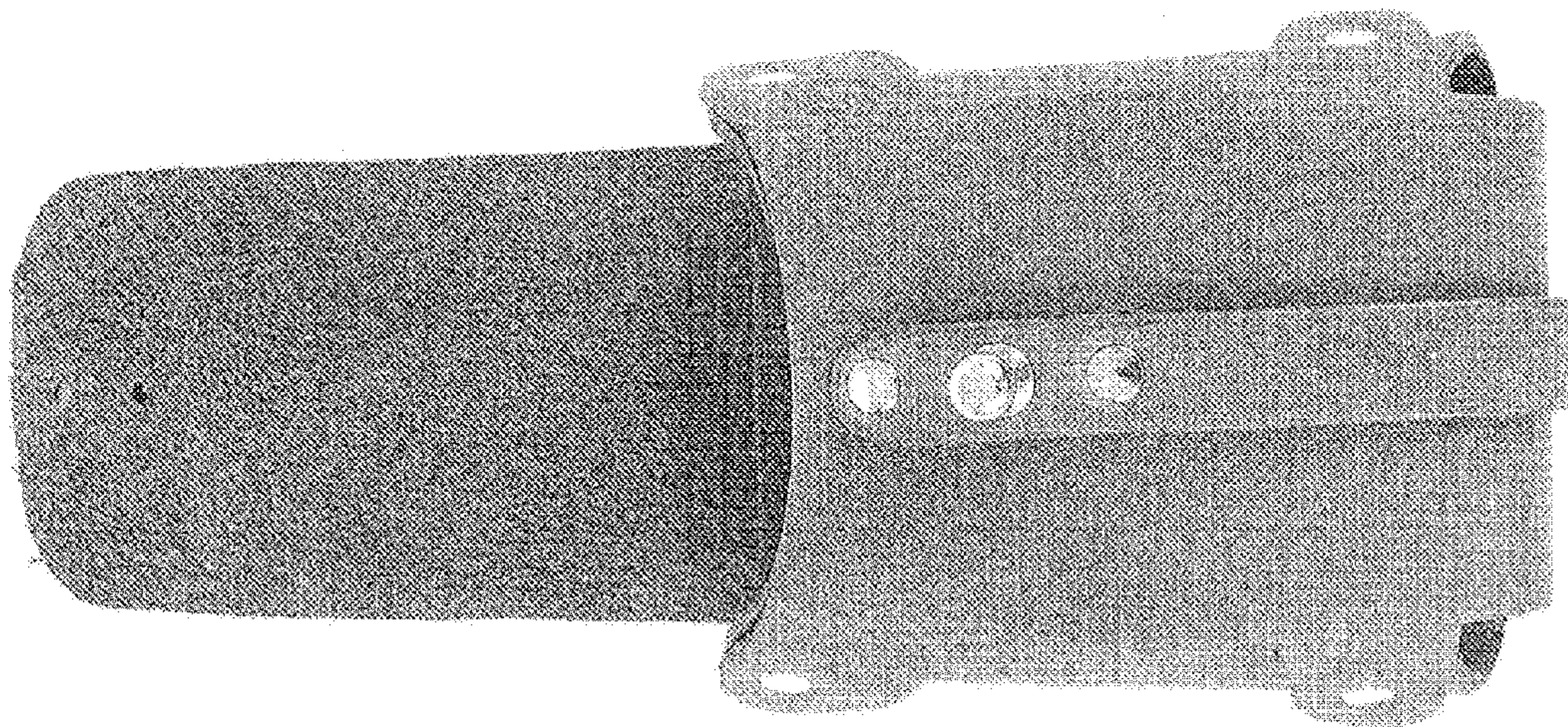


Fig. 3 - Front View/Flag
Open

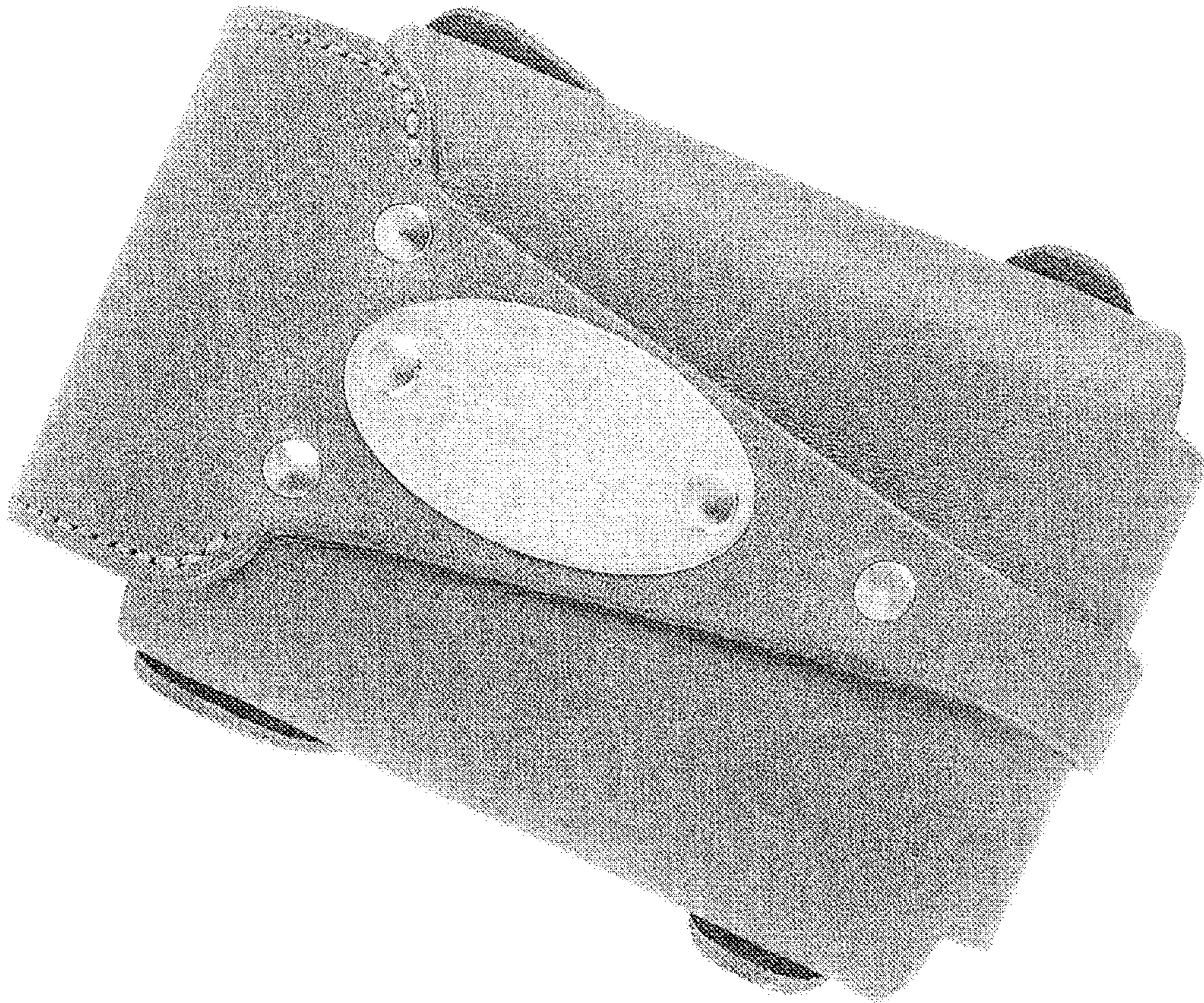


Fig. 3 -- Back View/Flap
Closed

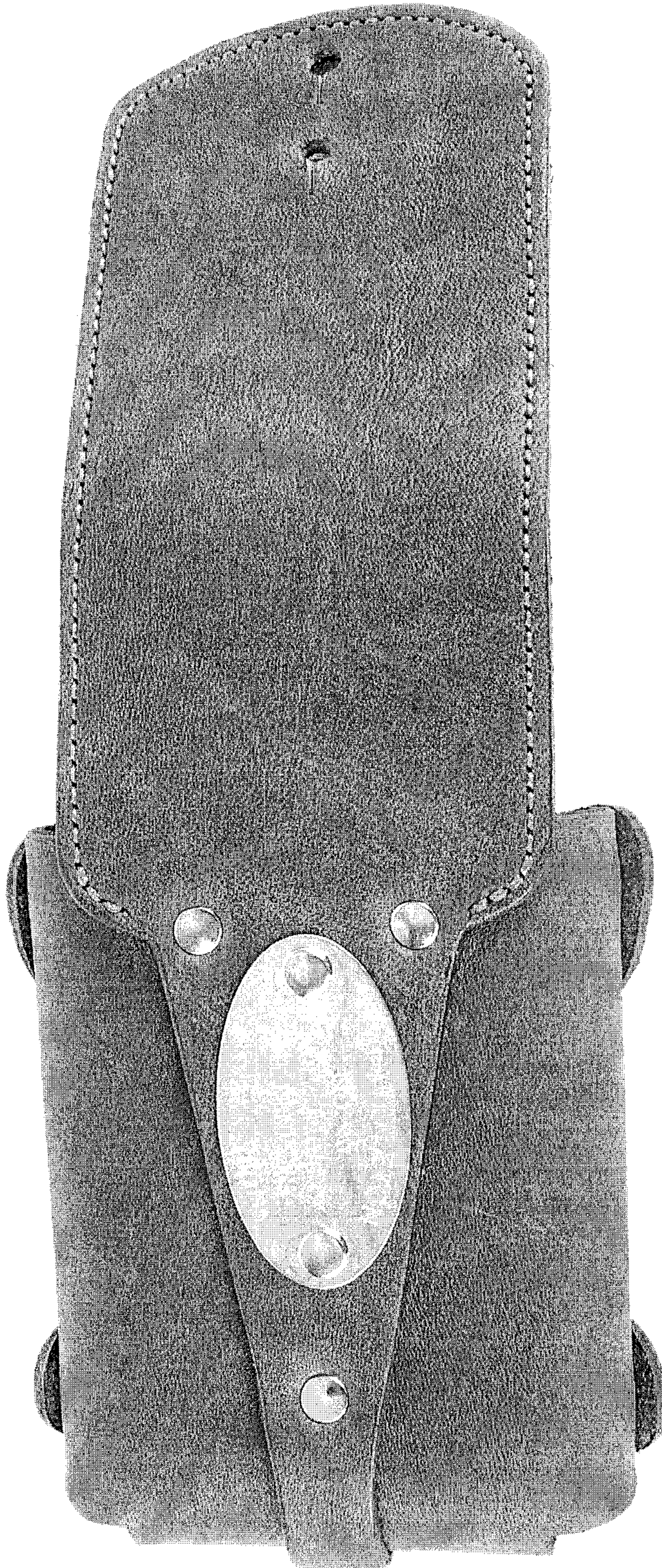


Fig. 4 – Back View/
Flap Open

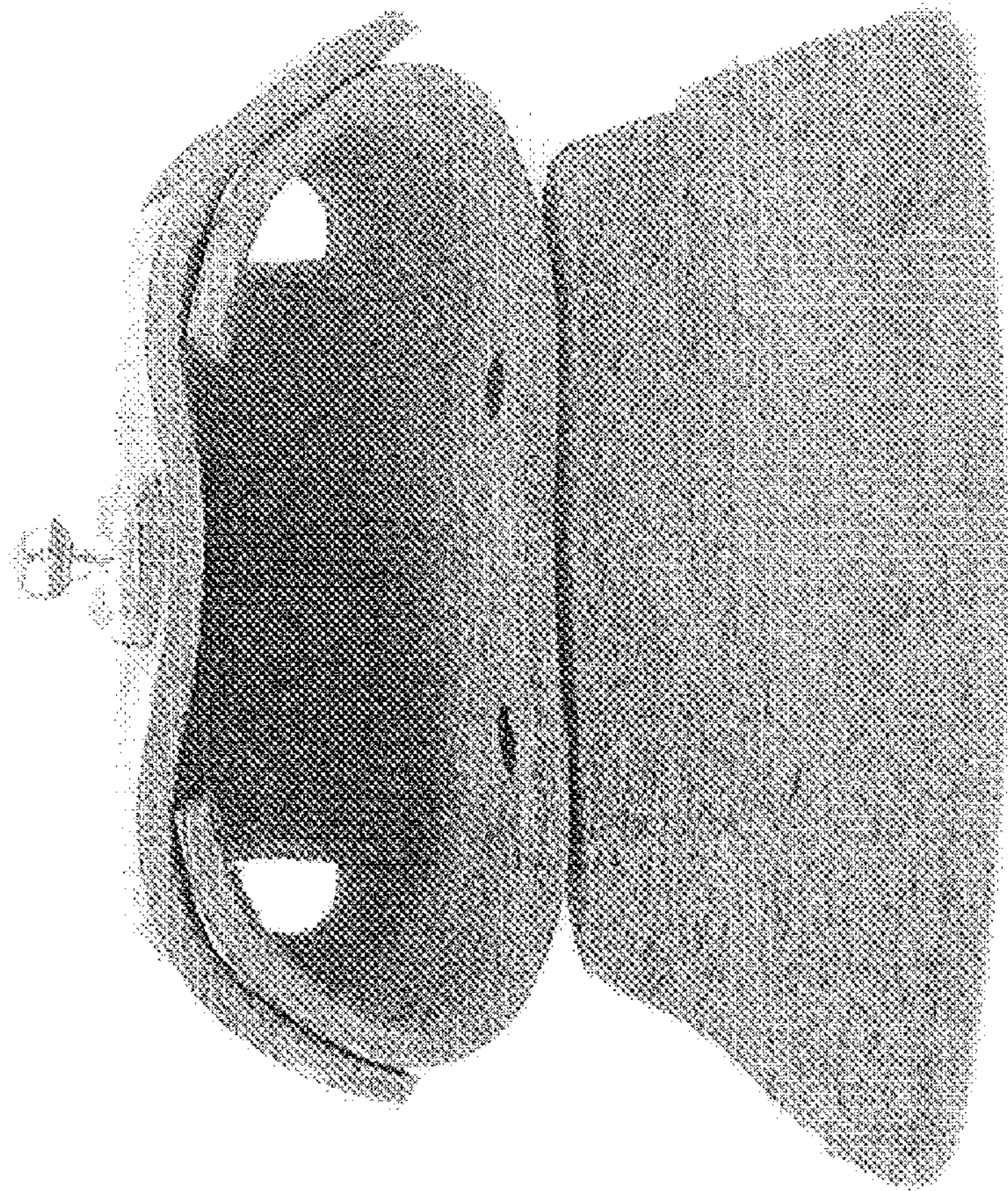


Fig. 5 -- Top View/Flap
Open

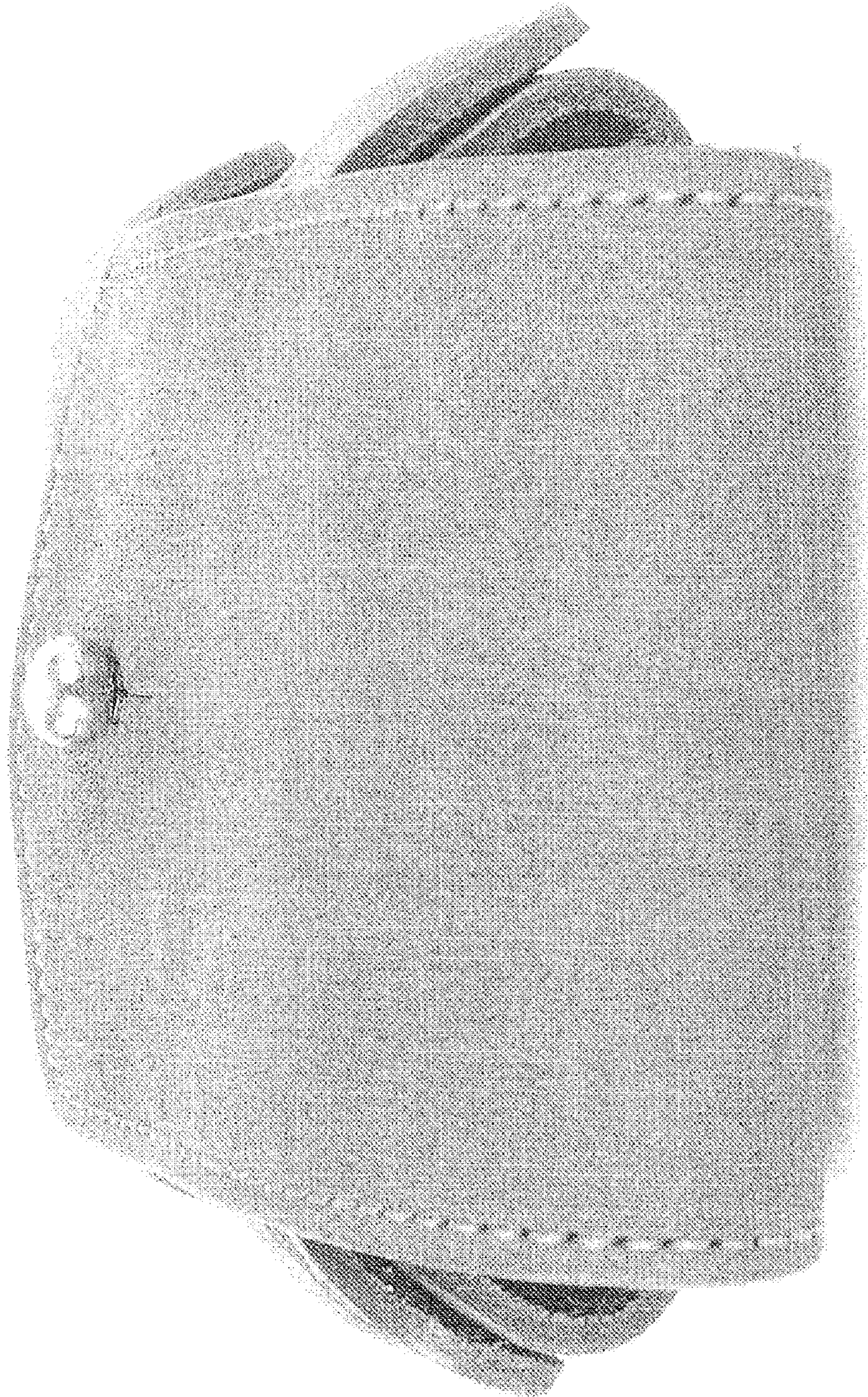


Fig. 6 -- Top View/Flap
Closed

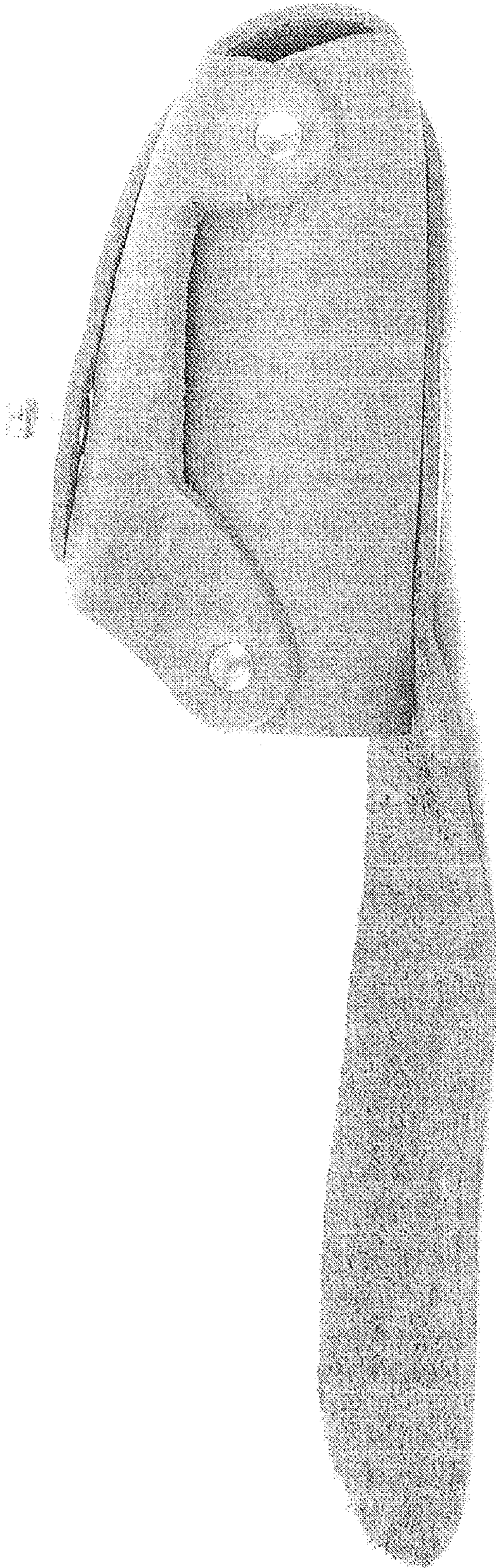


Fig. 7 - Left Side View/
Flap Open

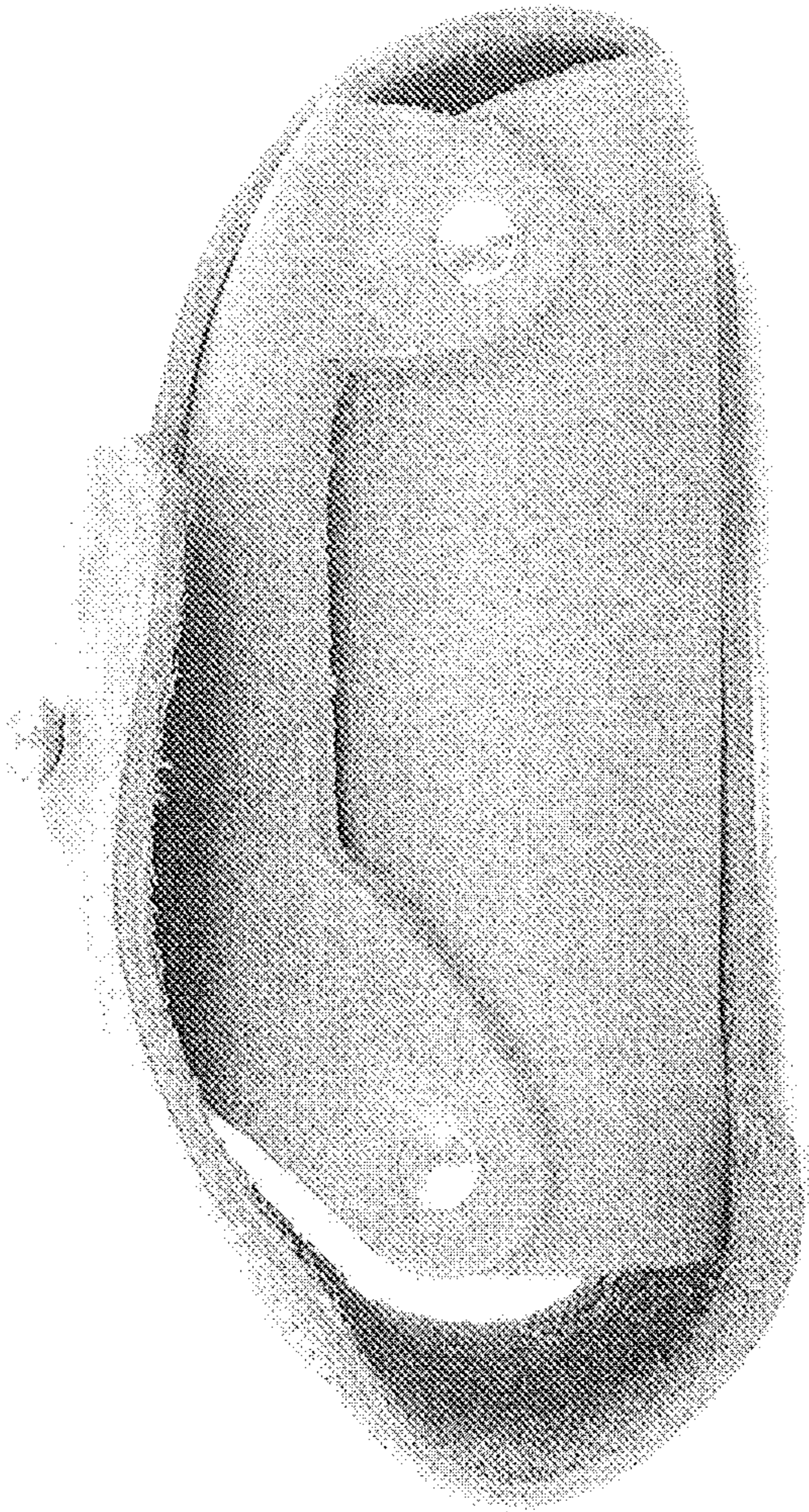


Fig. 8 -- Left Side View/Flap Closed

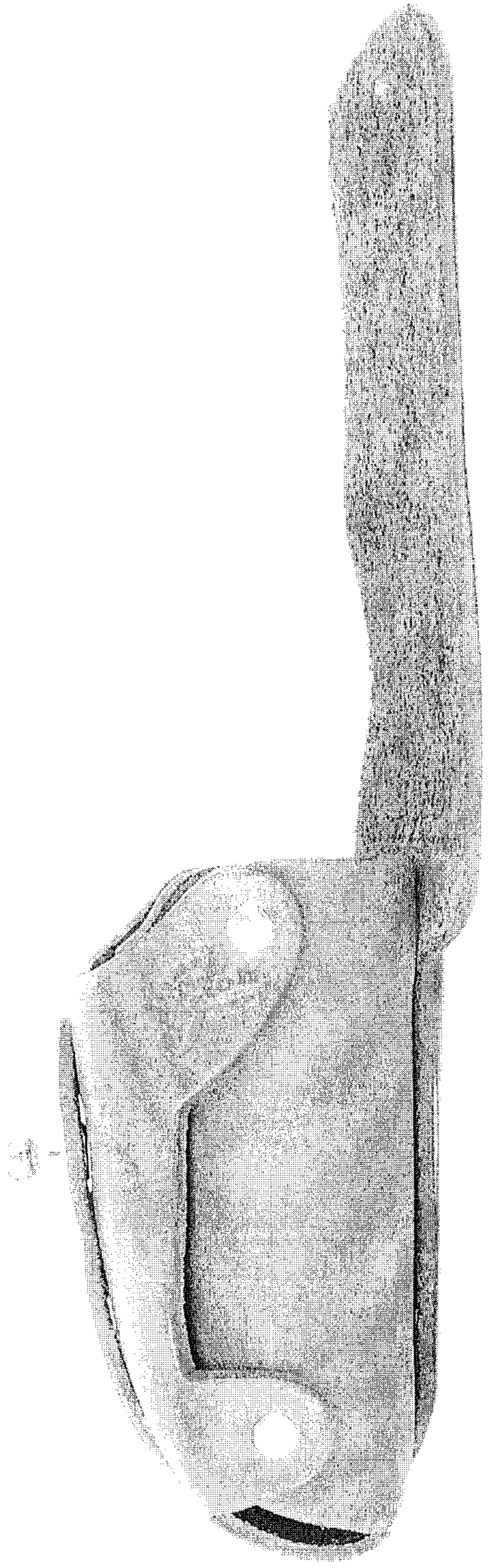


Fig. 9 – Right Side View/Flap
Open

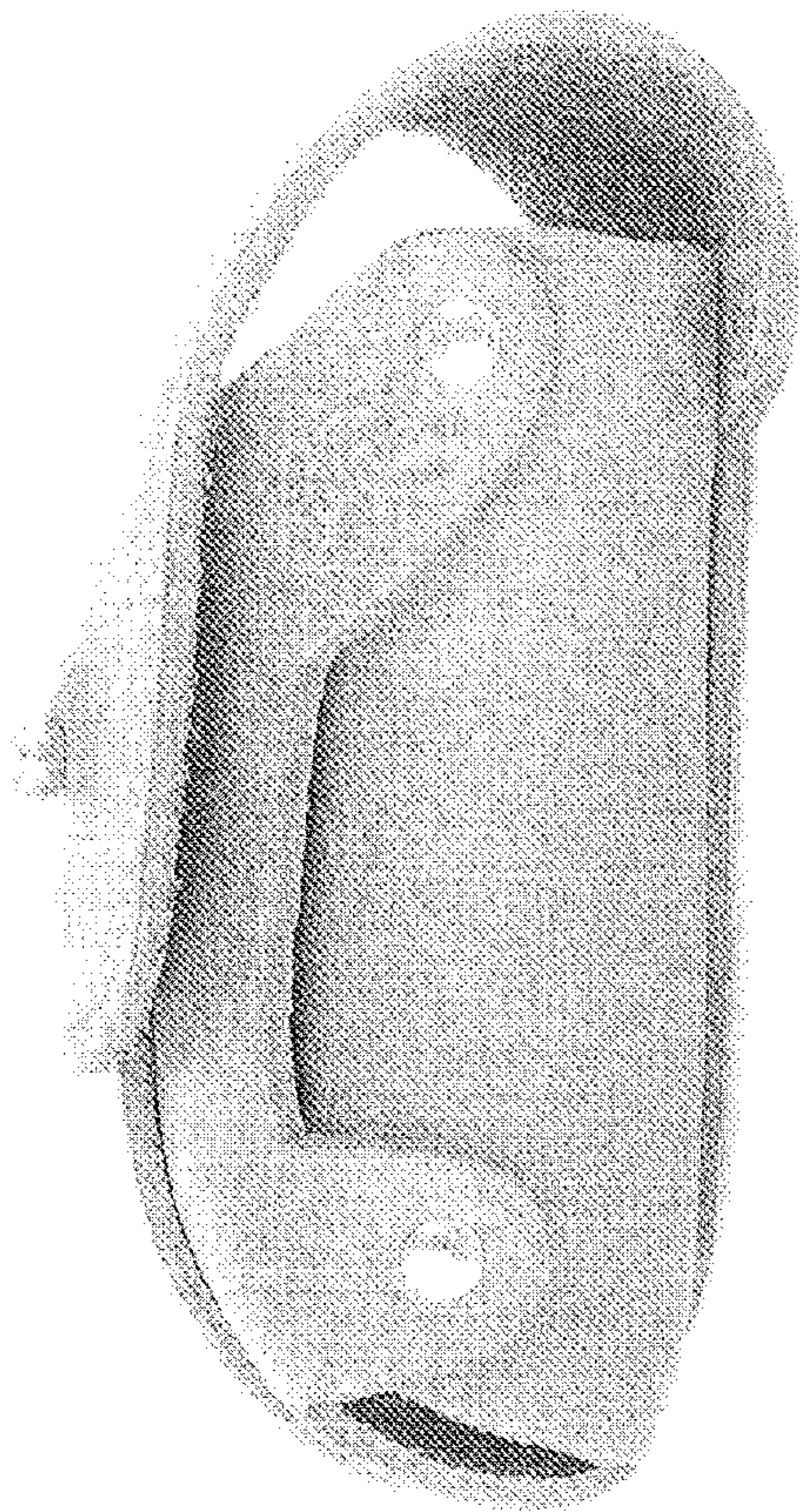


Fig. 10 - Right Side View/
