The ornamental design for a toilet brush, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a toilet brush which embodies the design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

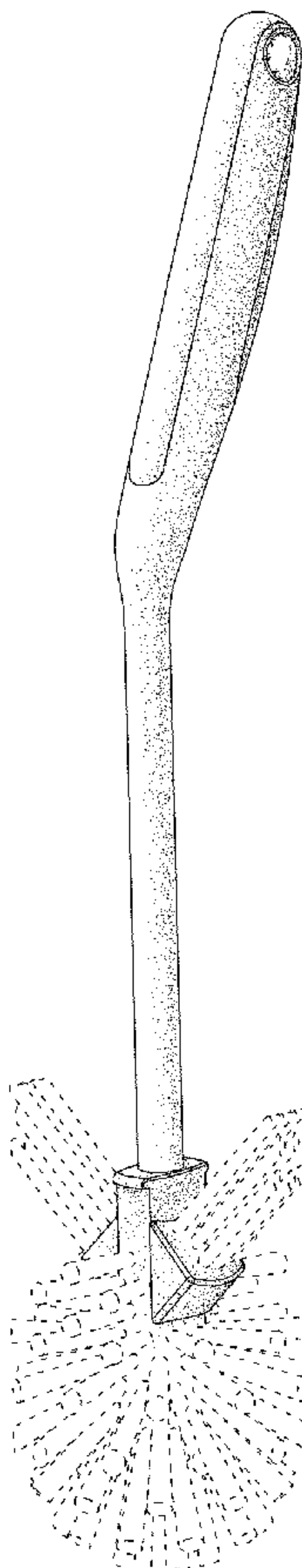
FIG. 4 is a right side view thereof; the left side view thereof being a mirror image of the right side view thereof;

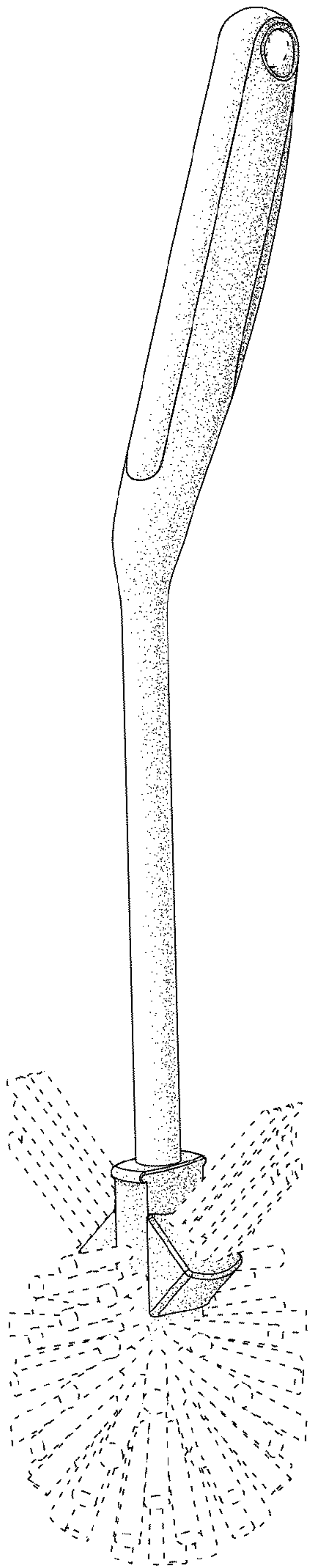

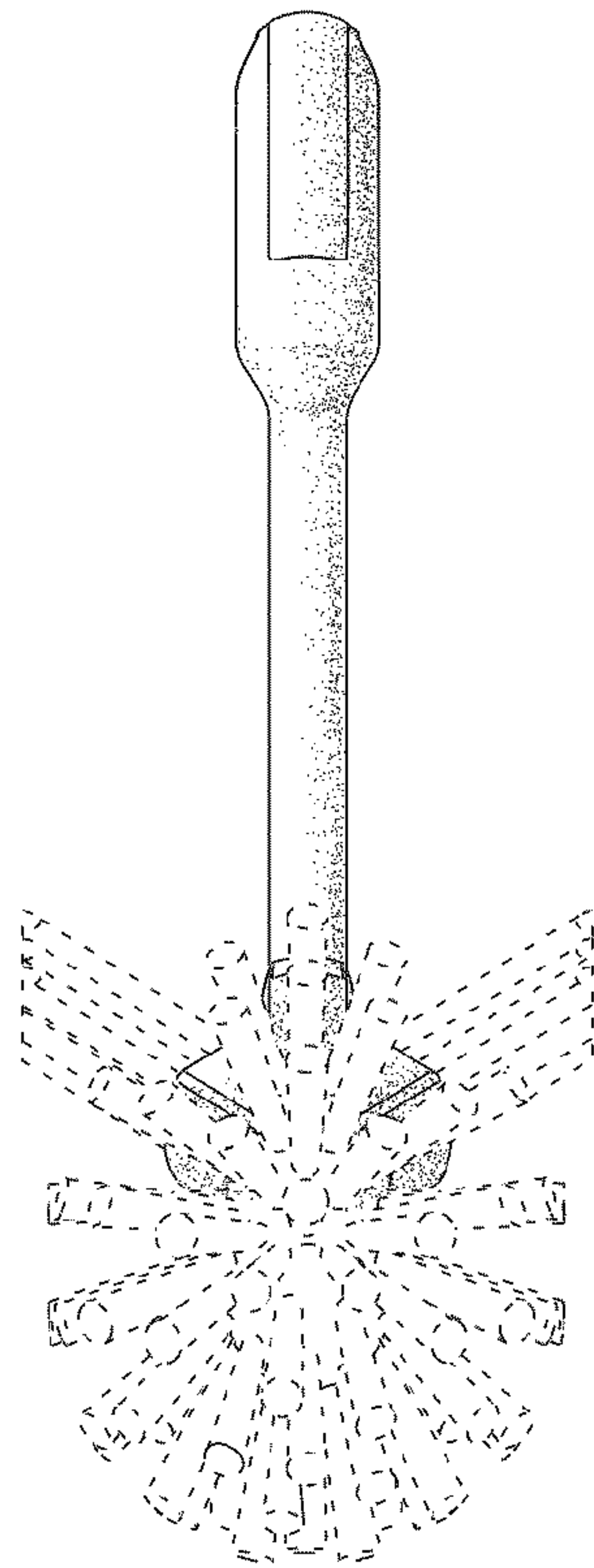

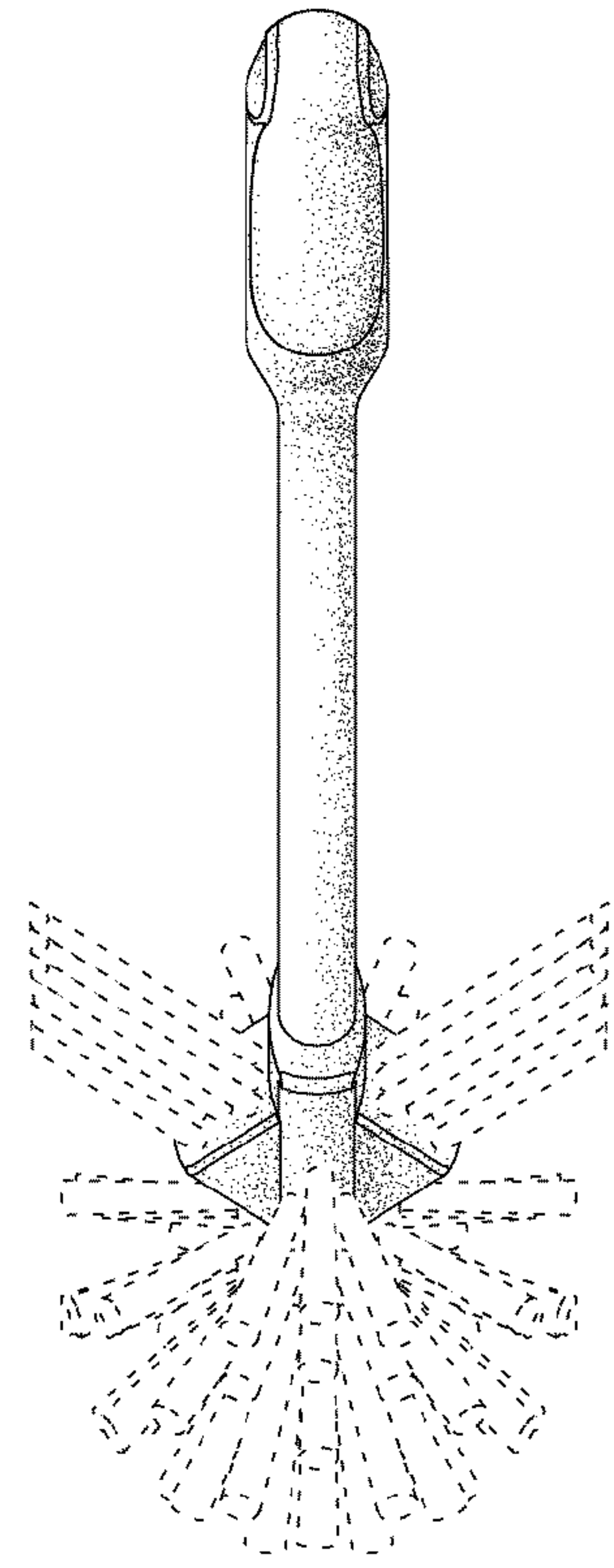

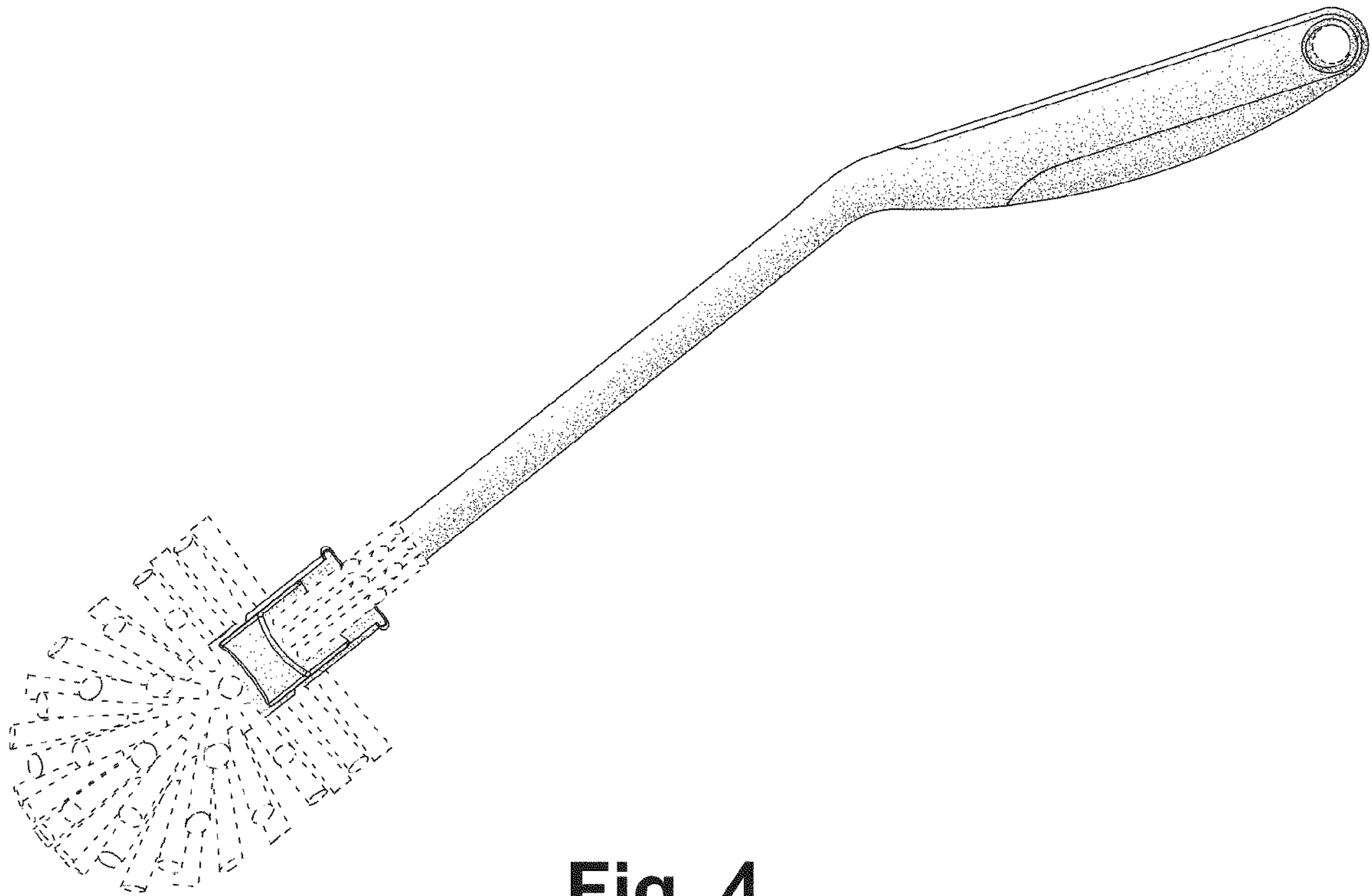

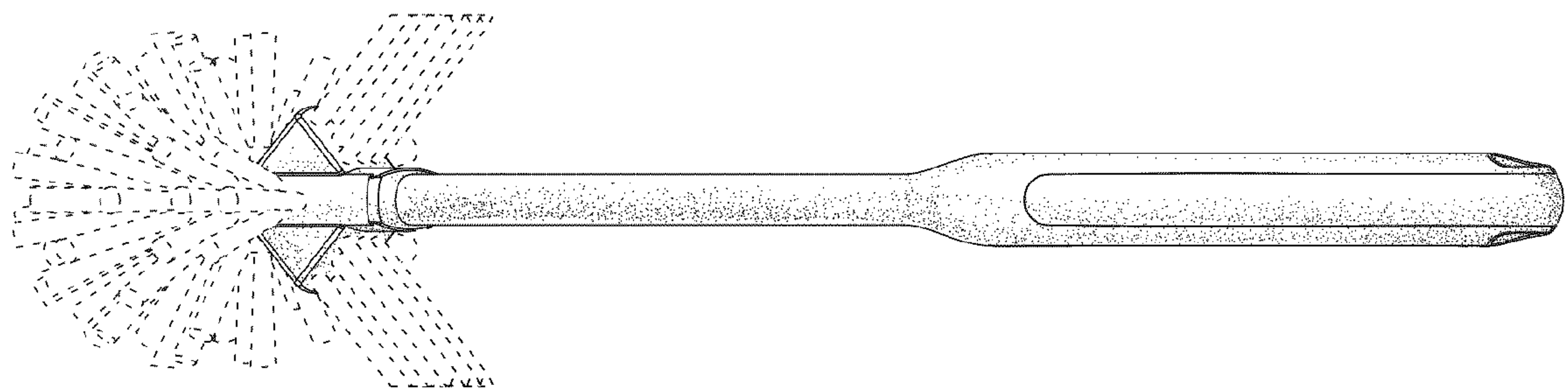

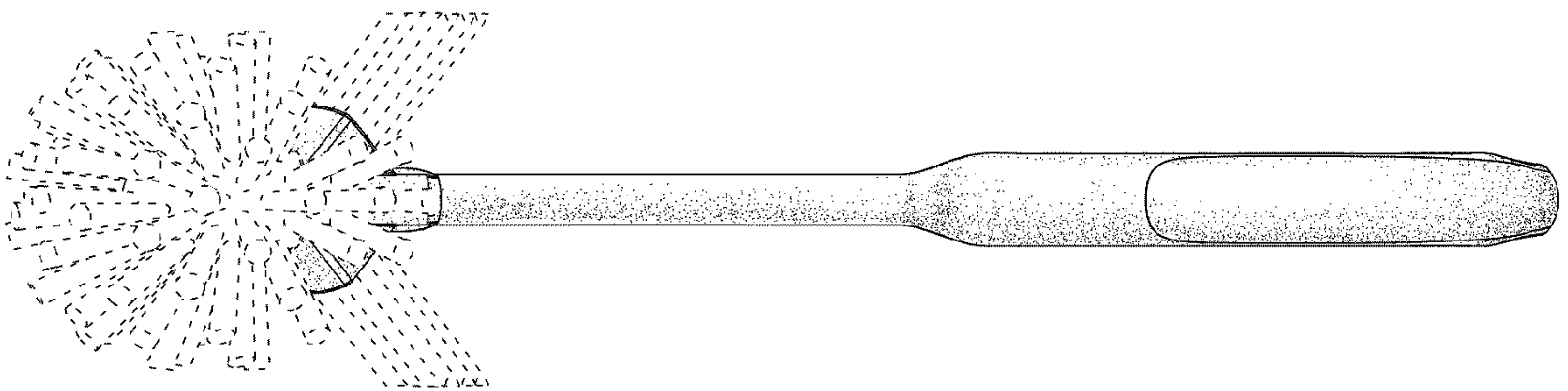
