(57) **CLAIM**

The ornamental design for a rotisserie flamberge, as shown and described.

DESCRIPTION

FIG. 1 is a bottom, side perspective view of a rotisserie flamberge according to an embodiment of the present invention;

FIG. 2 is a side perspective view of the rotisserie flamberge of FIG. 1;

FIG. 3 is a bottom perspective view of the rotisserie flamberge of FIG. 1;

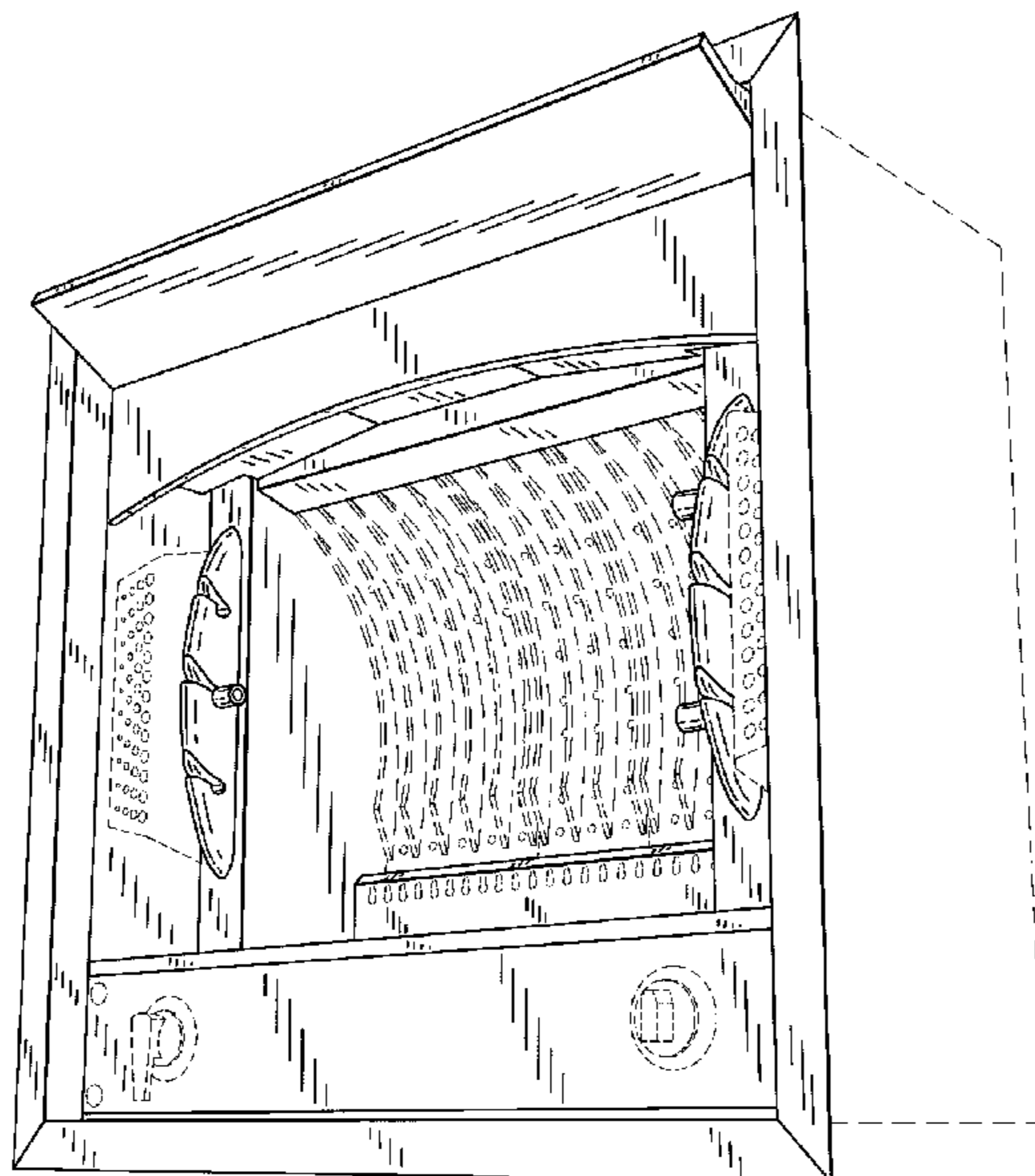
FIG. 4 is a front view of the rotisserie flamberge of FIG. 1;

FIG. 5 is a top perspective view of the rotisserie flamberge of FIG. 1; and,

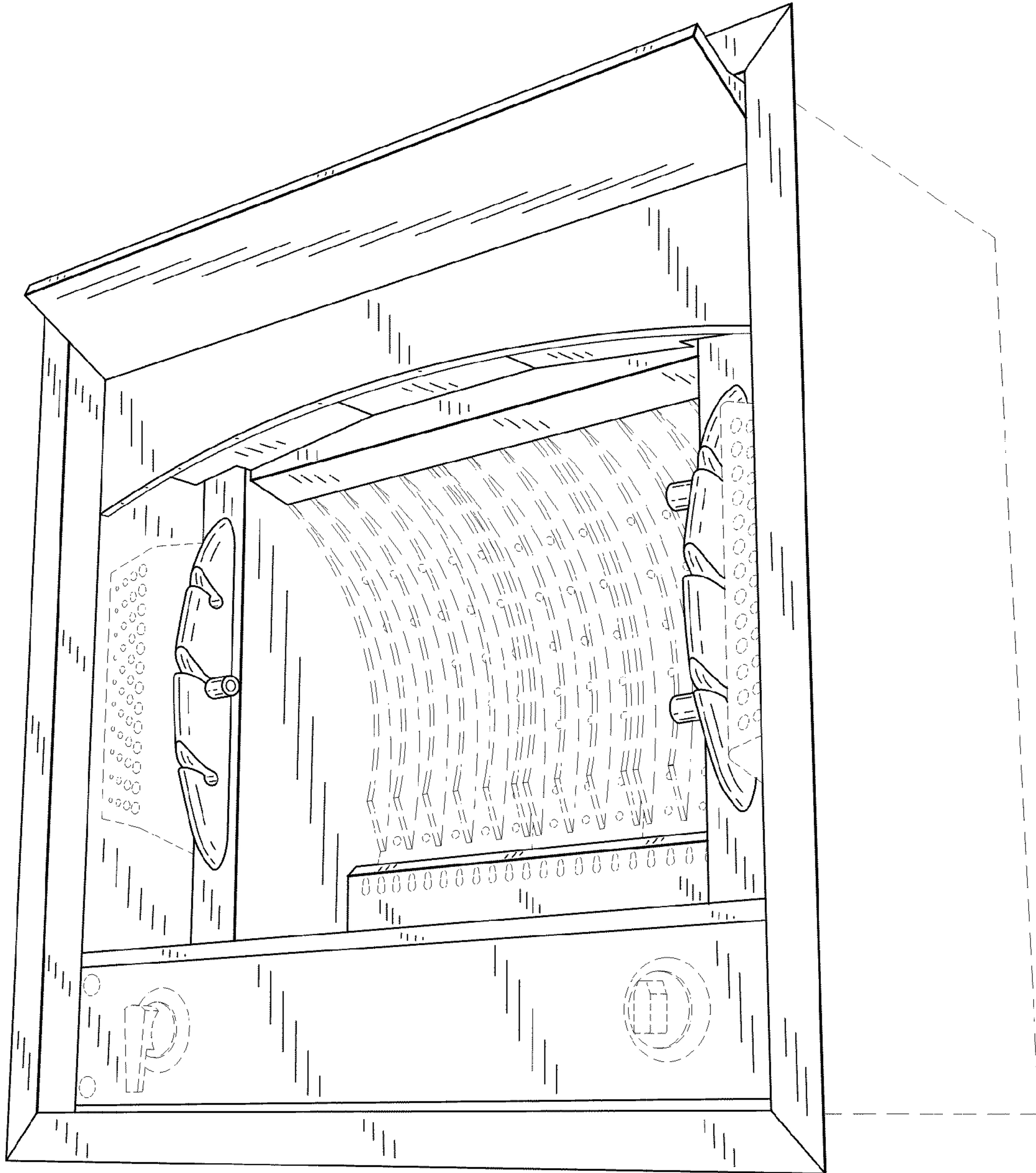

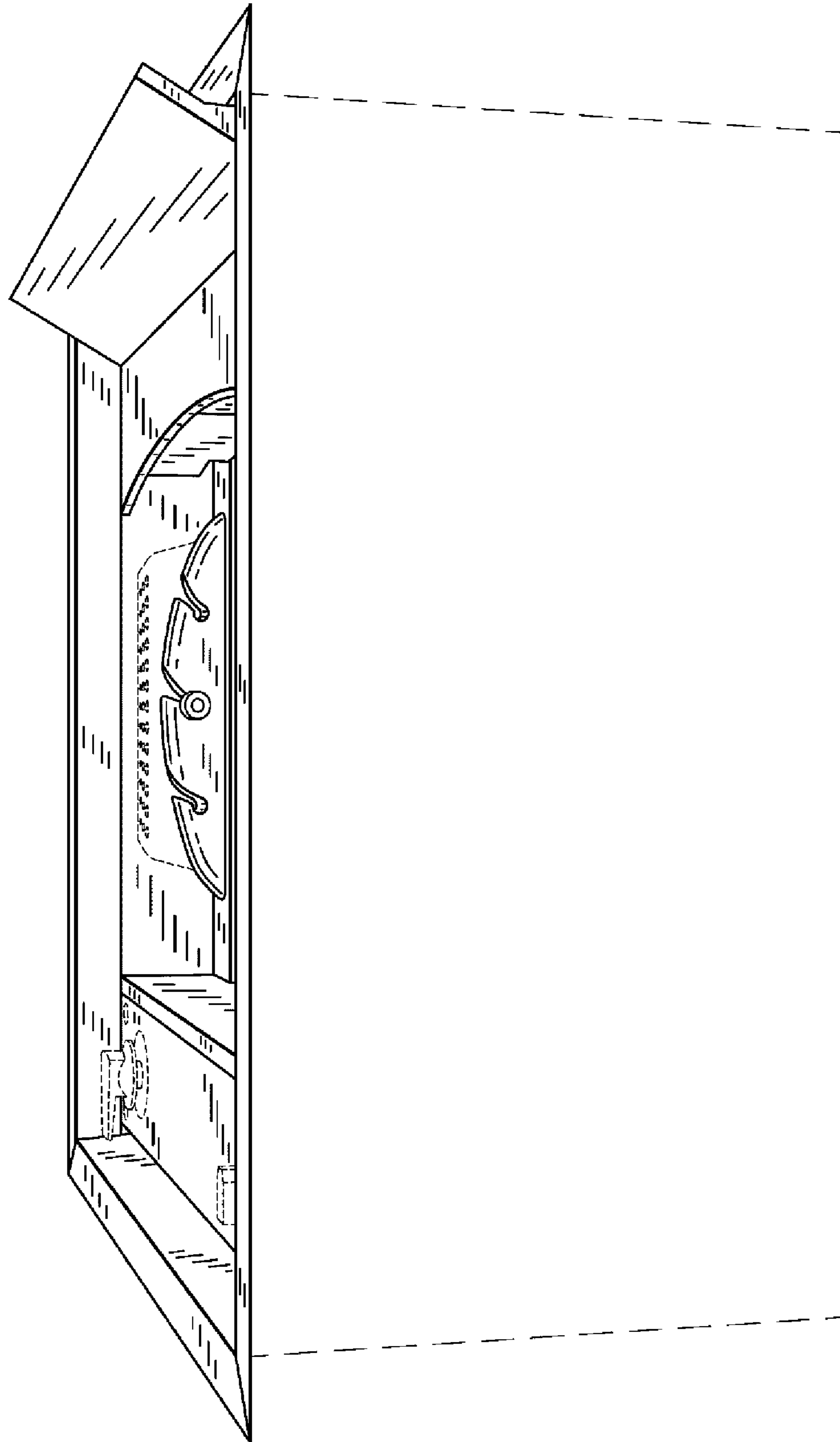

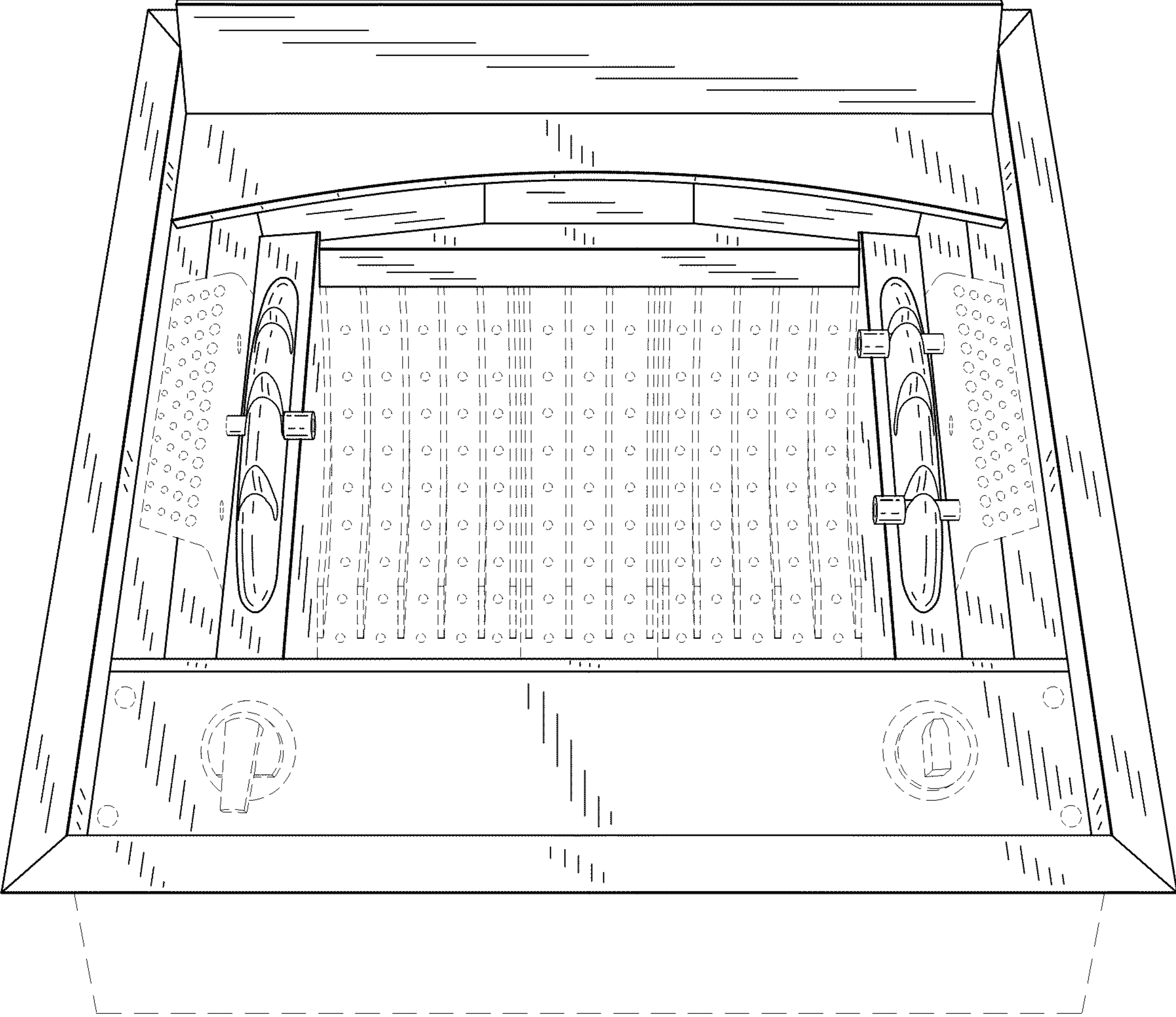

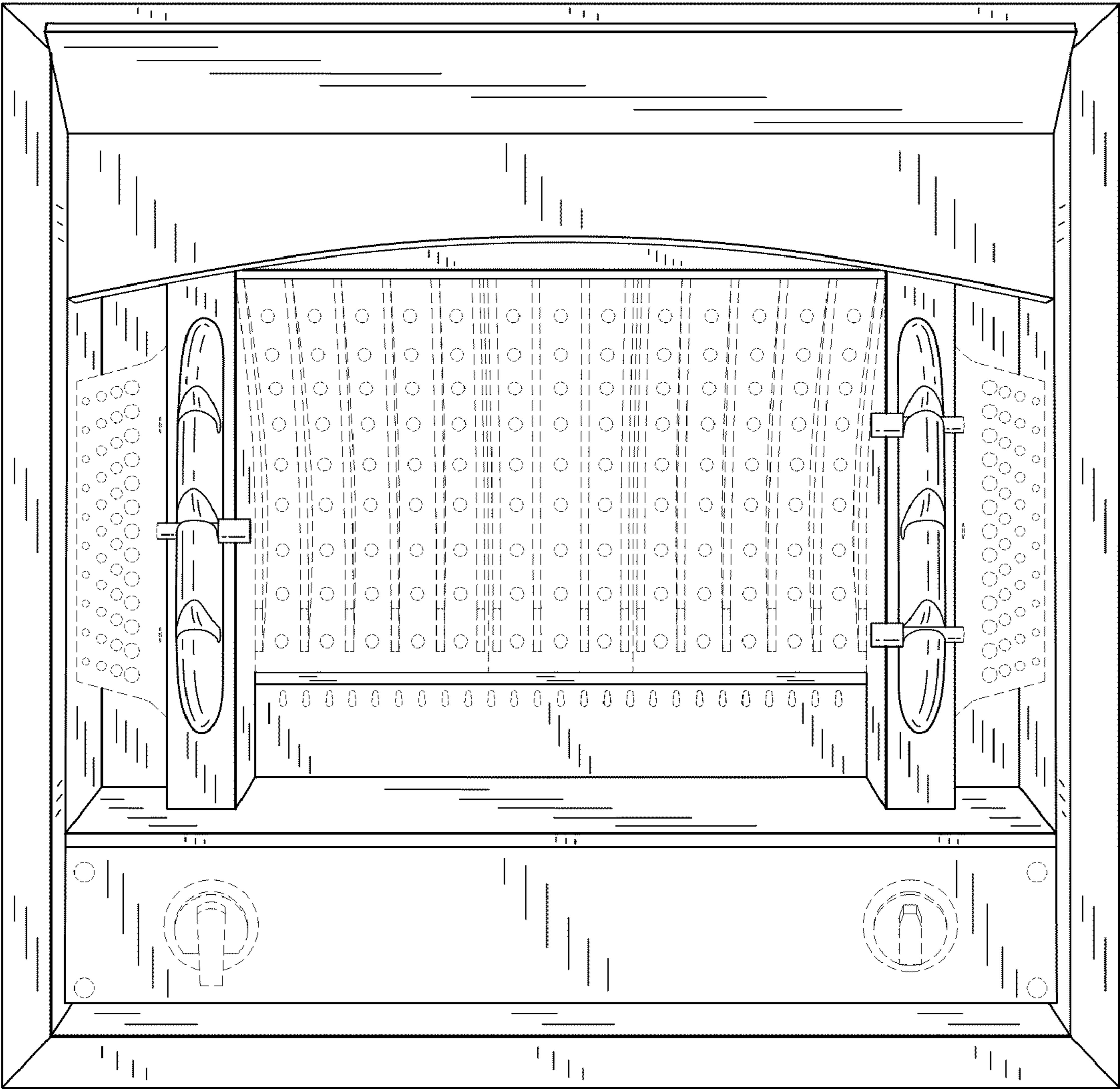

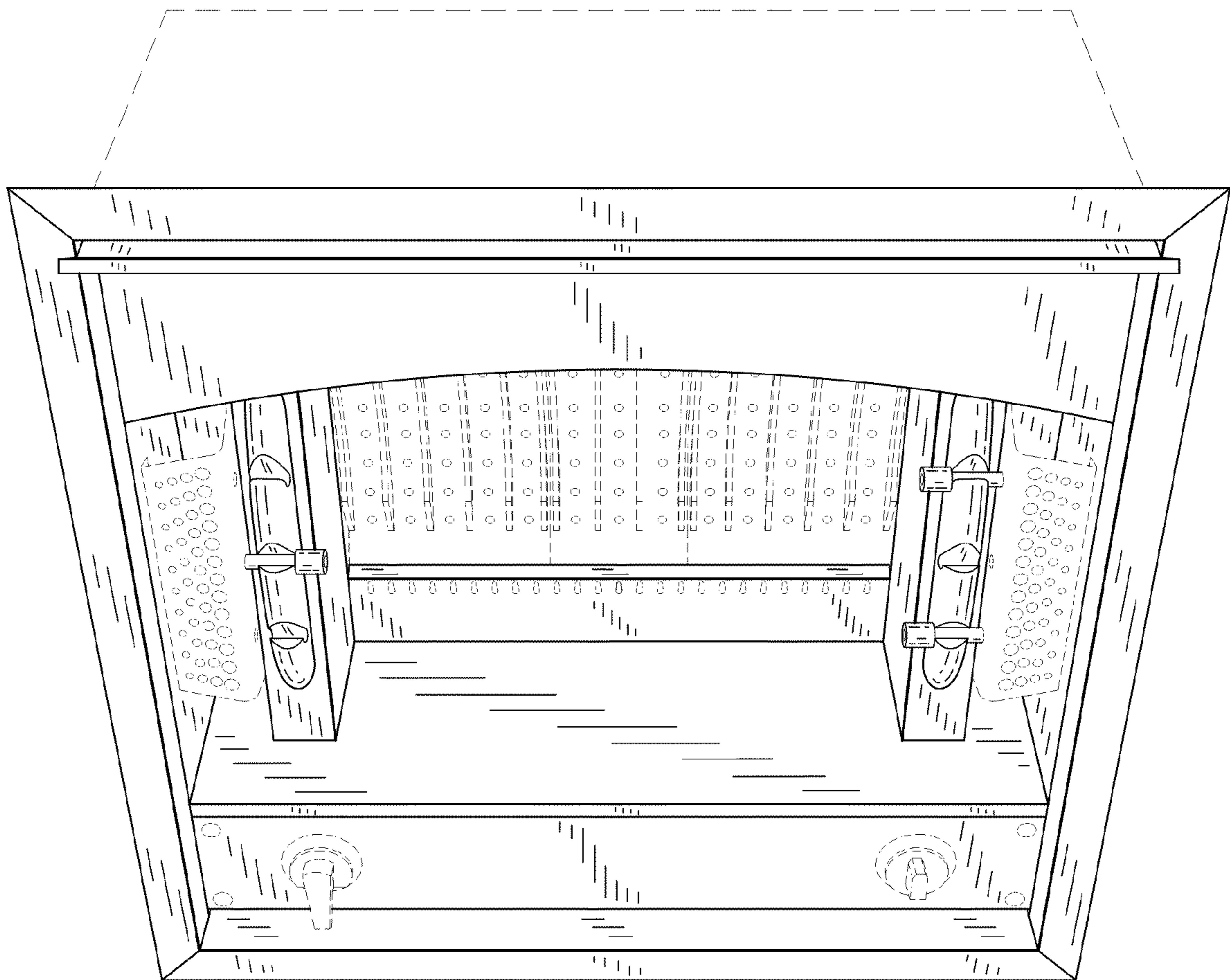

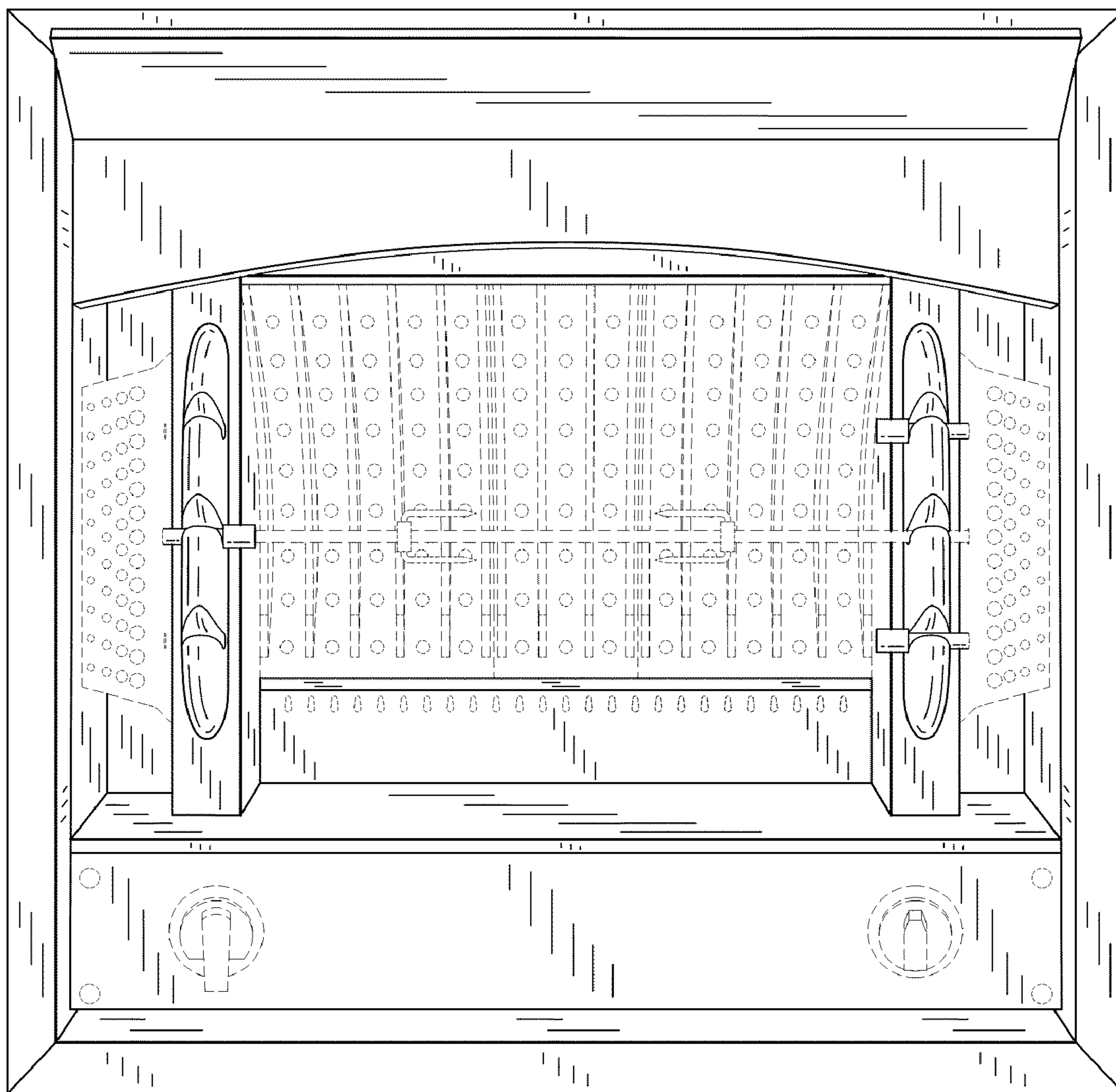
