The ornamental design for a portable range, as shown and described.

DESCRIPTION

FIG. 1 is a front/right-side/top perspective view of a portable range showing our new design;

FIG. 2 is a front-side elevational view thereof;

FIG. 3 is a rear-side elevational view thereof;

FIG. 4 is a left-side elevational view thereof;

FIG. 5 is a right-side elevational view thereof;

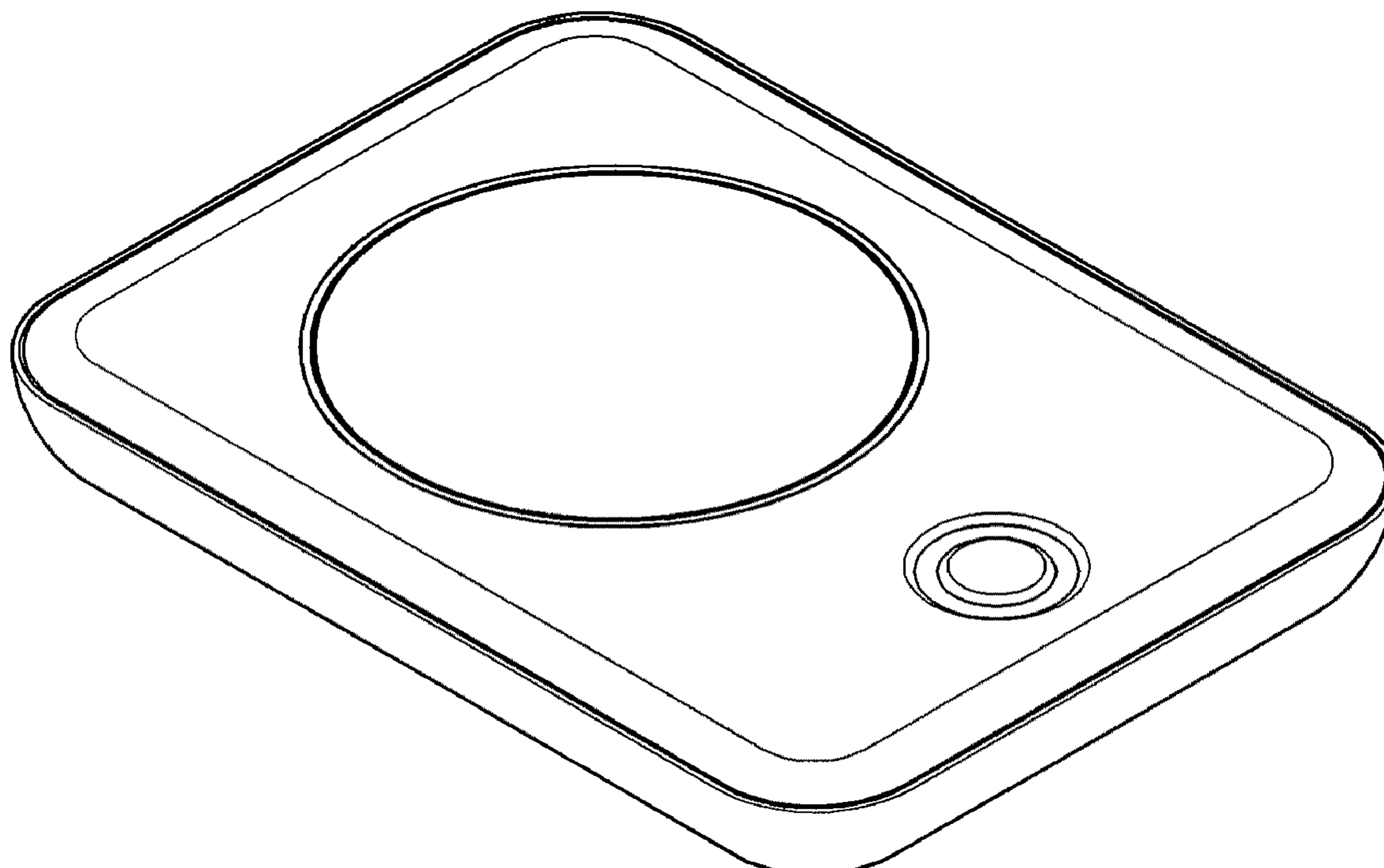

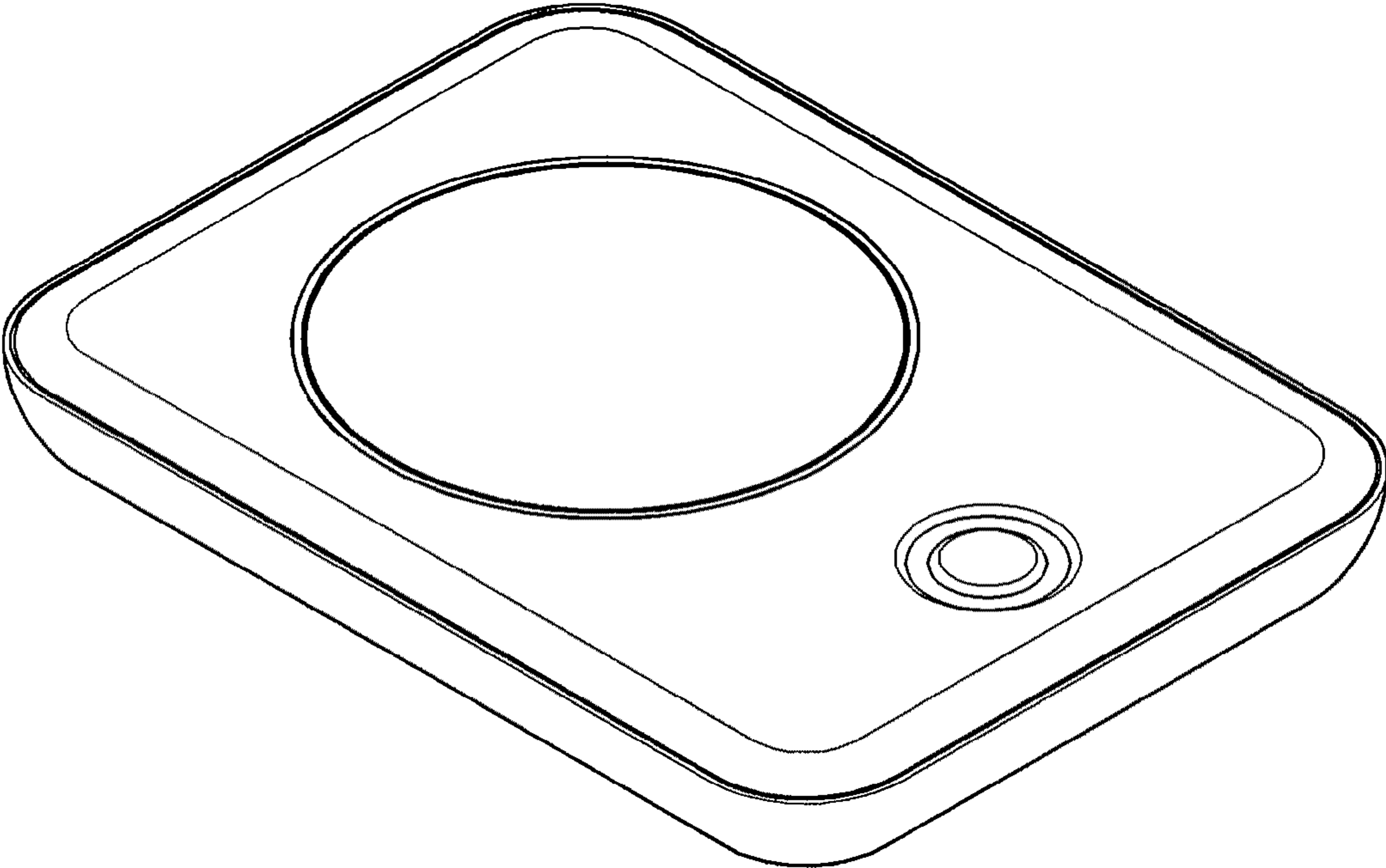

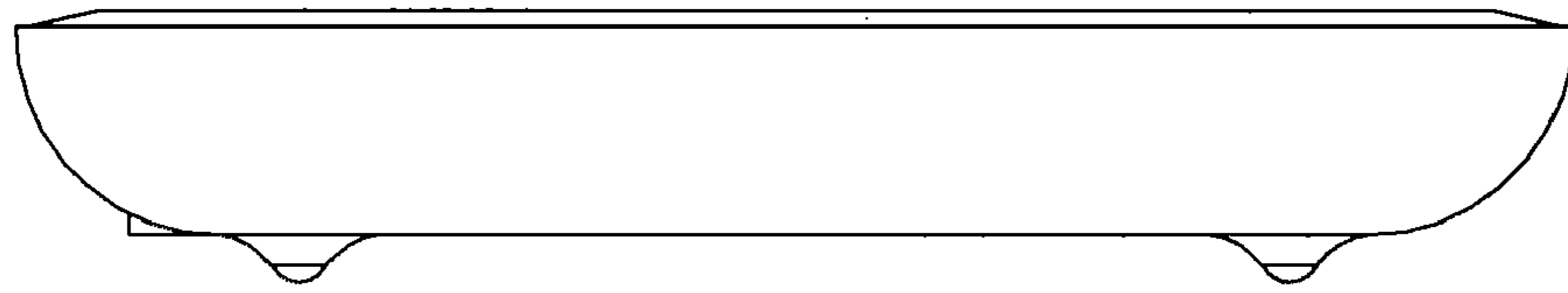

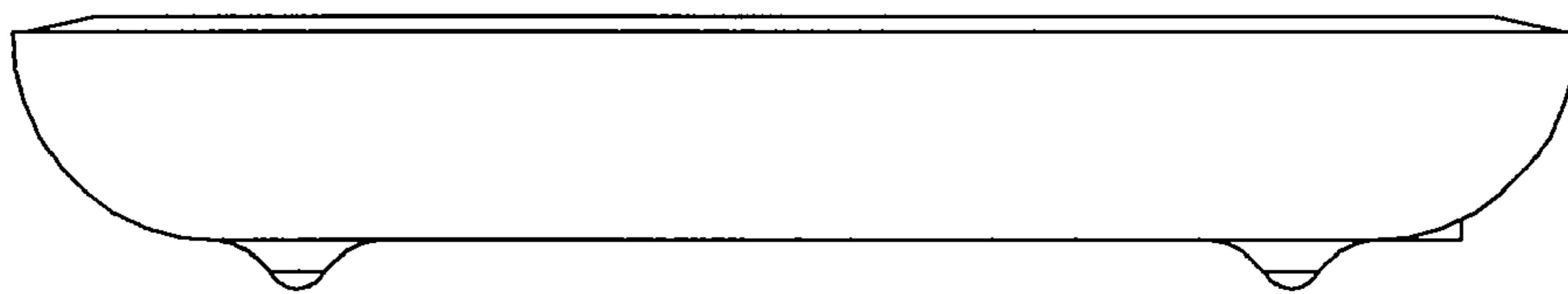

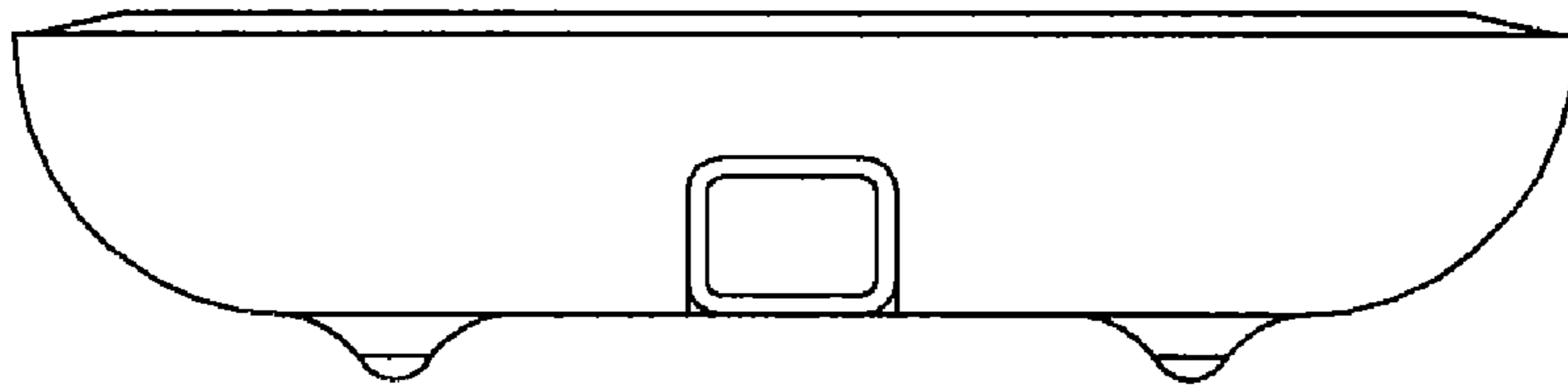

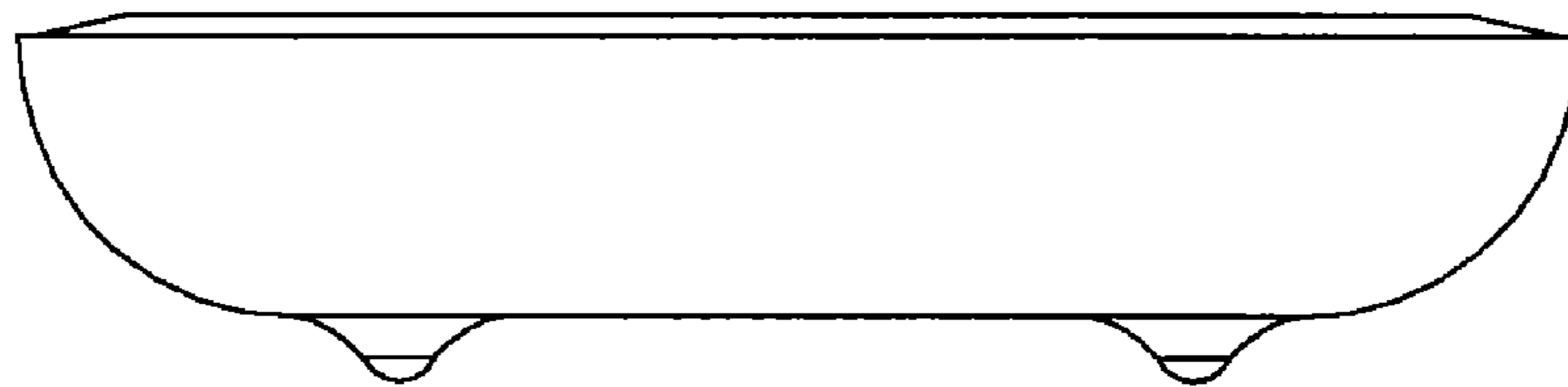

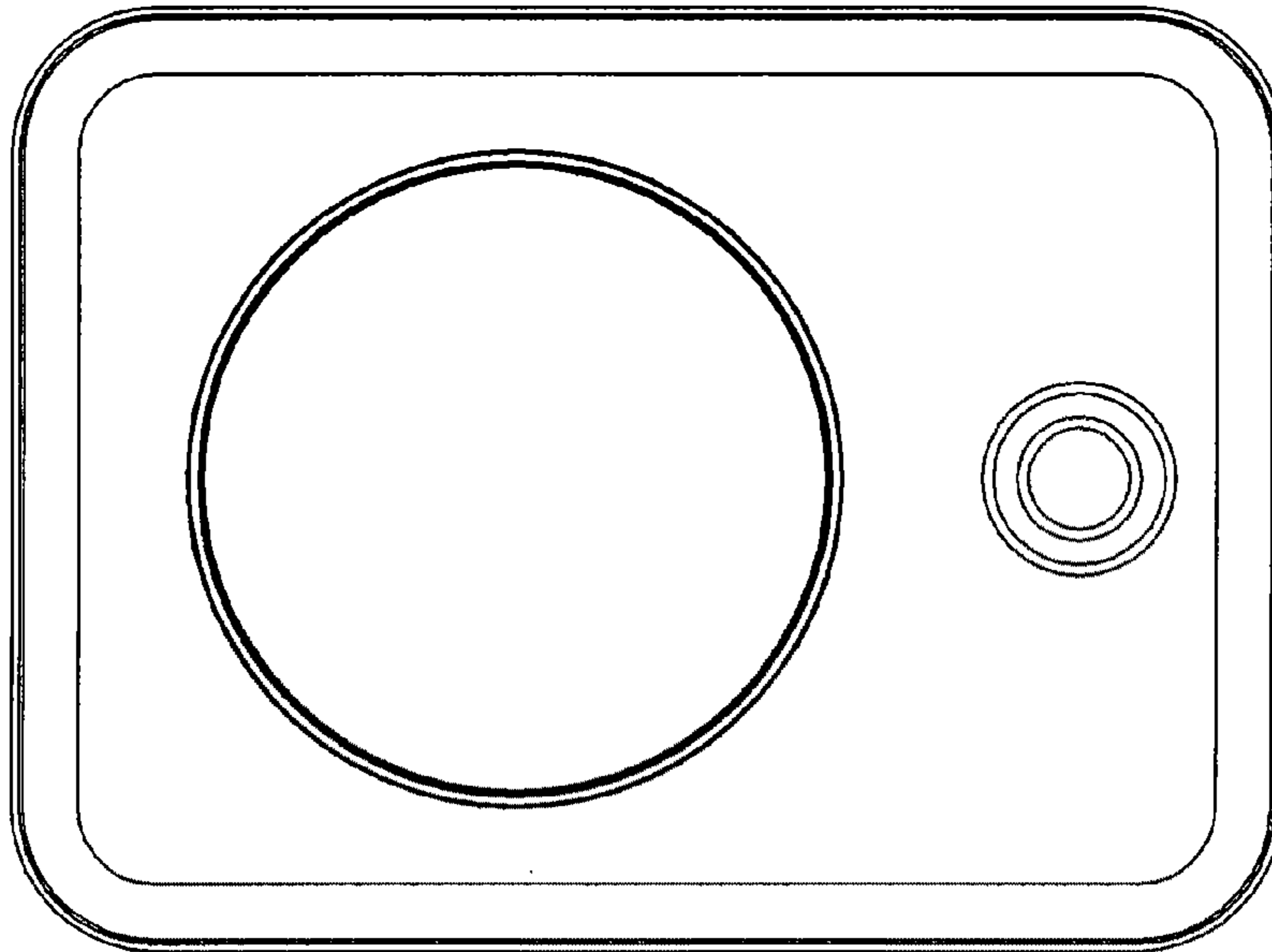
