The ornamental design for a drink cup thermal protection sleeve, as shown and described.

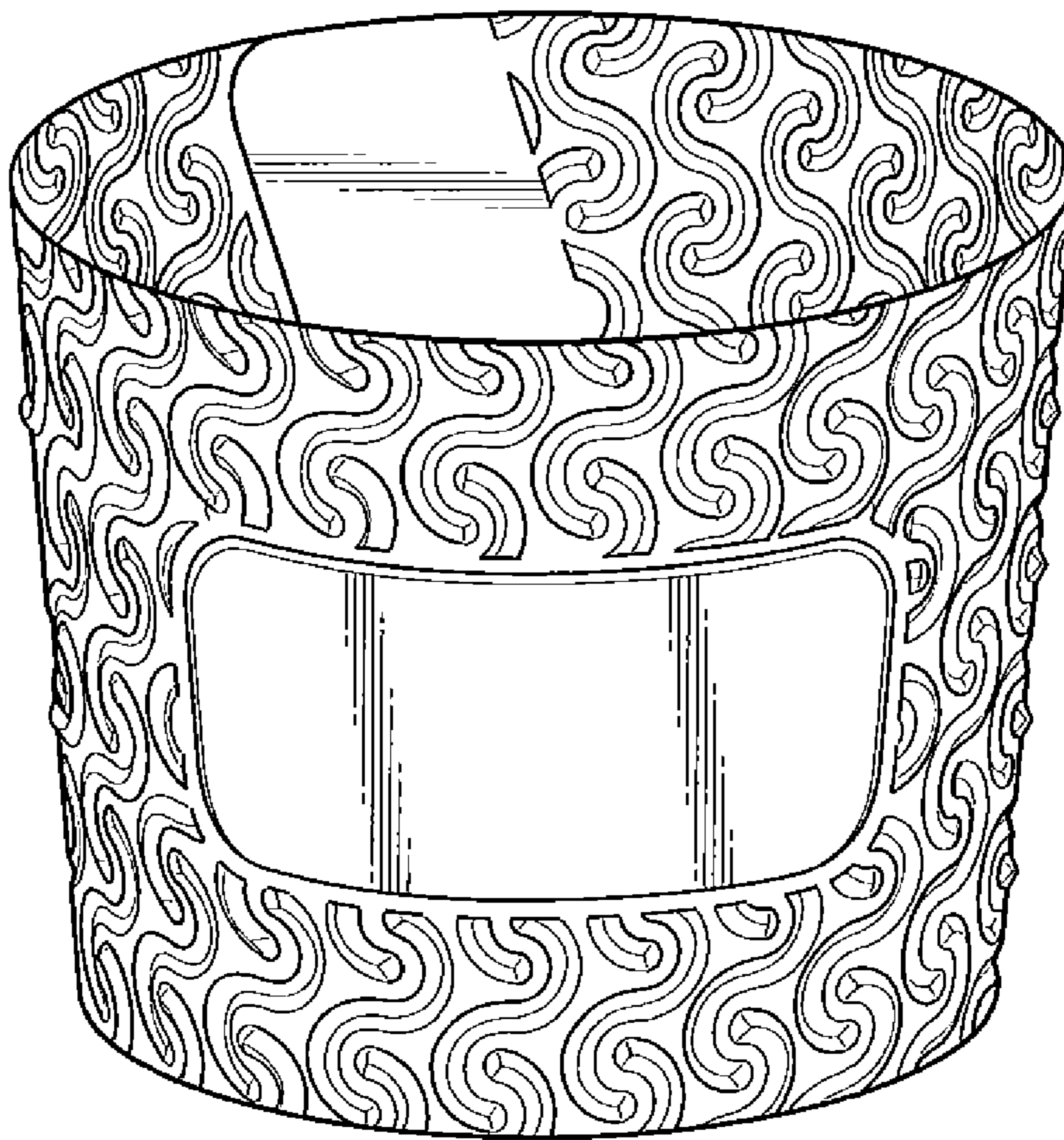

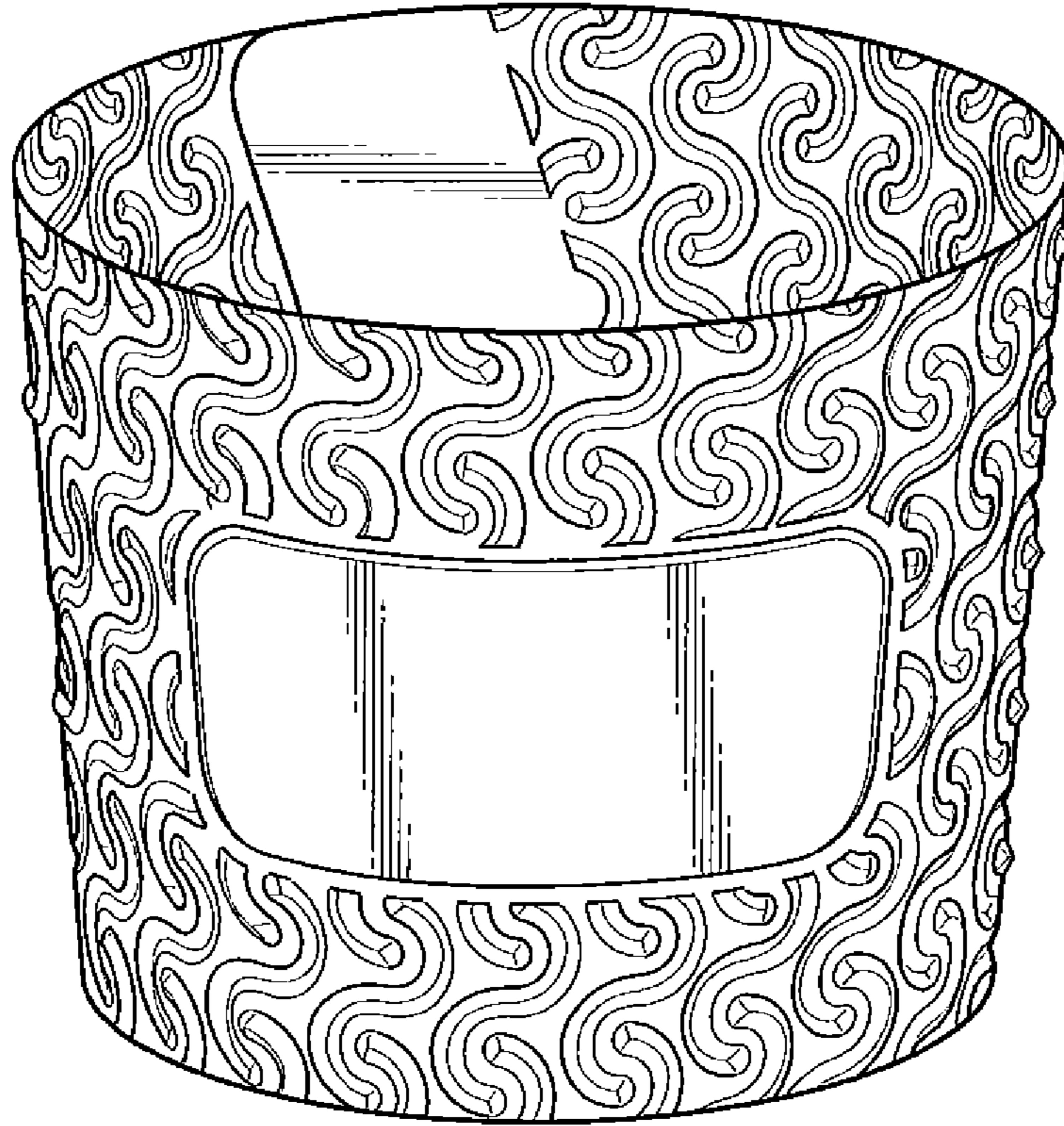
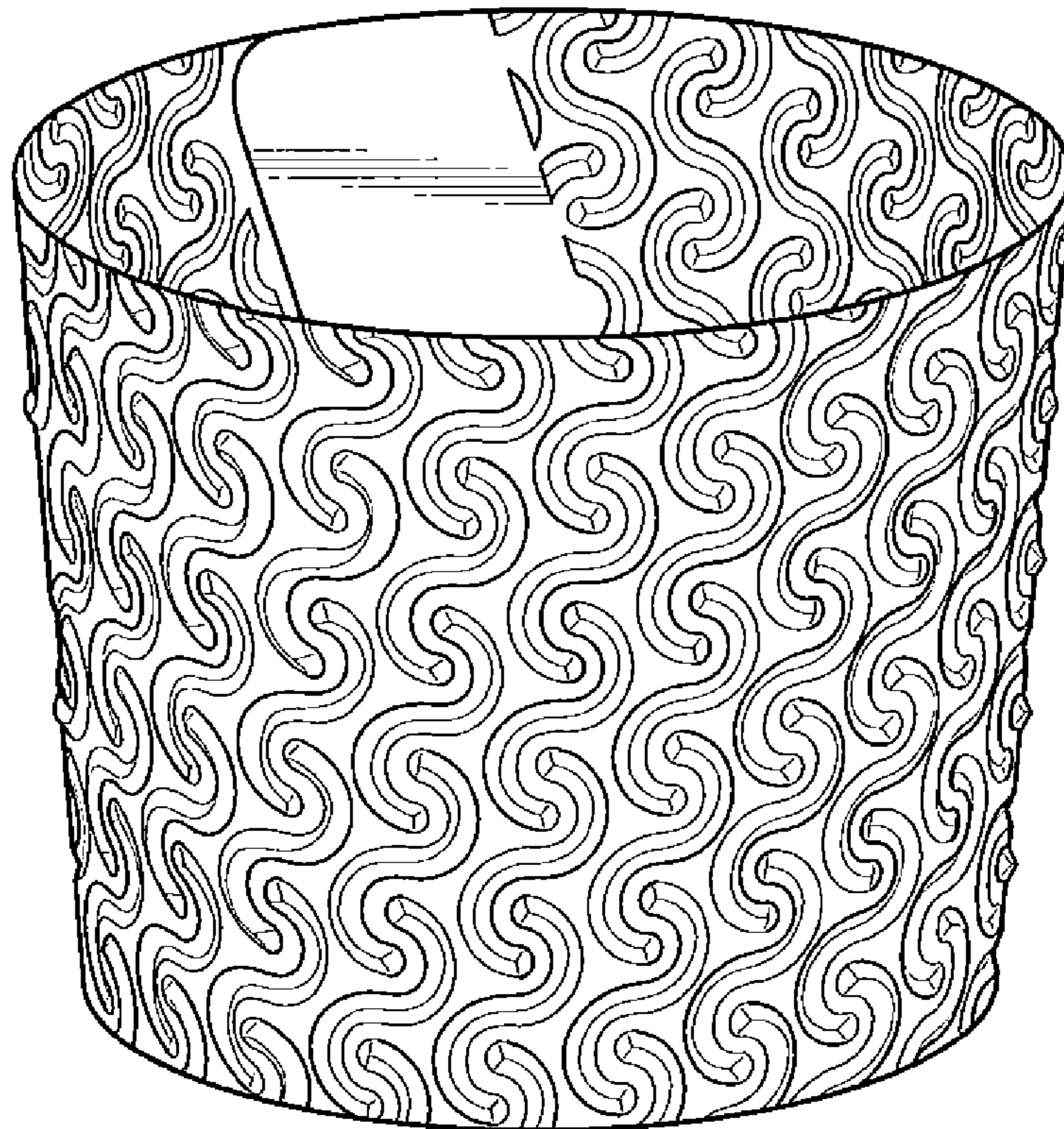

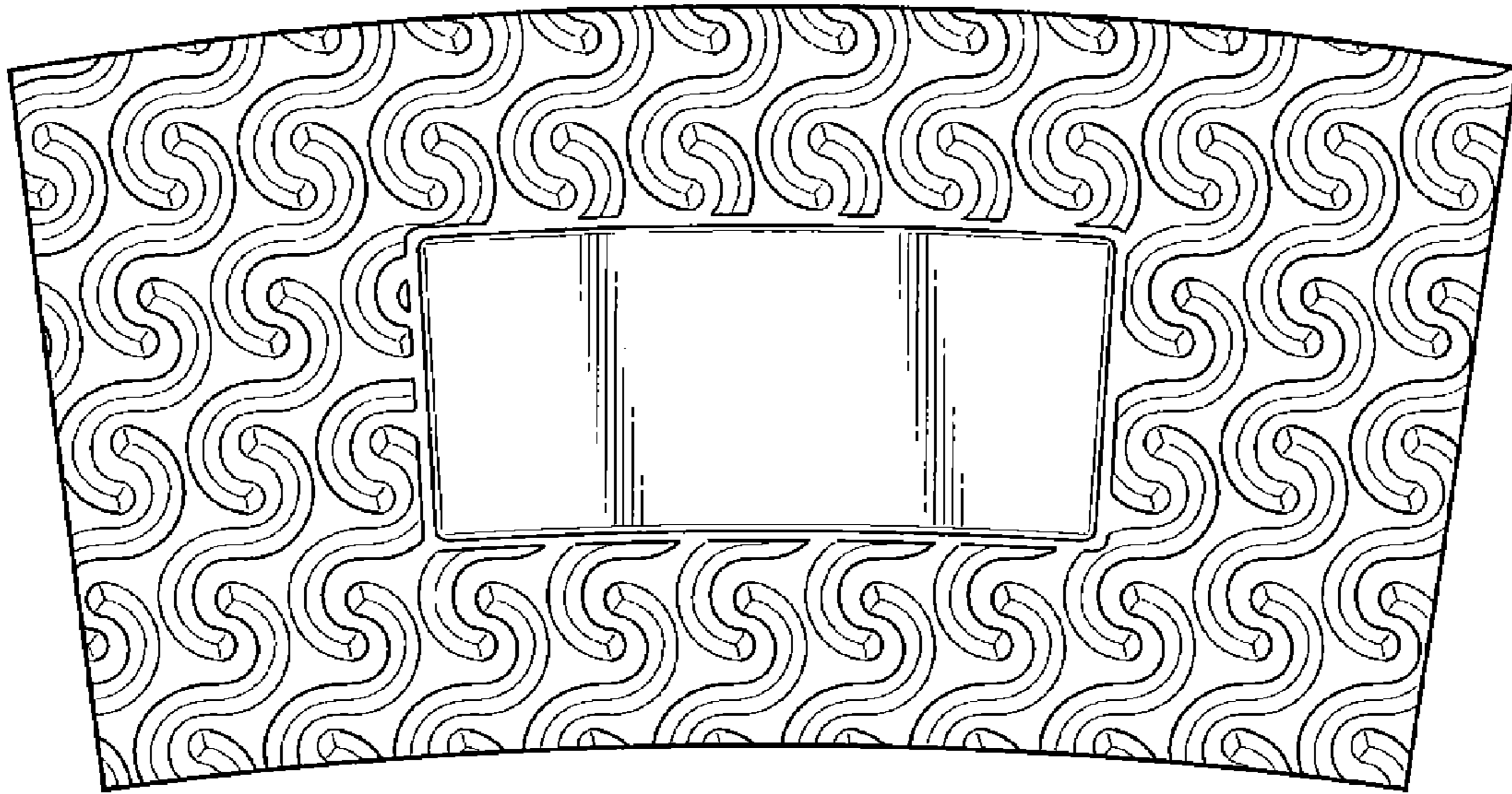

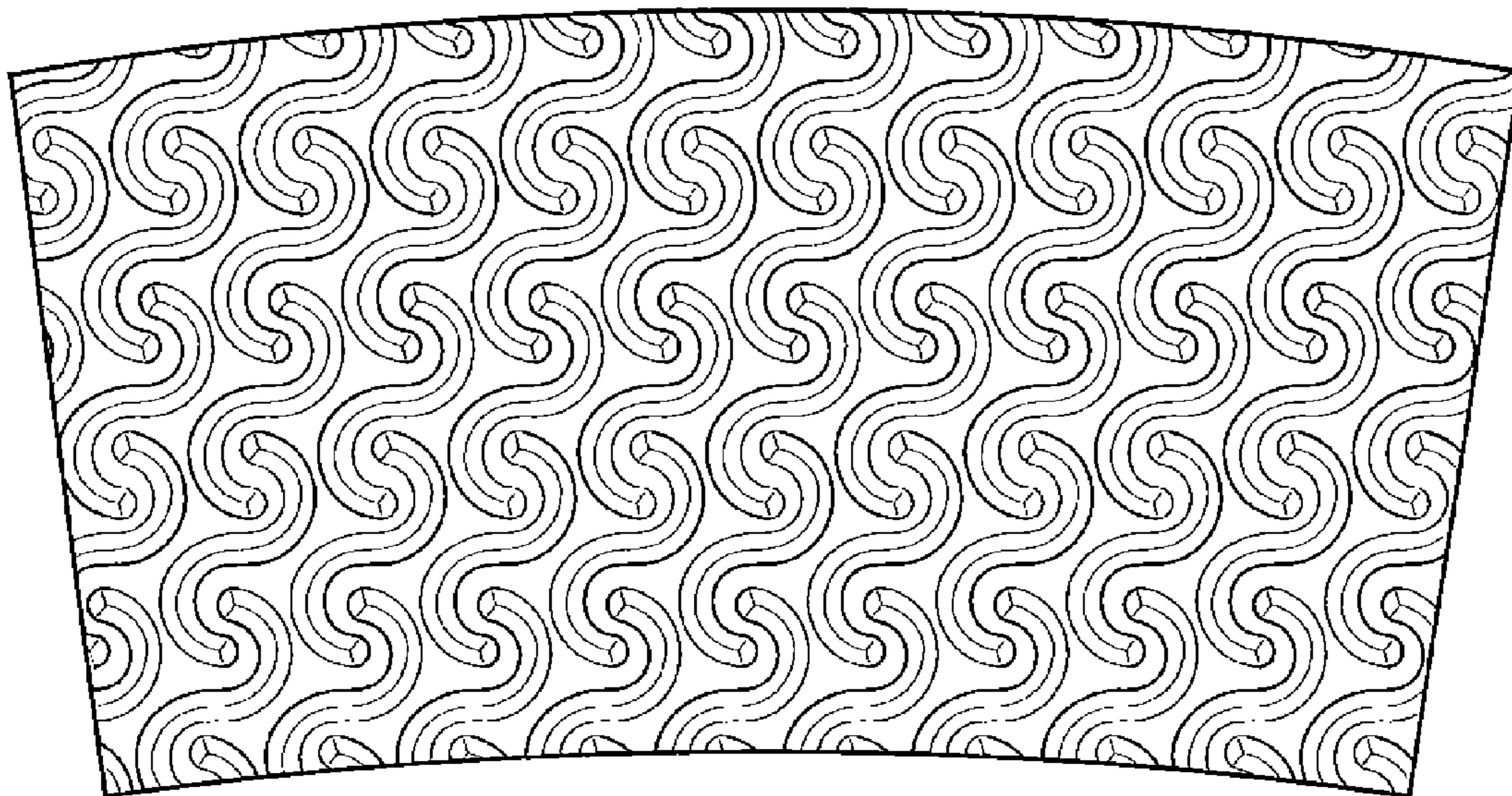

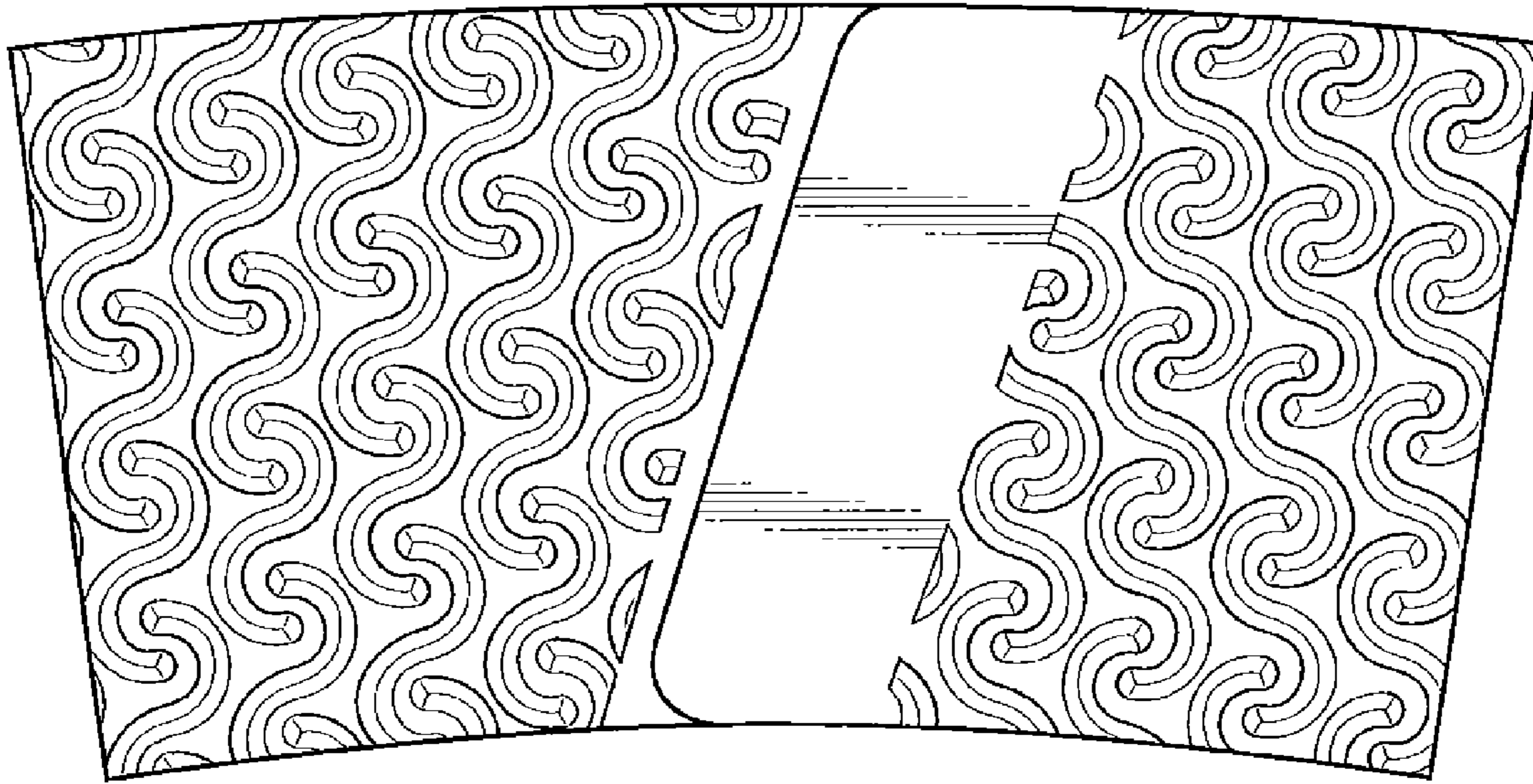
