**DESCRIPTION**

FIG. 1 is a front perspective view of a clip showing my new design;

FIG. 7 is right side elevational view thereof;

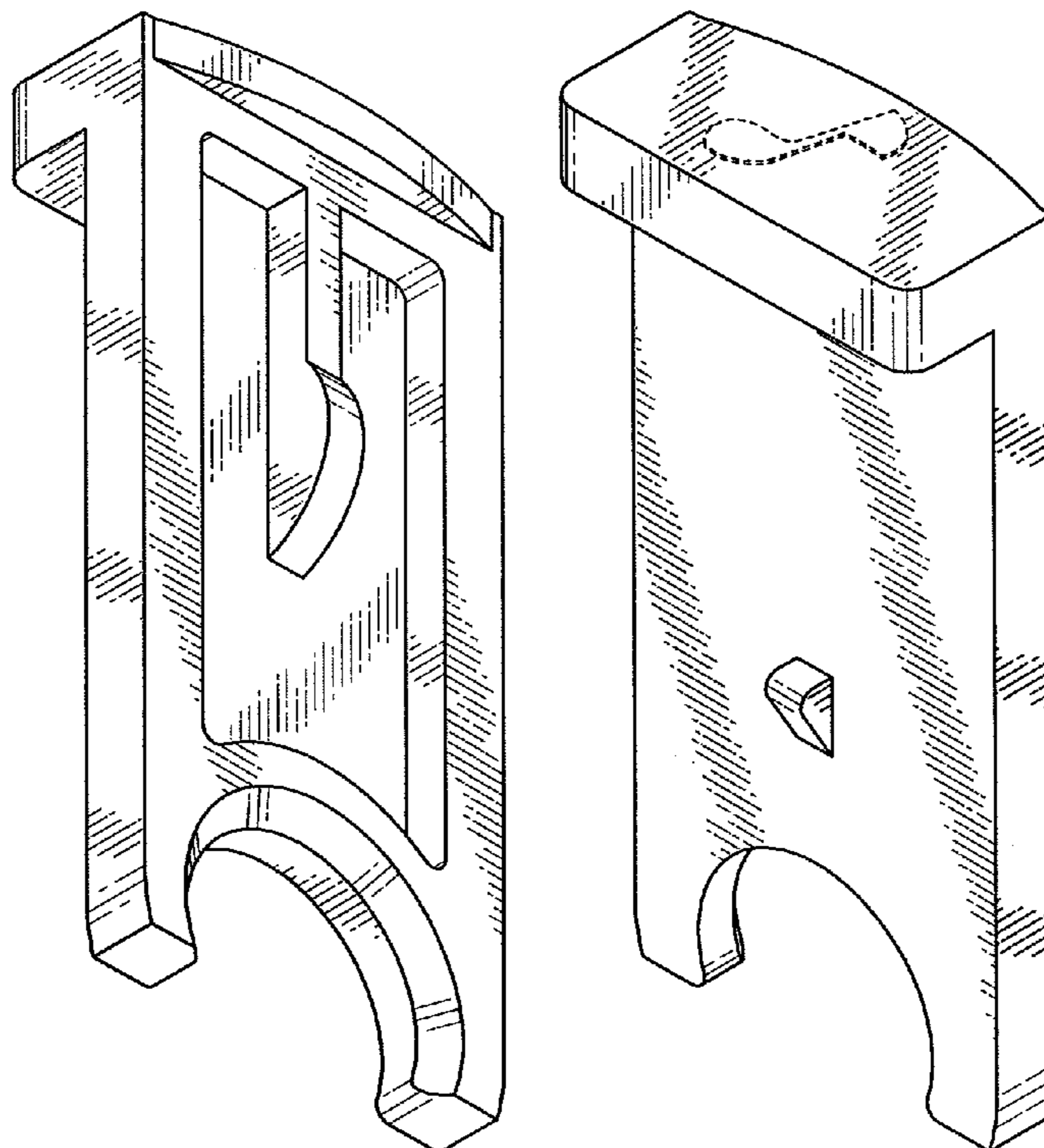
FIG. 8 is left side elevational view thereof;

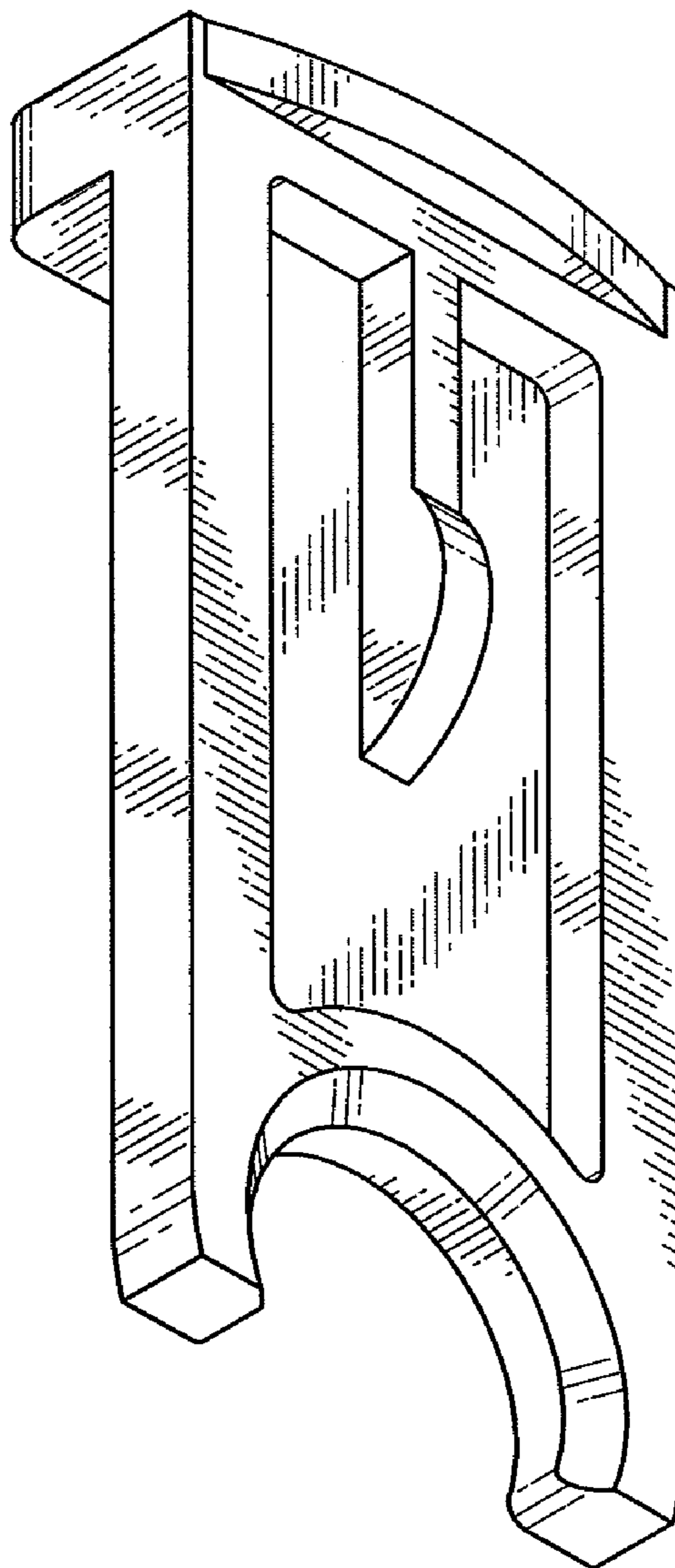

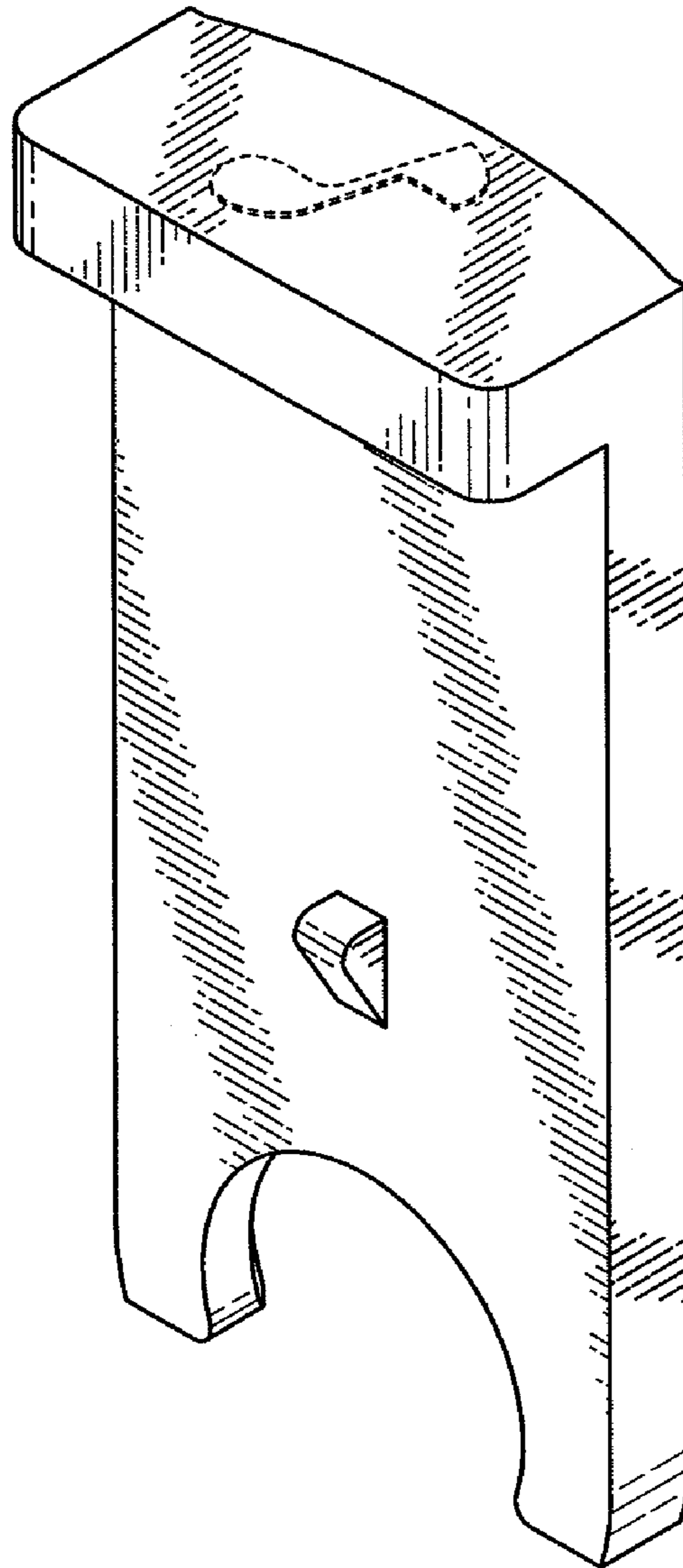

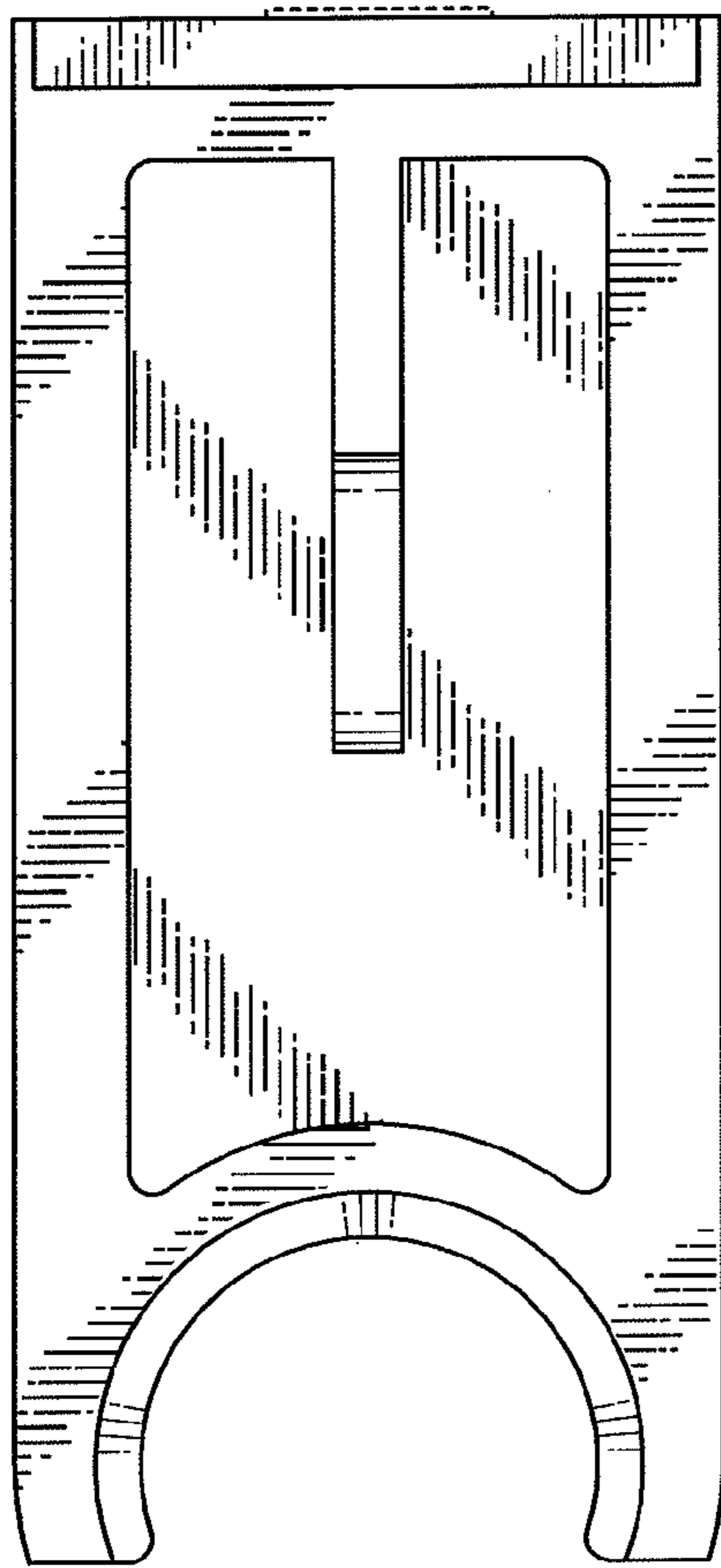

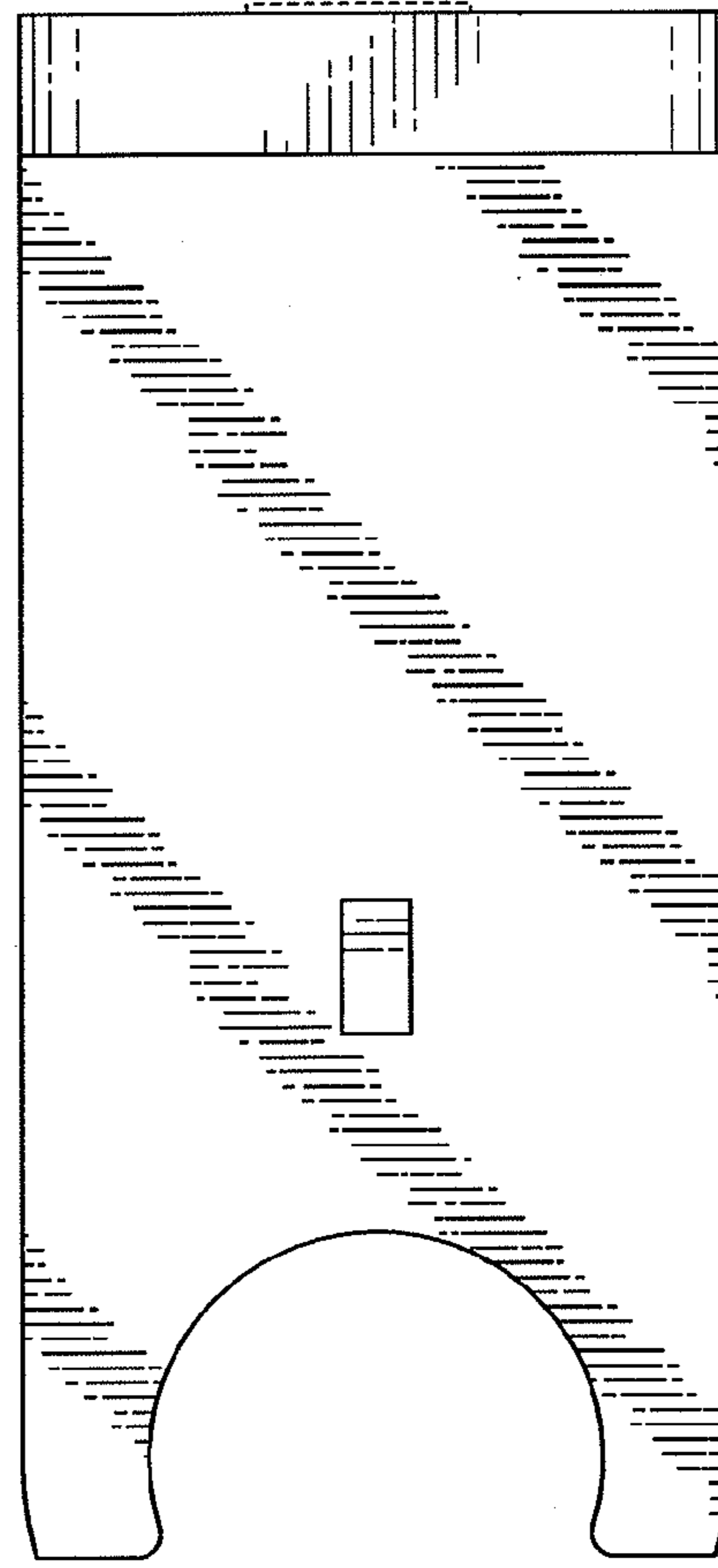

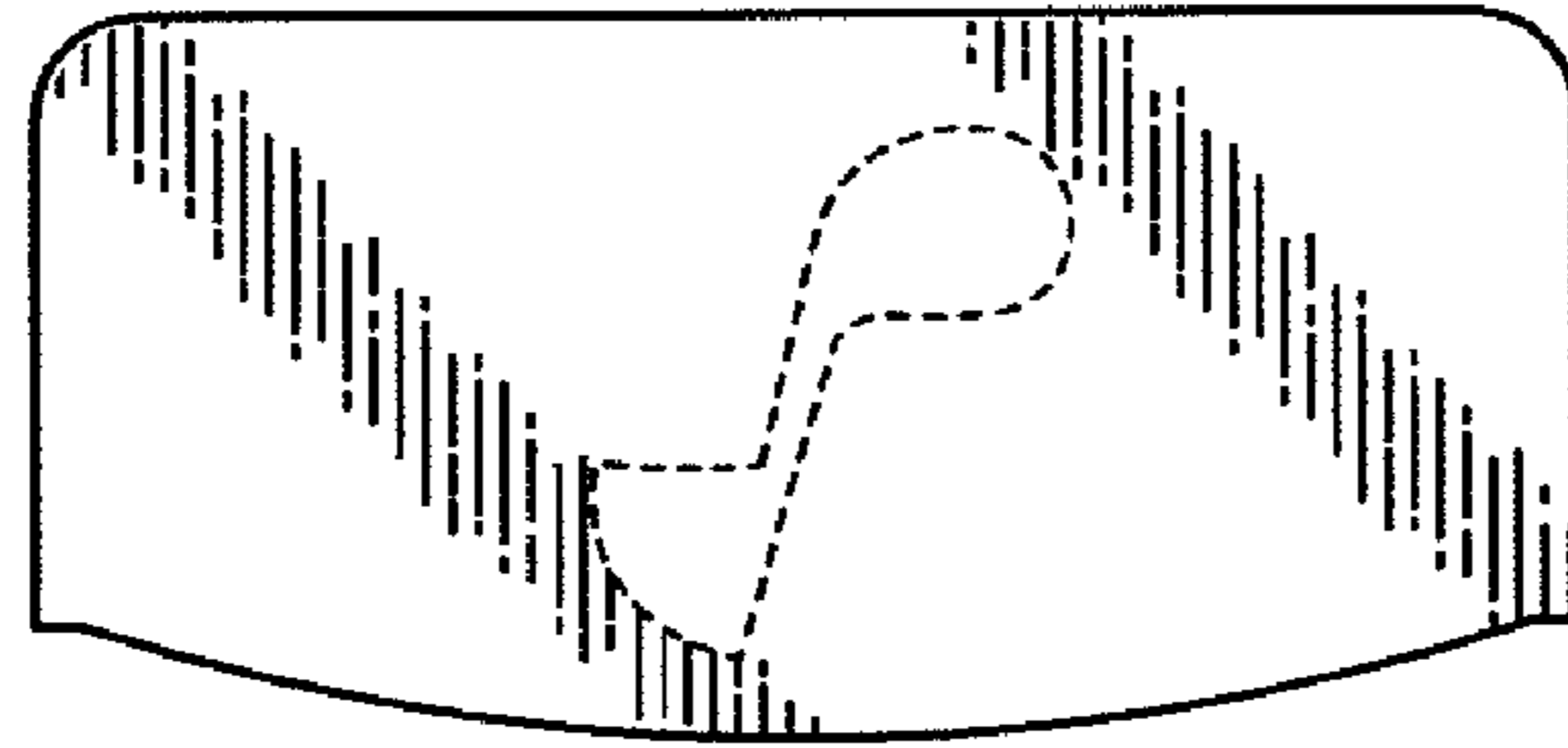

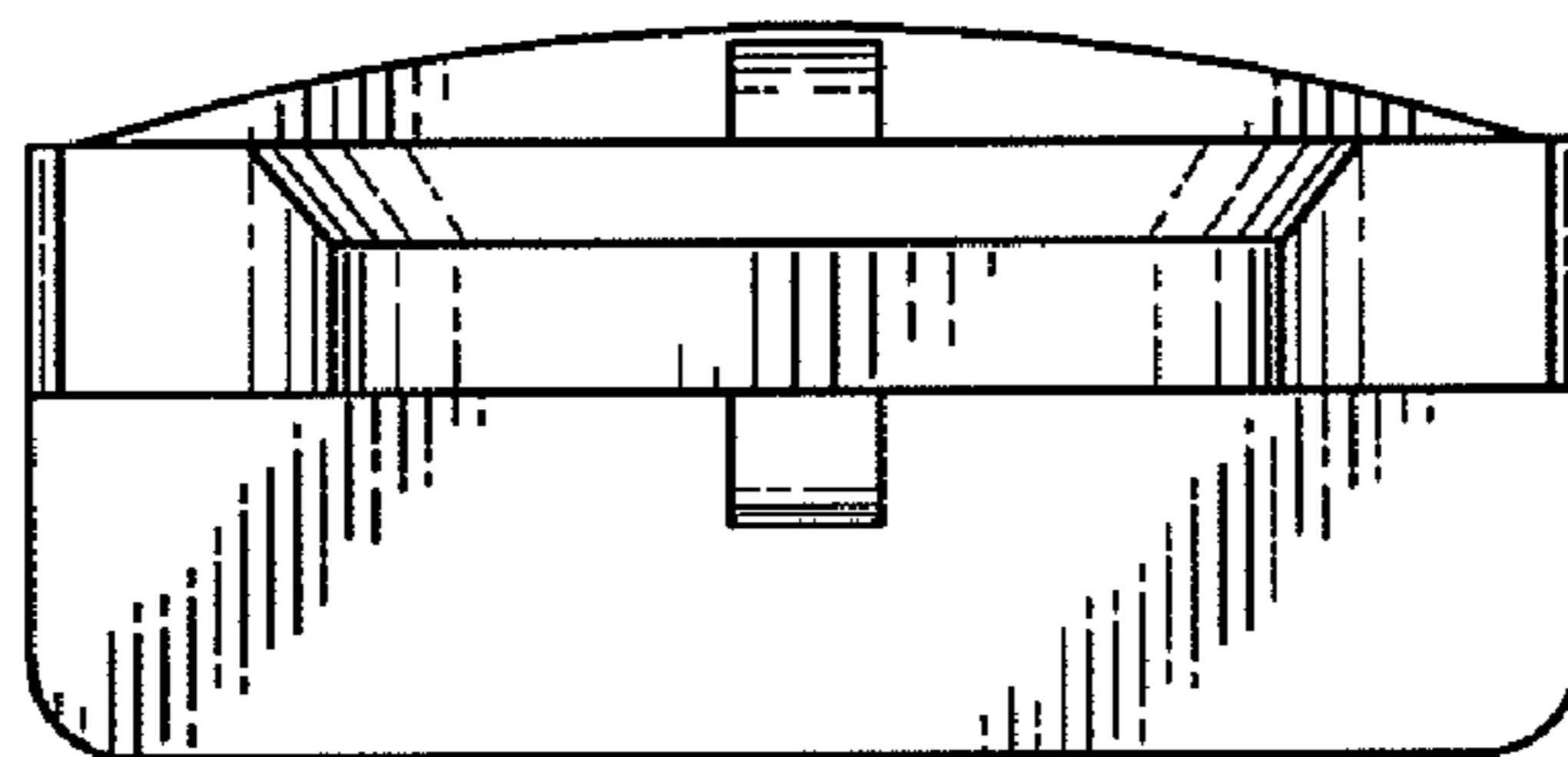

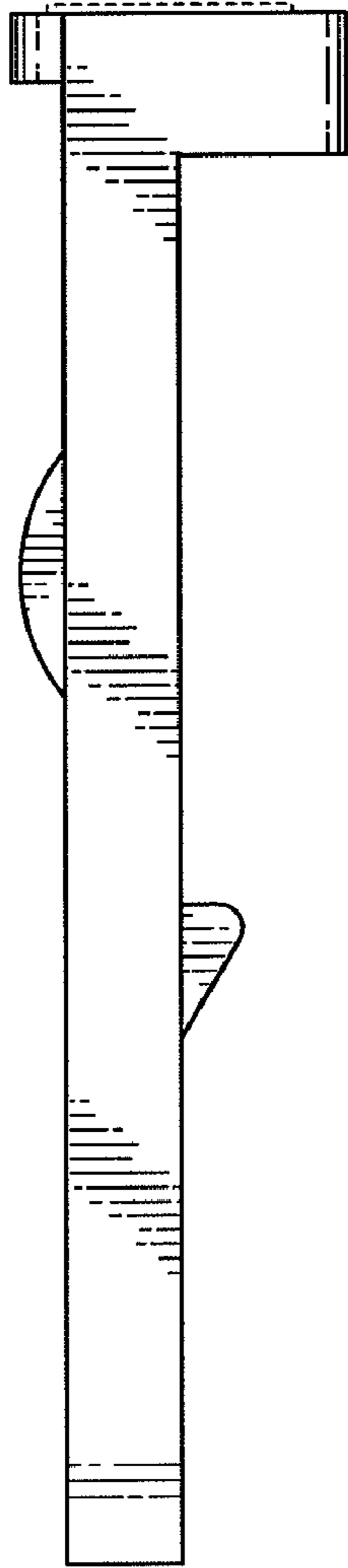

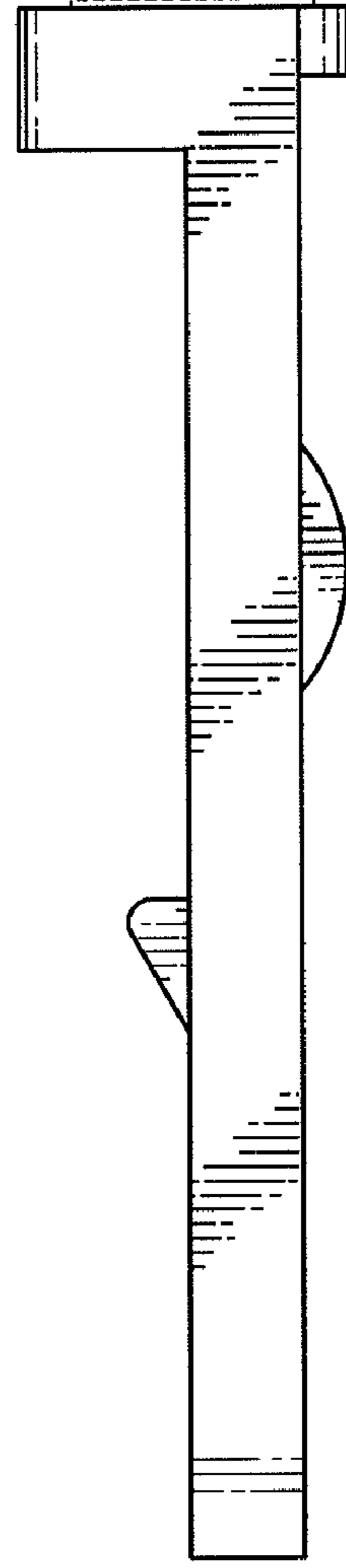

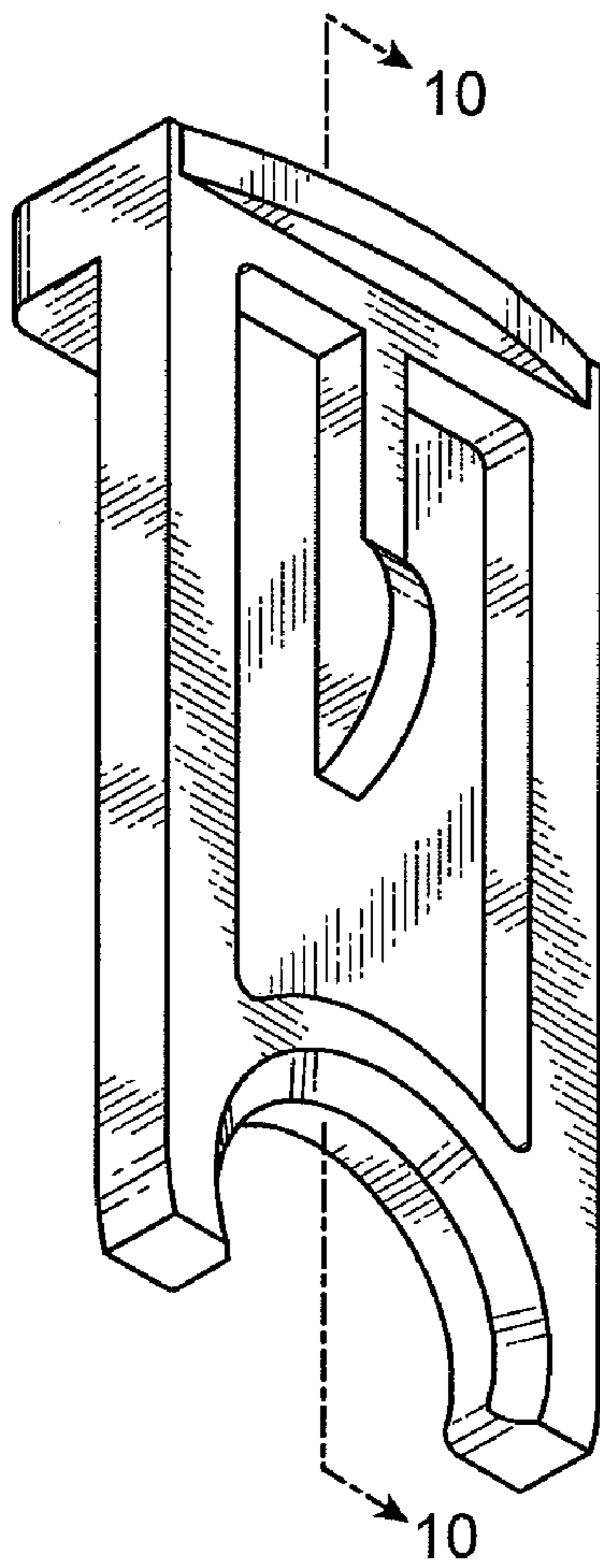

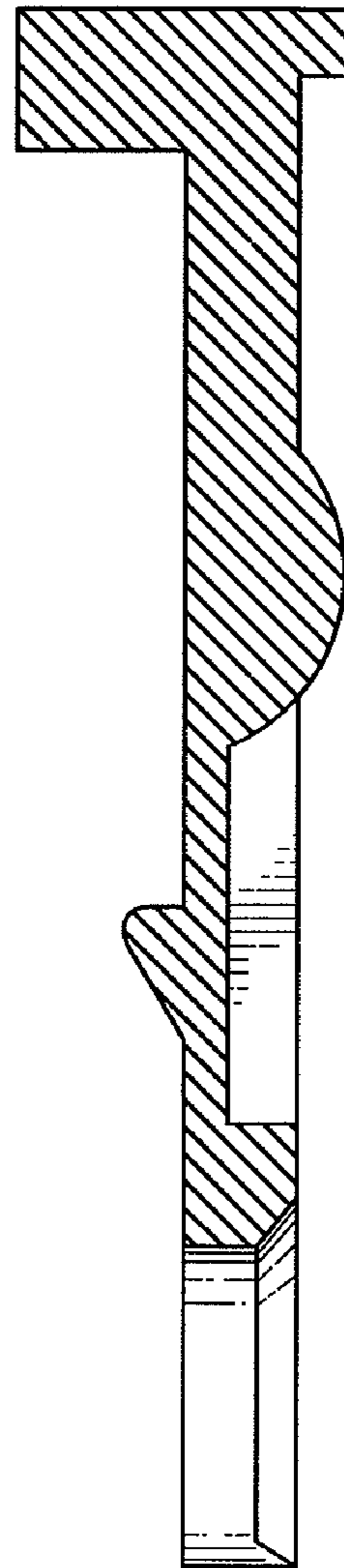
