FIG. 3 is a rear view thereof;

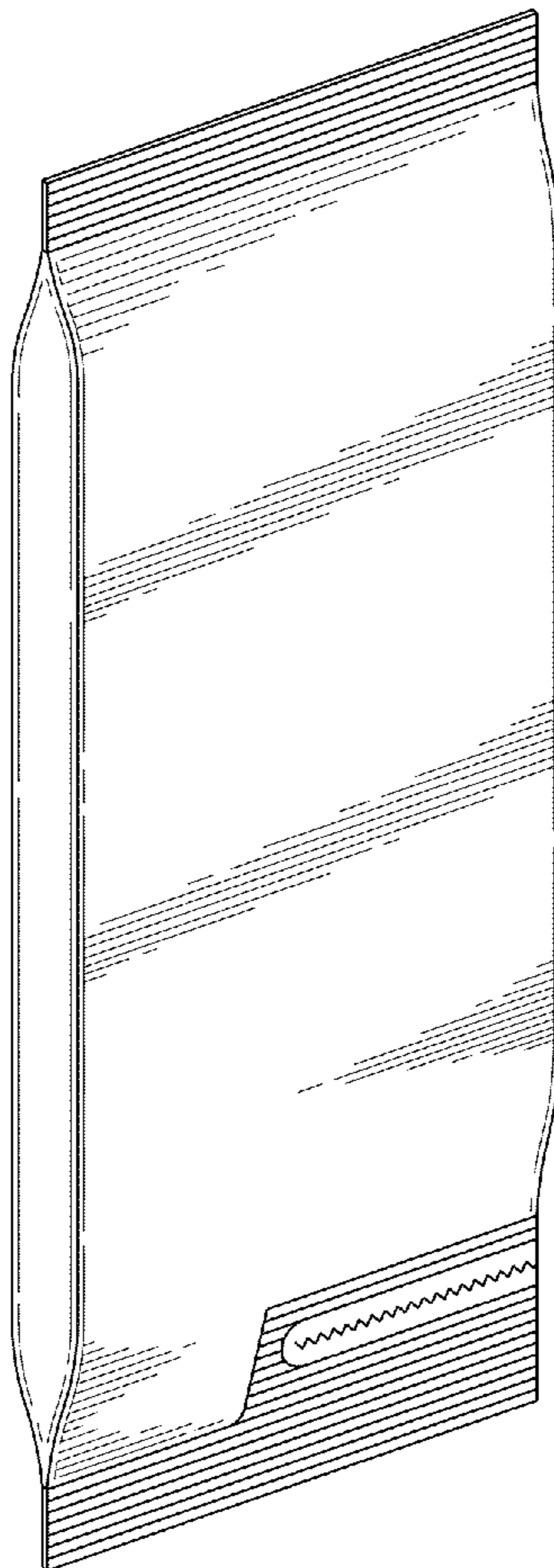
FIG. 4 a left side view thereof;

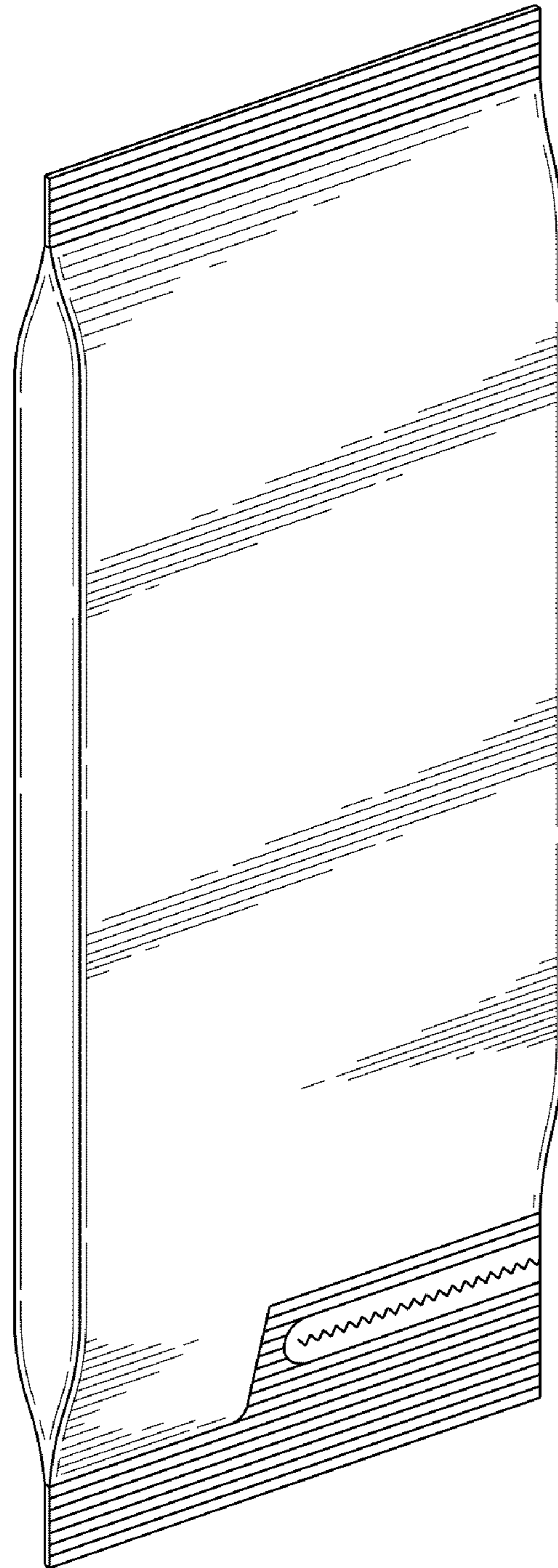

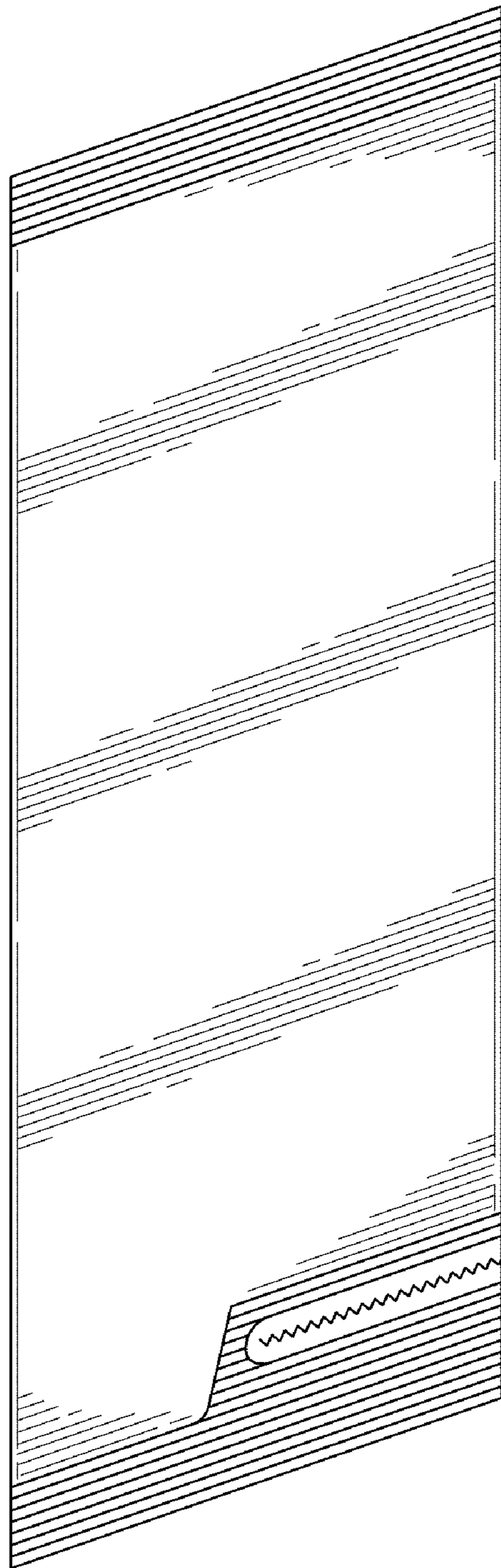

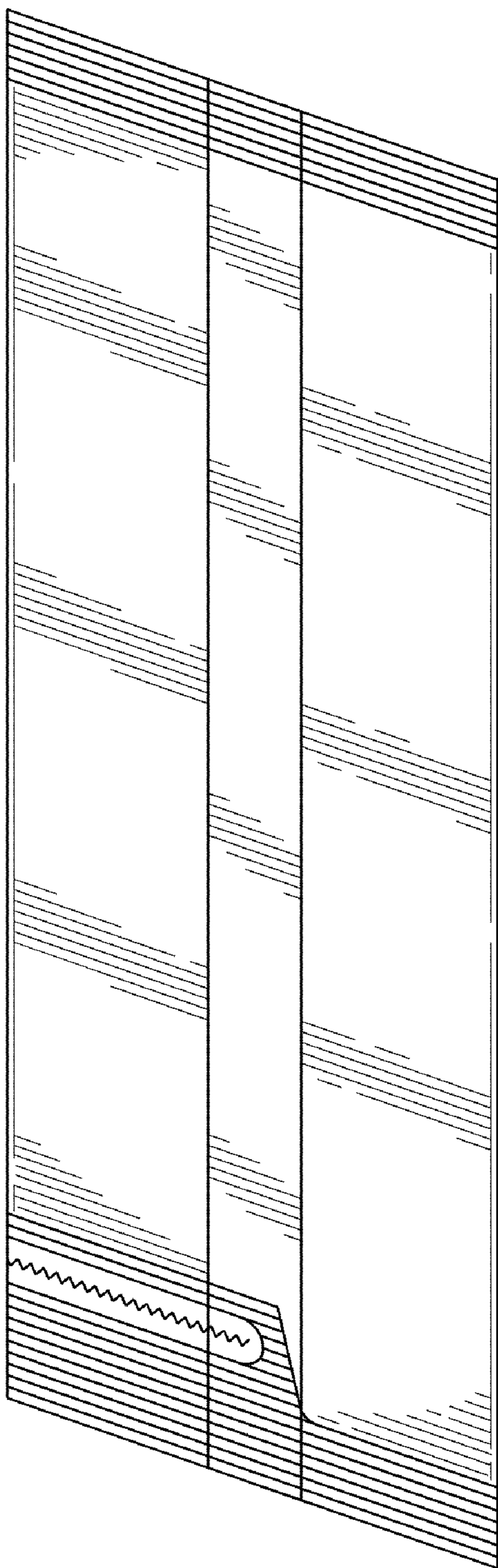

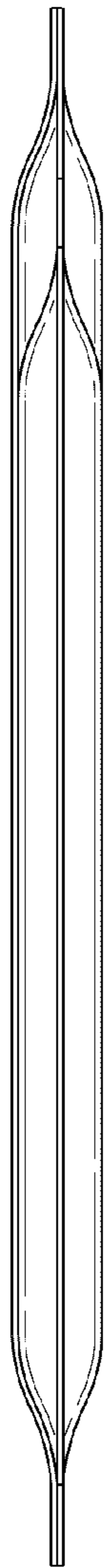

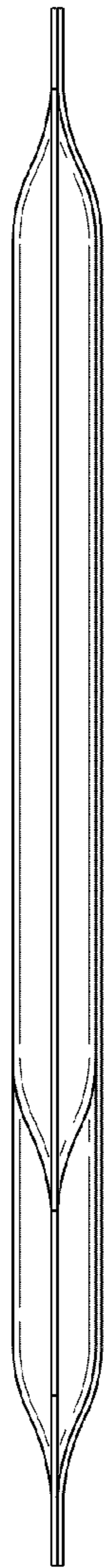

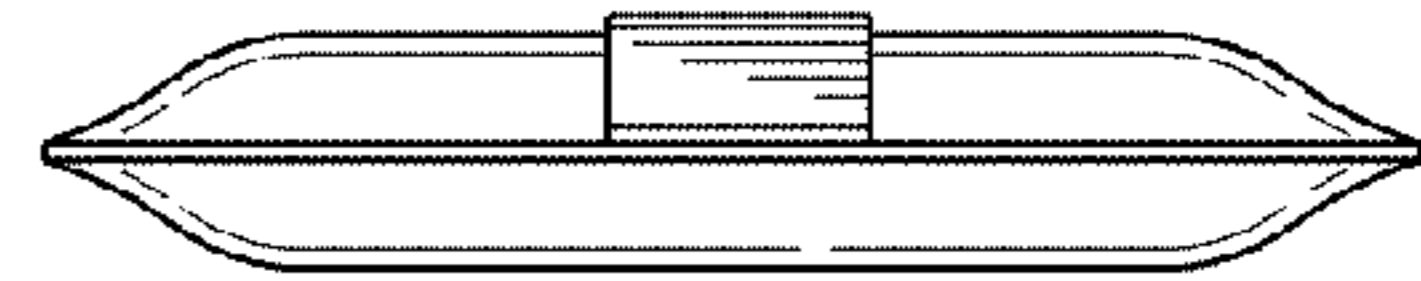

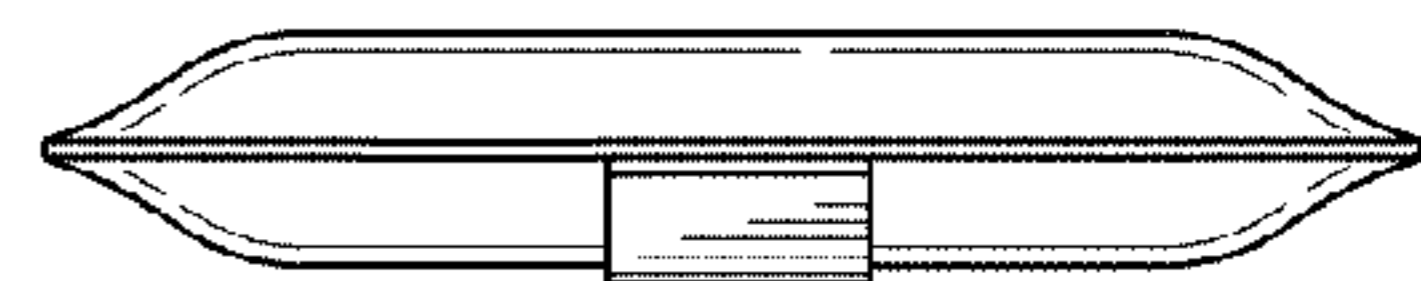
