The ornamental design for gemstone jewelry, as shown and described.

DESCRIPTION

FIG. 1 is a front and side perspective view of gemstone jewelry showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a right side elevational view thereof, with the left side being a mirror image;

FIG. 5 is a bottom plan view thereof, with the top plan view being a mirror image;

FIG. 6 is a front and side perspective view of a second embodiment of gemstone jewelry showing my new design;

FIG. 7 is a front elevational view thereof;

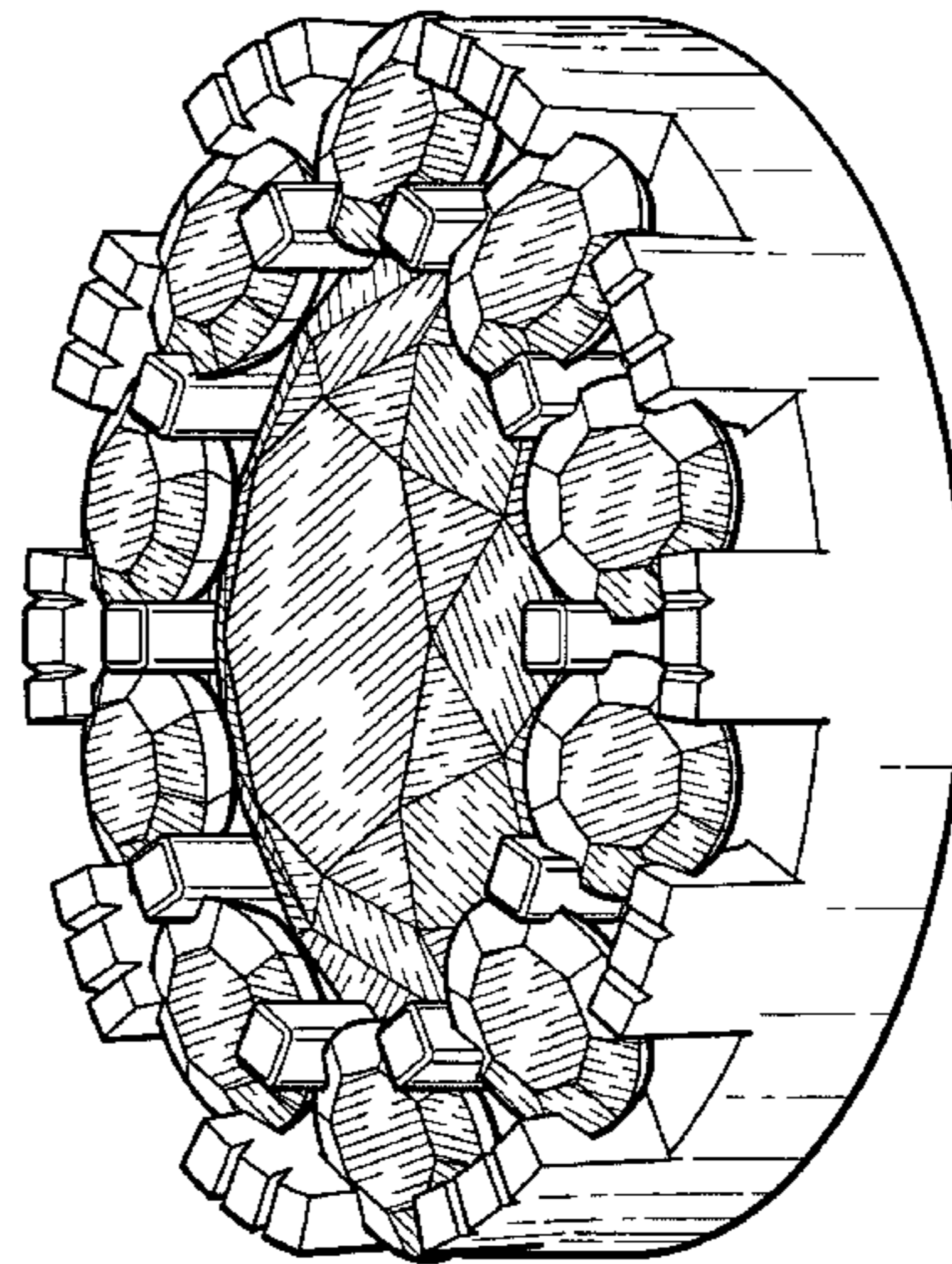
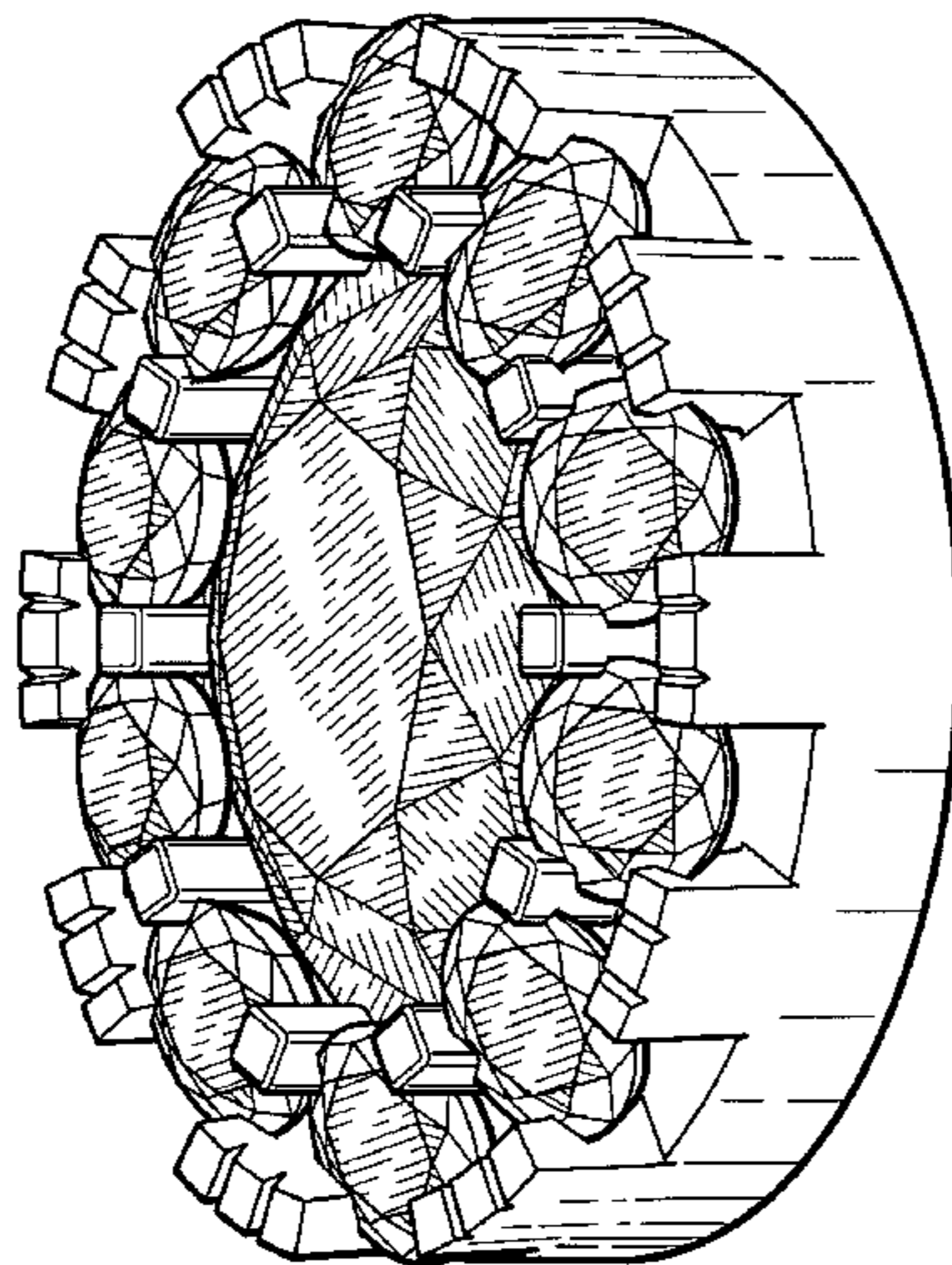
FIG. 8 is a rear elevational view thereof;

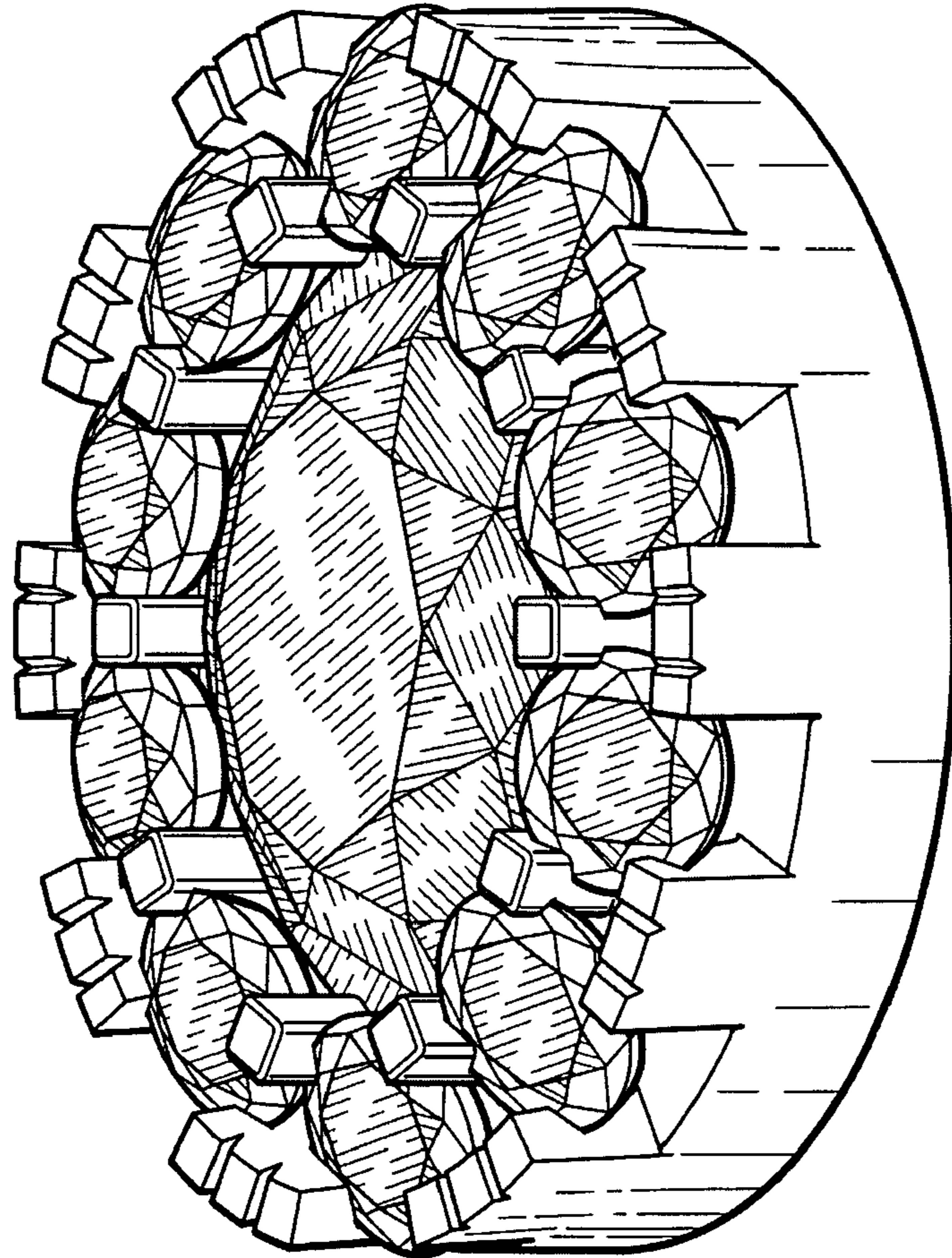

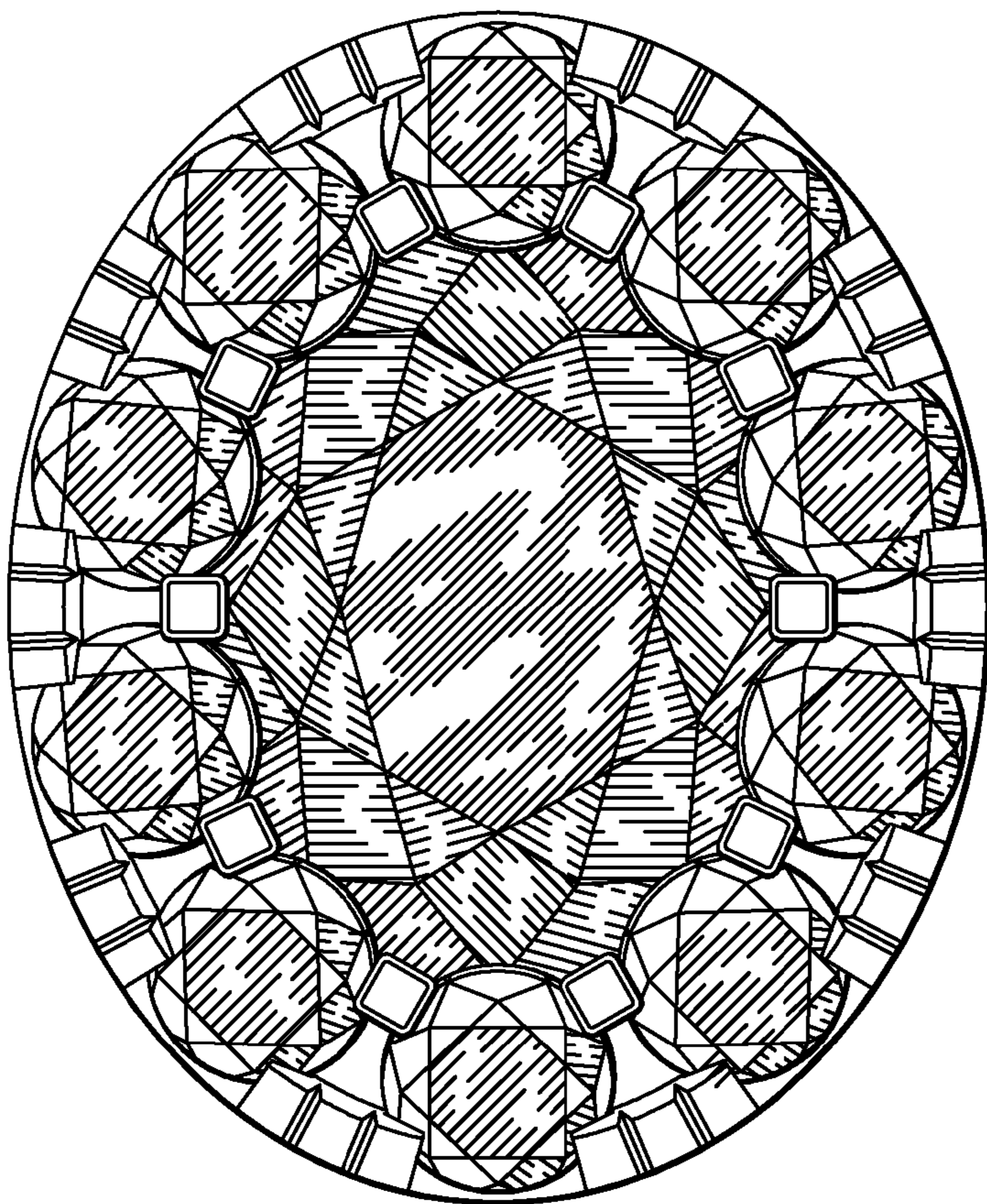

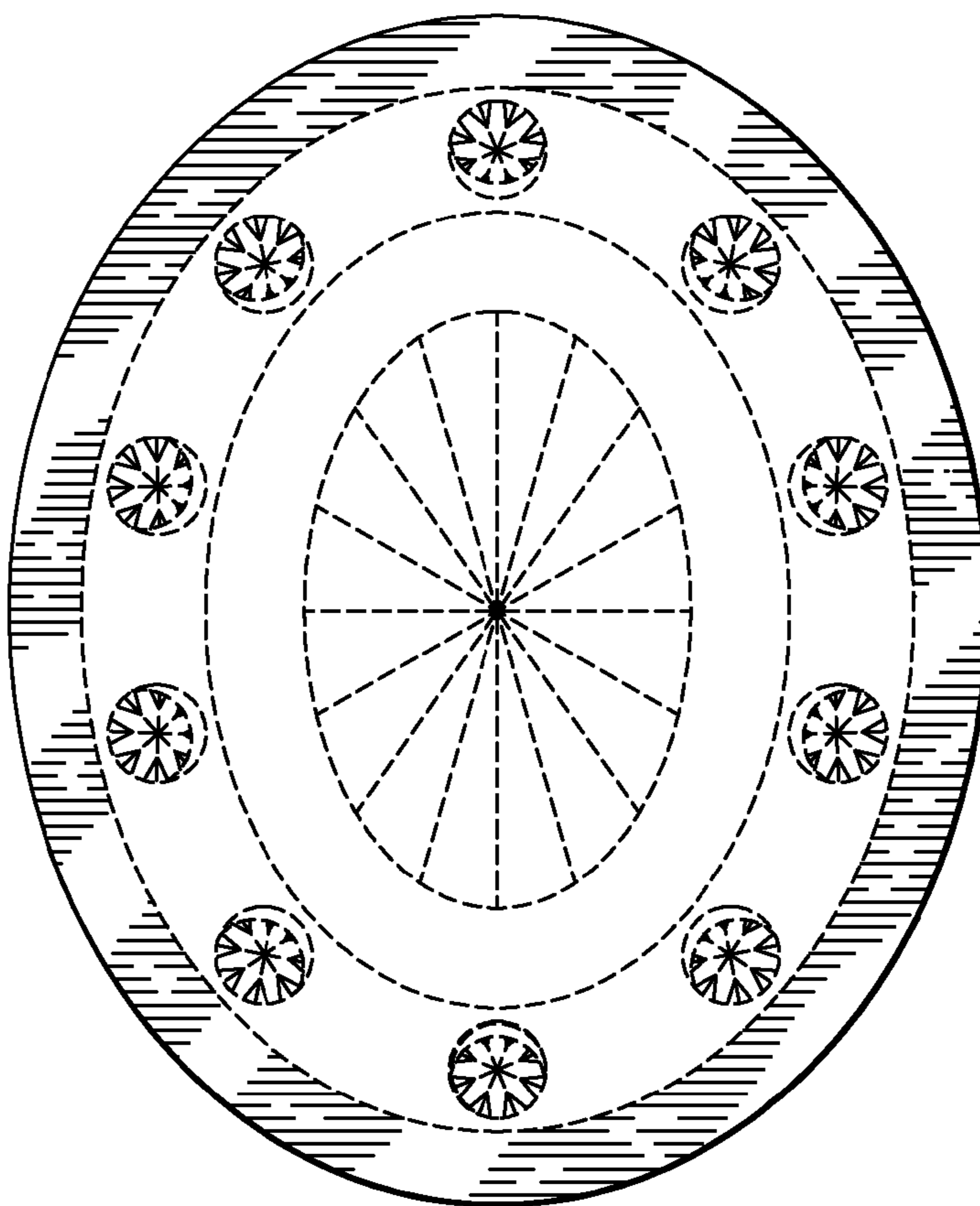

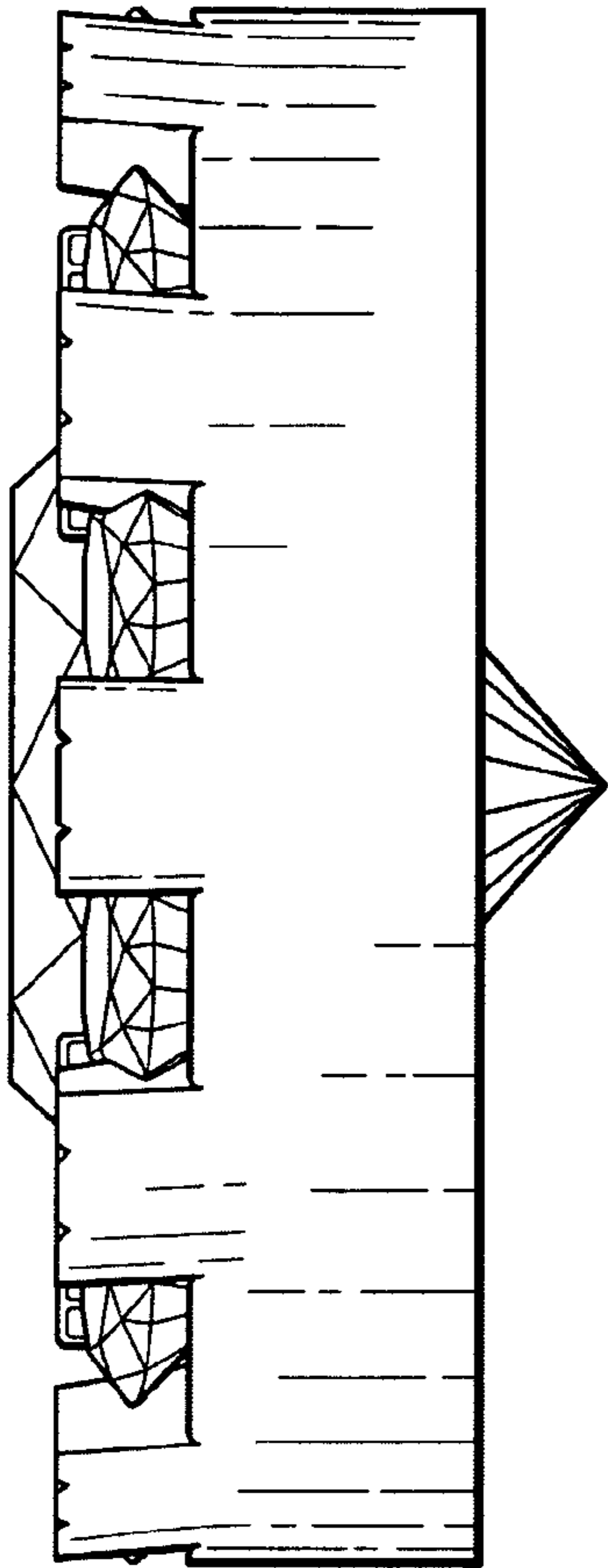

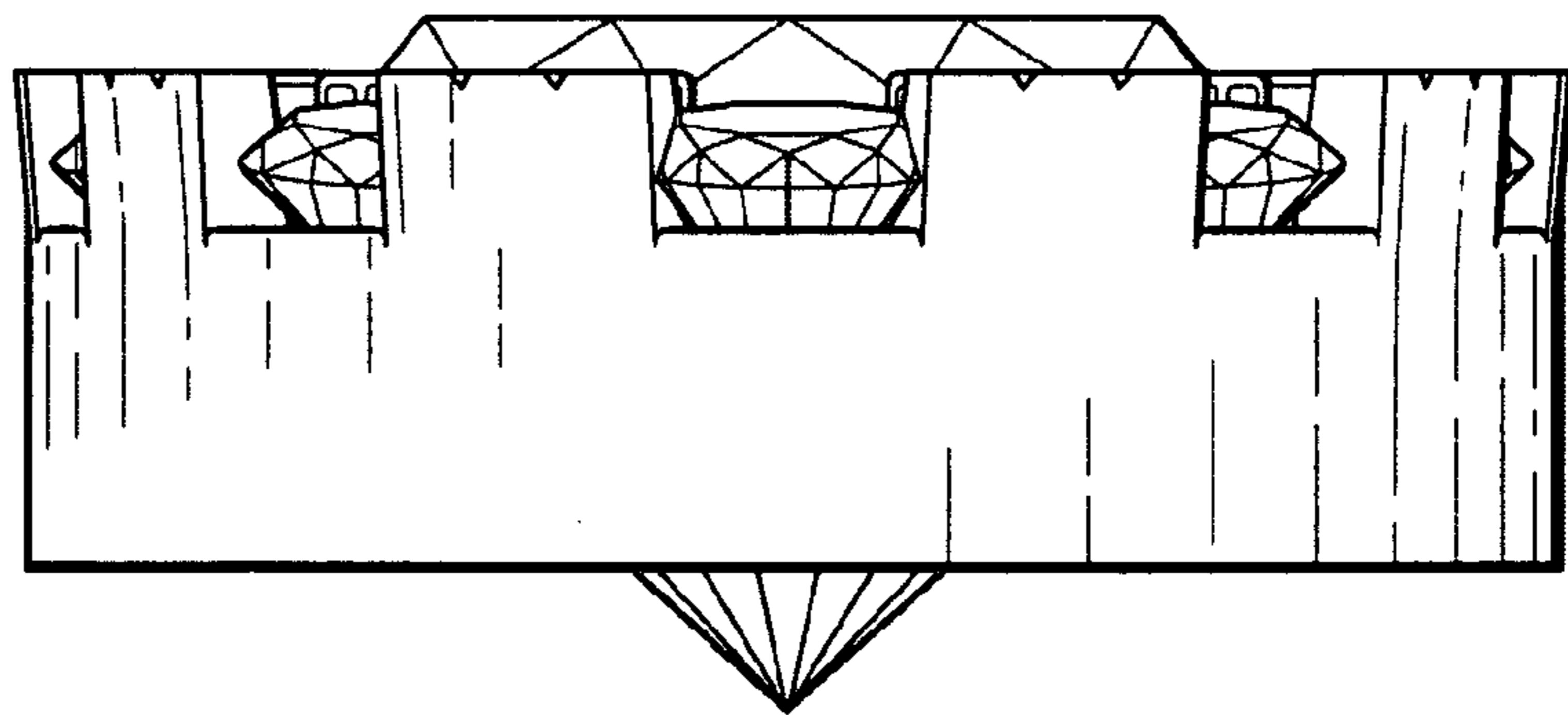

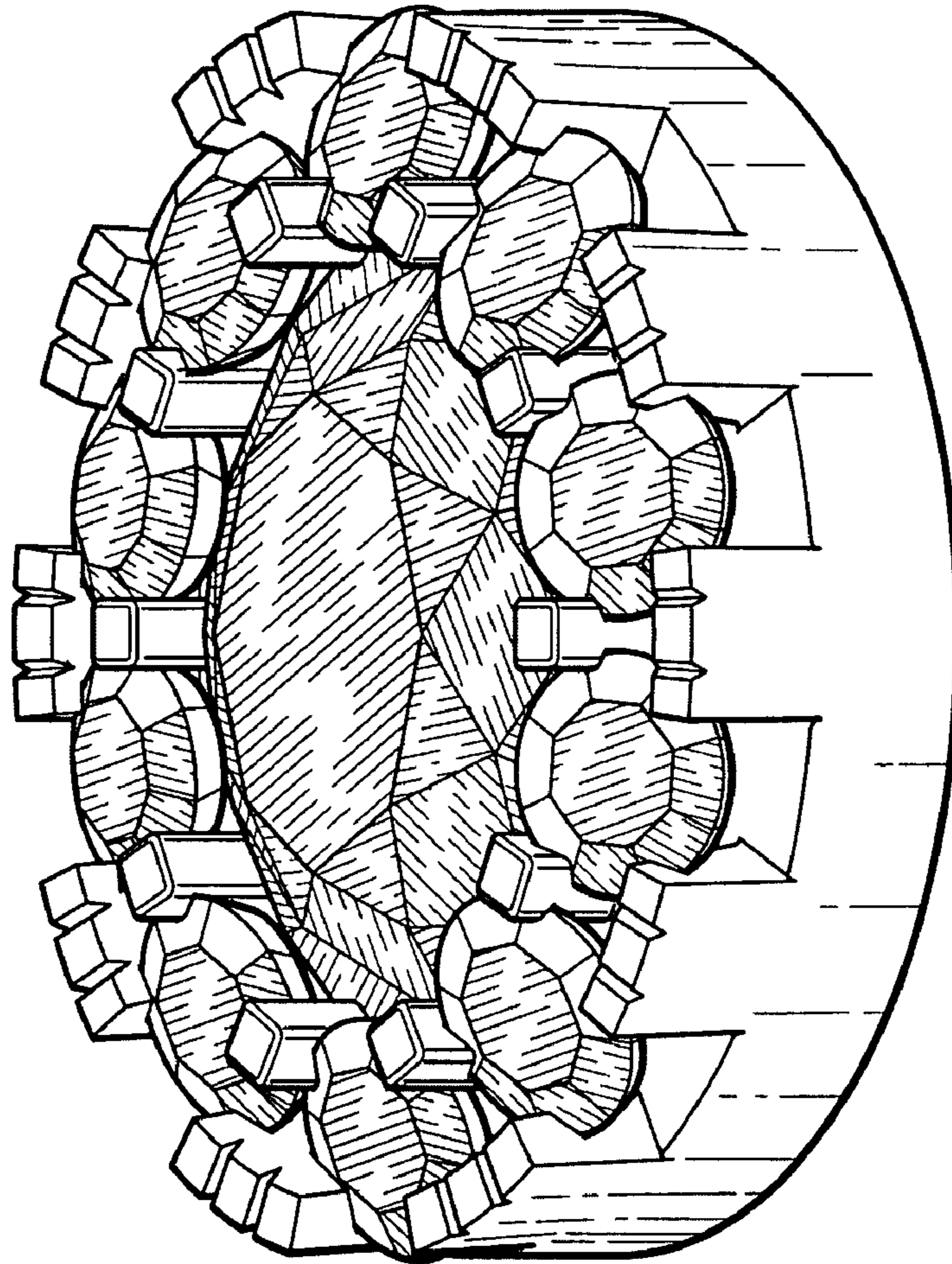

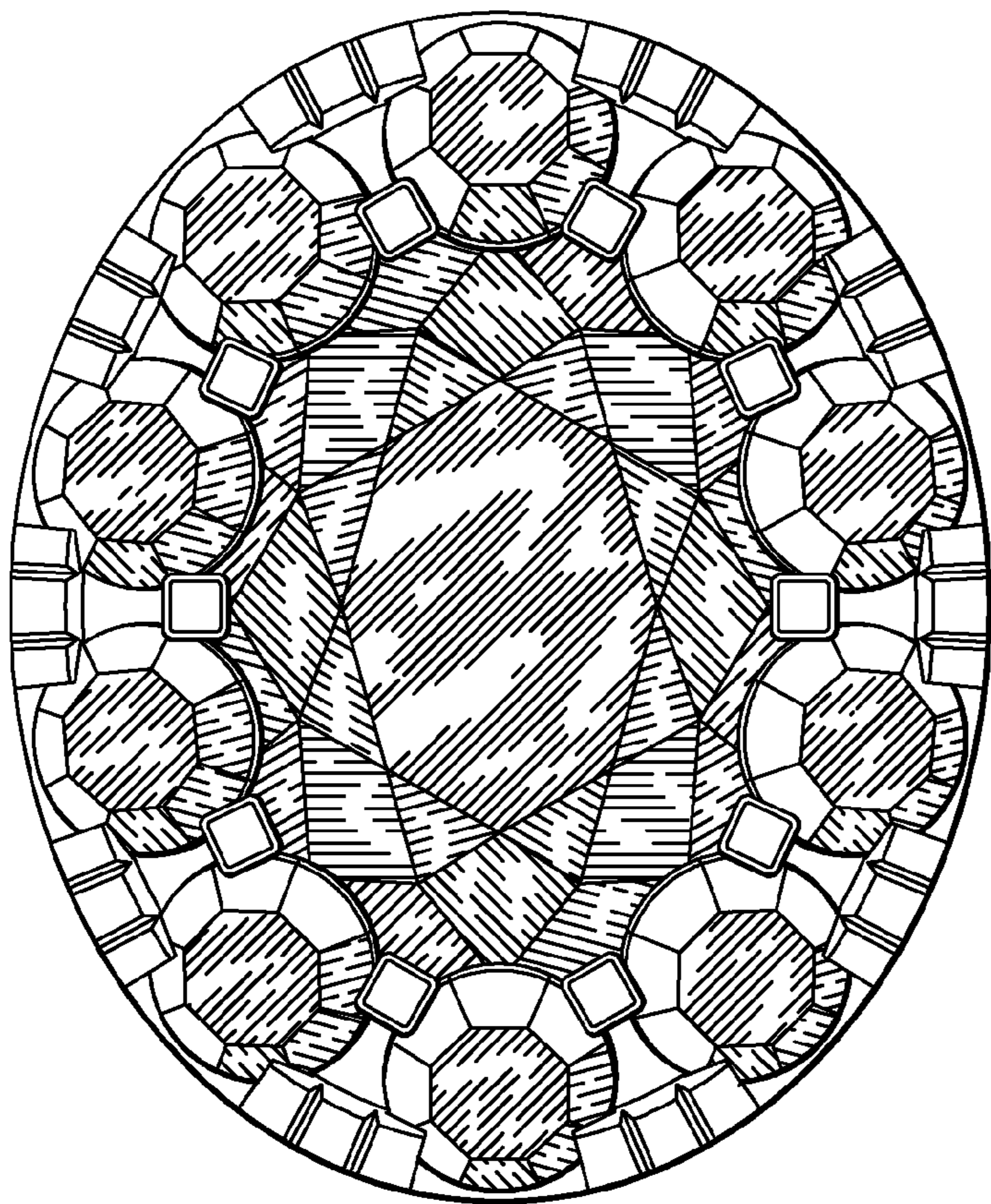

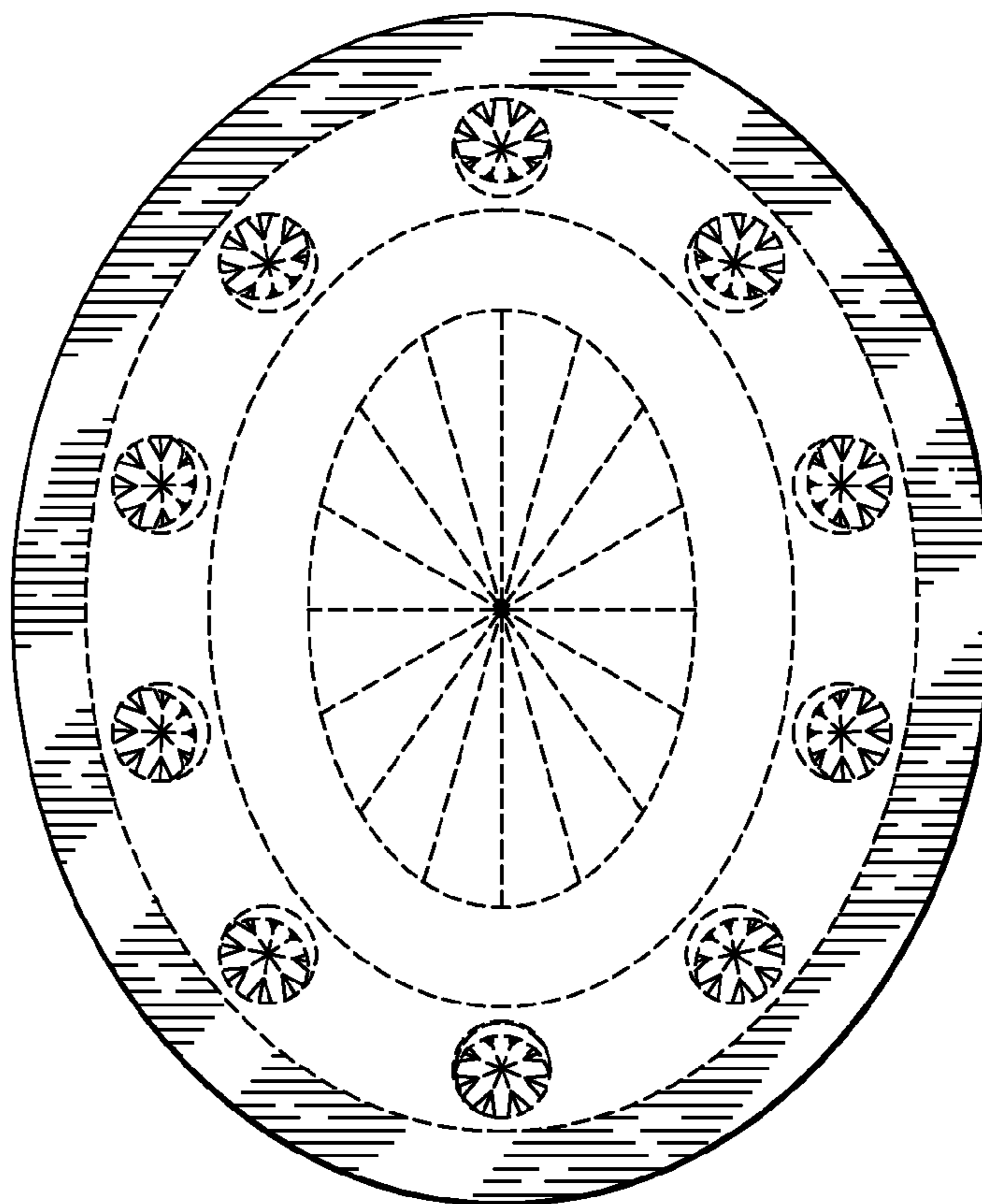

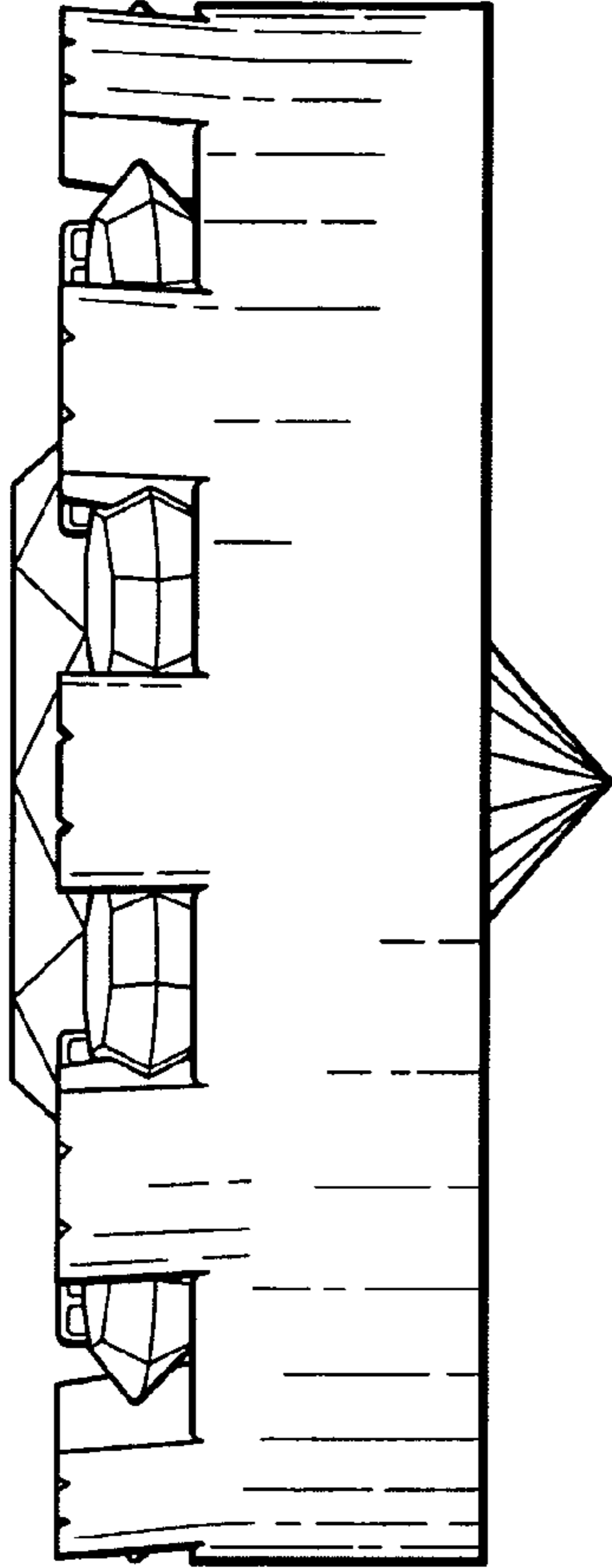

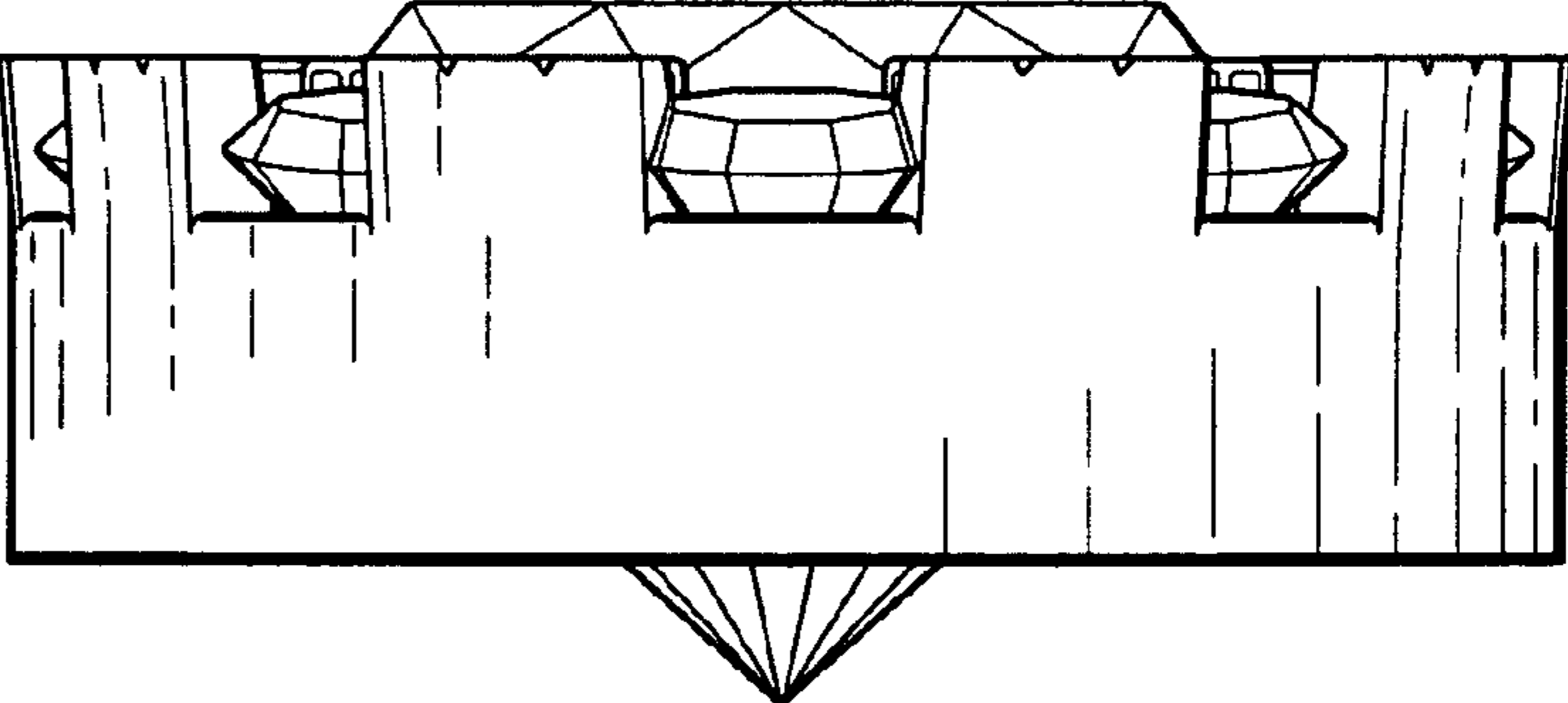
