The ornamental design for a storage battery, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a storage battery of the present invention.

FIG. 17 is a sectional view of the storage battery taken along line 17-17 of FIG. 3.

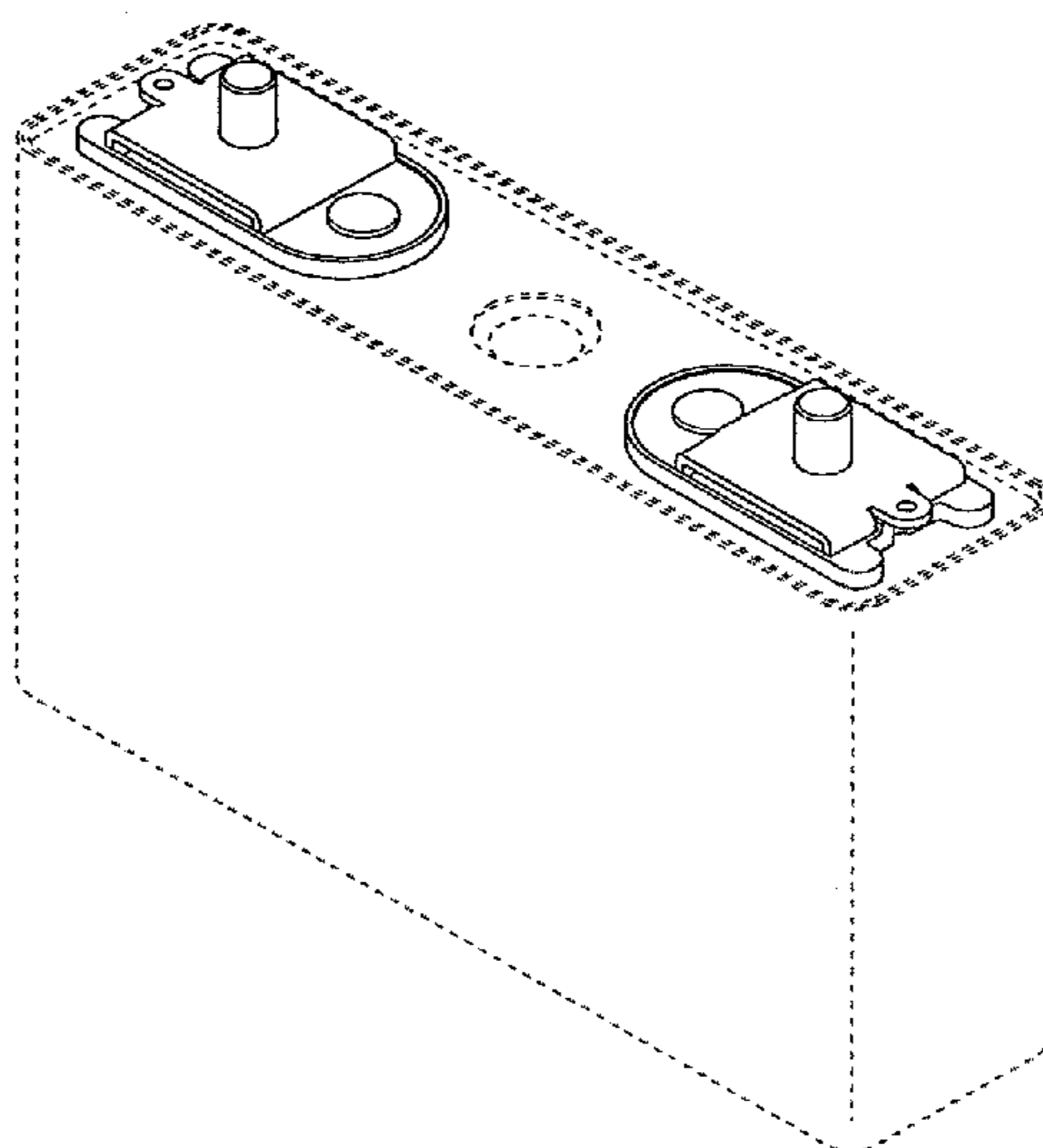
FIG. 18 is a sectional view of the storage battery taken along line 18-18 of FIG. 3.

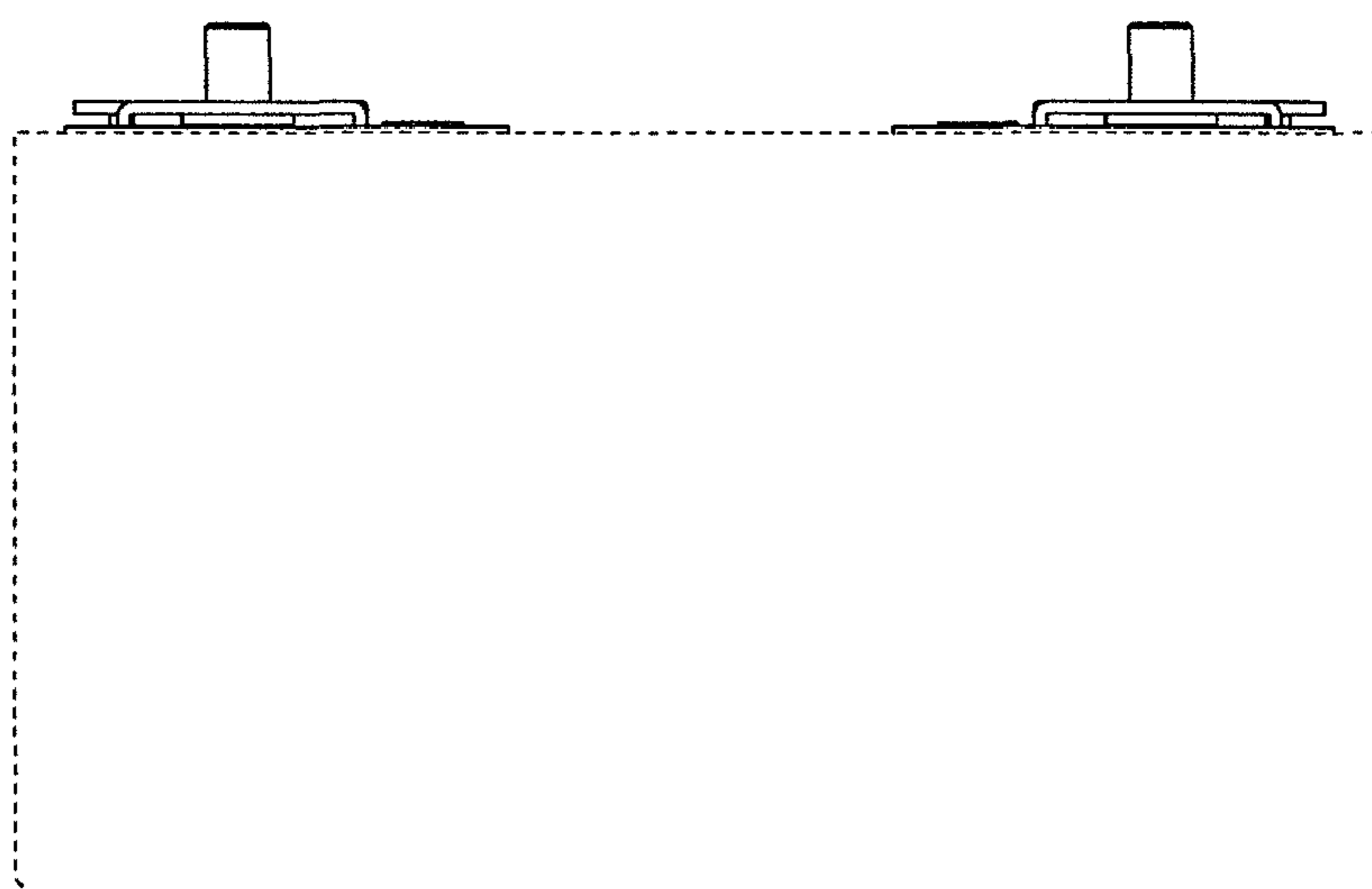

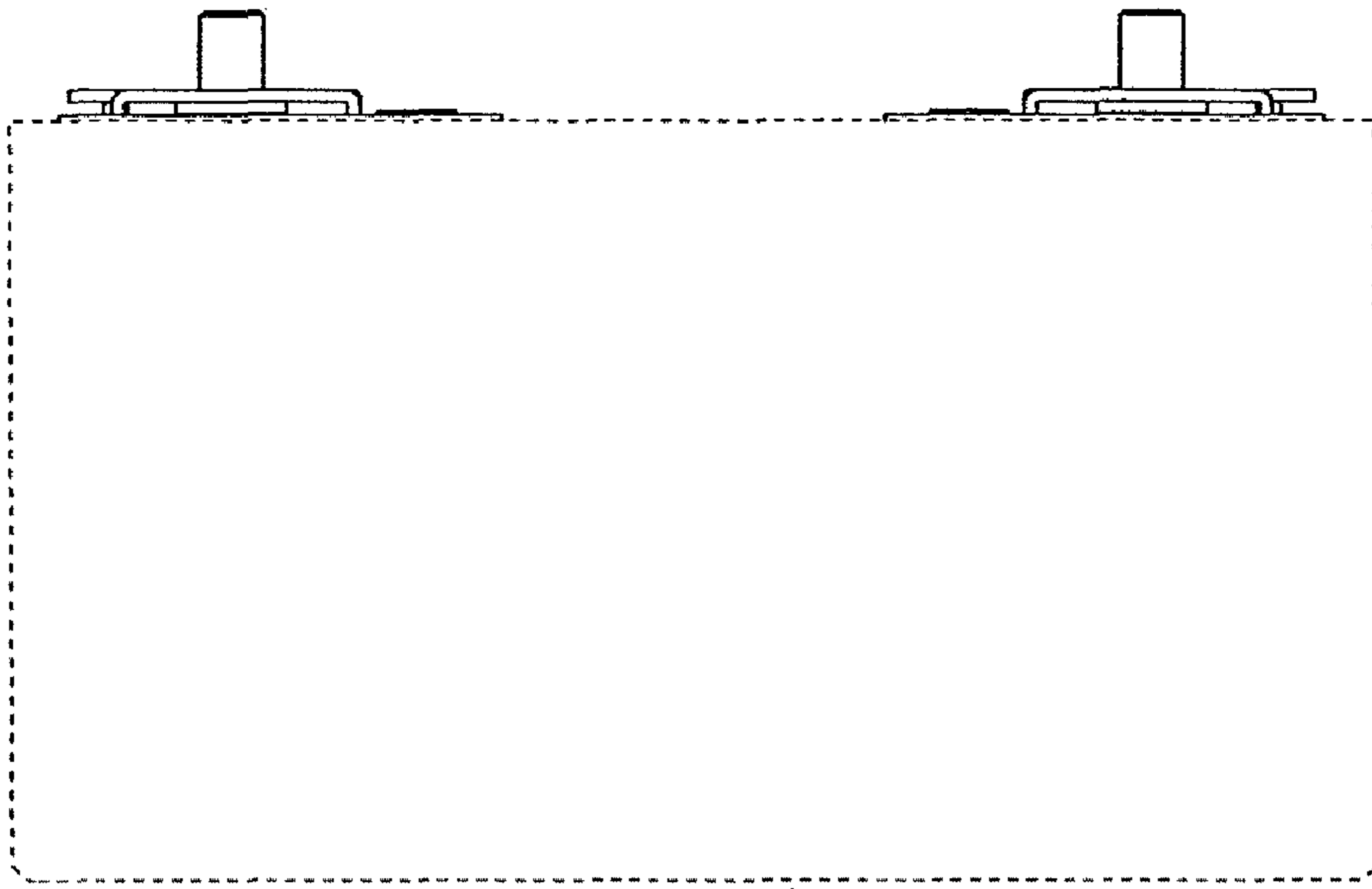

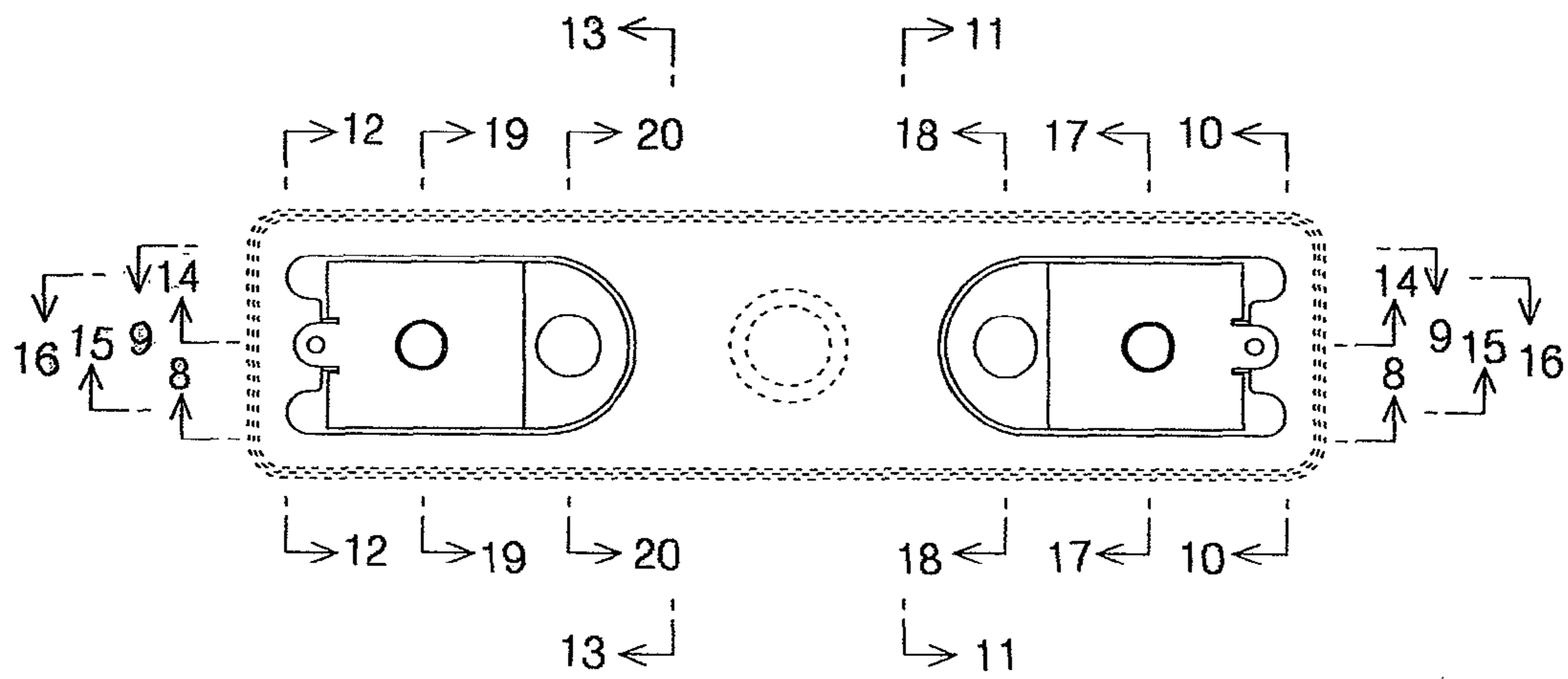
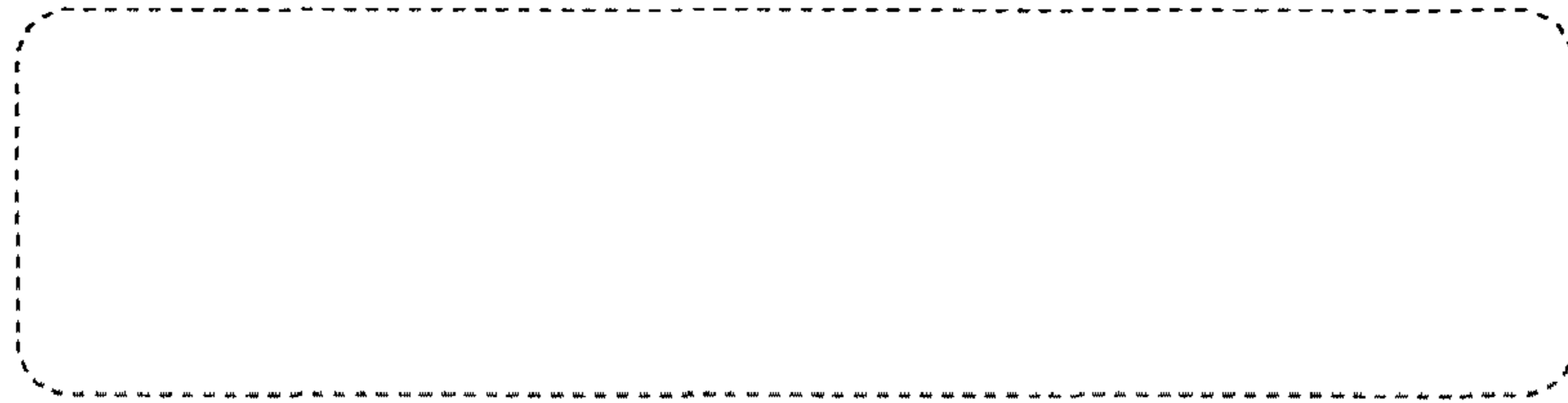

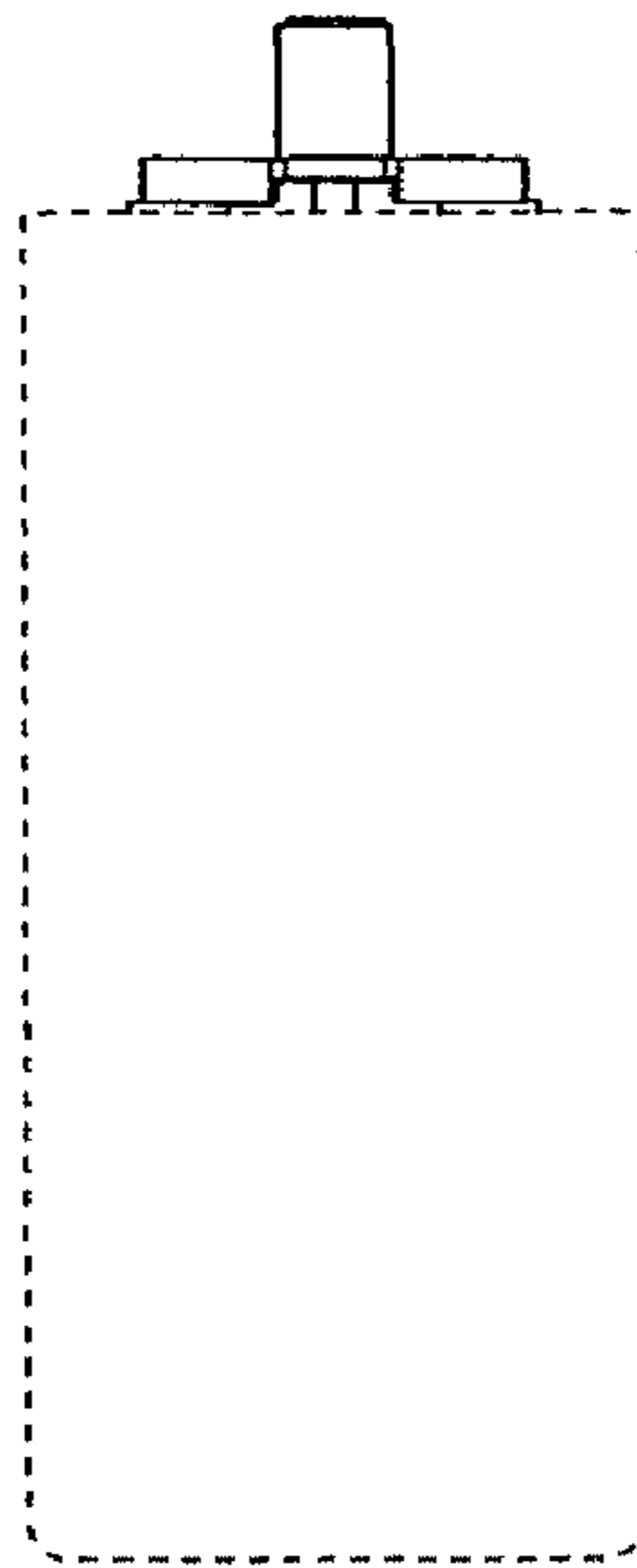

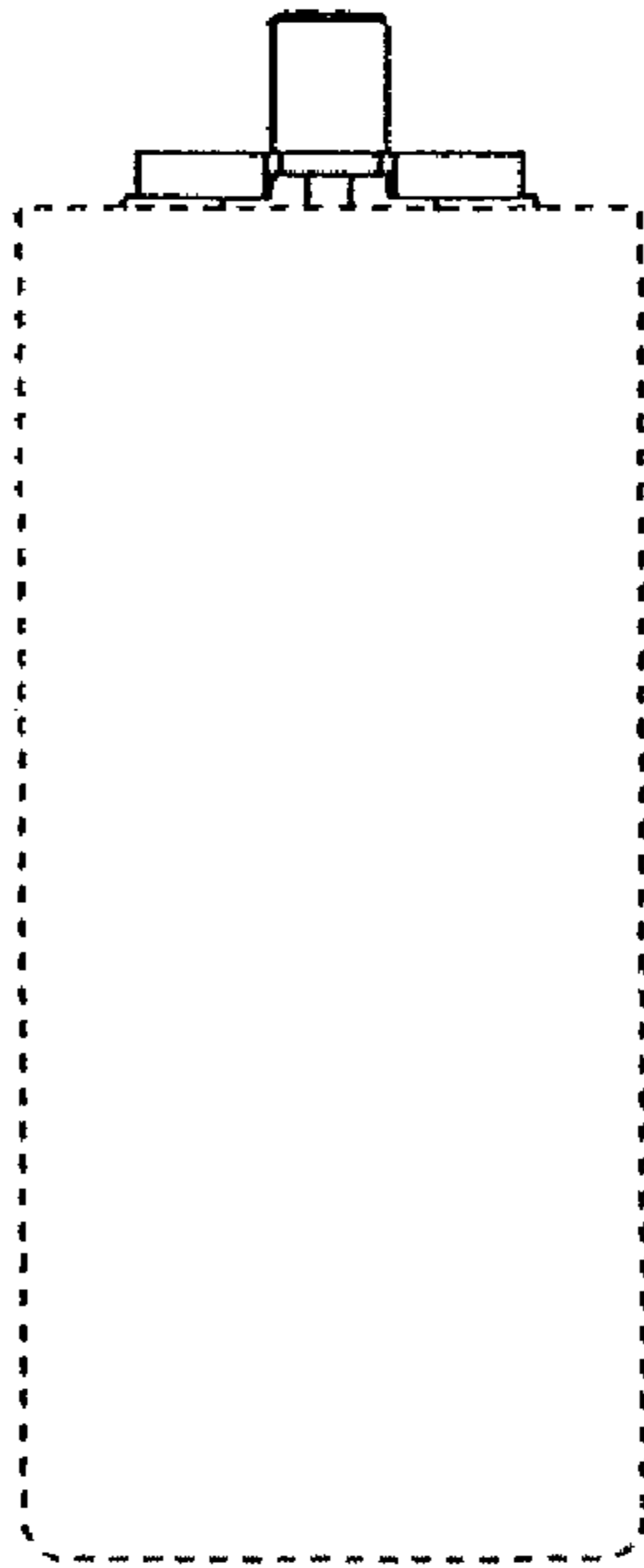

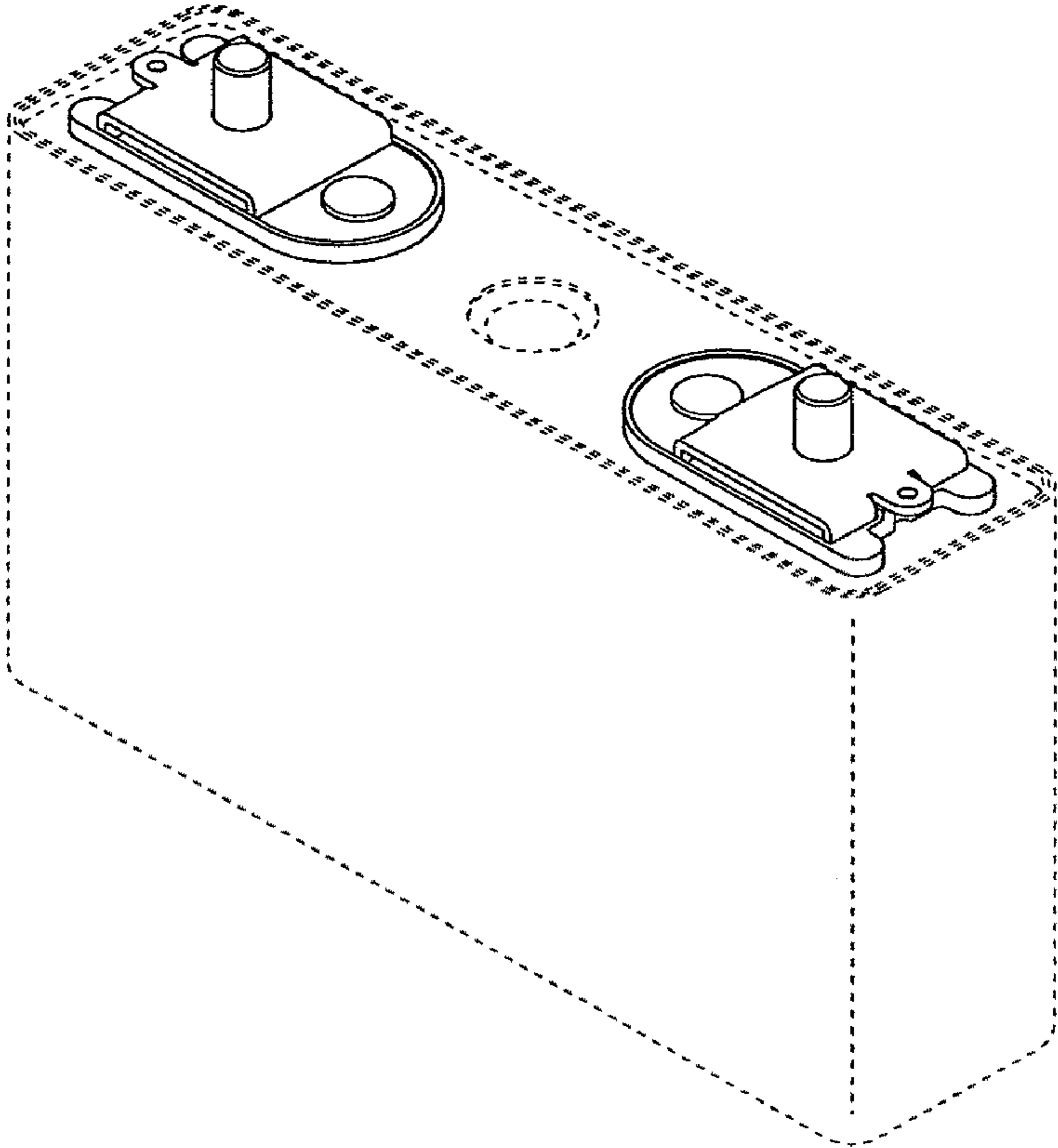

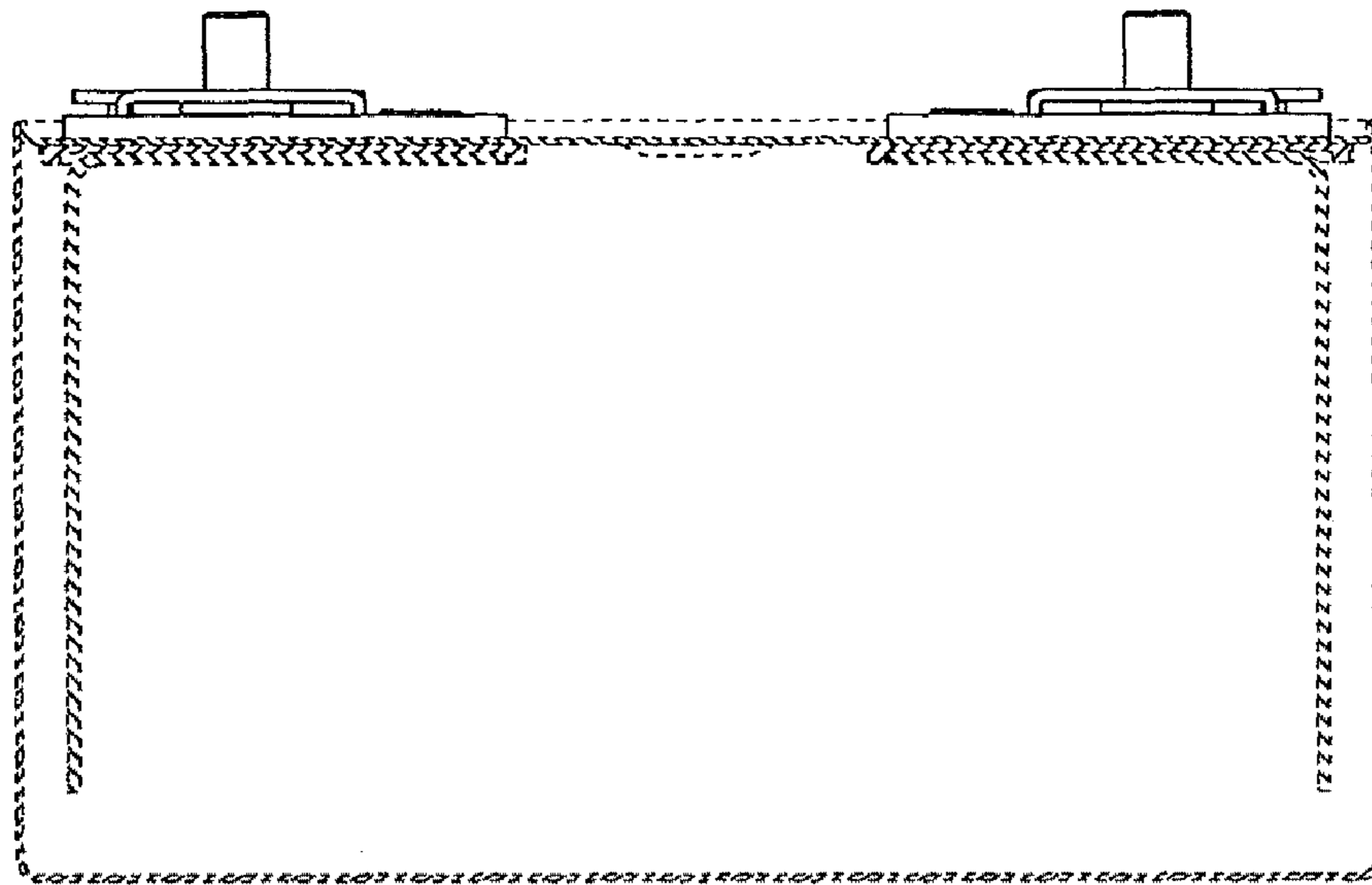

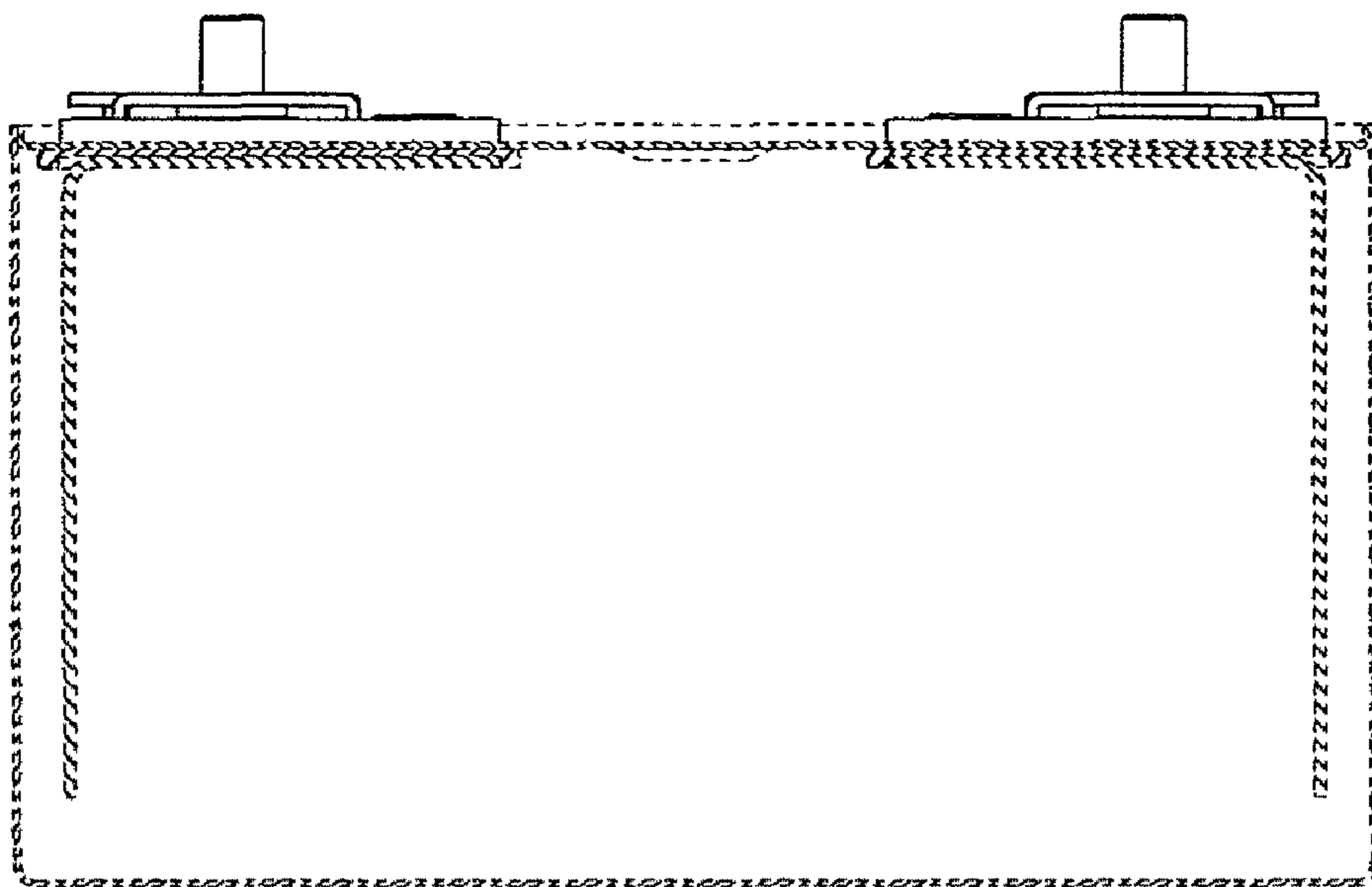

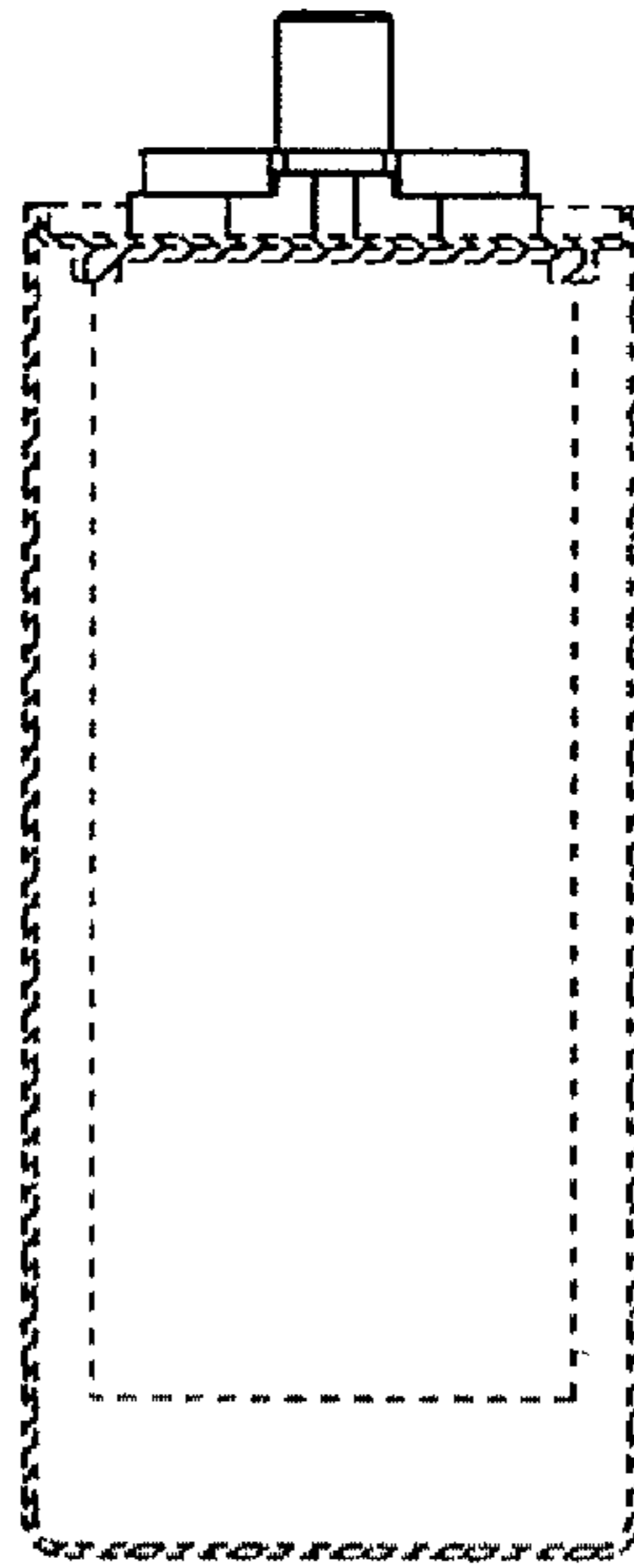

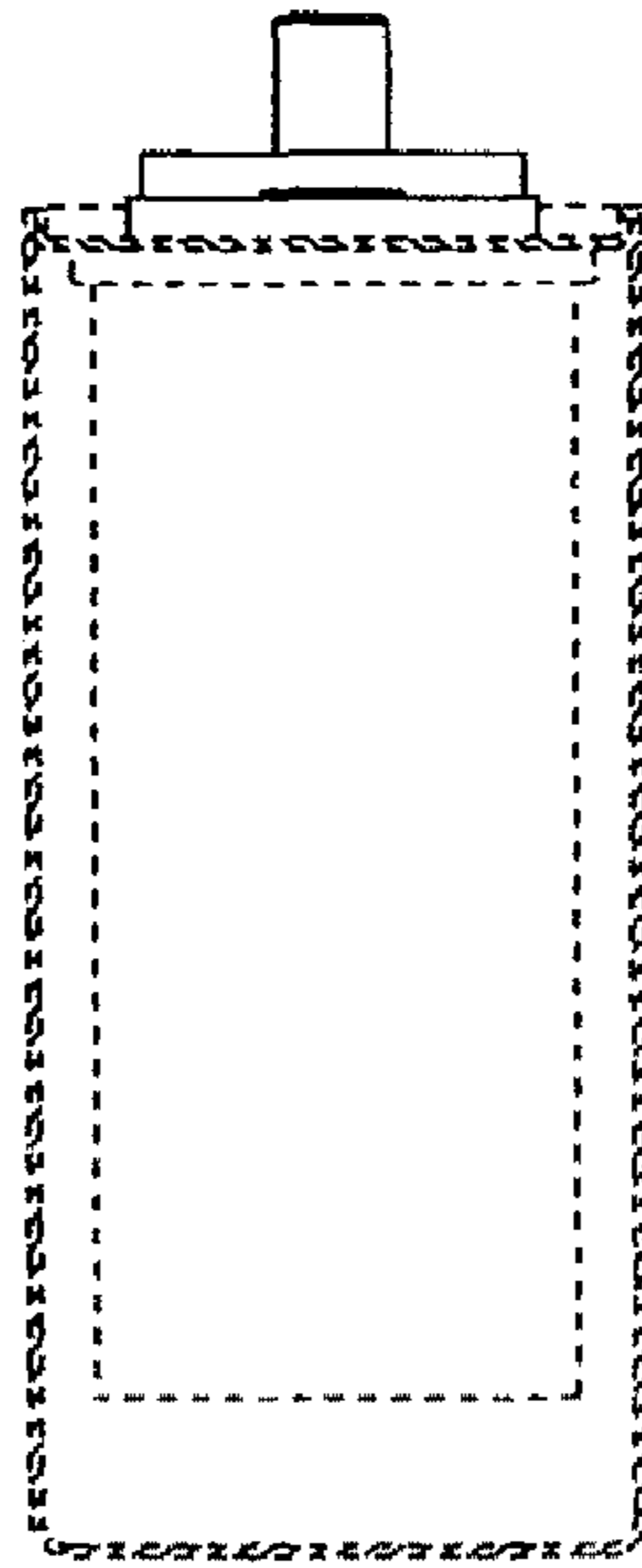

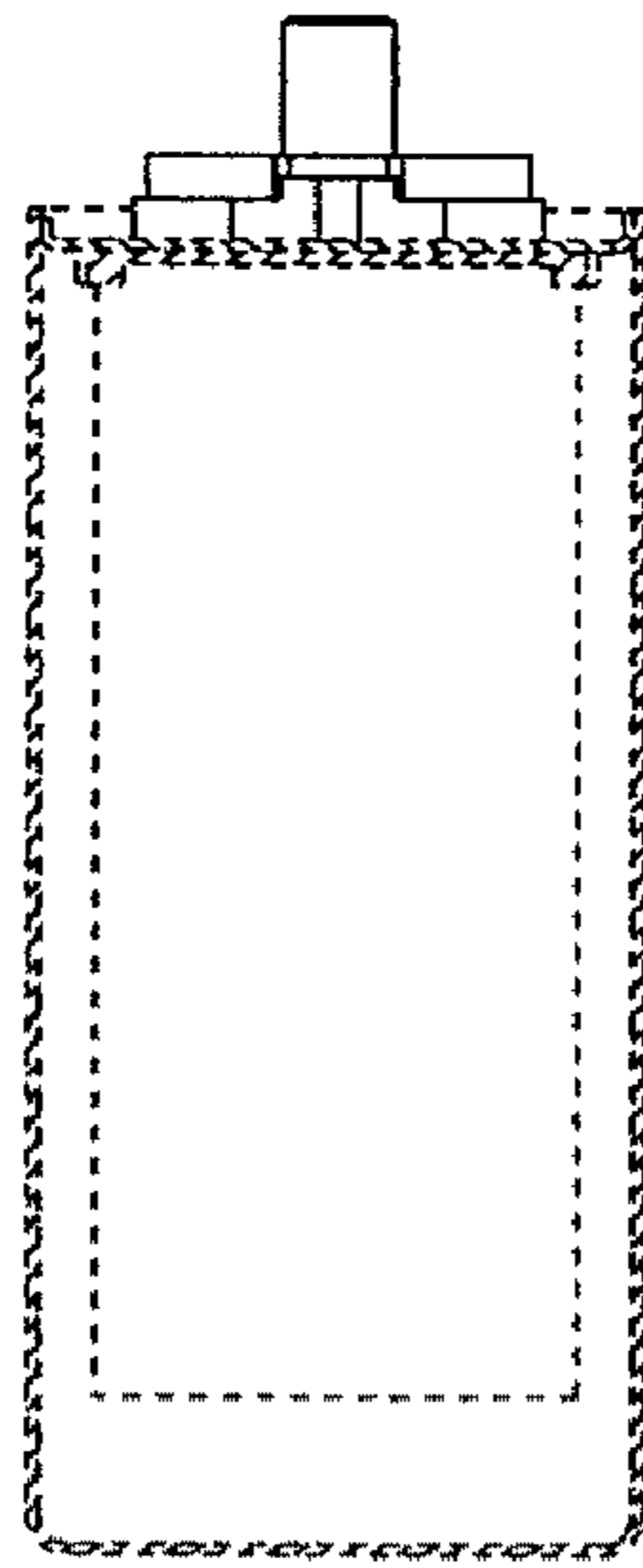

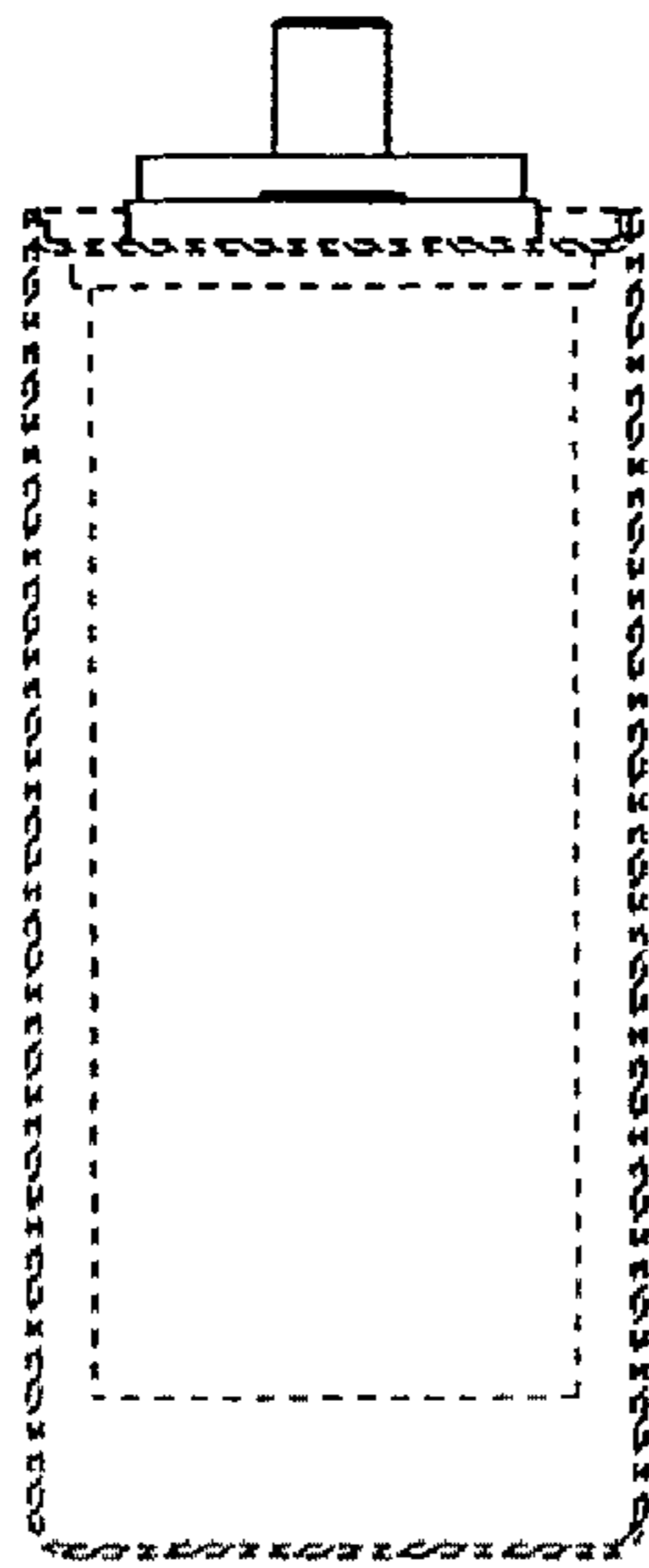

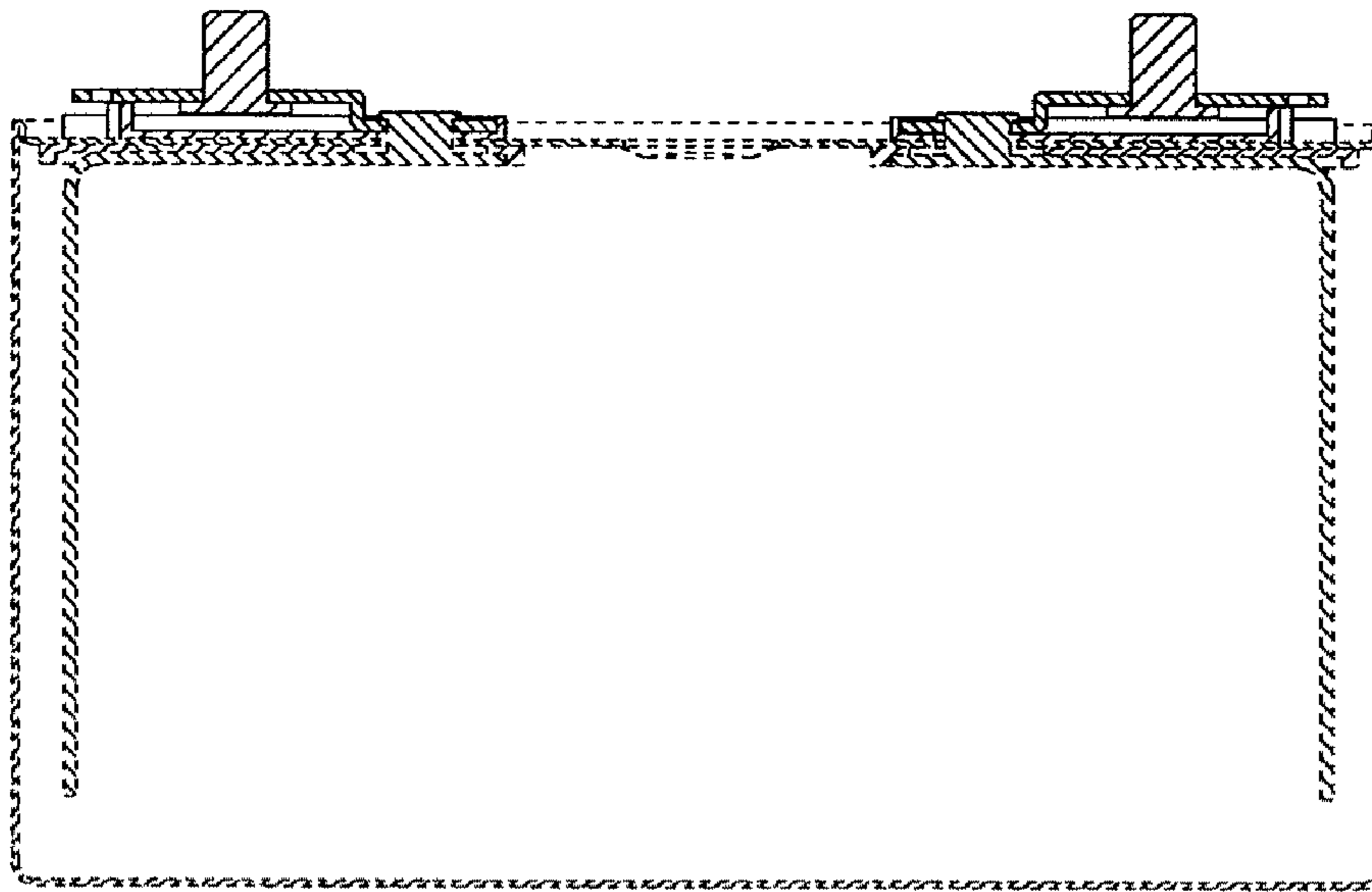

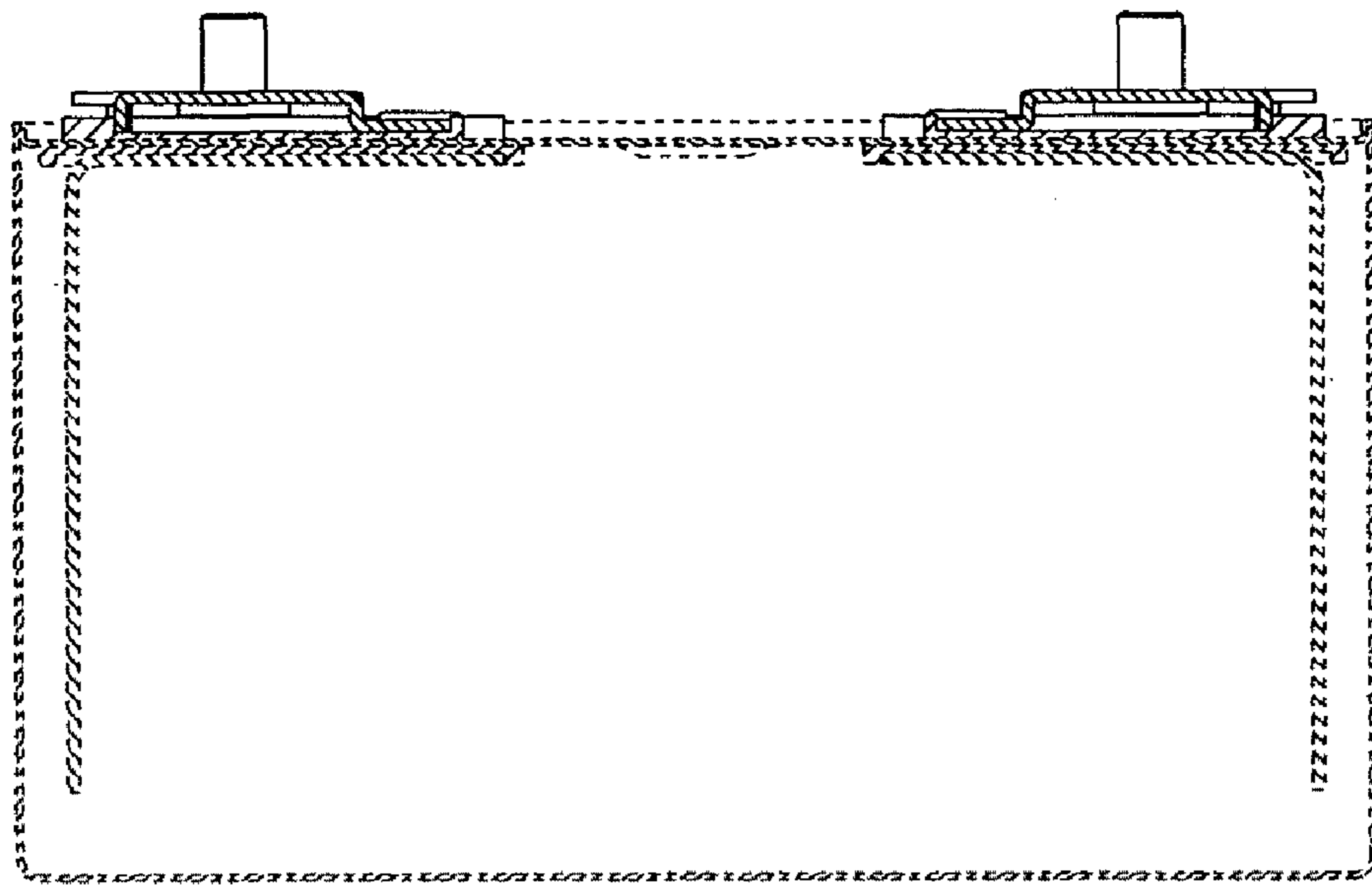

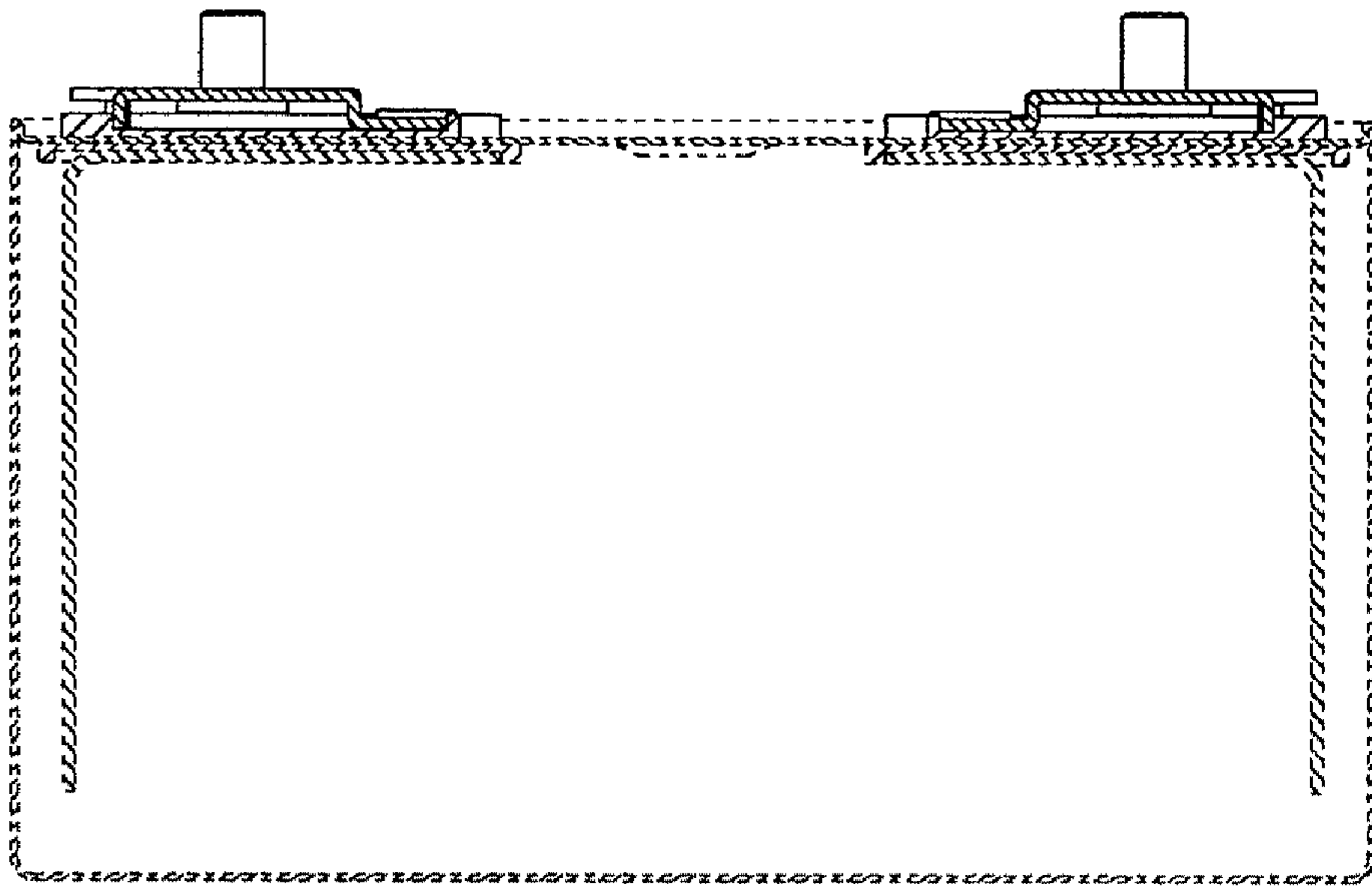

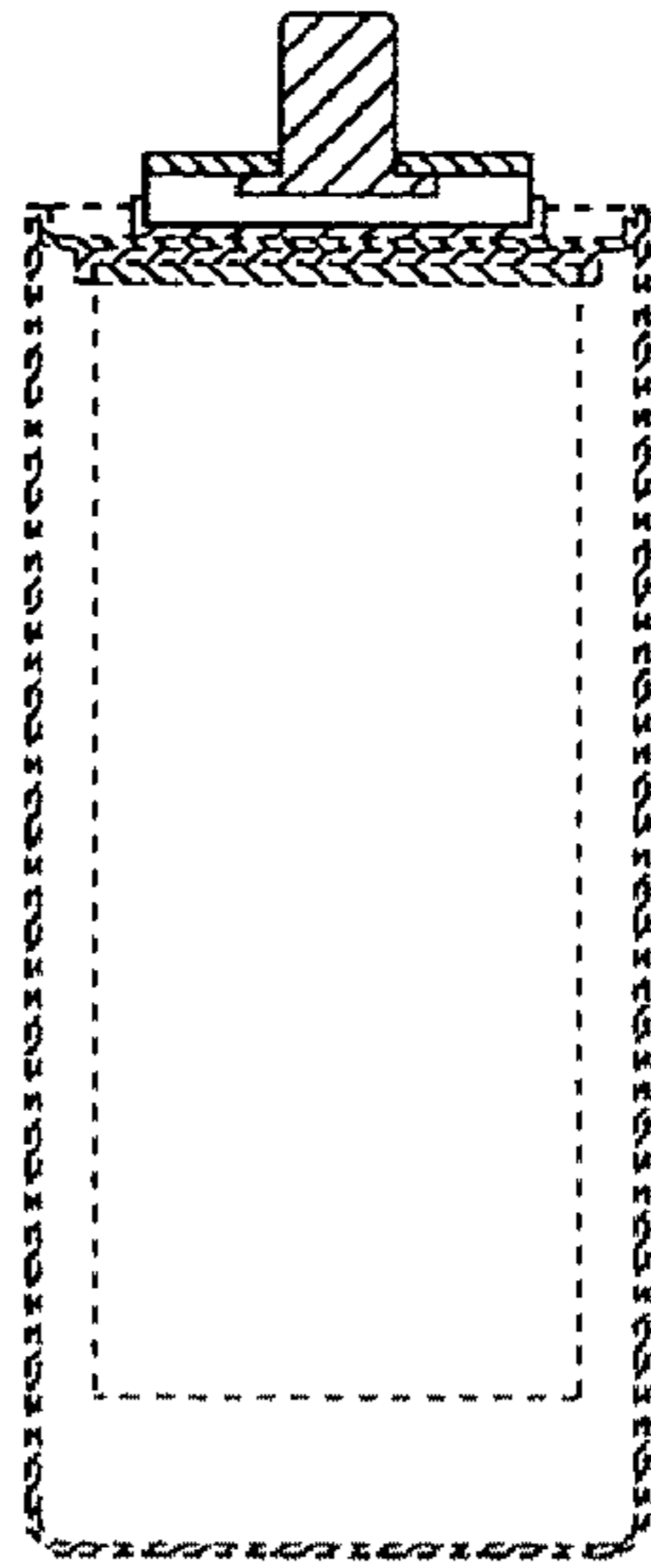

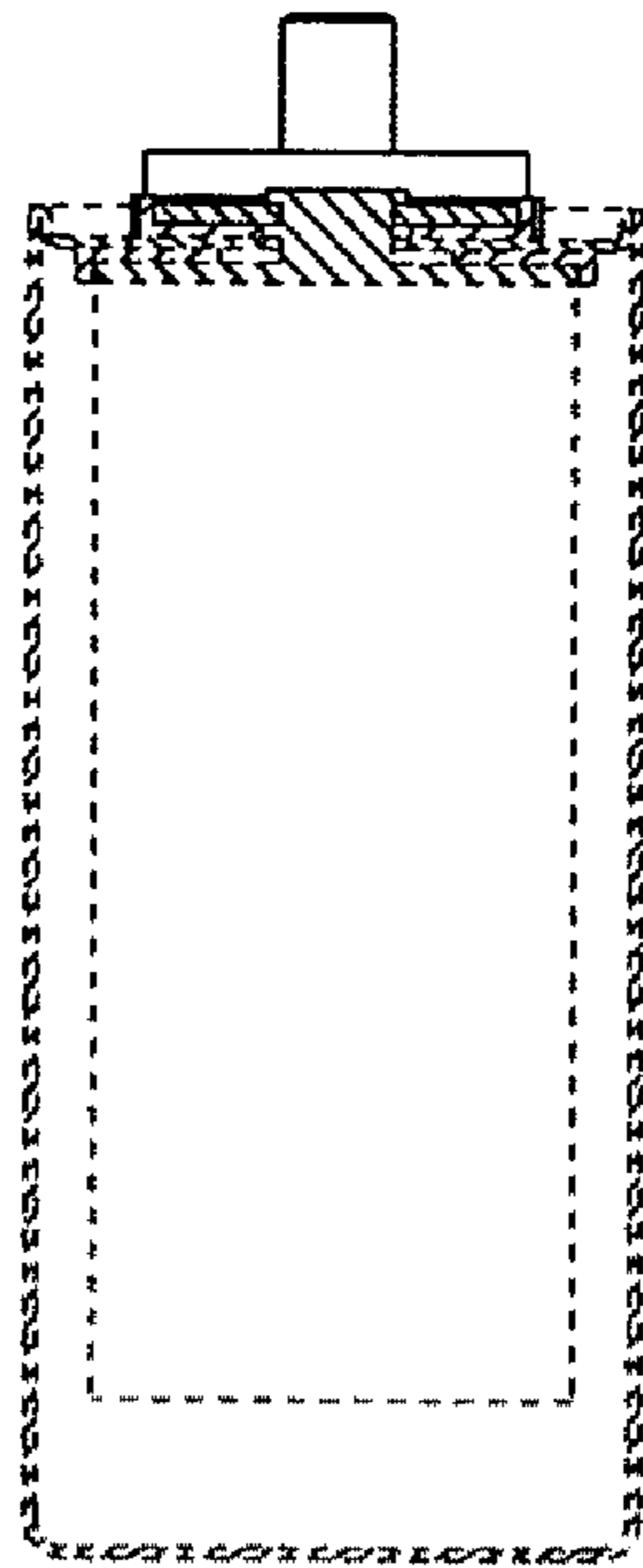

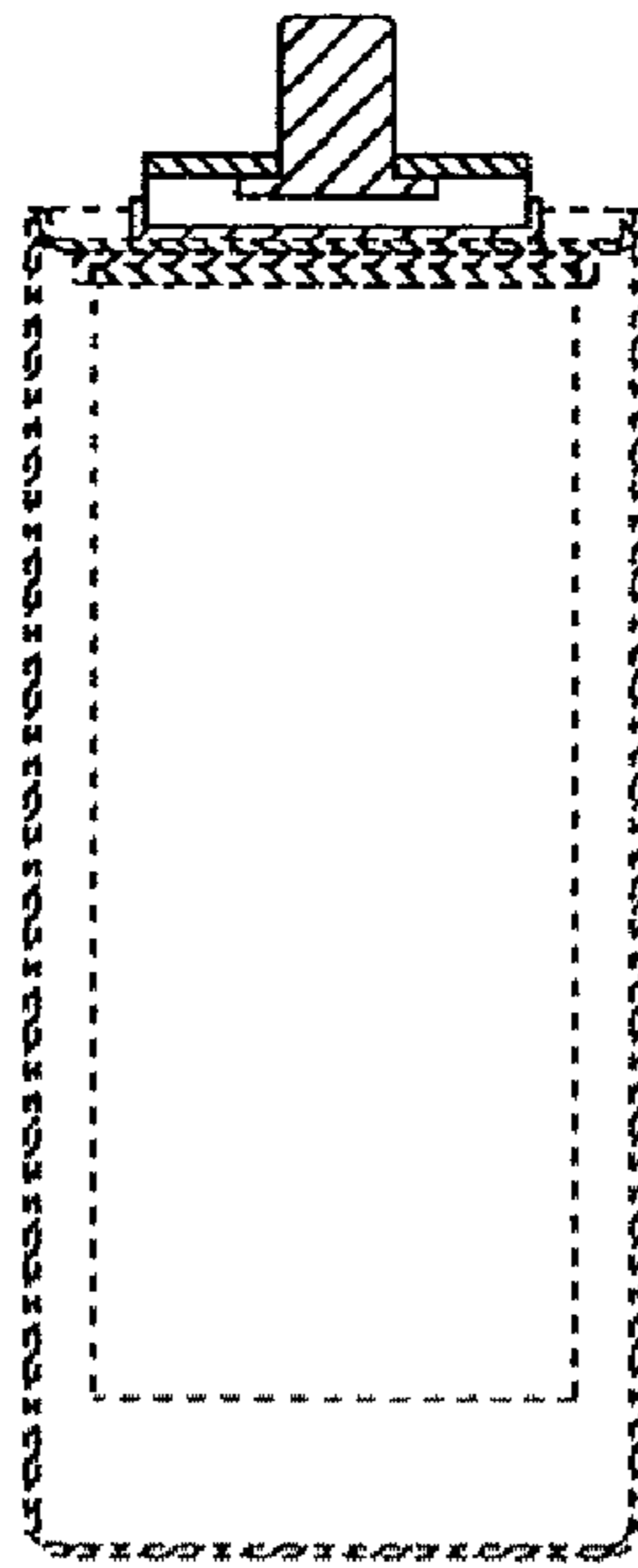

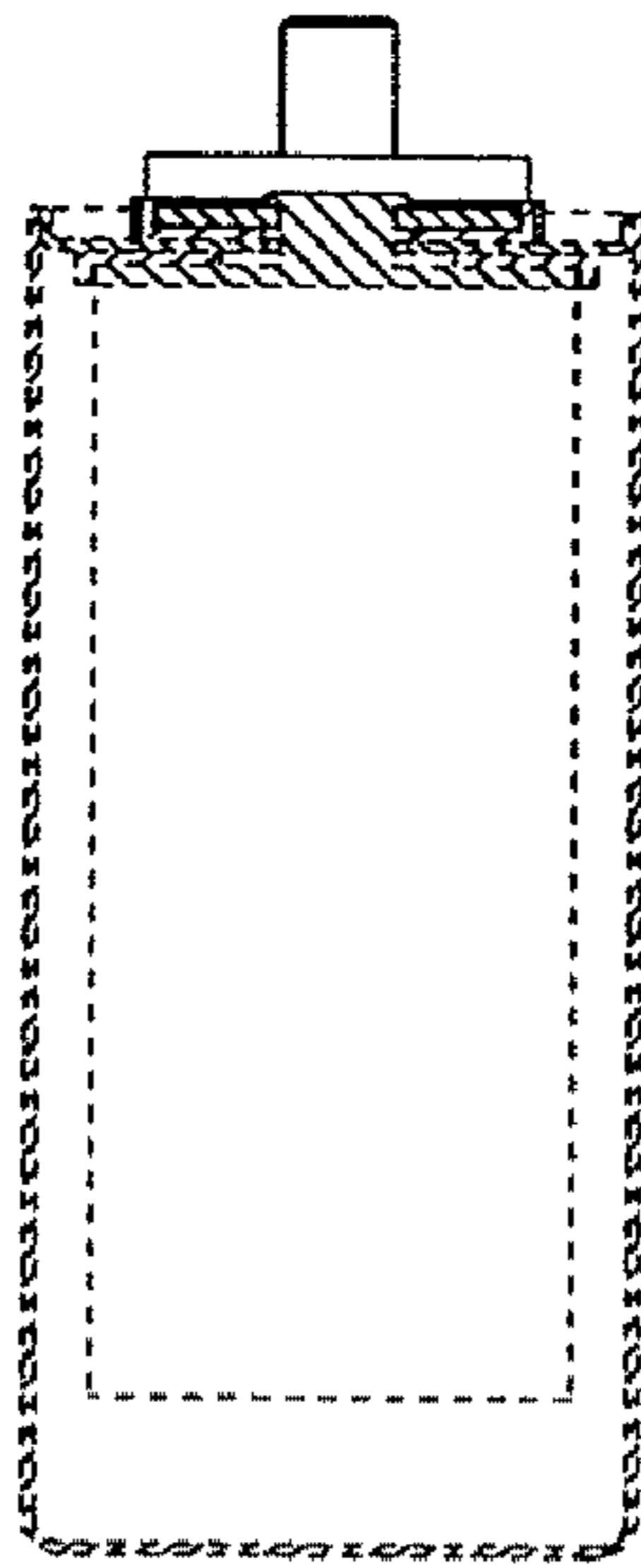
