(57) **CLAIM**

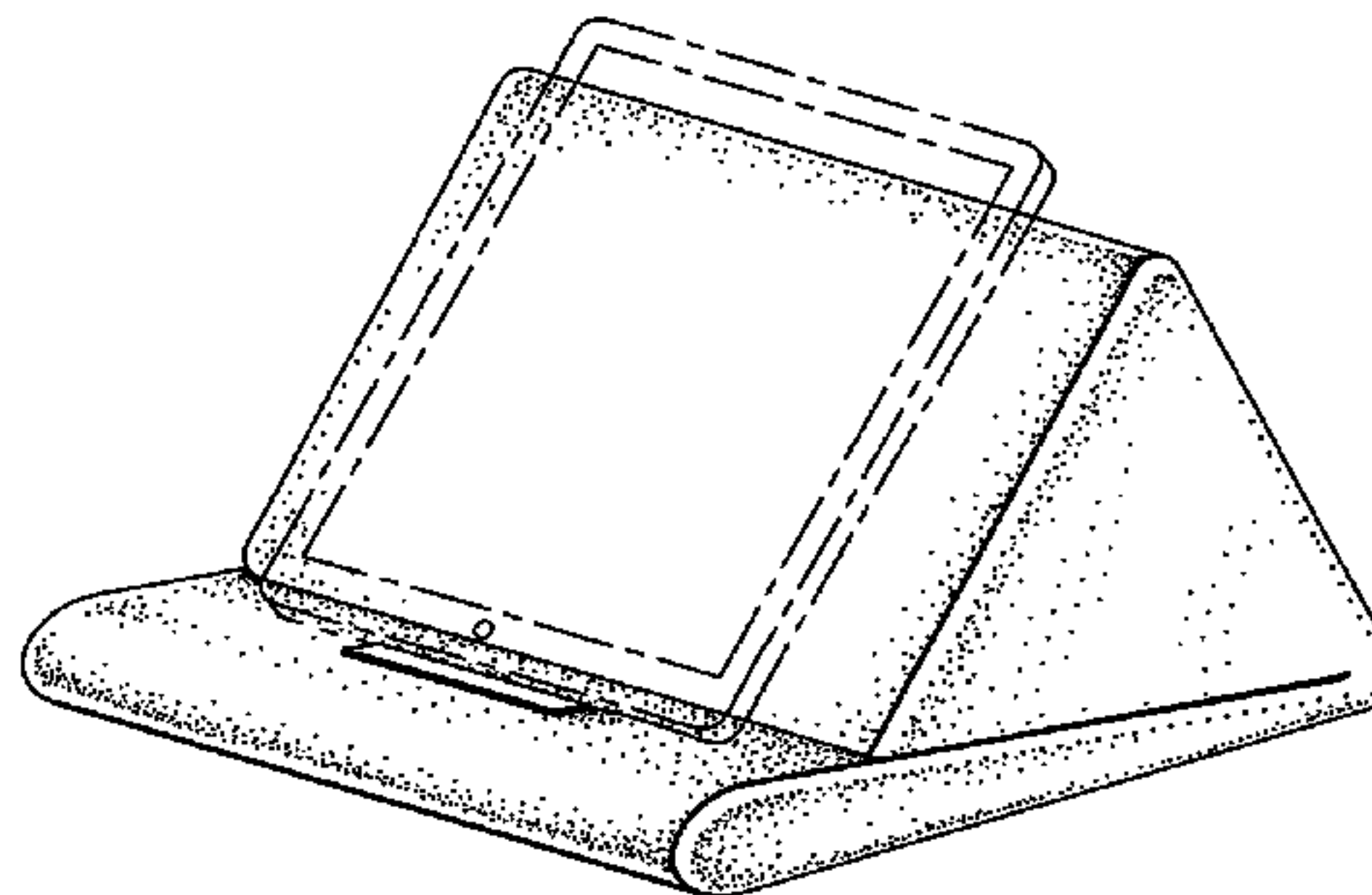
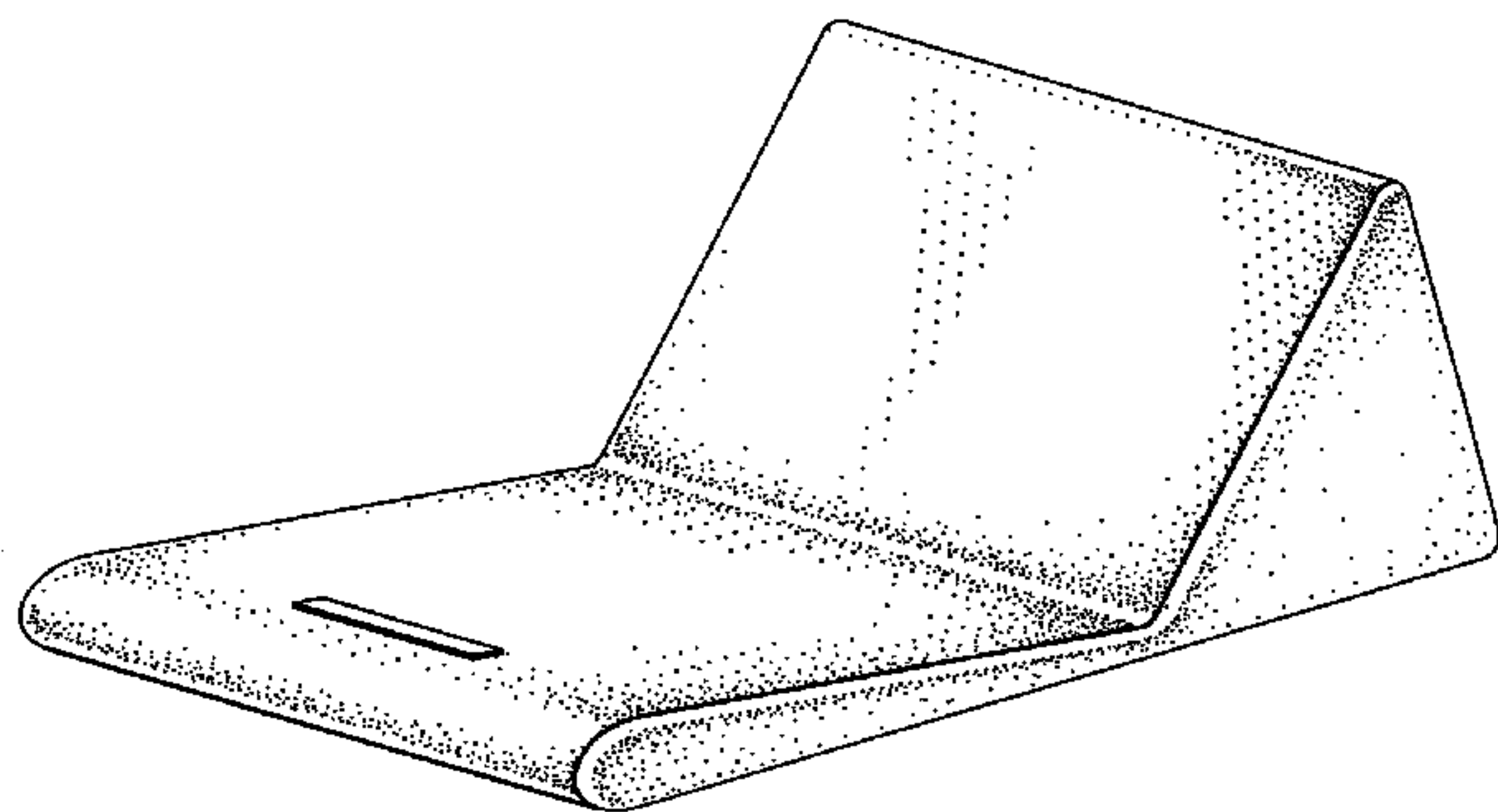
The ornamental design for a cushion for a flat computer, as shown and described.

**DESCRIPTION**

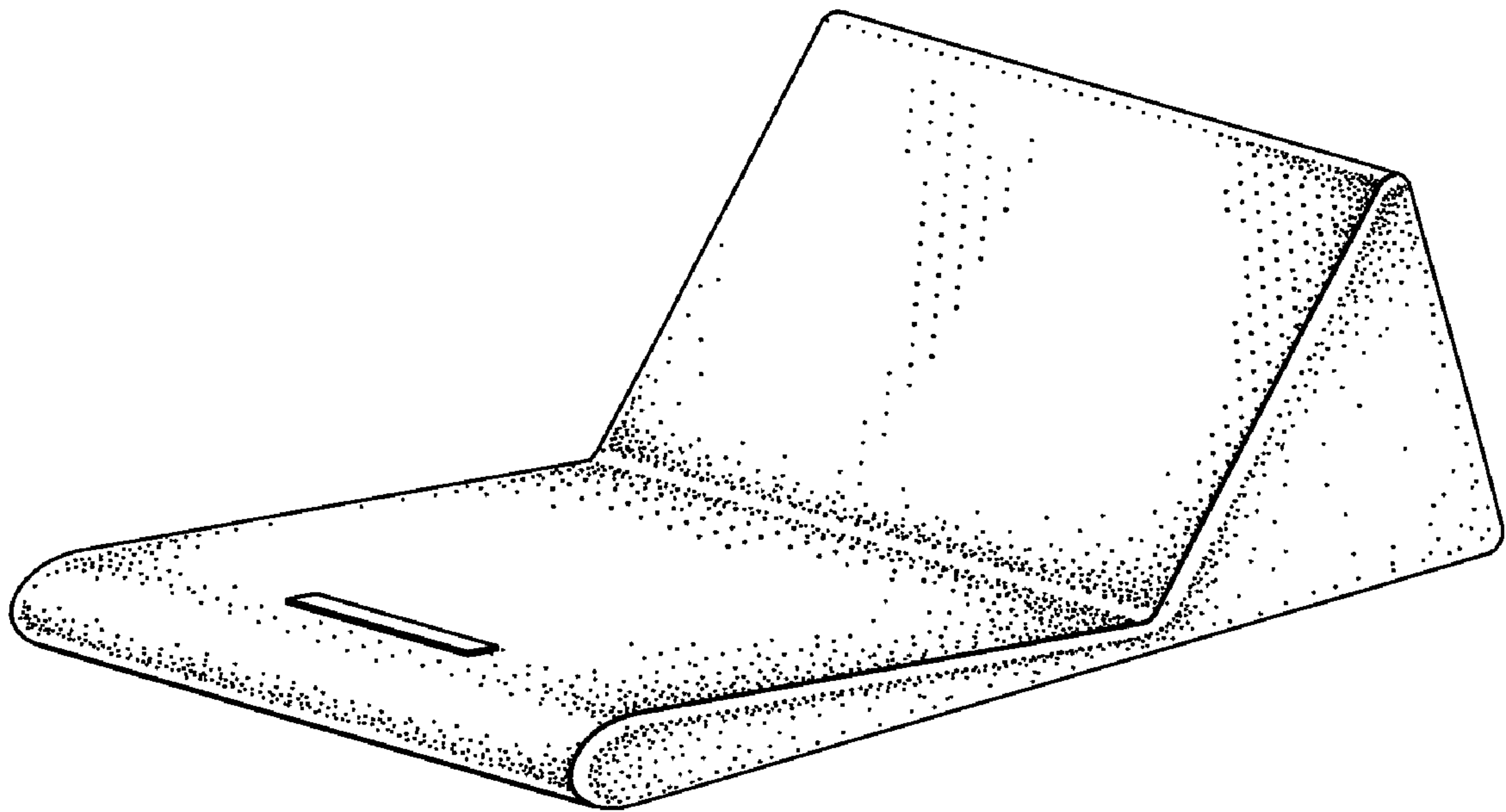

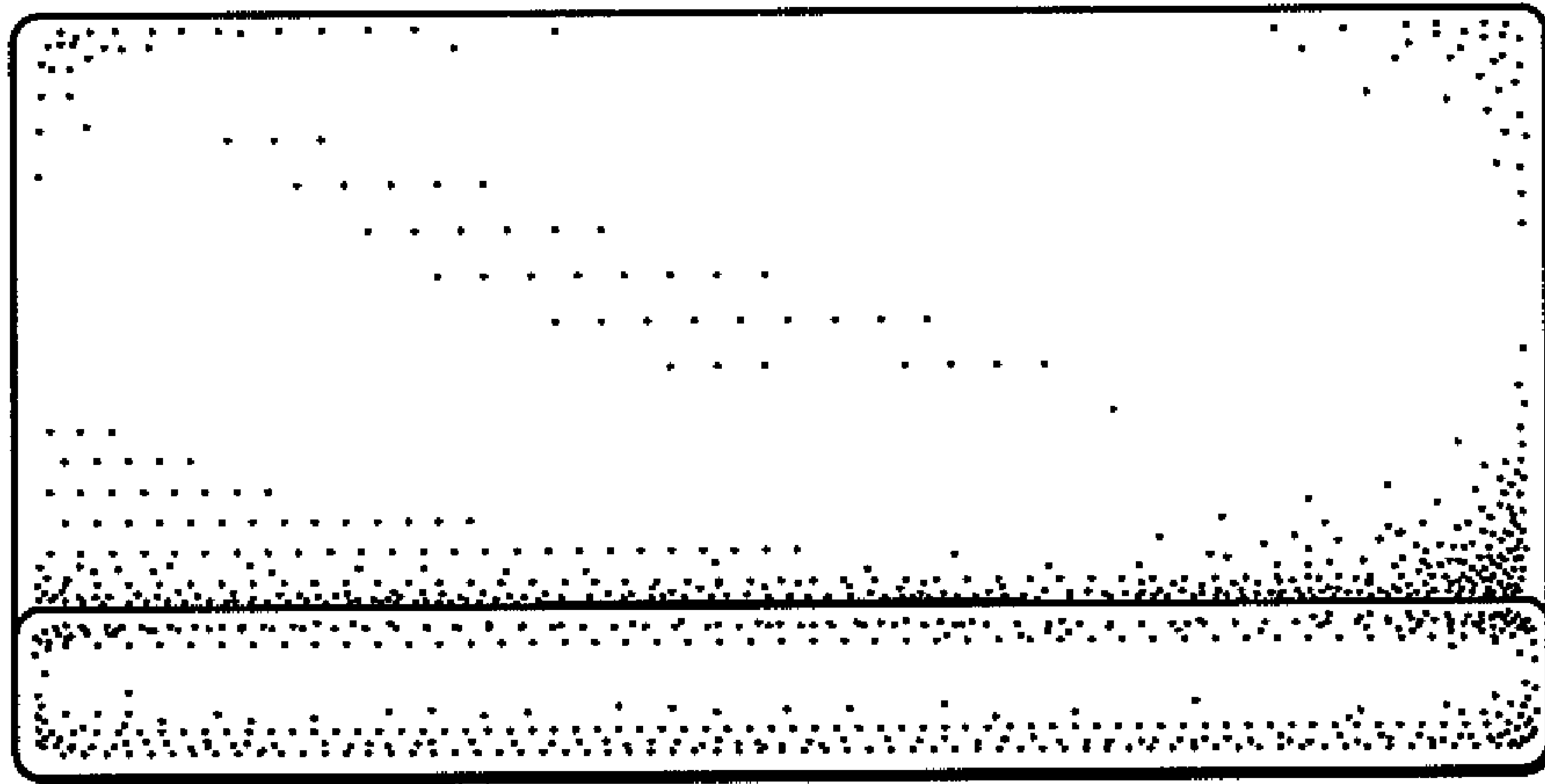

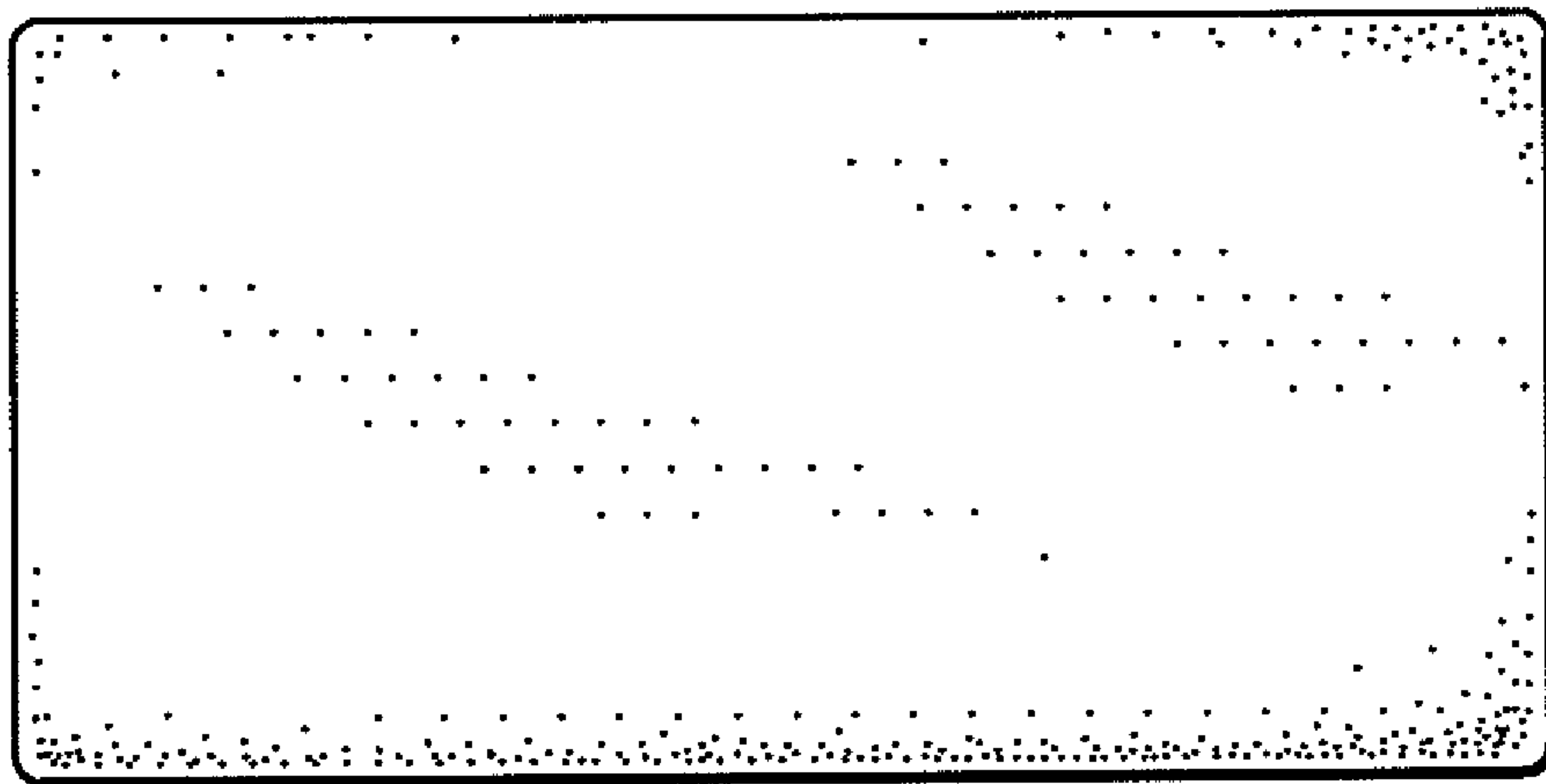

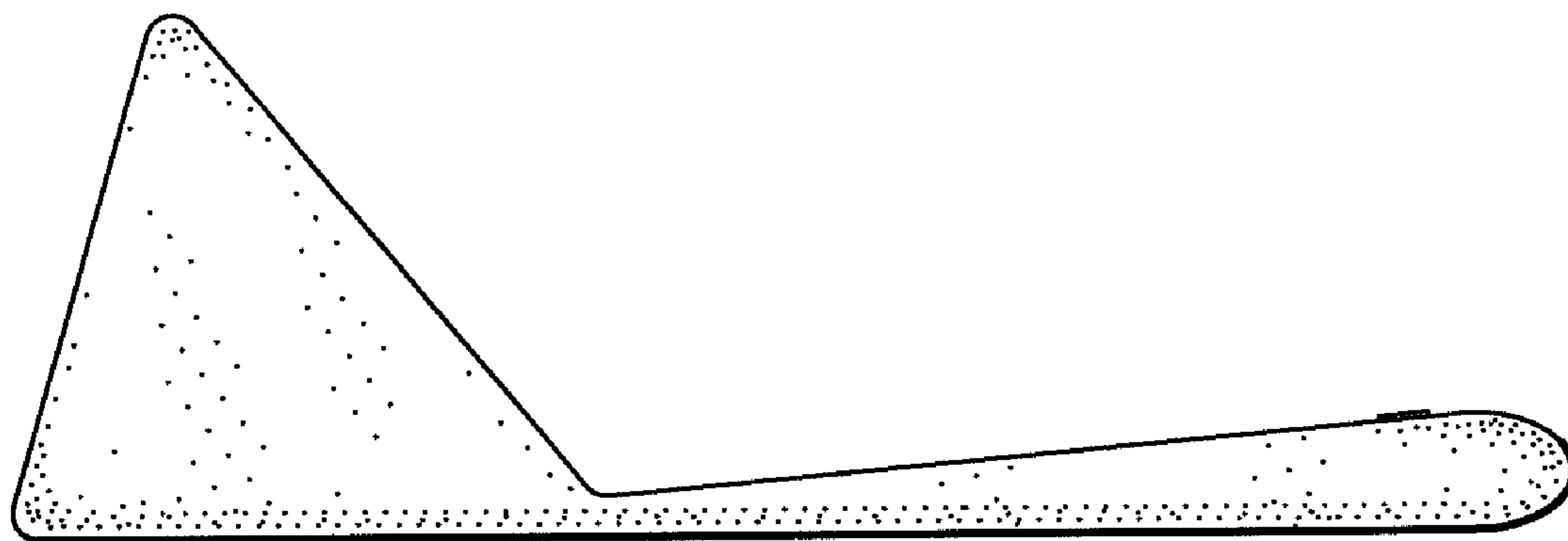

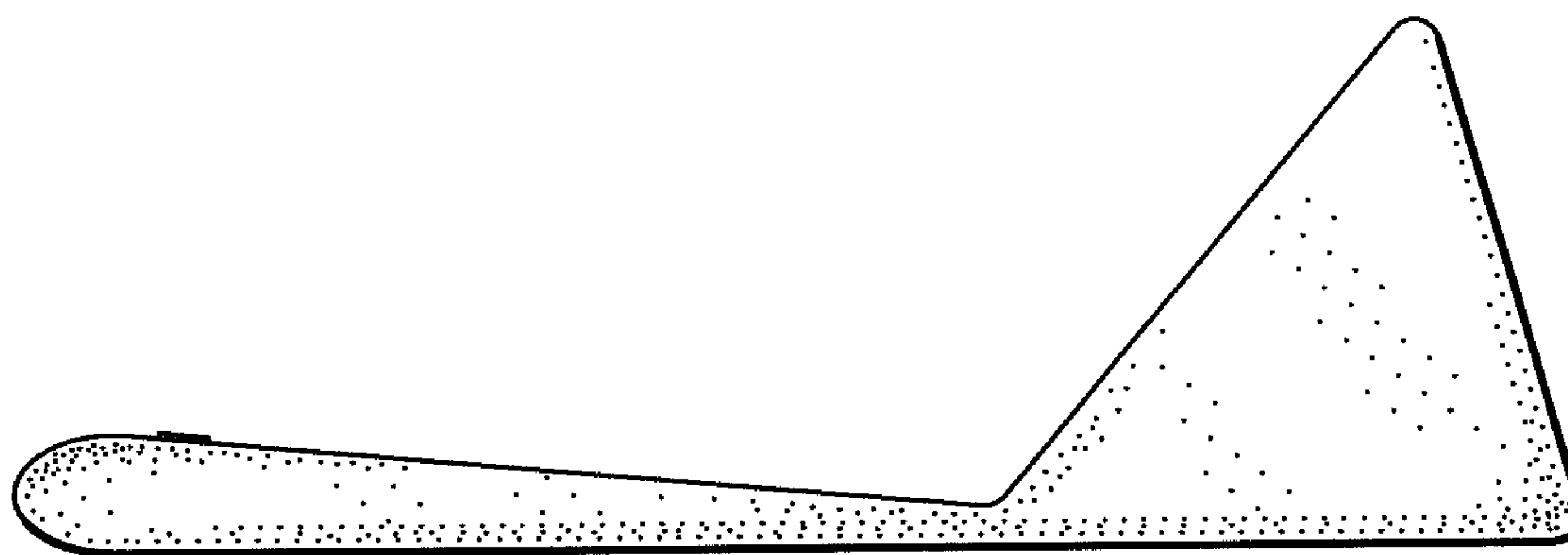

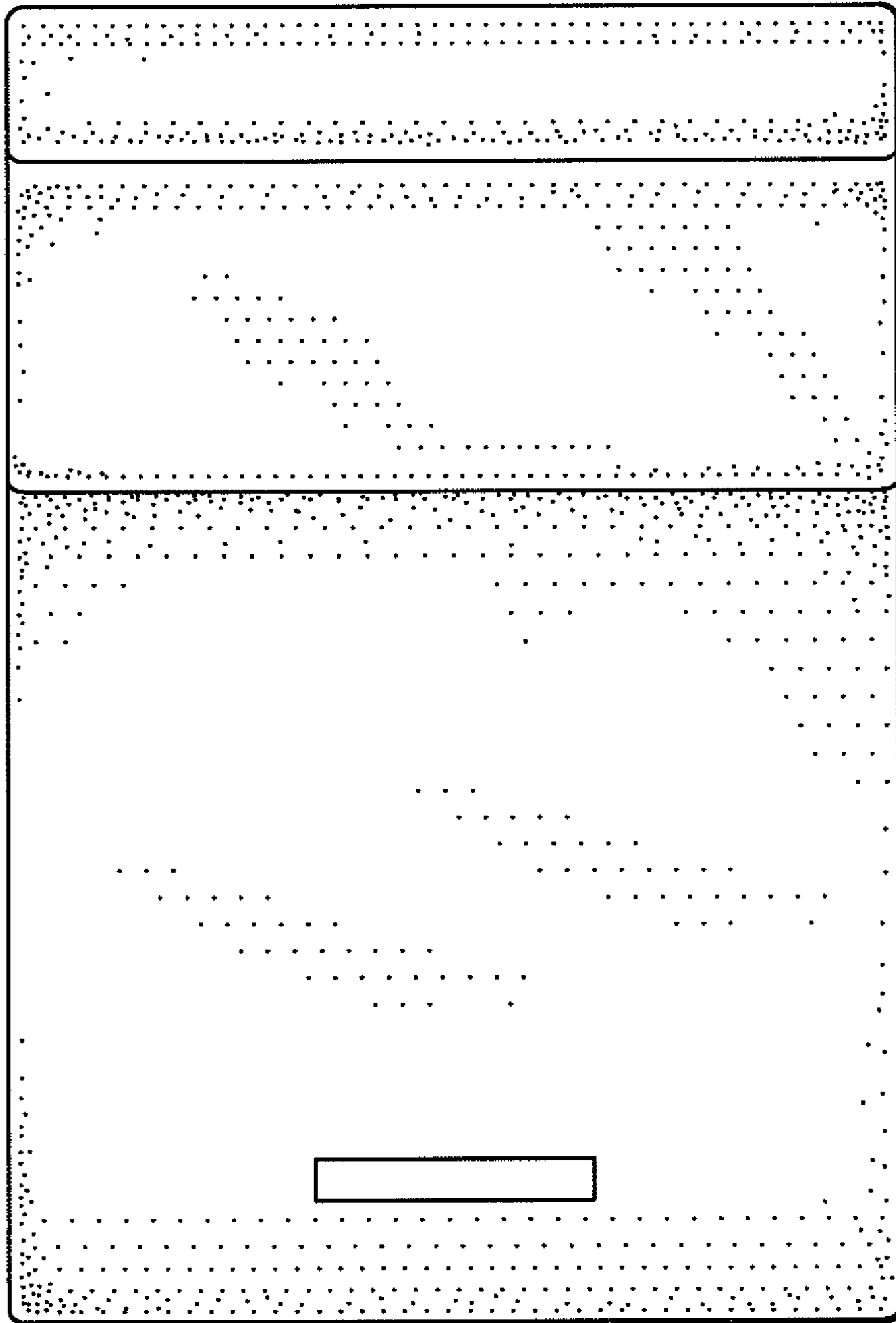

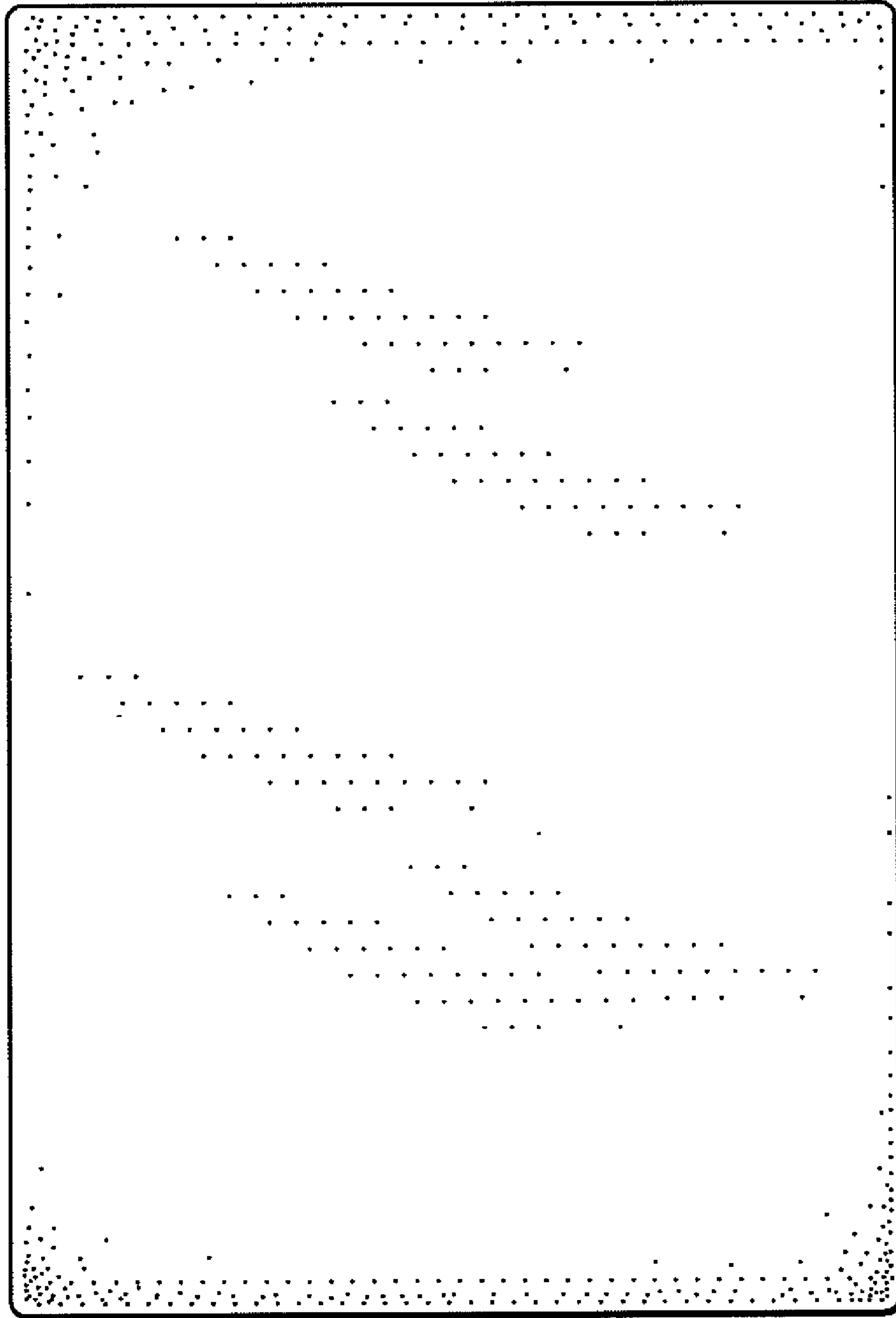

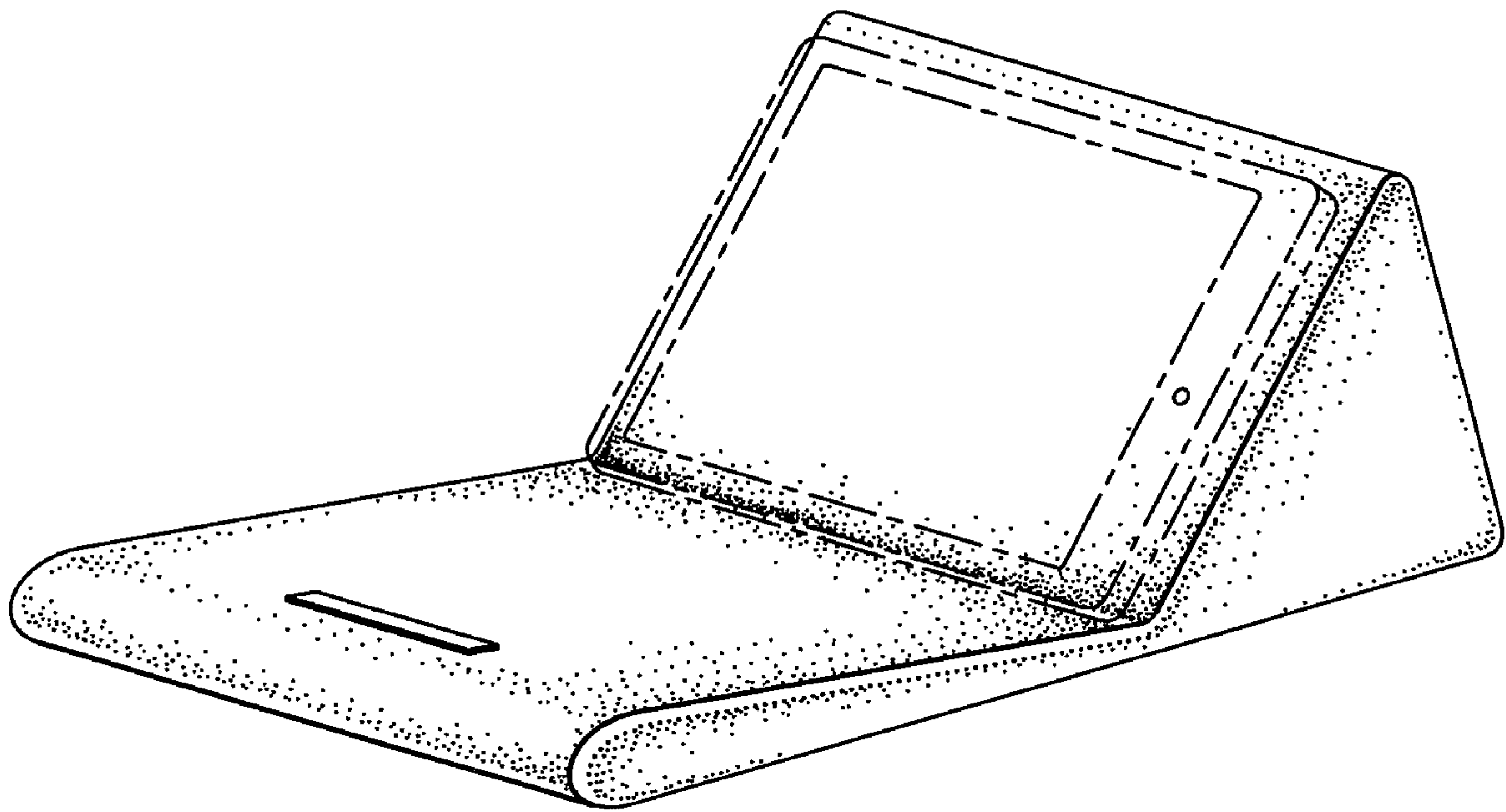

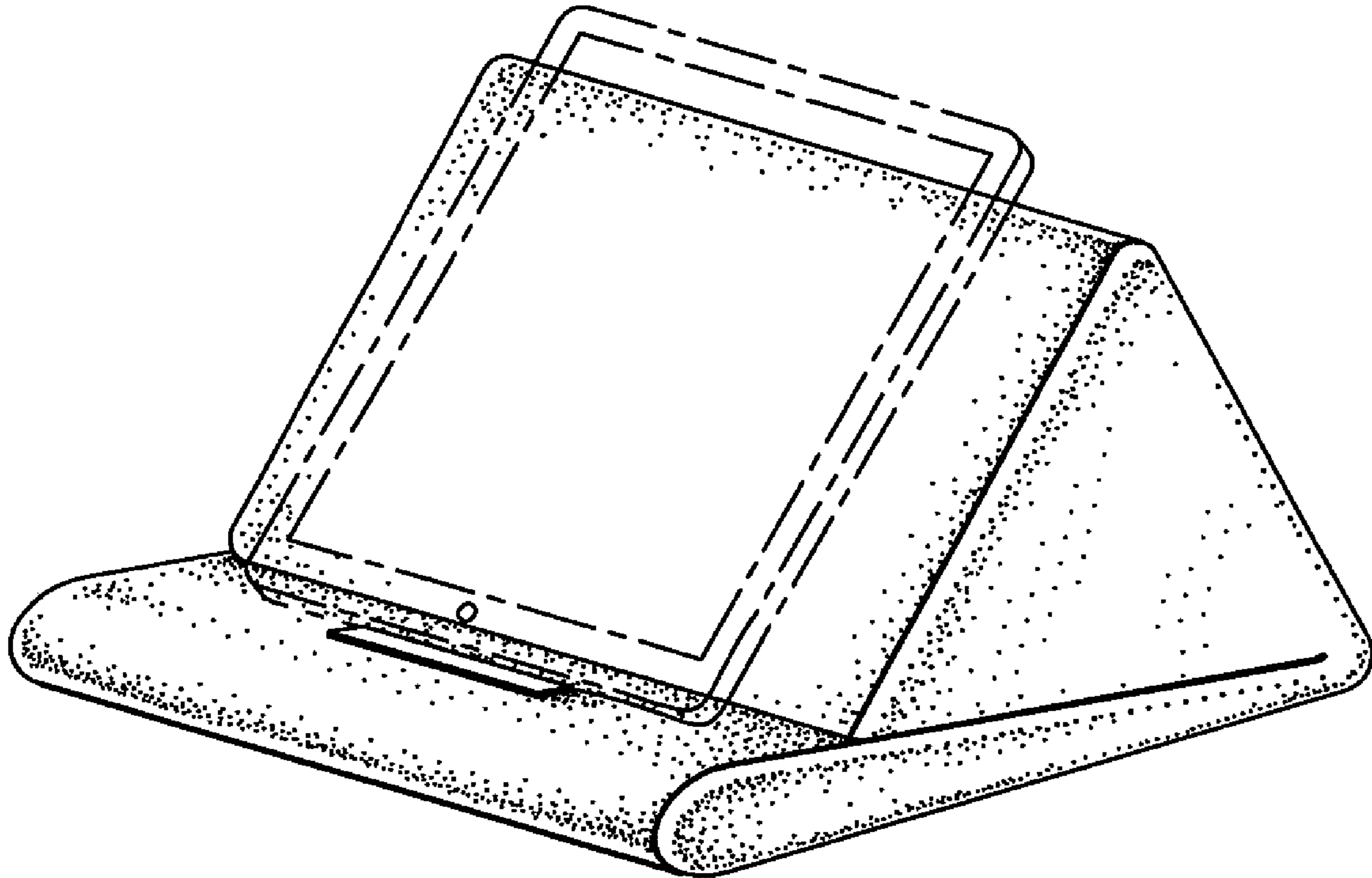
