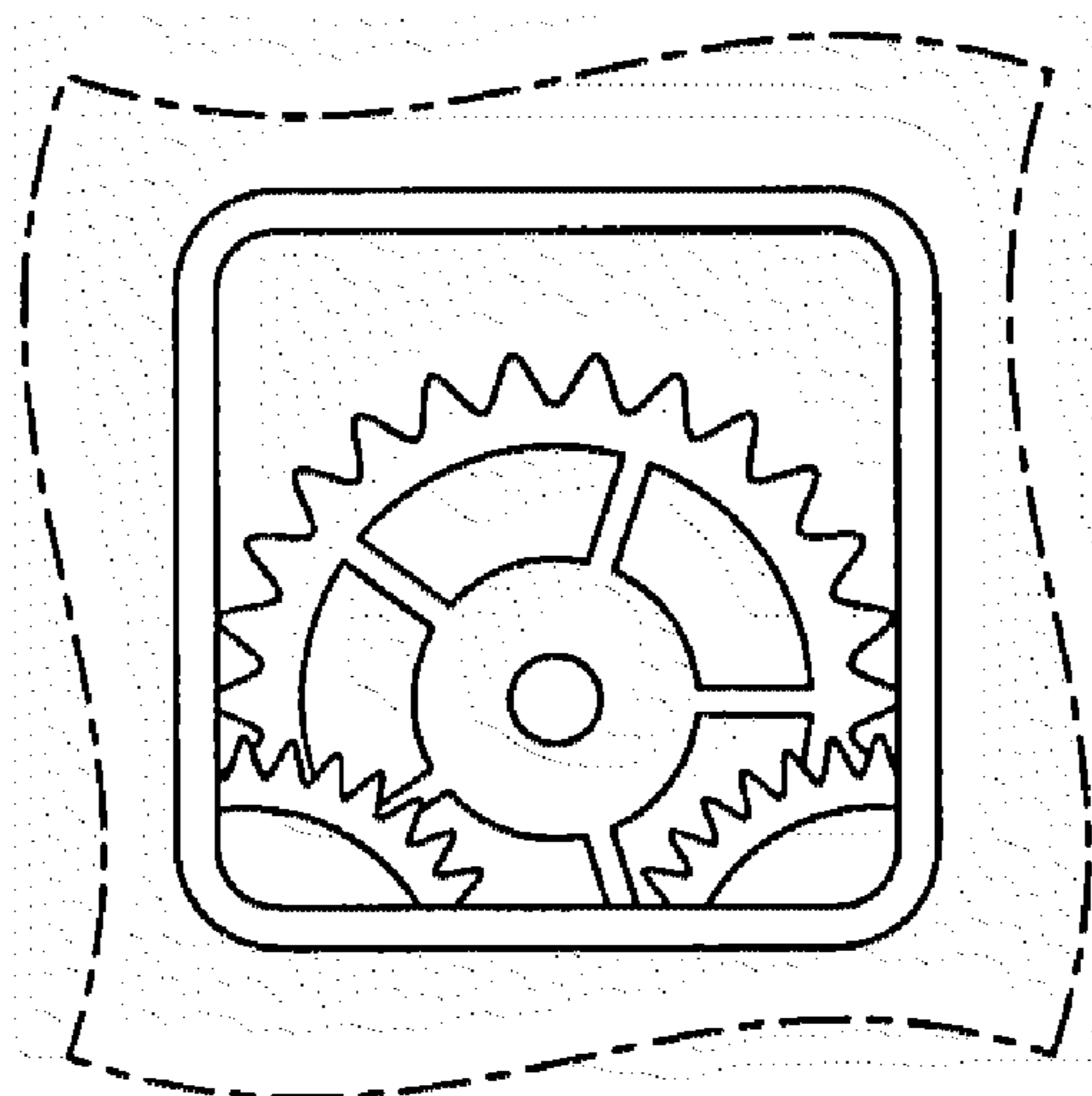
CLAIM

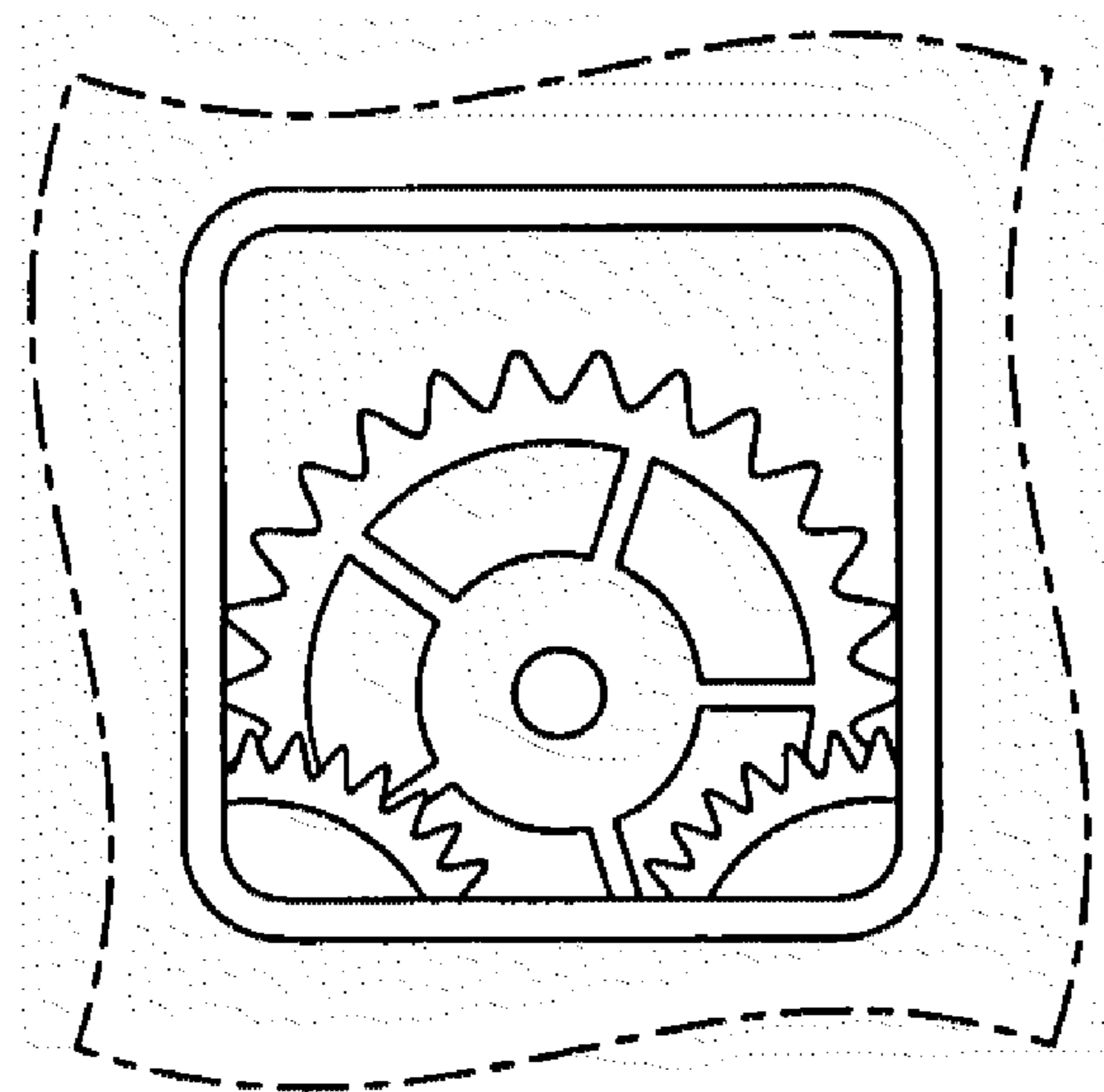
