(57) **CLAIM**

The ornamental design for a font having interchangeable indicia, as shown and described.

DESCRIPTION

FIG. 1 is a face view of the first embodiment of a font, representing capital letters “A” through “Z”, having interchangeable indicia;

FIG. 2 is a face view of the first embodiment of a font, representing numerals “0” through “9”, having interchangeable indicia;

FIG. 3 is a face view of the first embodiment of a font, representing characters “!”, “\$”, “%”, “&”, and “?”, having interchangeable indicia;

FIG. 4 is a face view showing exemplary indicia placed into the first embodiment of a font having interchangeable indicia; FIG. 5 is a face view of the second embodiment of a font, representing capital letters “A” through “Z”, having interchangeable indicia;

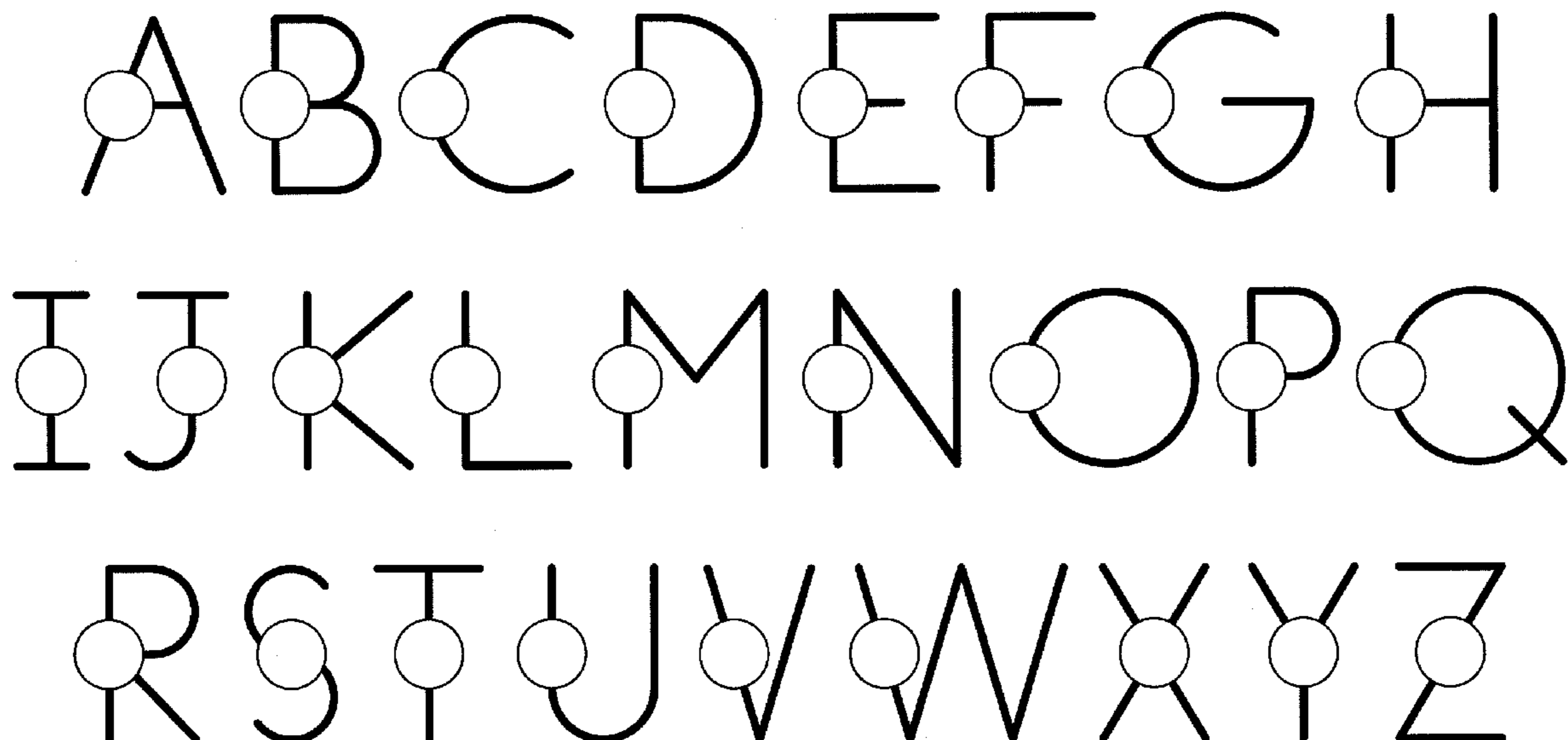
FIG. 6 is a face view of the second embodiment of a font, representing numerals “0” through “9”, having interchangeable indicia;

FIG. 7 is a face view of the second embodiment of a font, representing characters “!”, “\$”, “%”, “&”, and “?”, having interchangeable indicia; and,

FIG. 8 is a face view showing exemplary indicia placed into the second embodiment of a font having interchangeable indicia.

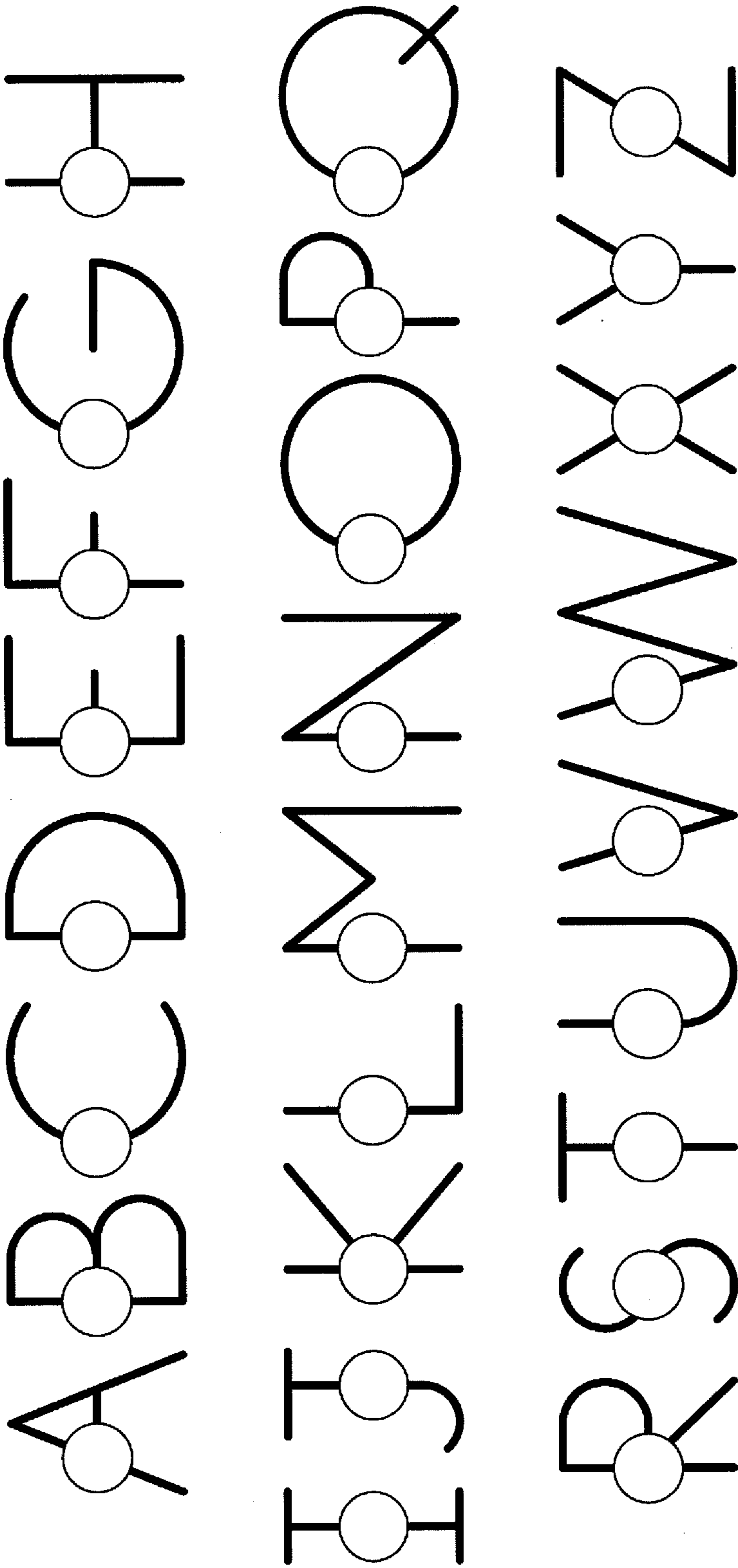

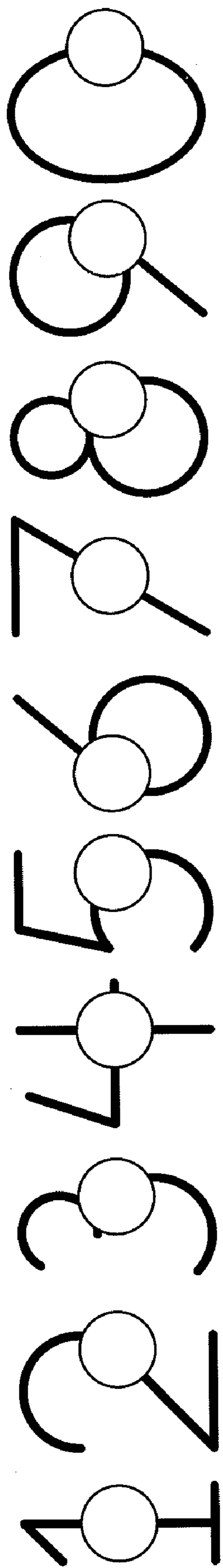

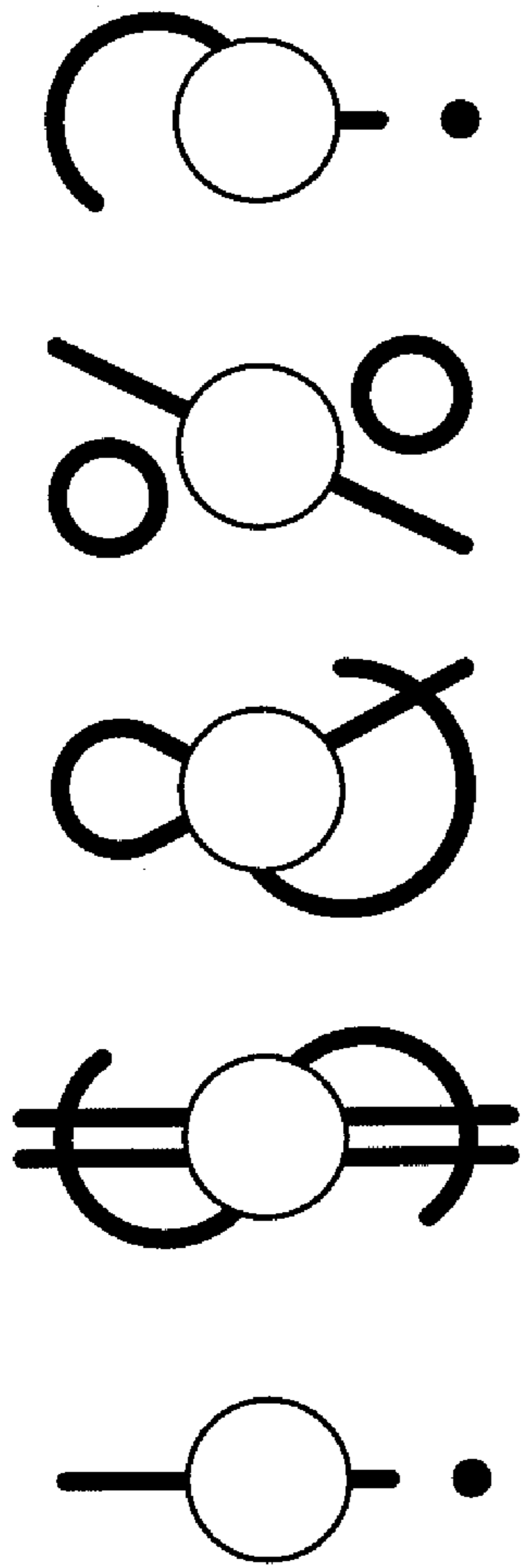

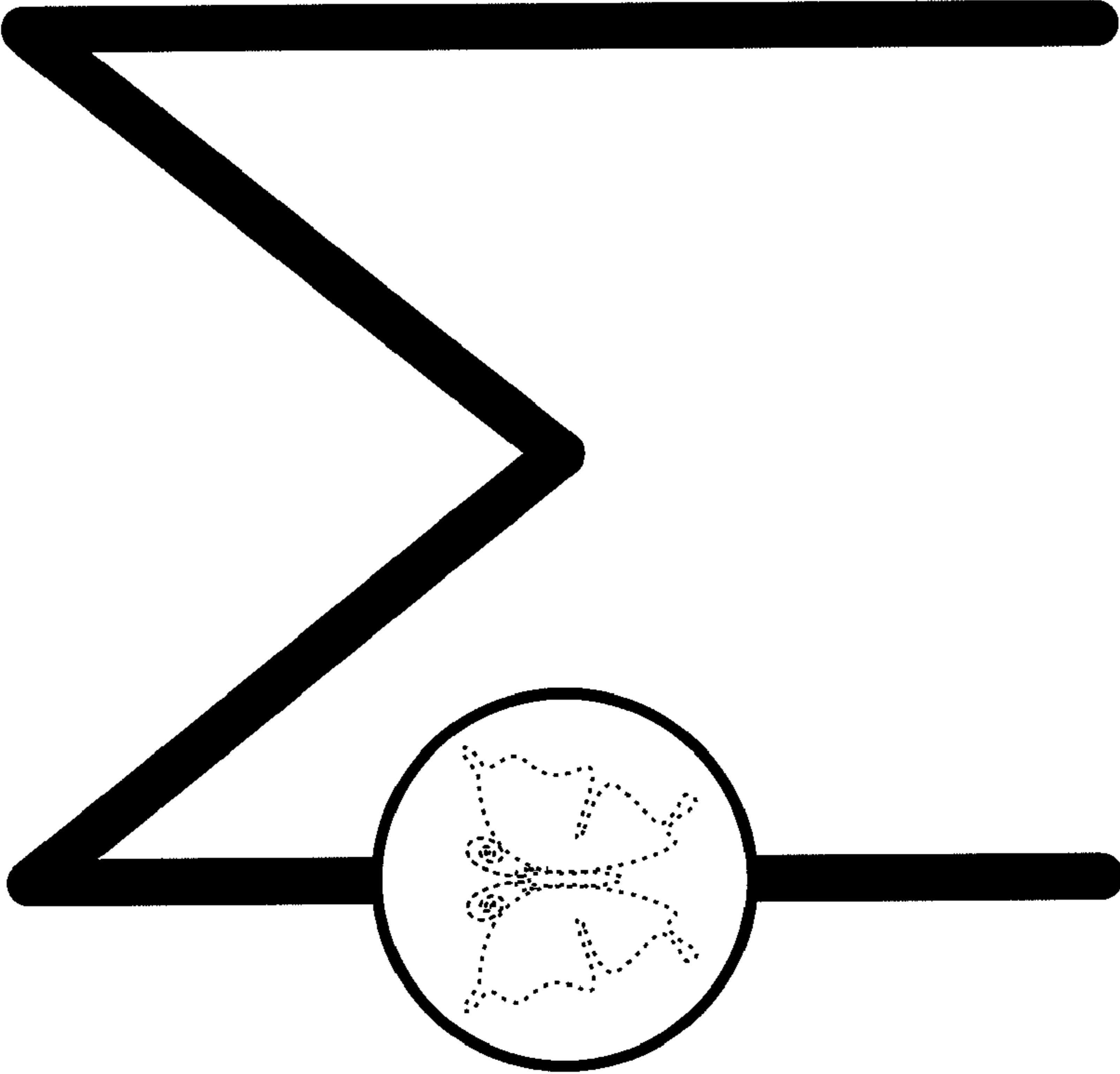

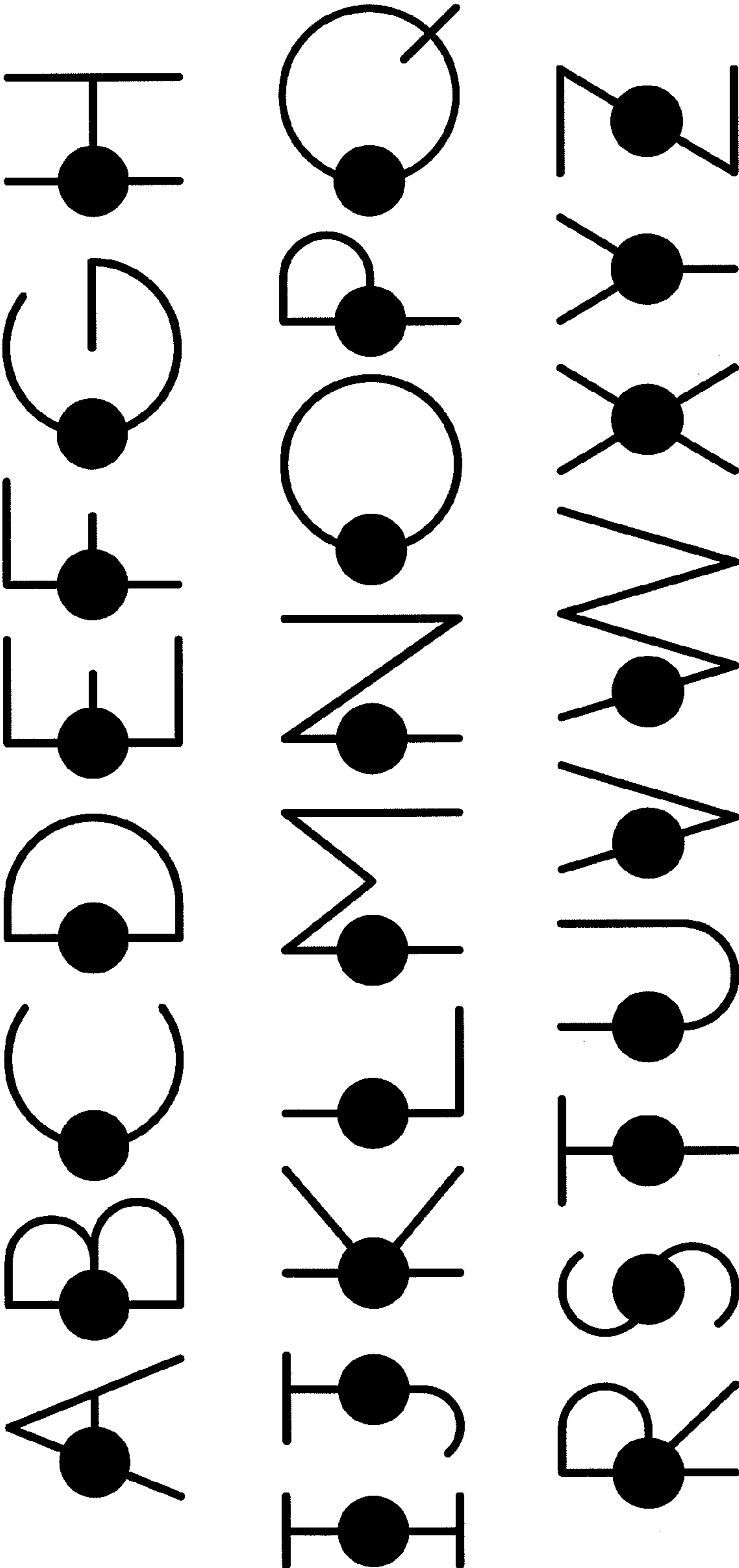

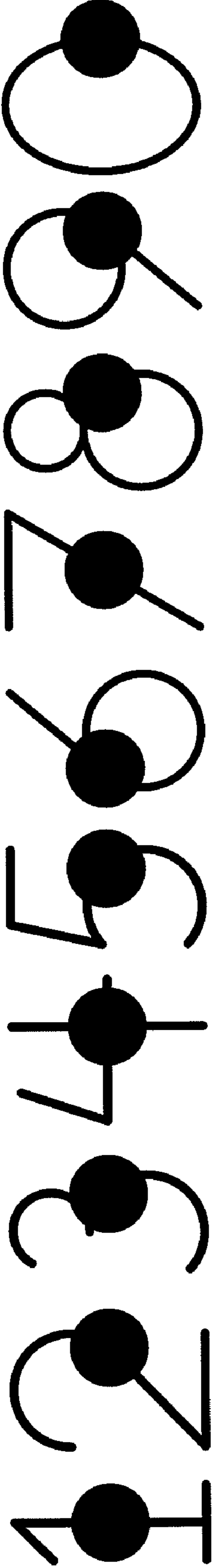

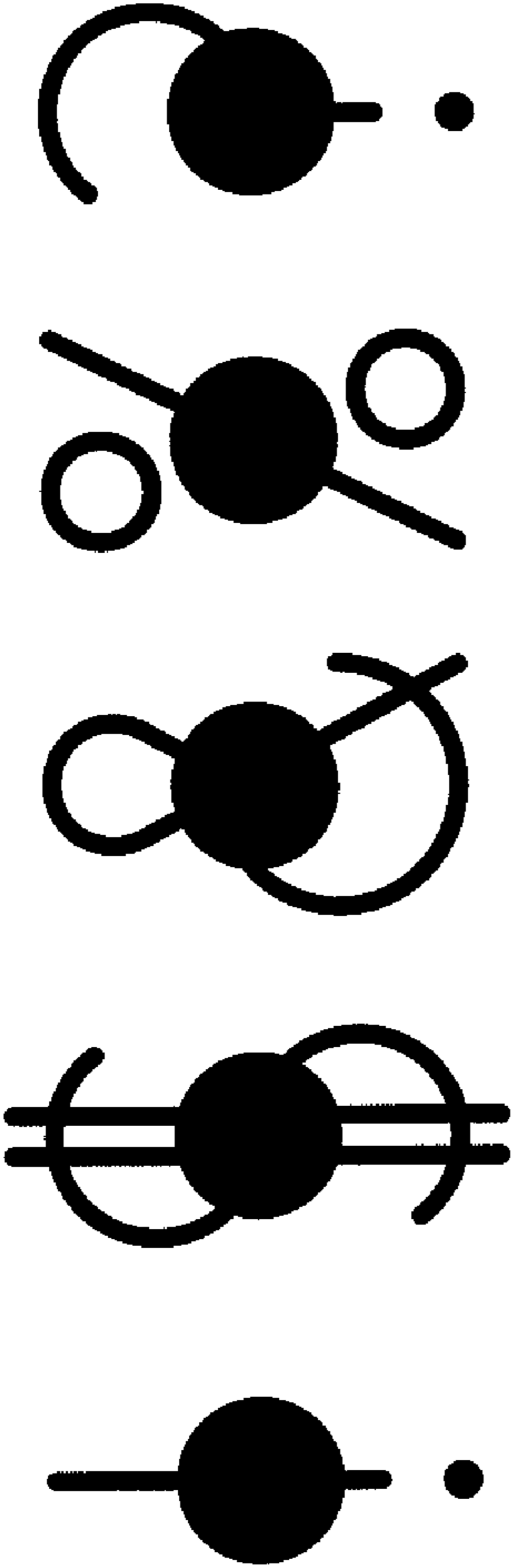

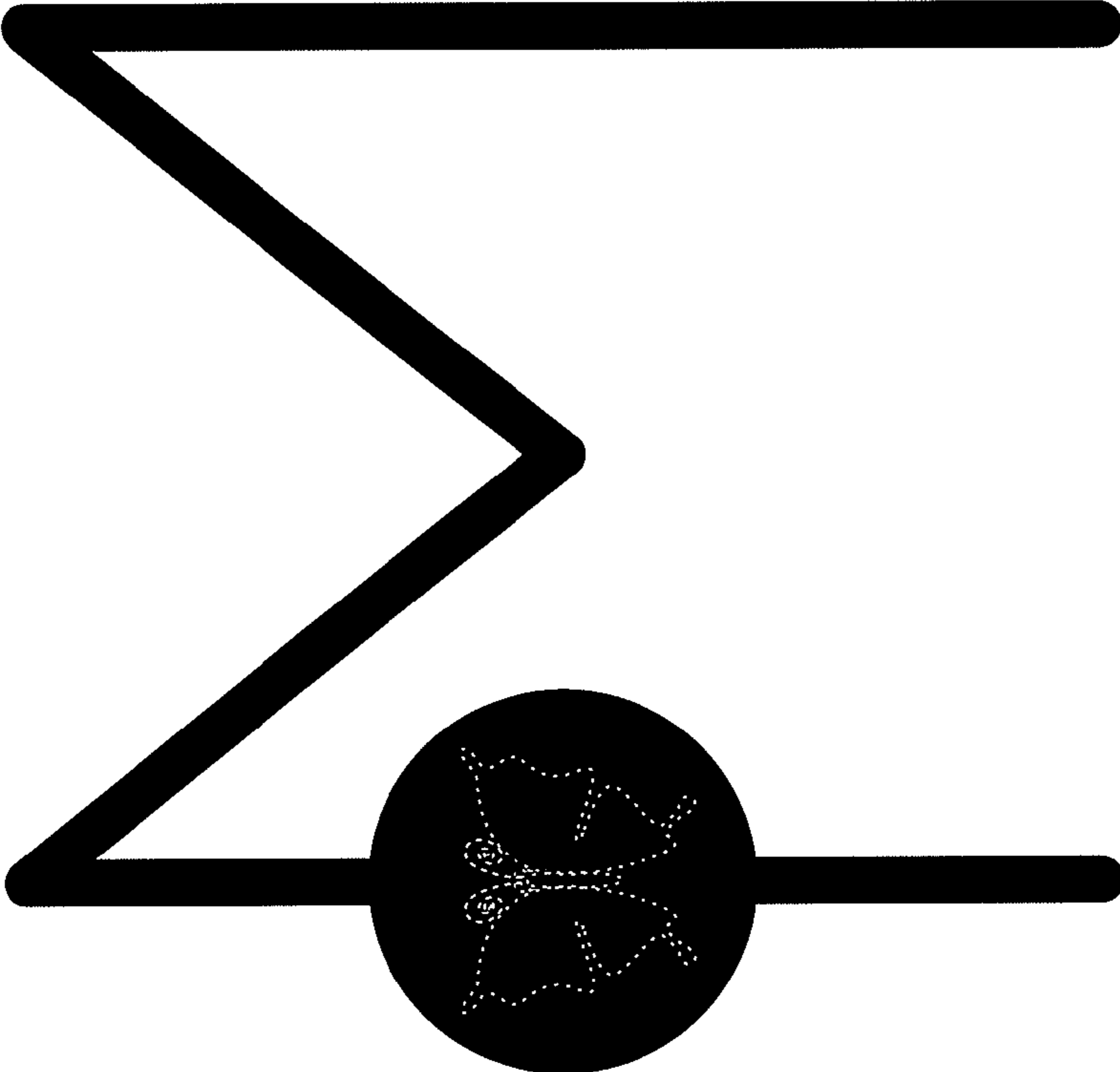
