(57) **CLAIM**

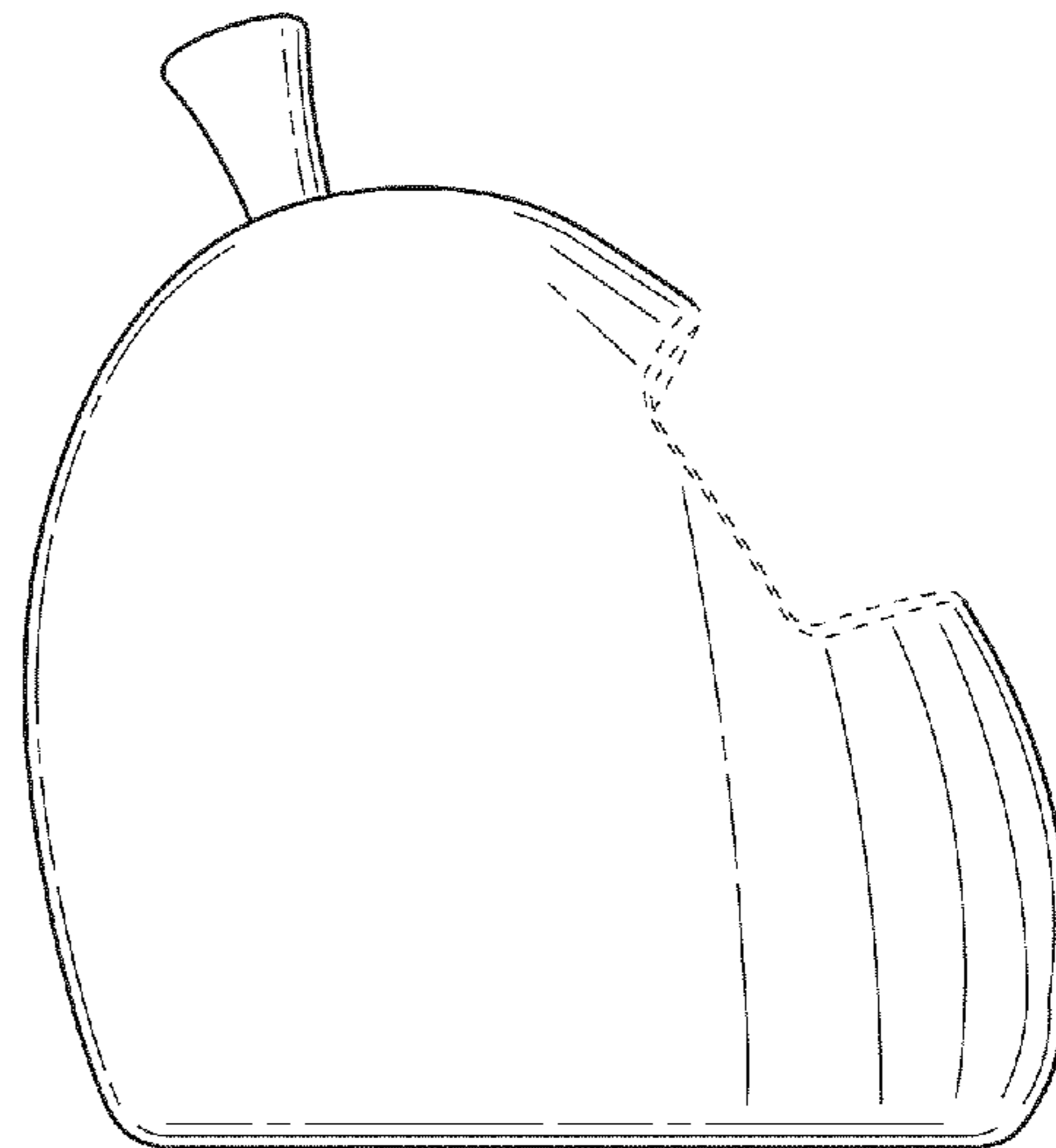
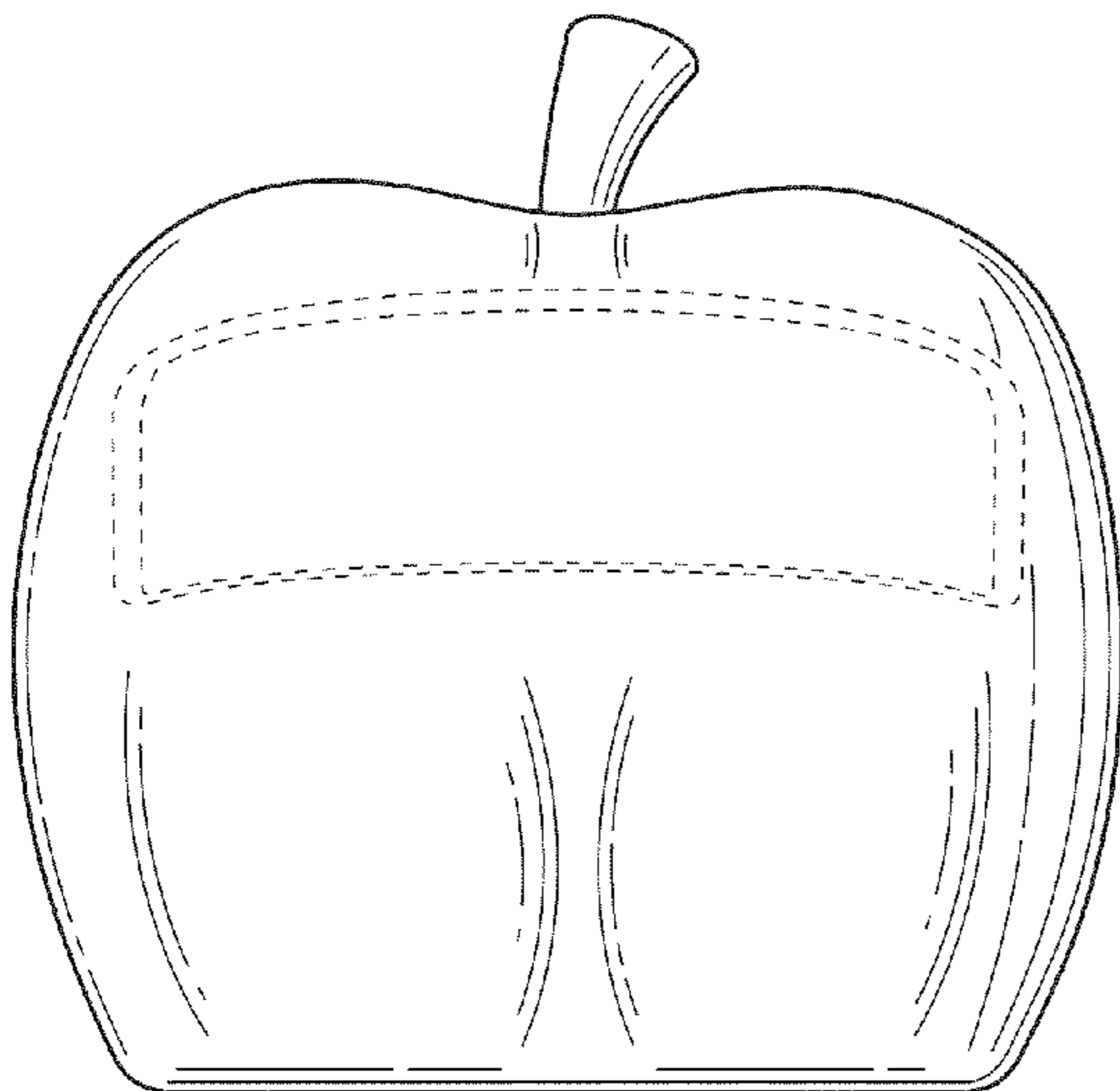
The ornamental design for an apple shaped dispenser for notes, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the new design for an apple shaped dispenser for notes;
FIG. 2 is a front view thereof;
FIG. 3 is a back view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

The broken lines showing the slot in the dispenser in FIGS. 1, 2, 4, 5, and 6 are included to show a feature that forms no part of the claimed design.

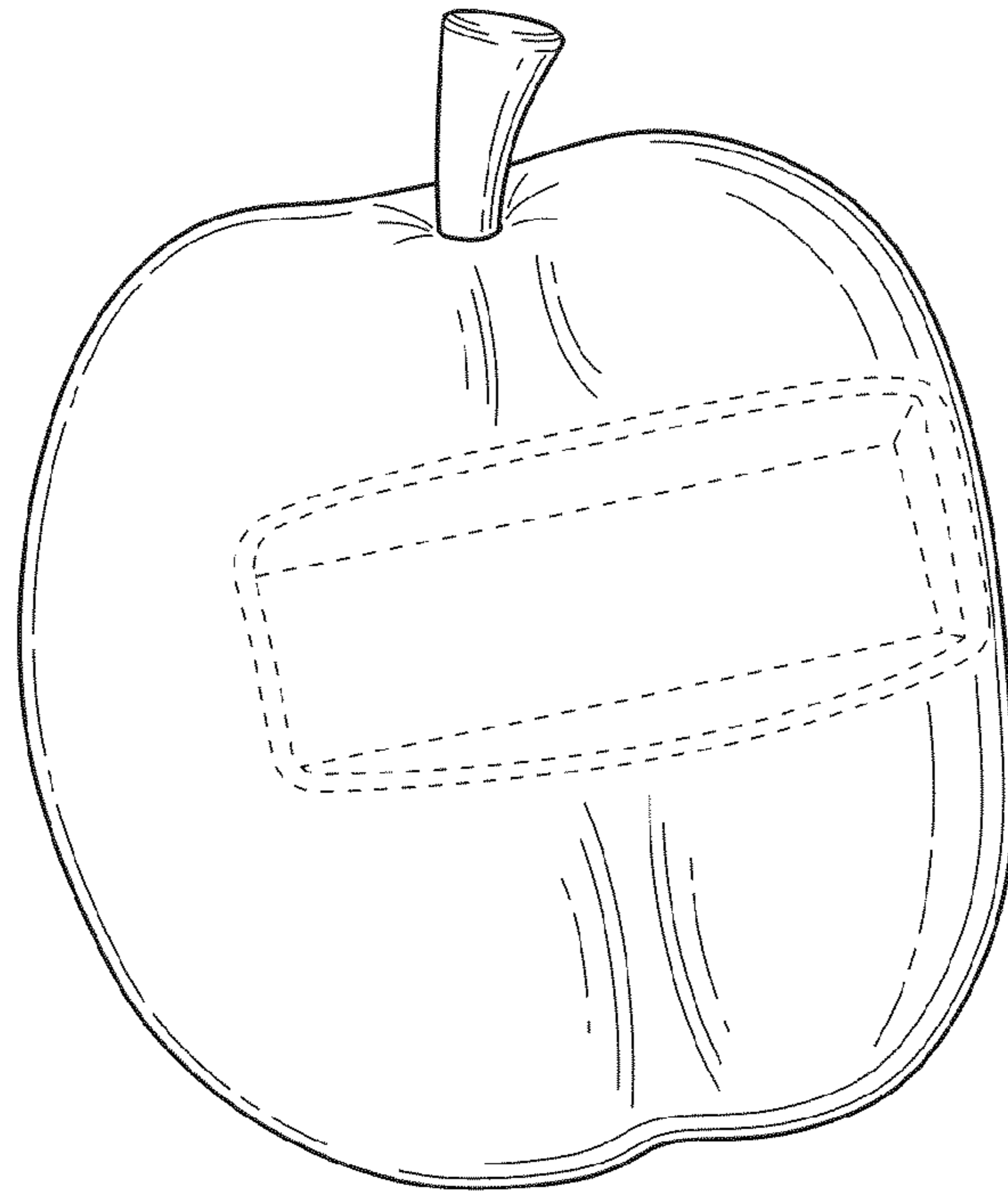

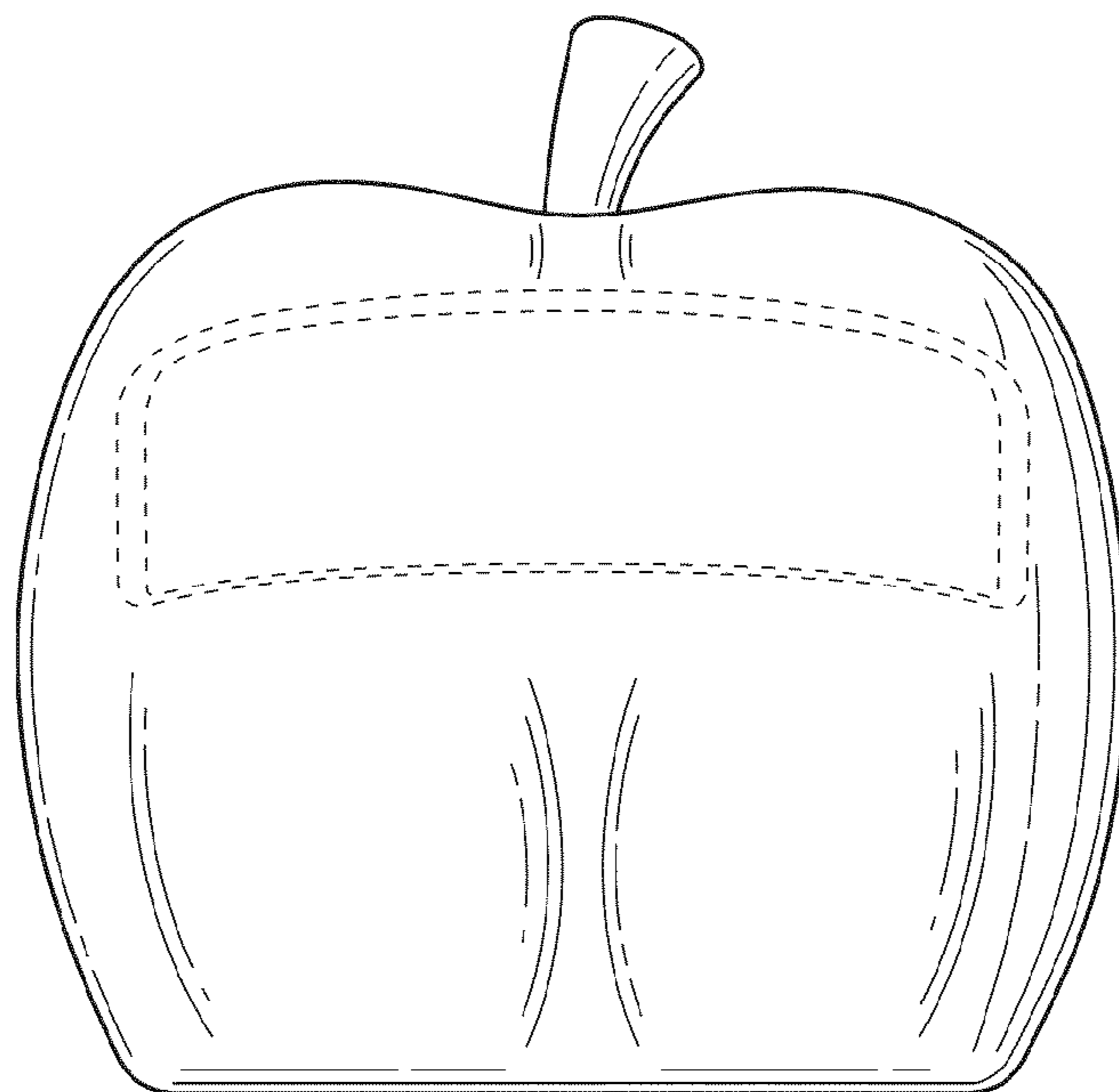

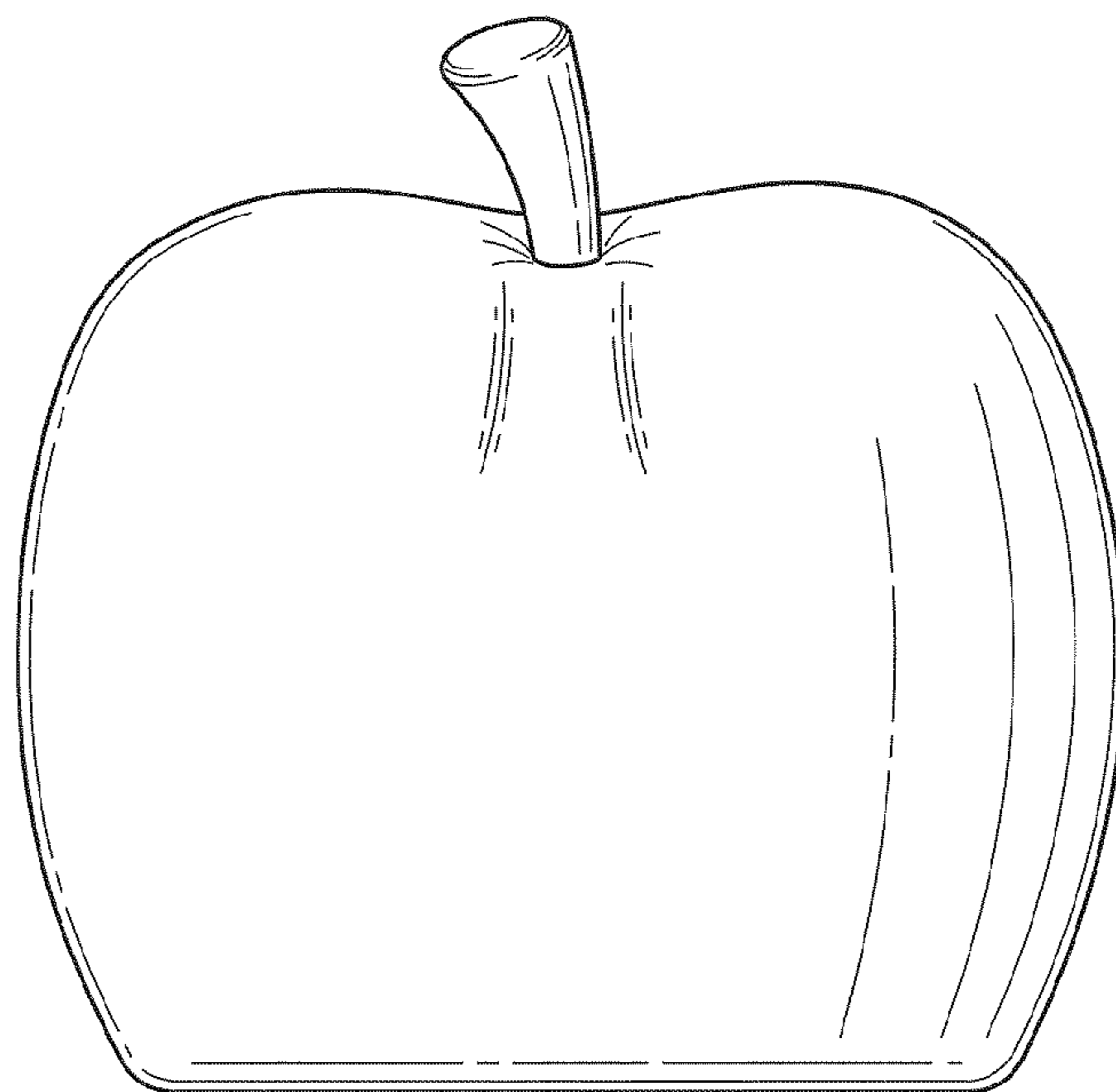

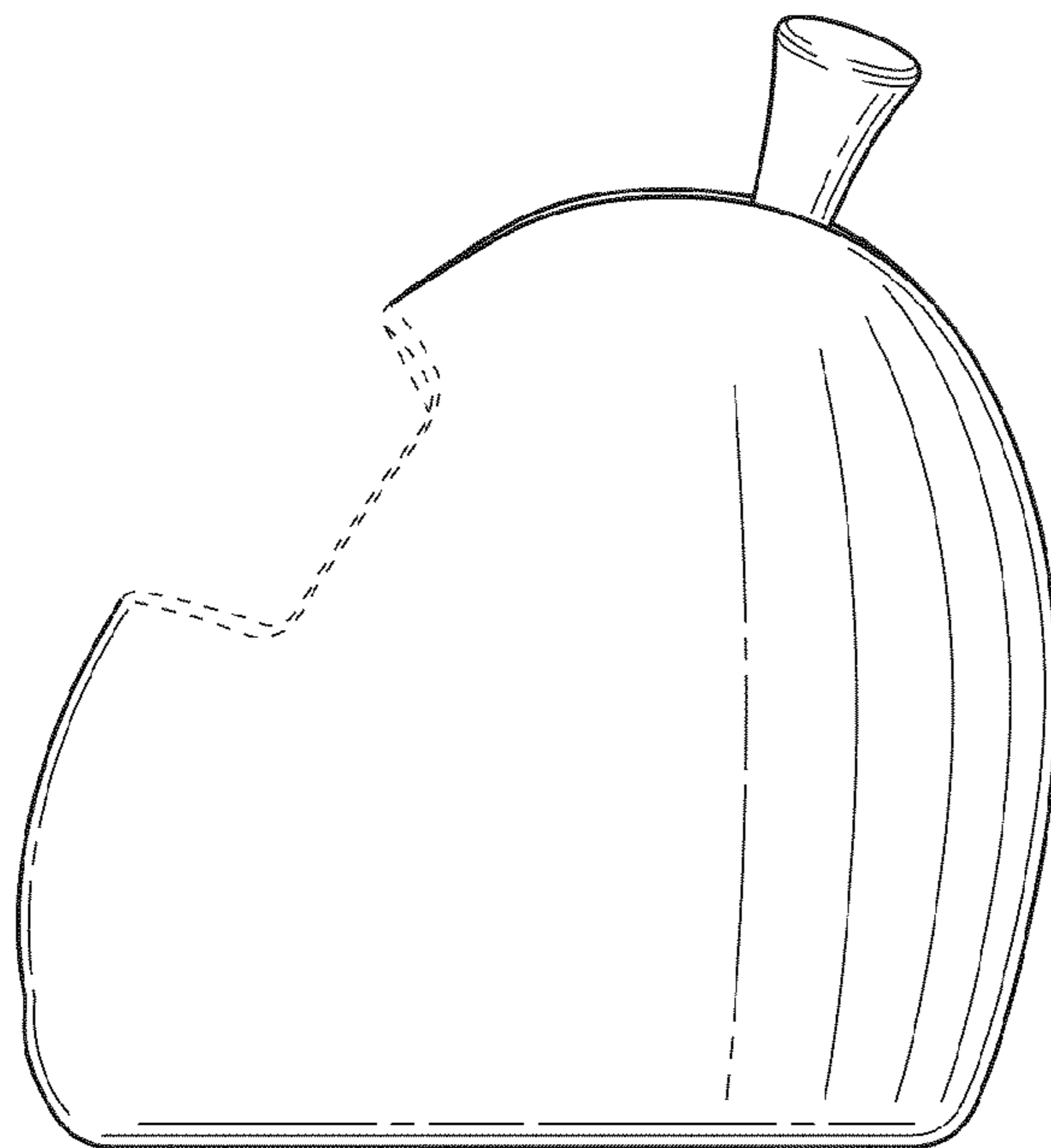

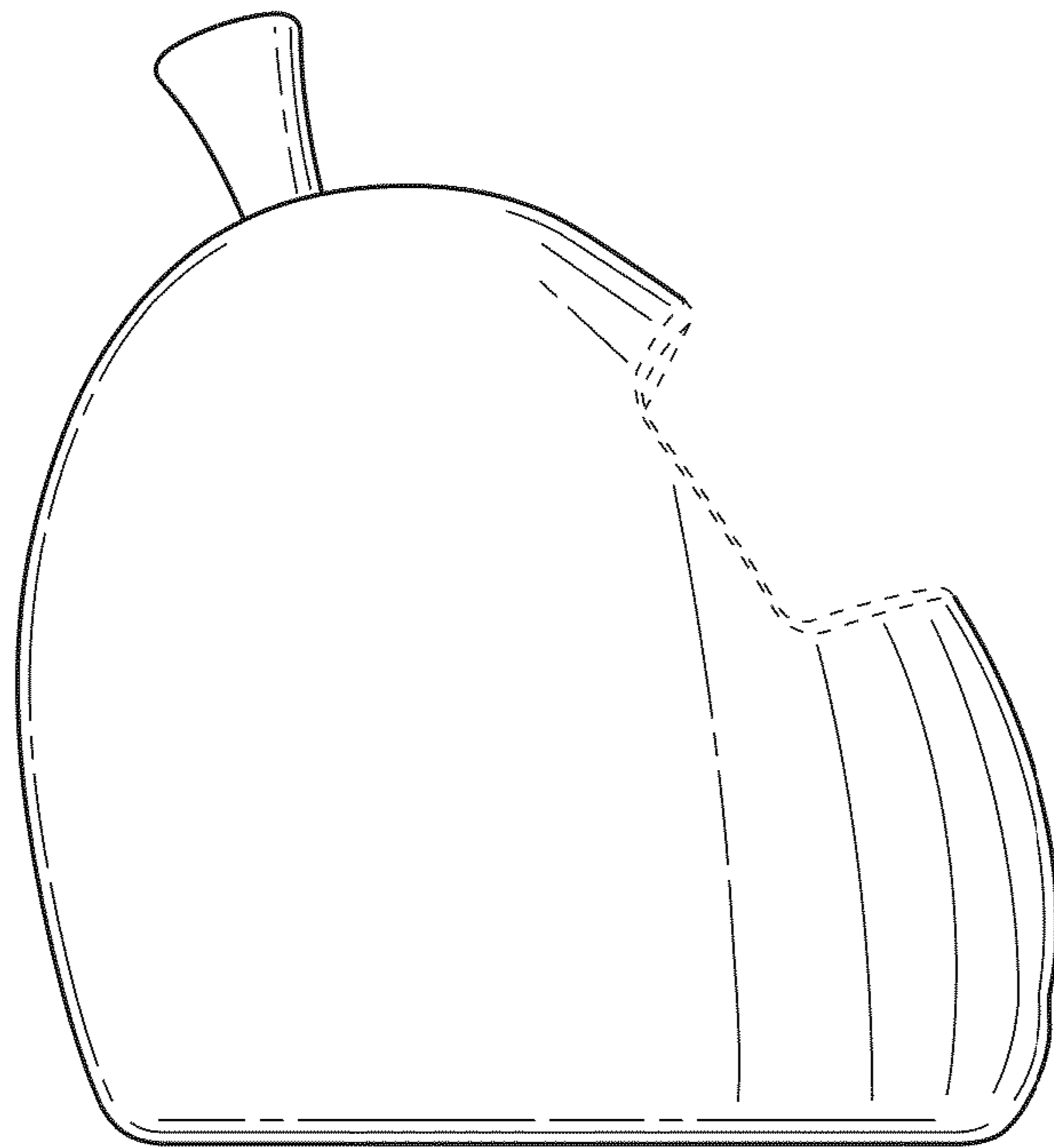

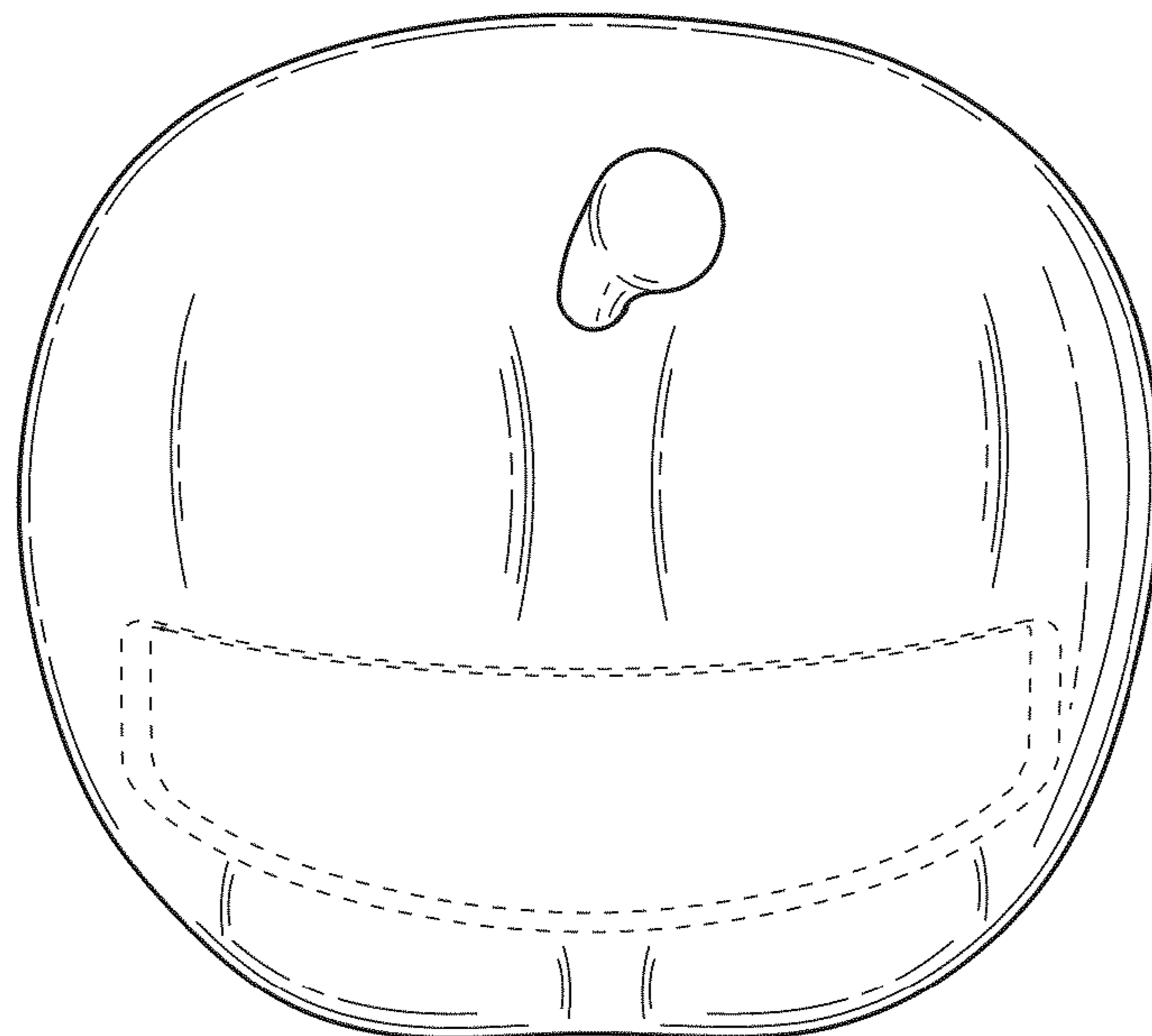

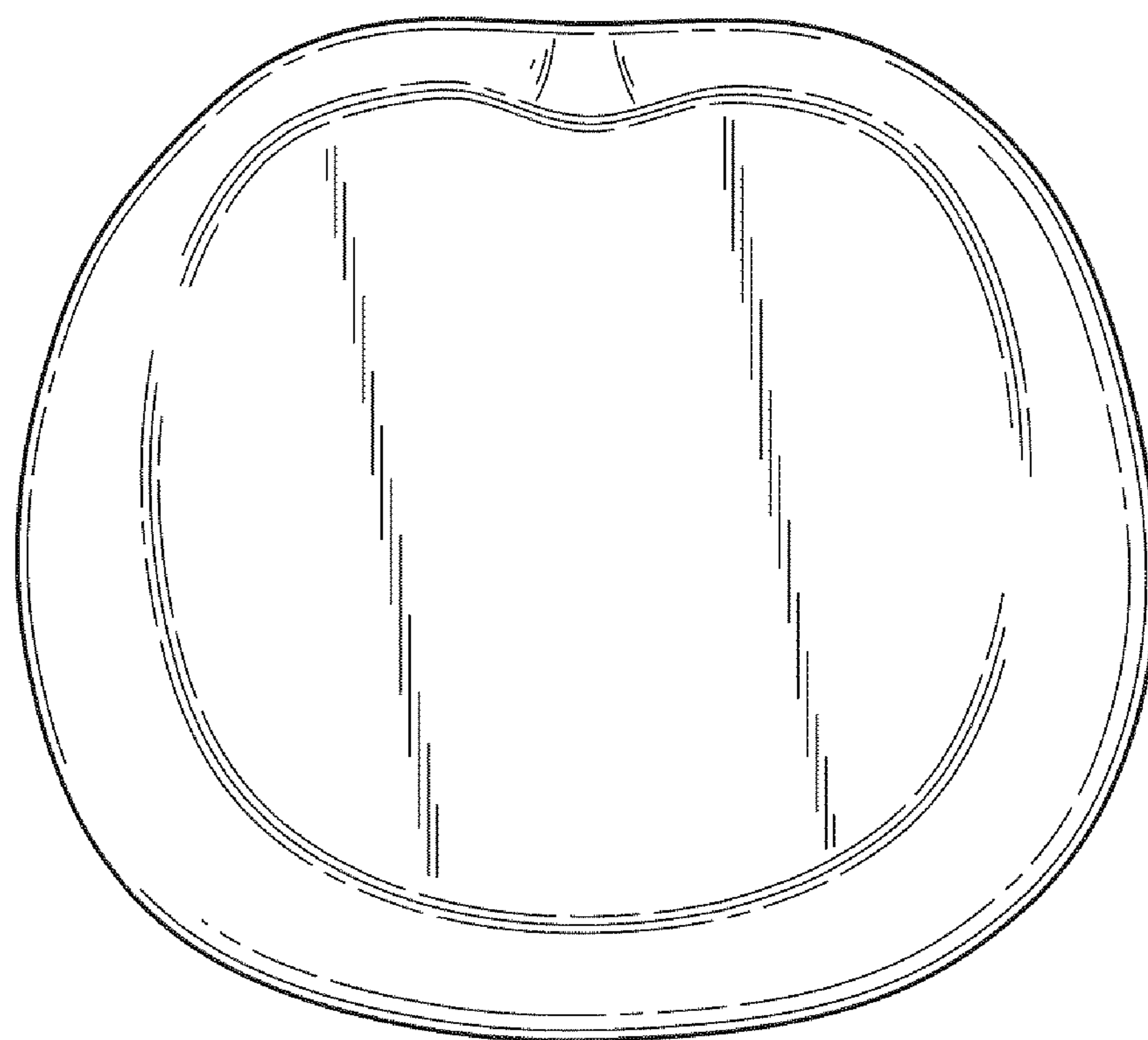
