DESCRIPTION

FIG. 1 is a perspective view of an adjustable golf tee showing my new design.

FIG. 2 is a front elevation view thereof.

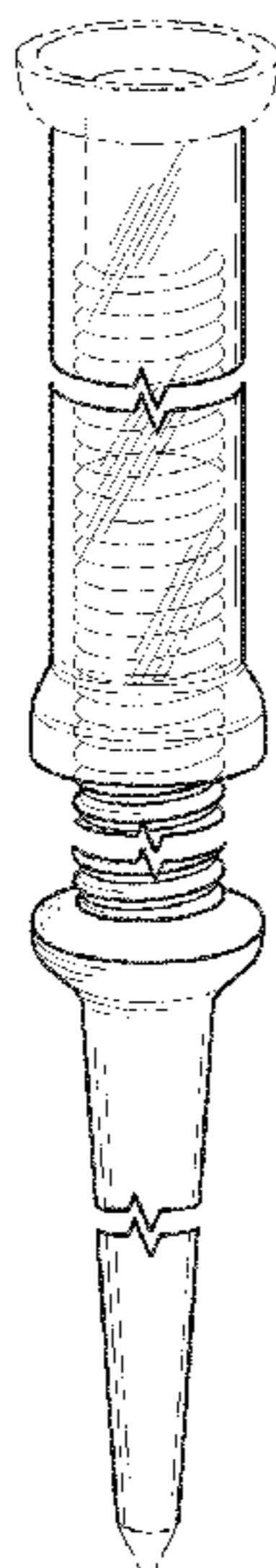
FIG. 3 is an exploded view thereof.

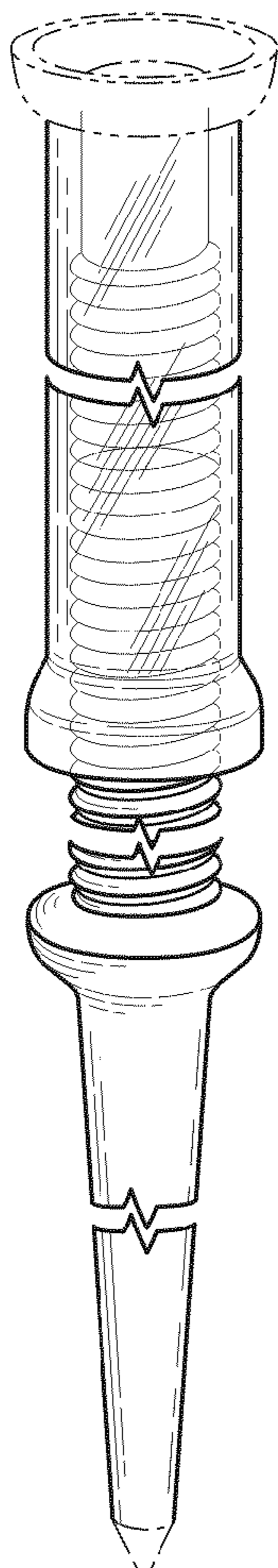

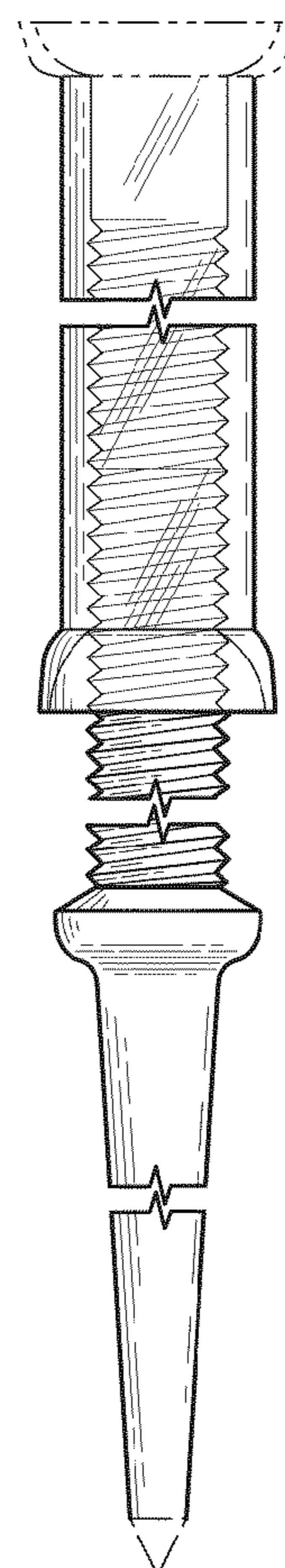

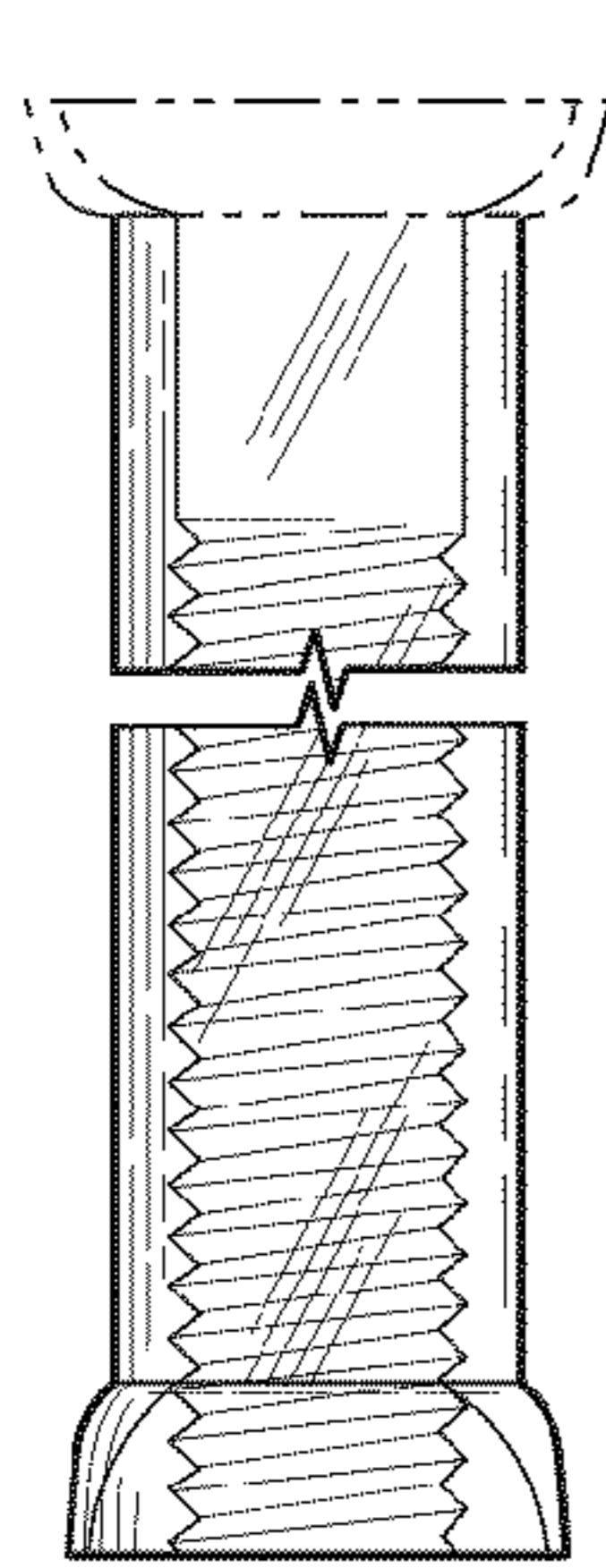

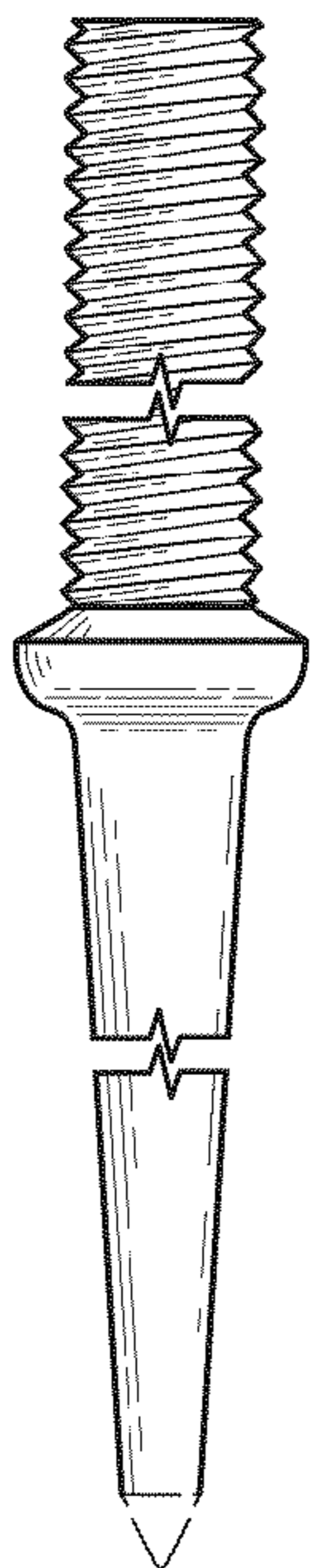

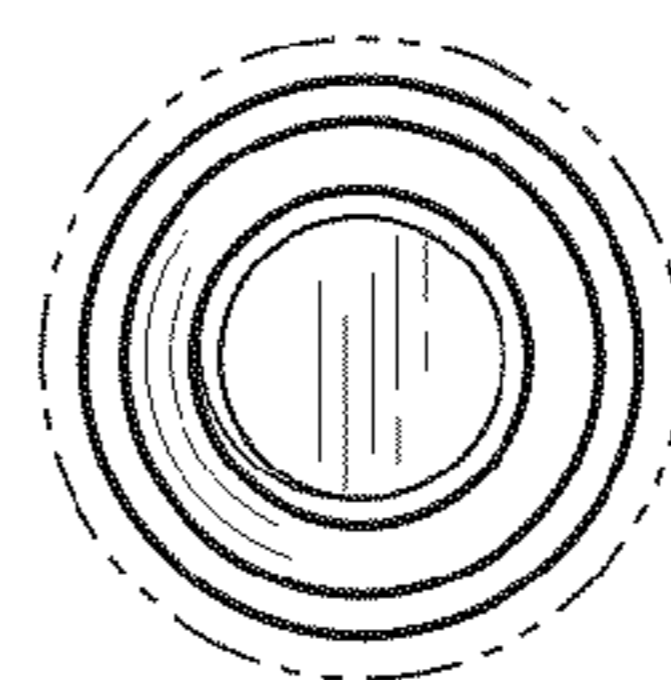
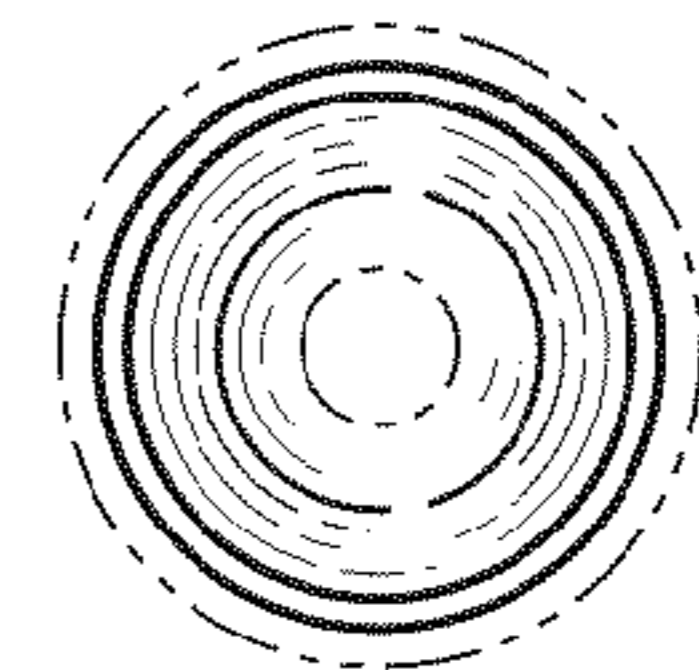
