FIG. 3 is a rear elevation thereof;

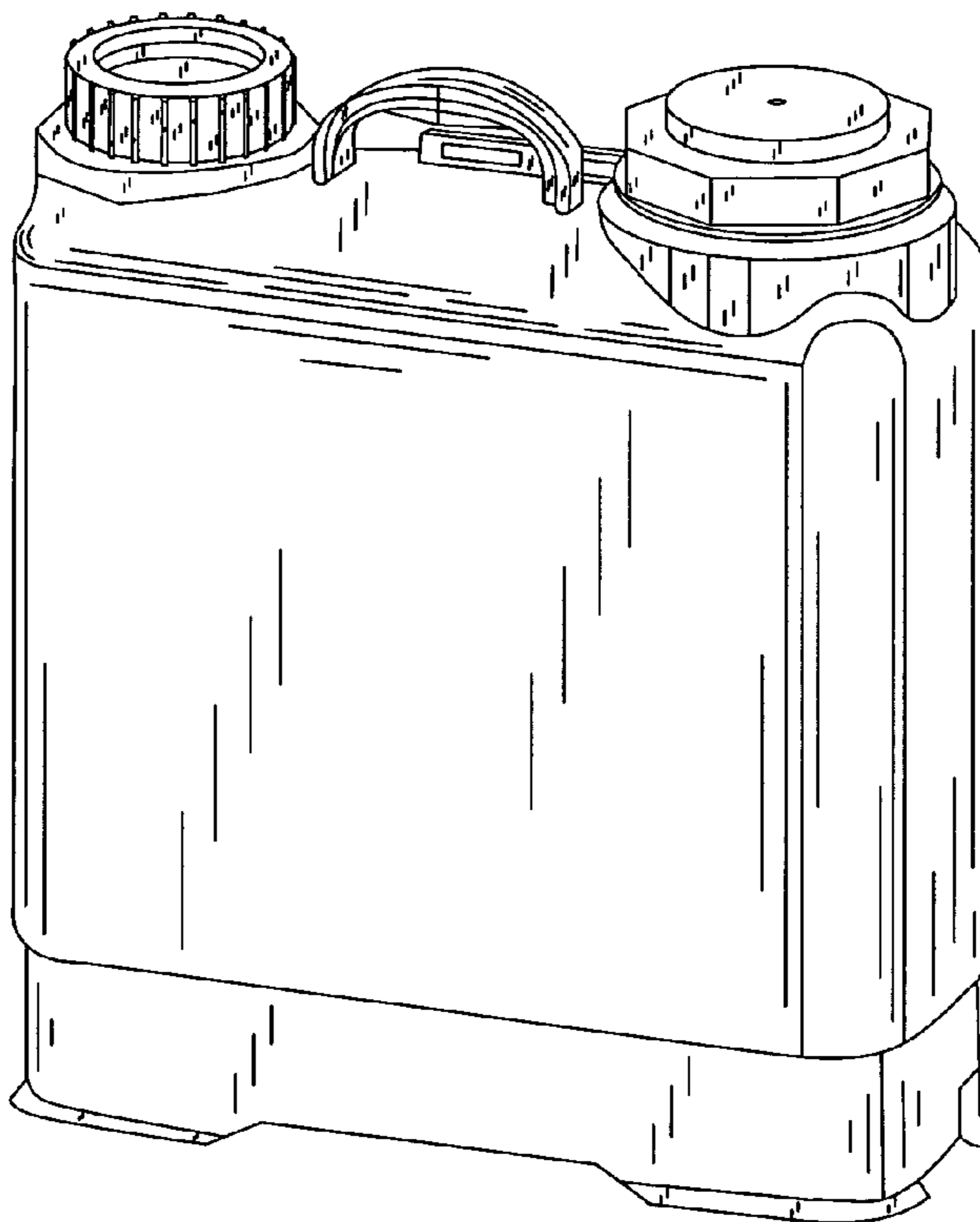
FIG. 4 is a side elevation taken from the left side thereof as

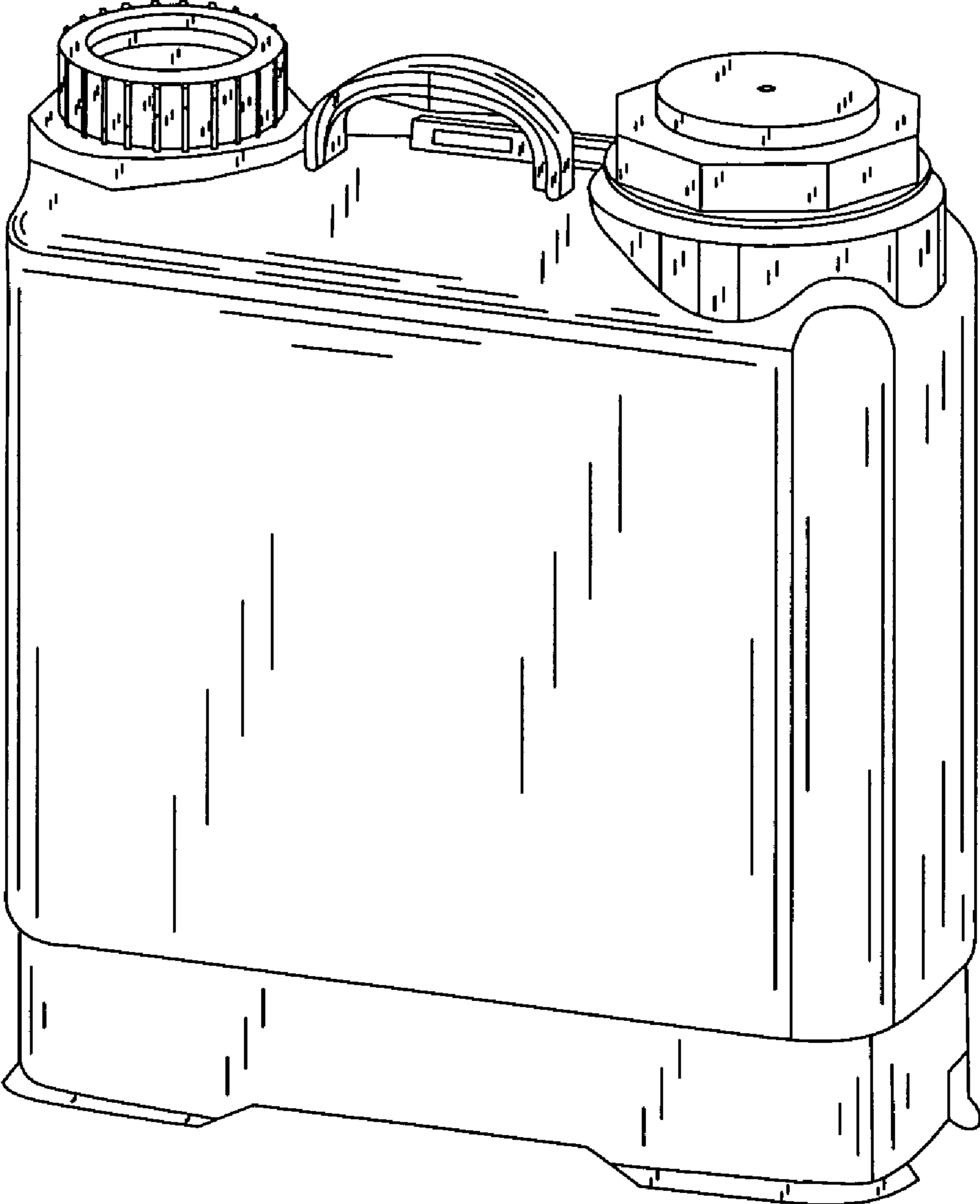

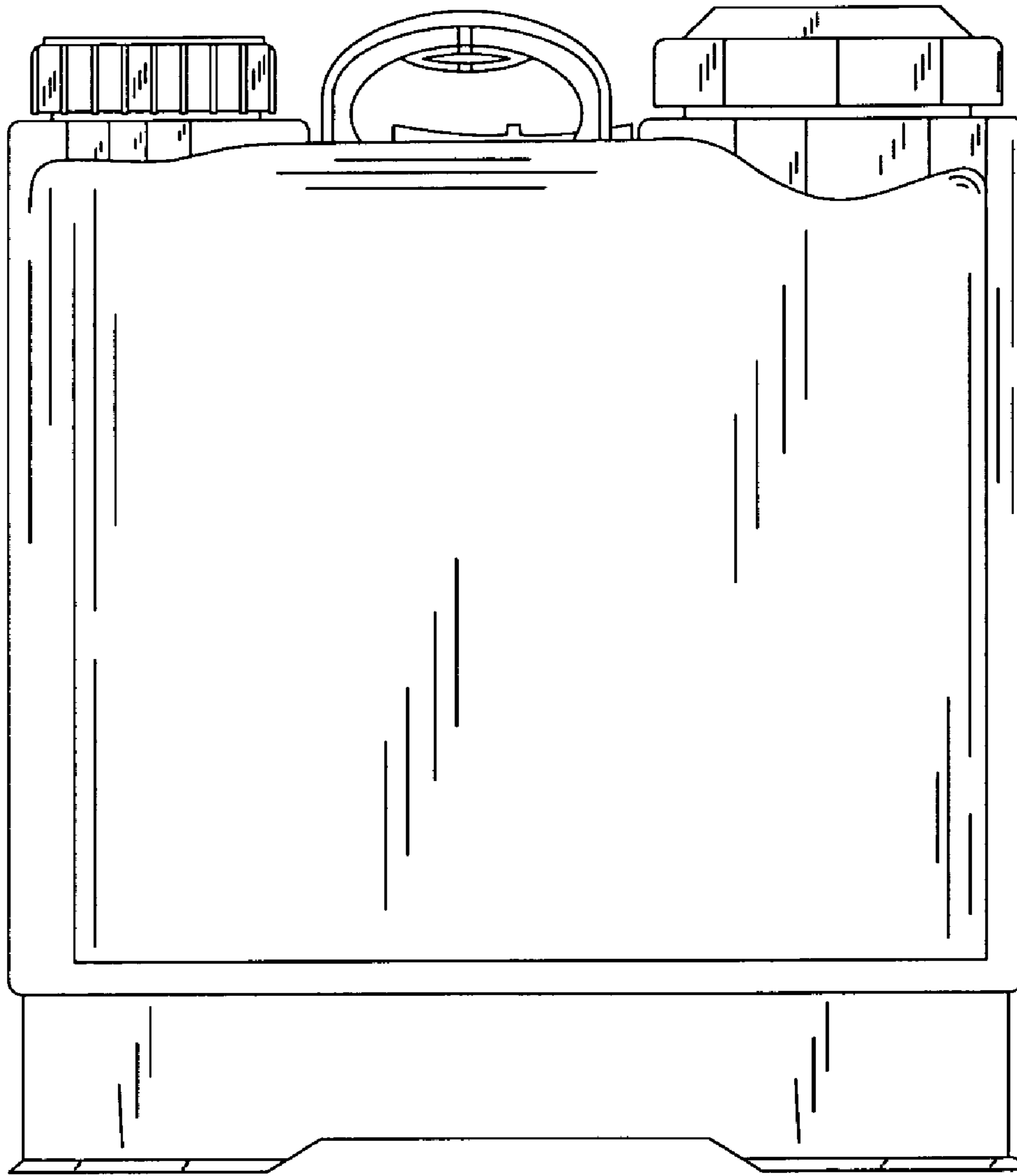

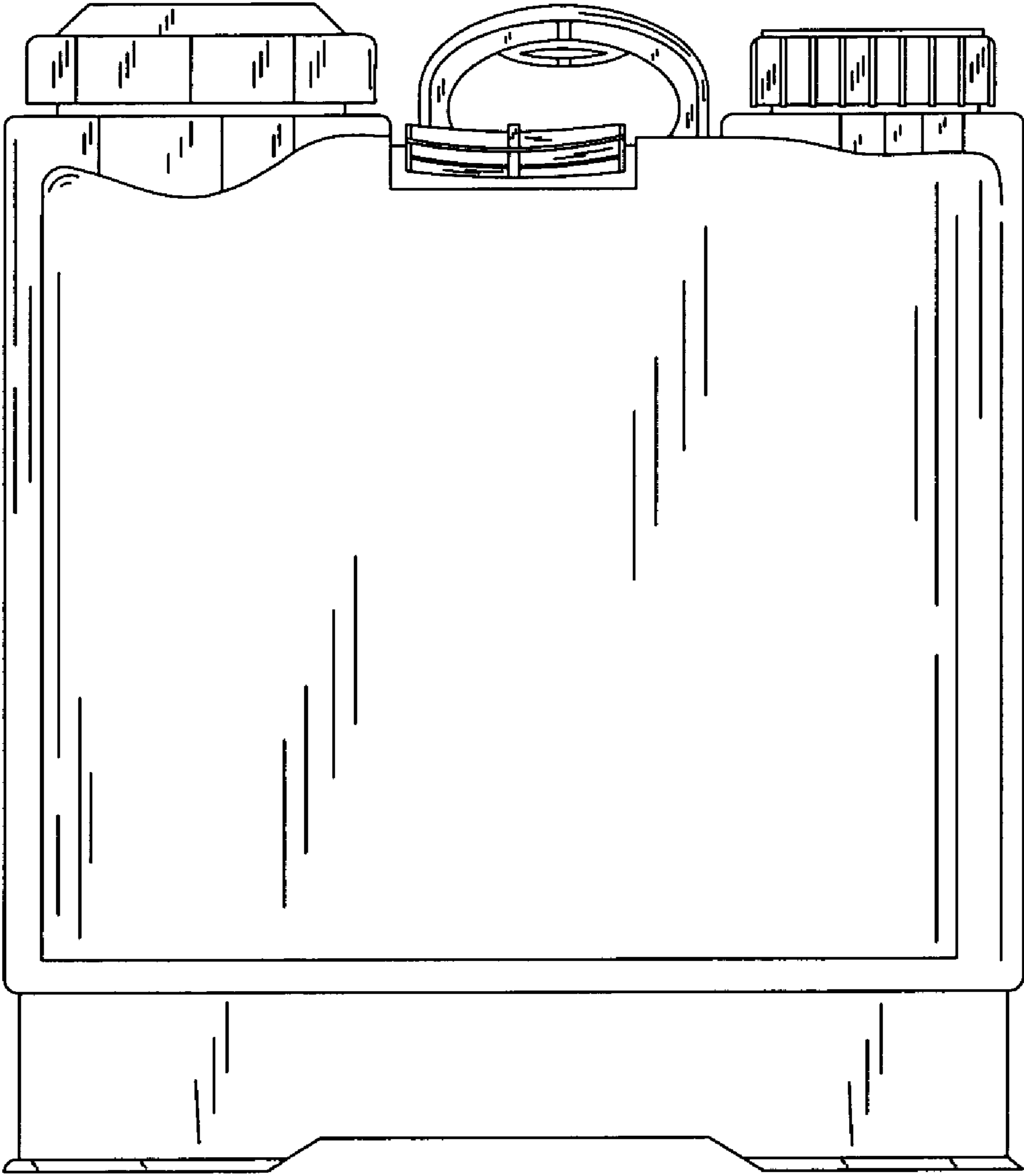

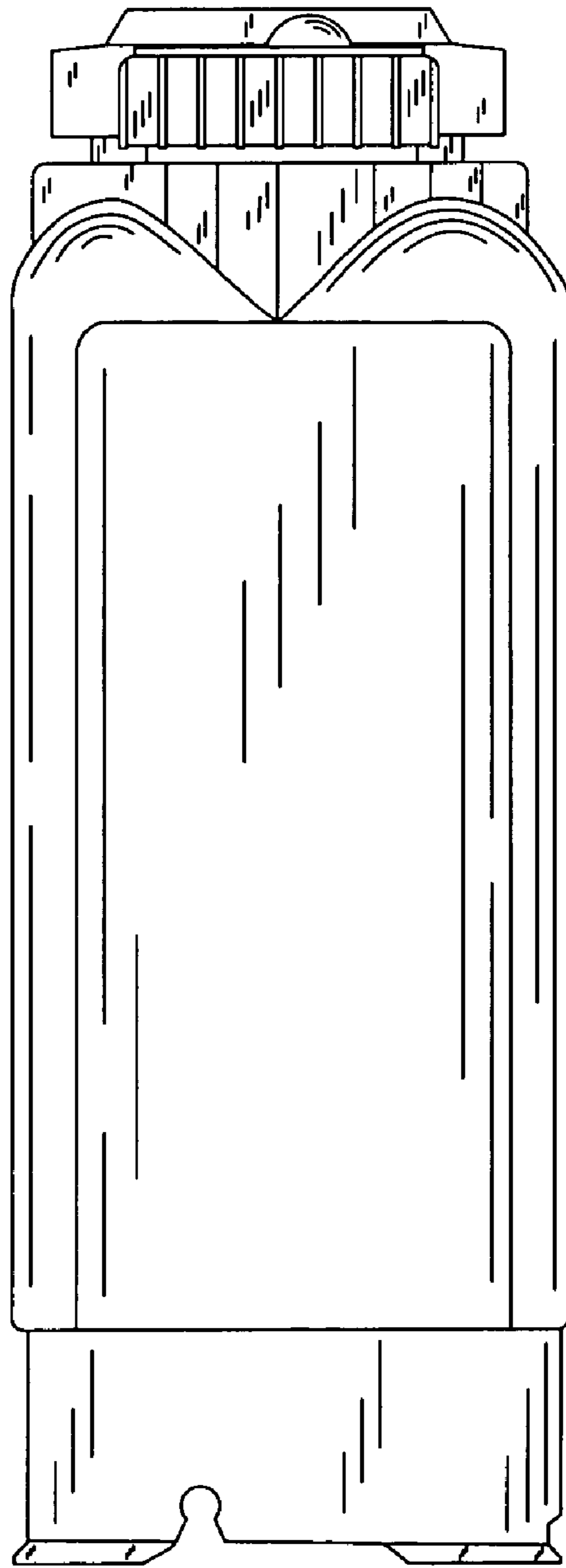

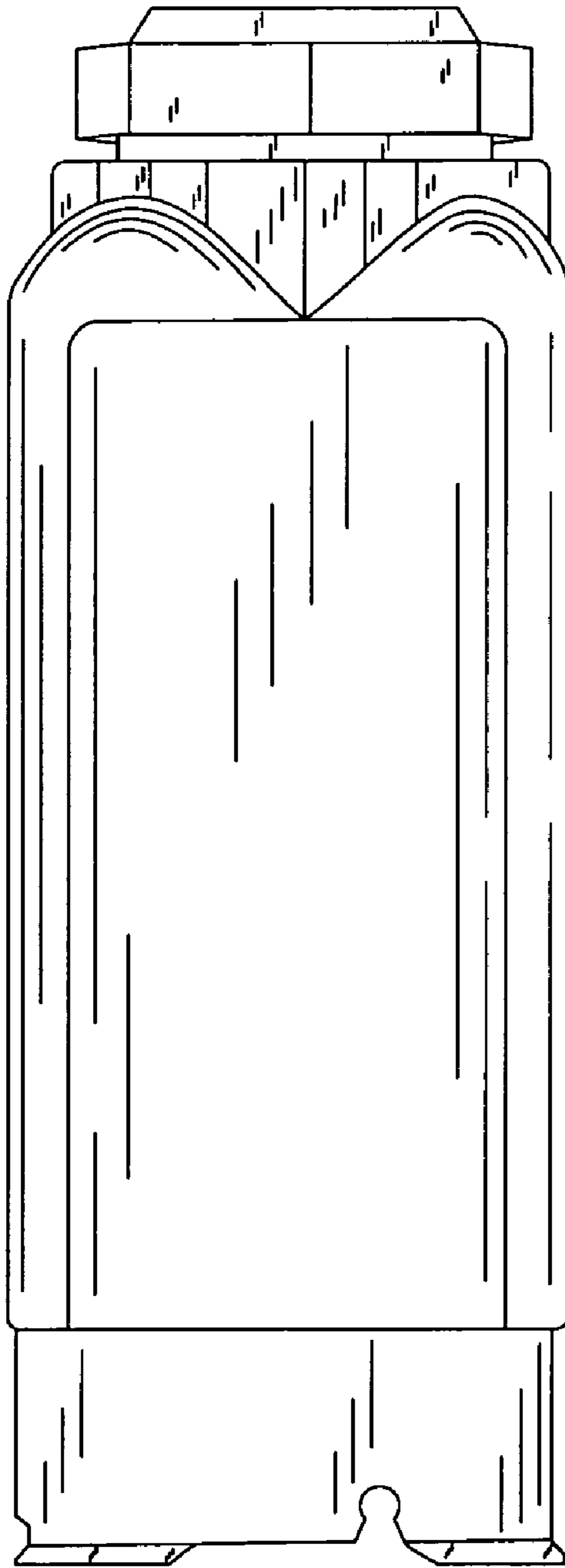

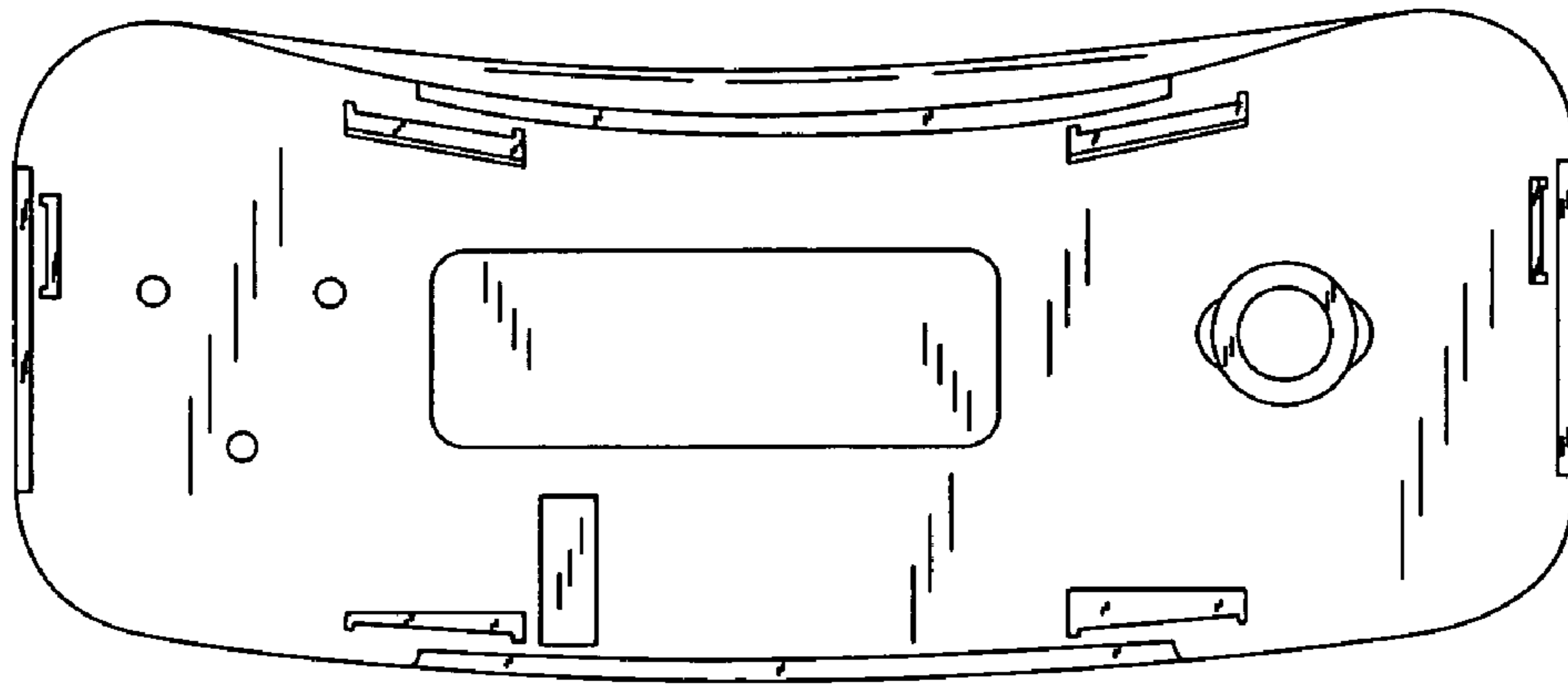

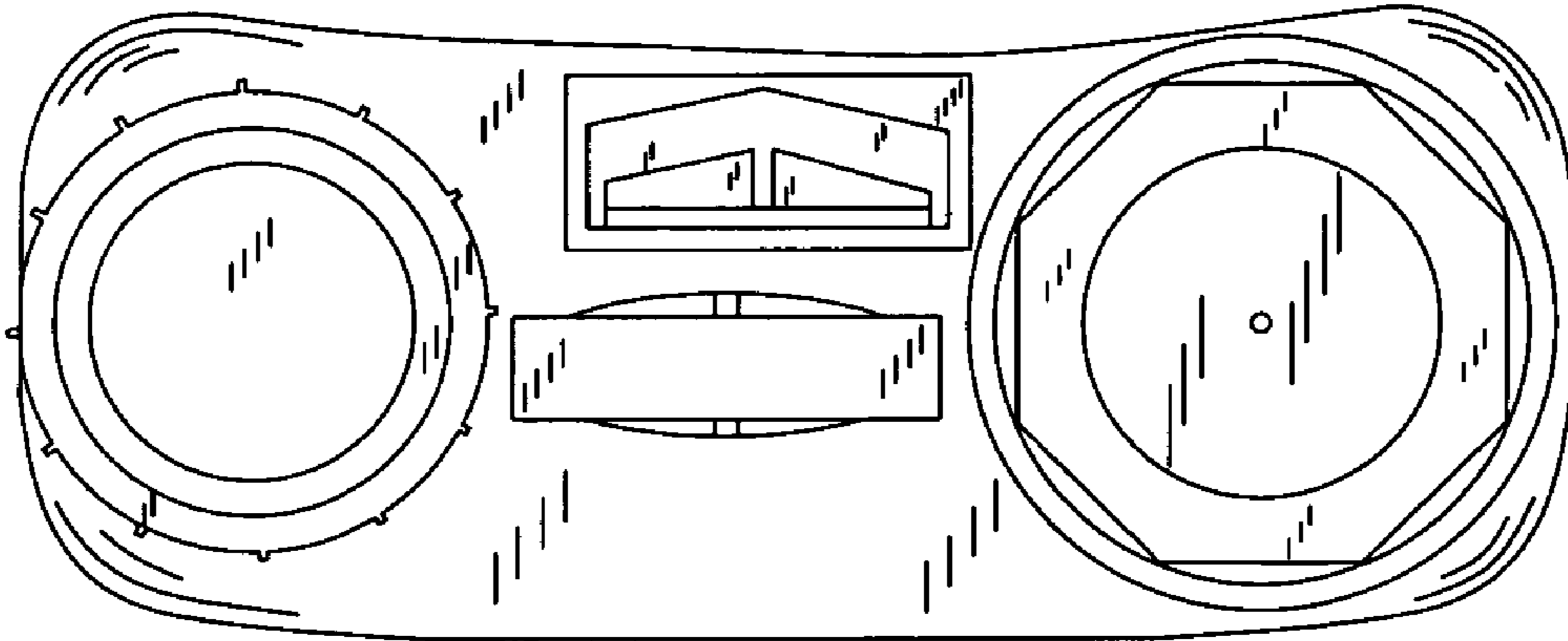
