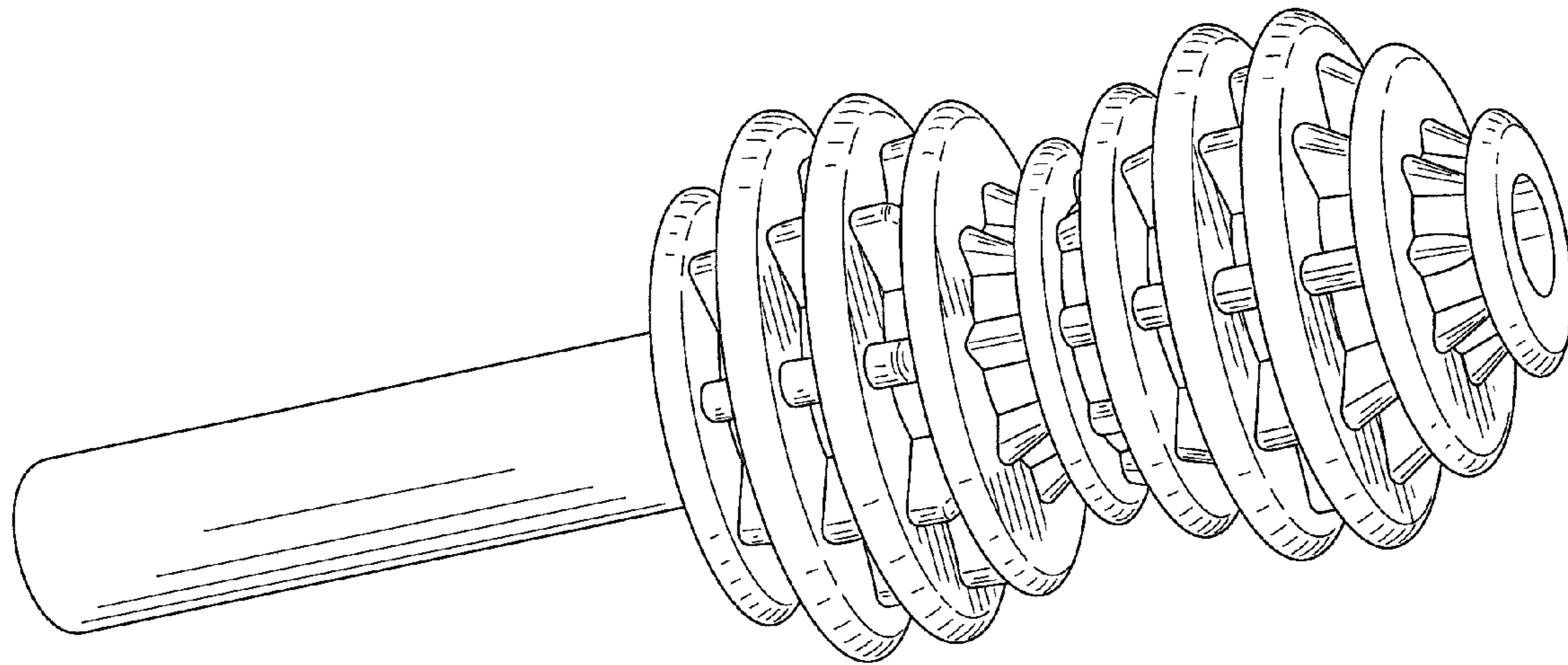
(57) **CLAIM**

We claim, the ornamental design for a catheter for artificial insemination, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a catheter for artificial insemination, showing our new design;

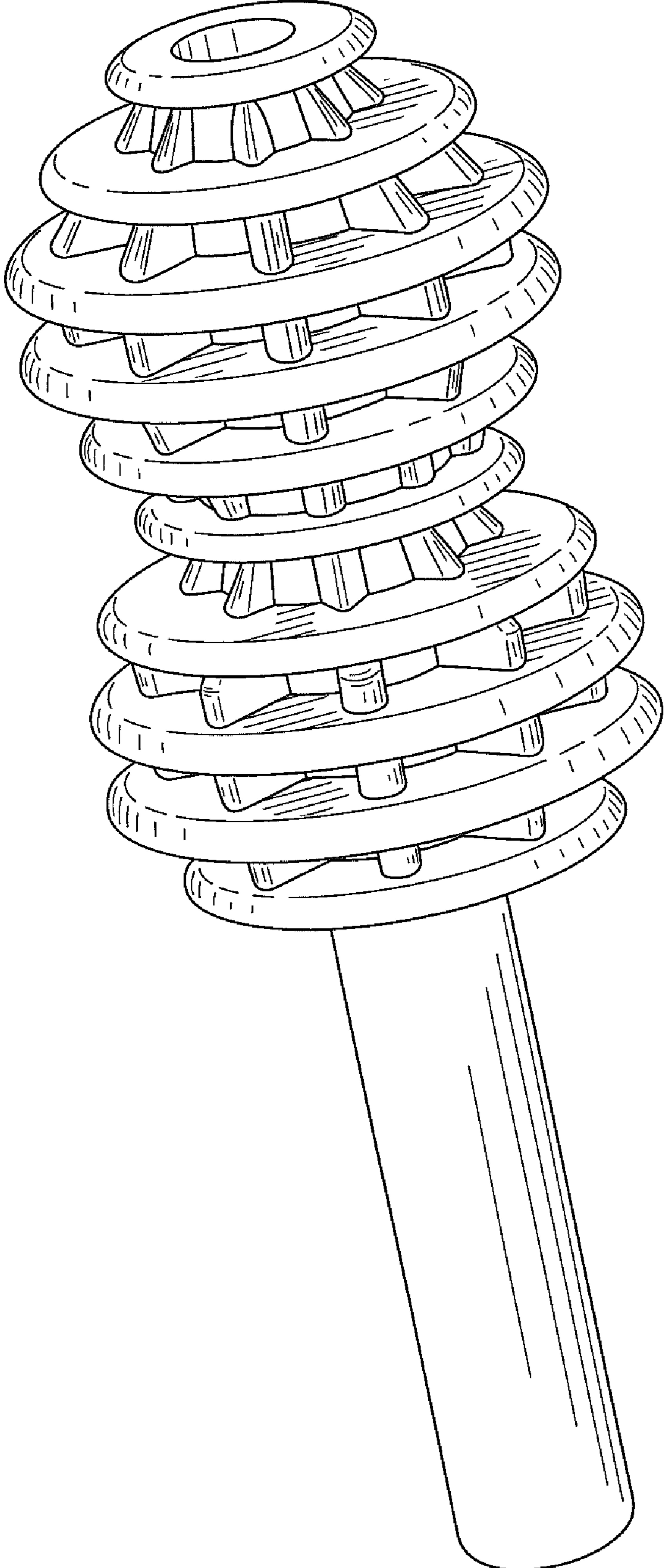

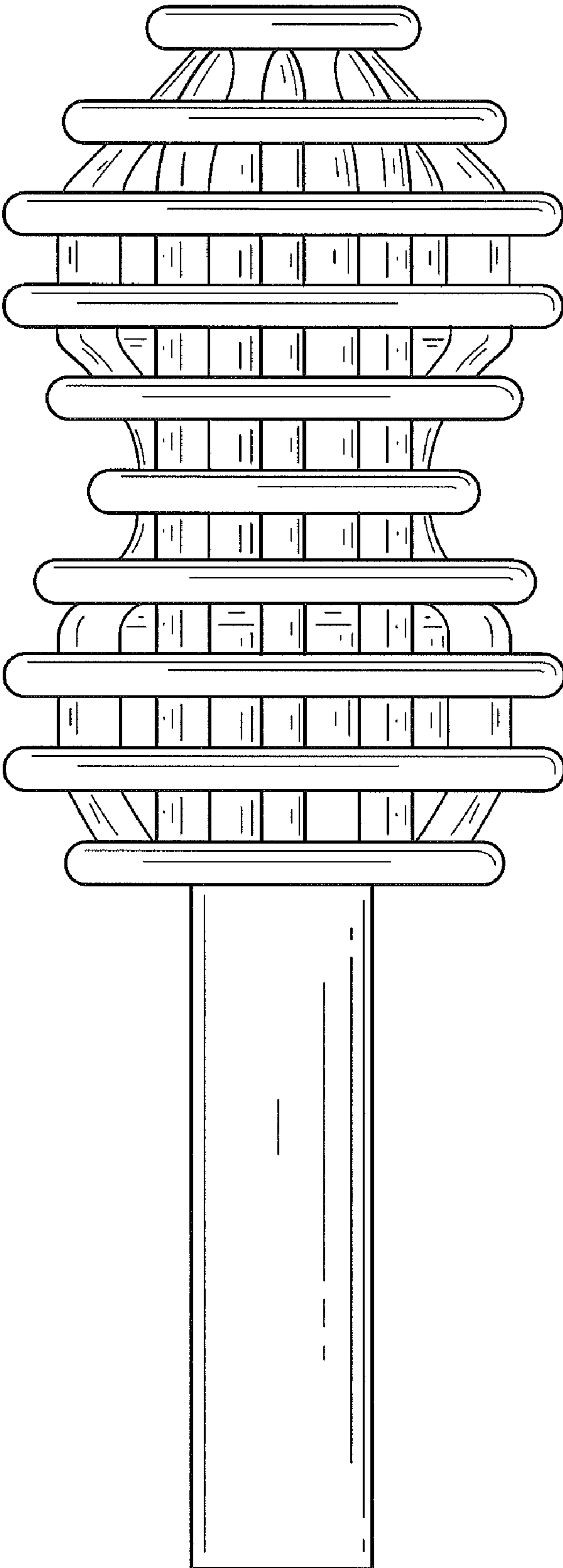
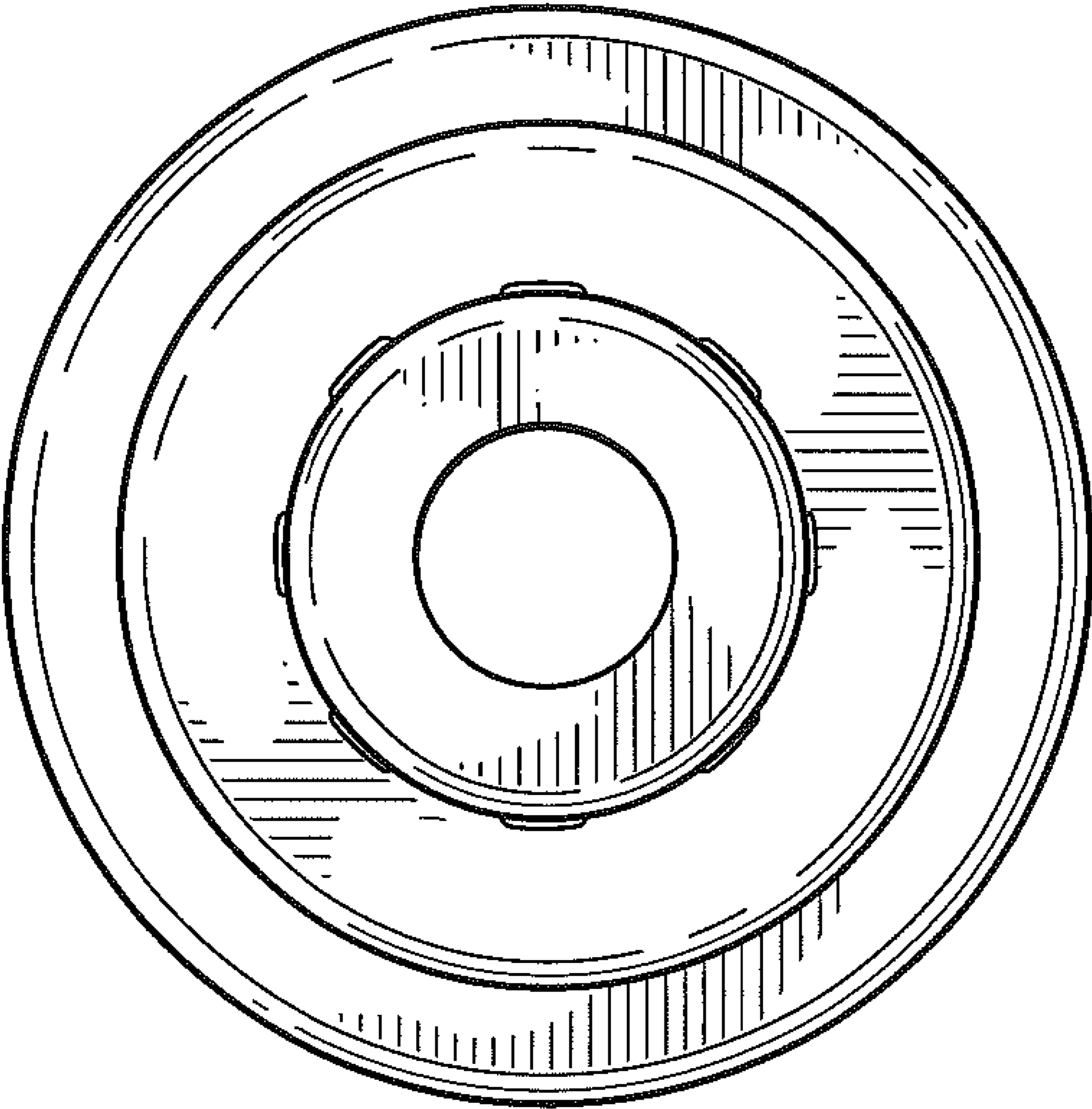

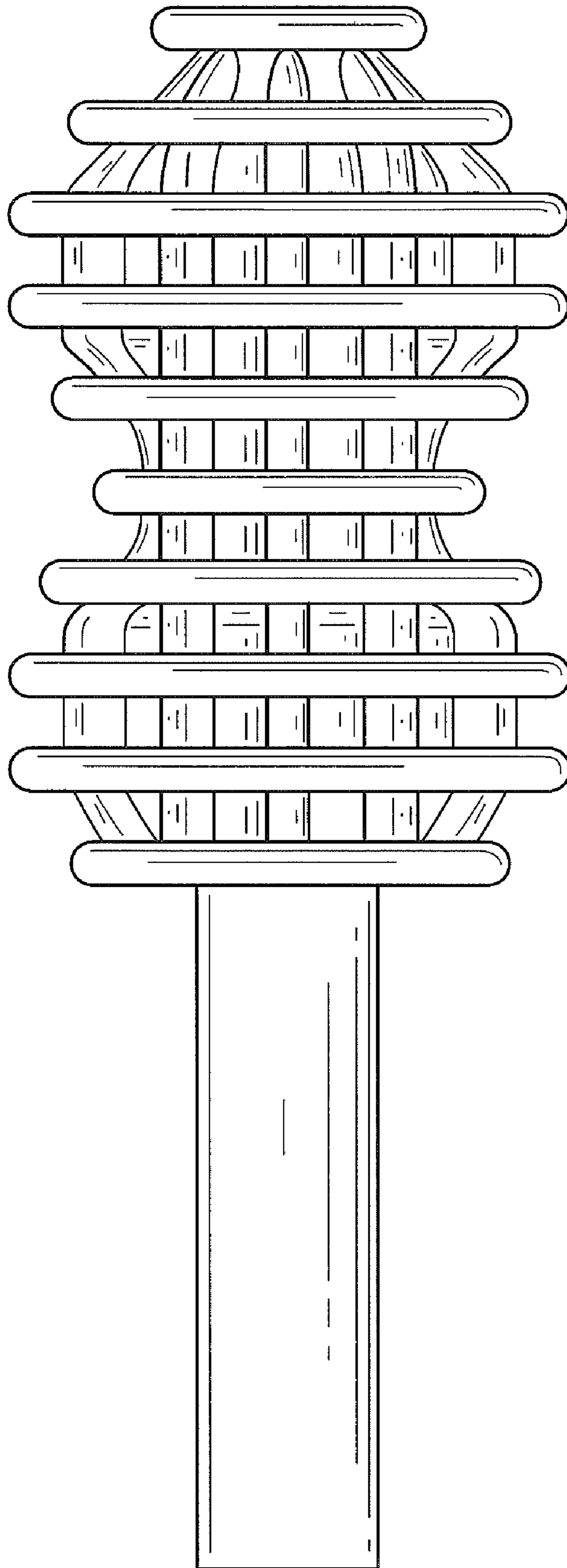

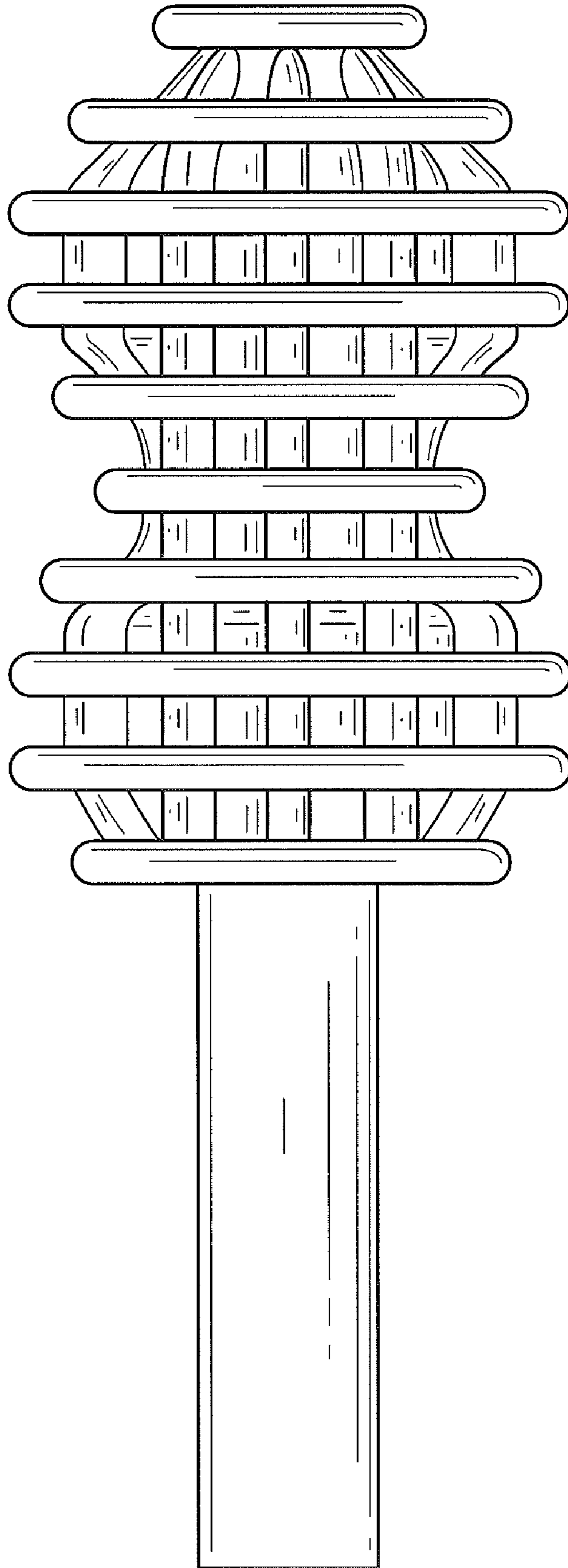
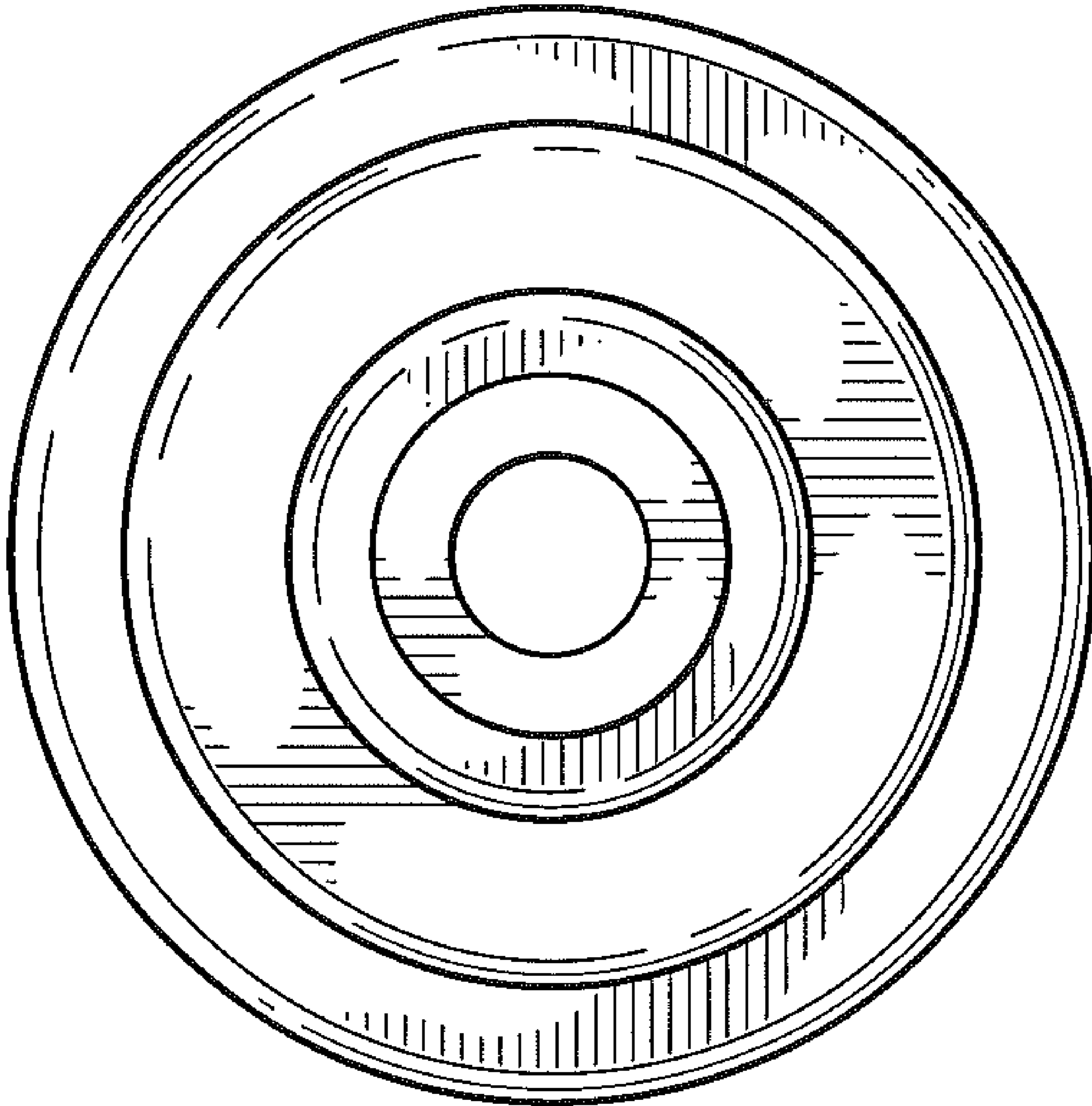

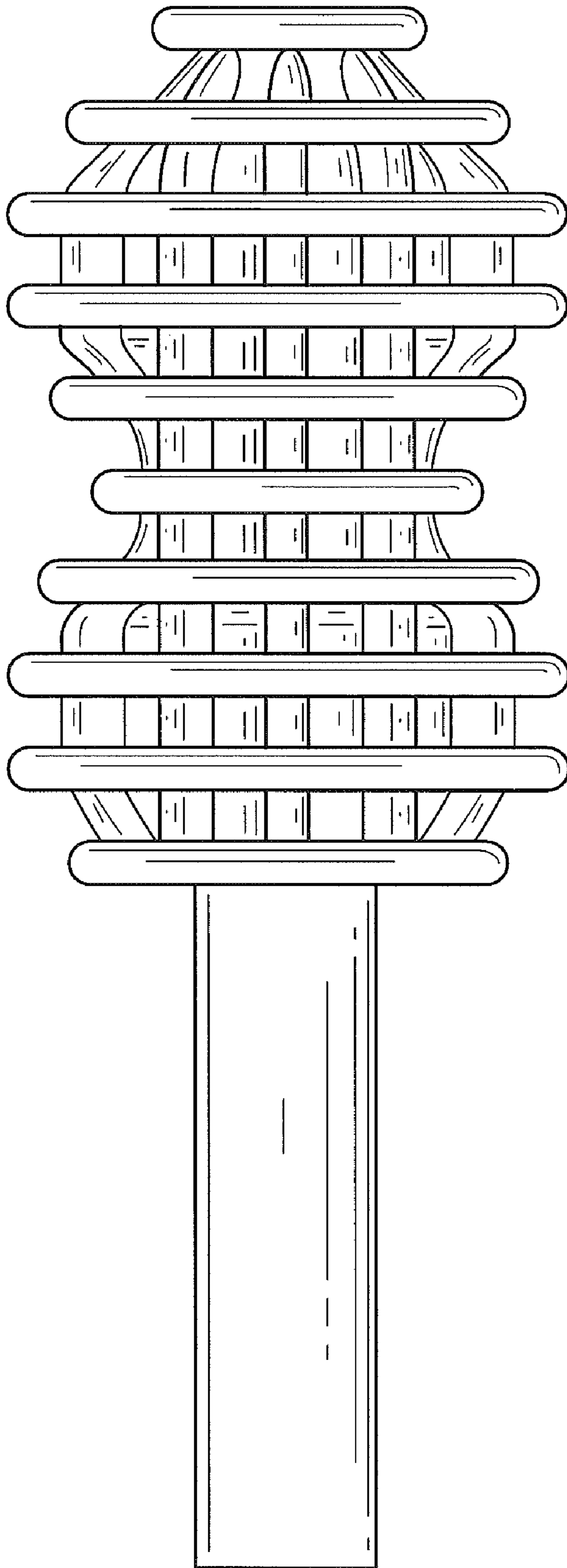
