FIG. 4 is a right side view thereof;

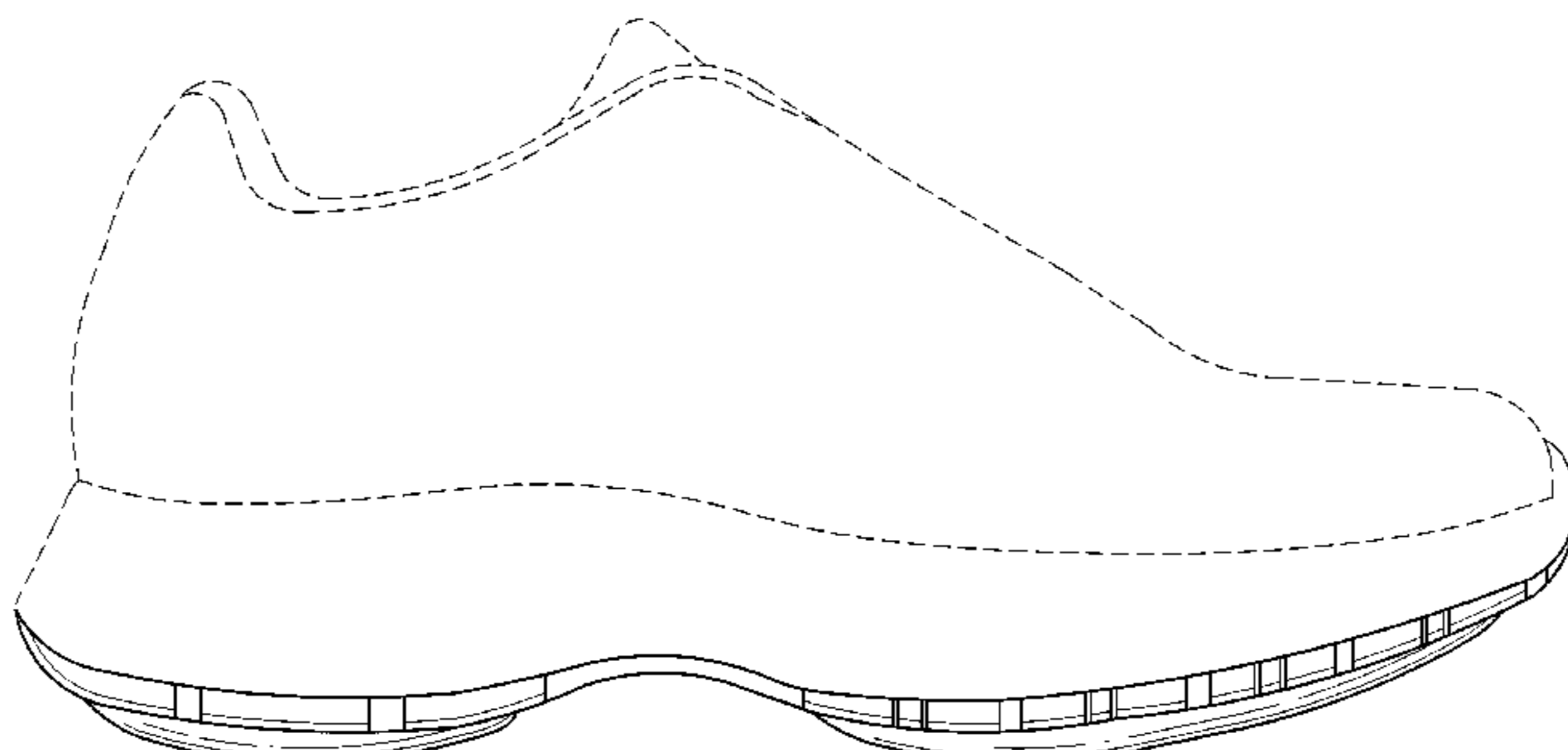
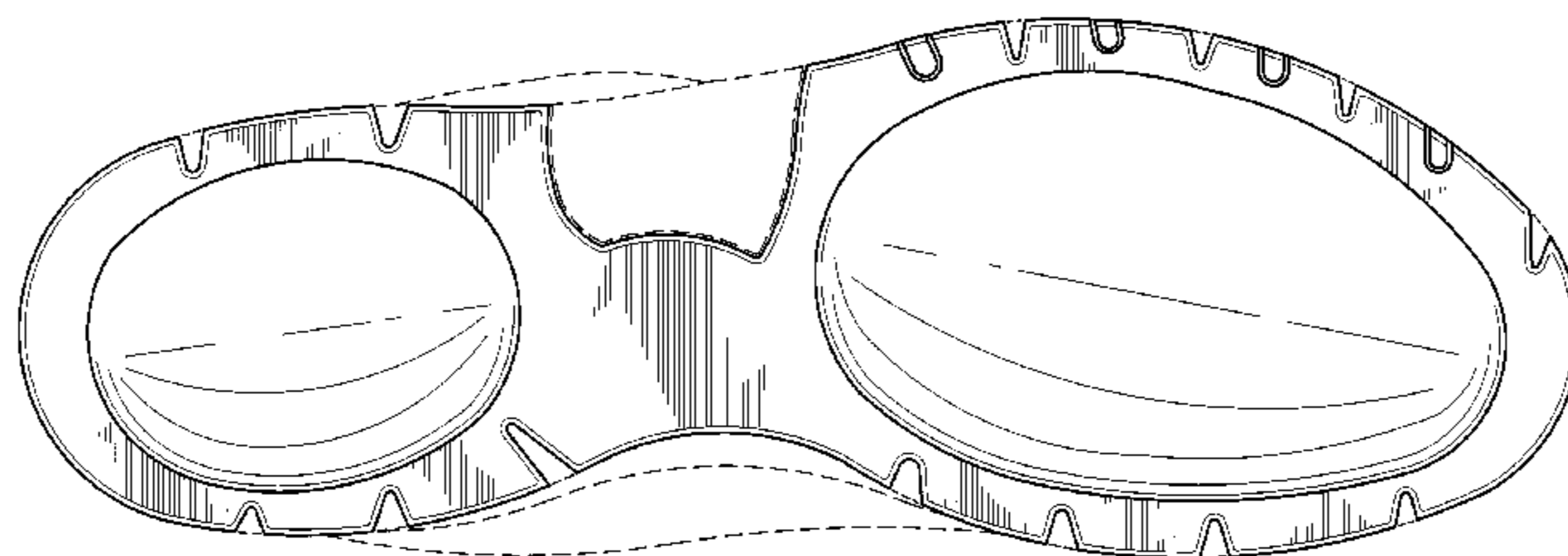
FIG. 5 is a rear elevation view thereof;

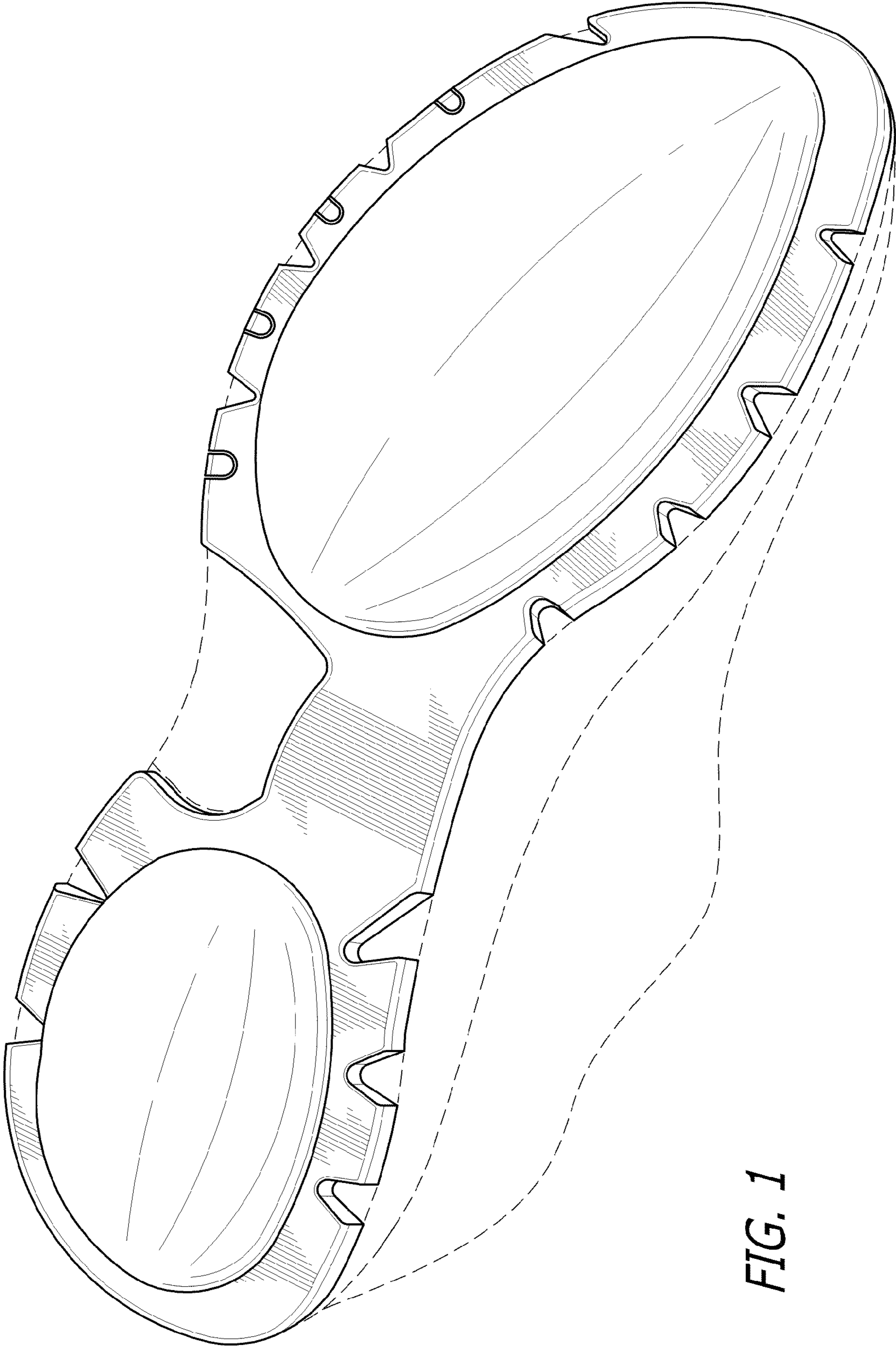

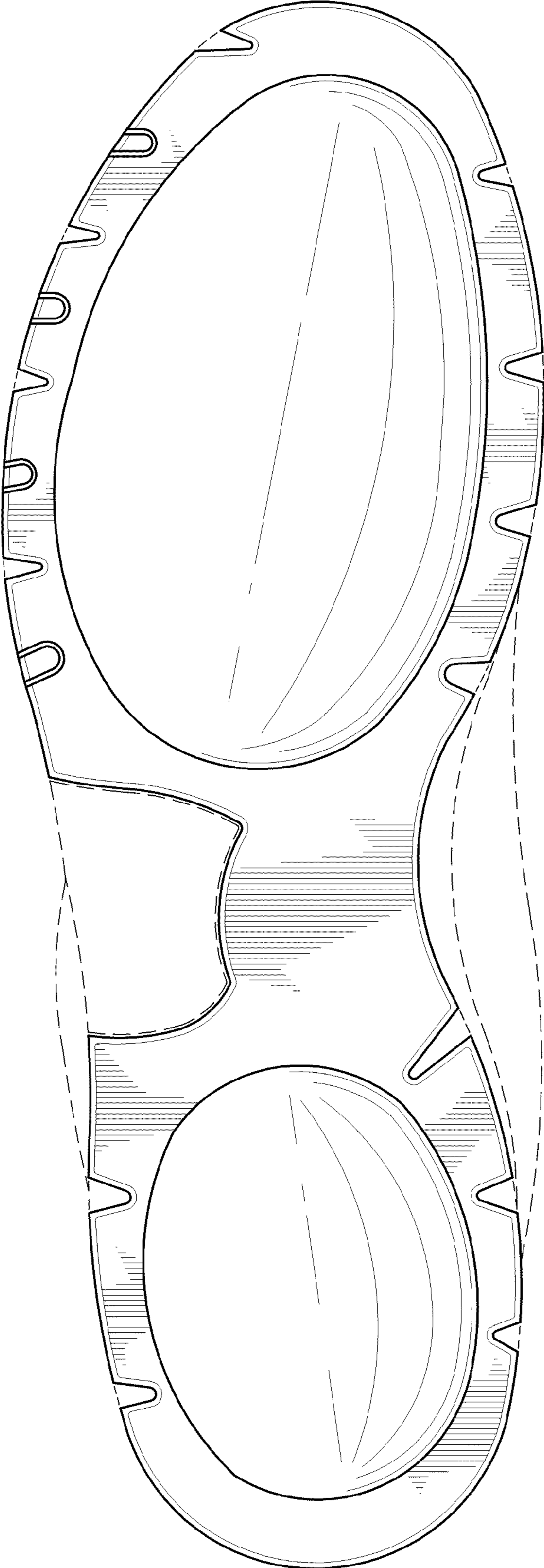

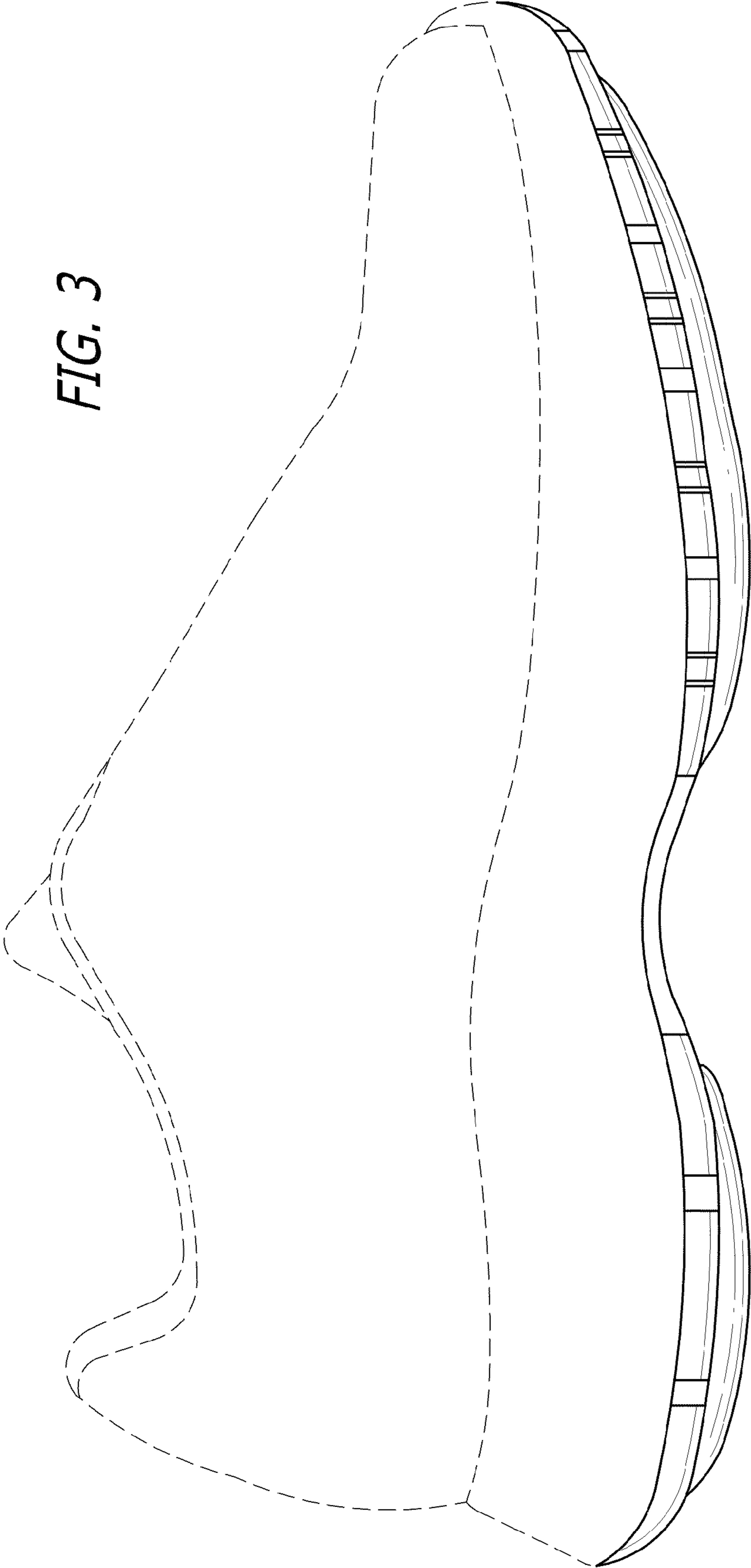

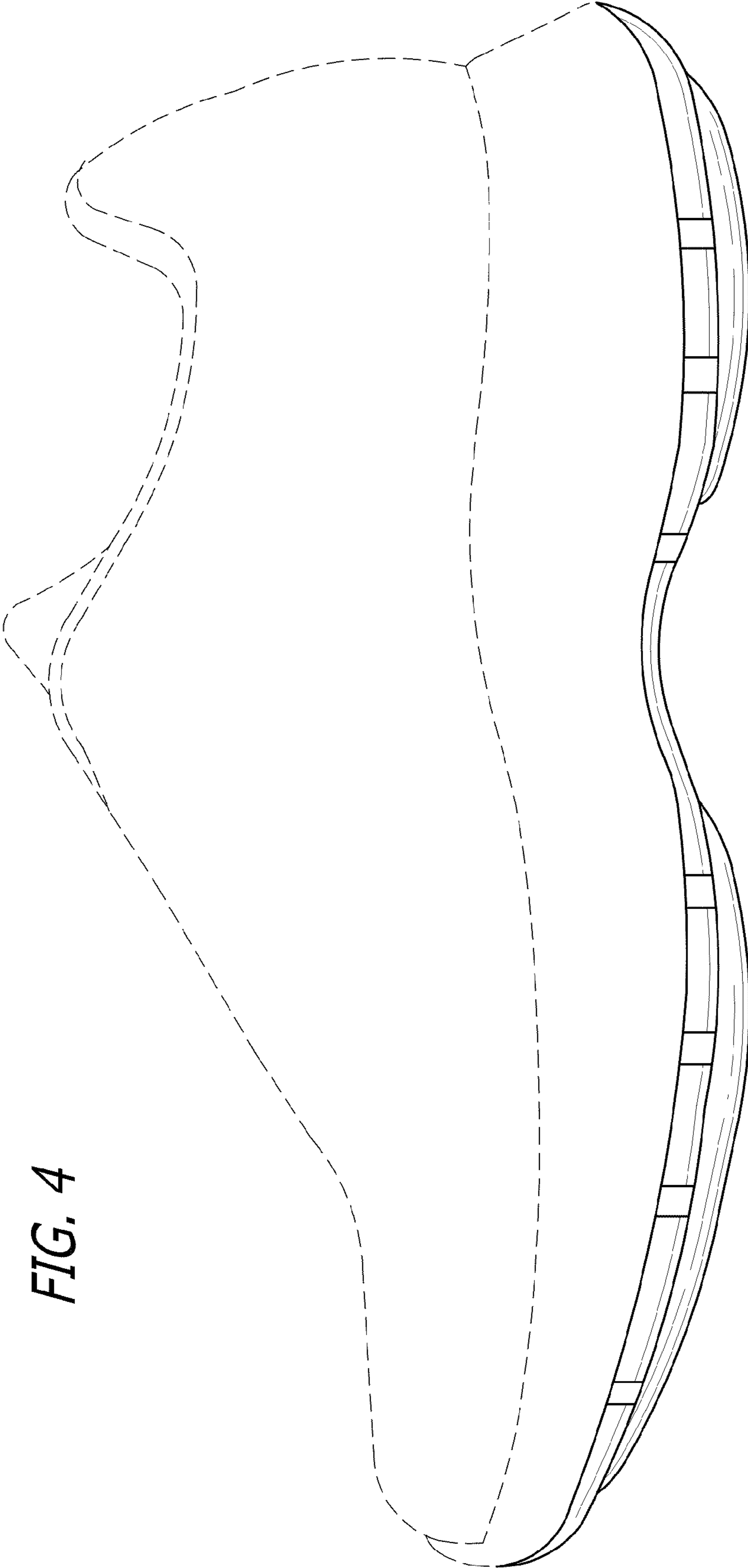

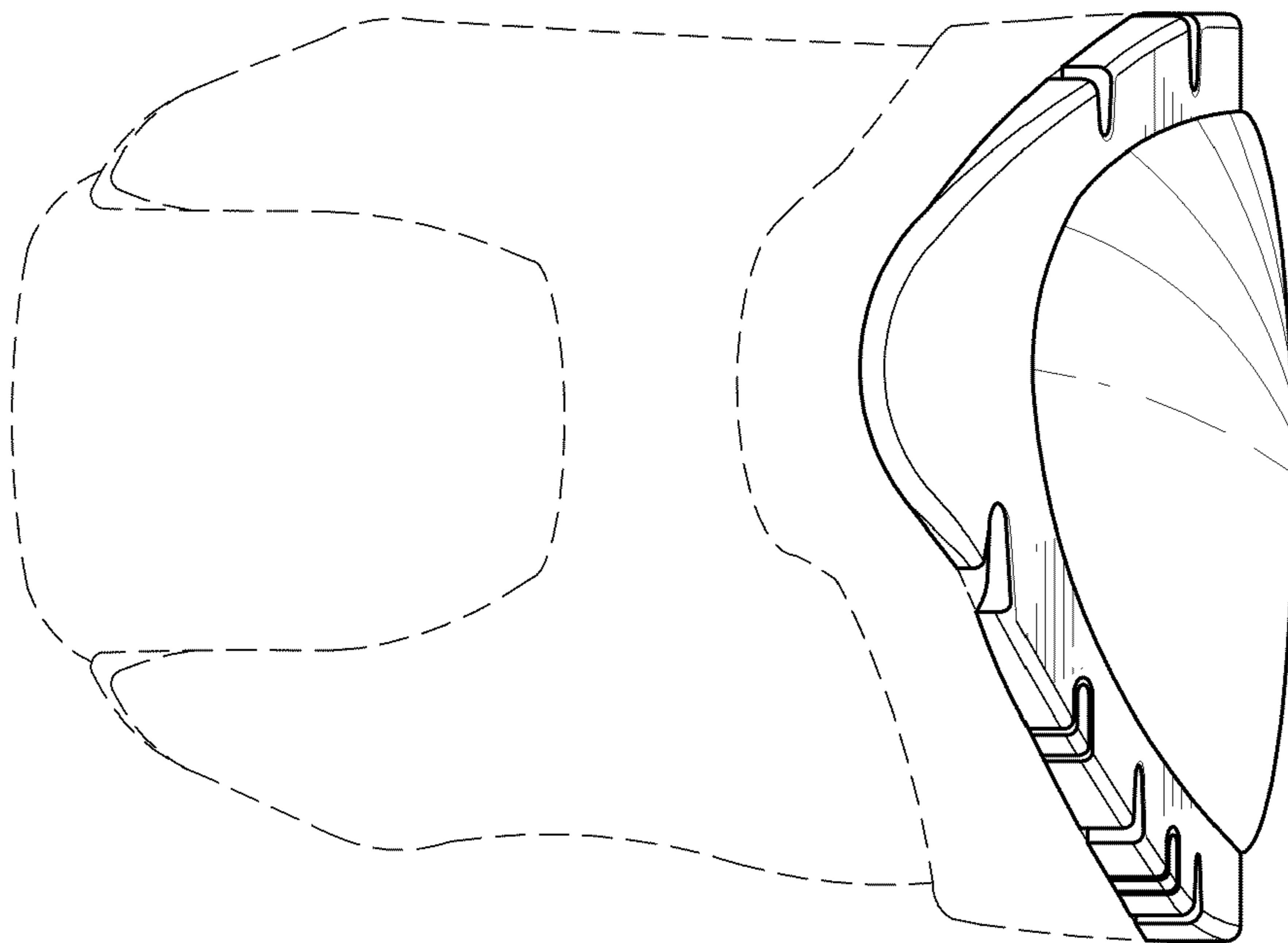
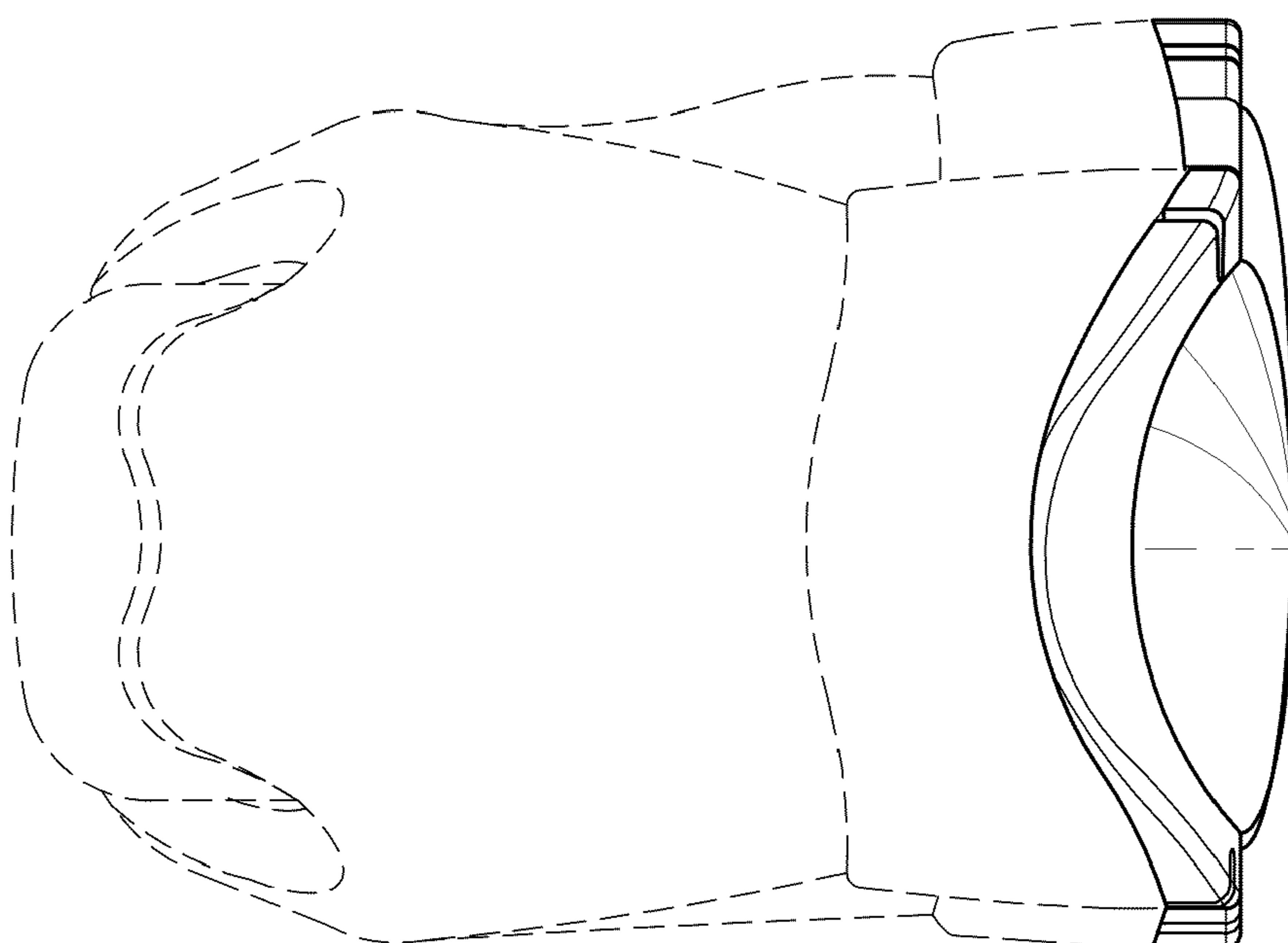

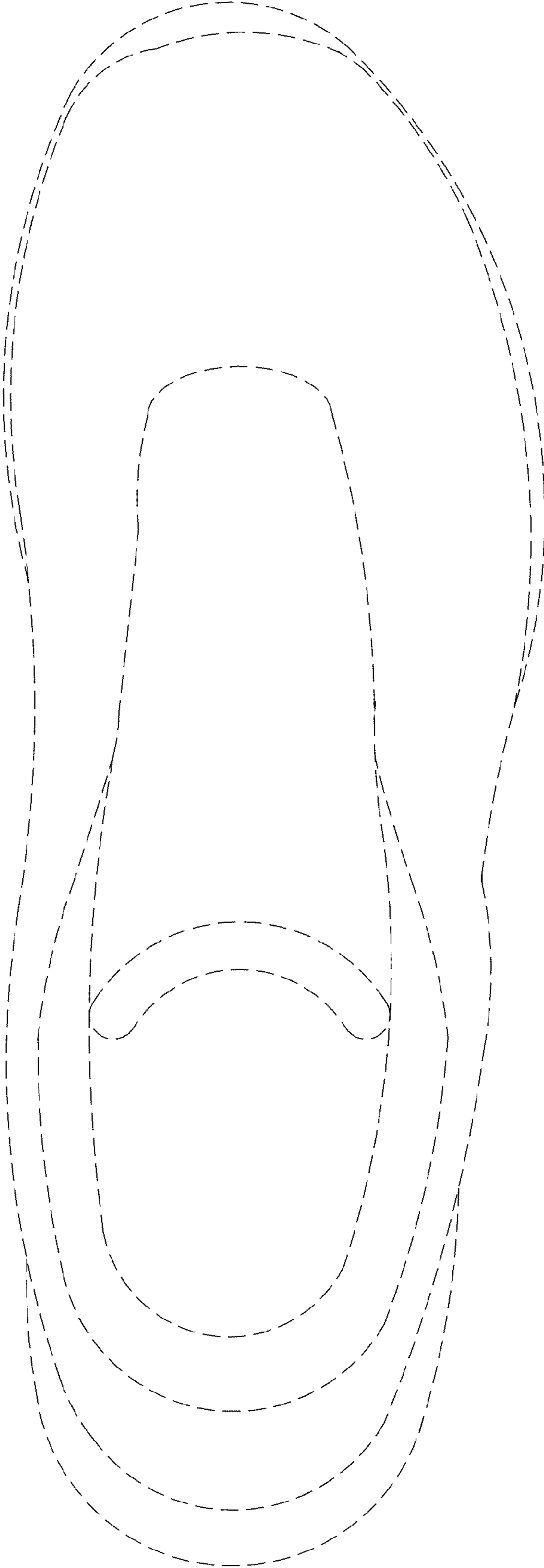
