DESCRIPTION

FIG. 1 is a perspective view of a shoe bottom embodying my new design.

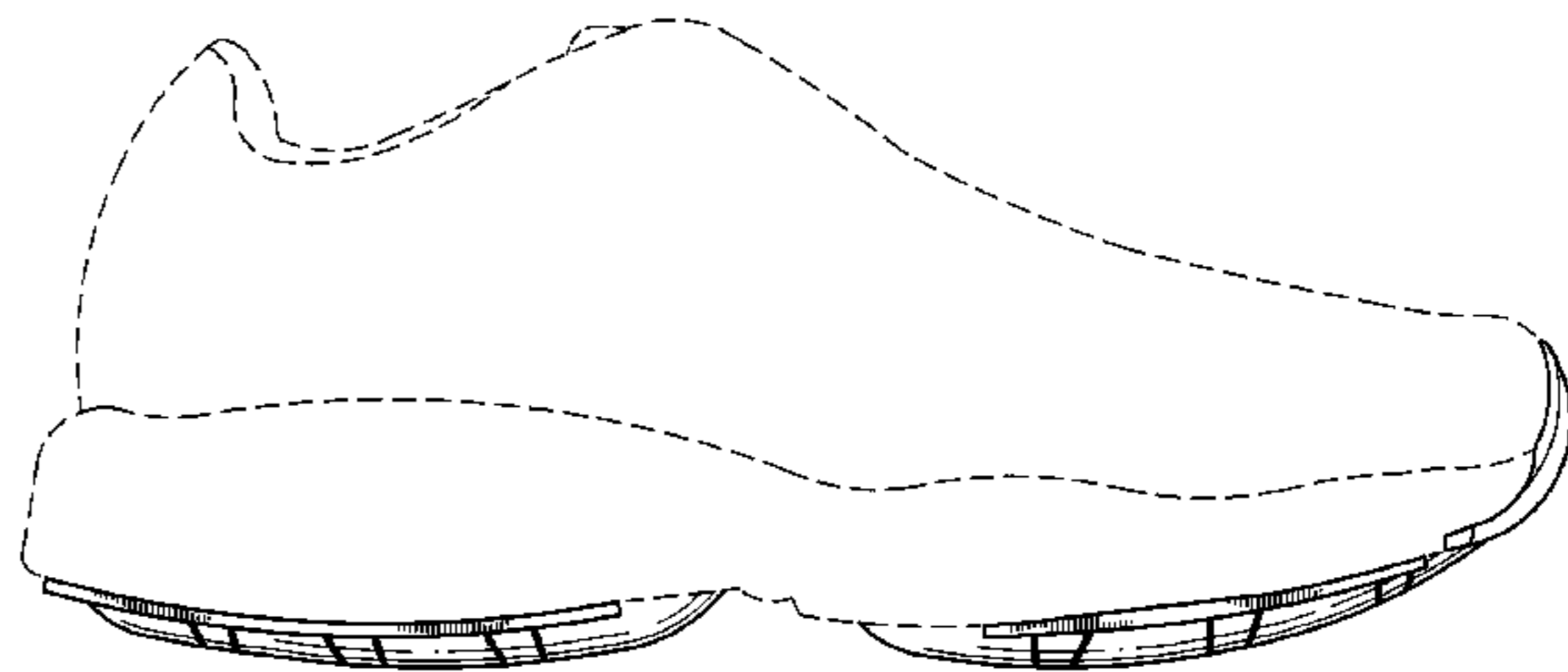
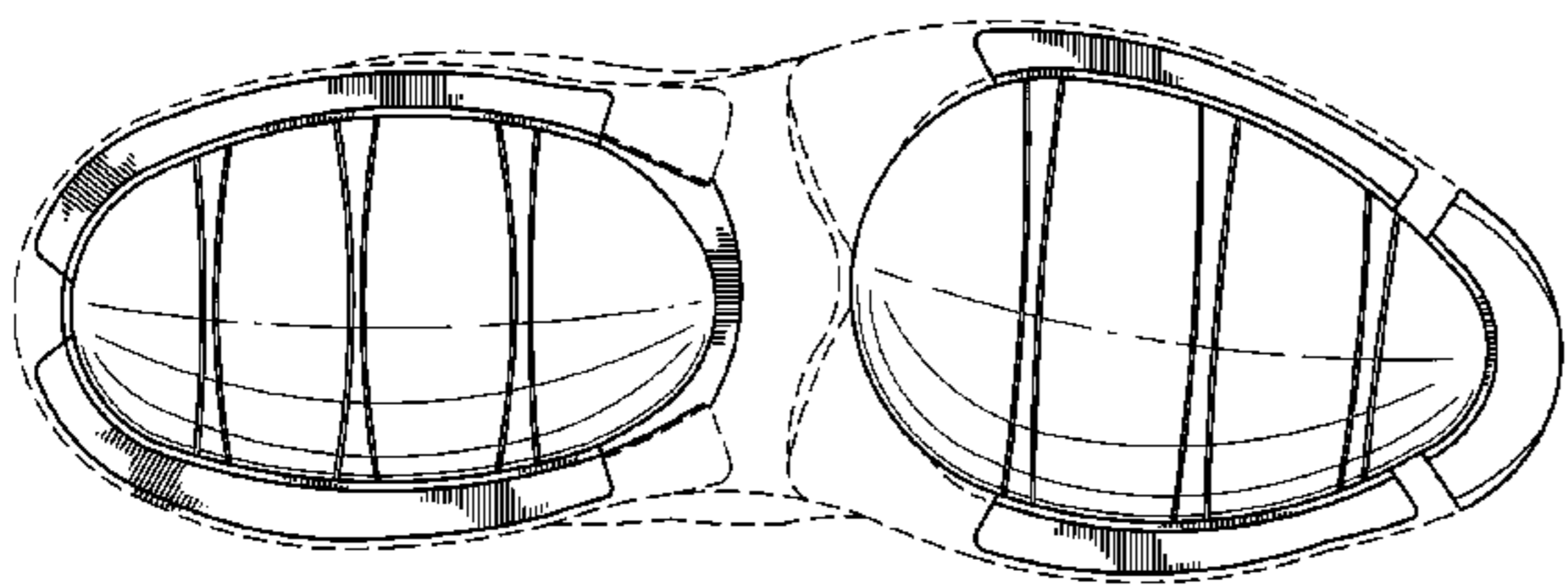
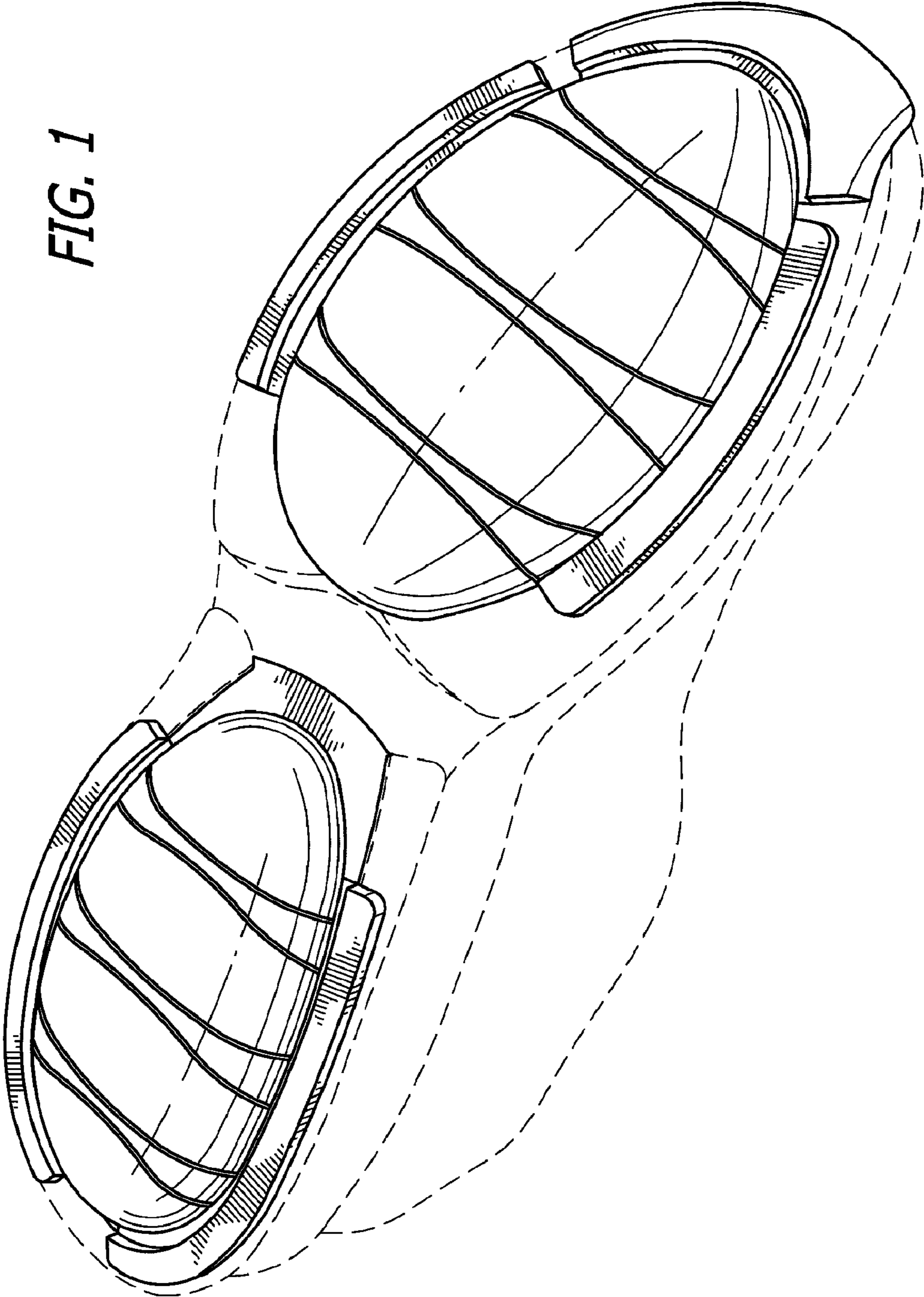

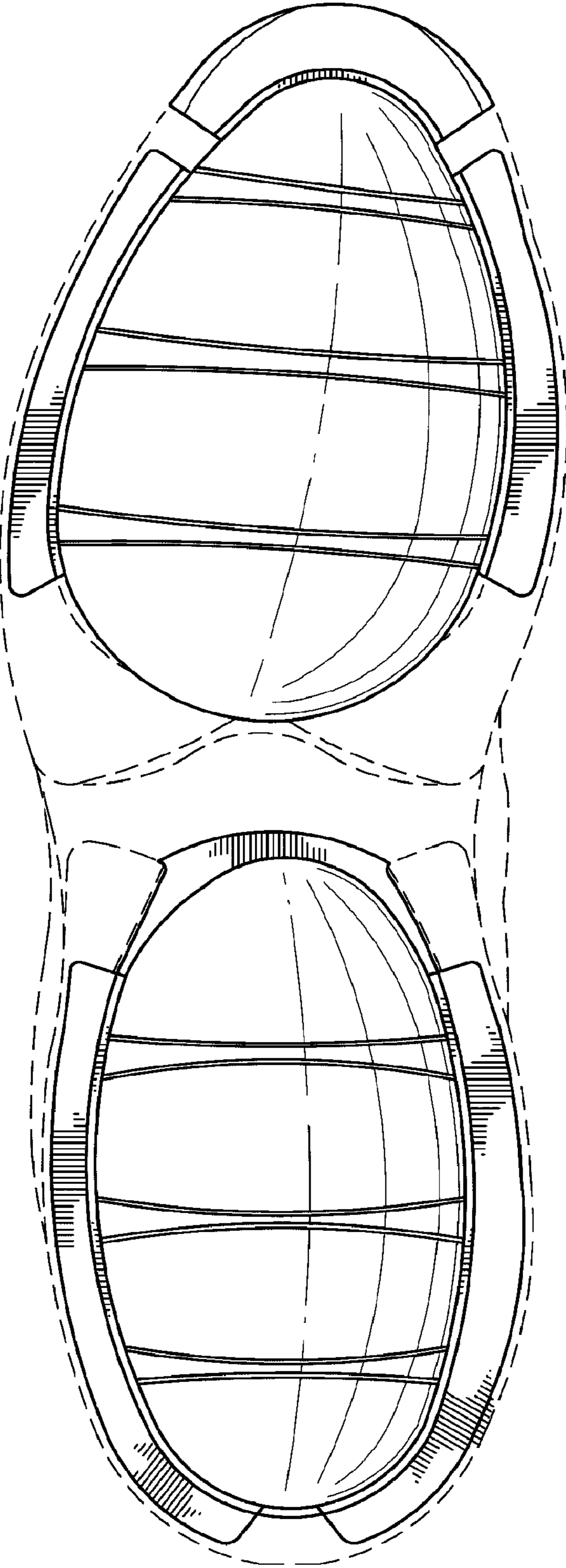
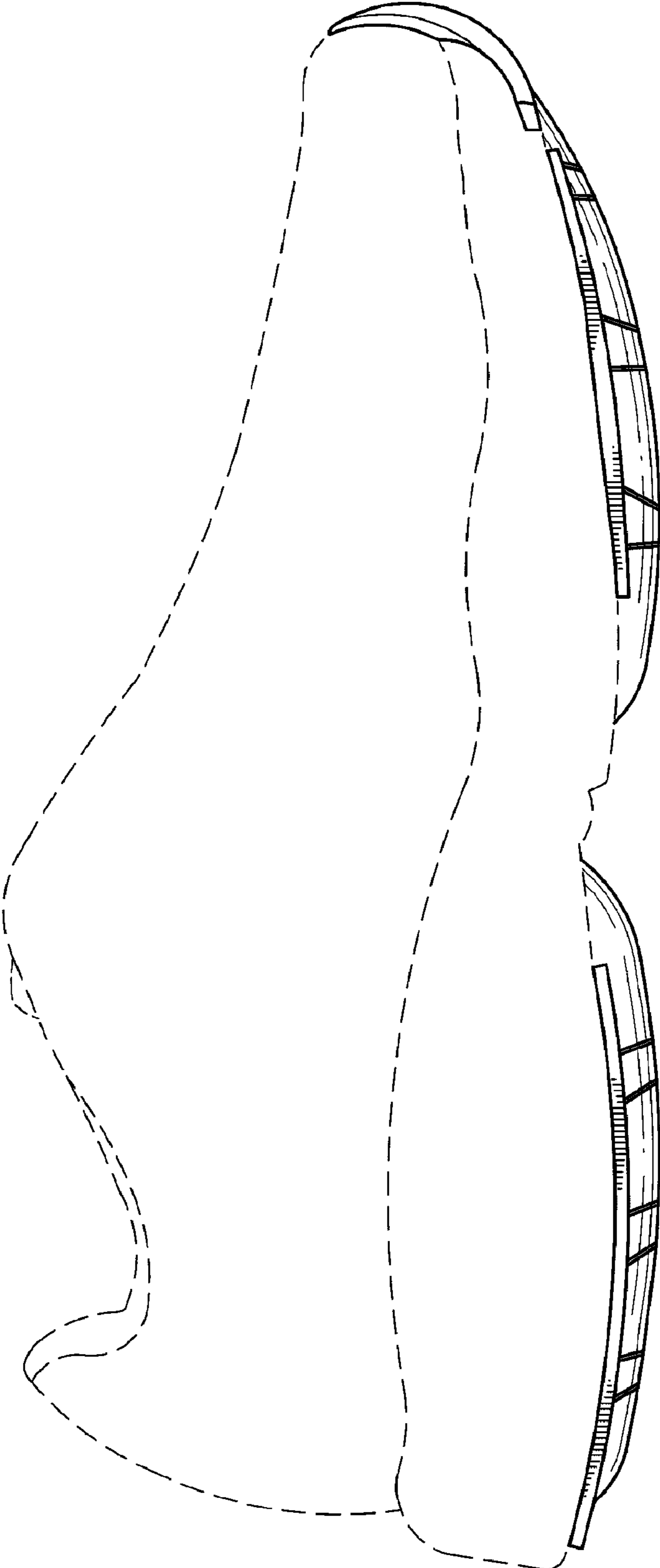

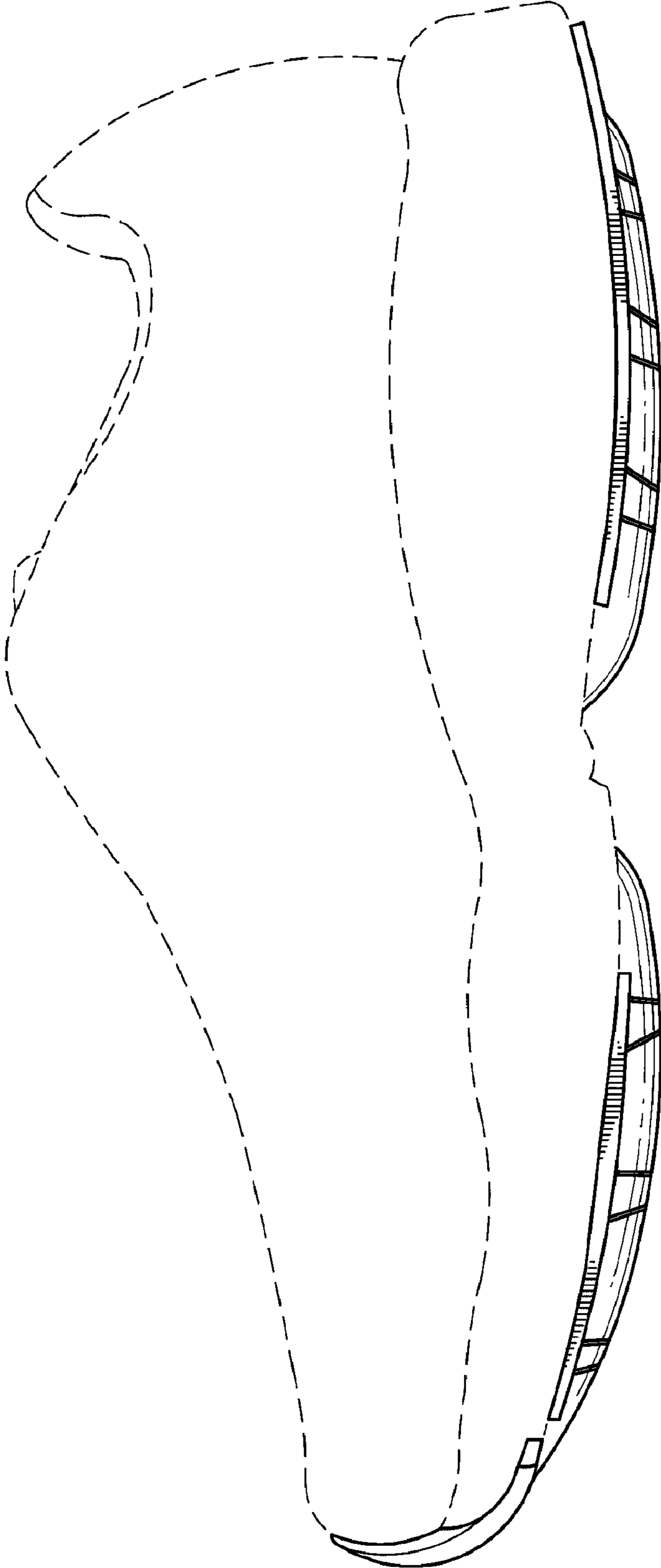

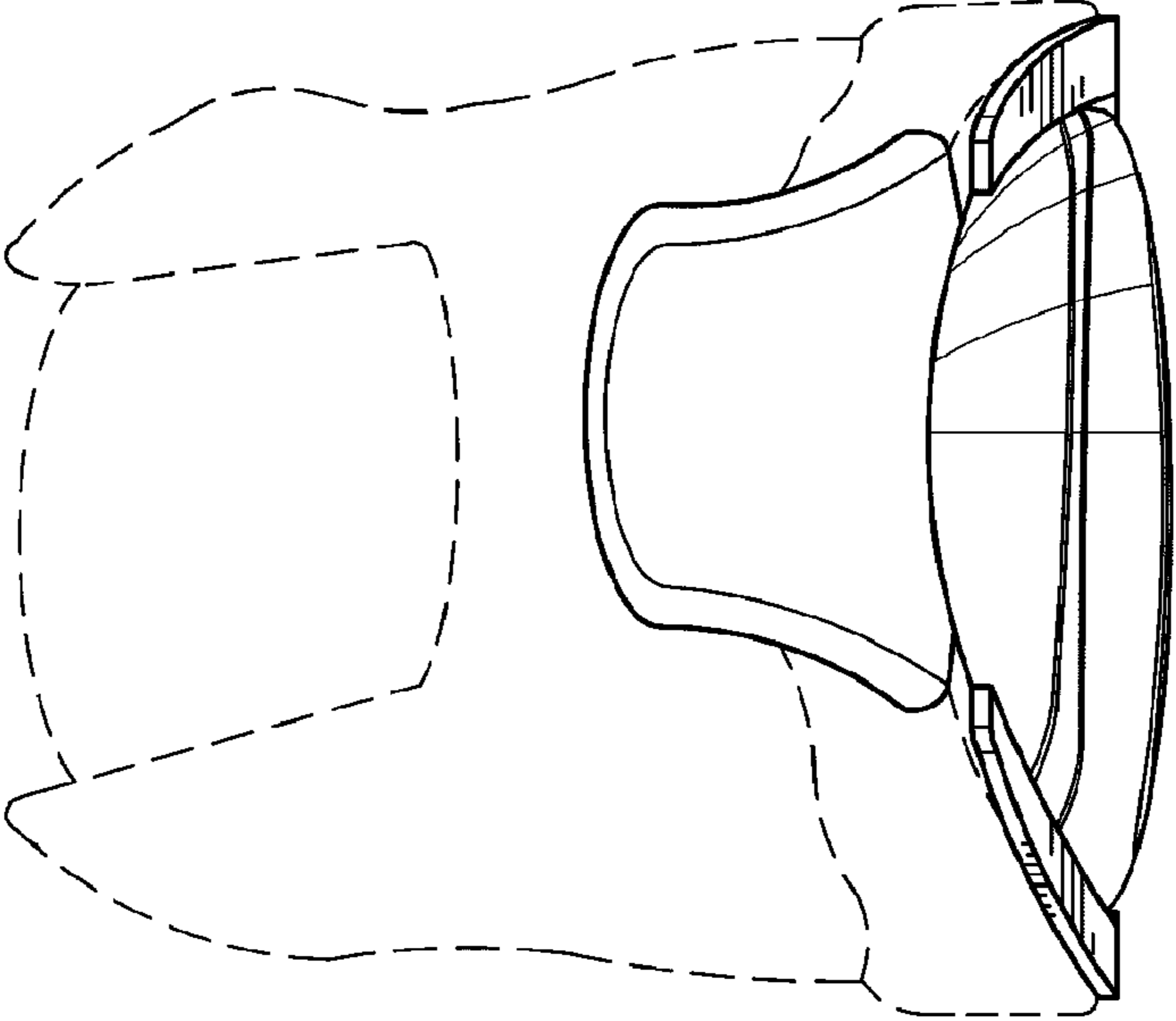
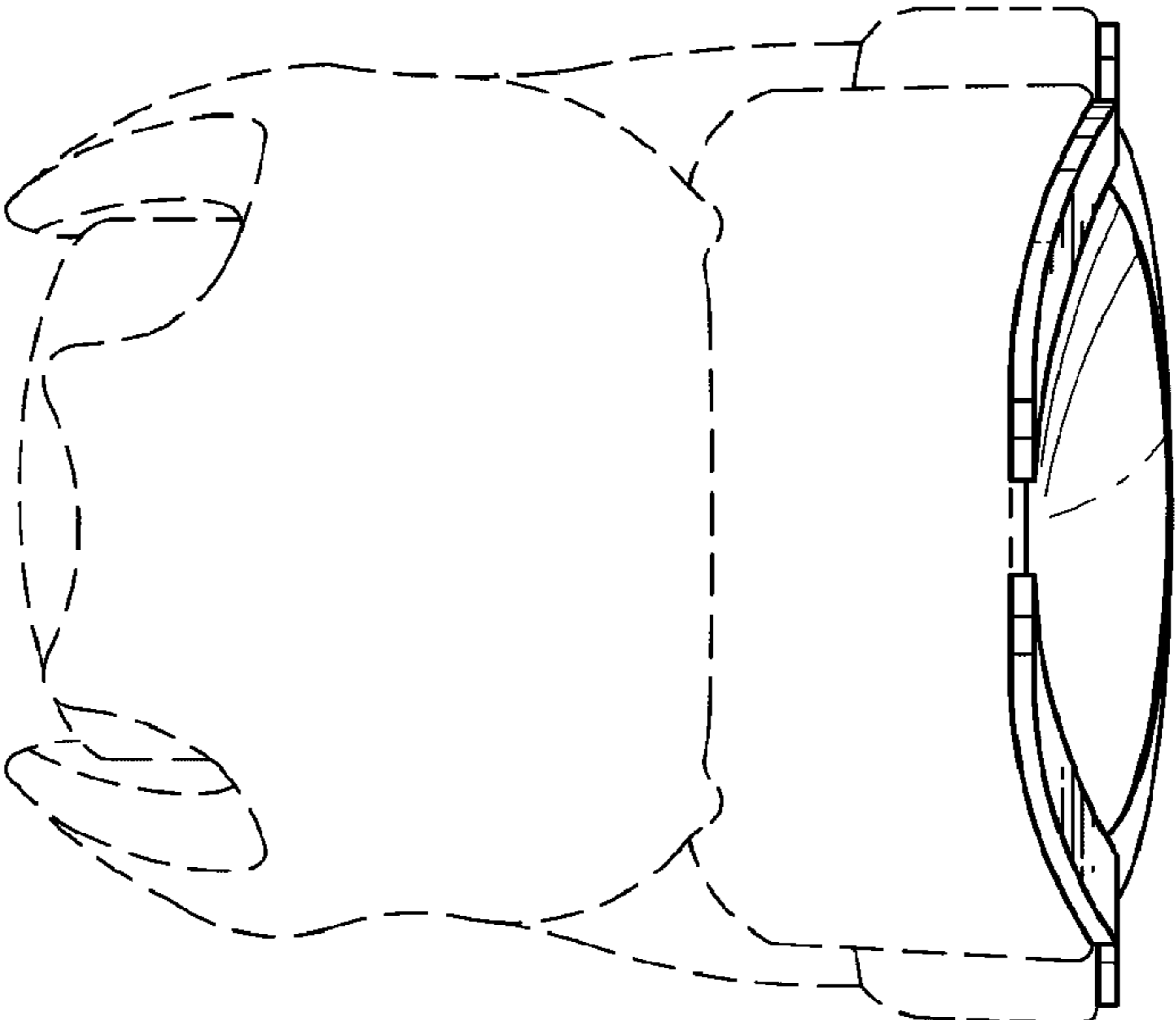

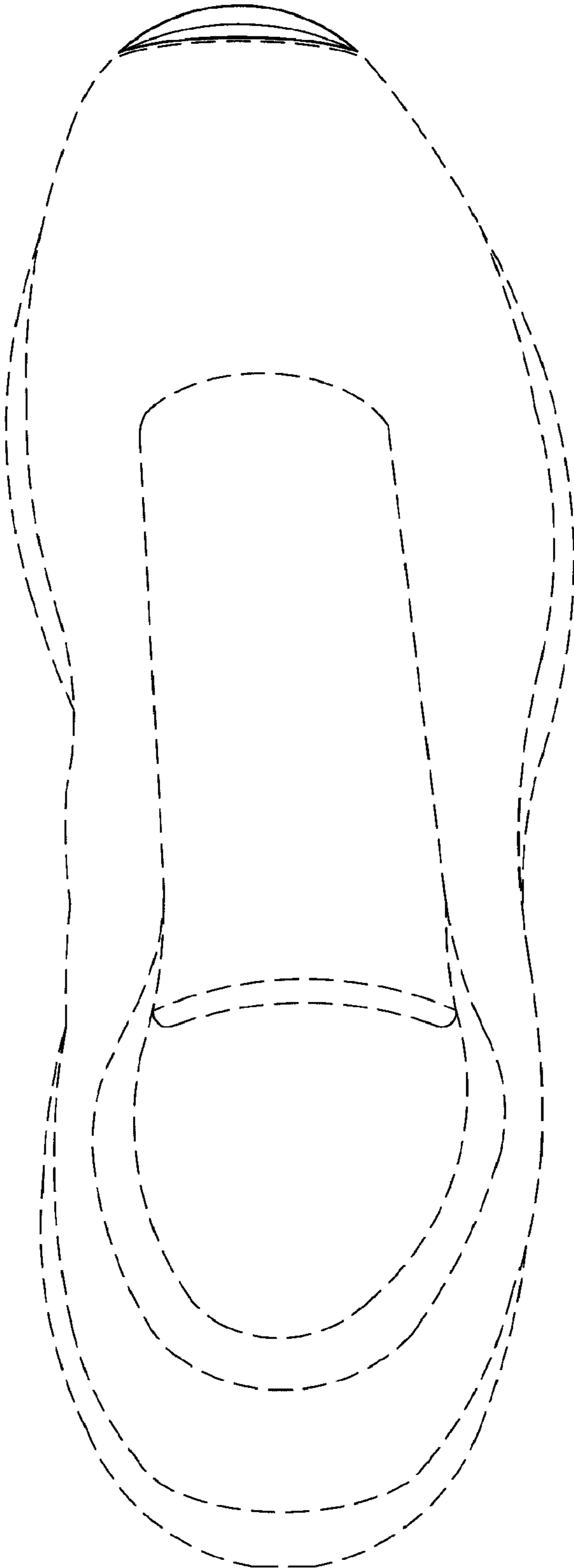
