FIG. 1 a perspective view of a product display embodying our
new design;

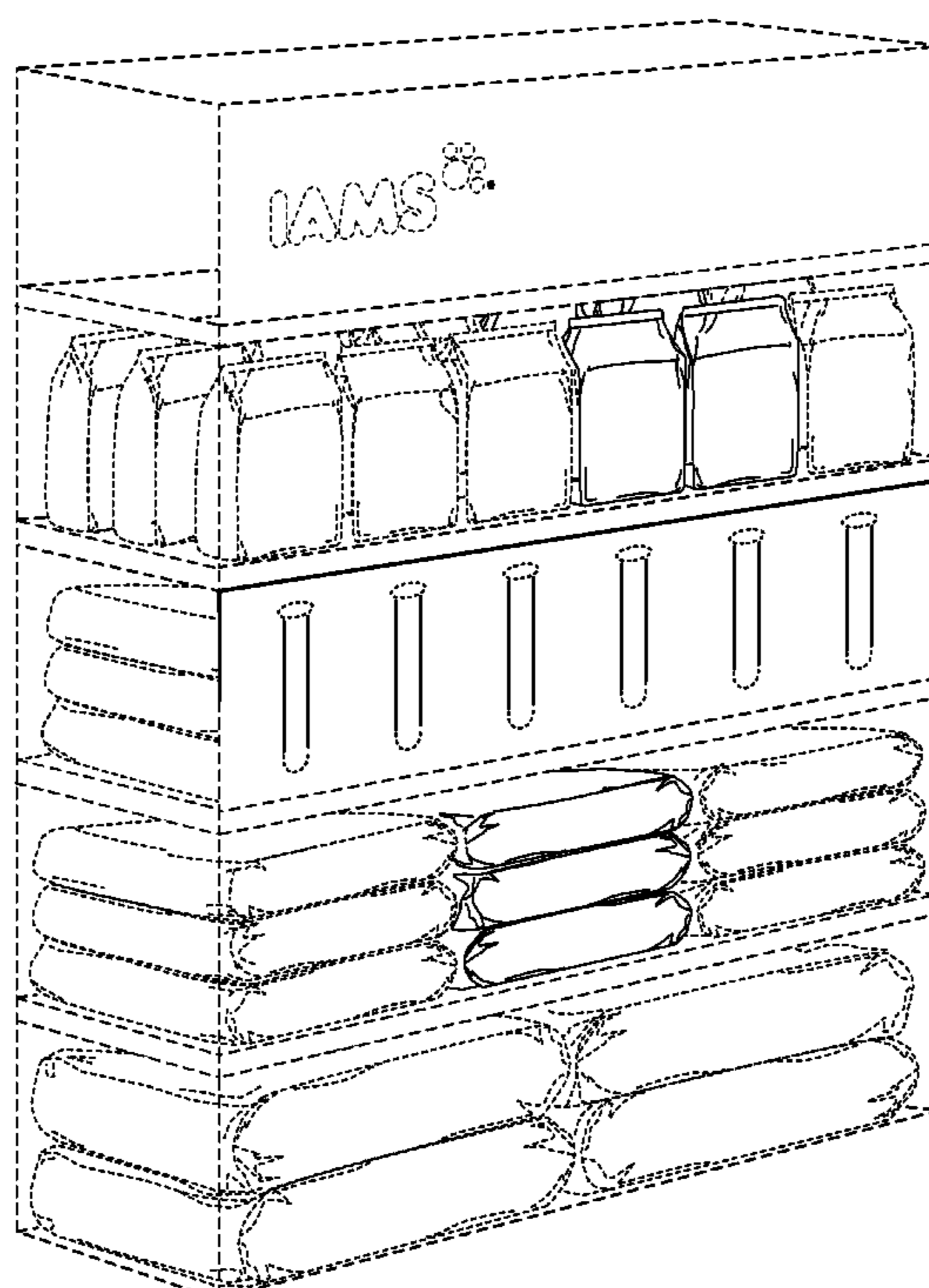
FIG. 2 is a front view thereof;

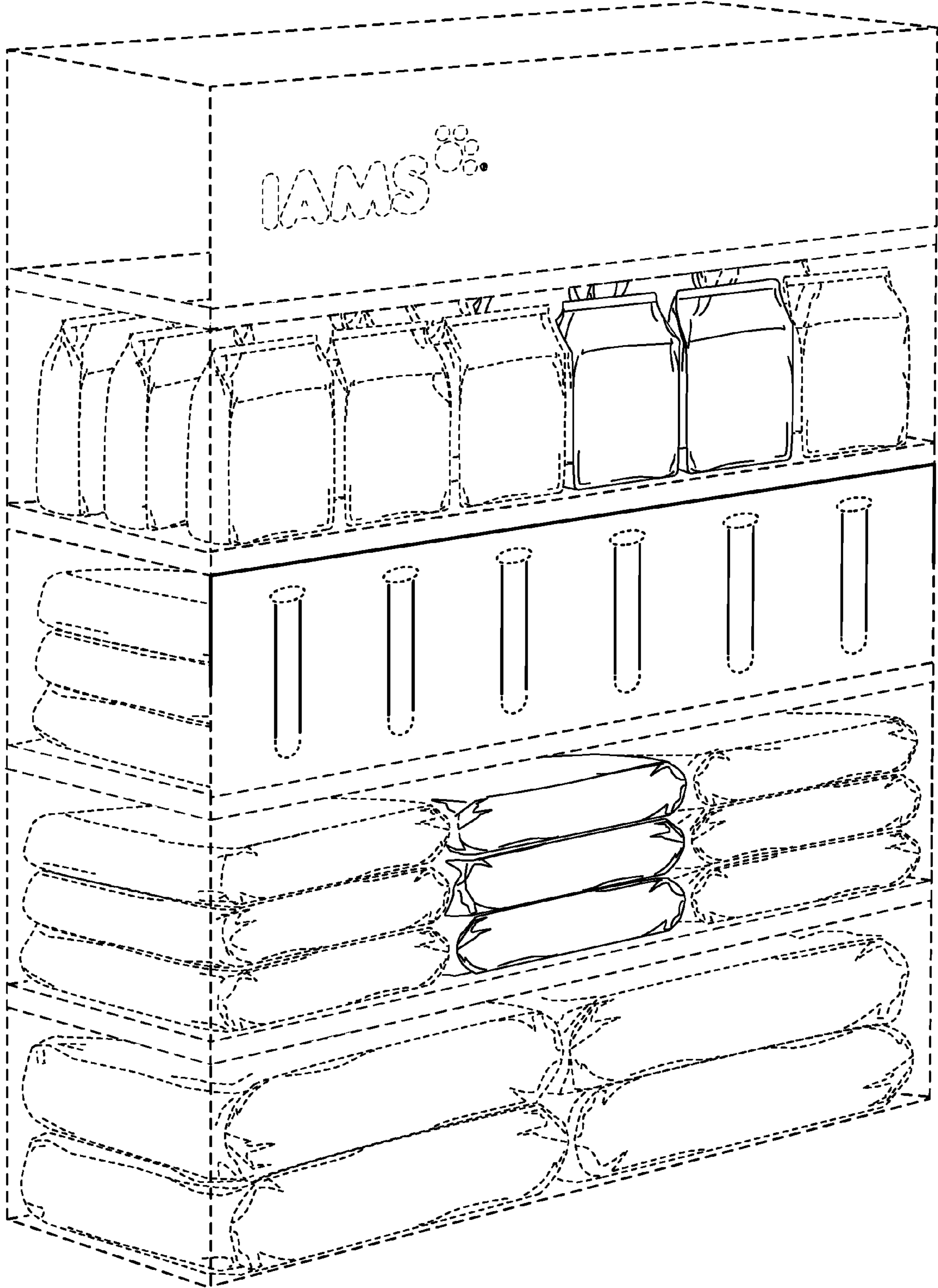

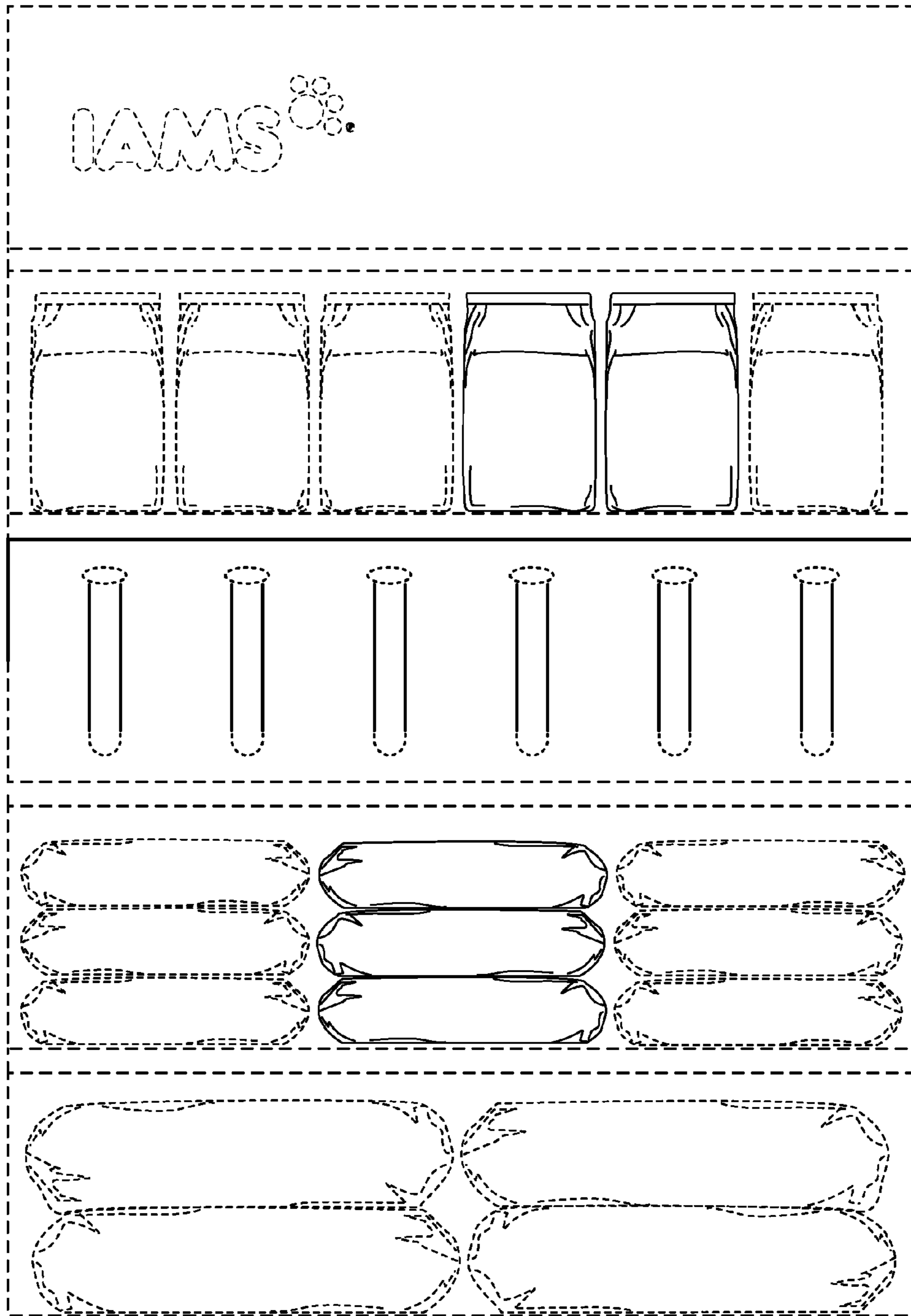

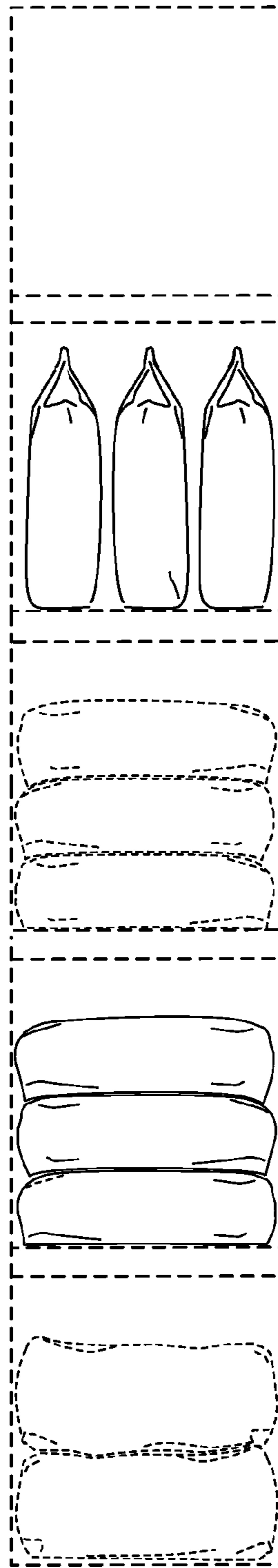

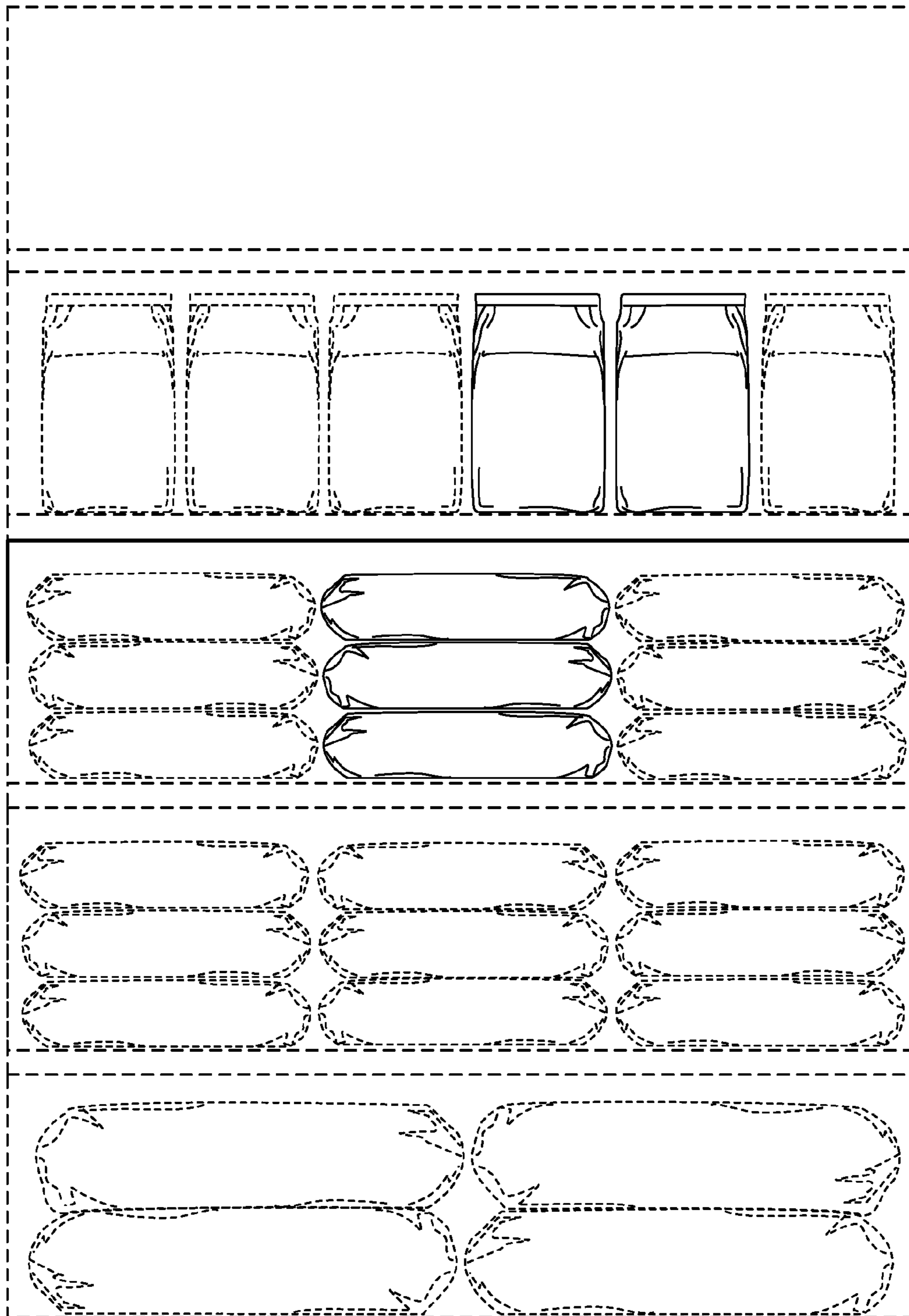
