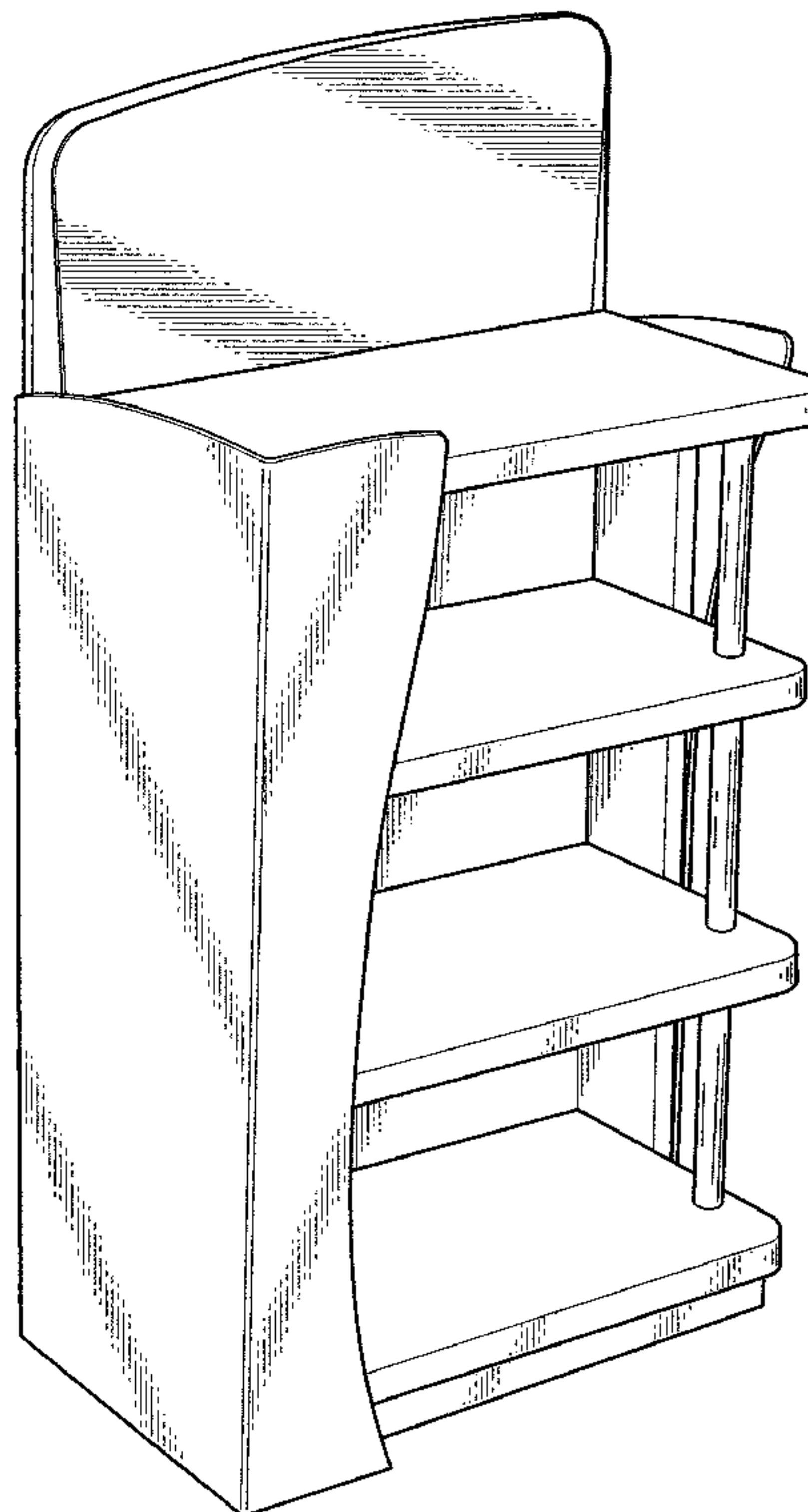
(57) **CLAIM**

We claim the ornamental design for a merchandising display rack, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a merchandising display rack showing our new design; FIG. 2 is a left side perspective view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a back elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

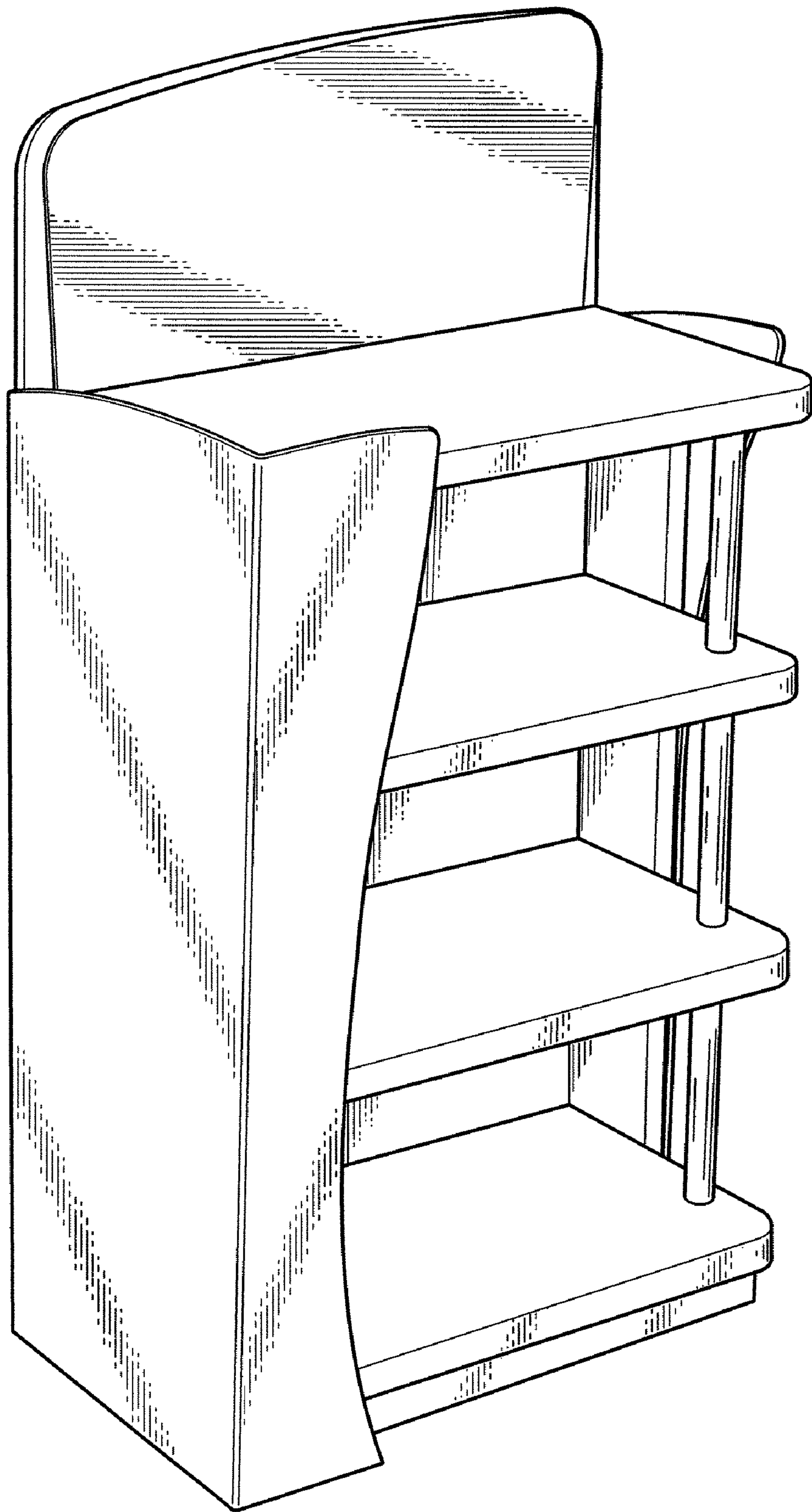

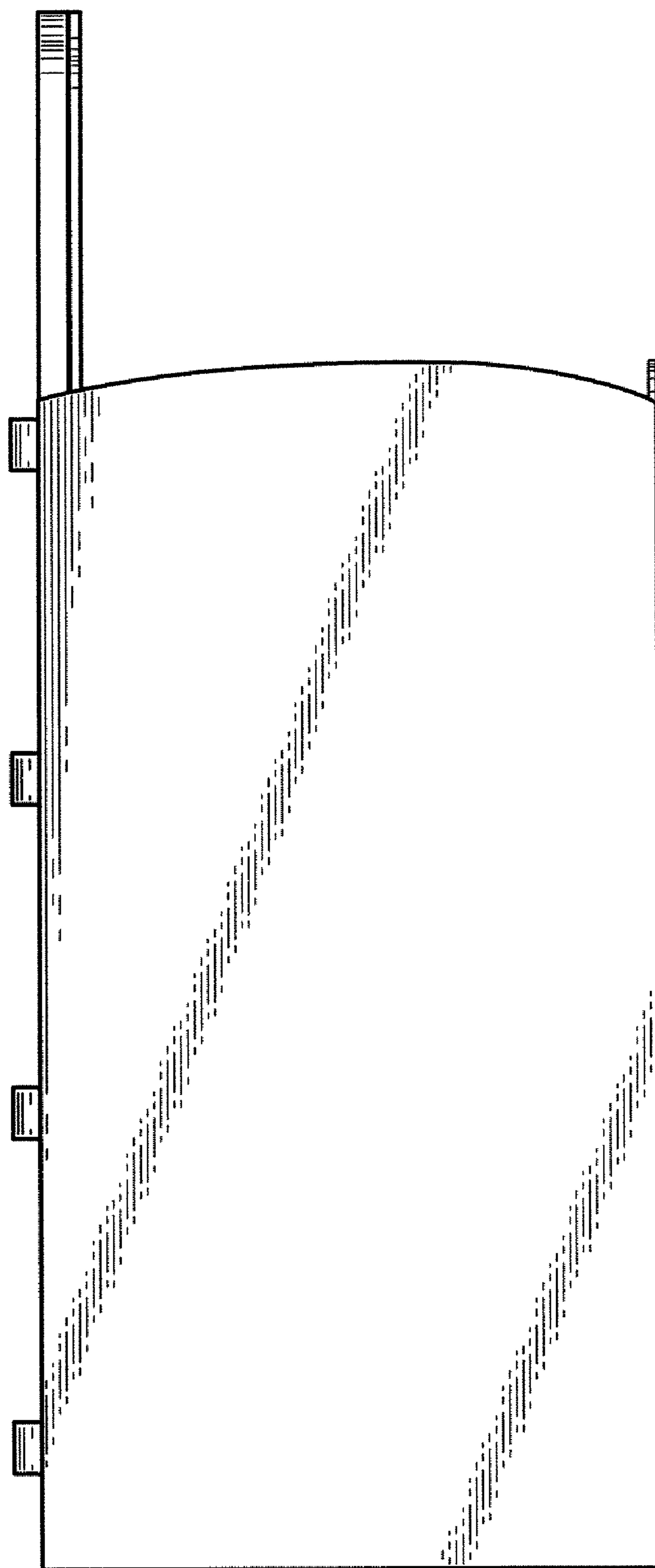

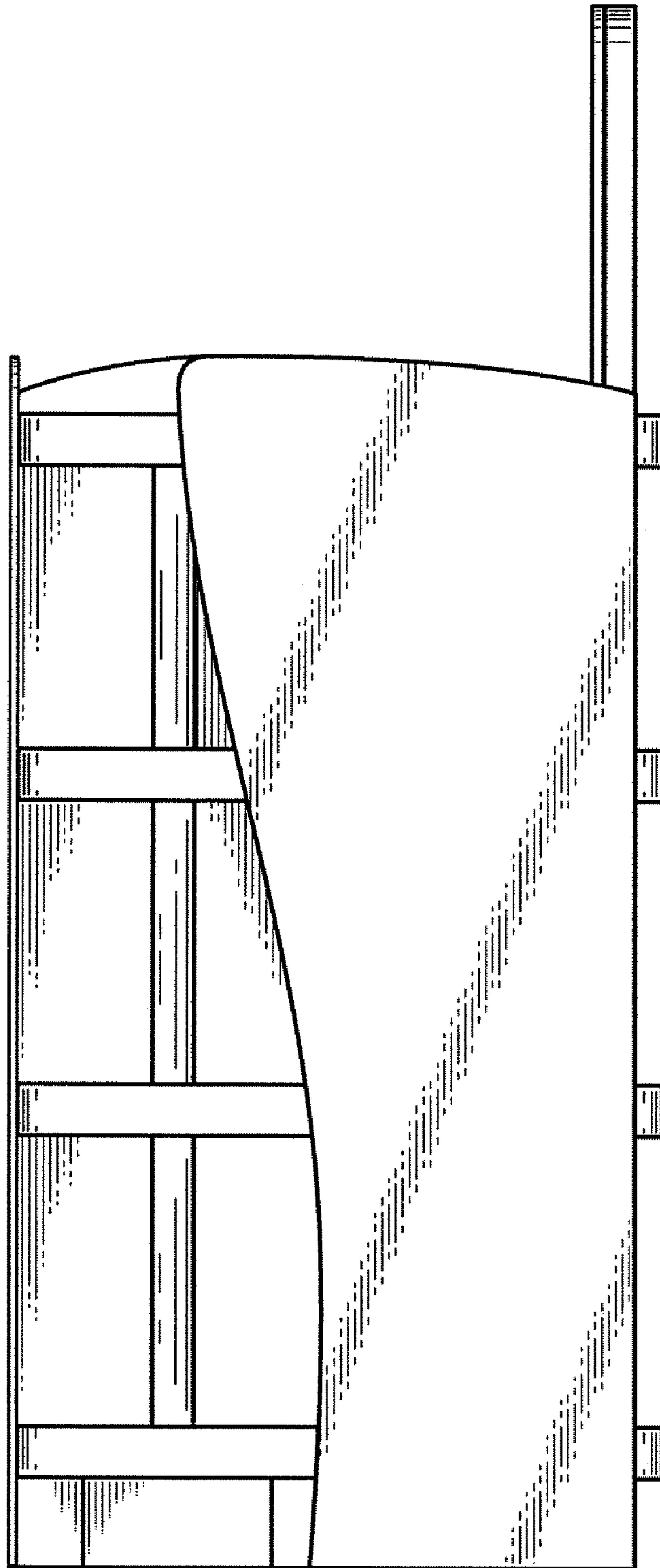

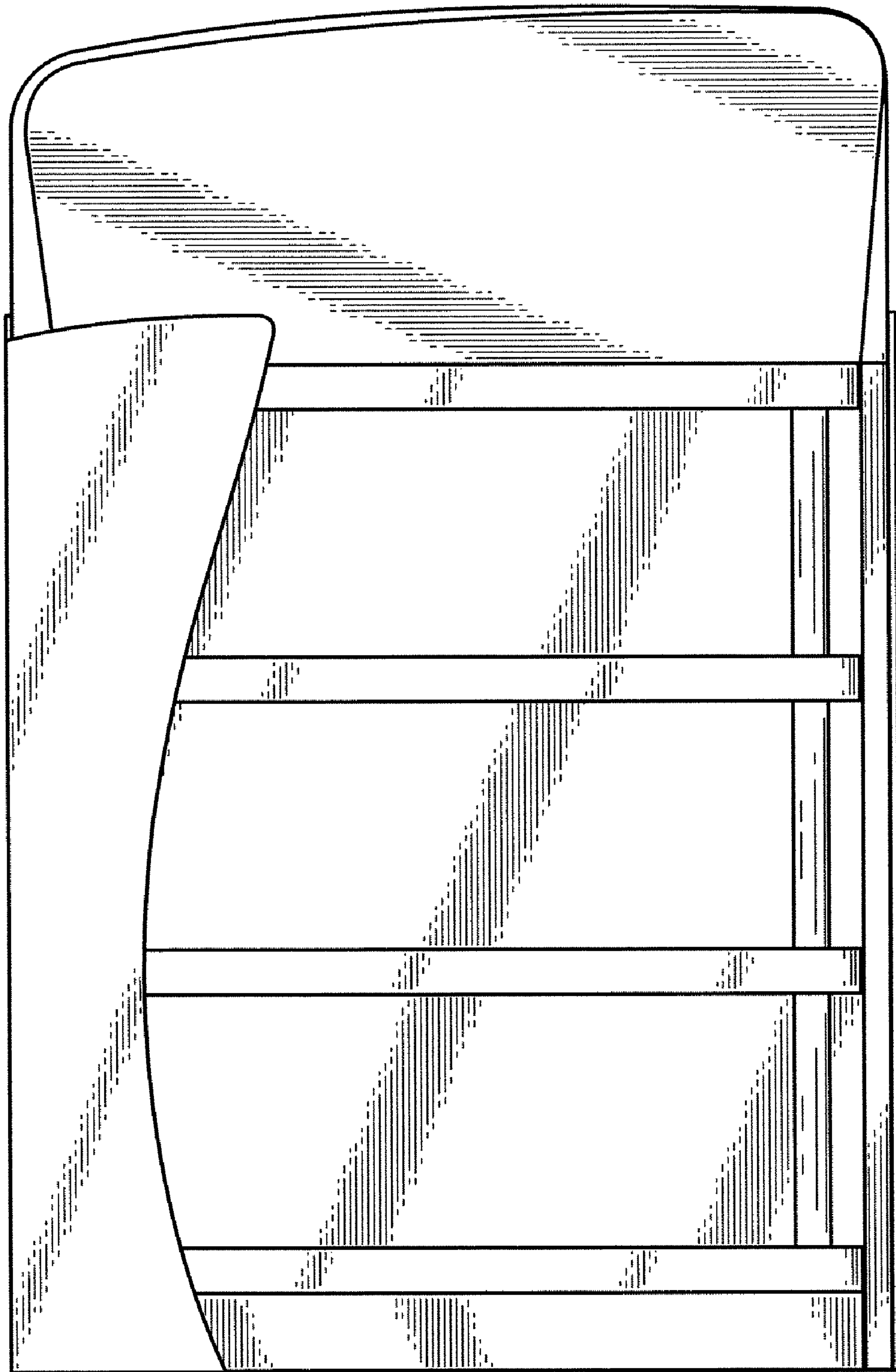

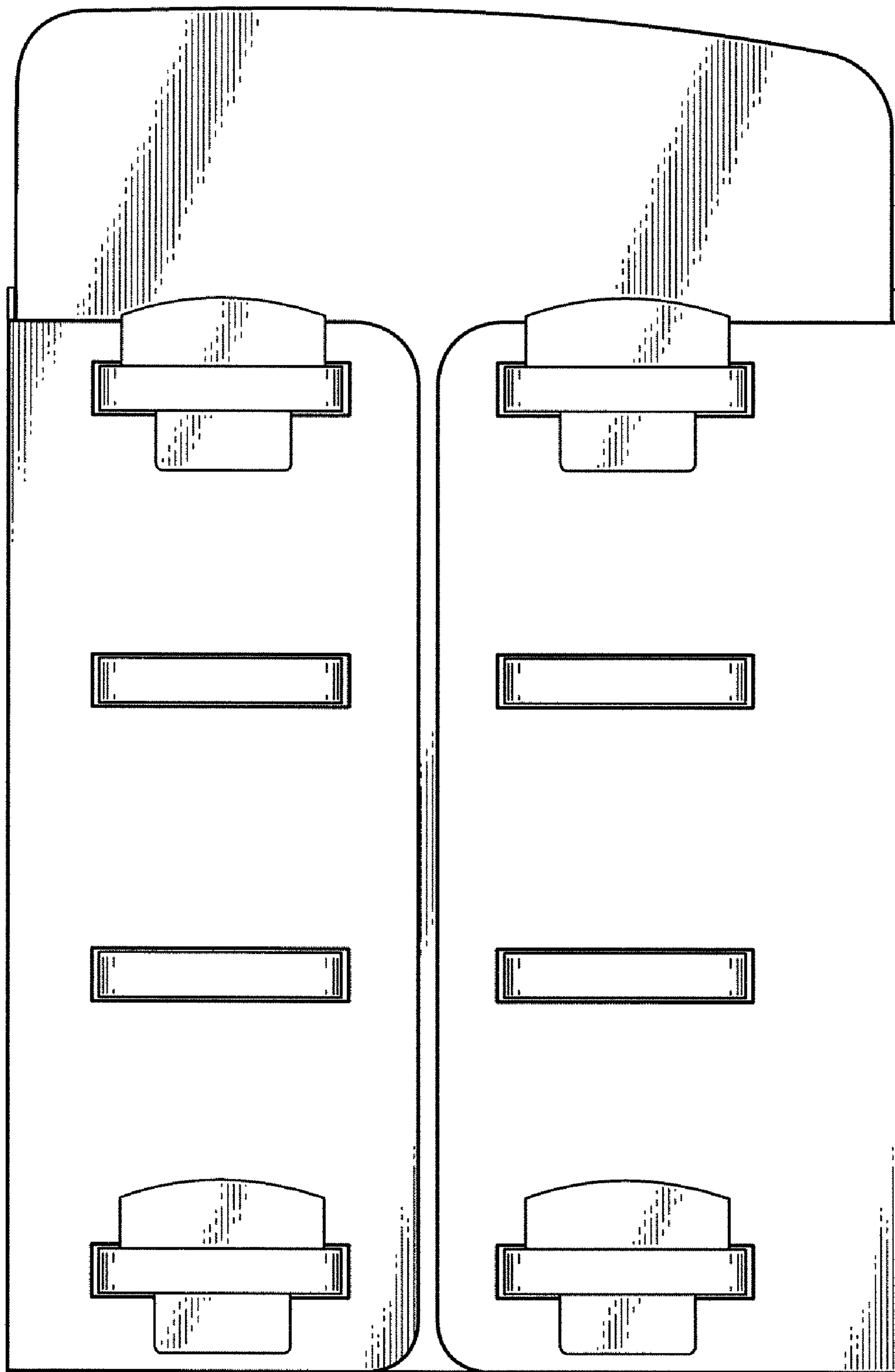

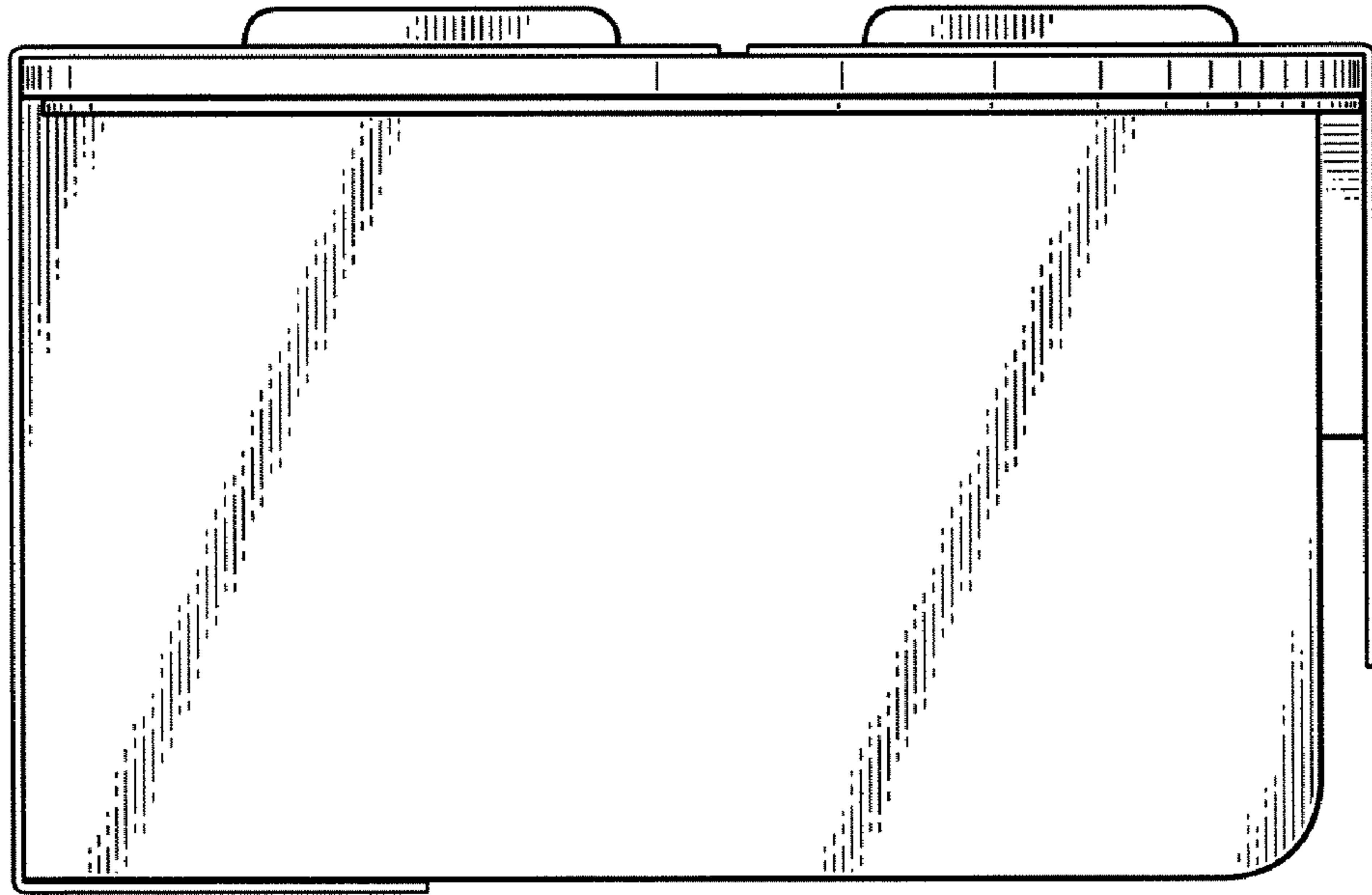

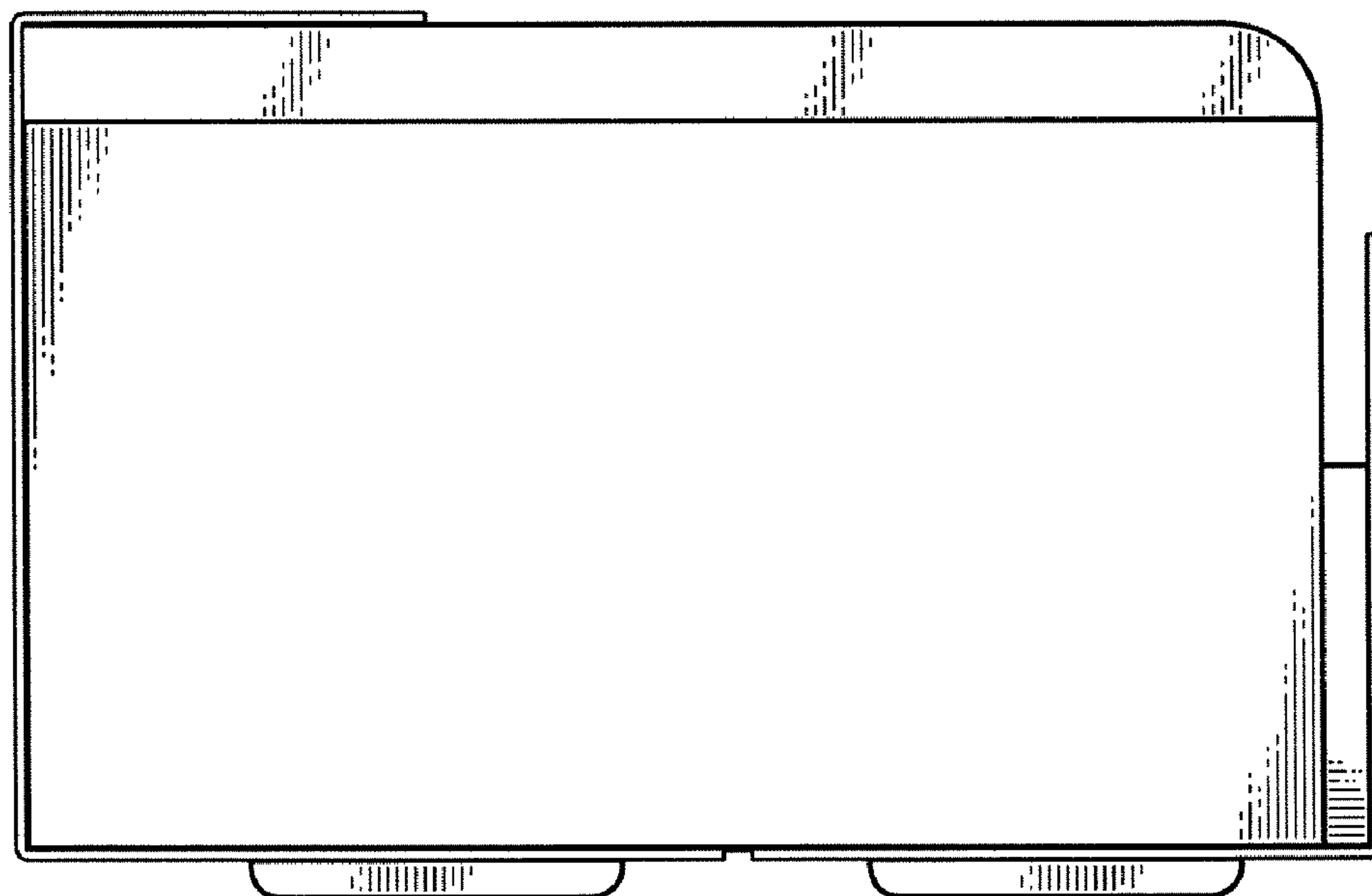
