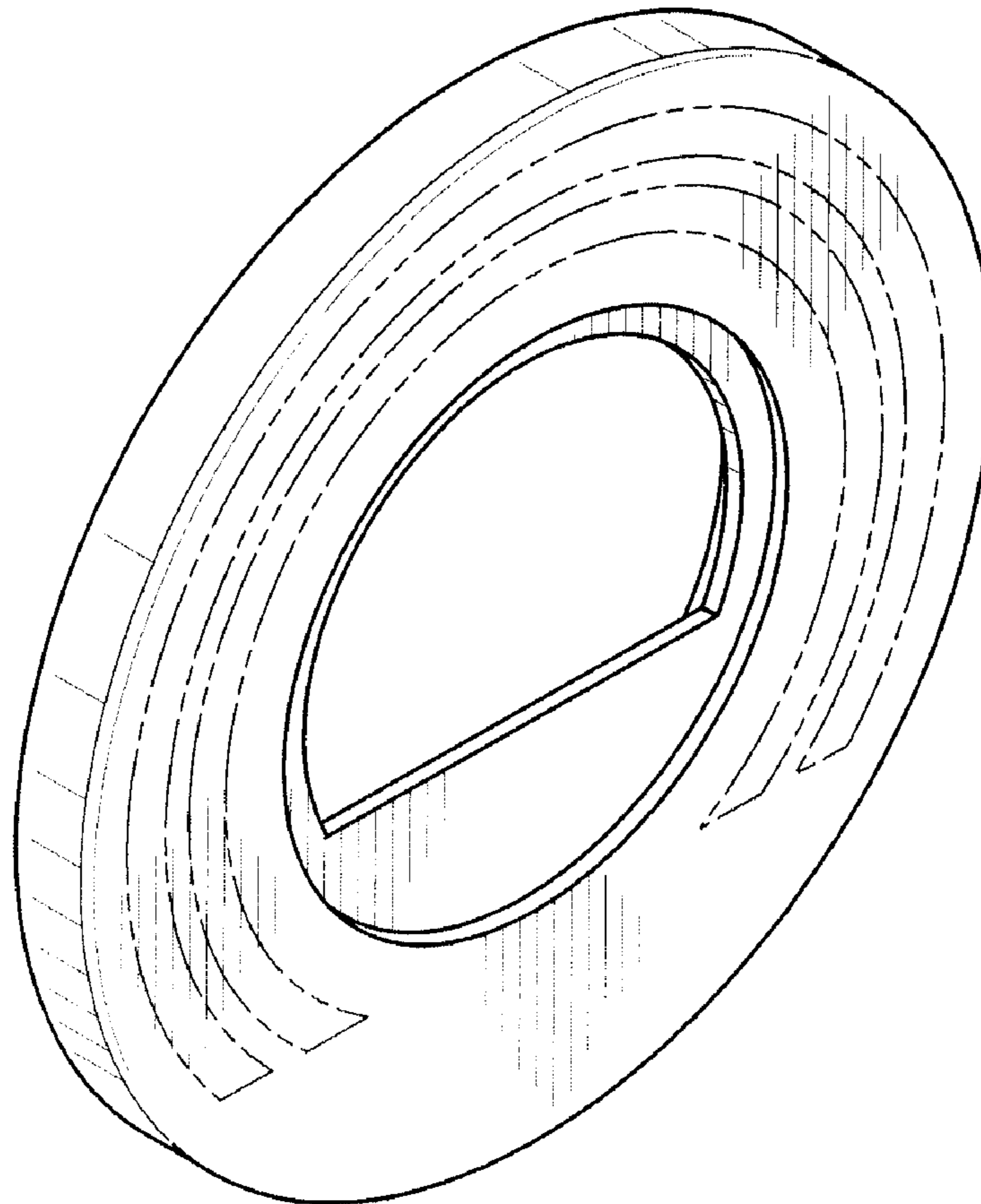
(57) **CLAIM**

The ornamental design for a washer bottle opener, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a washer bottle opener showing my new design;
FIG. 2 is a front elevational view thereof, the rear elevational view being identical thereto.
FIG. 3 is a right side elevational view thereof, the left side elevational view being identical thereto; and,

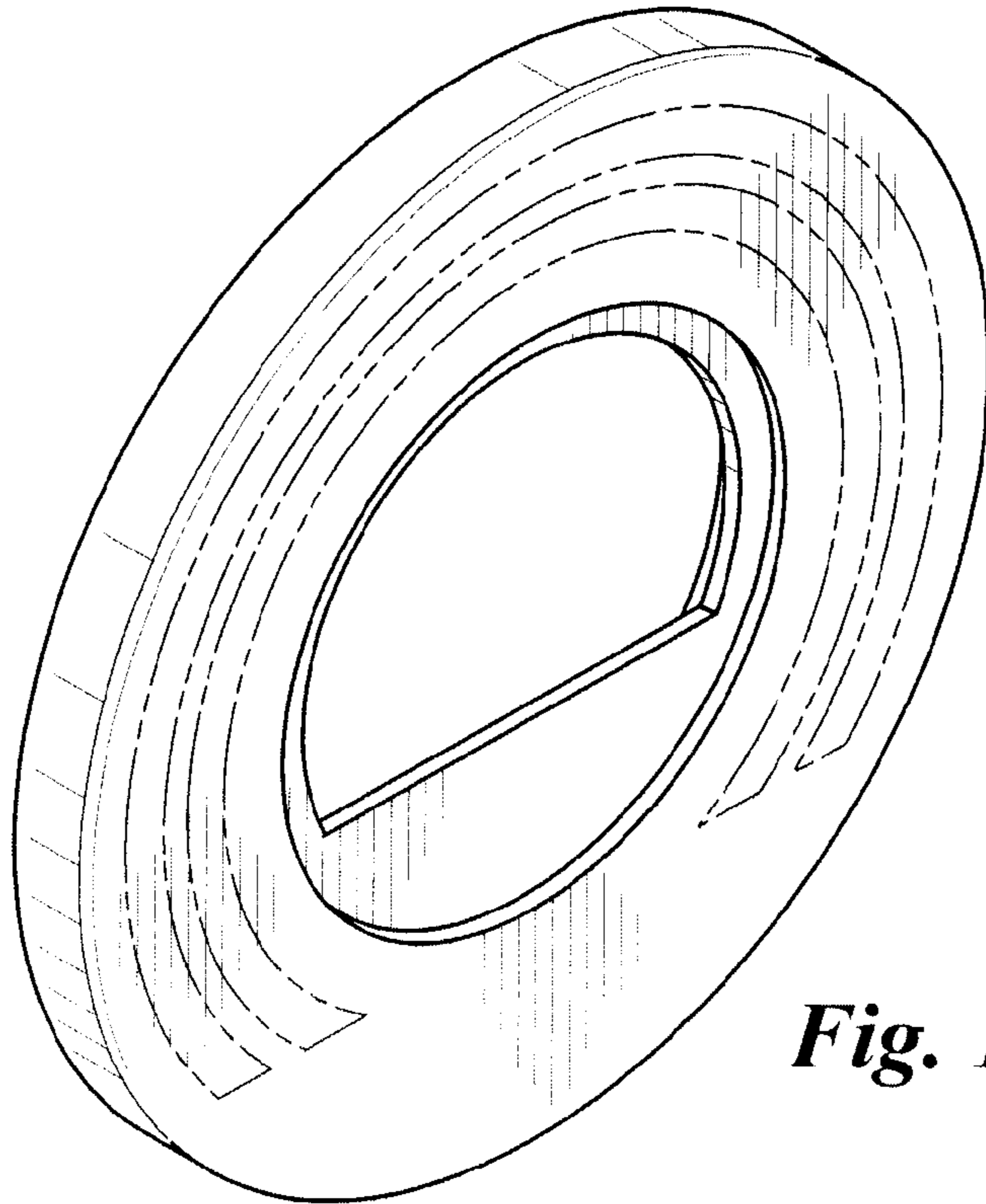

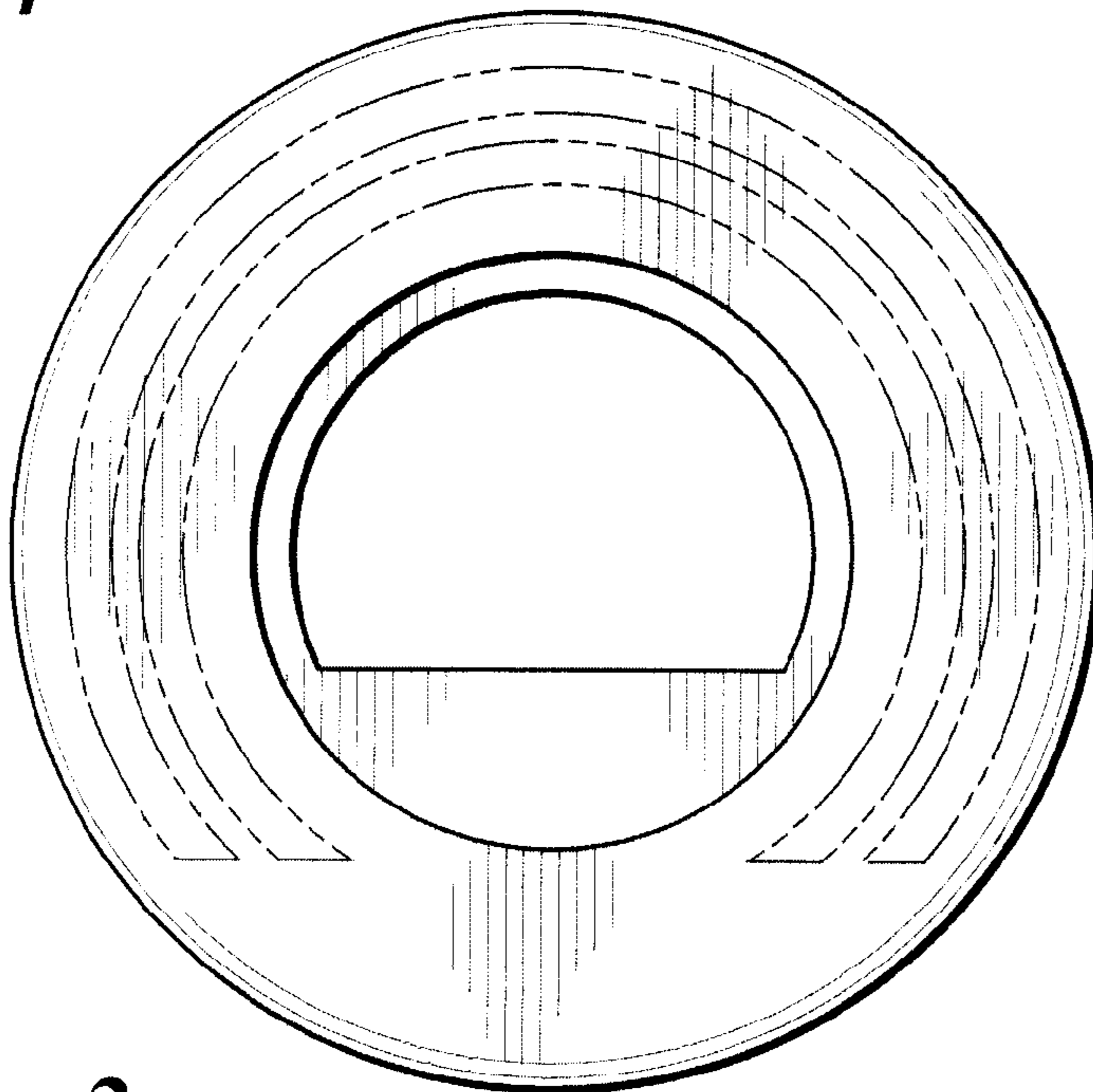
