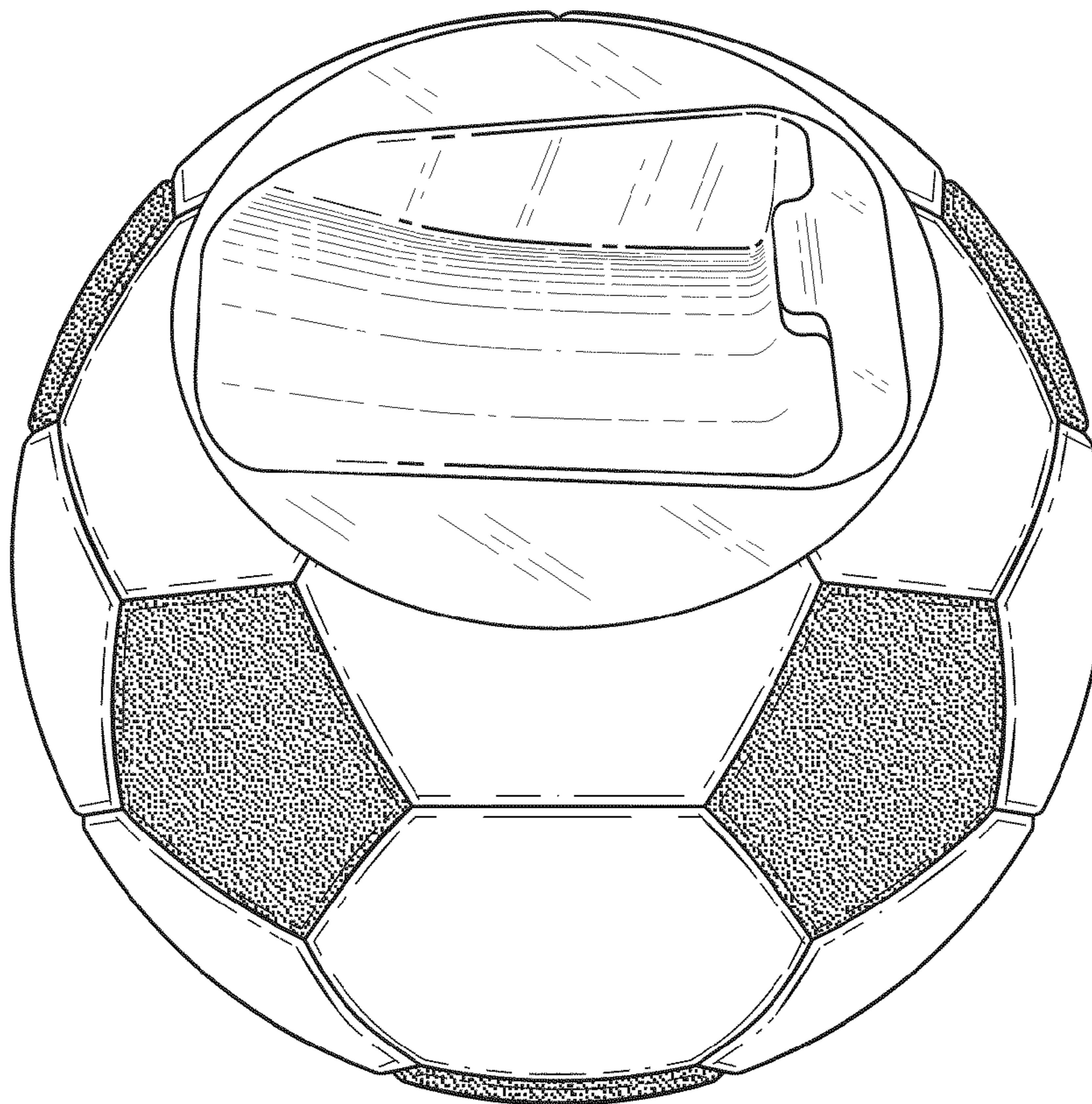
(57) **CLAIM**

The ornamental design for a soccer ball shaped bottle opener, as shown herein.

DESCRIPTION

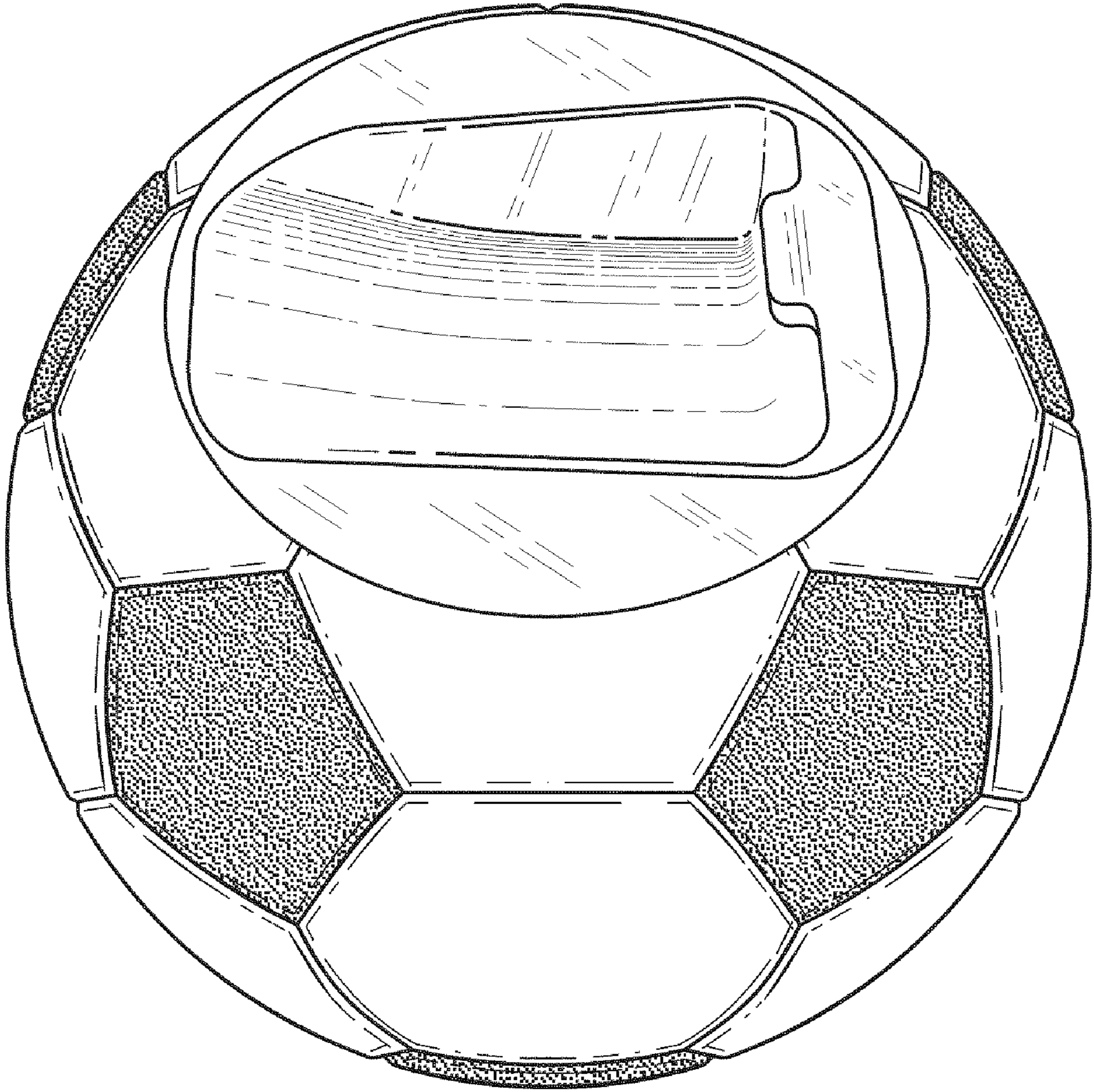

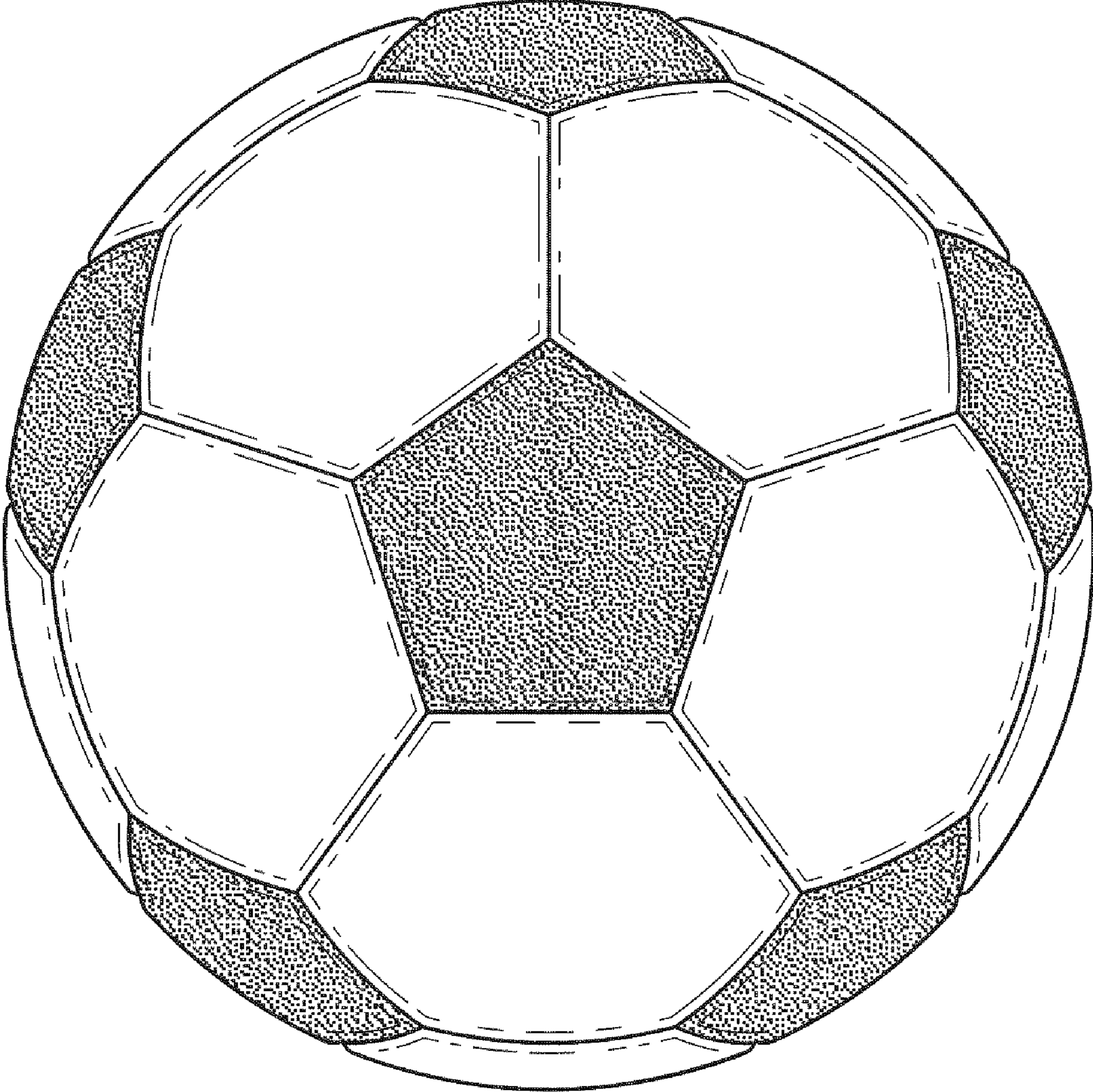

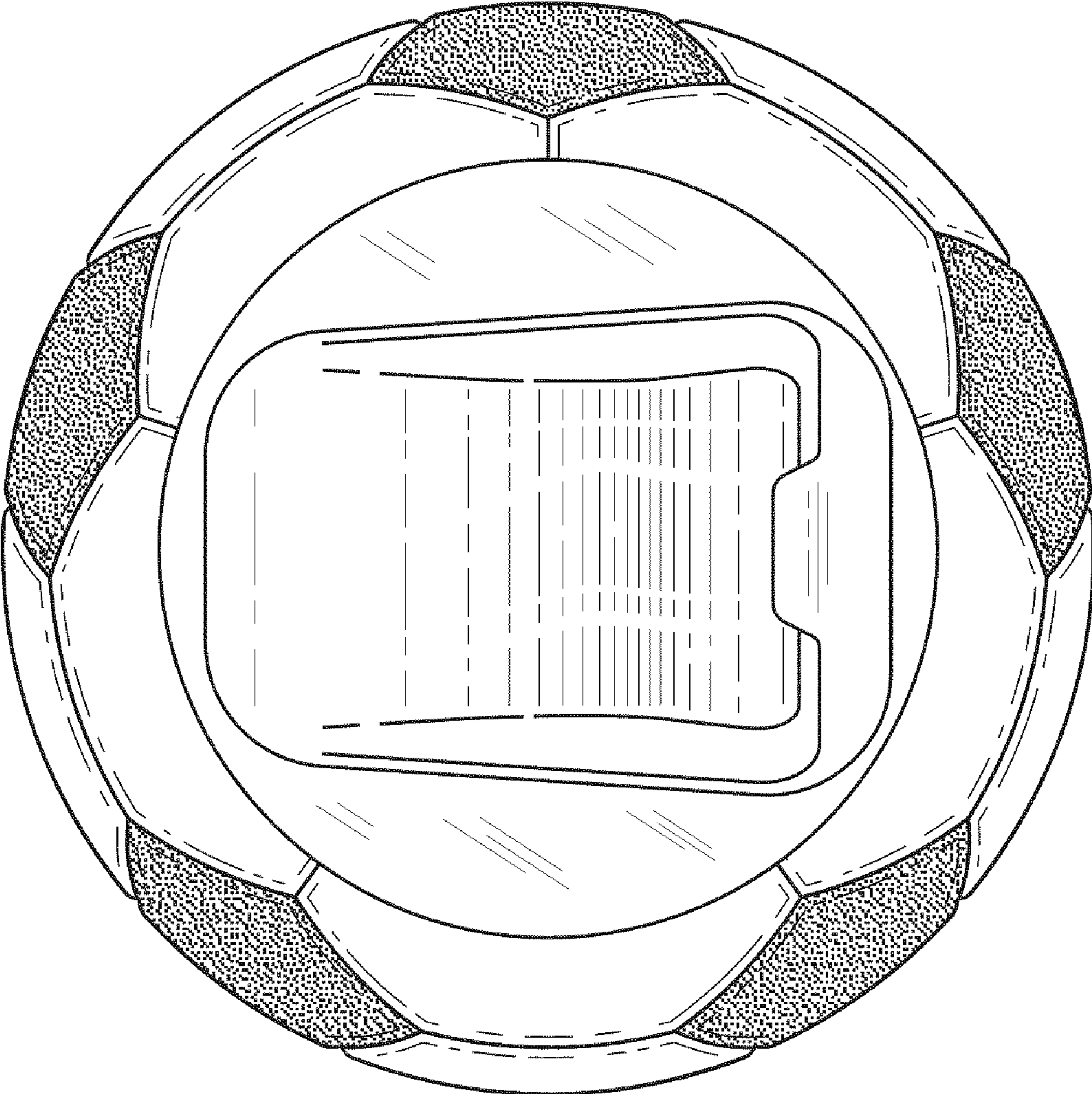

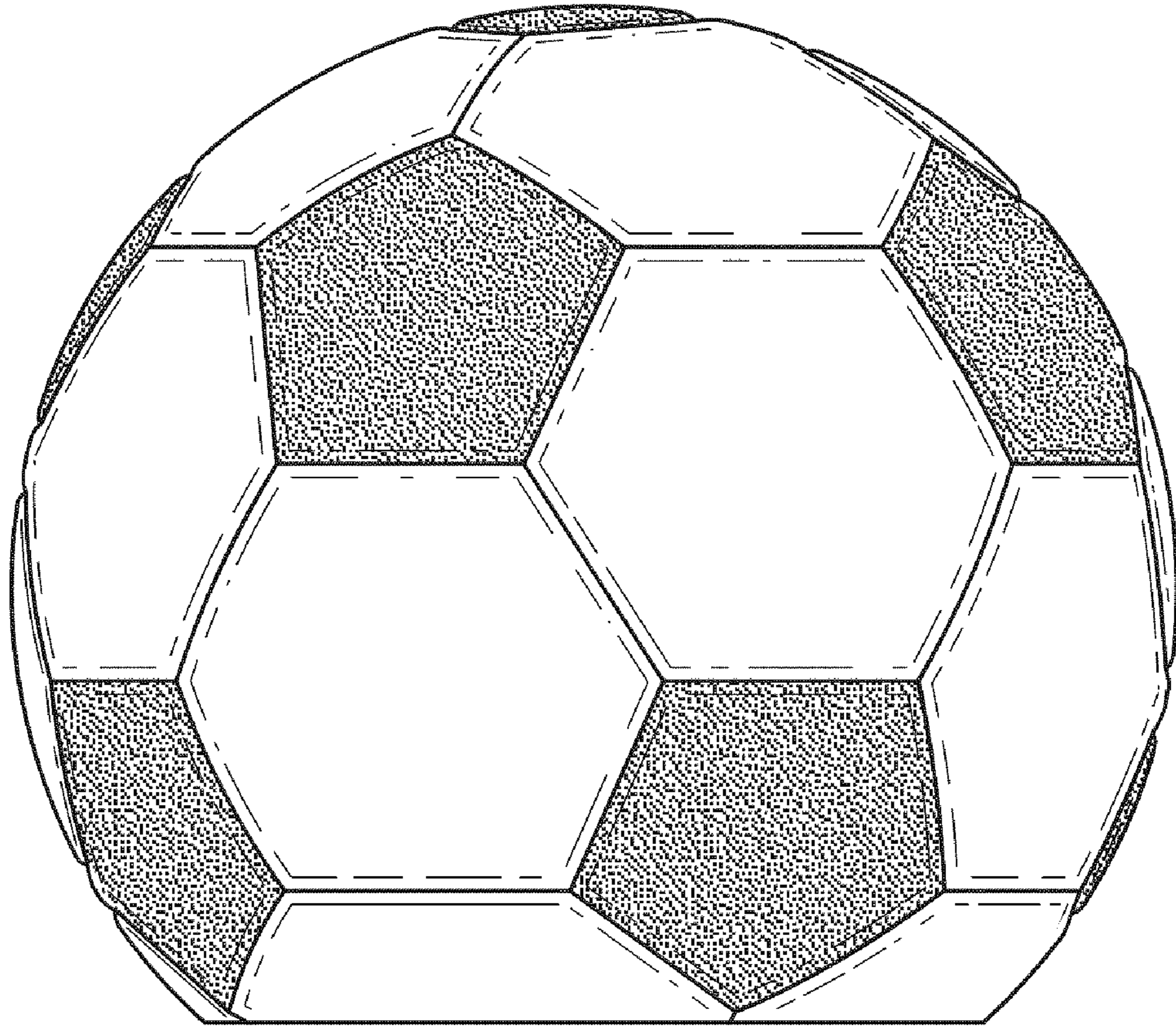

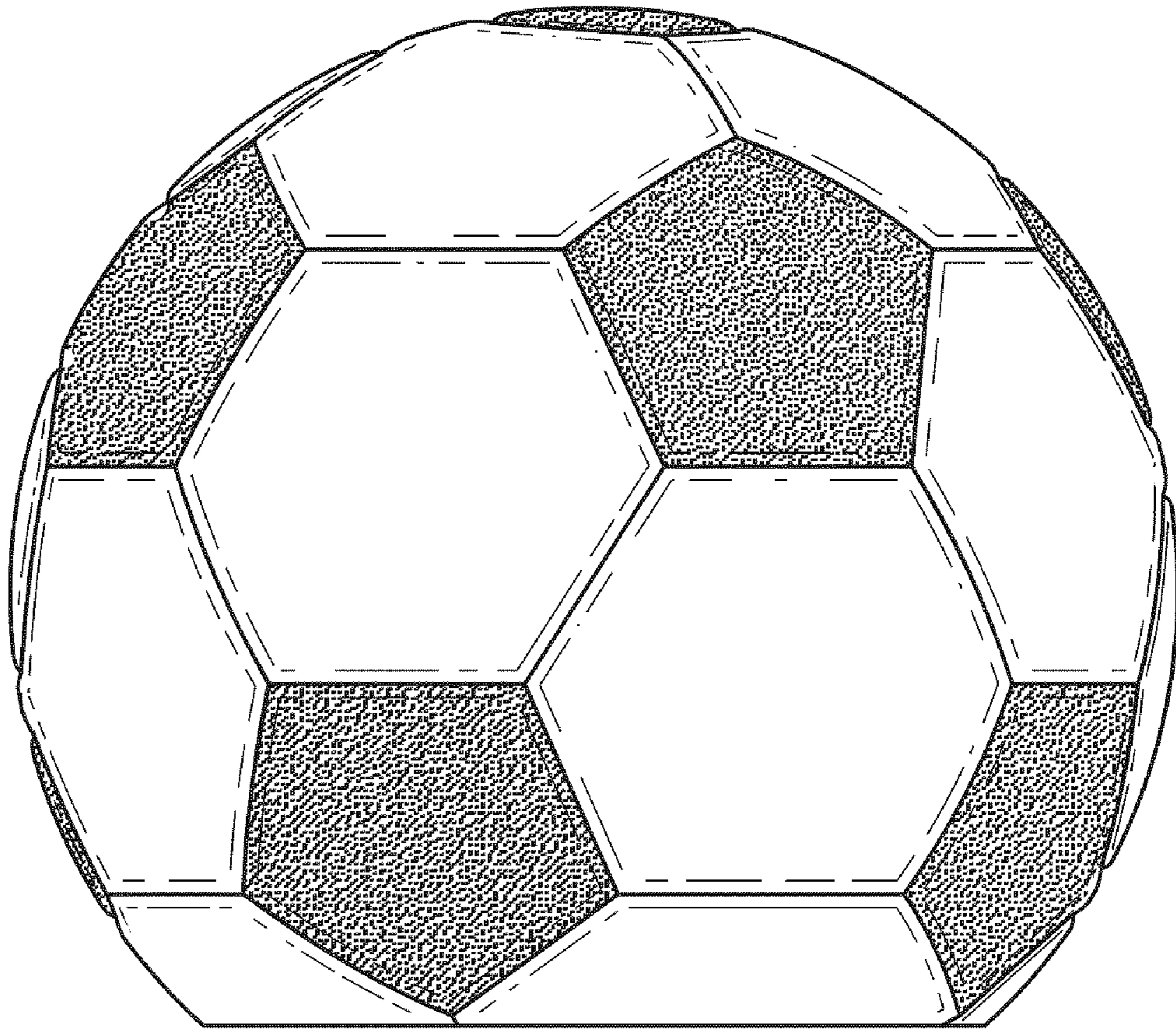

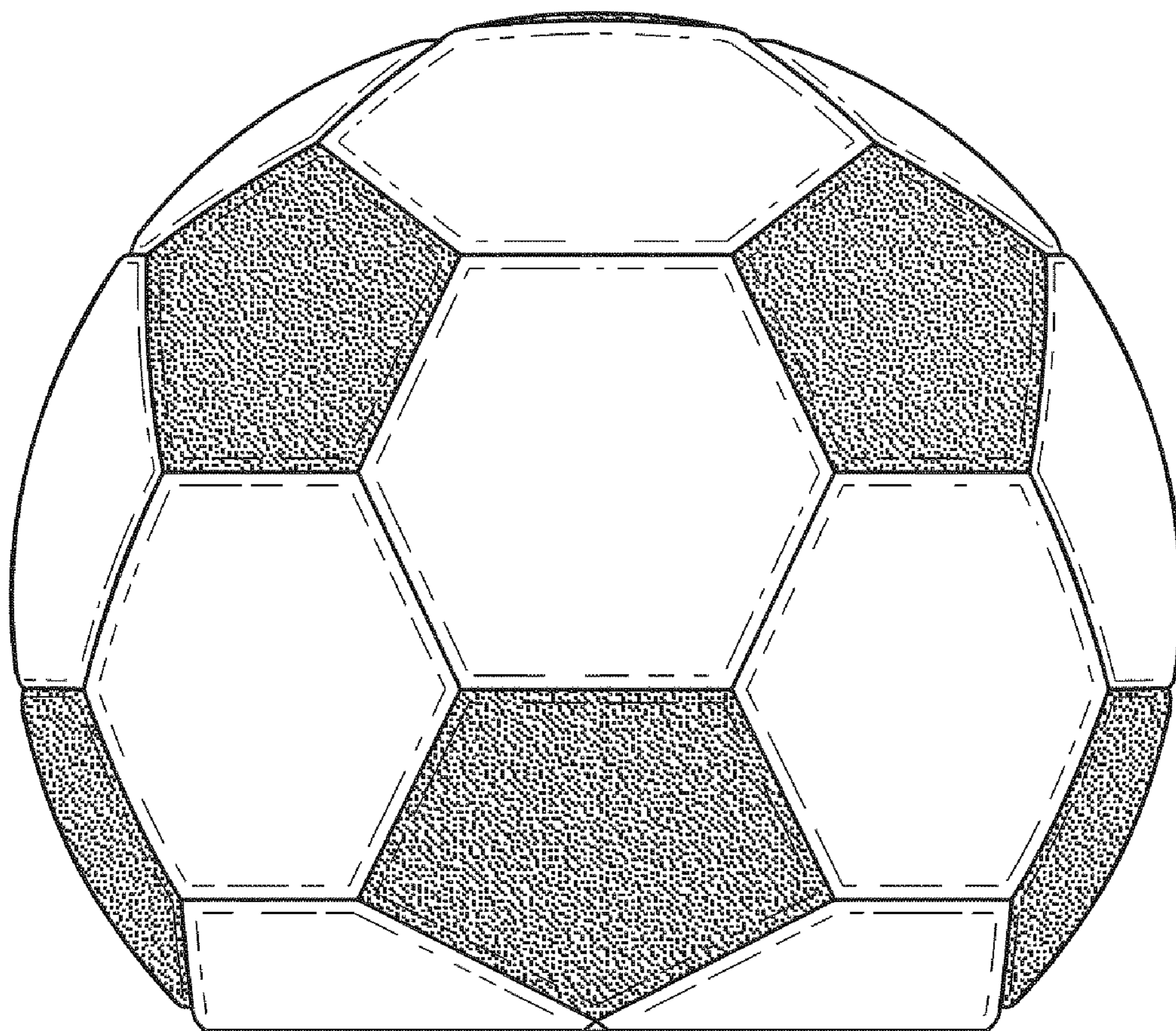

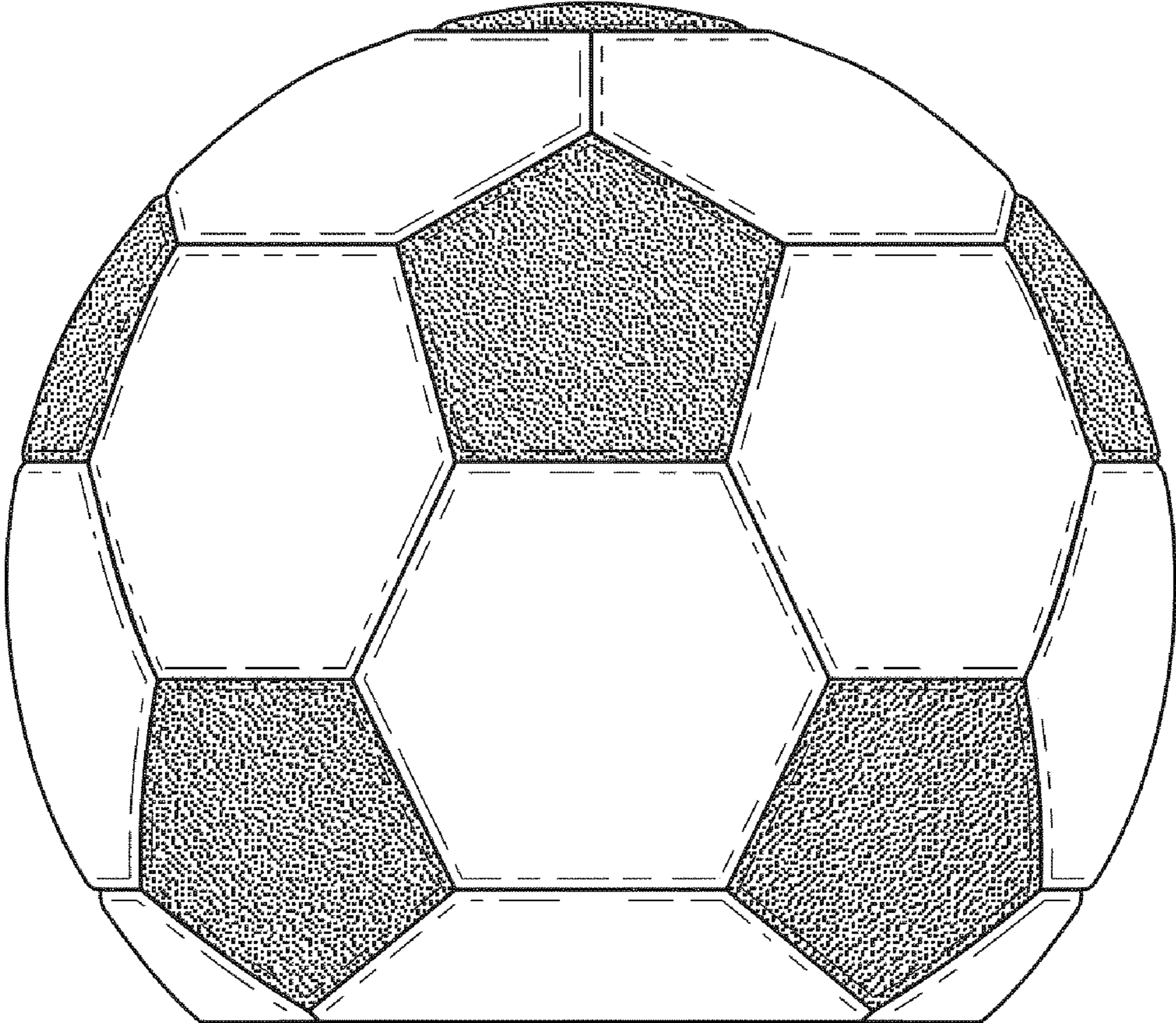
