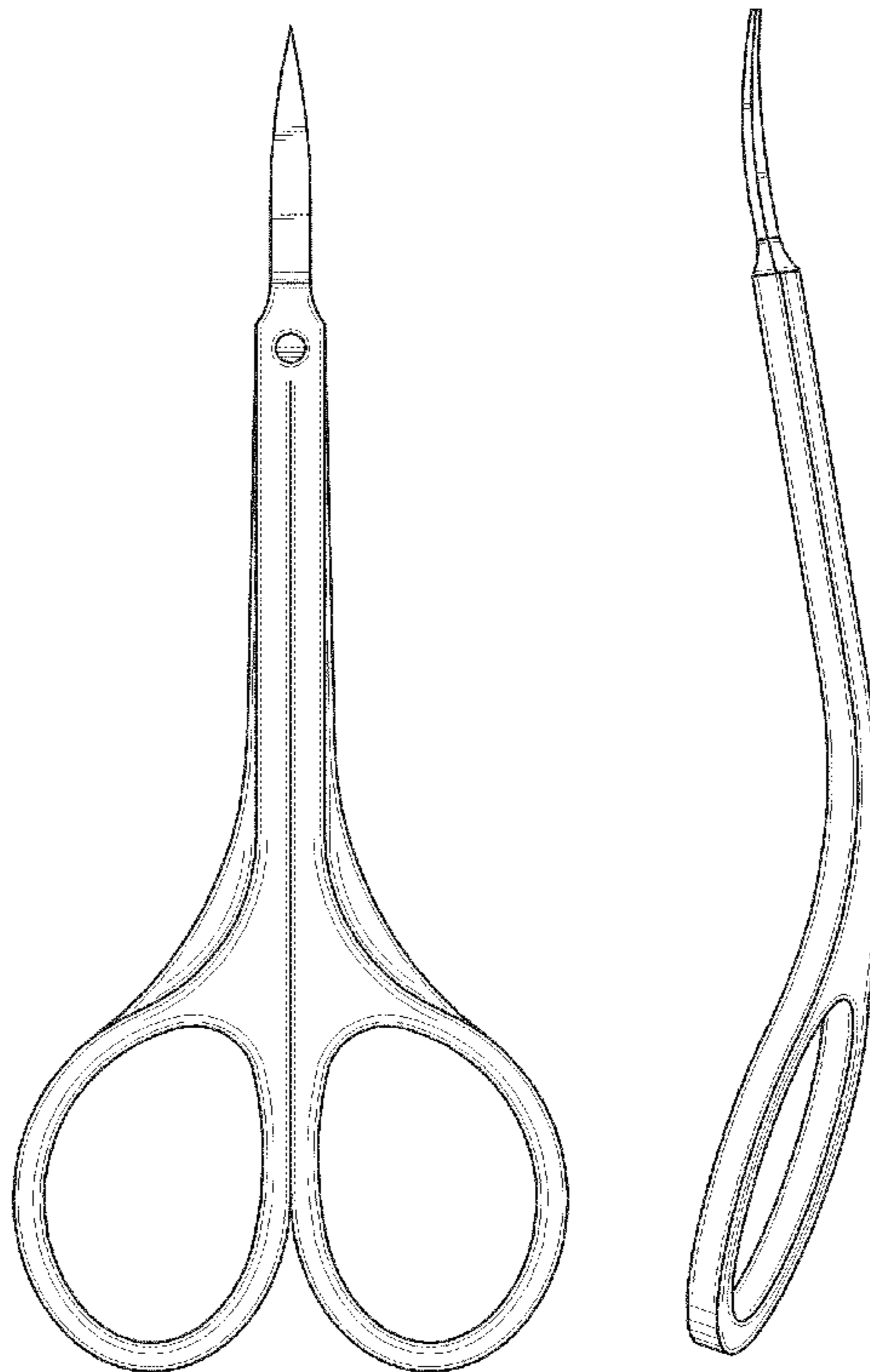
(57) **CLAIM**

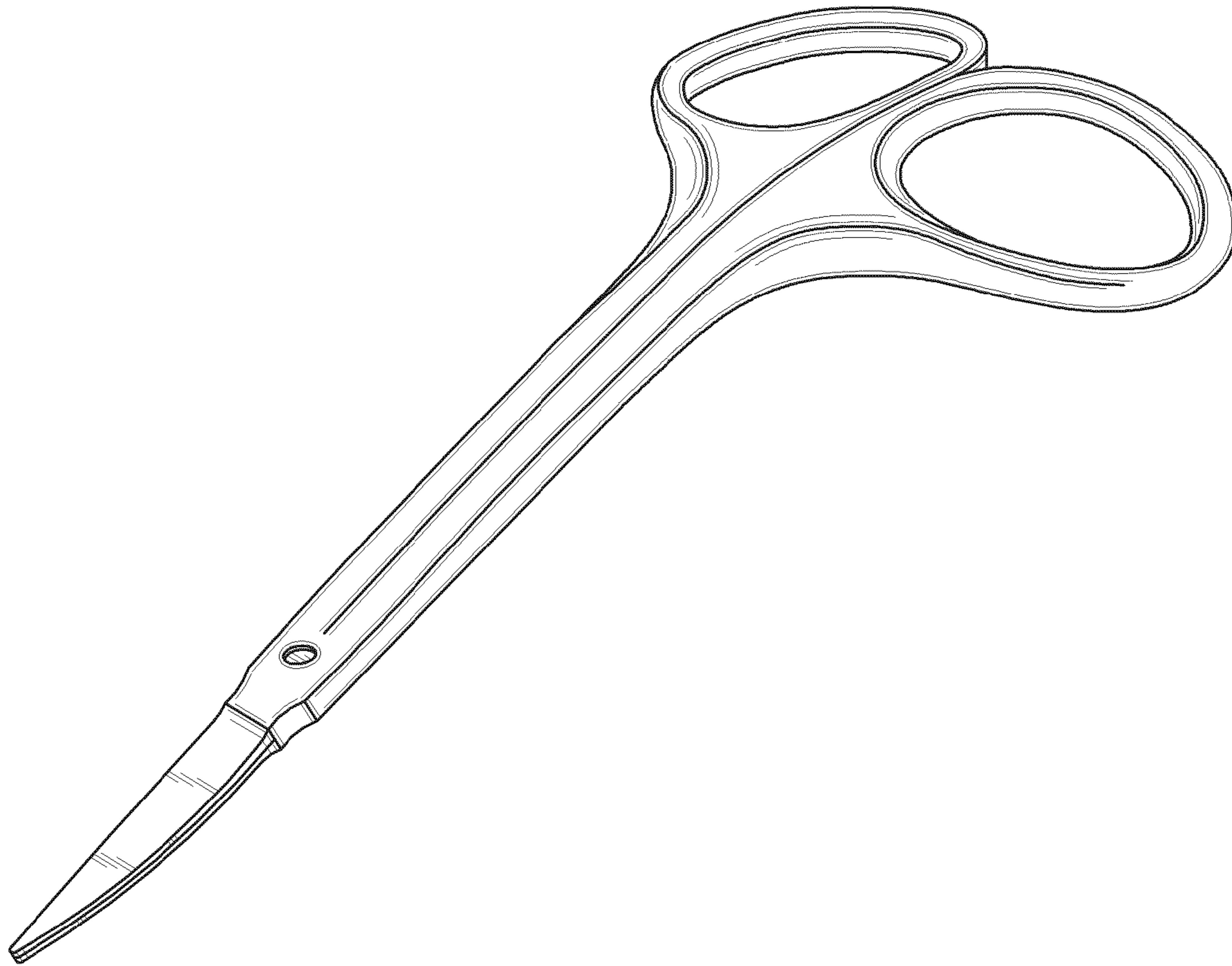
We claim the ornamental design for the cuticle scissors, as shown and described.

**DESCRIPTION**

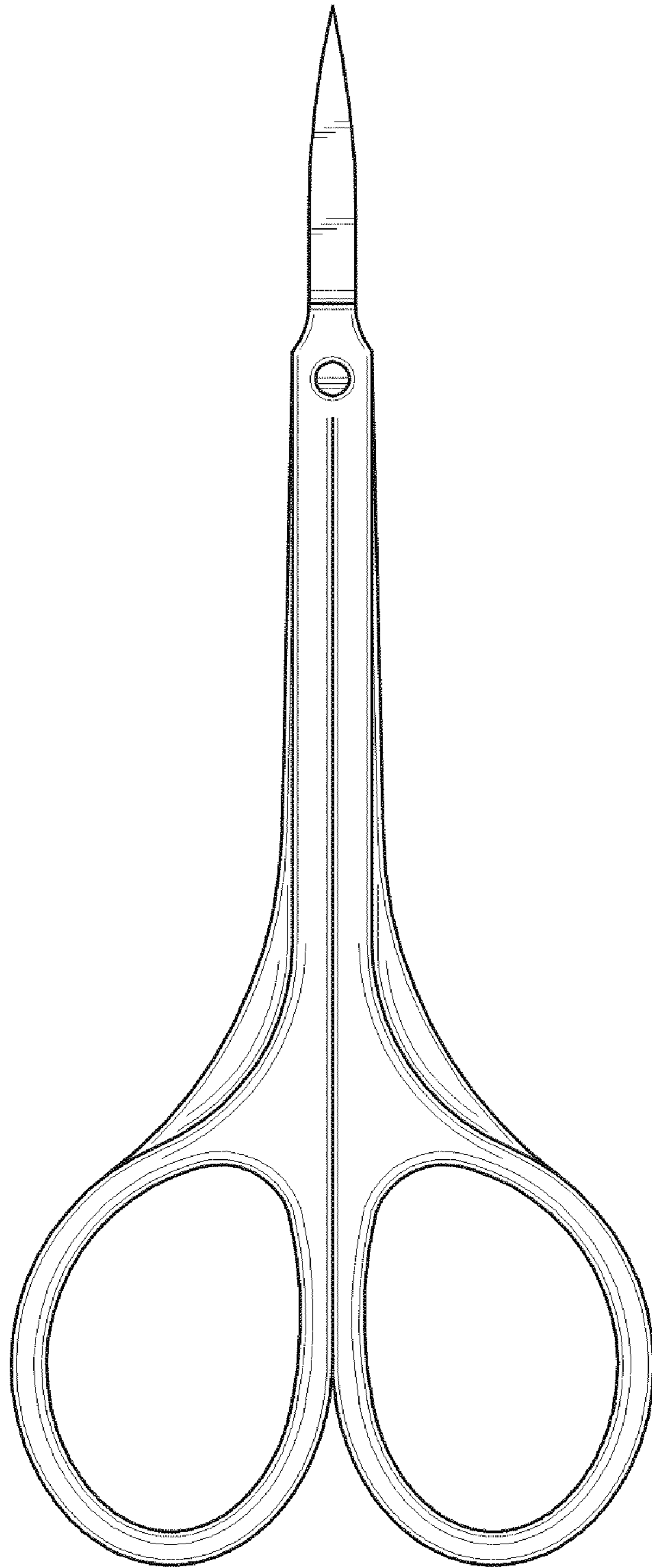
FIG. 1 is a perspective view of a cuticle scissors, incorporating our new design;

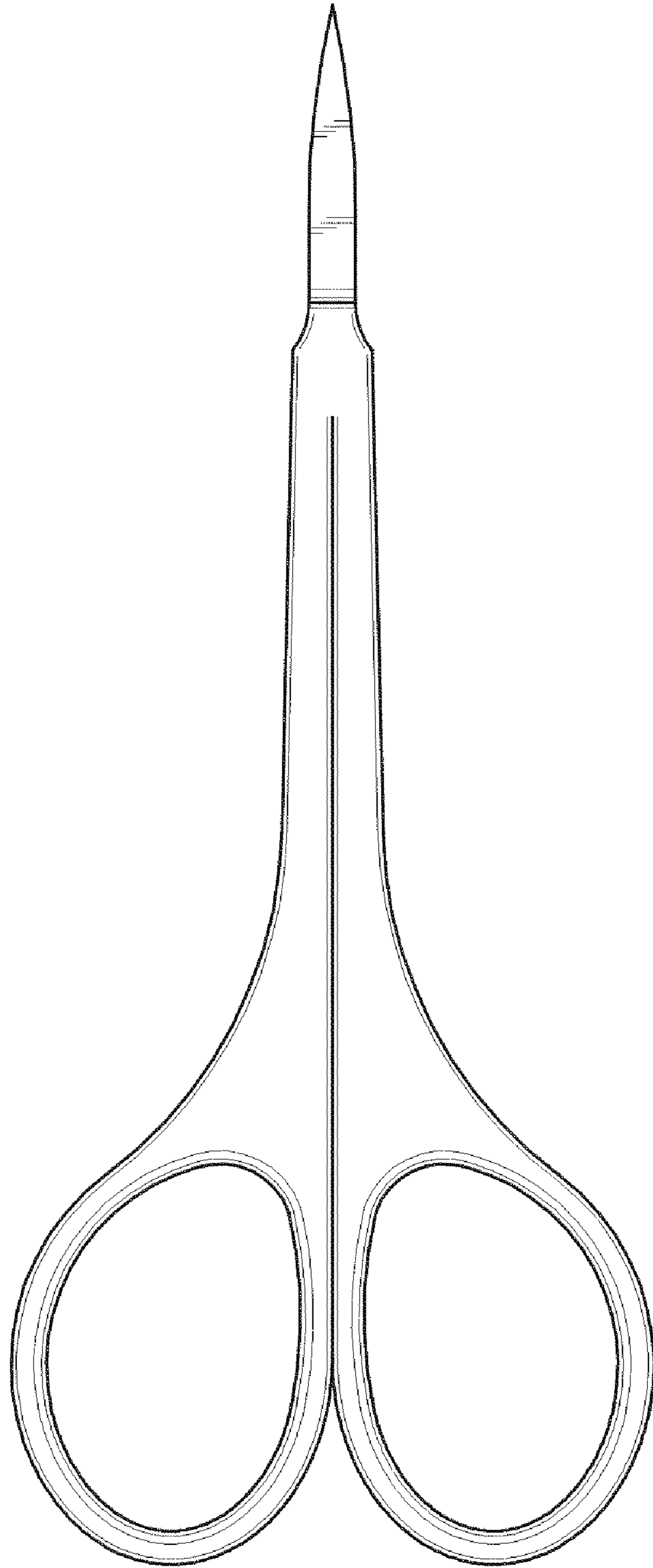




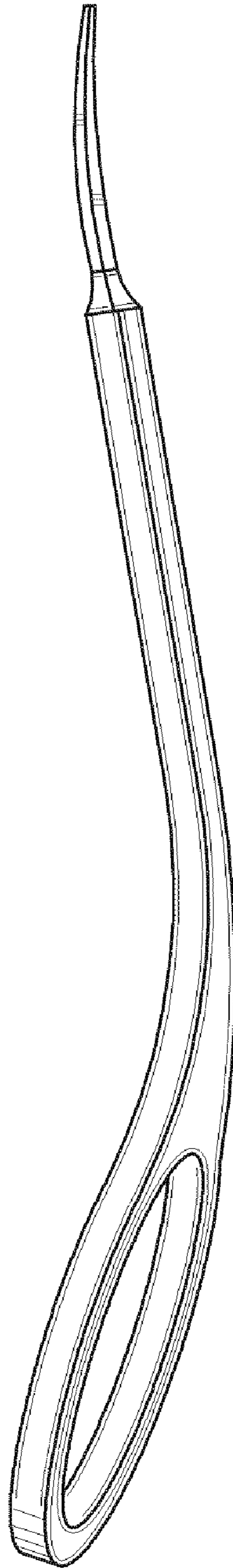

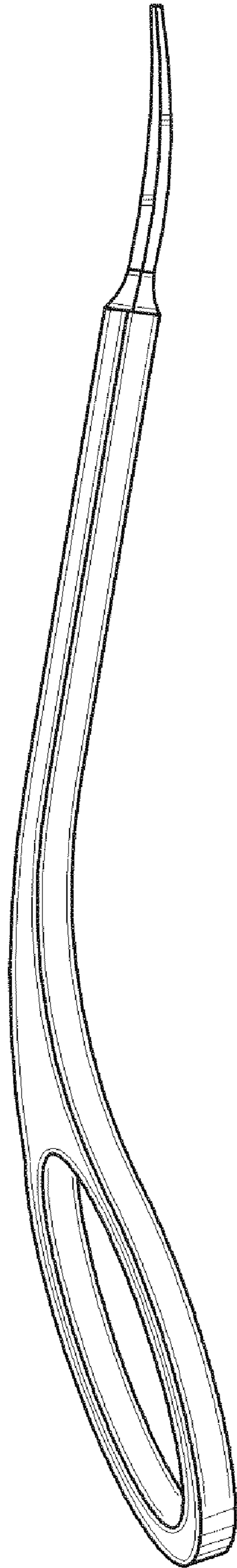
