(57) **CLAIM**

The ornamental design for a telescoping support, as shown and described.

**DESCRIPTION**

FIG. 1 is a top-front-outside perspective view of a preferred embodiment of a telescoping support, the telescoping support shown in a contracted configuration.

FIG. 2 is a bottom-front-outside perspective view of the telescoping support in FIG. 1, the telescoping support shown in a partially extended configuration.

FIG. 3 is a top-rear-inside perspective view of the telescoping support in FIG. 1, the telescoping support shown in a contracted configuration.

FIG. 4 is a bottom-rear-inside perspective view of the telescoping support in FIG. 1, the telescoping support shown in a partially extended configuration.

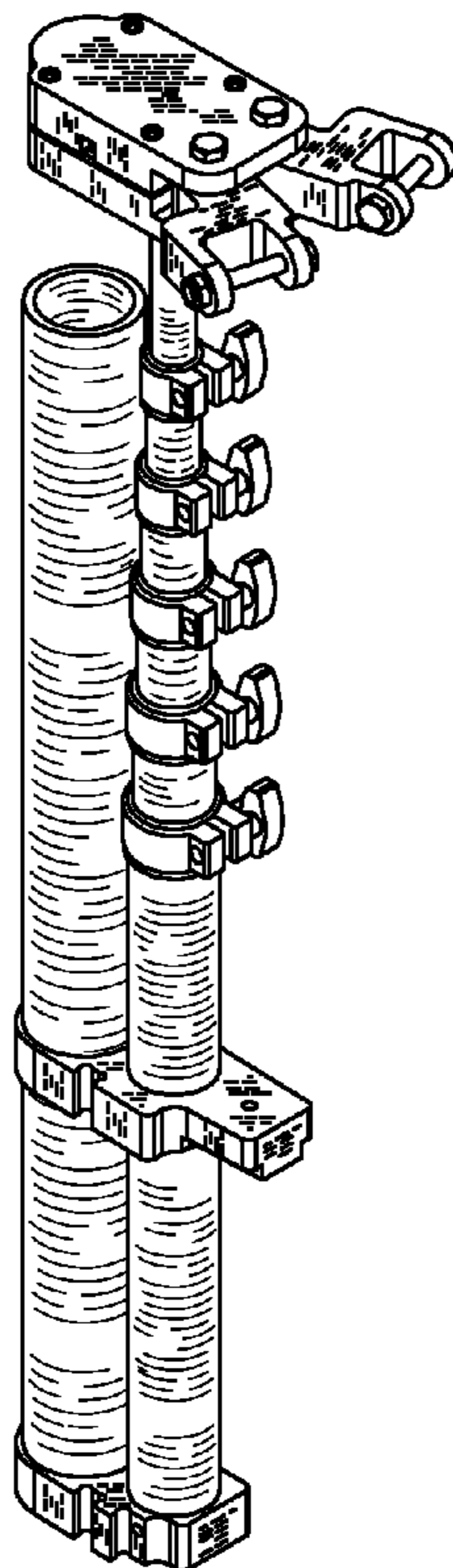

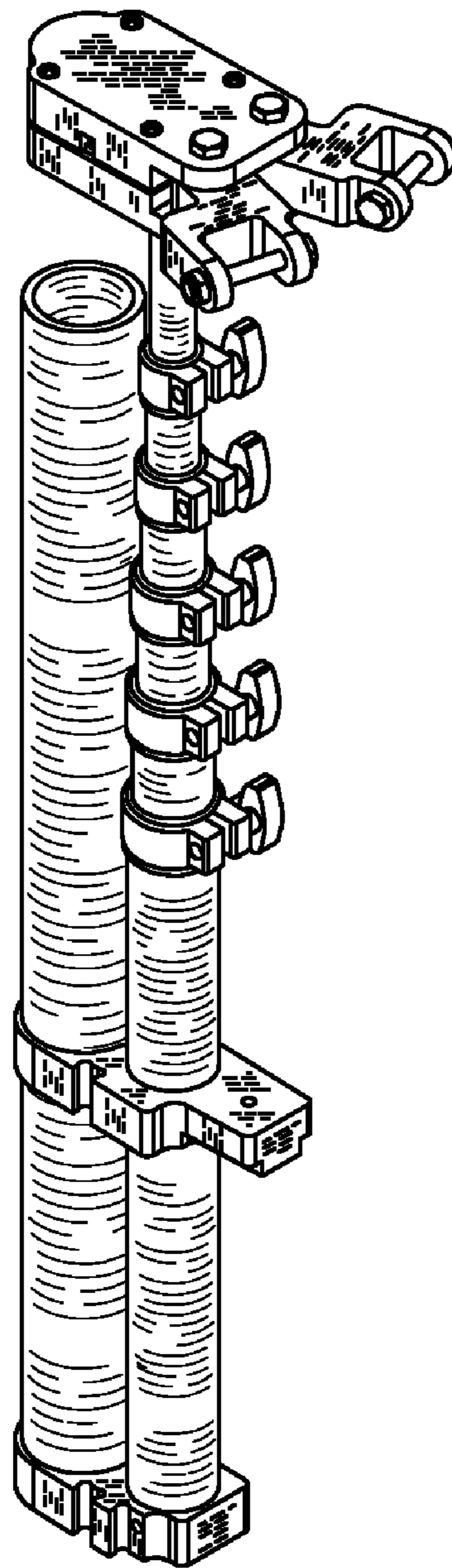

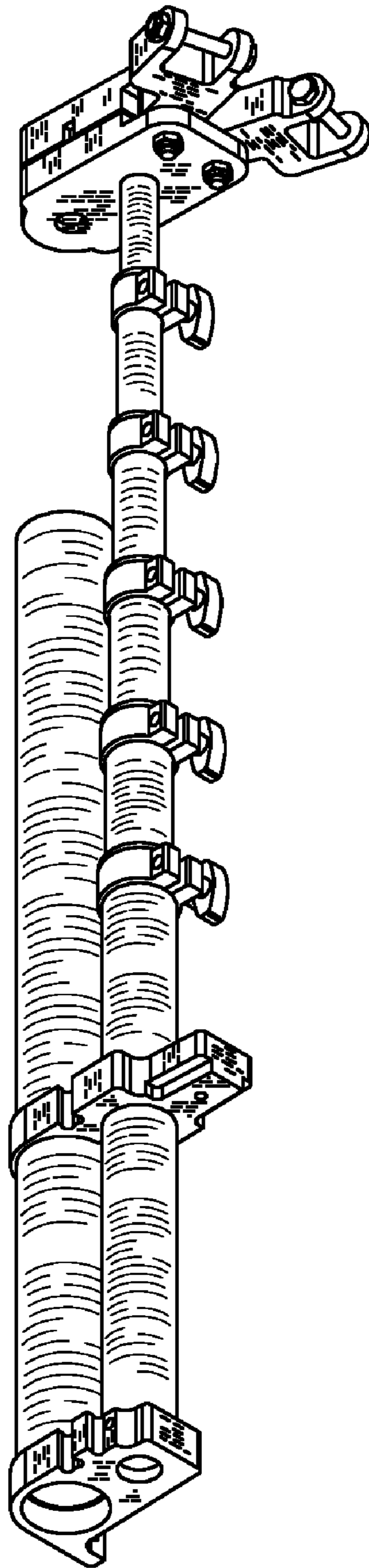

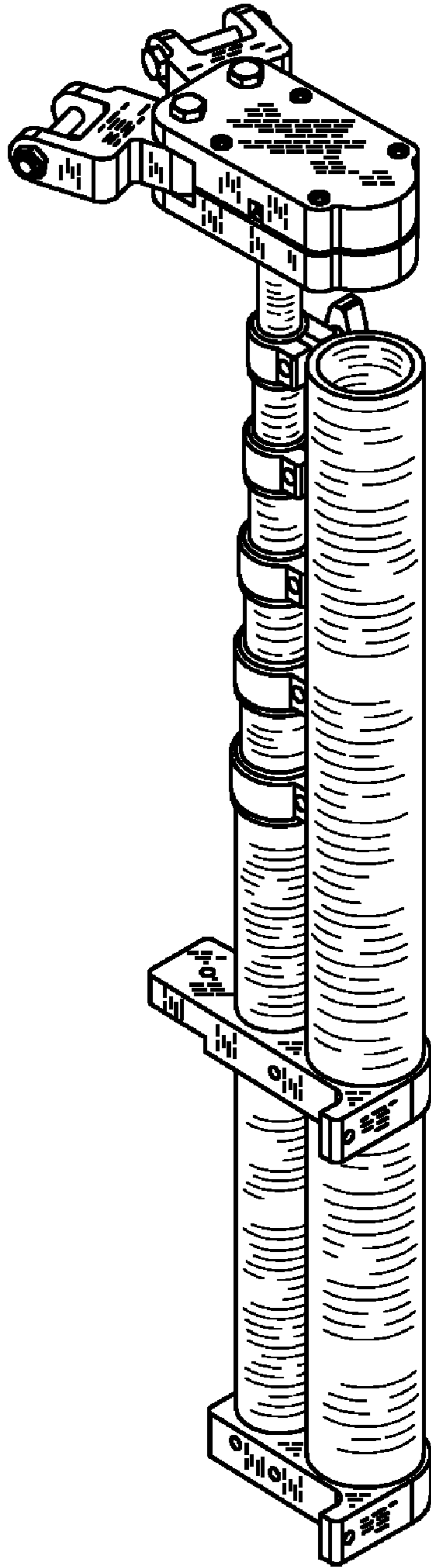

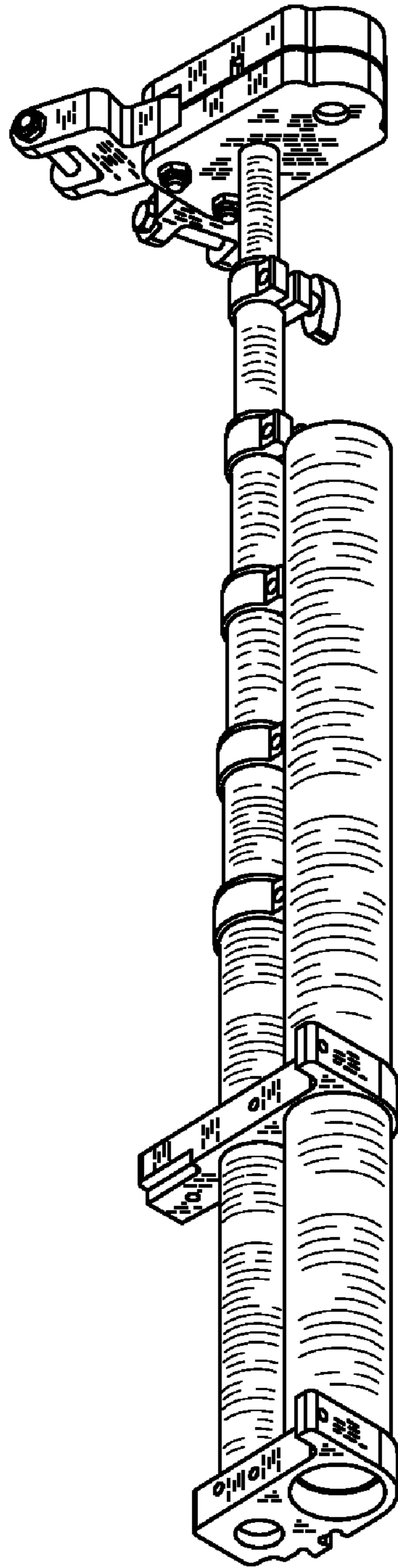

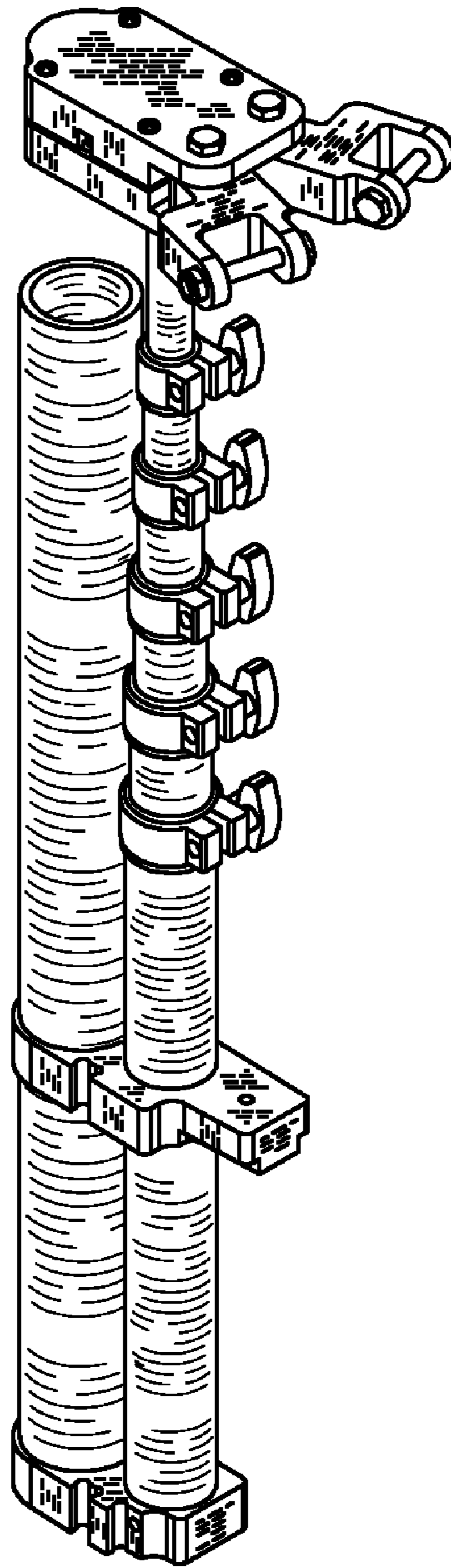

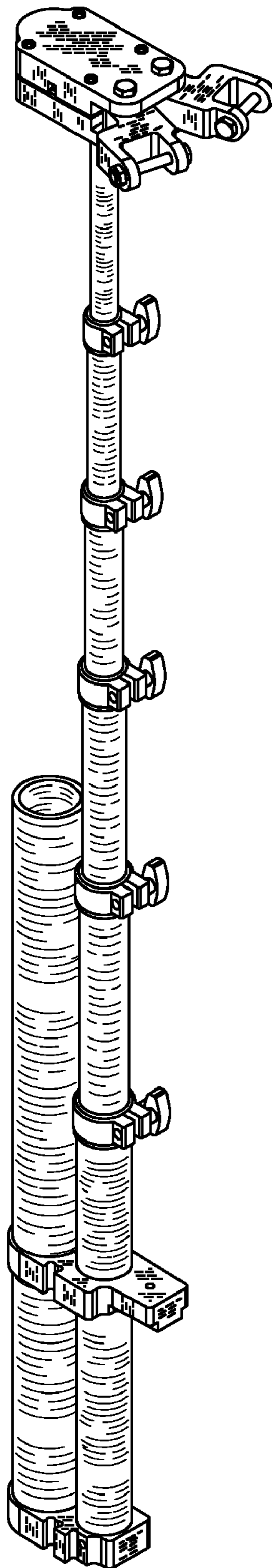

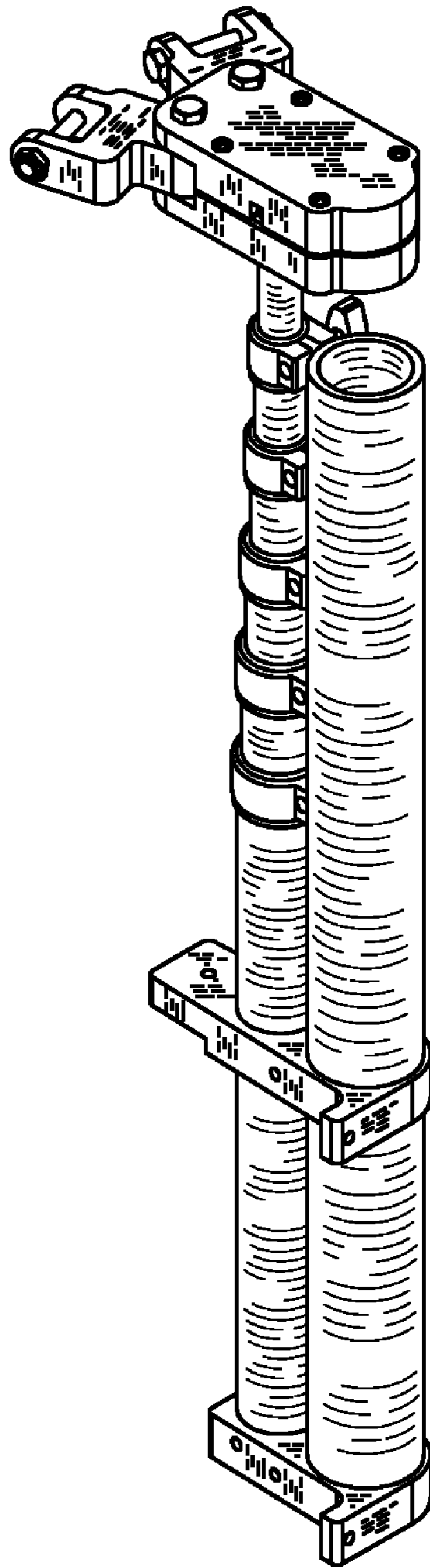

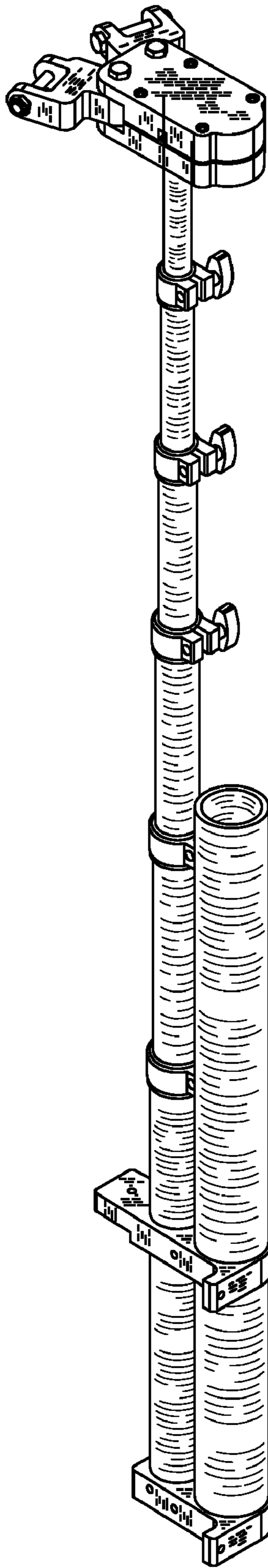
