FIG. 1 is a top perspective view of the can;

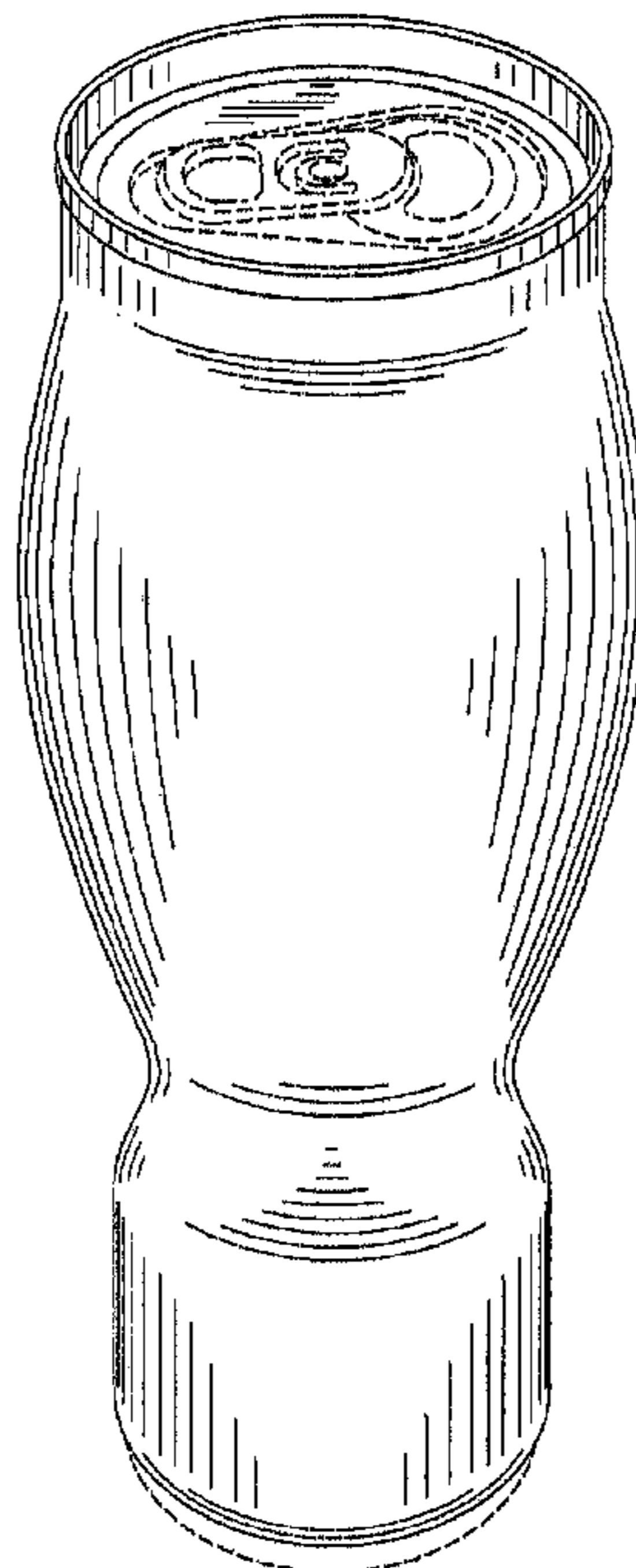
FIG. 2 is a side view thereof;

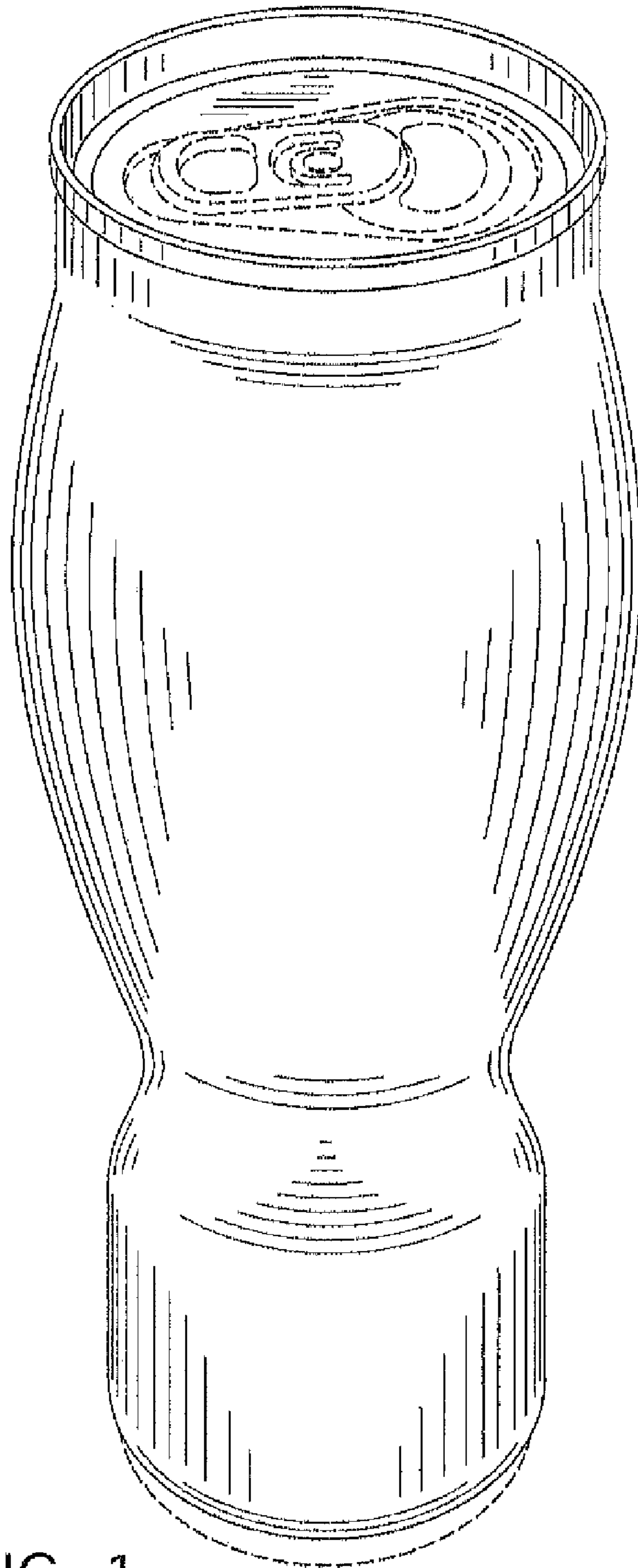

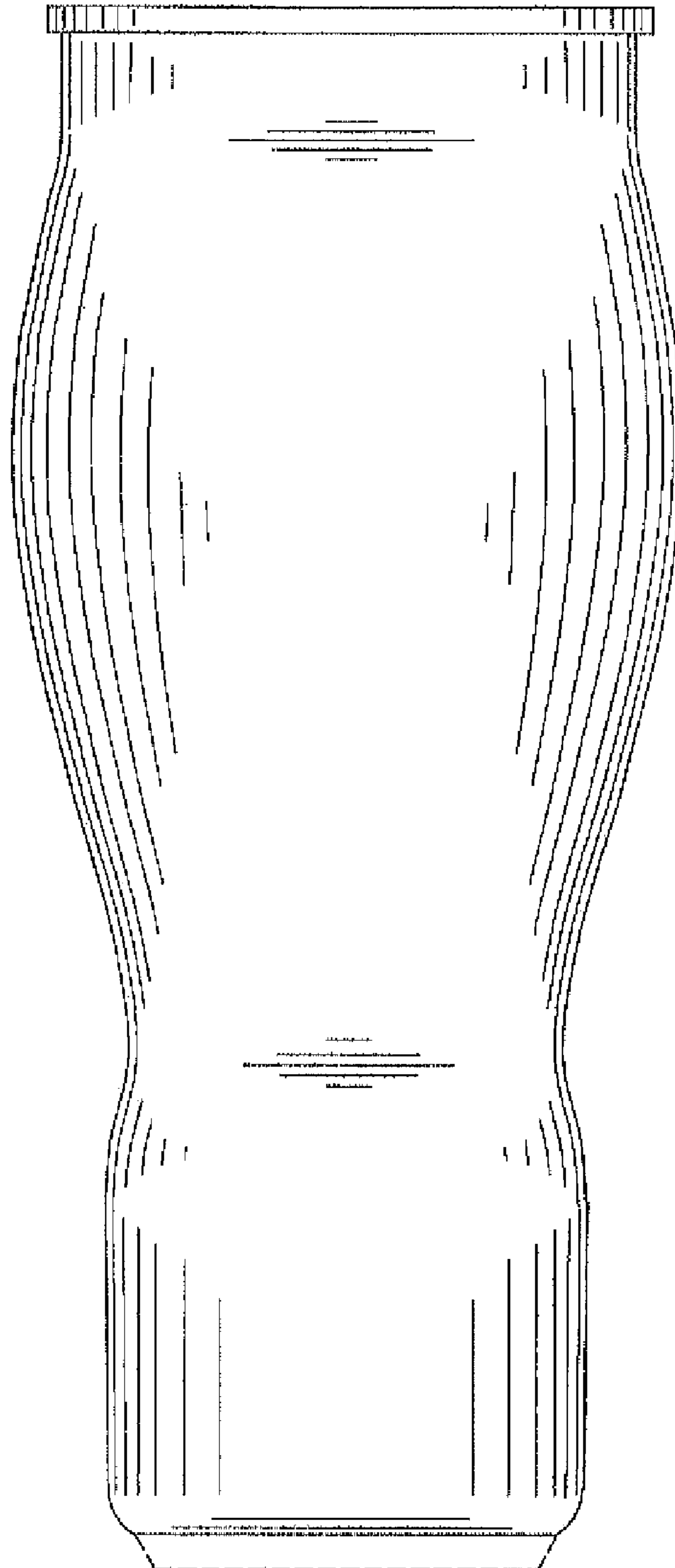

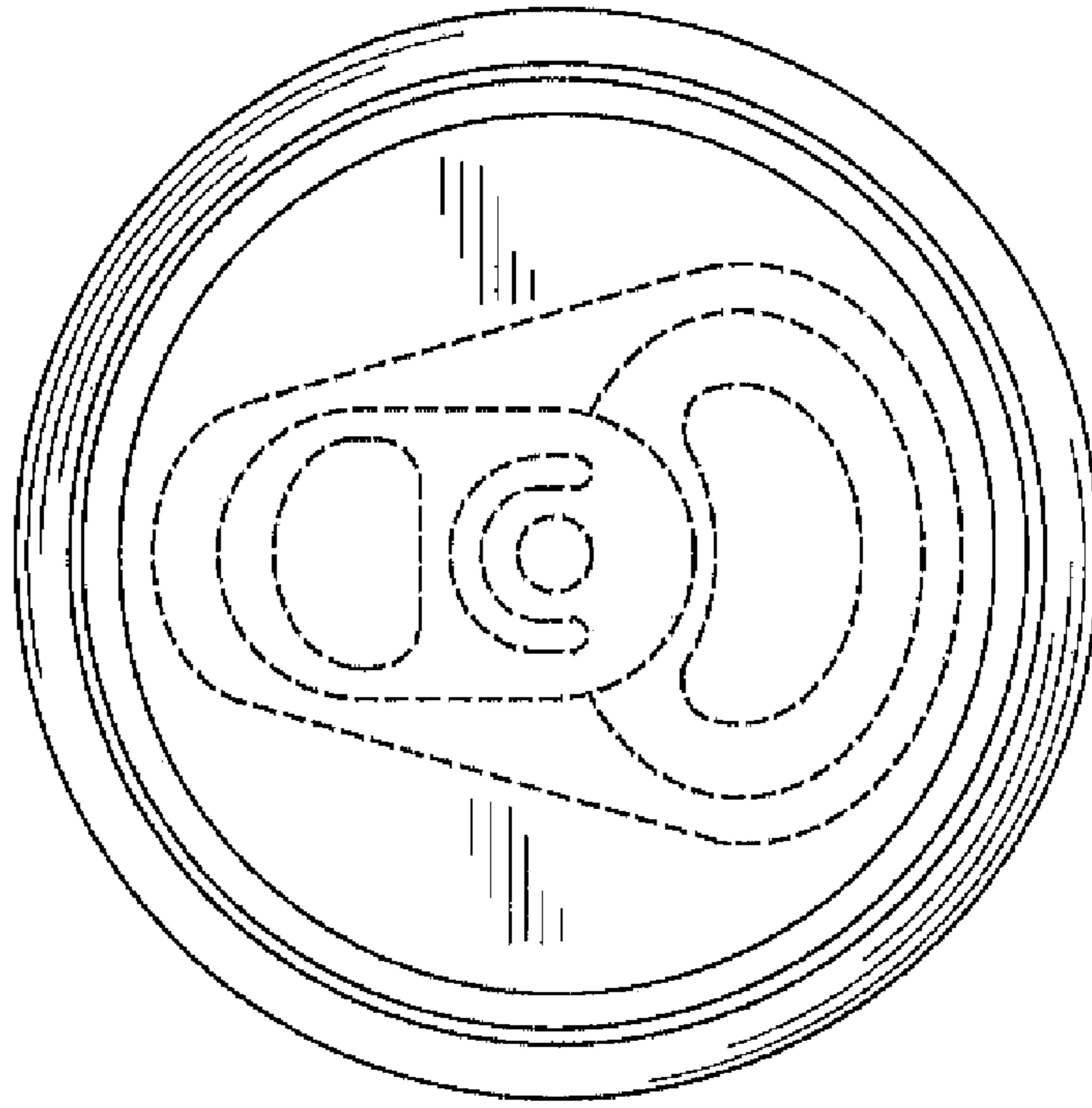

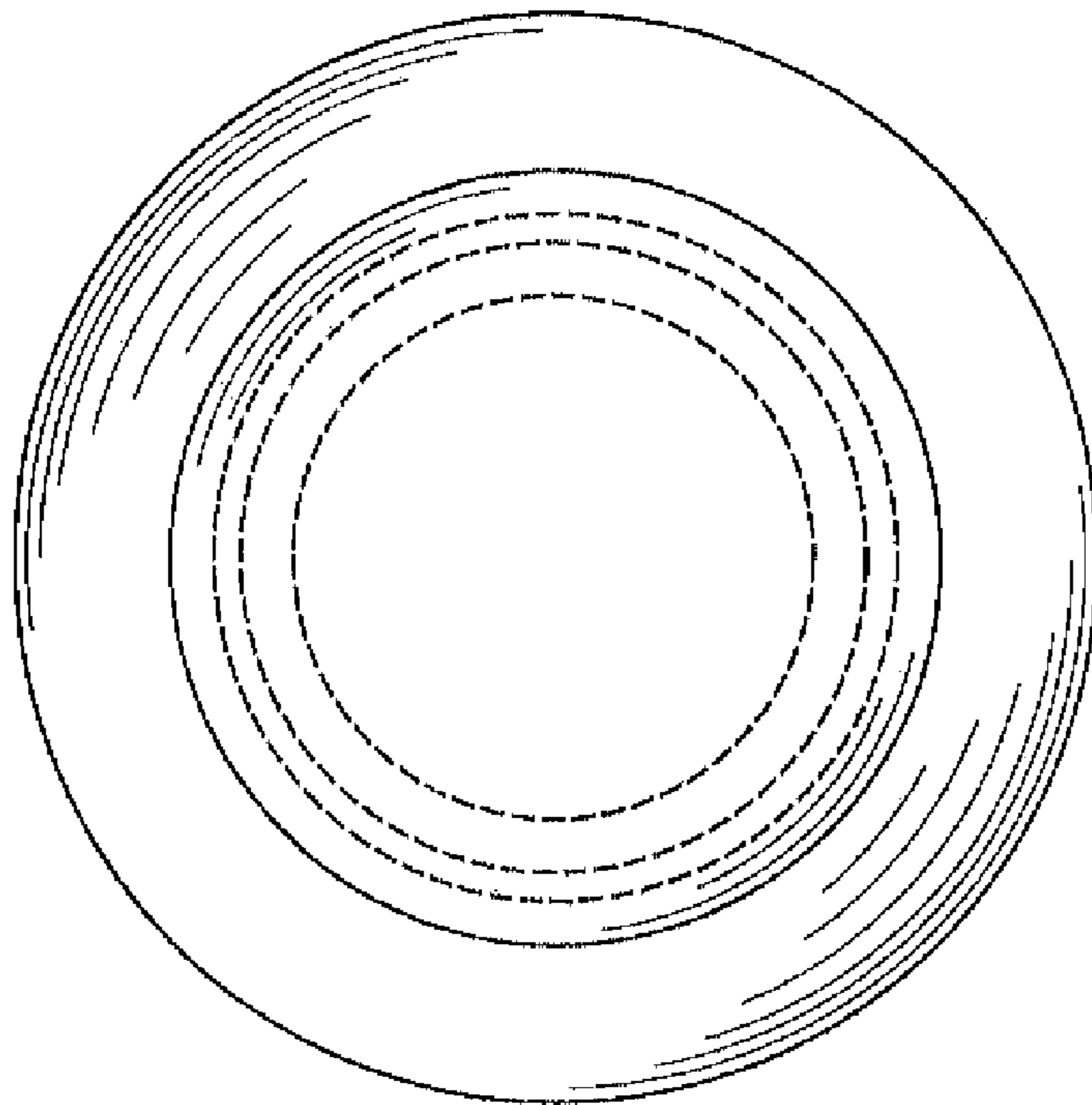
