**DESCRIPTION**

FIG. 11 is a top plan view of FIG. 8;

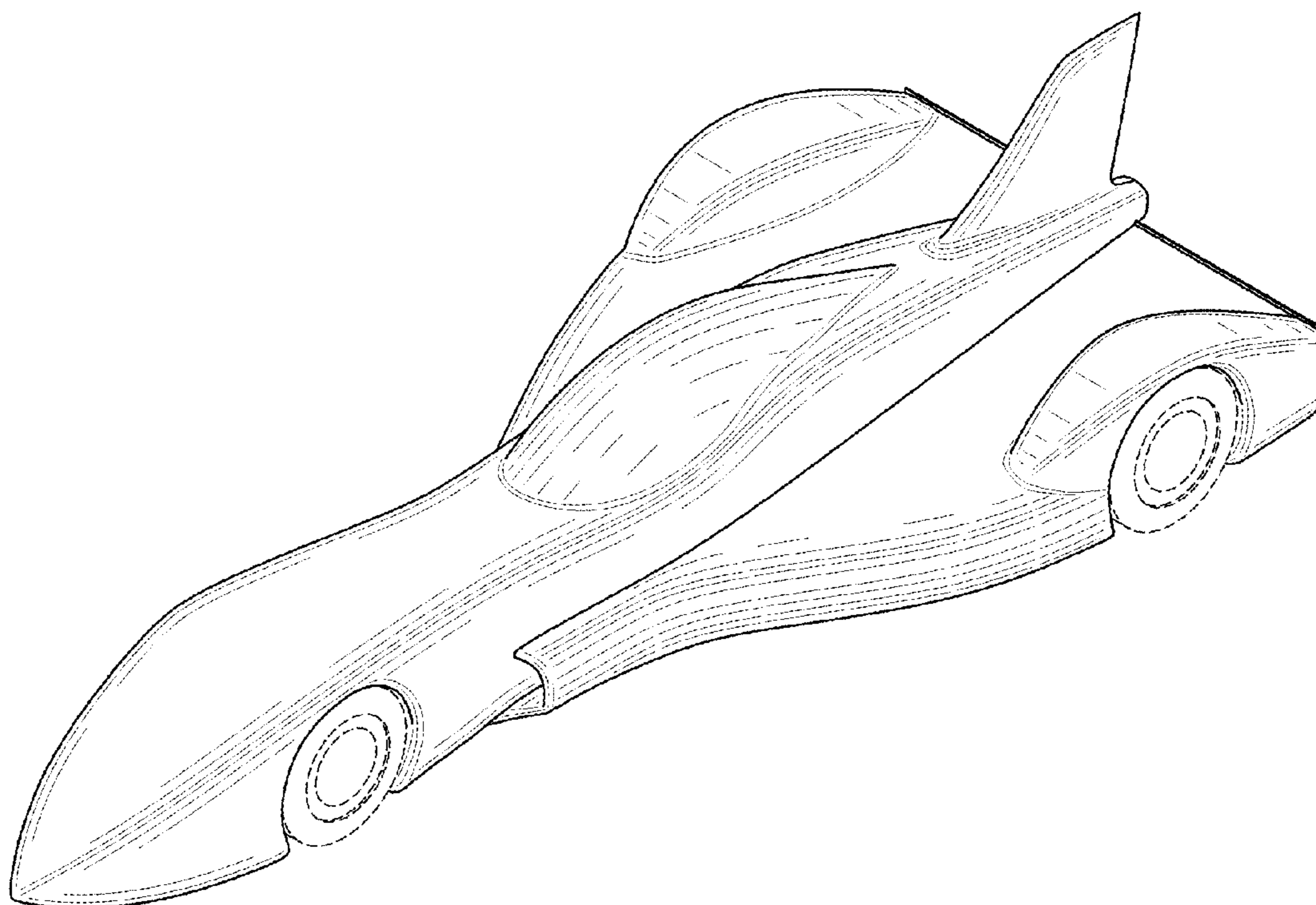
FIG. 12 is a bottom plan view of FIG. 8;

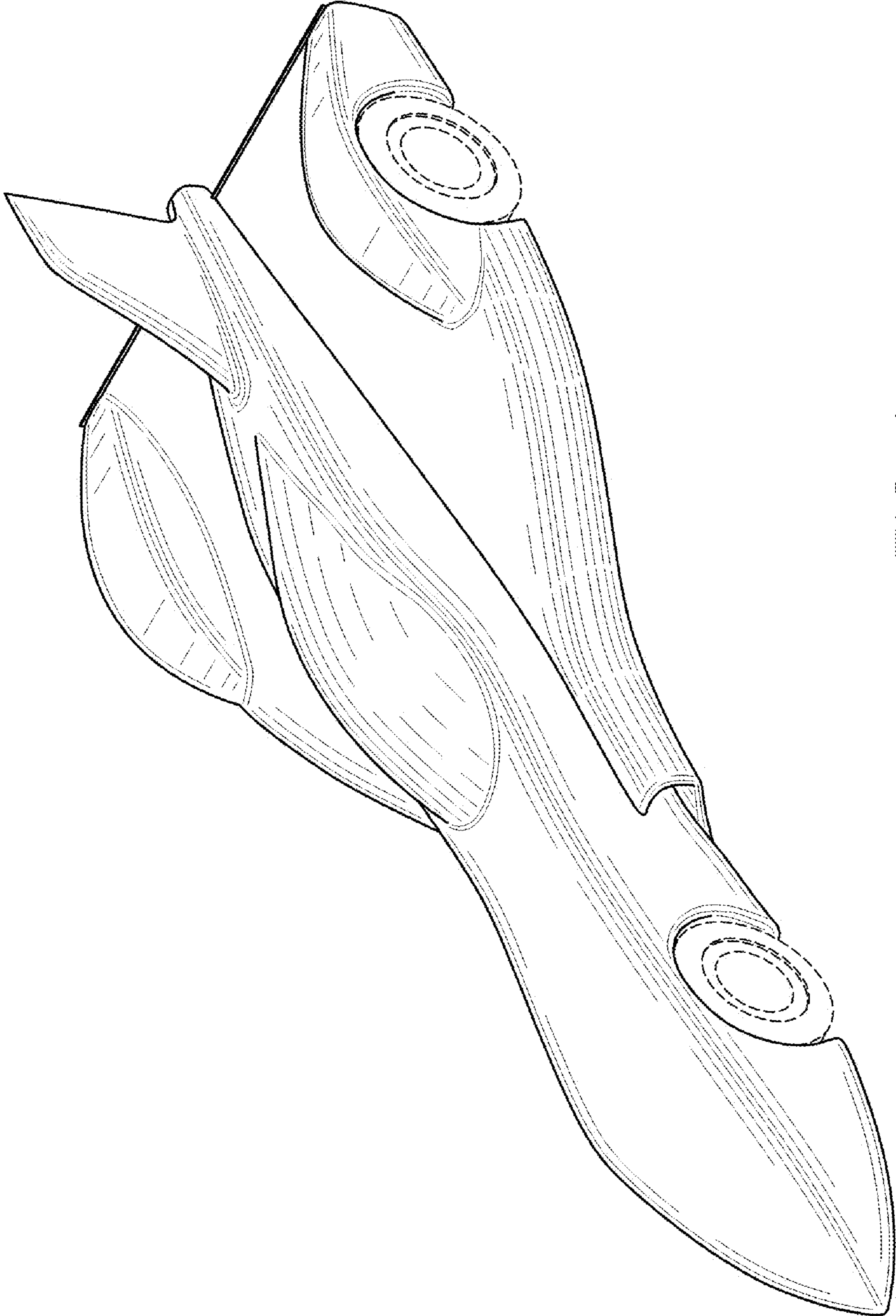

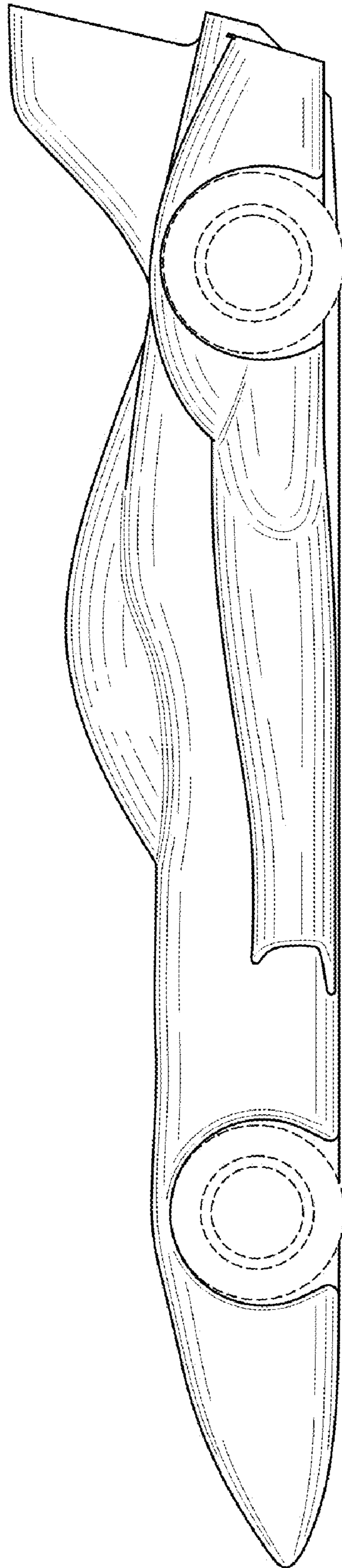

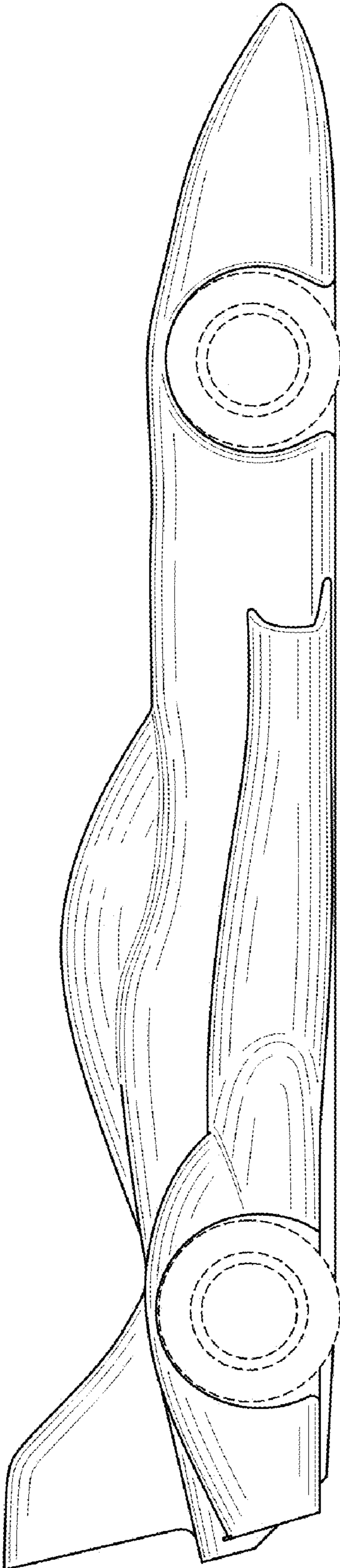

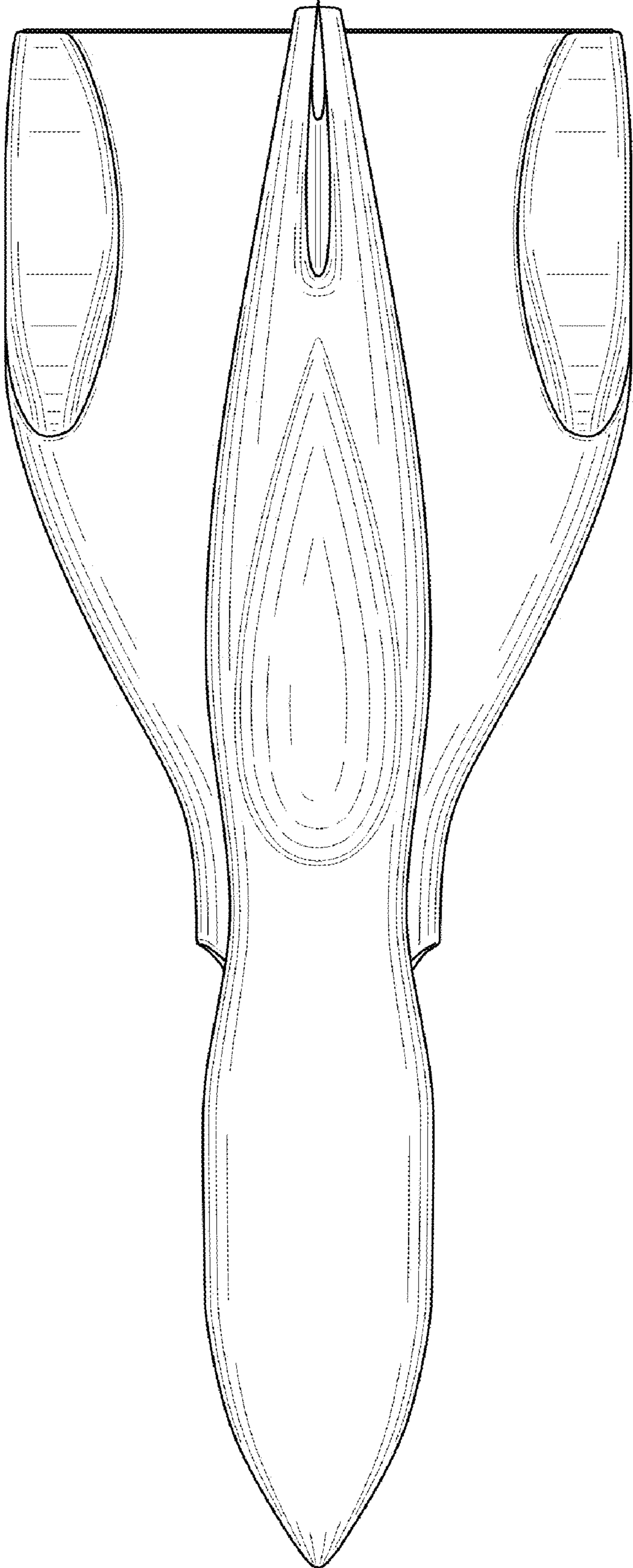

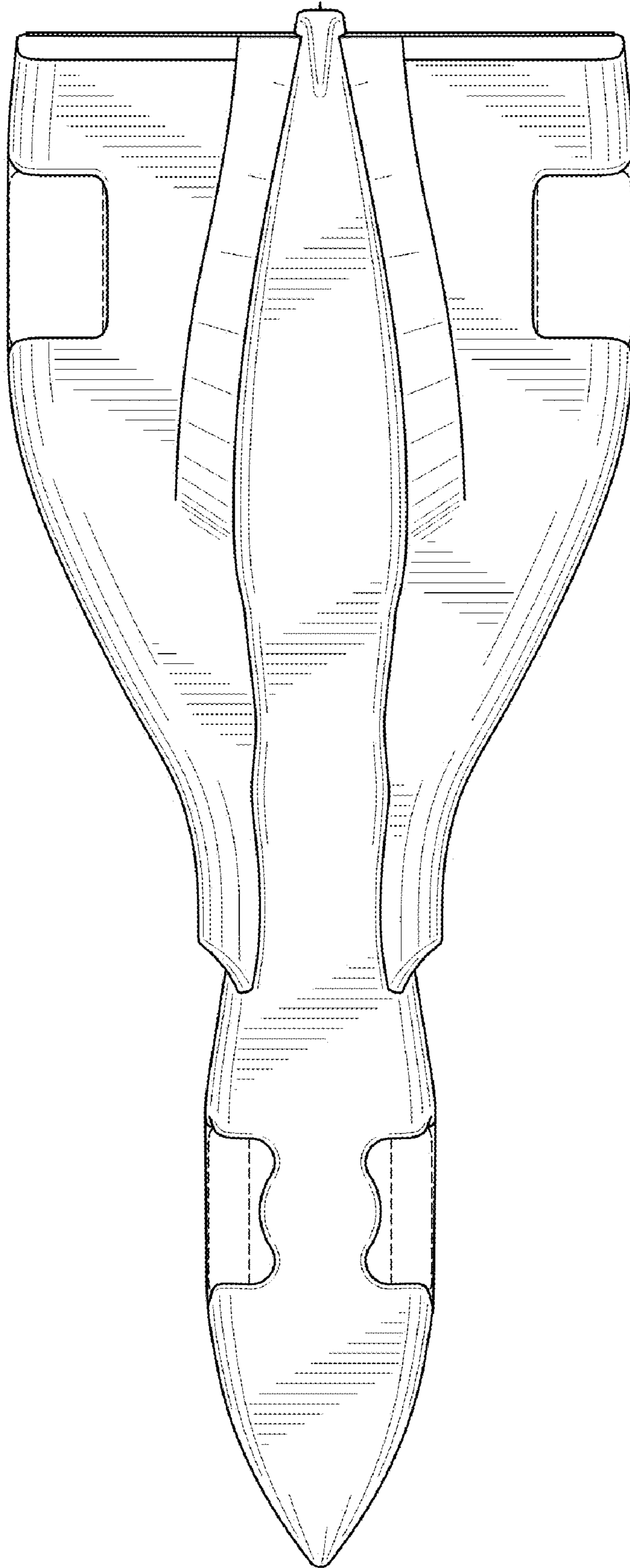

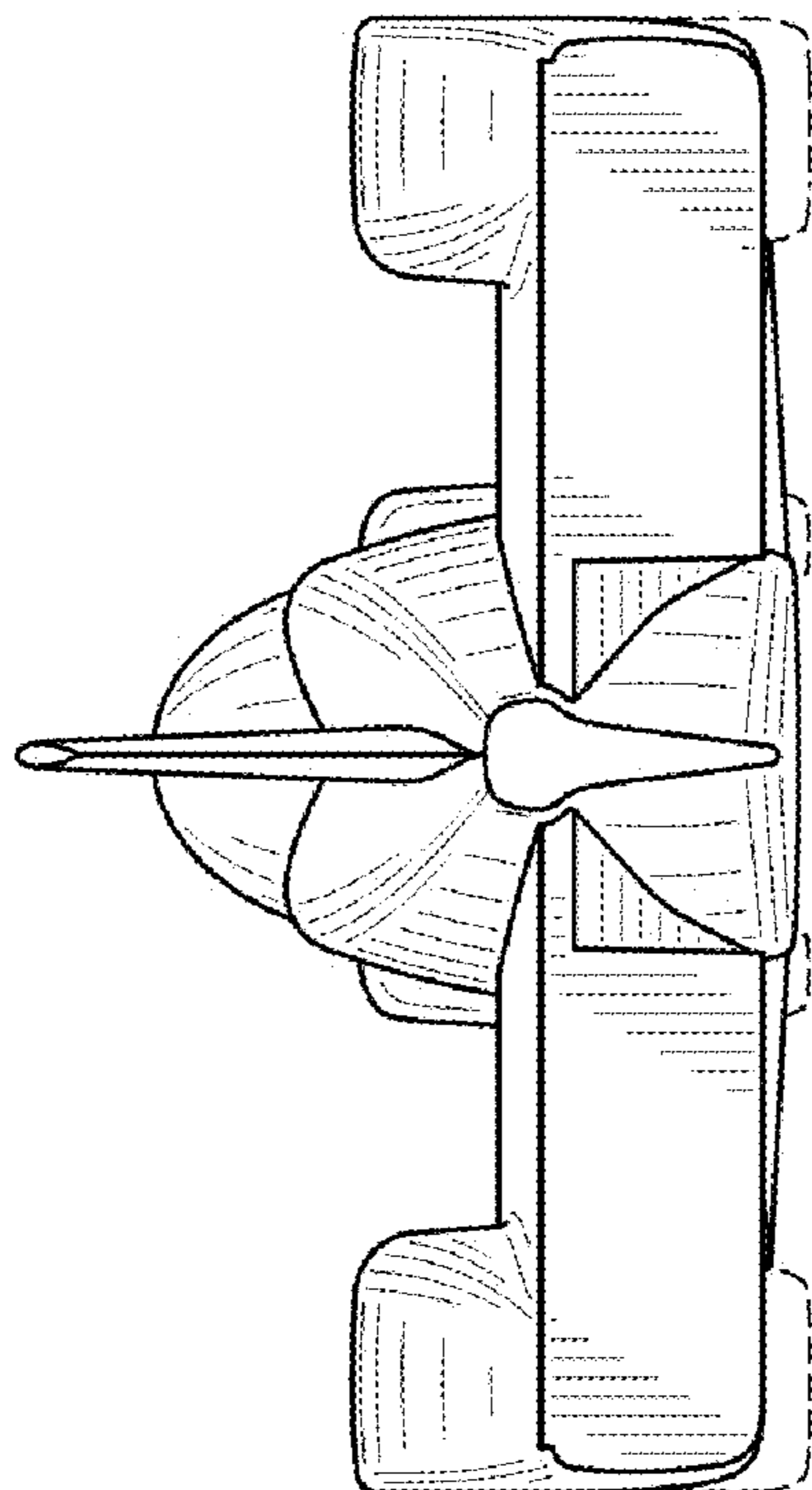

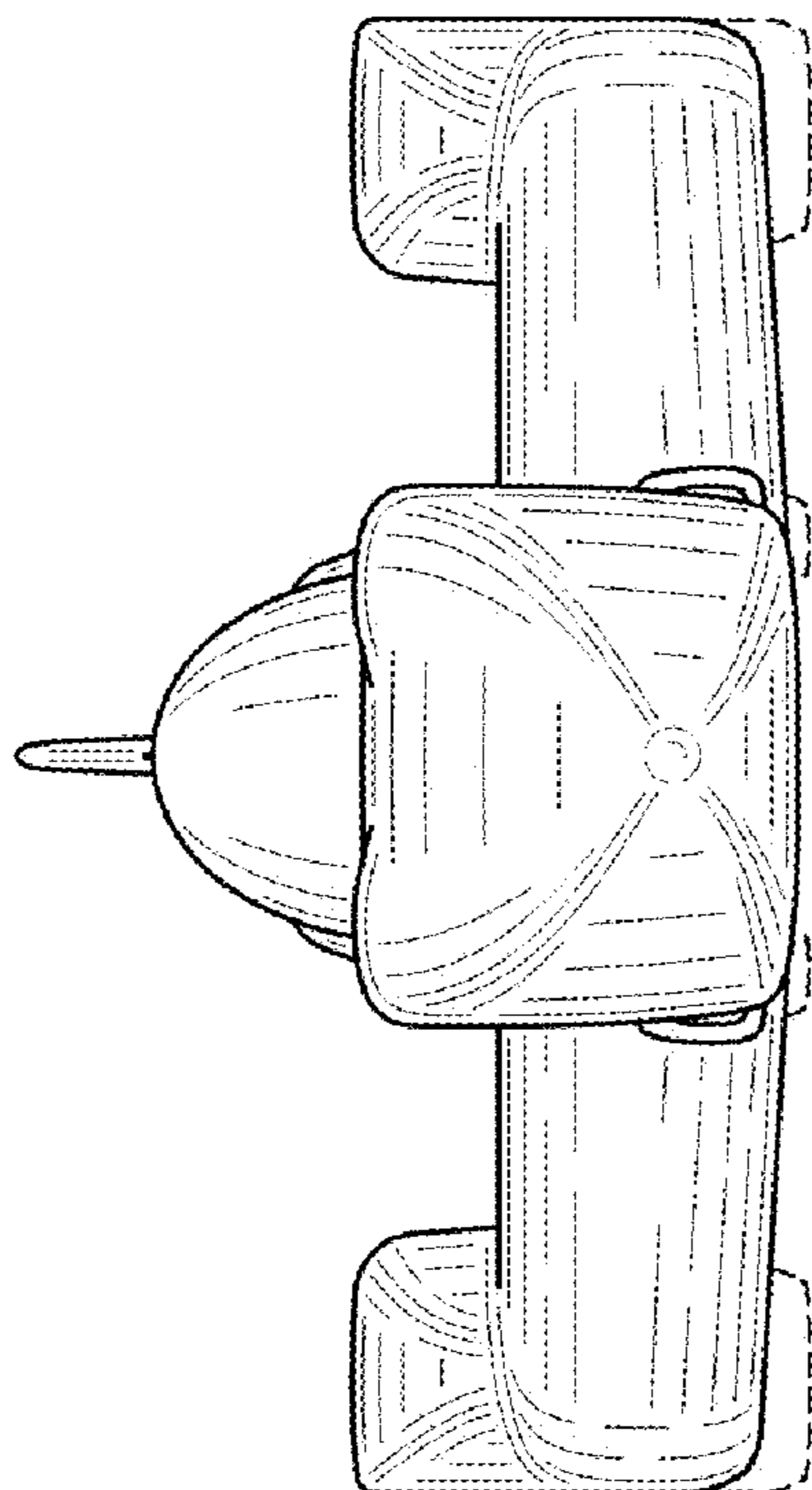

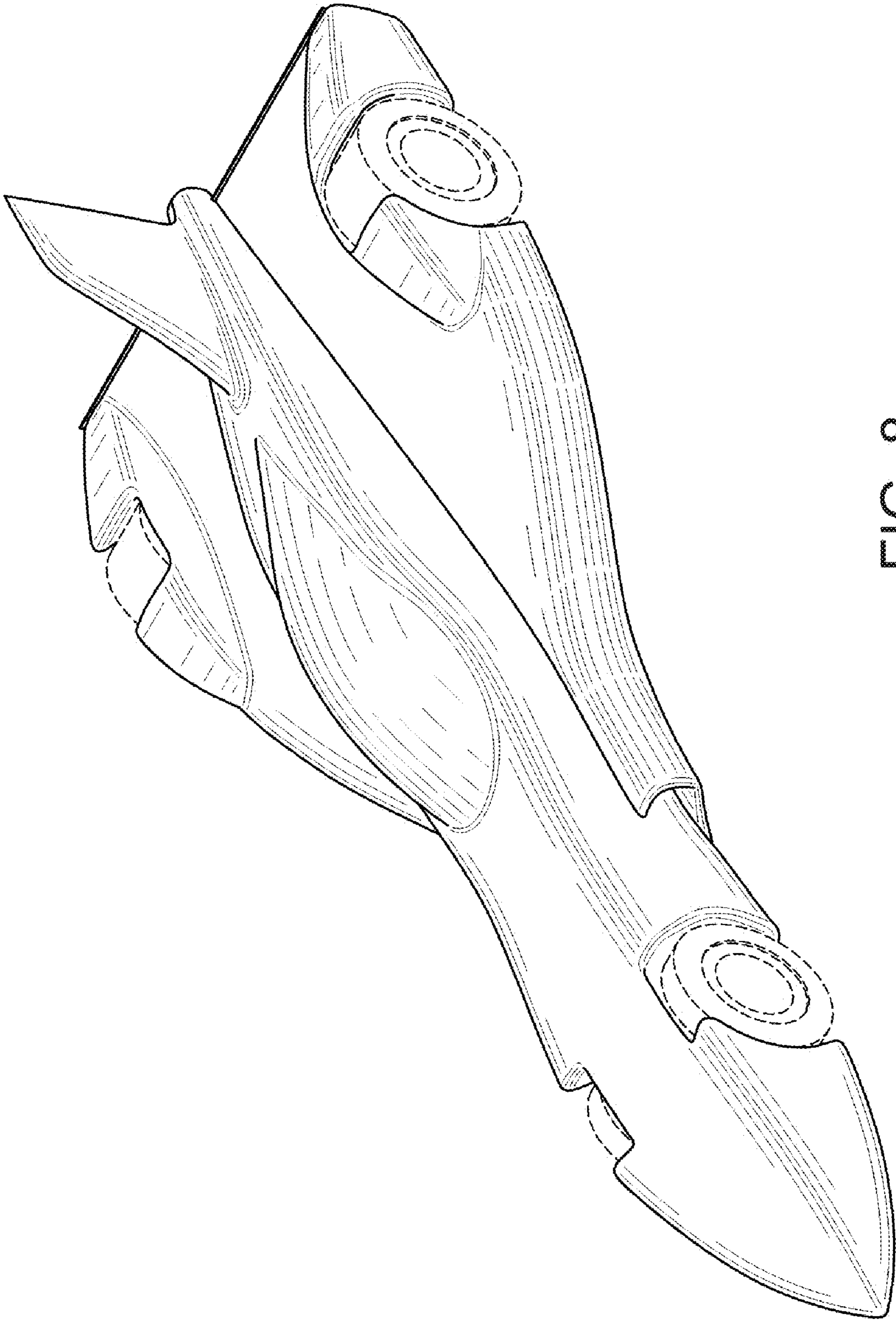

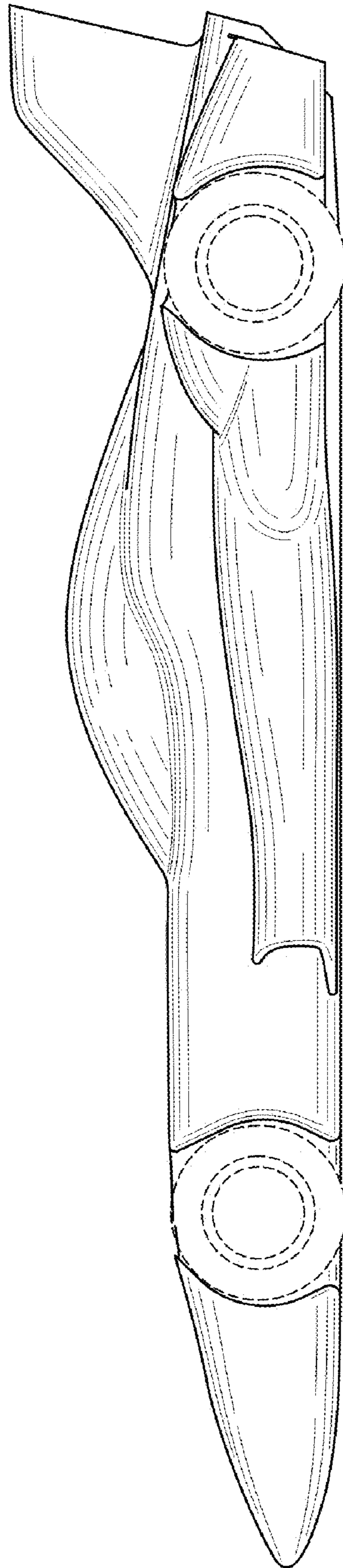

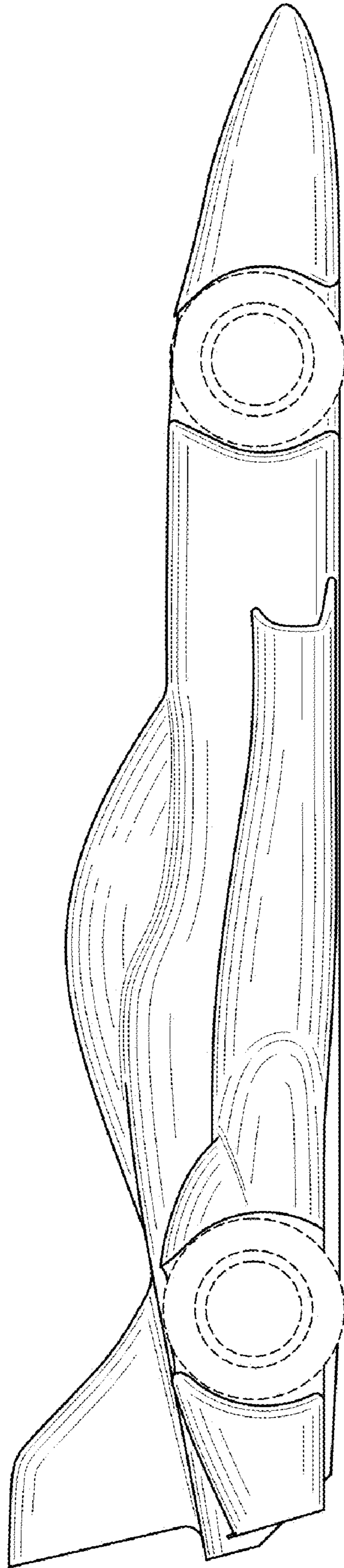

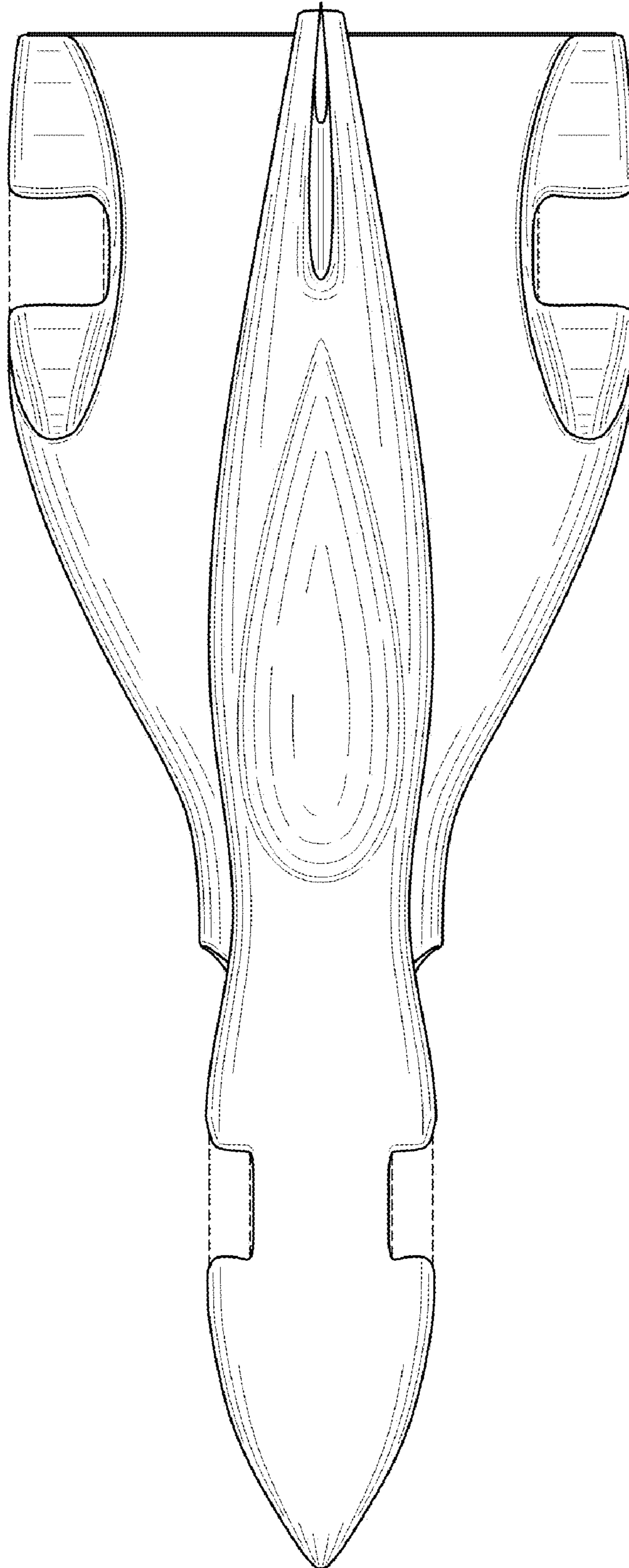

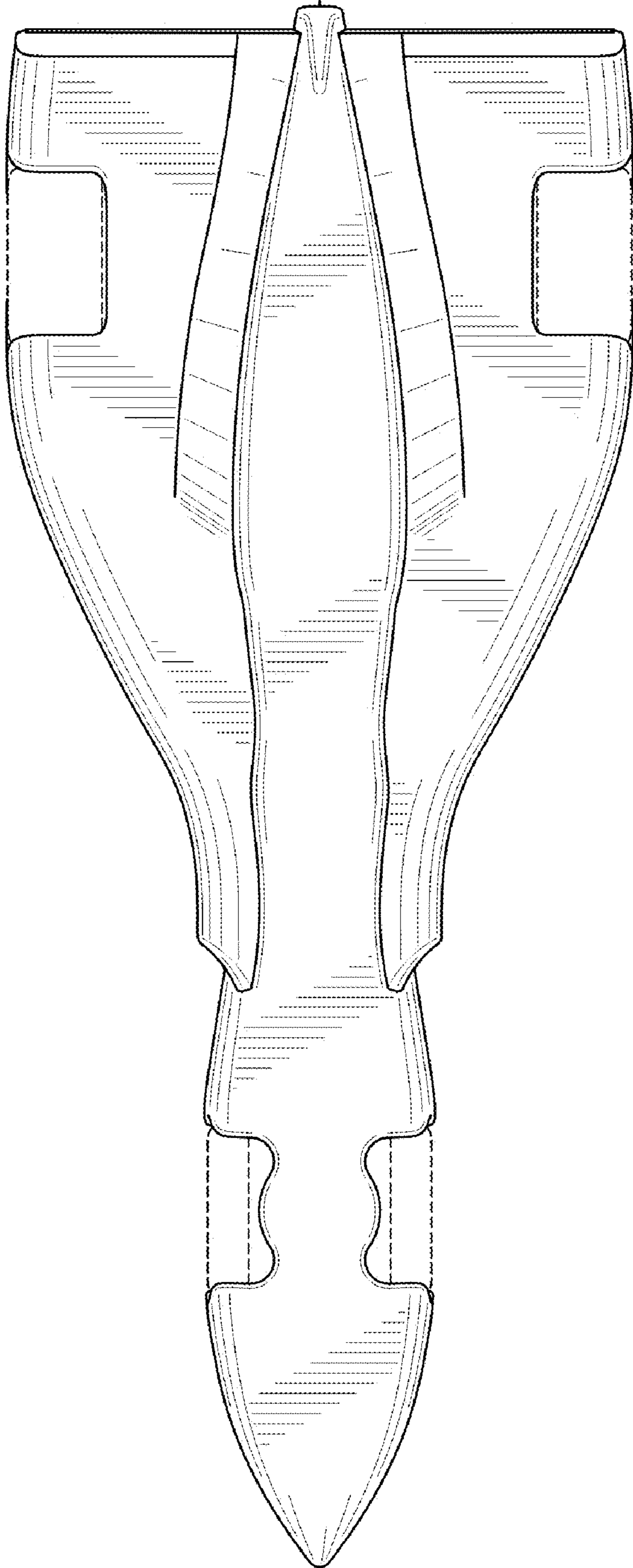

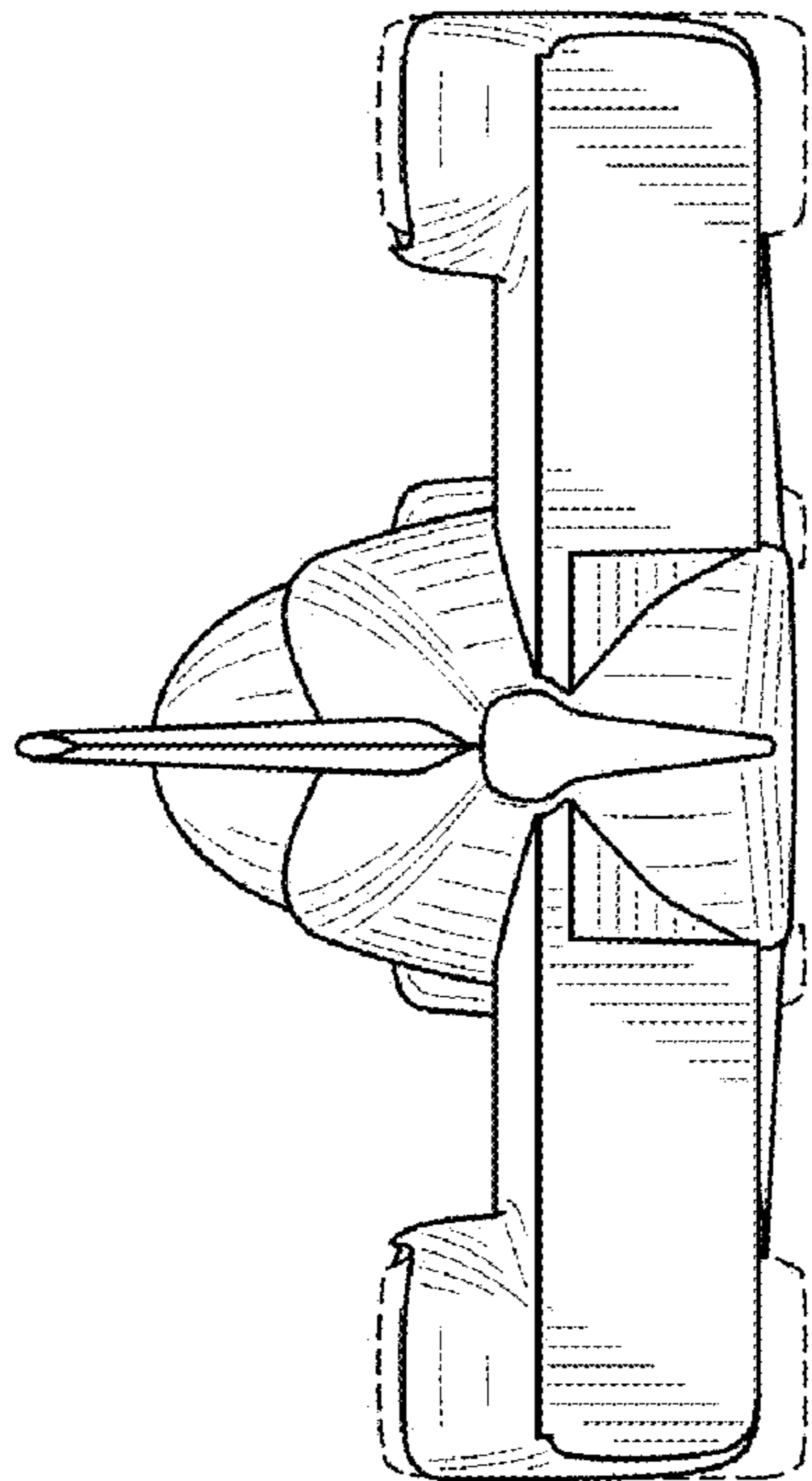

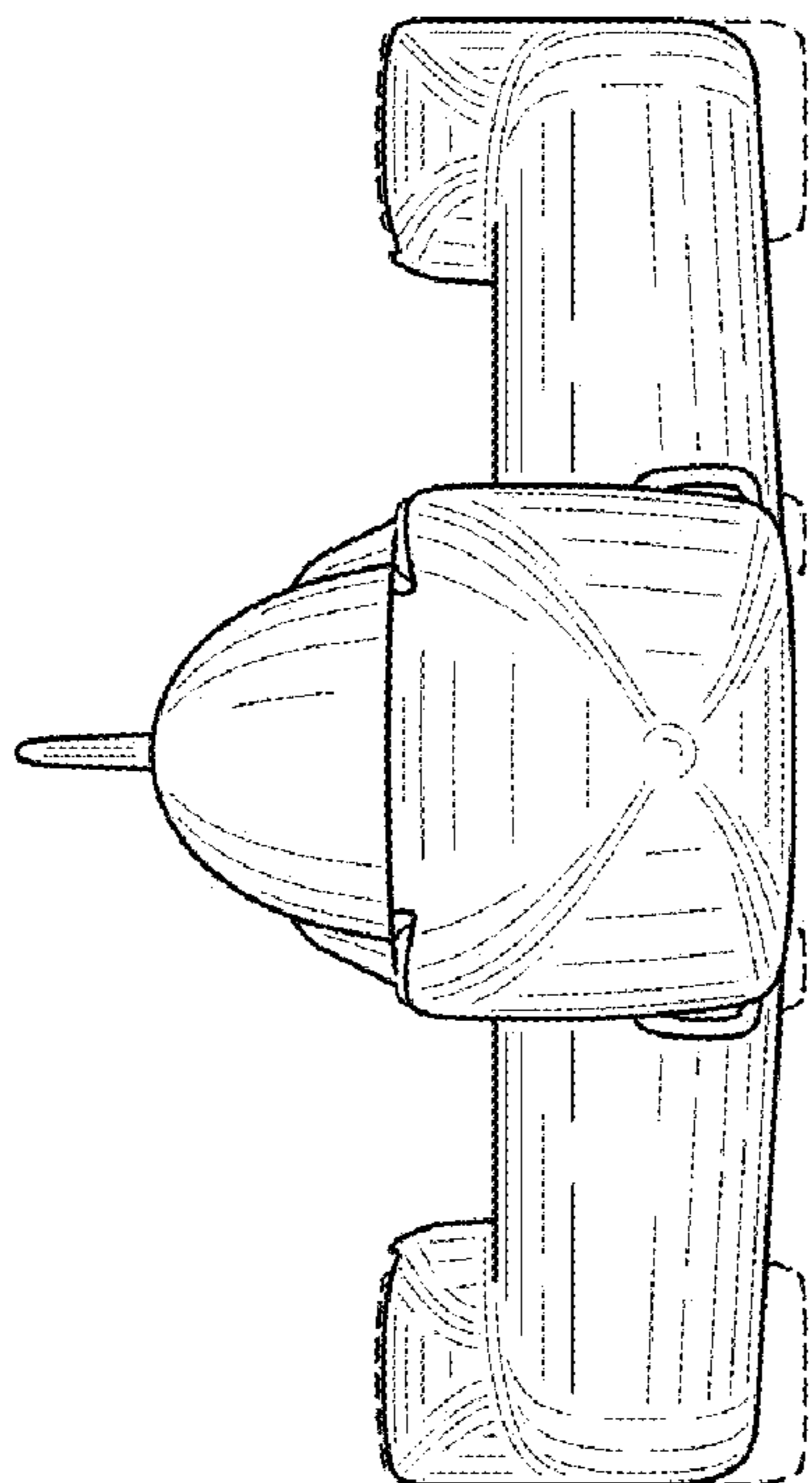
