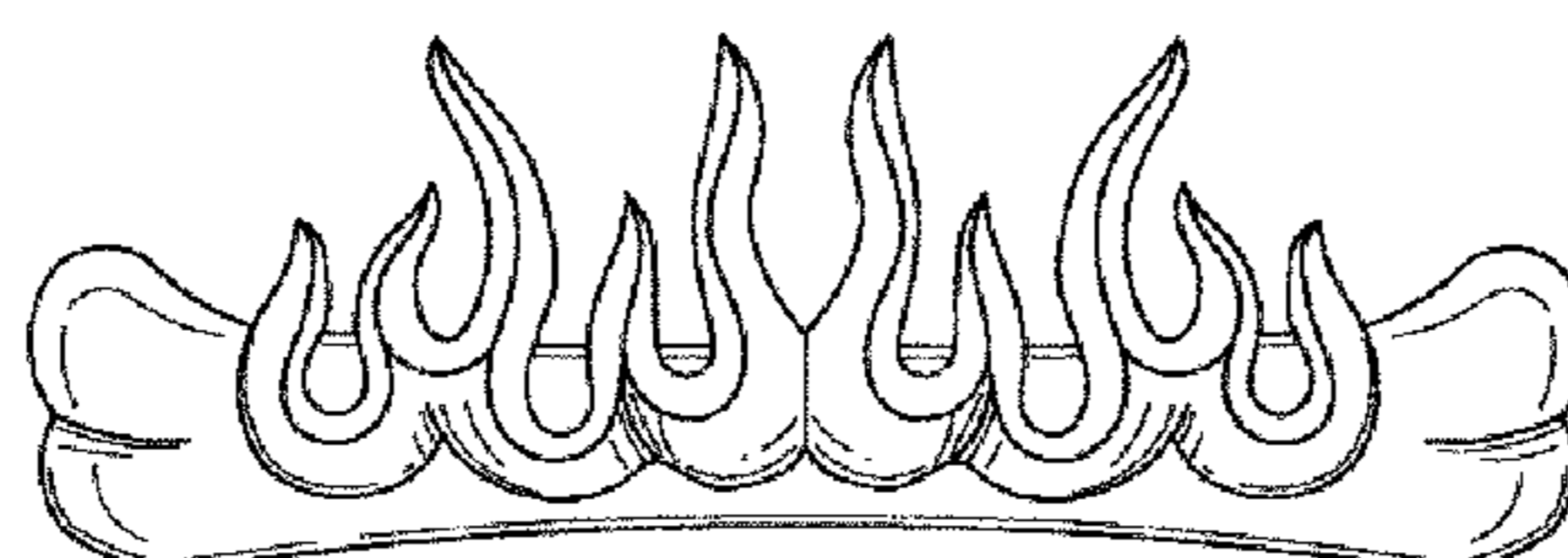
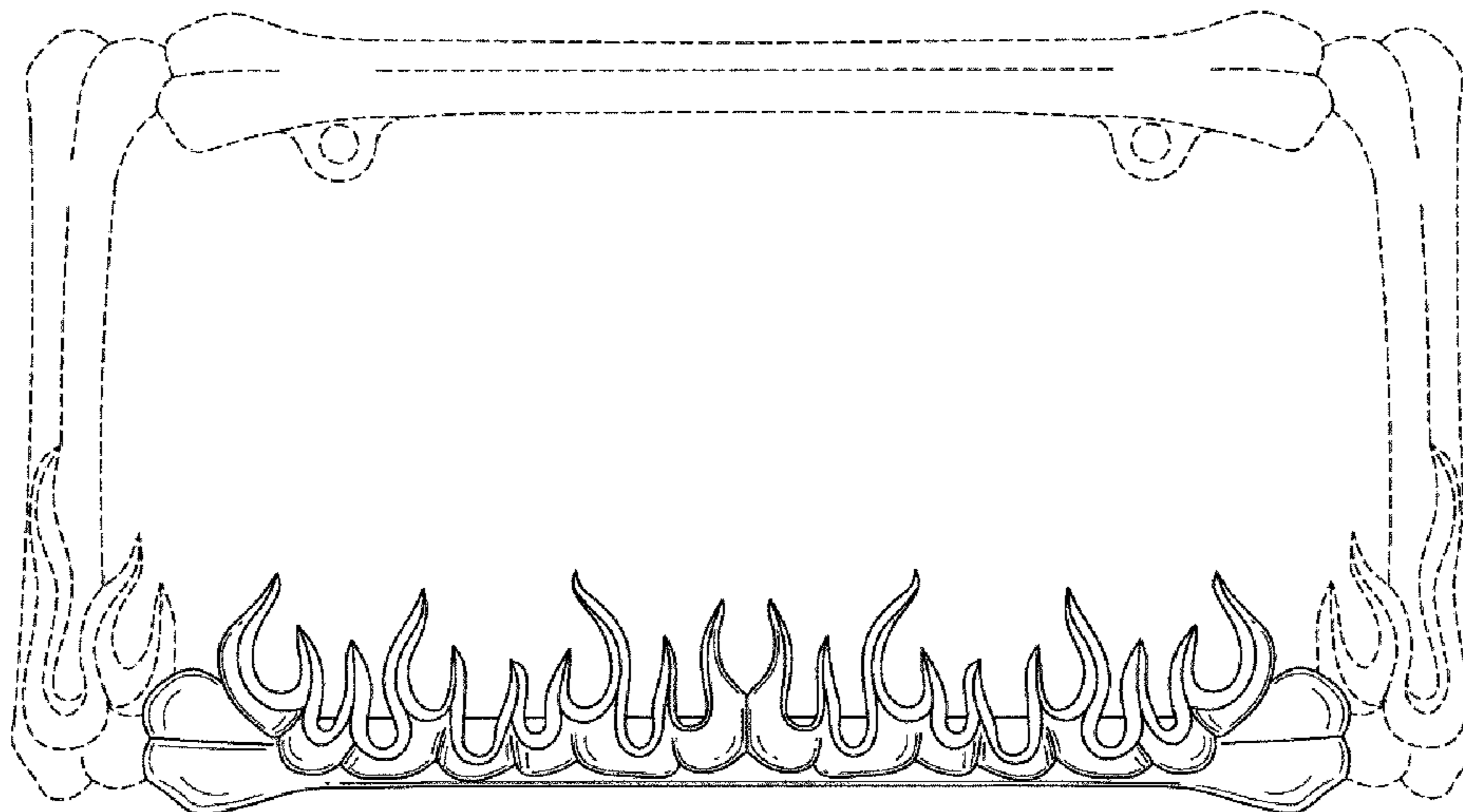
The ornamental design for vehicle decor, as shown and described.

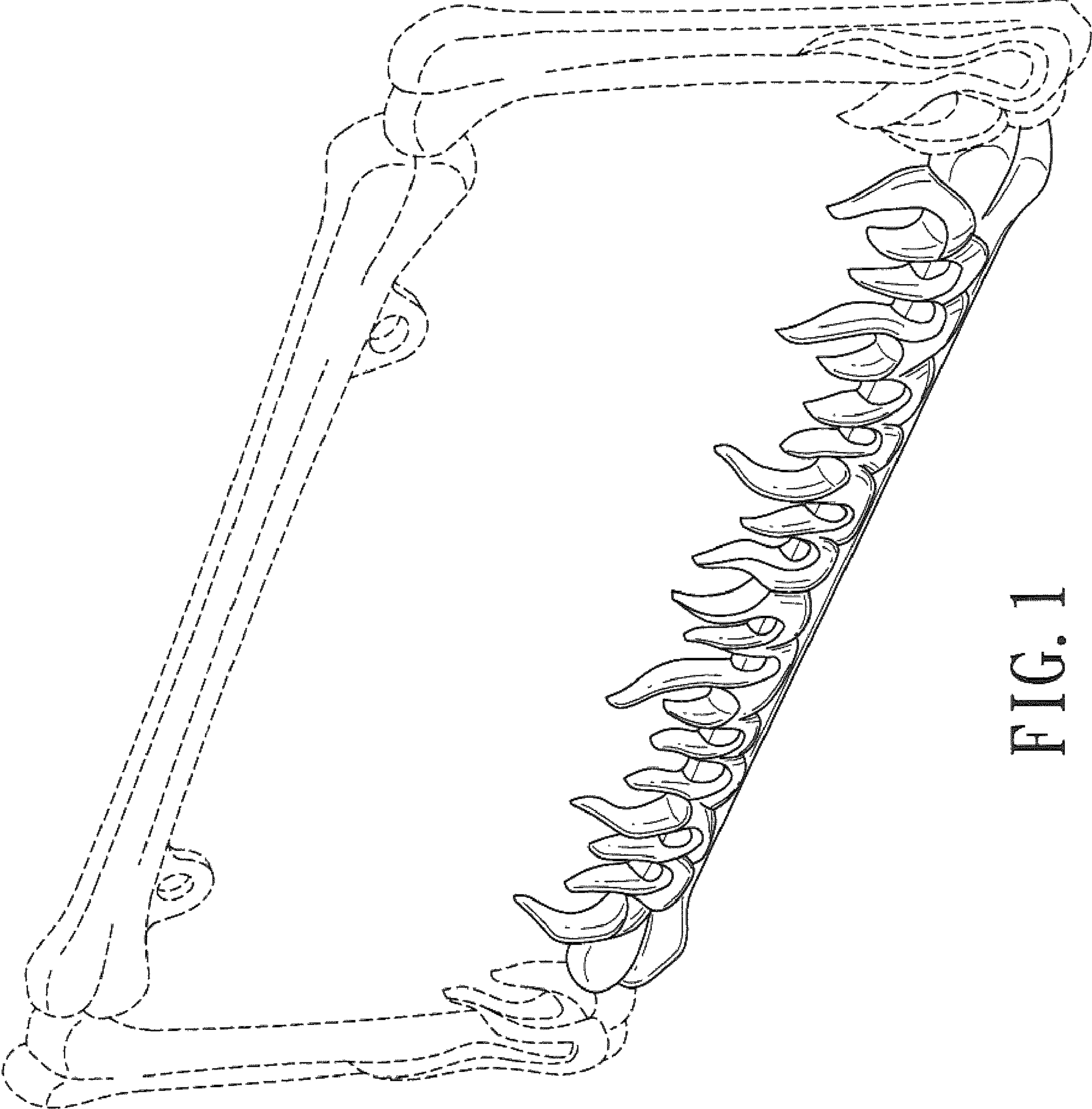

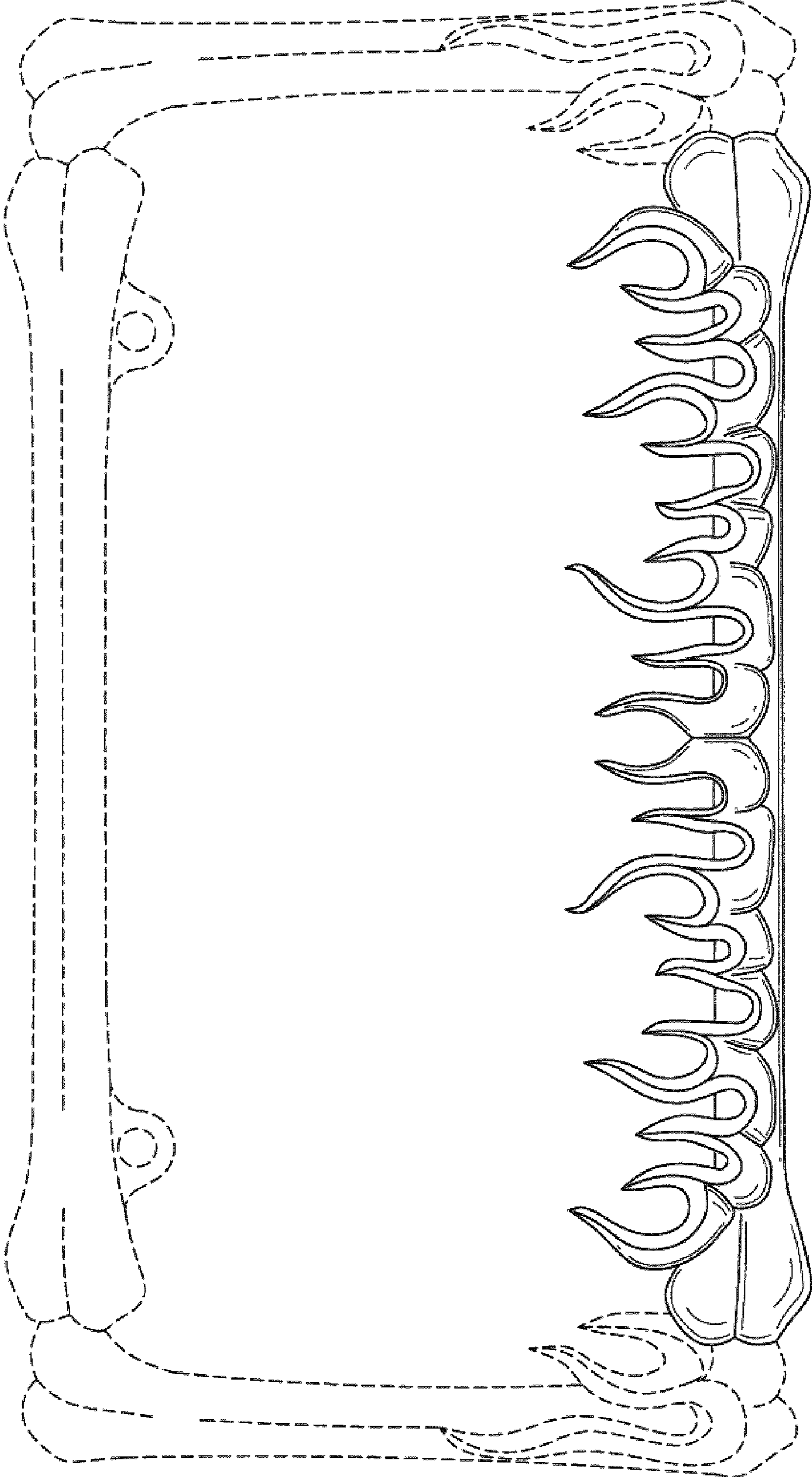

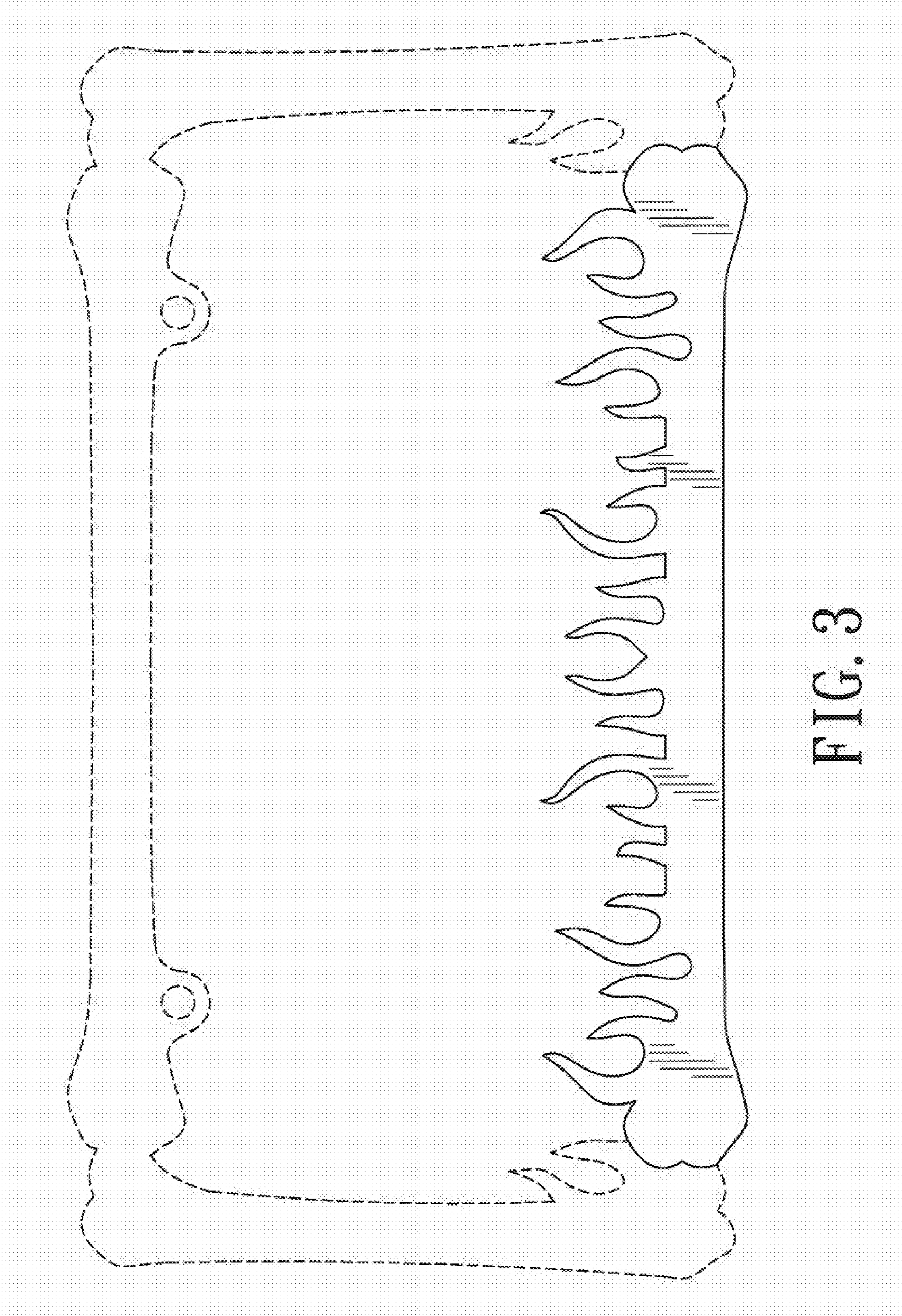

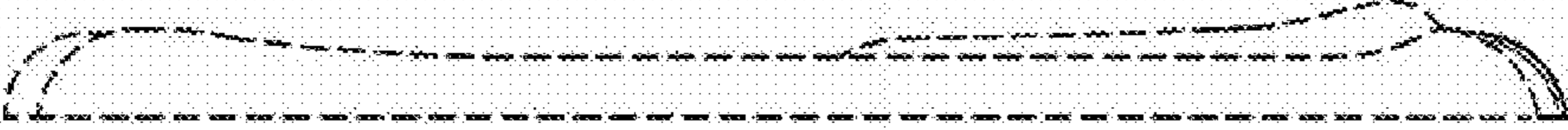

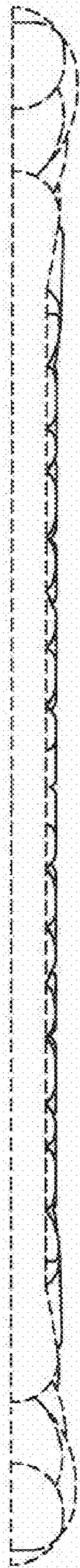

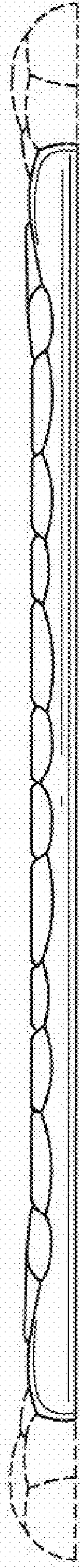

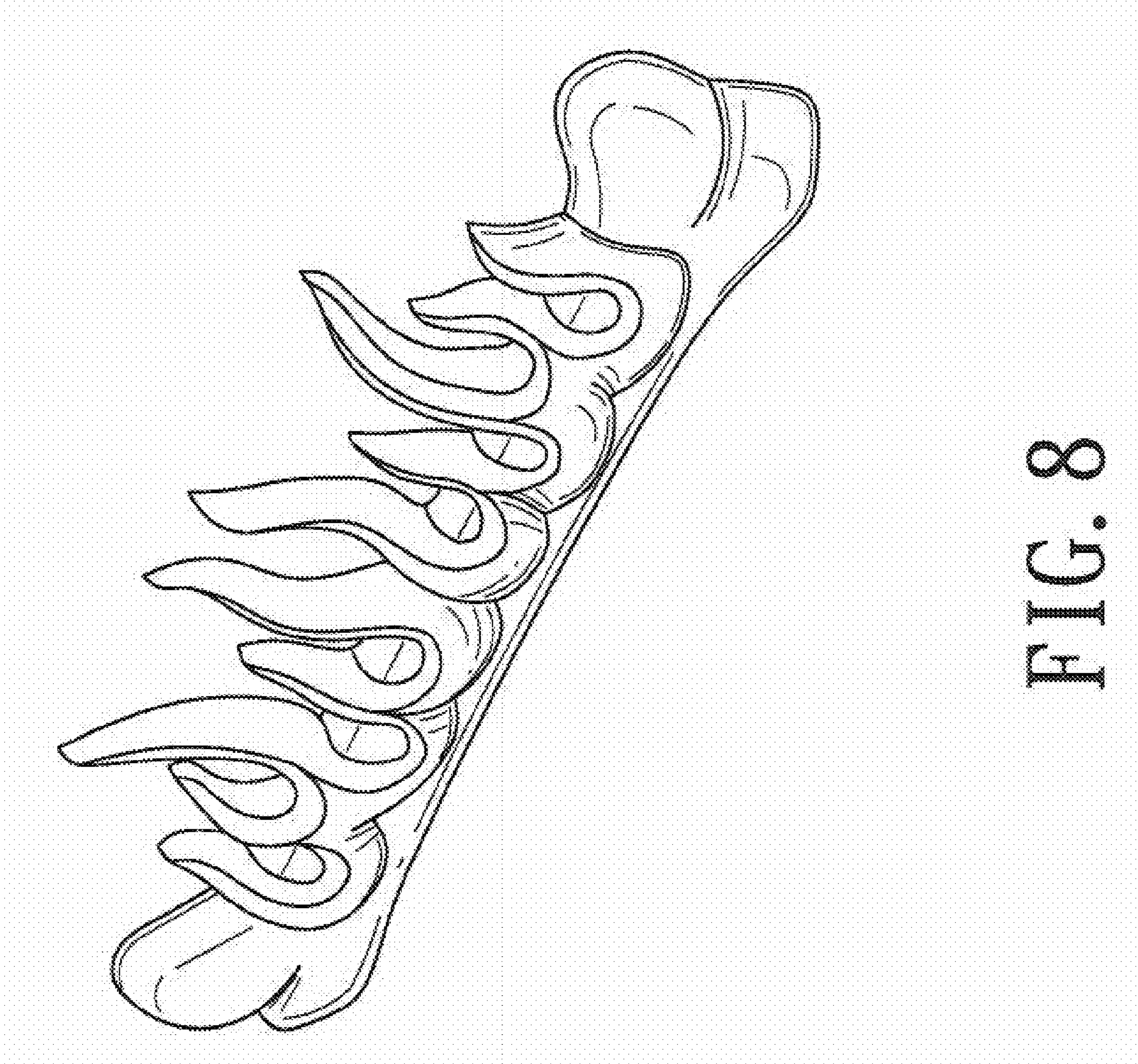

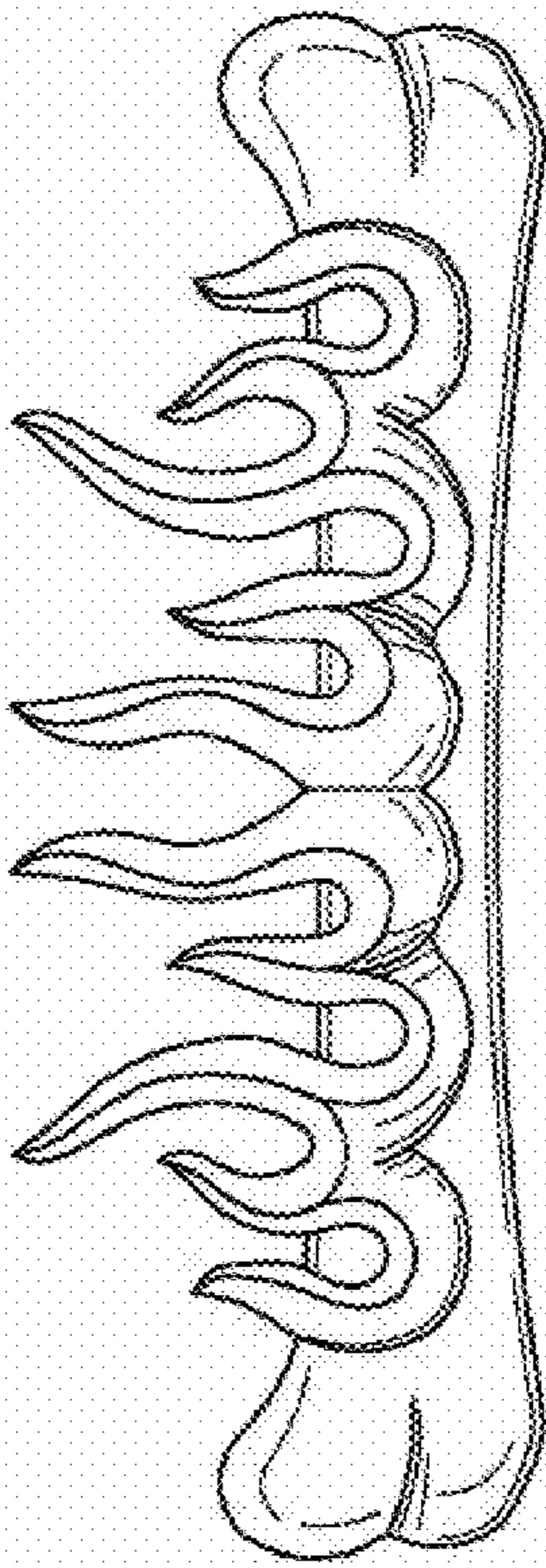

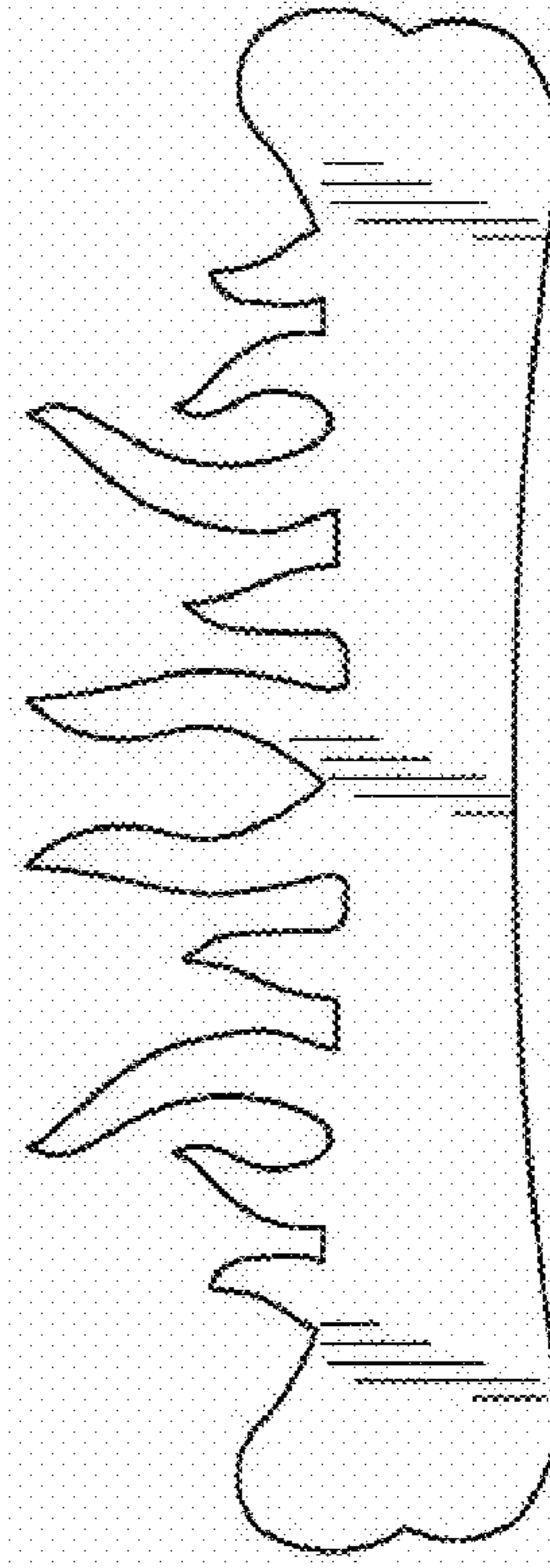
