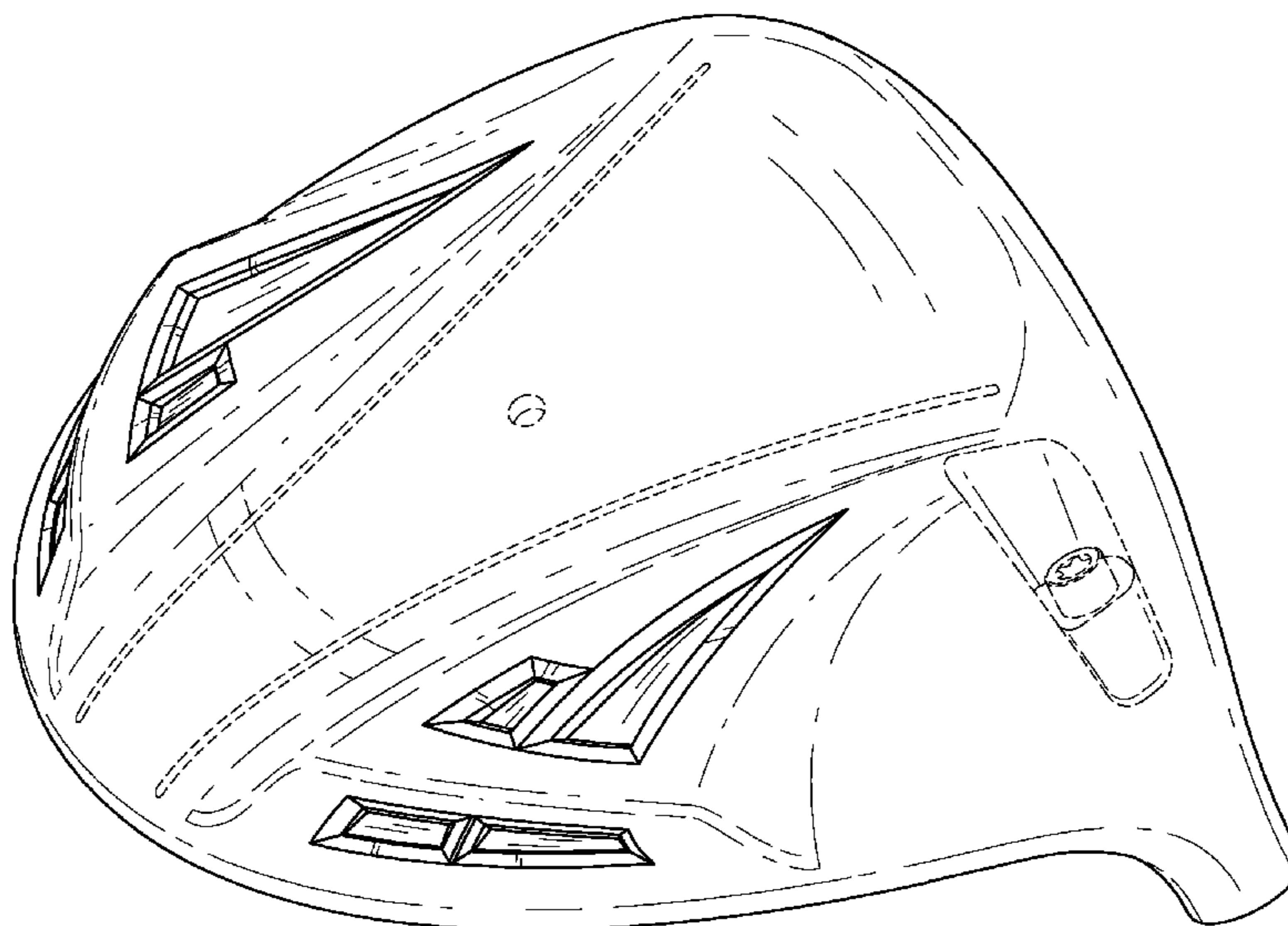
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a bottom, heel side perspective view of a golf club head embodying our new design;

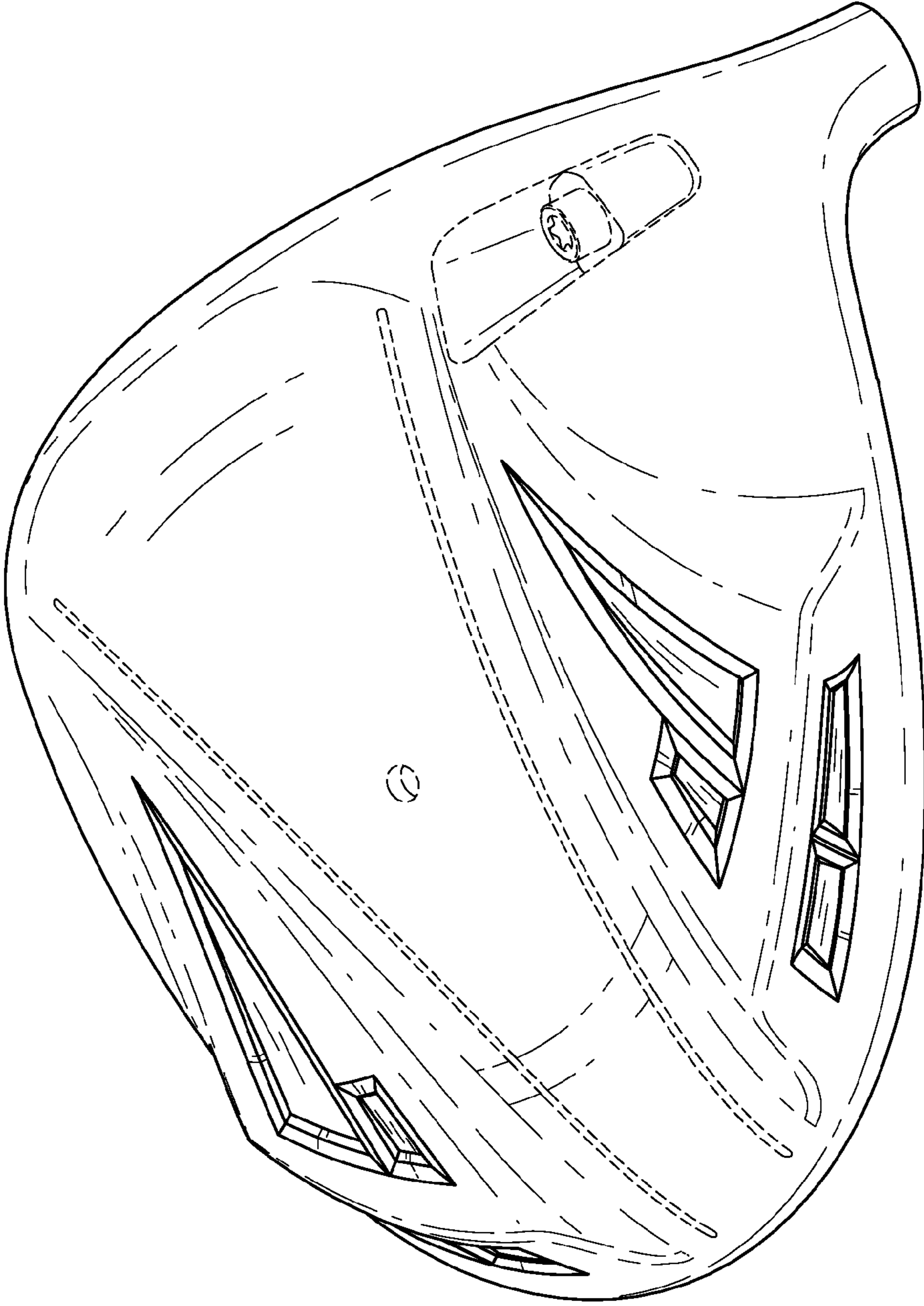

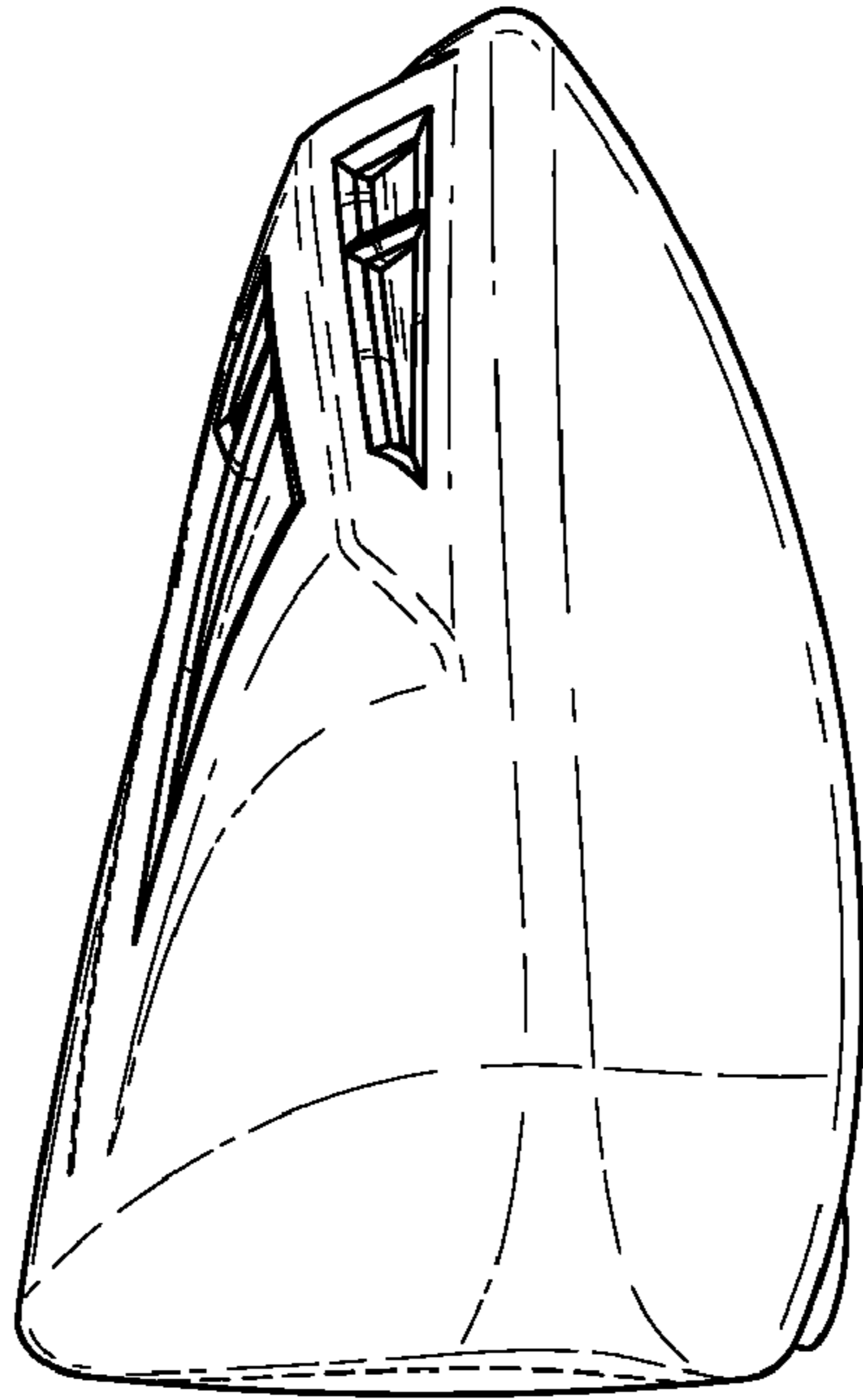

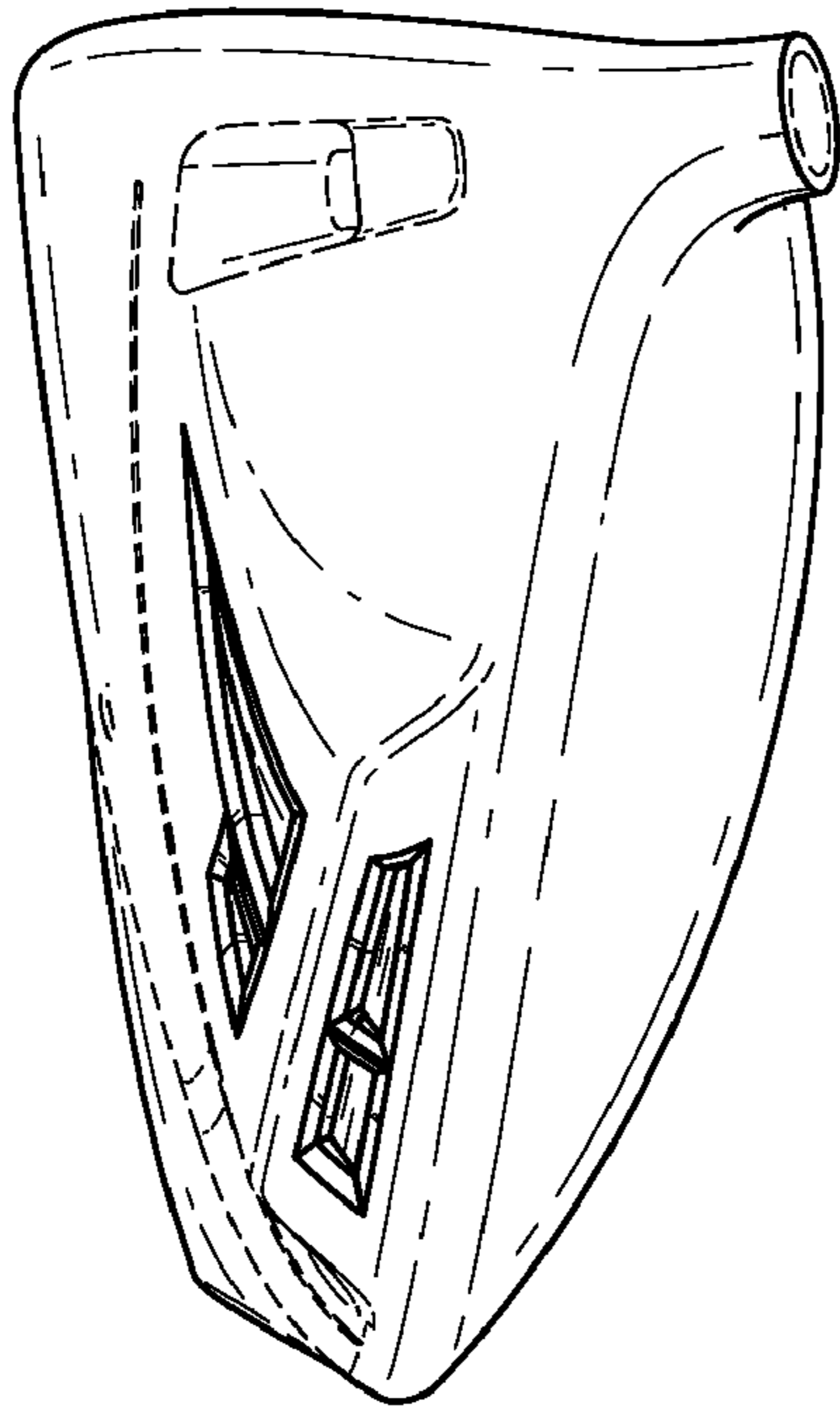

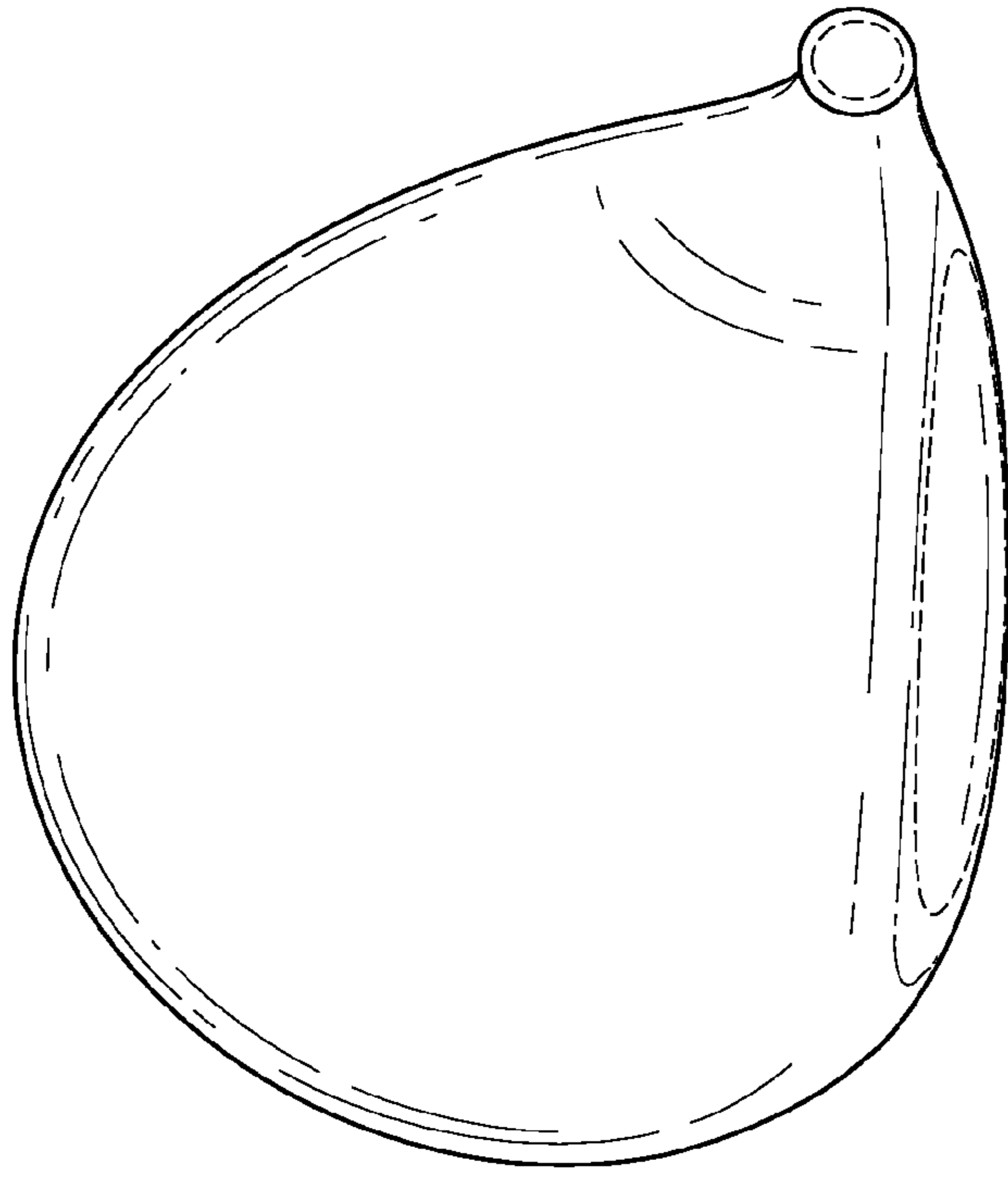

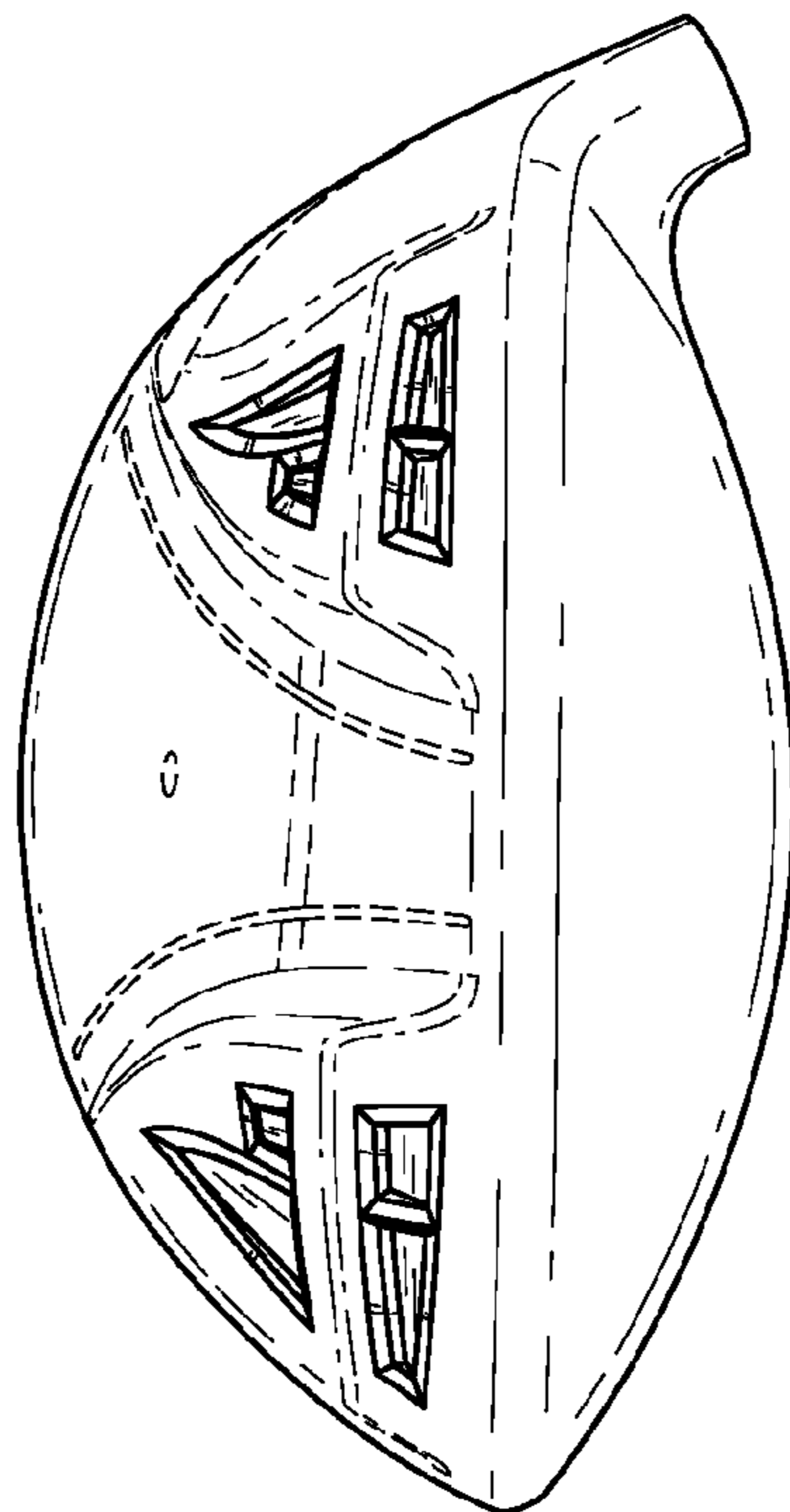

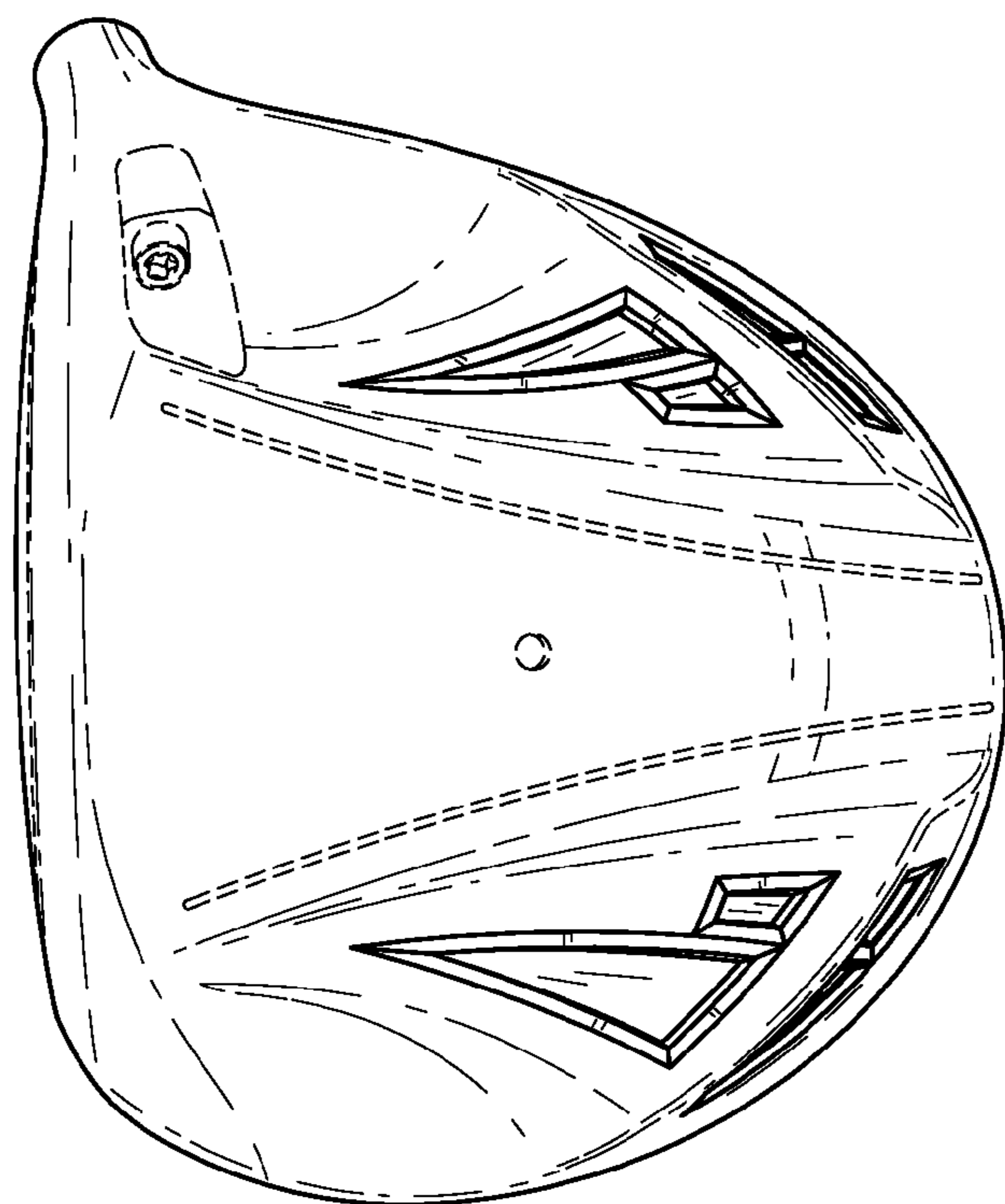

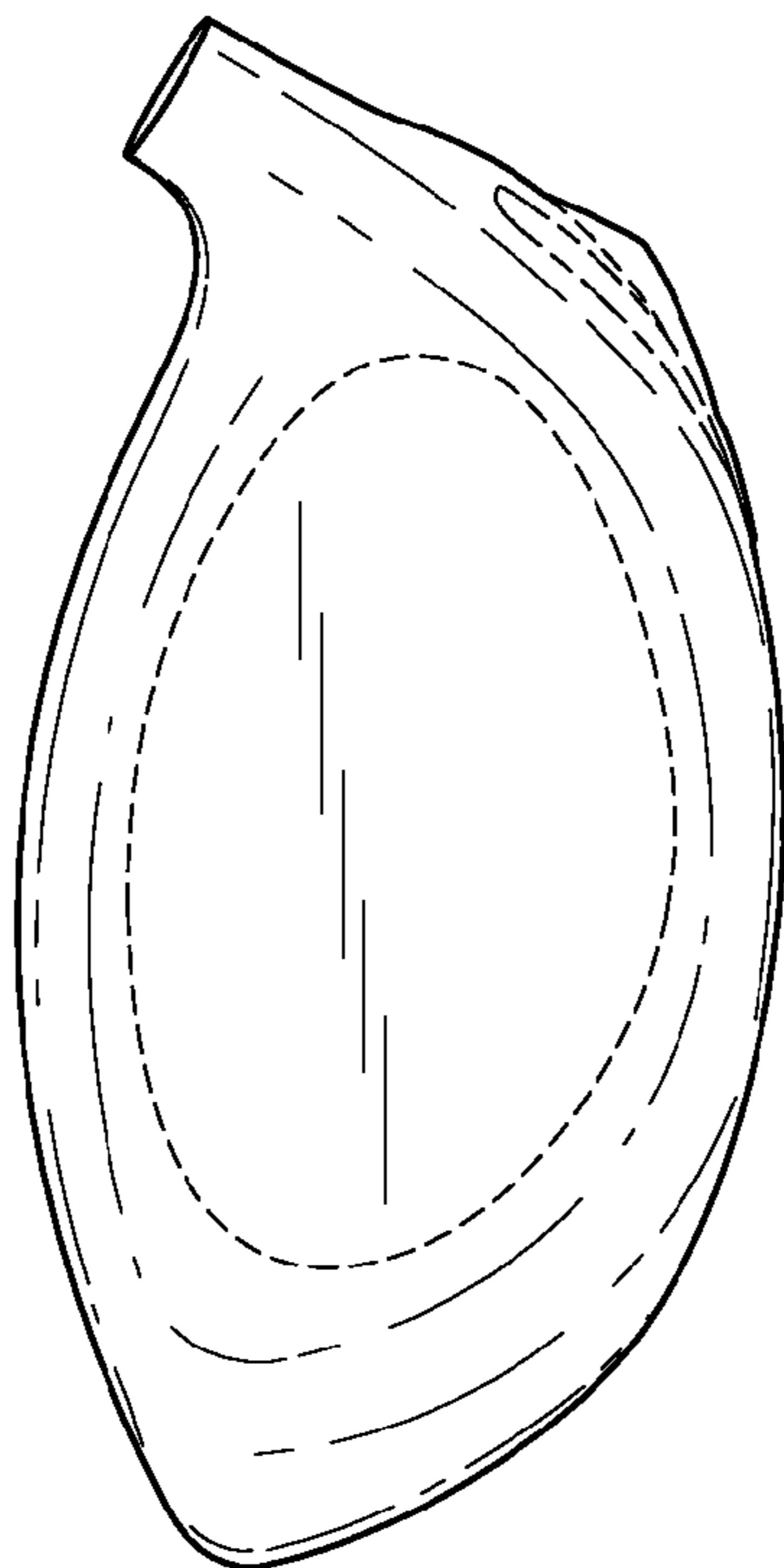
