(57) **CLAIM**

The ornamental design for a tissue repair implant, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a tissue repair implant, showing our new design; and,

FIG. 2 is a top plan view thereof.

The broken line showing of a tissue repair implant is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

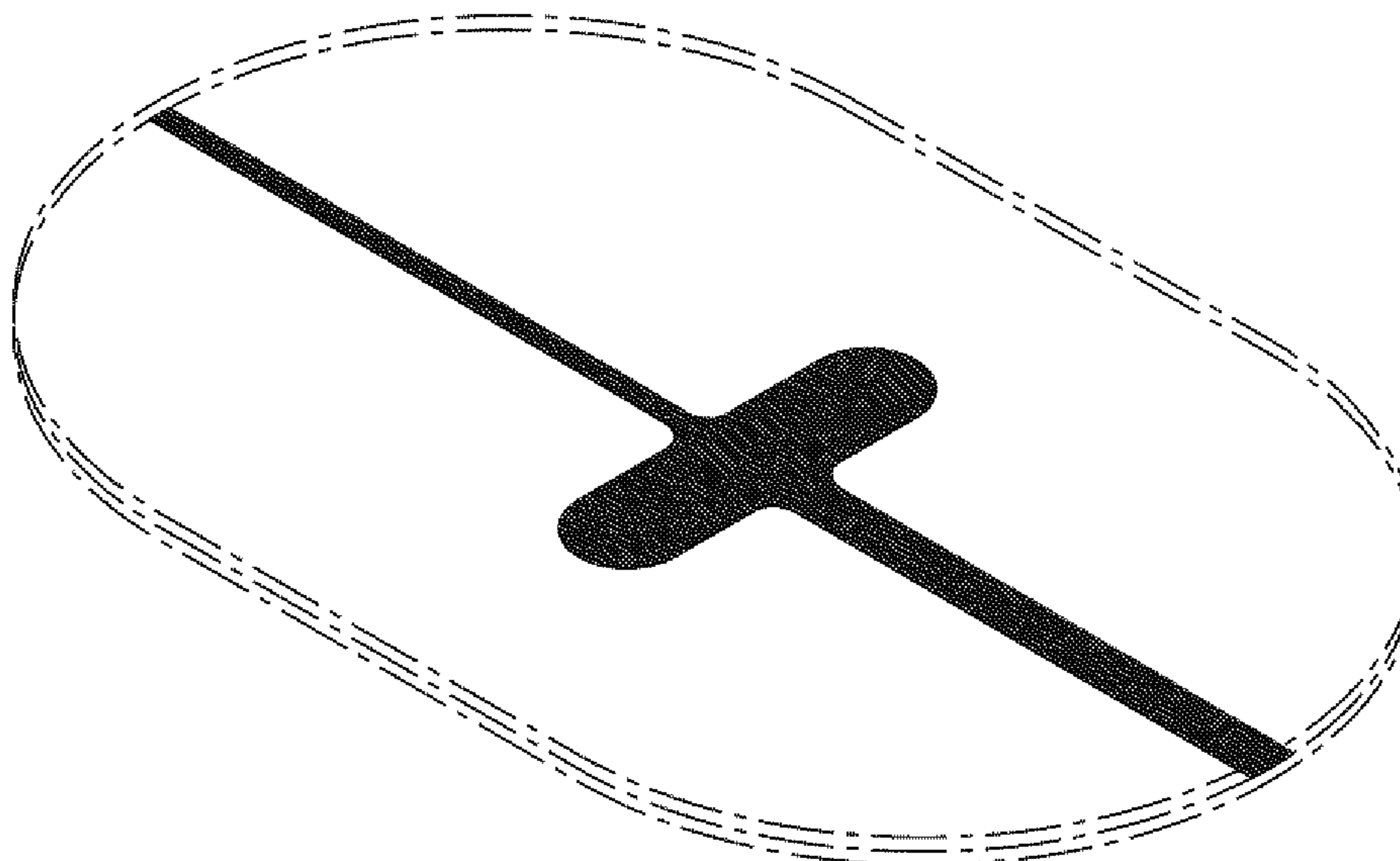

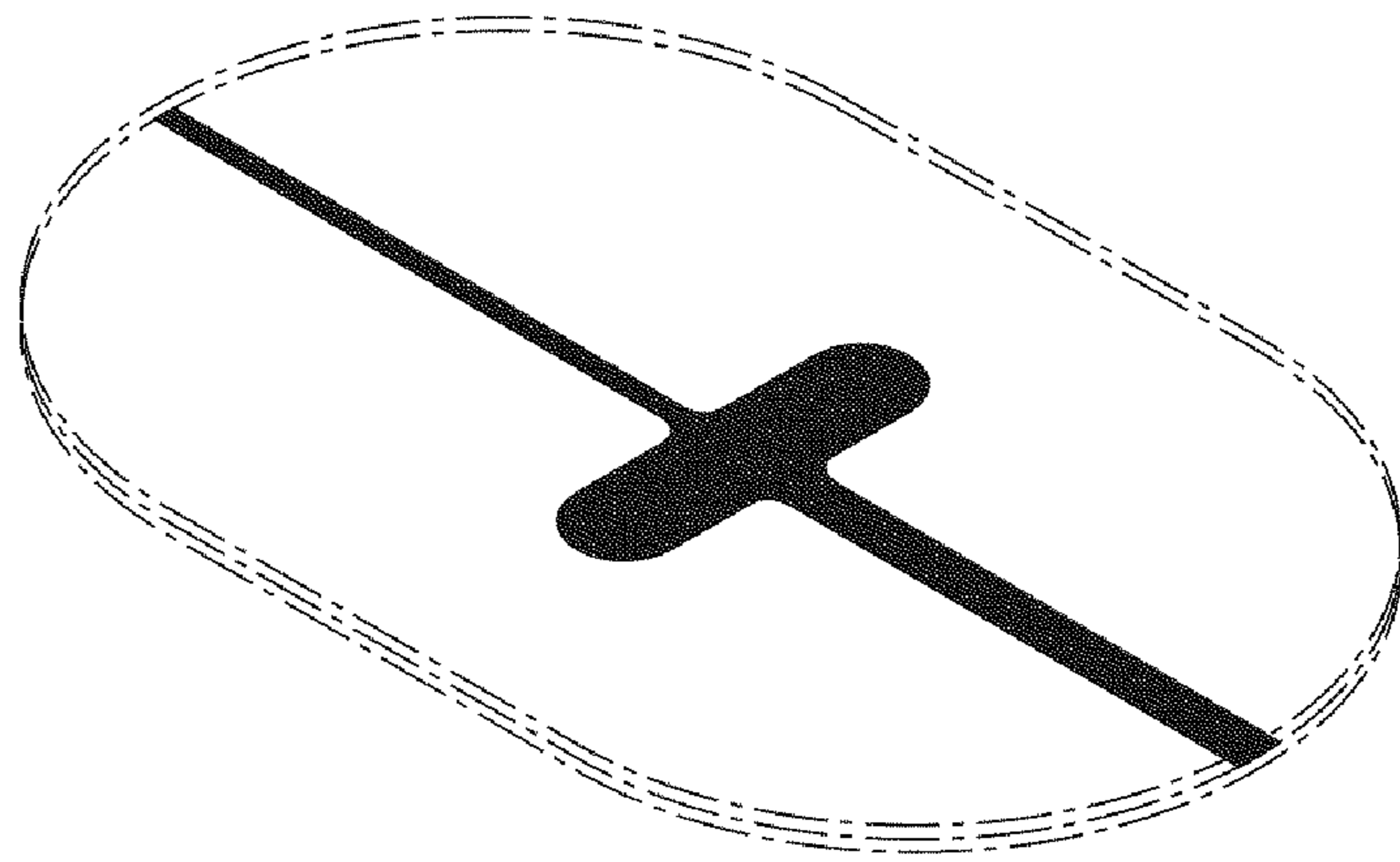
