(57) **CLAIM**

The ornamental design for a chocolate rabbit with wrapper, as shown and described in the accompanying drawings.

**DESCRIPTION**

FIG. 3 is a left side view of the chocolate rabbit with wrapper design;

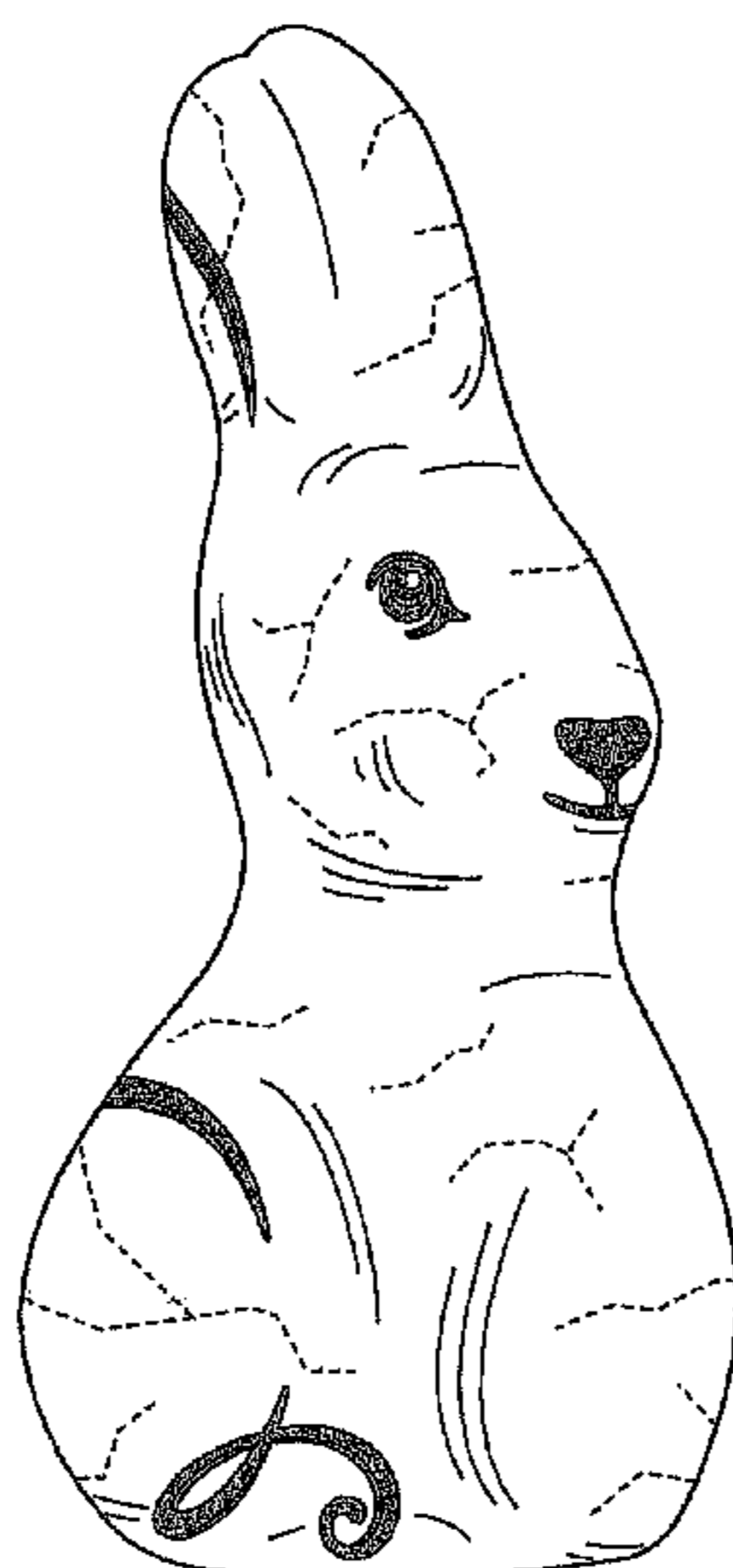
FIG. 4 is back view of the chocolate rabbit with wrapper design;

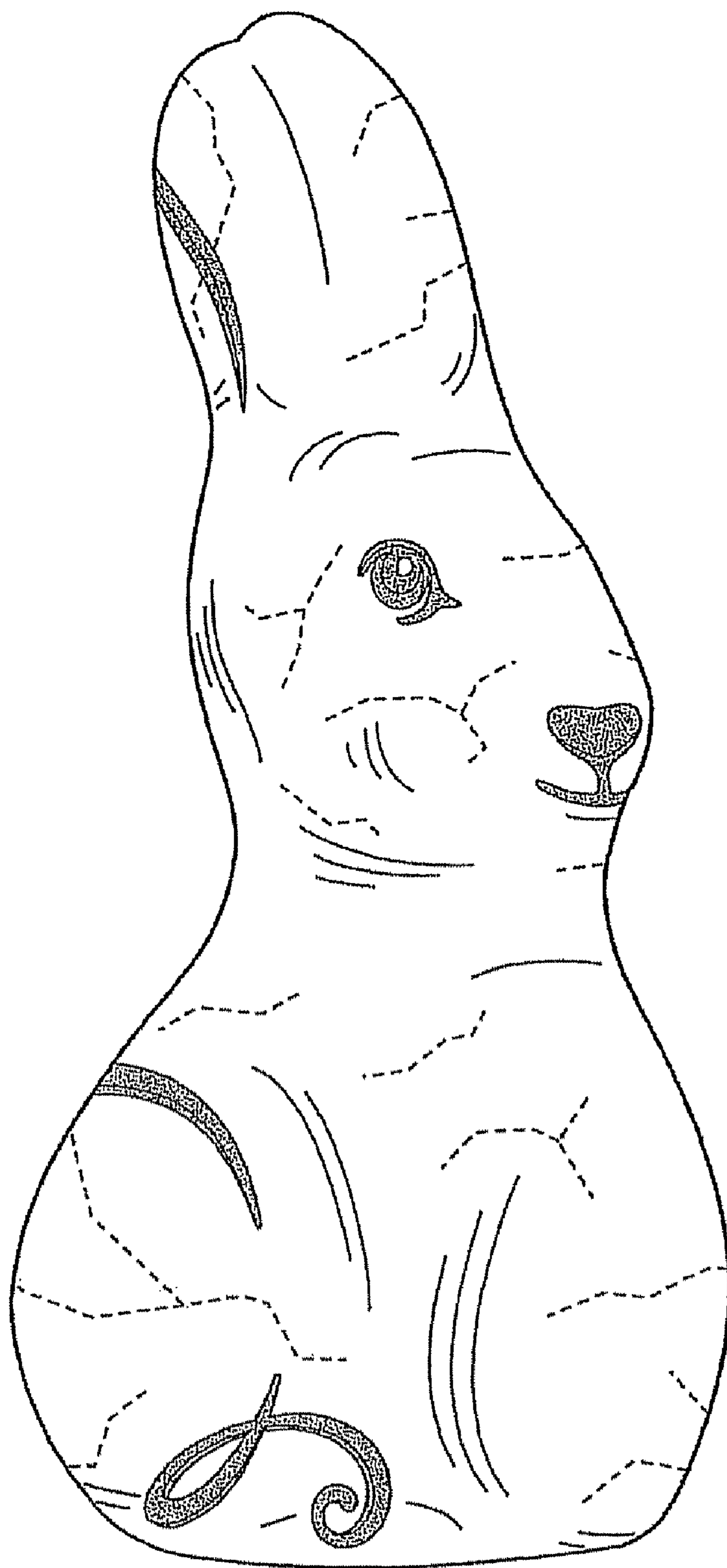

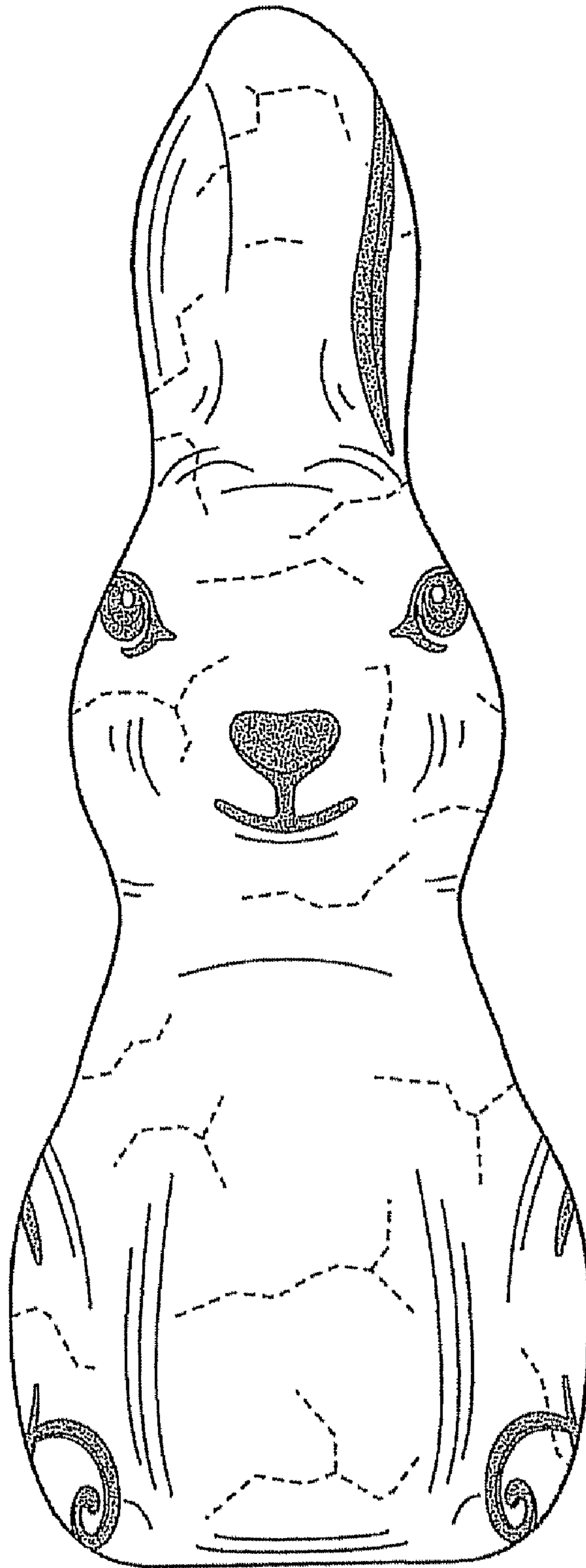

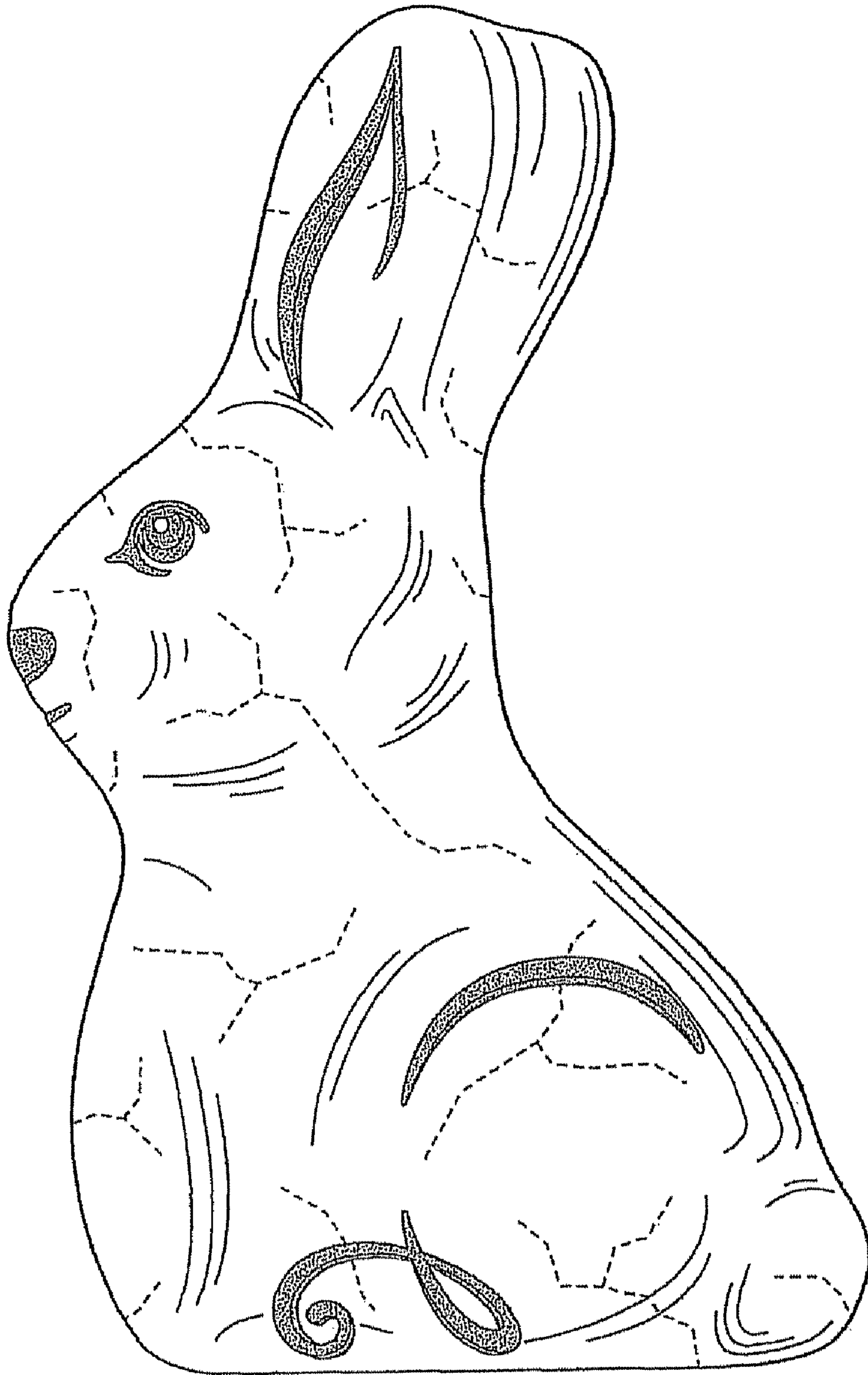

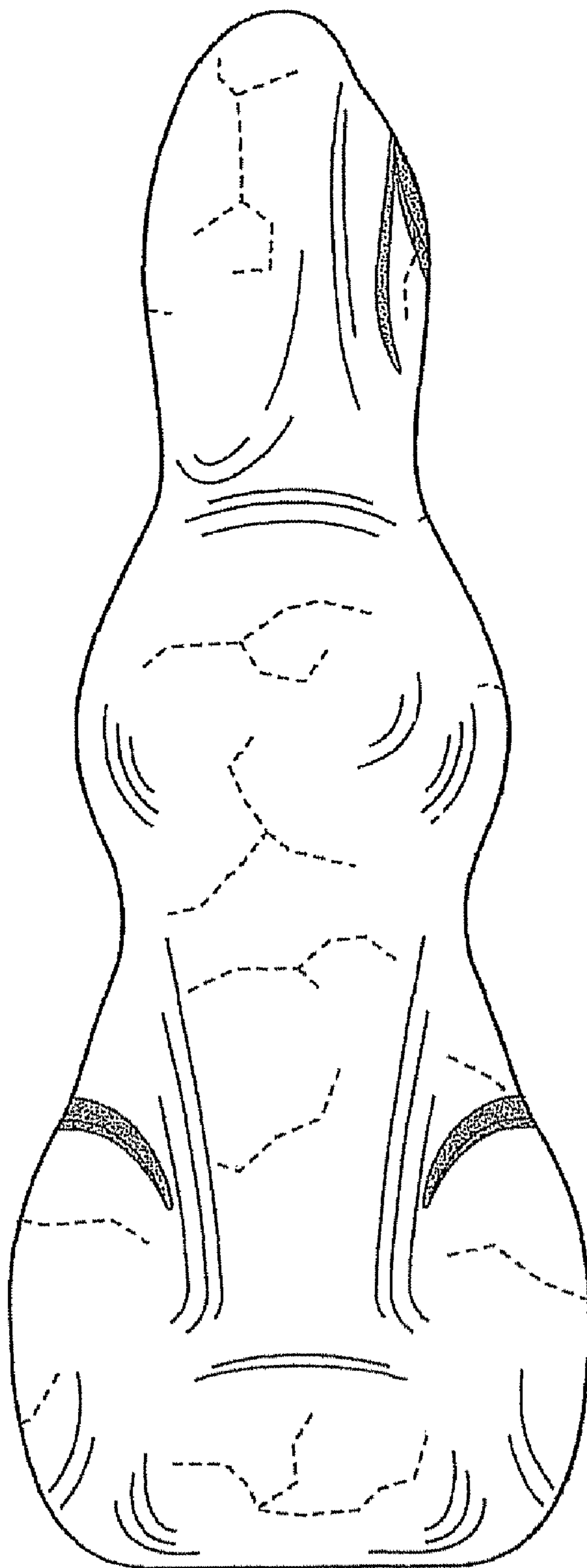

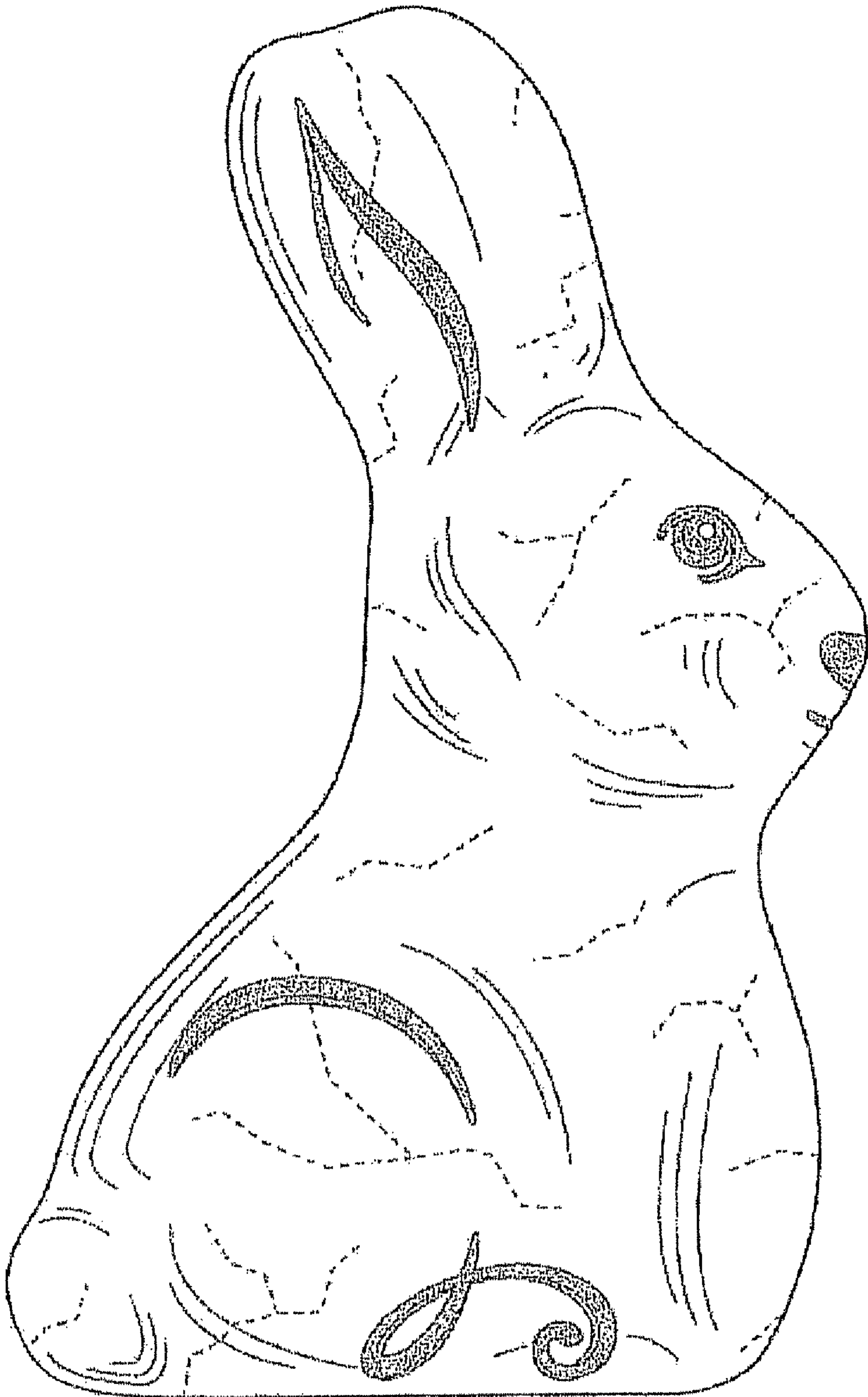

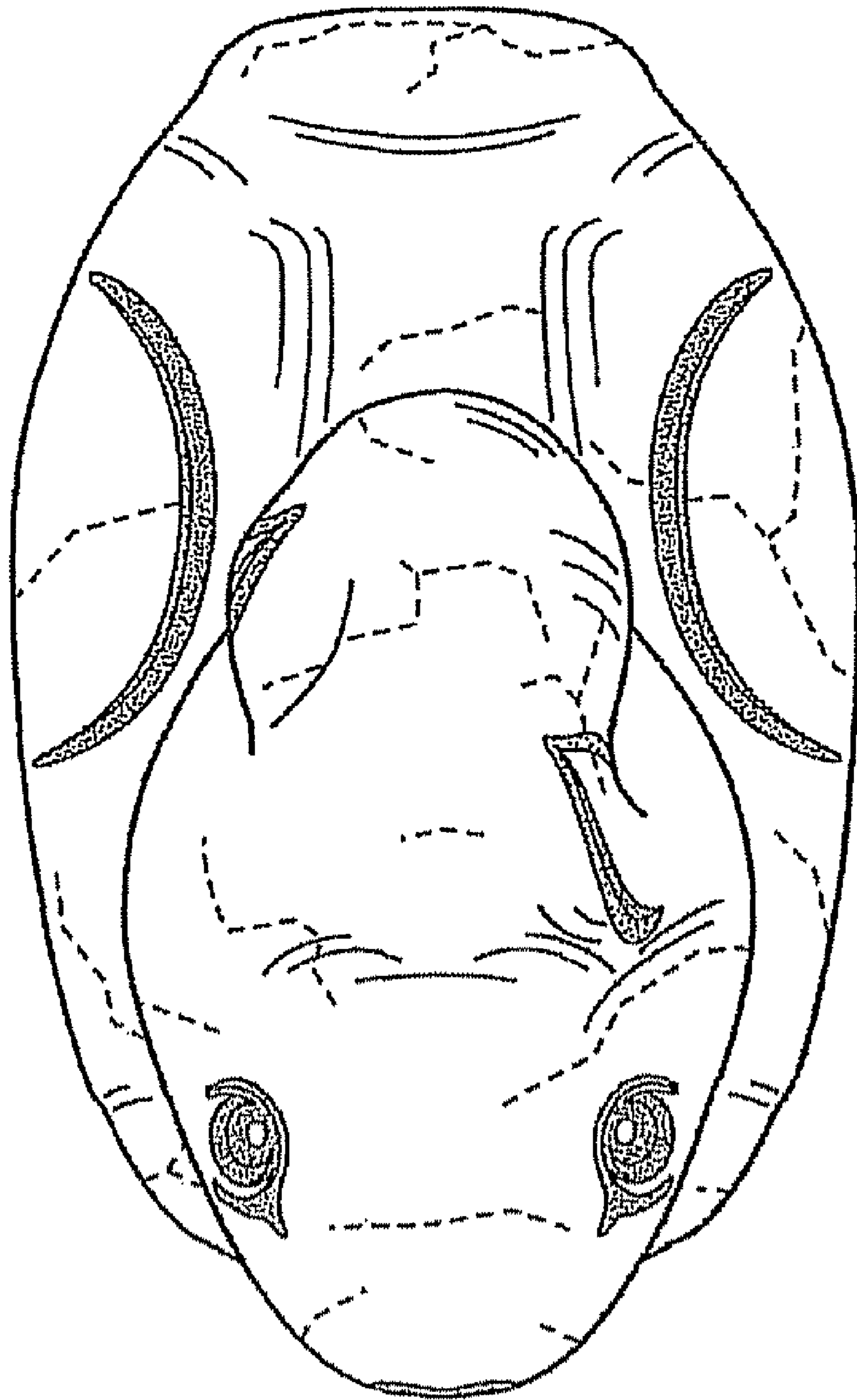
