**DESCRIPTION**

FIG. 1 is a perspective view of a shoe bottom in accordance with my new design.

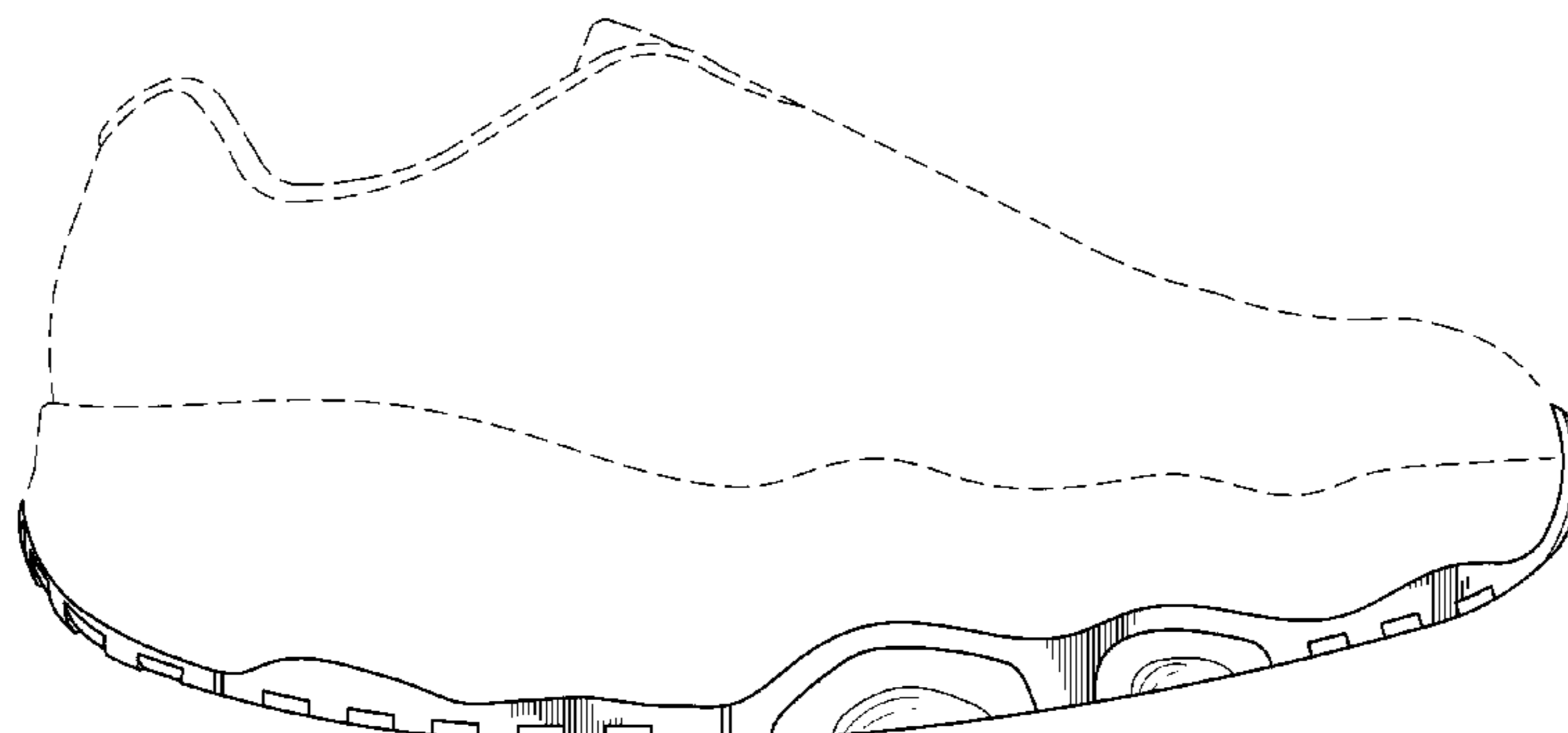
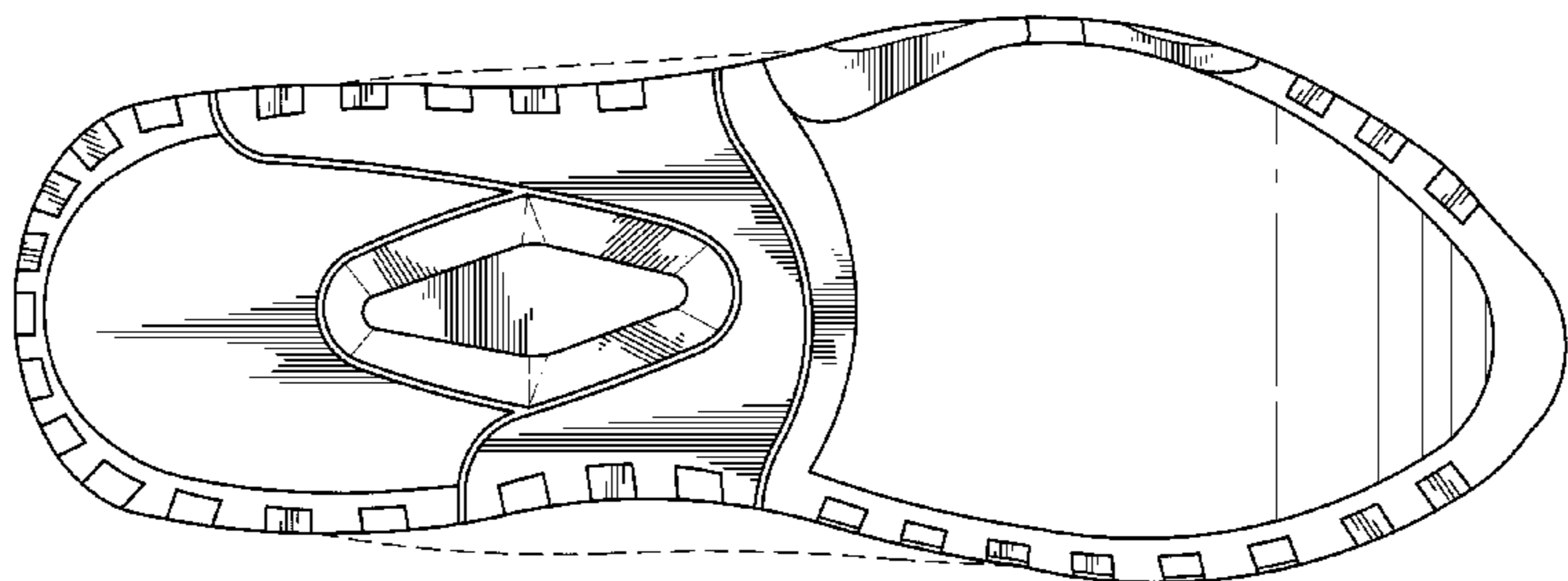

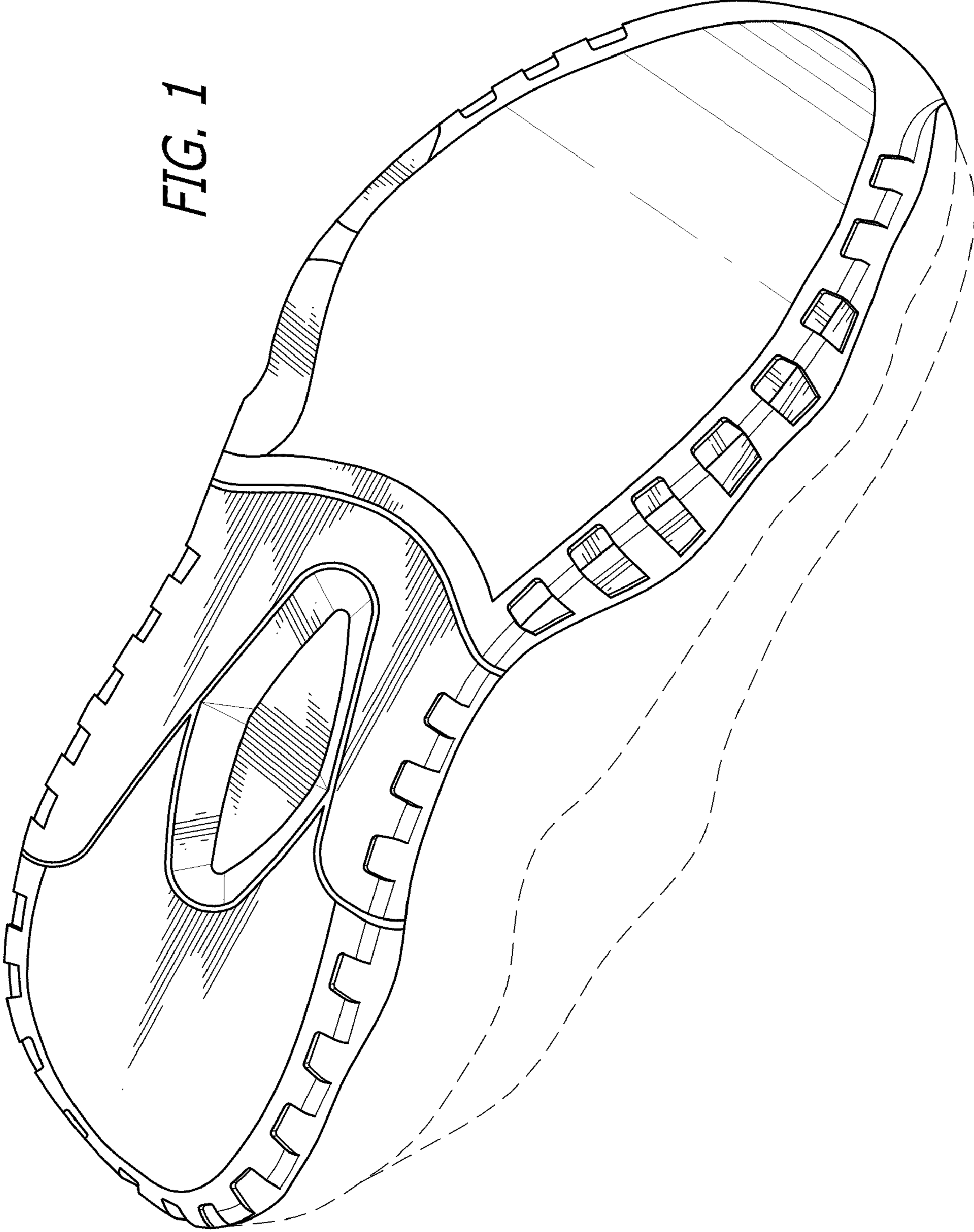

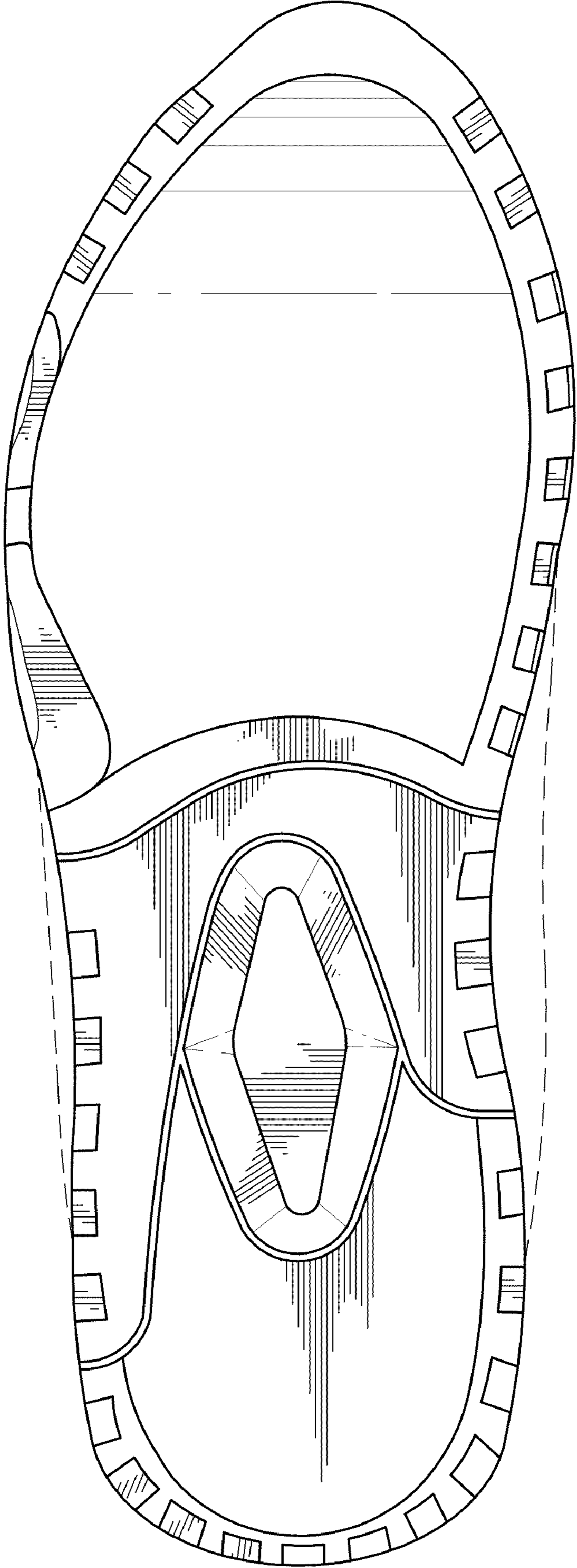
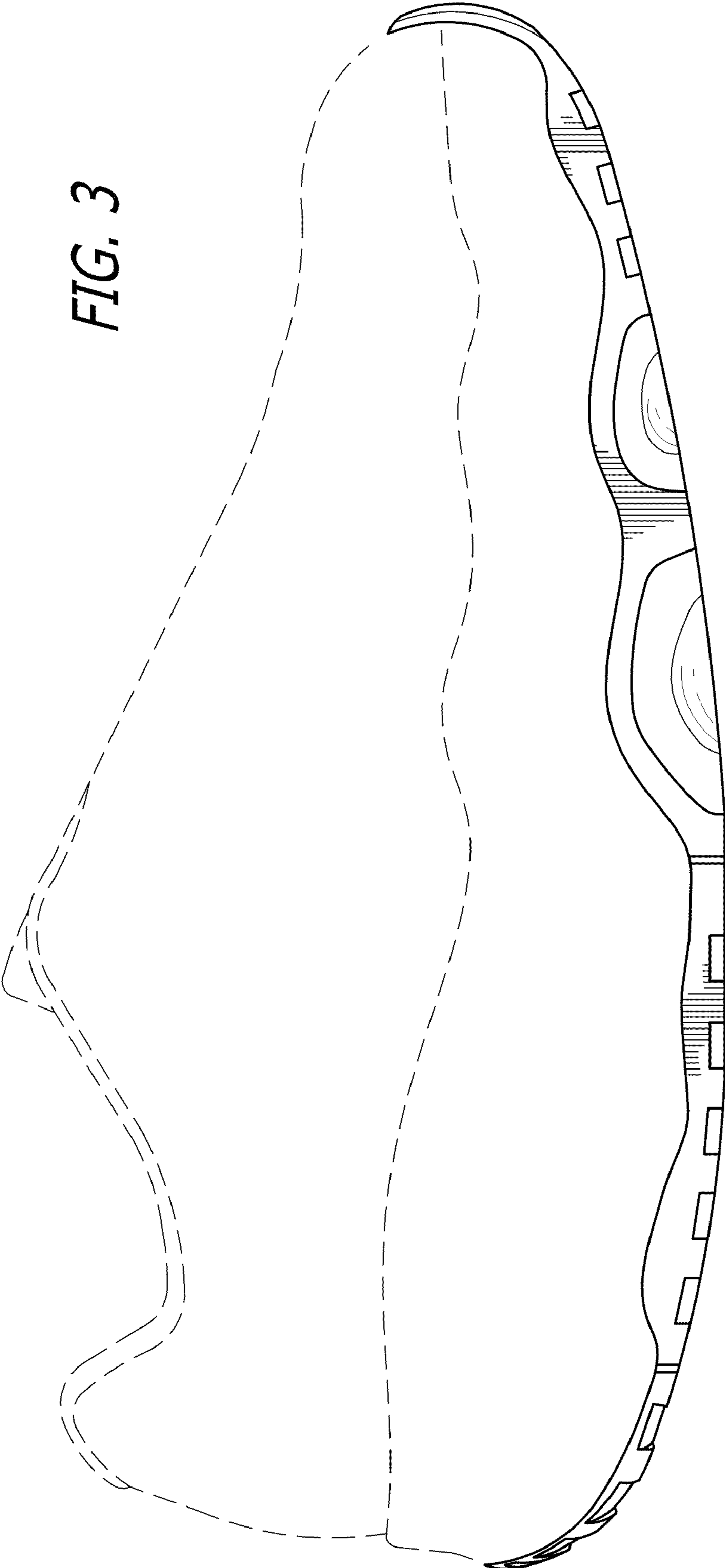

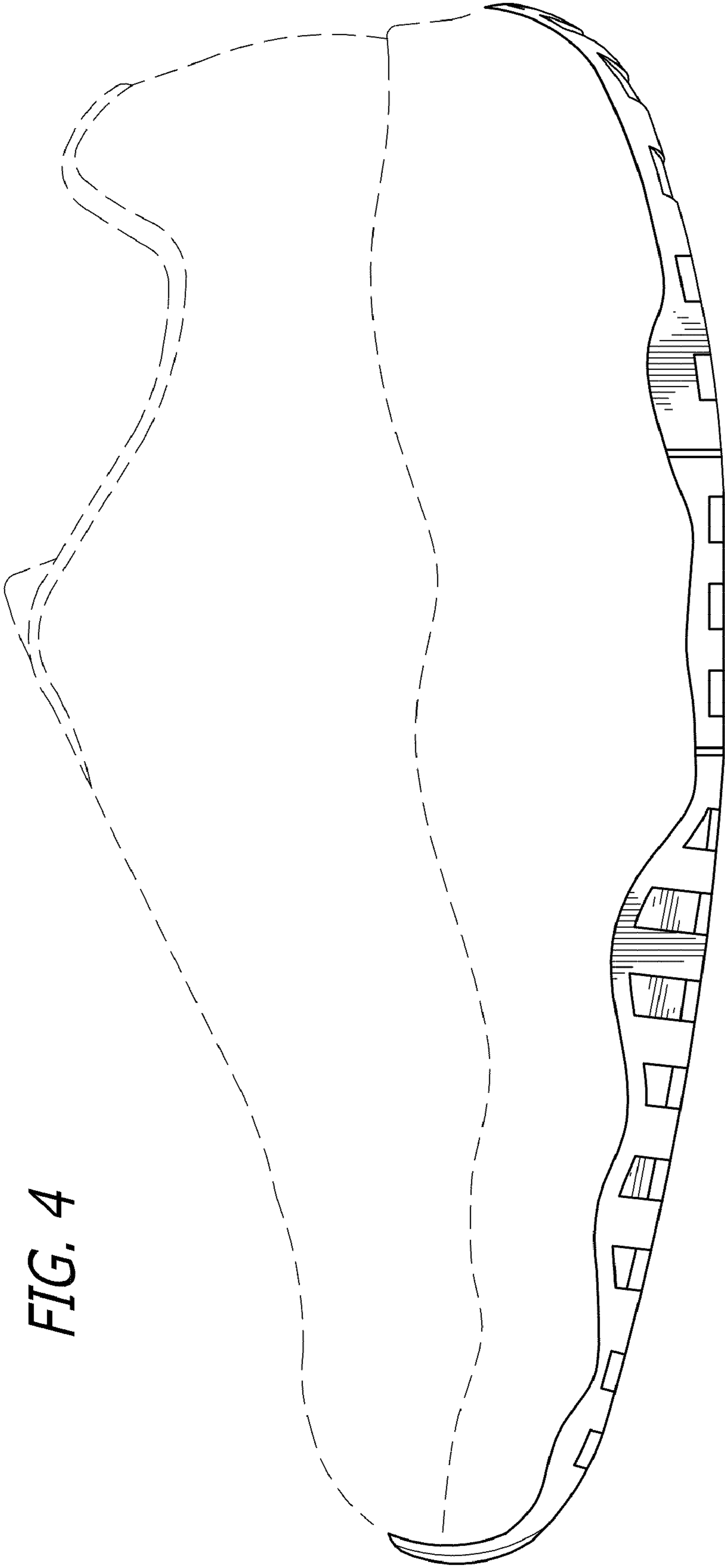

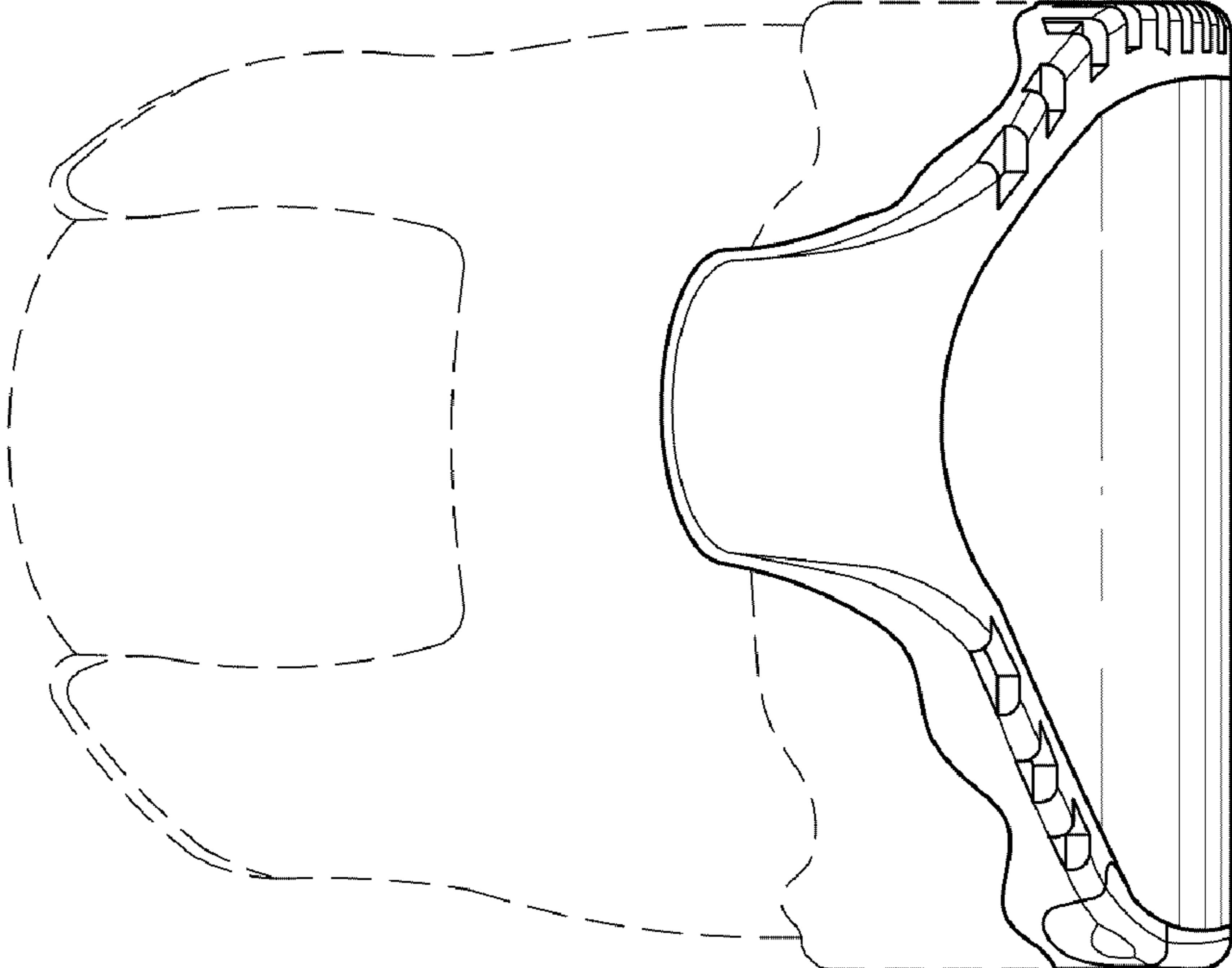
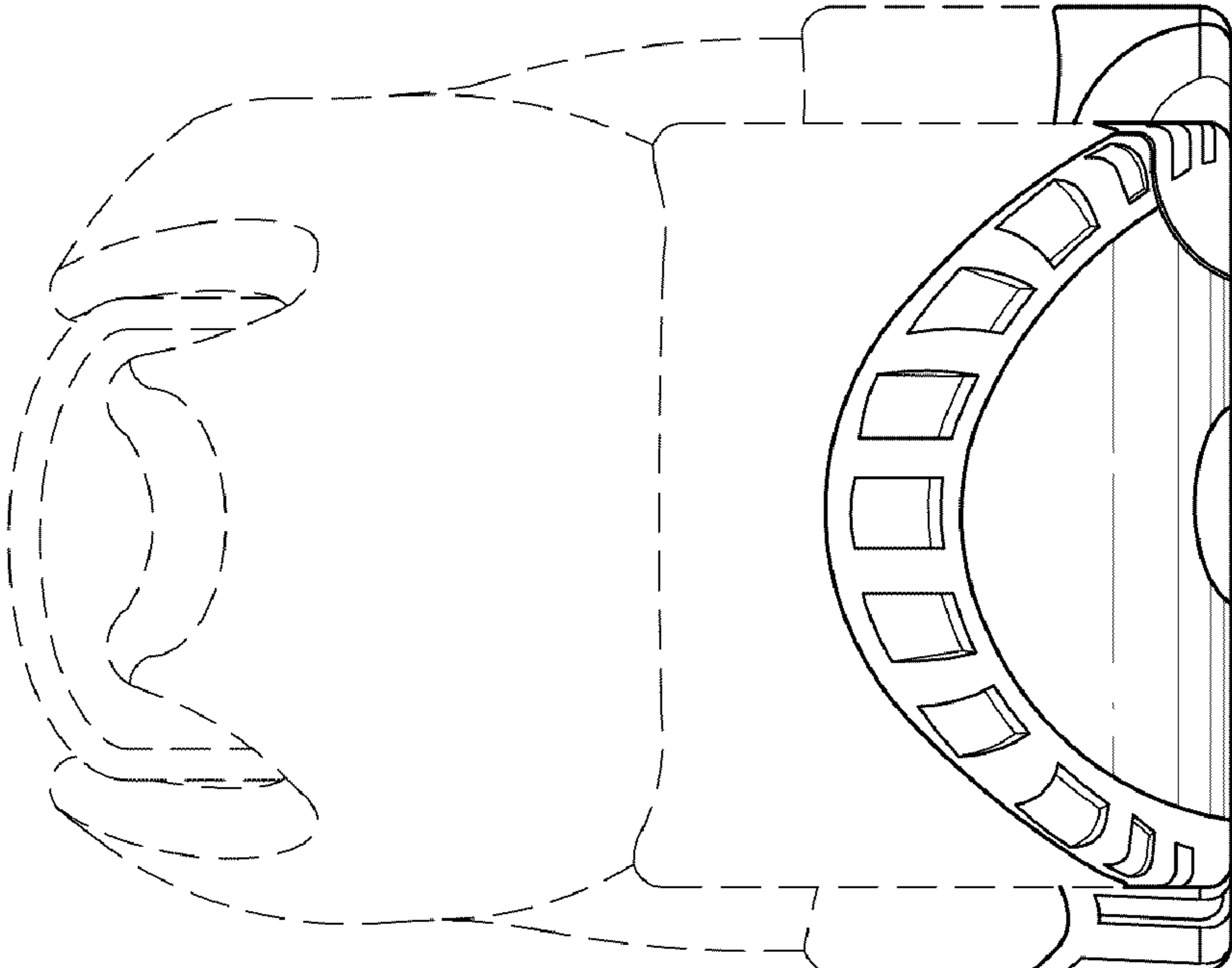

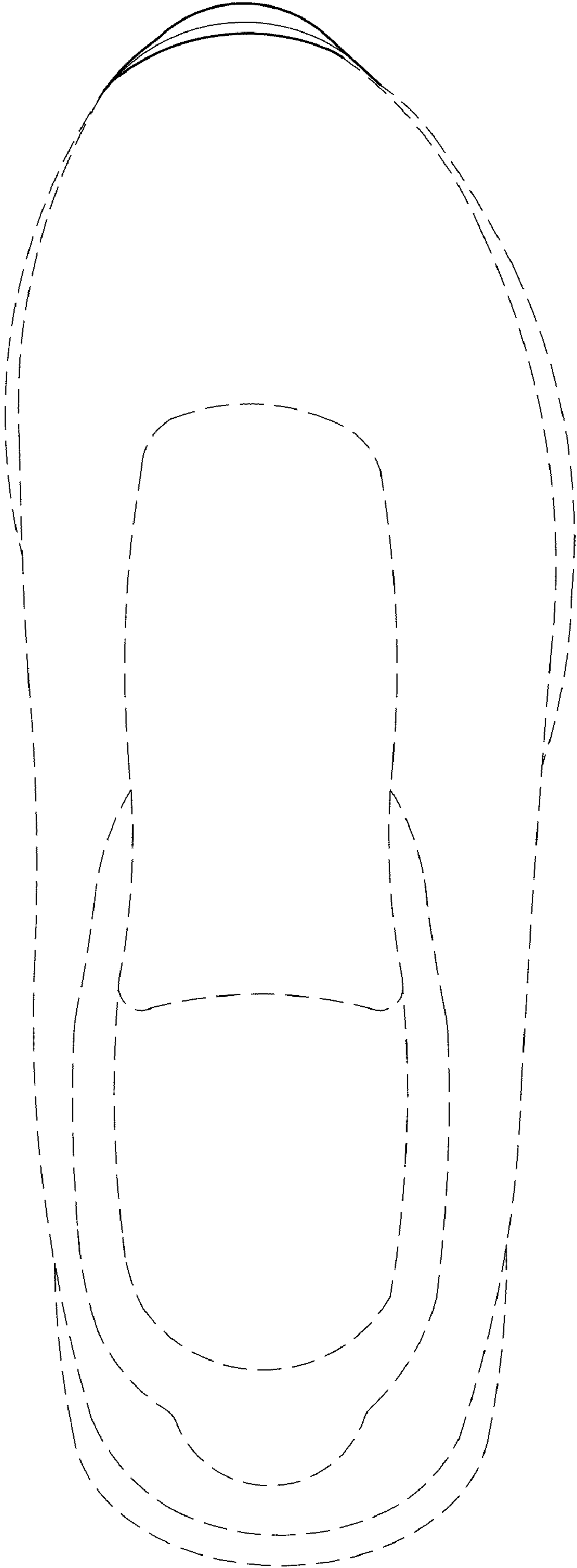
