FIG. 6 is a top view of the same;

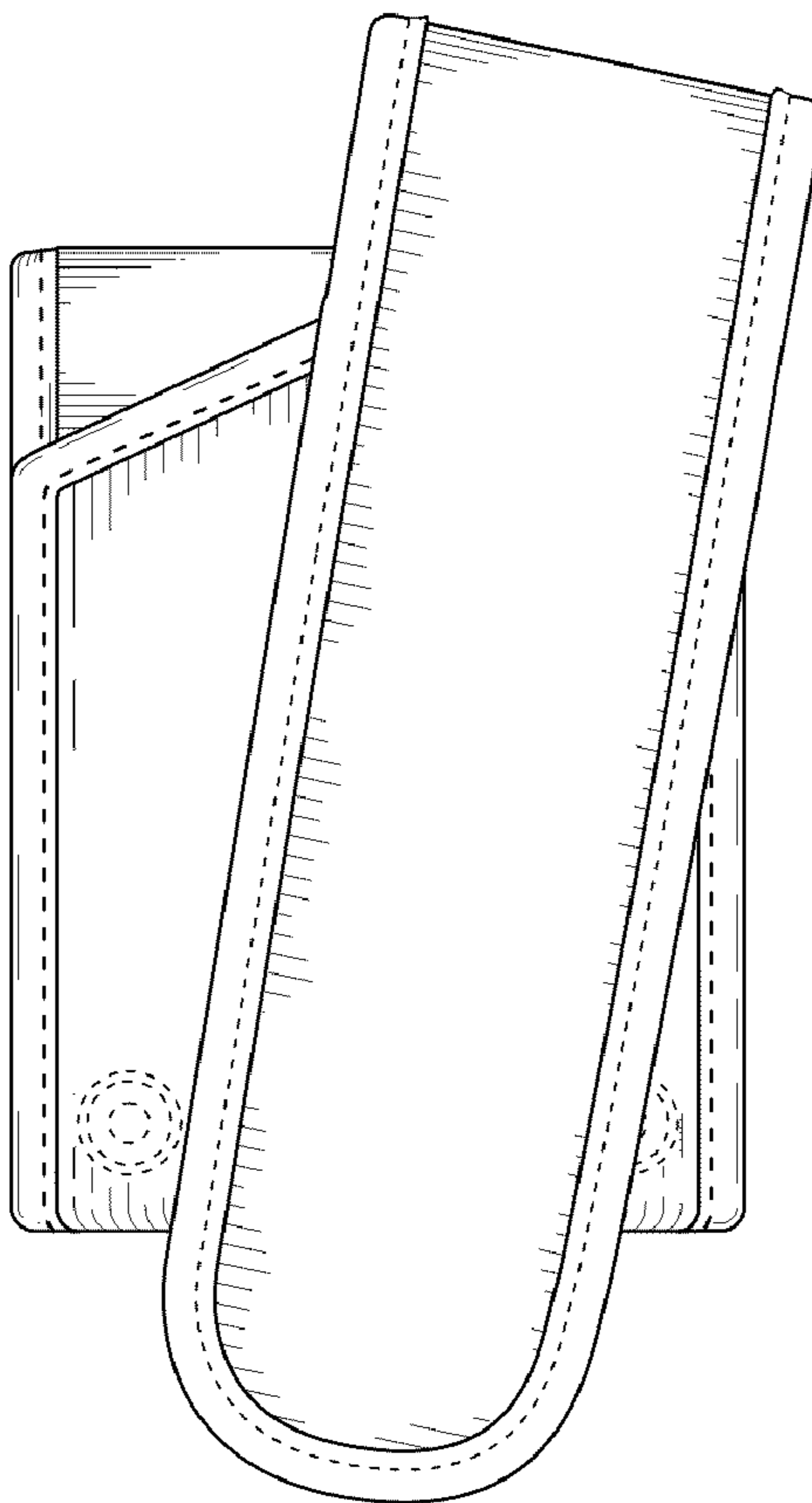
FIG. 7 is a bottom view of the same;

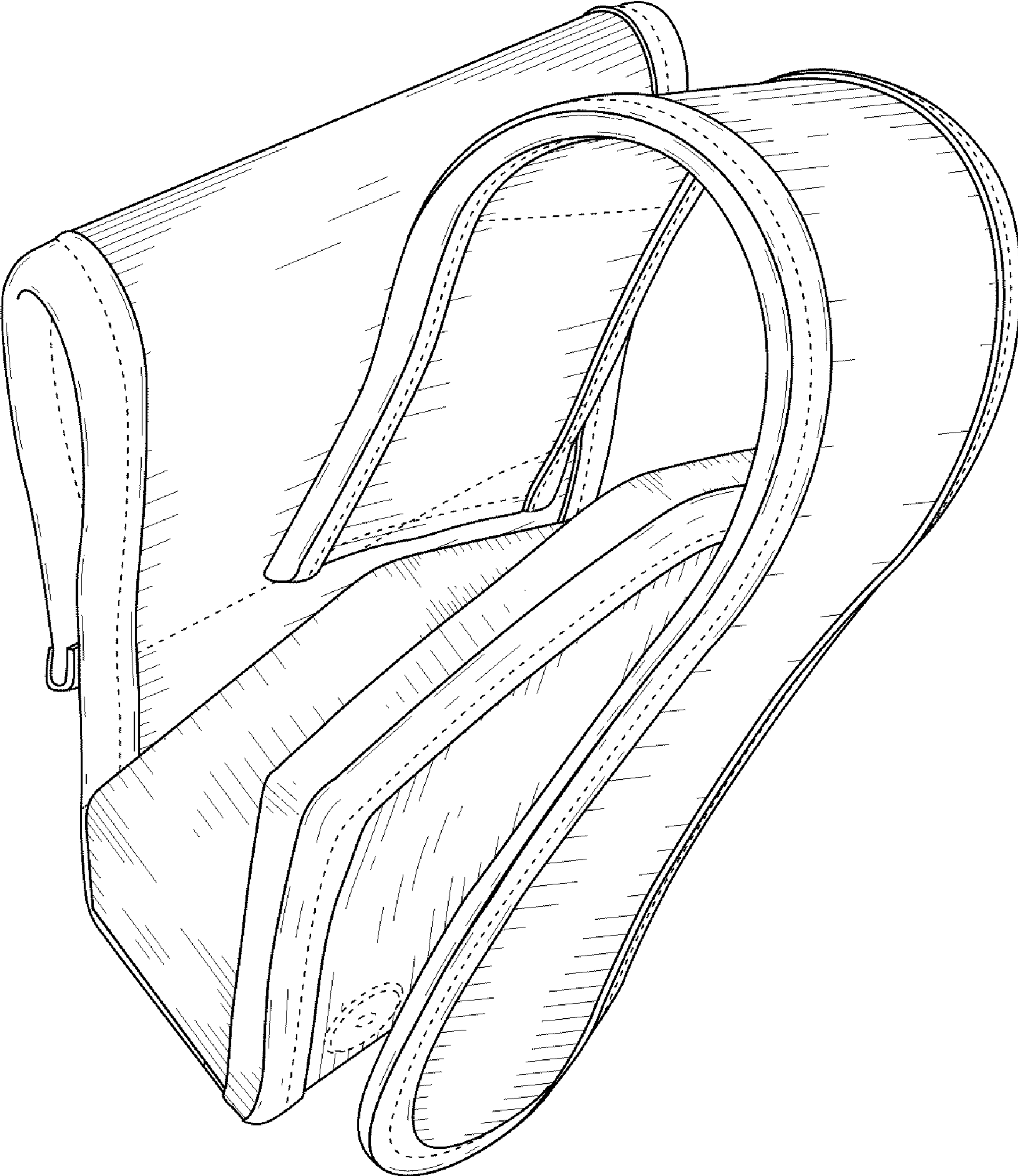
FIG. 8 is perspective view of the shotgun cradle attached to the belt of a wearer including an over/under shotgun secured by the shotgun cradle; and,

FIG. 9 is perspective view of the shotgun cradle attached to the belt of a wearer including an over/under shotgun supported by the shotgun cradle.

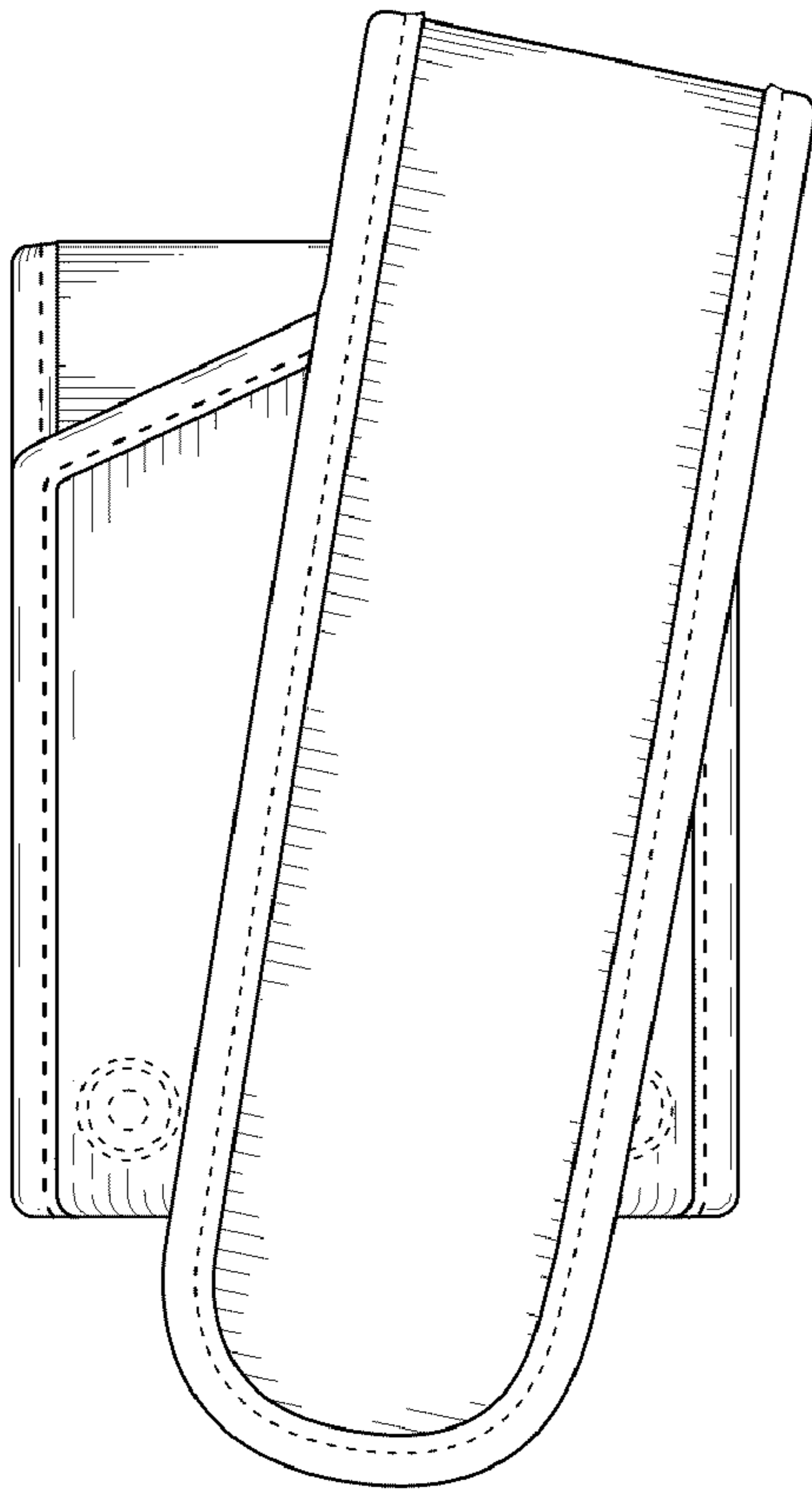

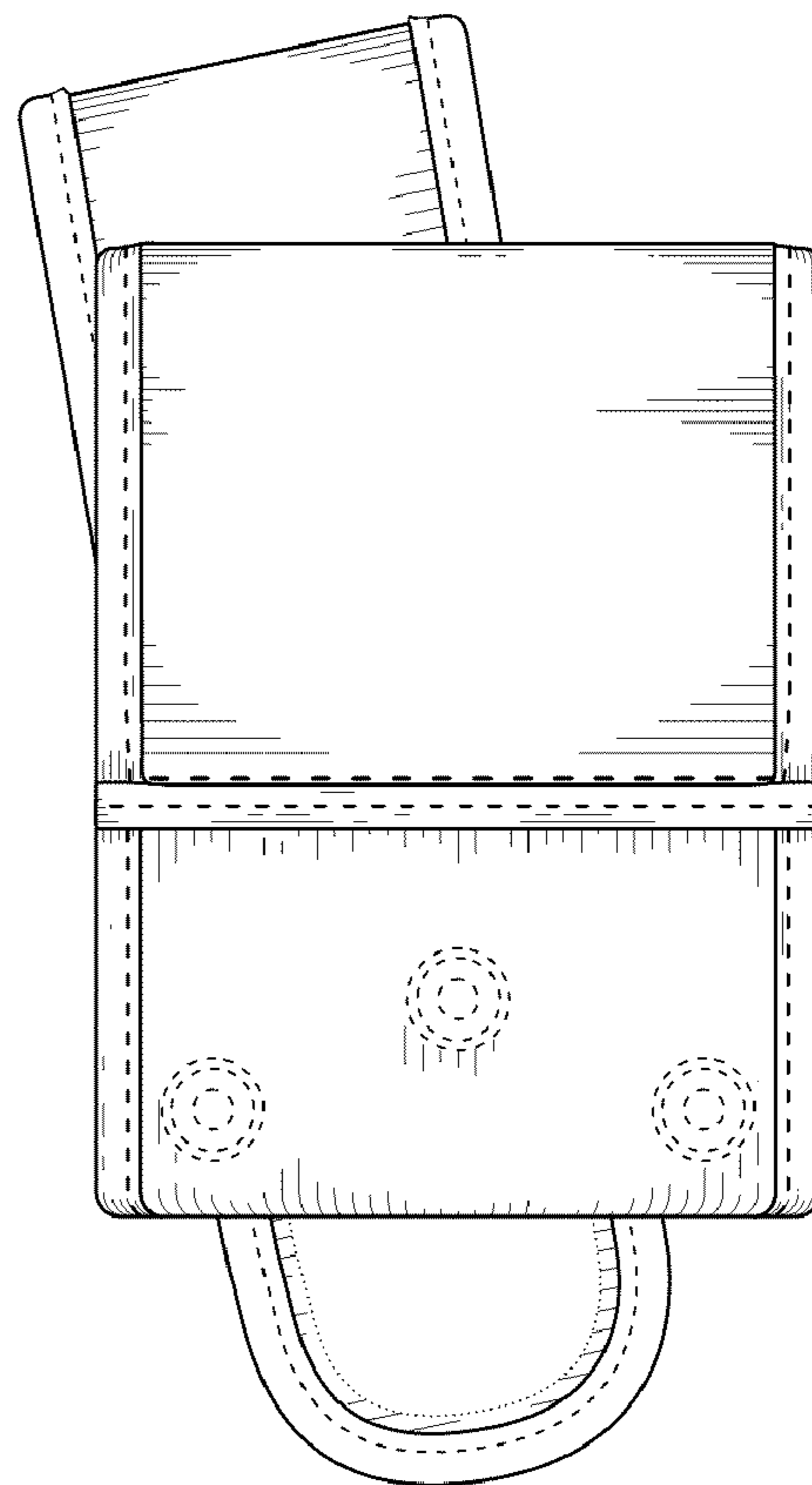




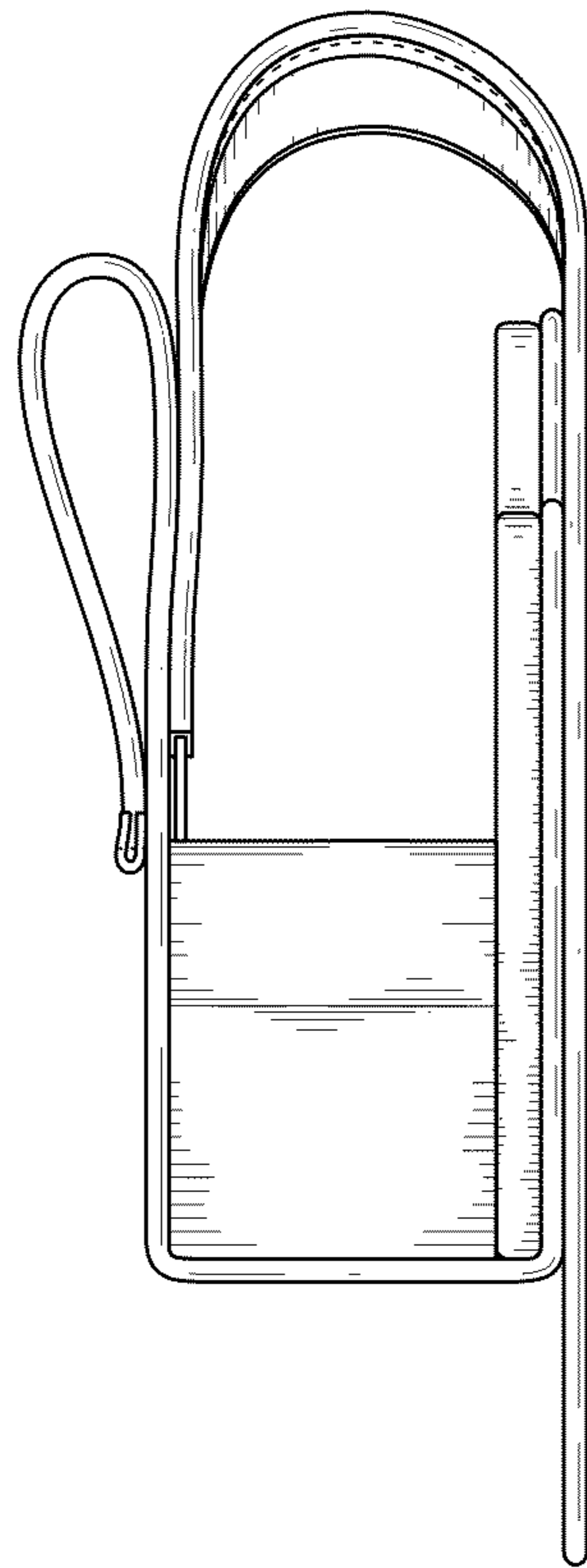

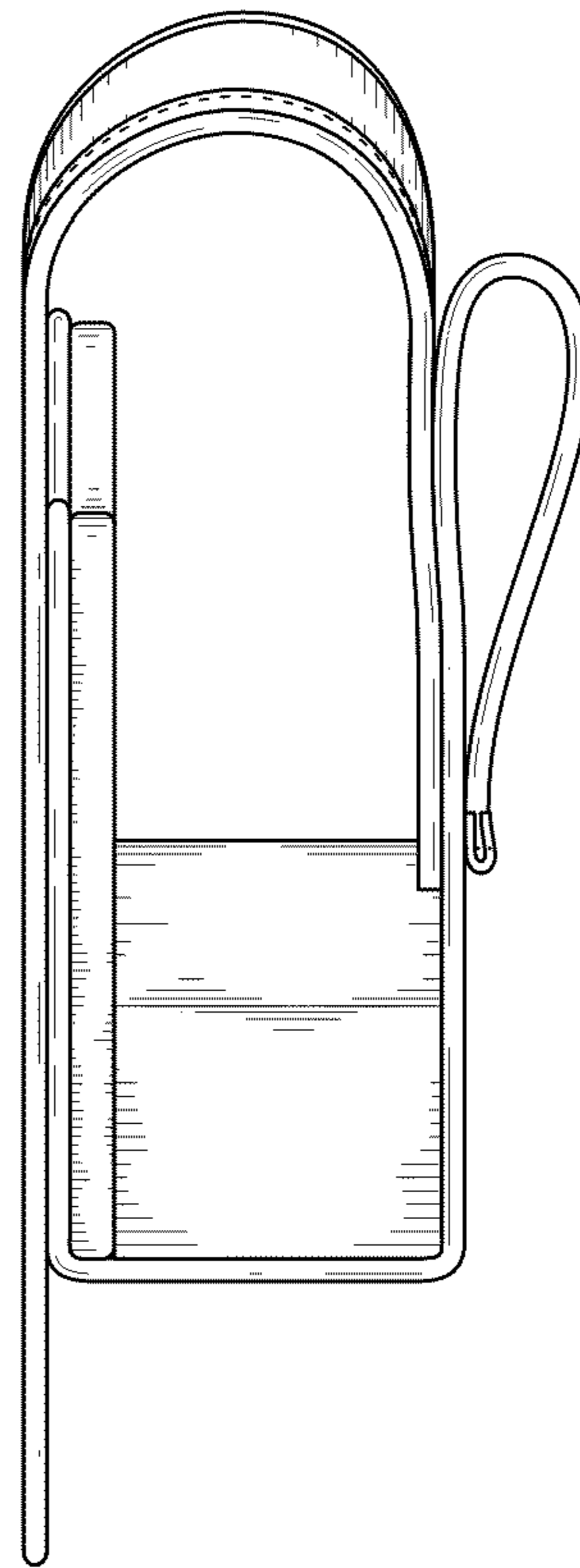

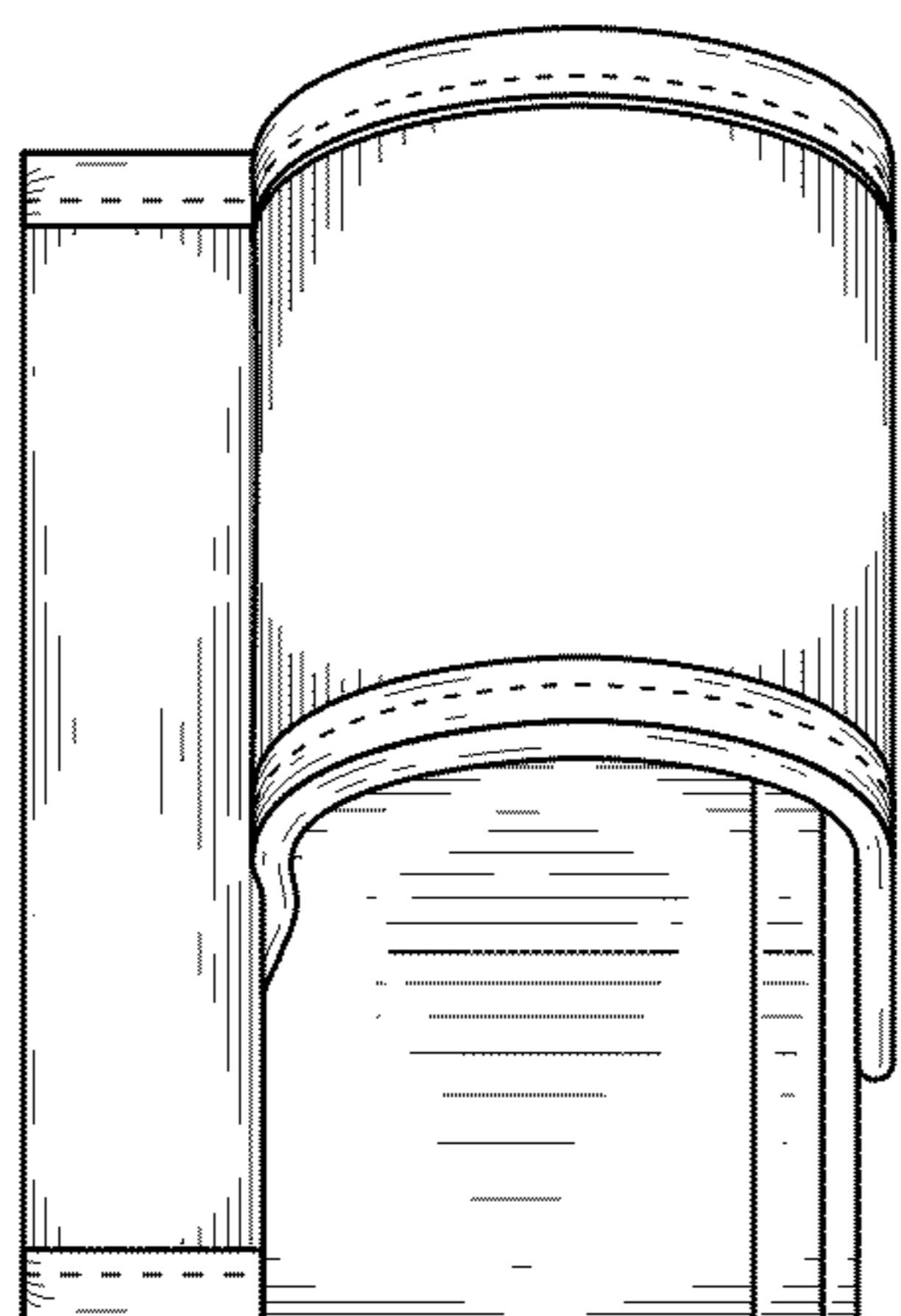

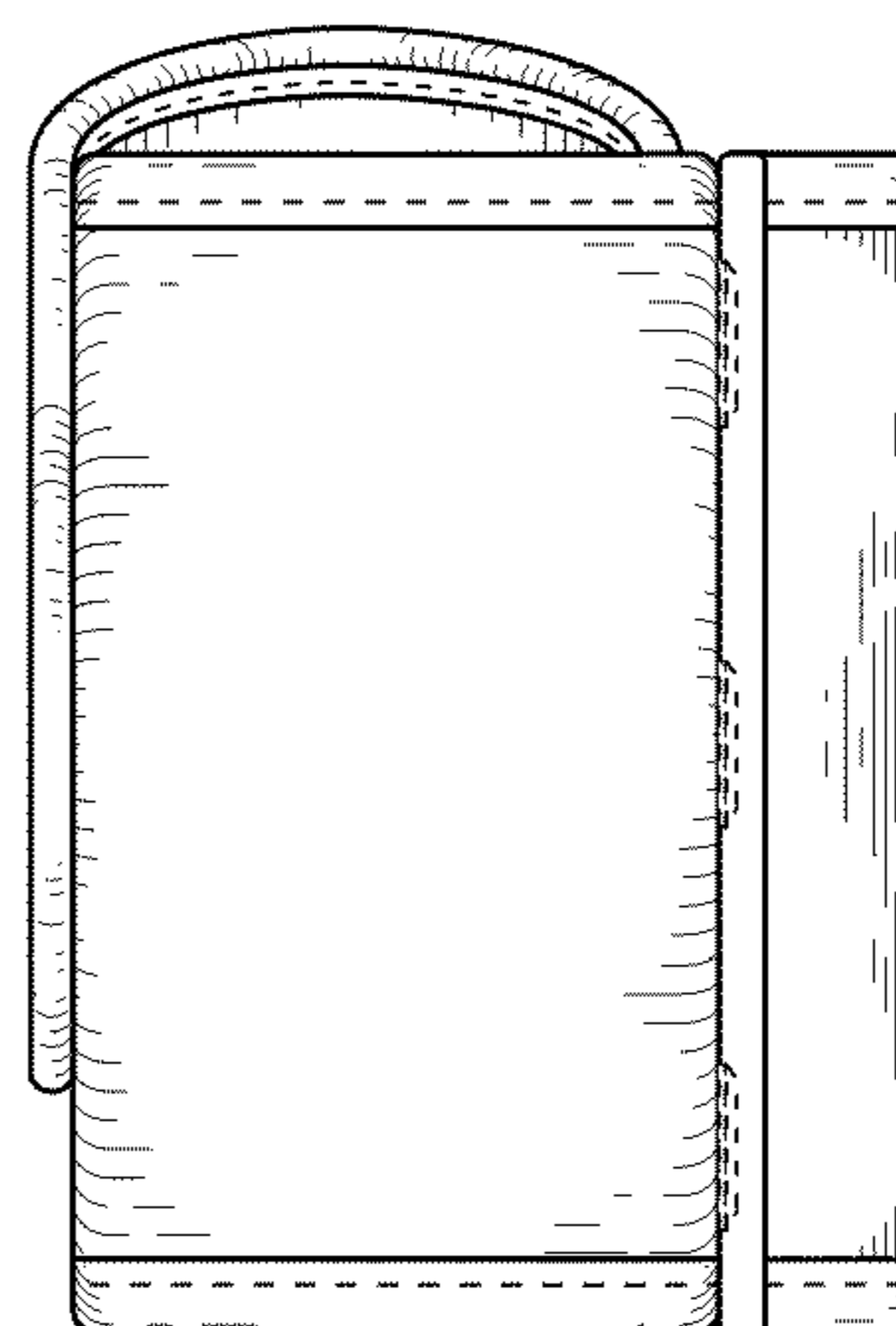

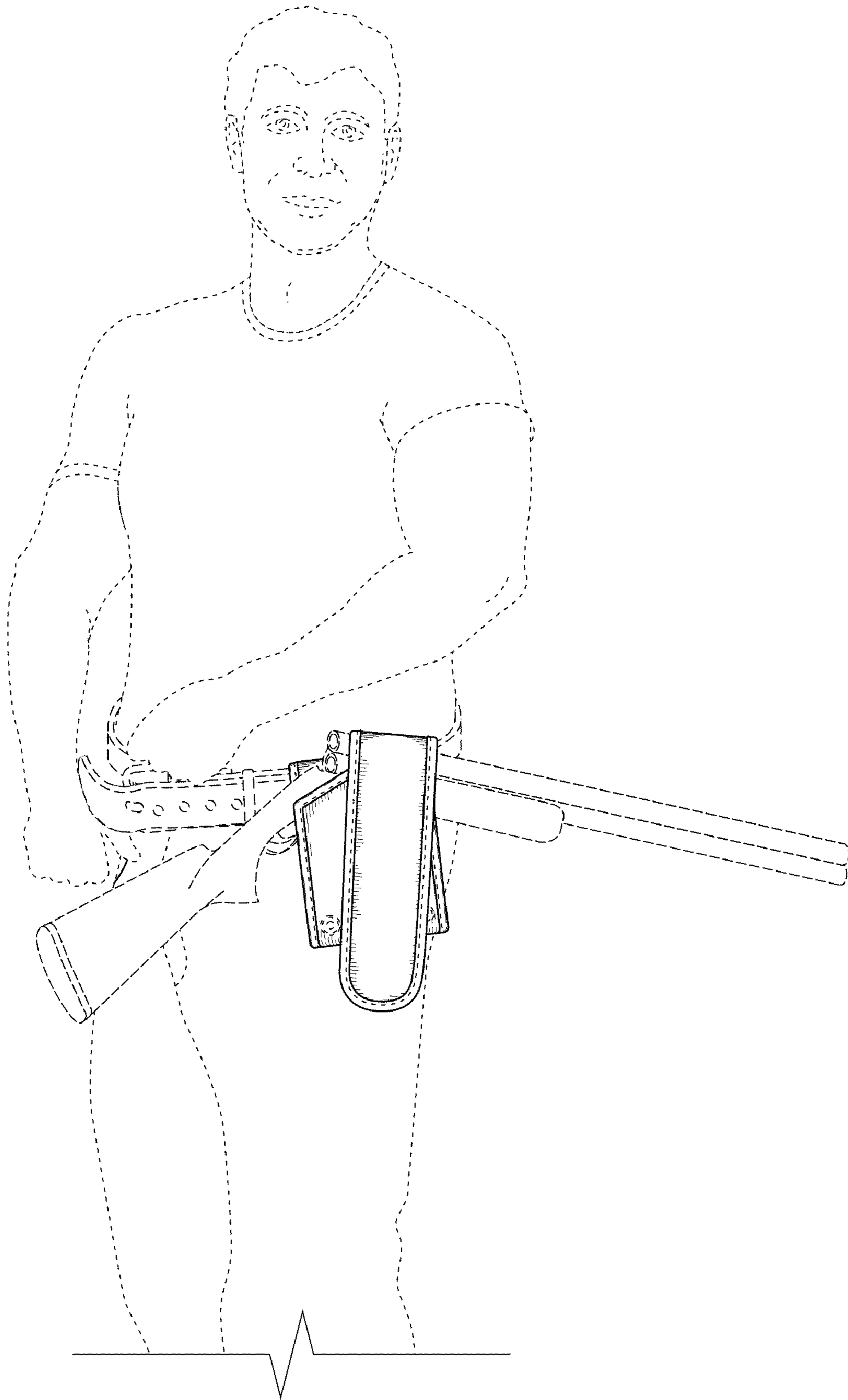

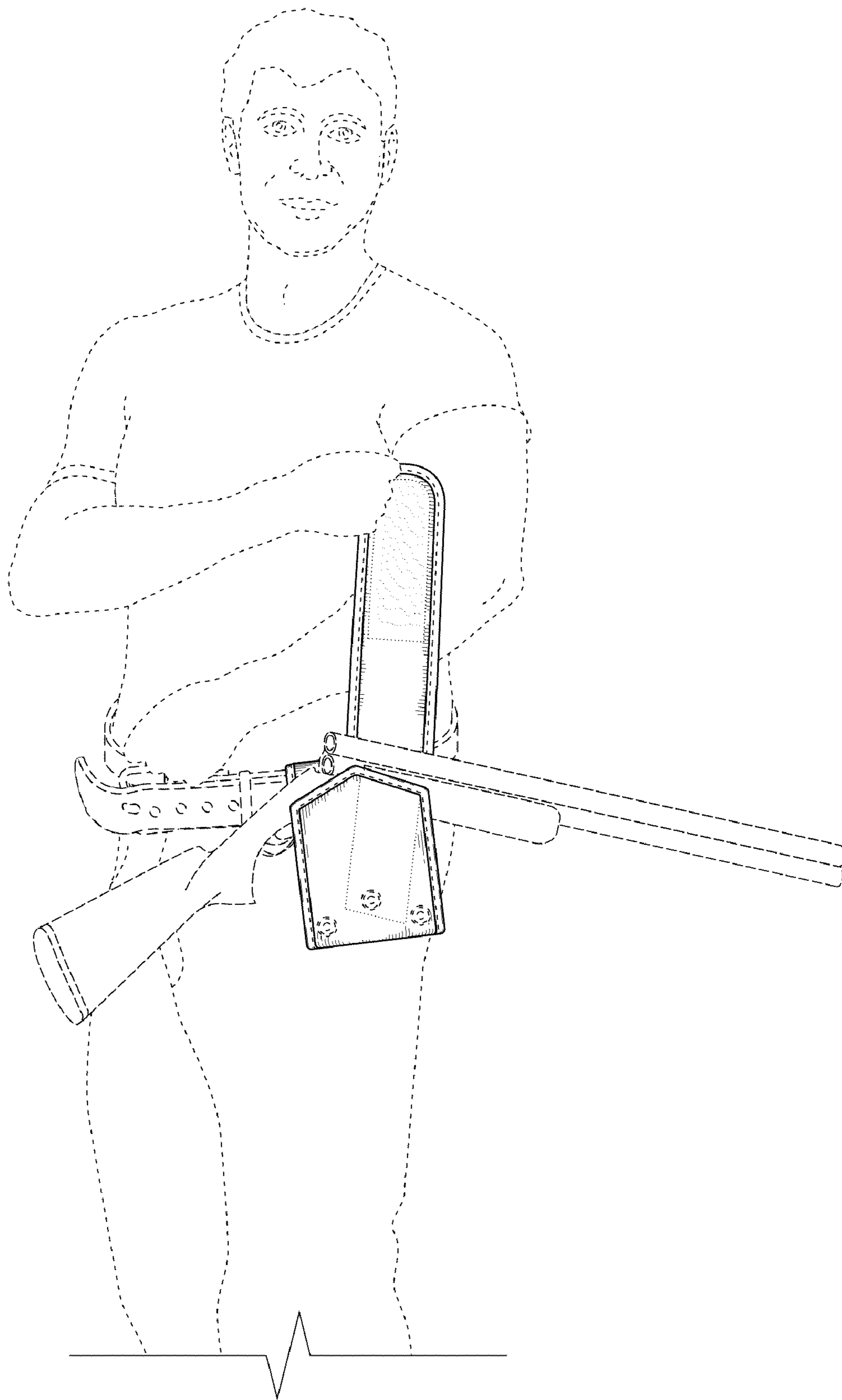
