(57) **CLAIM**

What is claimed is the ornamental design for a suitcase, as shown and described.

DESCRIPTION

FIG. 1 depicts a perspective view of a suitcase, showing the novel design;

FIG. 2 depicts a side view of a suitcase, showing the novel design;

FIG. 3 depicts an alternate side view of a suitcase, showing the novel design;

FIG. 4 depicts an alternate perspective view of a suitcase, showing the novel design;

FIG. 5 depicts a rear view of a suitcase, showing the novel design;

FIG. 6 depicts a top view of a suitcase, showing the novel design; and,

FIG. 7 depicts a bottom view of a suitcase, showing the novel design.

The dashed broken lines shown in the Figures do not represent a part of the claimed design. The design may be applicable to all types of articles of luggage, including suitcases, bags, and the like.

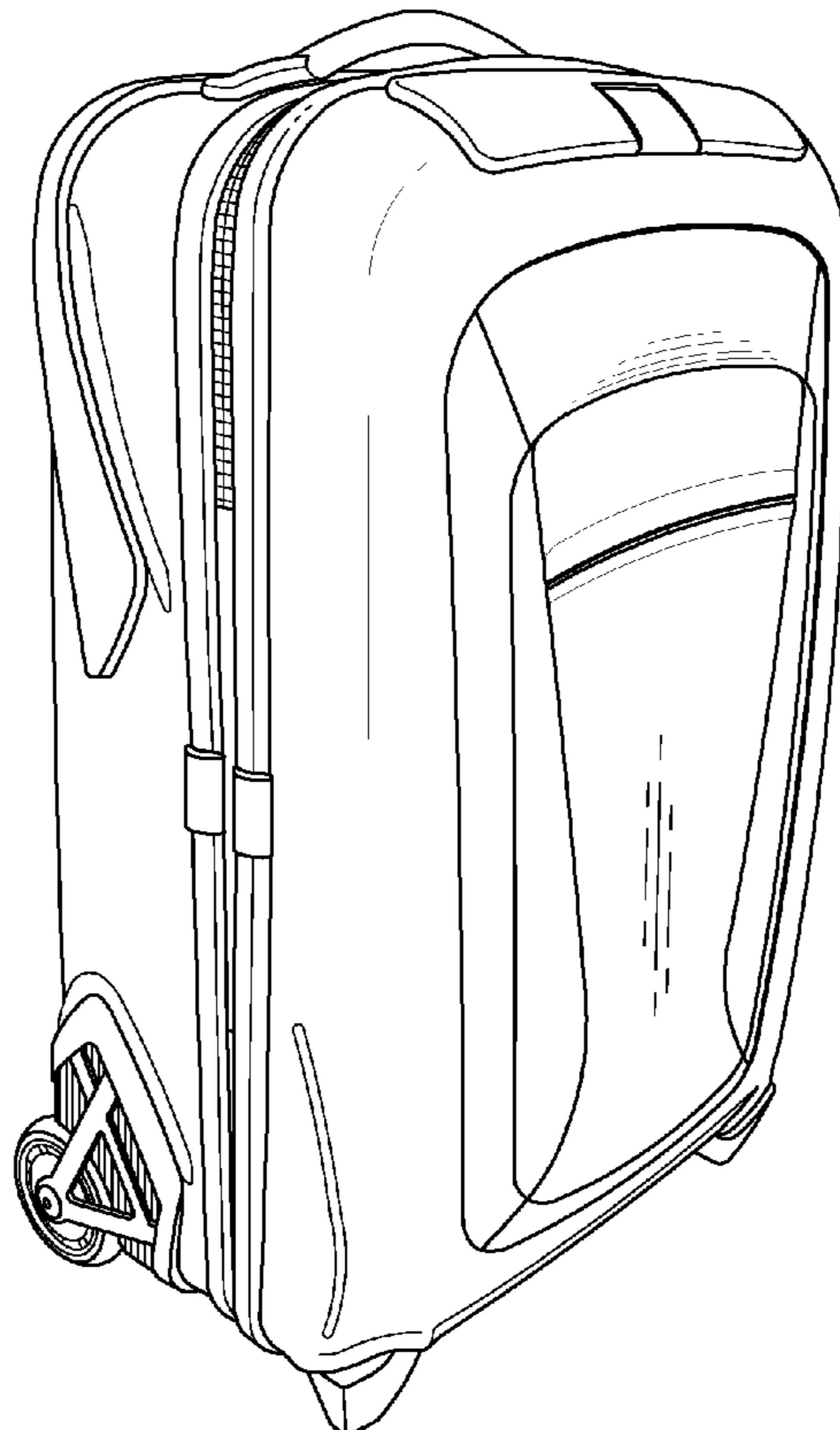

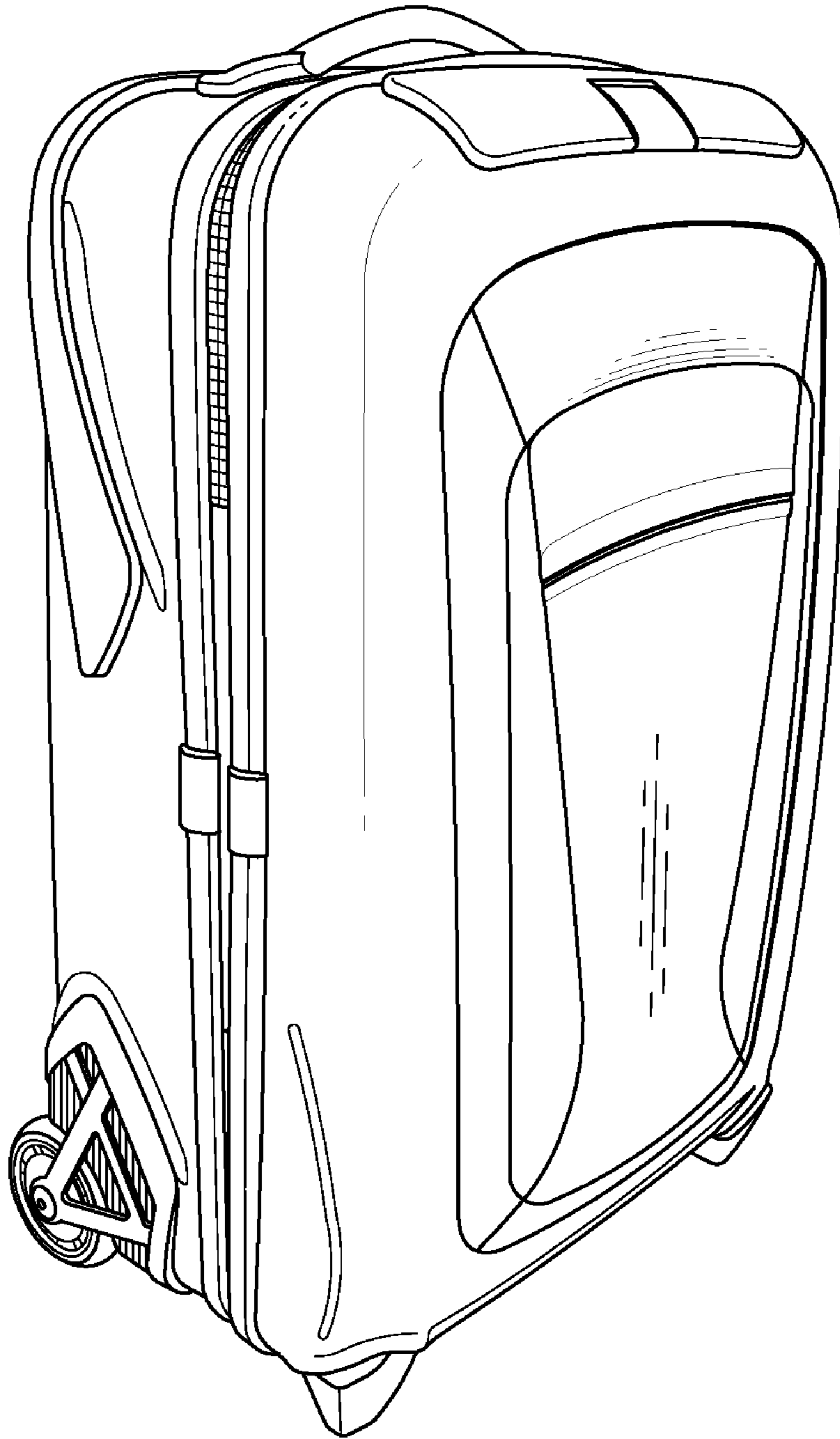

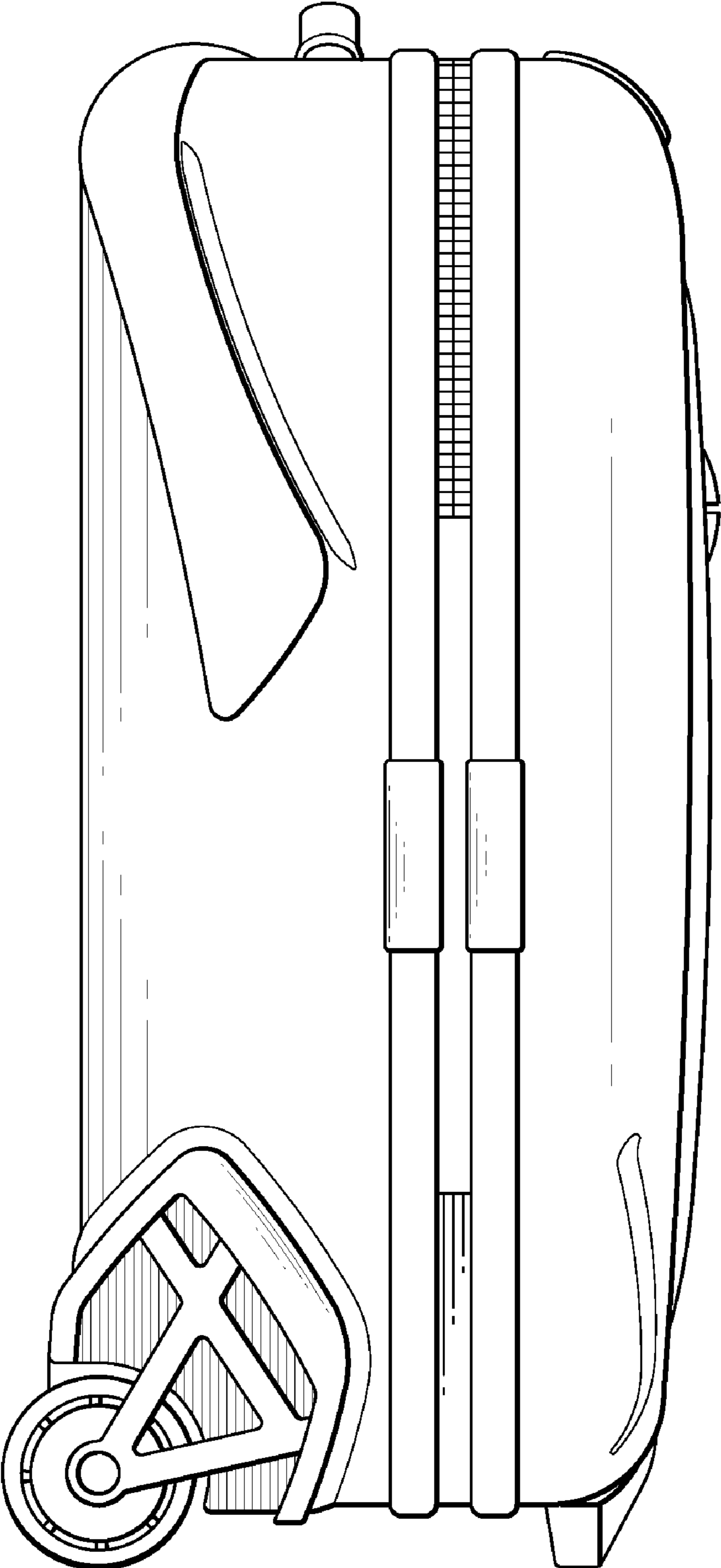

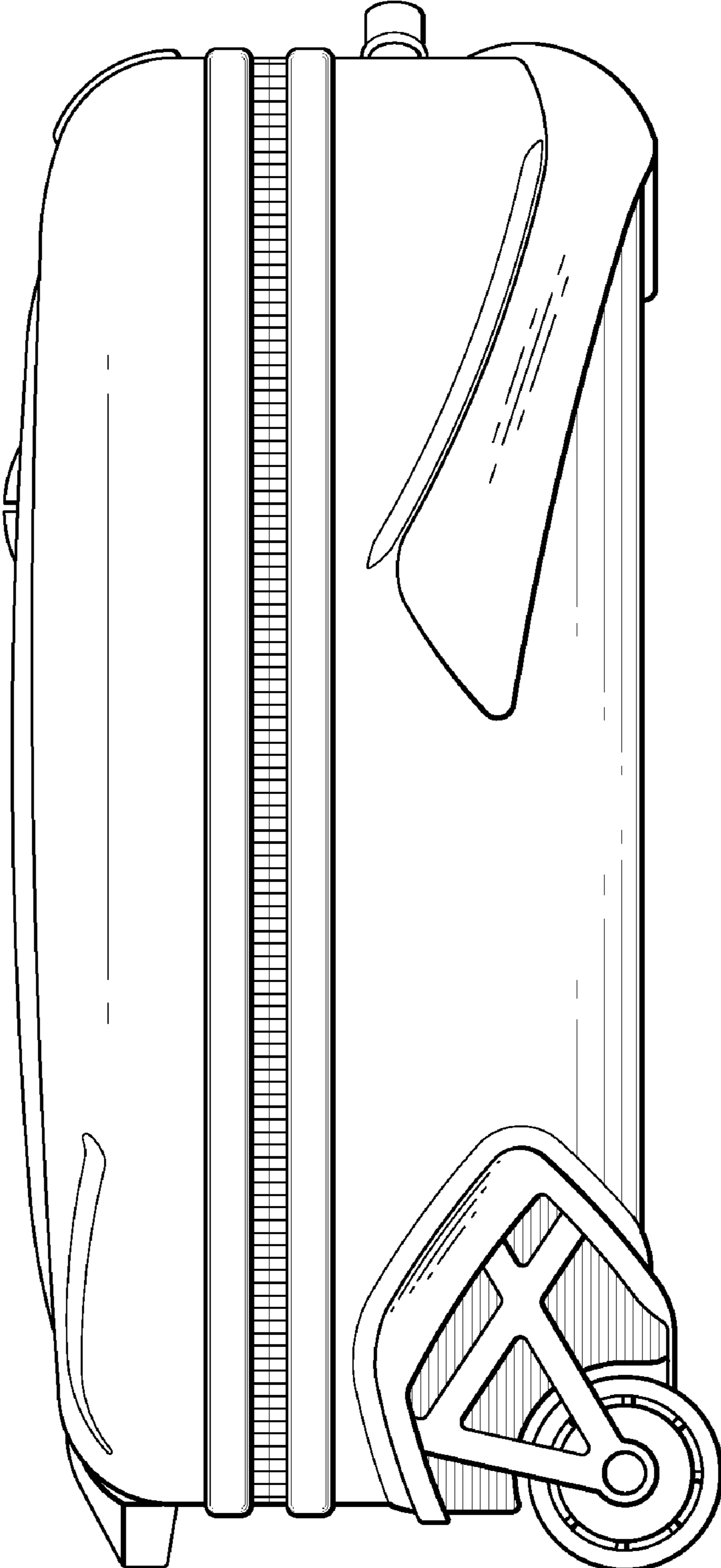

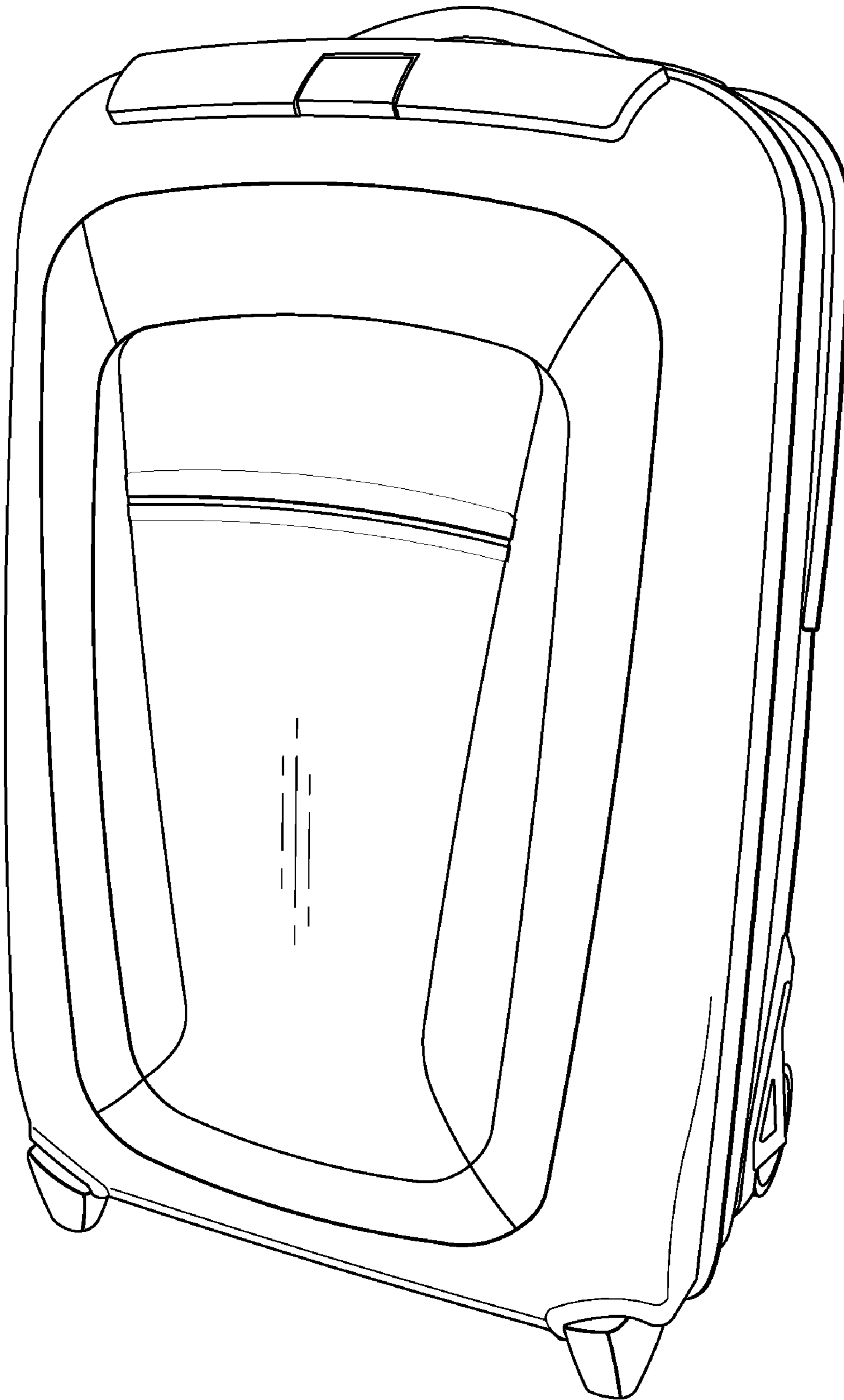

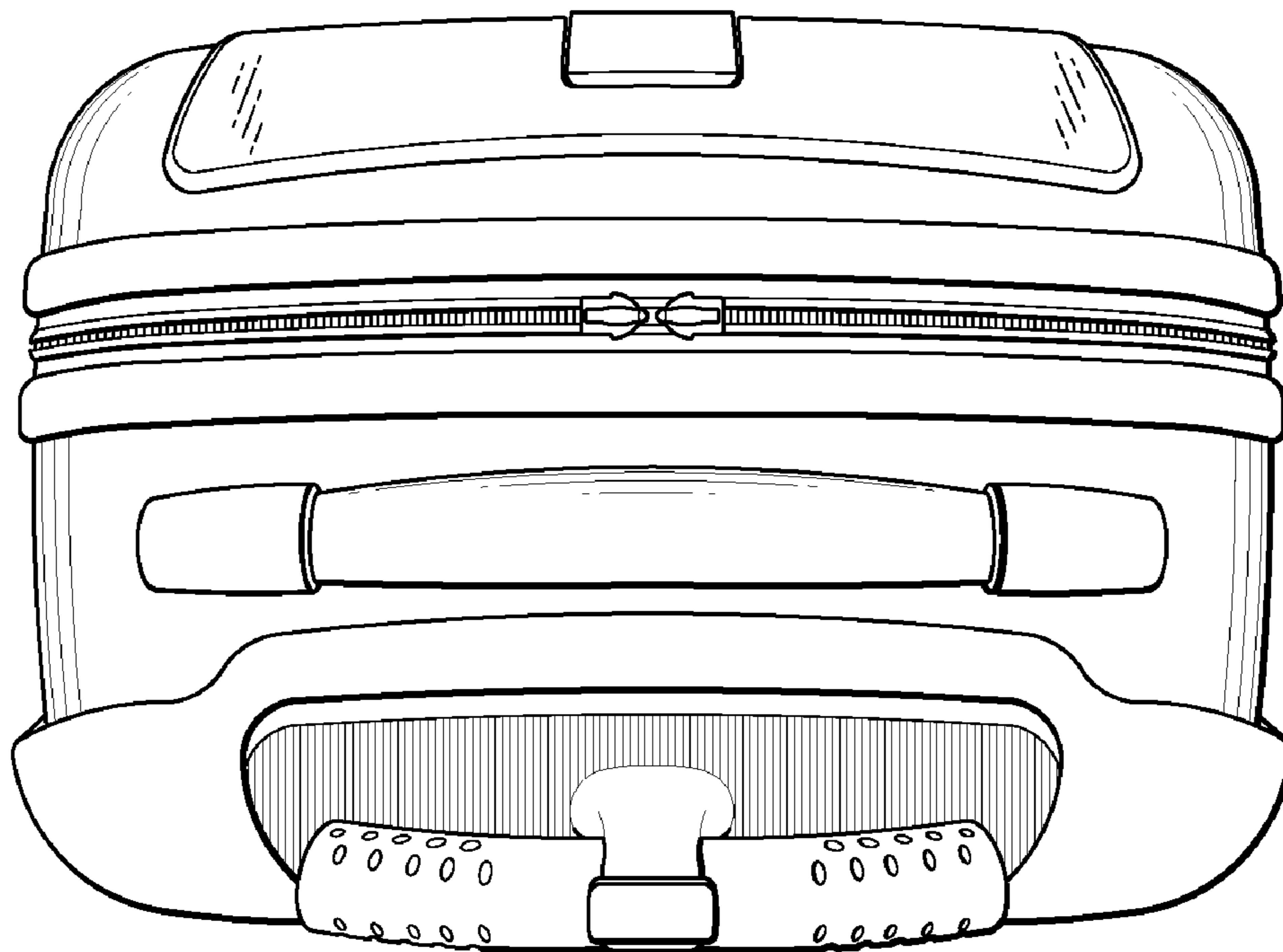
